The ornamental design for a carabiner with zip tie, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a carabiner with a zip tie, the gate and the stops and hinges of the ties being in broken lines are for illustrative purposes only and form no part of the claimed design.

FIG. 2 bottom plan view of FIG. 1.

FIG. 3 is a rear side elevation view of FIG. 1.

FIG. 4 is a front side elevation view of FIG. 1.

FIG. 5 is a left side elevation view of FIG. 1.

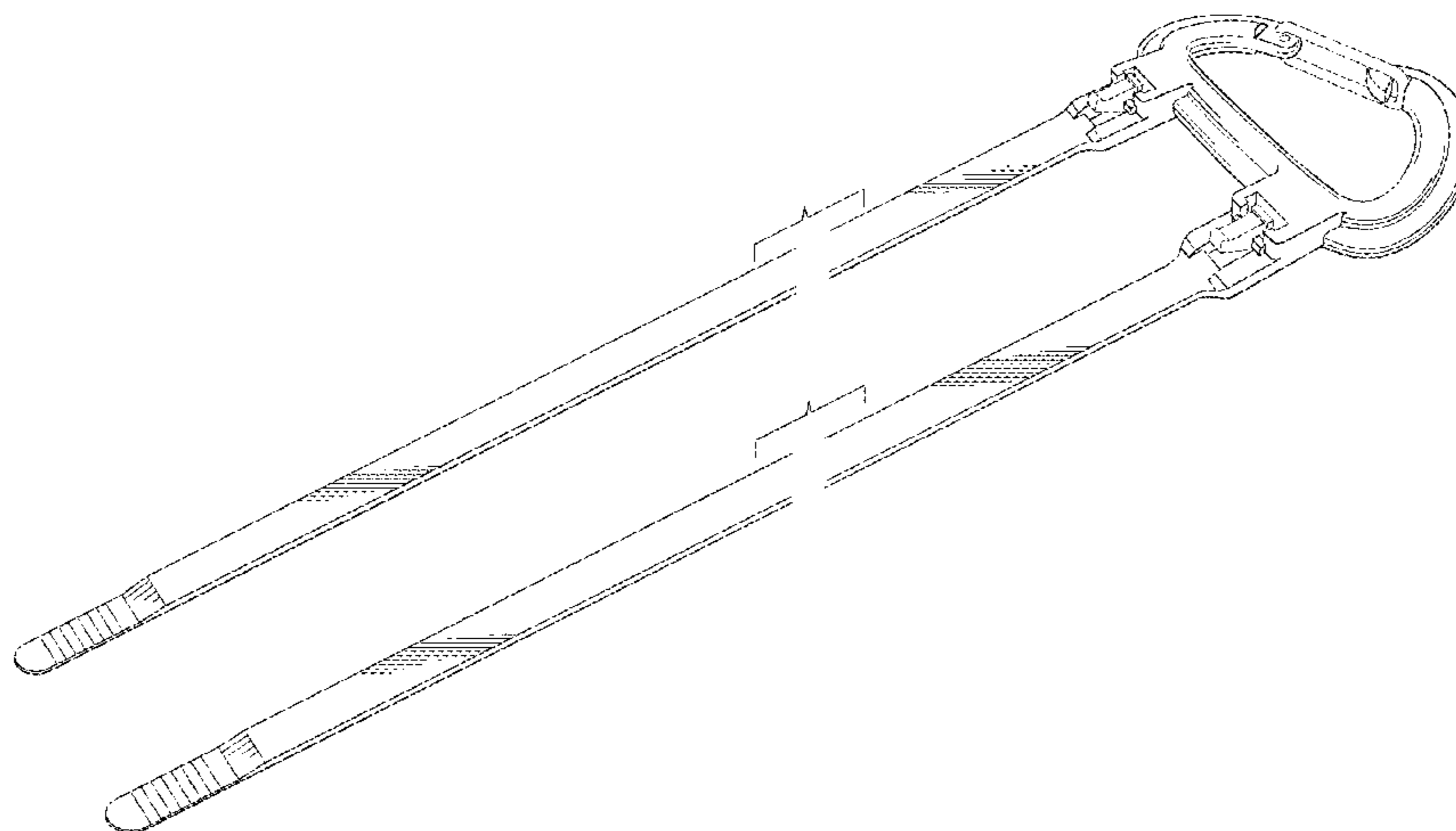
FIG. 6 is a right side elevation view of FIG. 1; and,

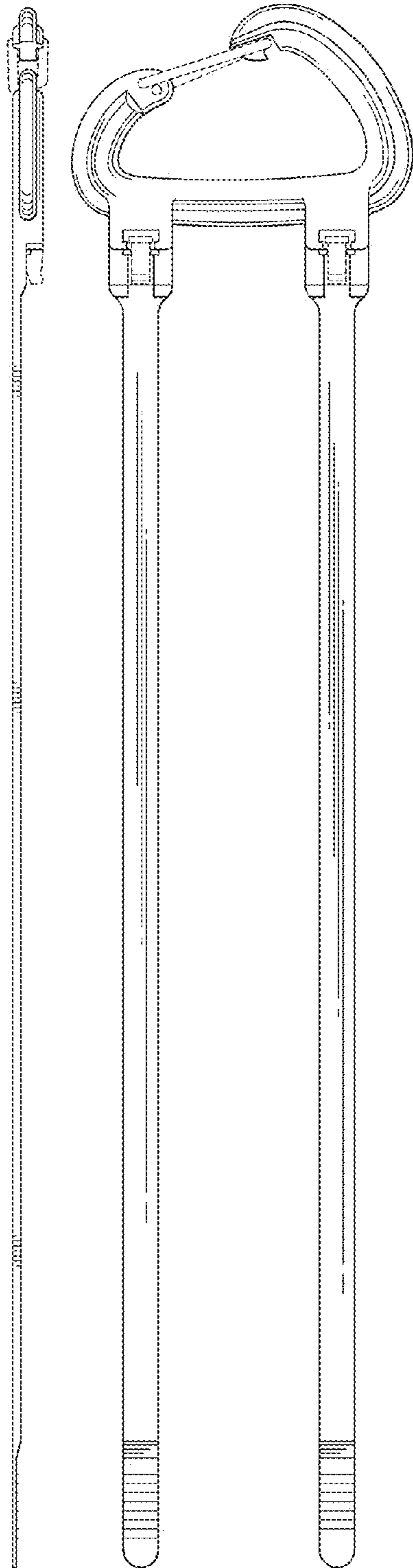

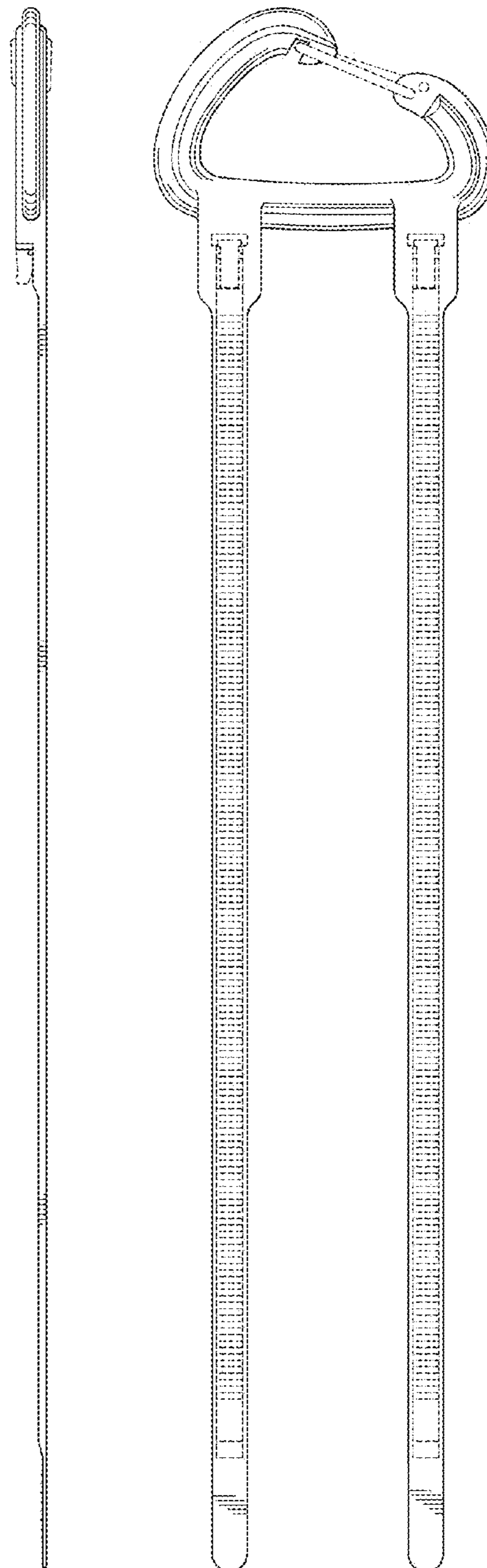

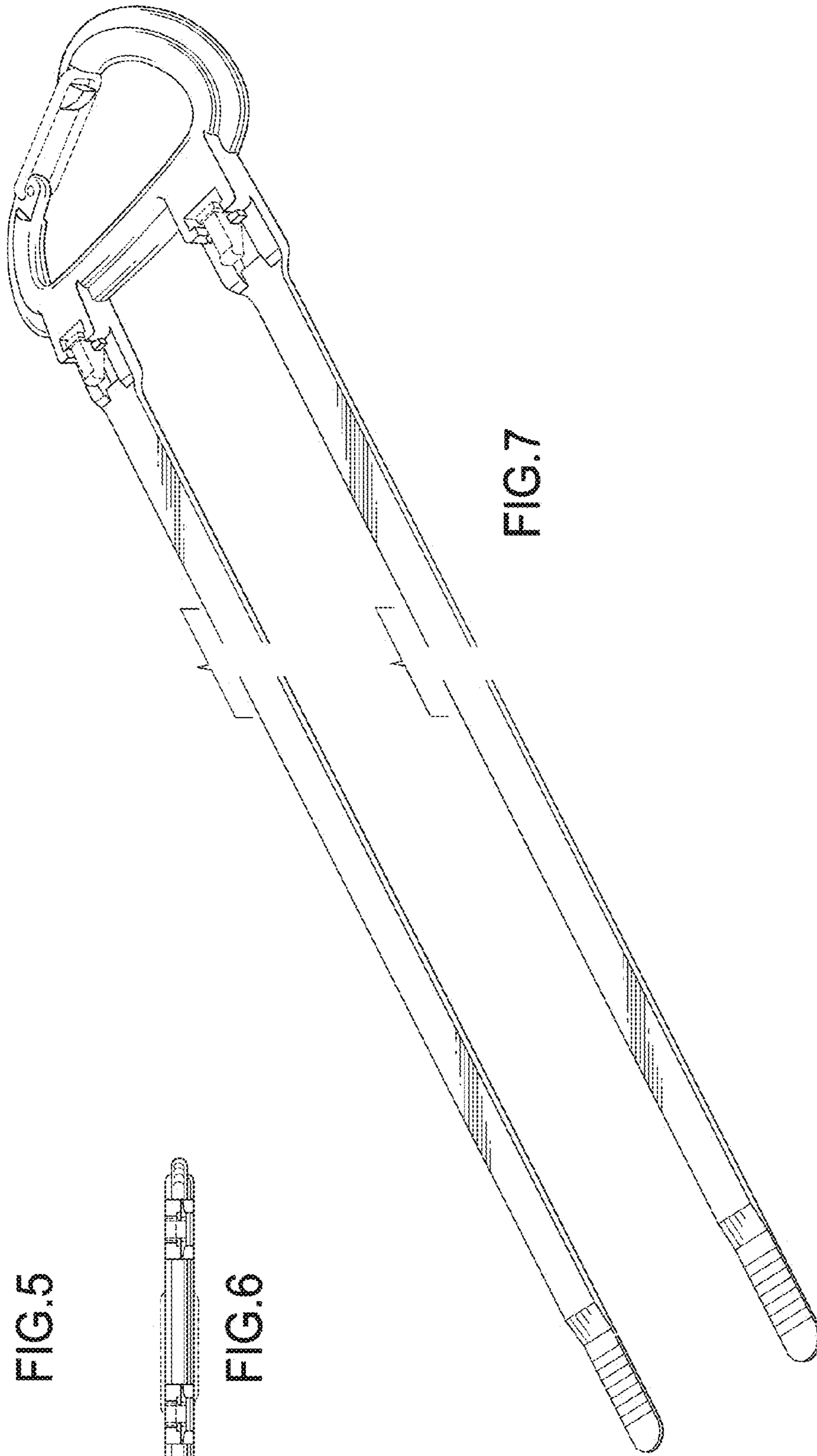
