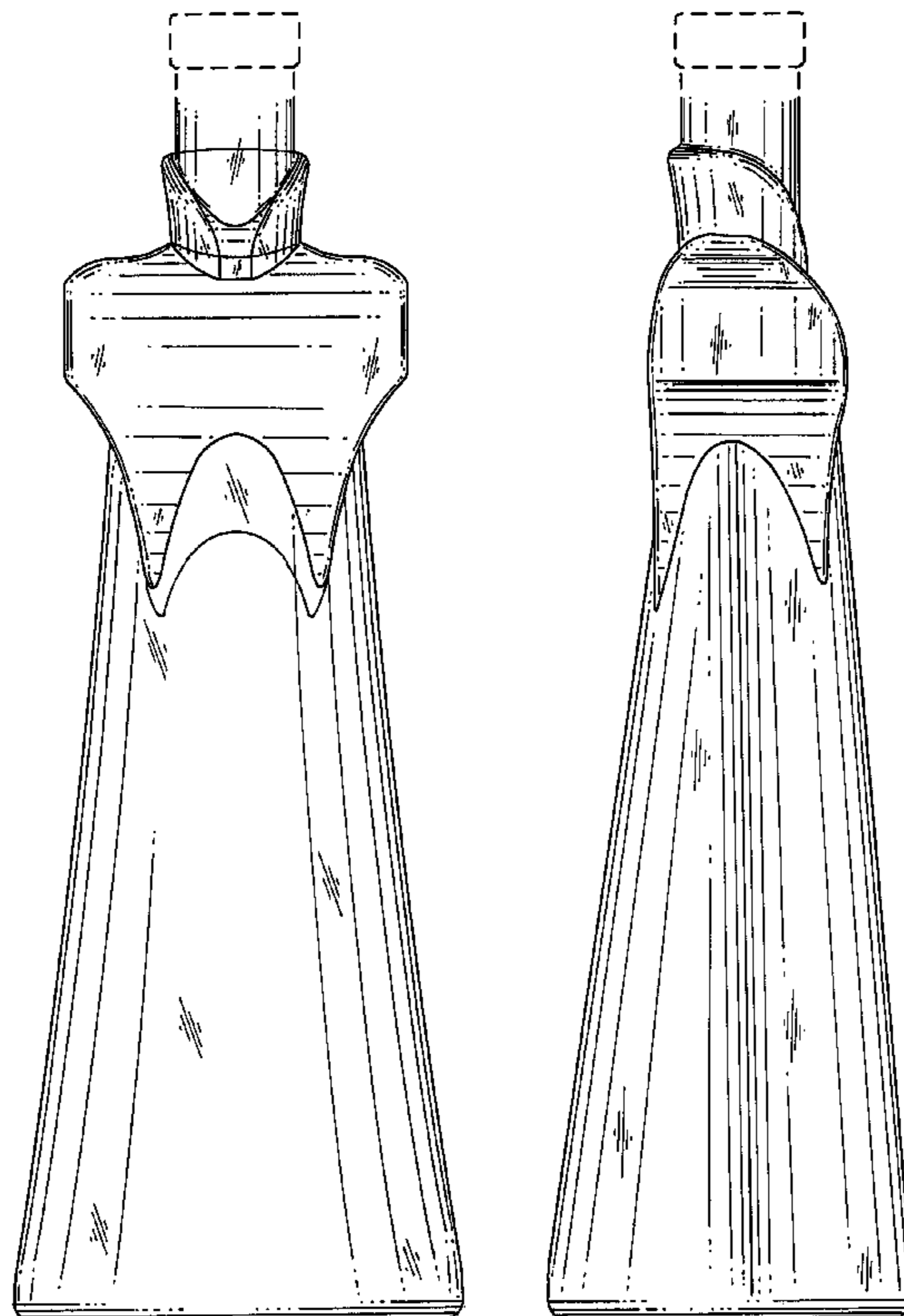
(57) **CLAIM**

The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a bottle according to my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a right side elevational view thereof, the left side view being a mirror image;
FIG. 4 is a rear elevational view thereof; and,
FIG. 5 is a bottom plan view thereof.

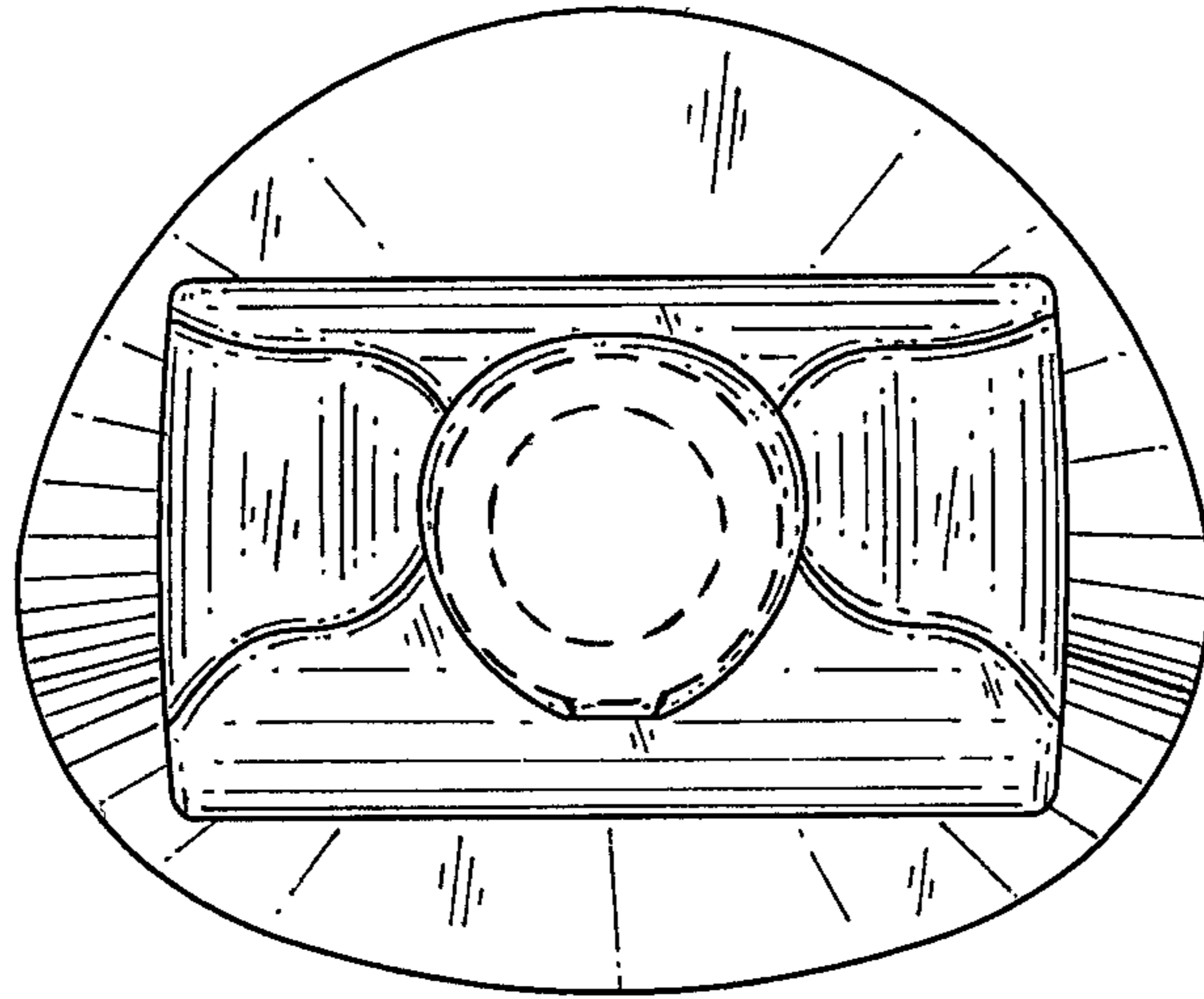

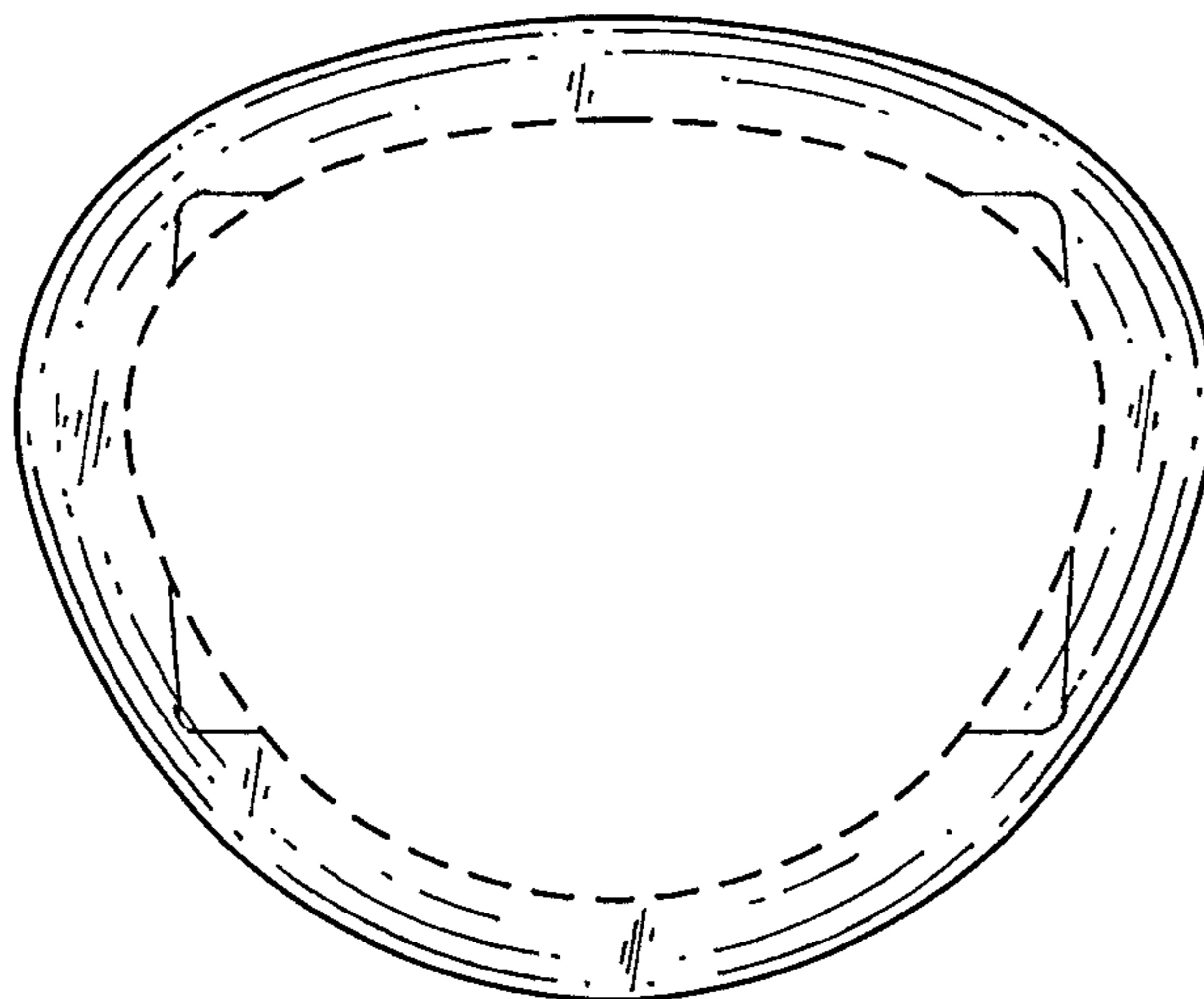

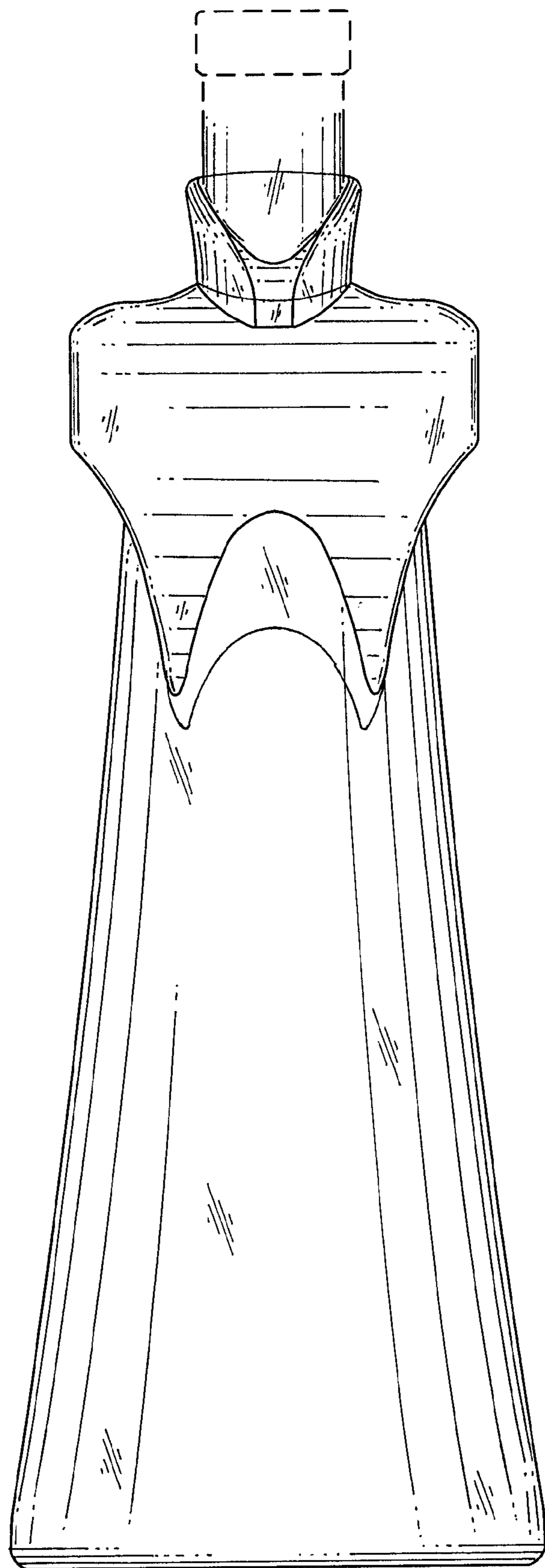

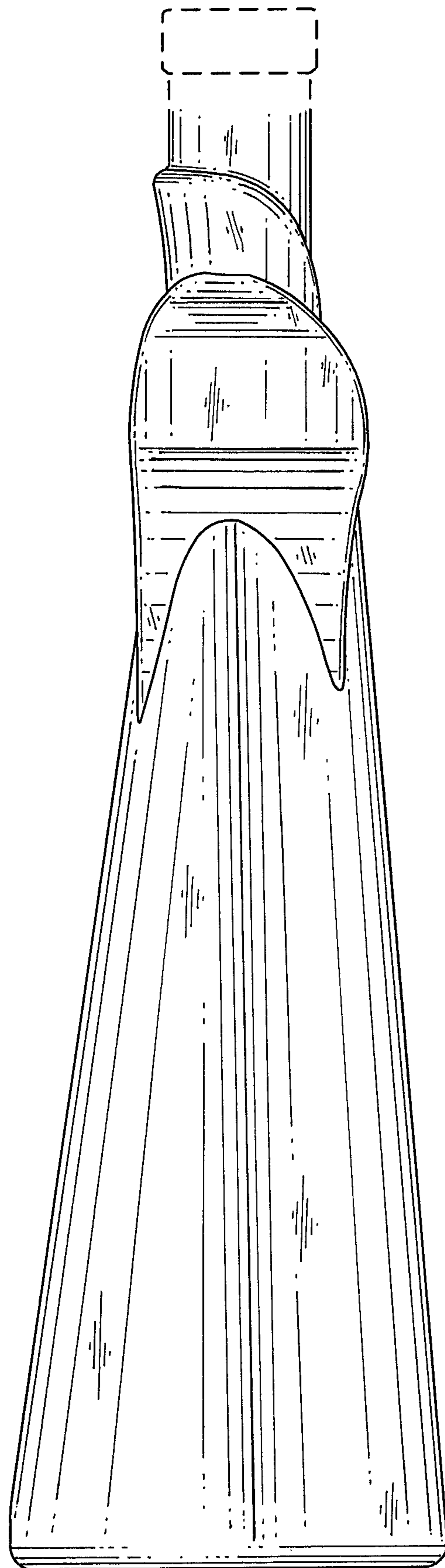

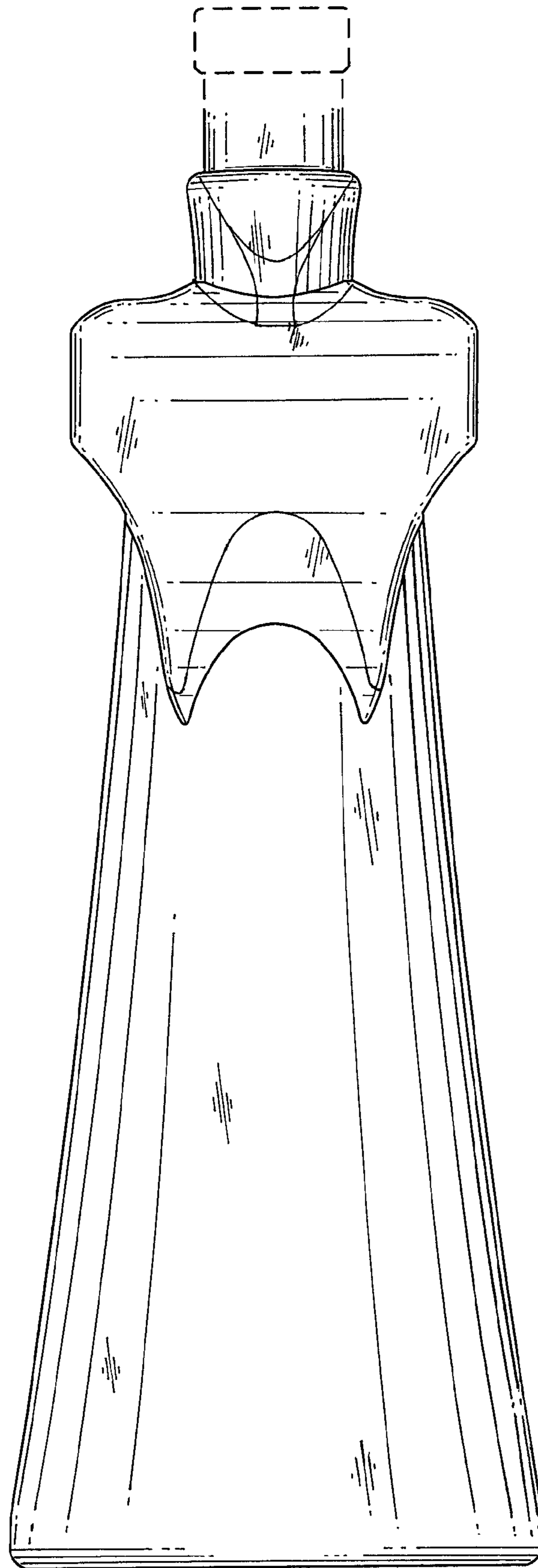
