FIG. 2 is a back view thereof.

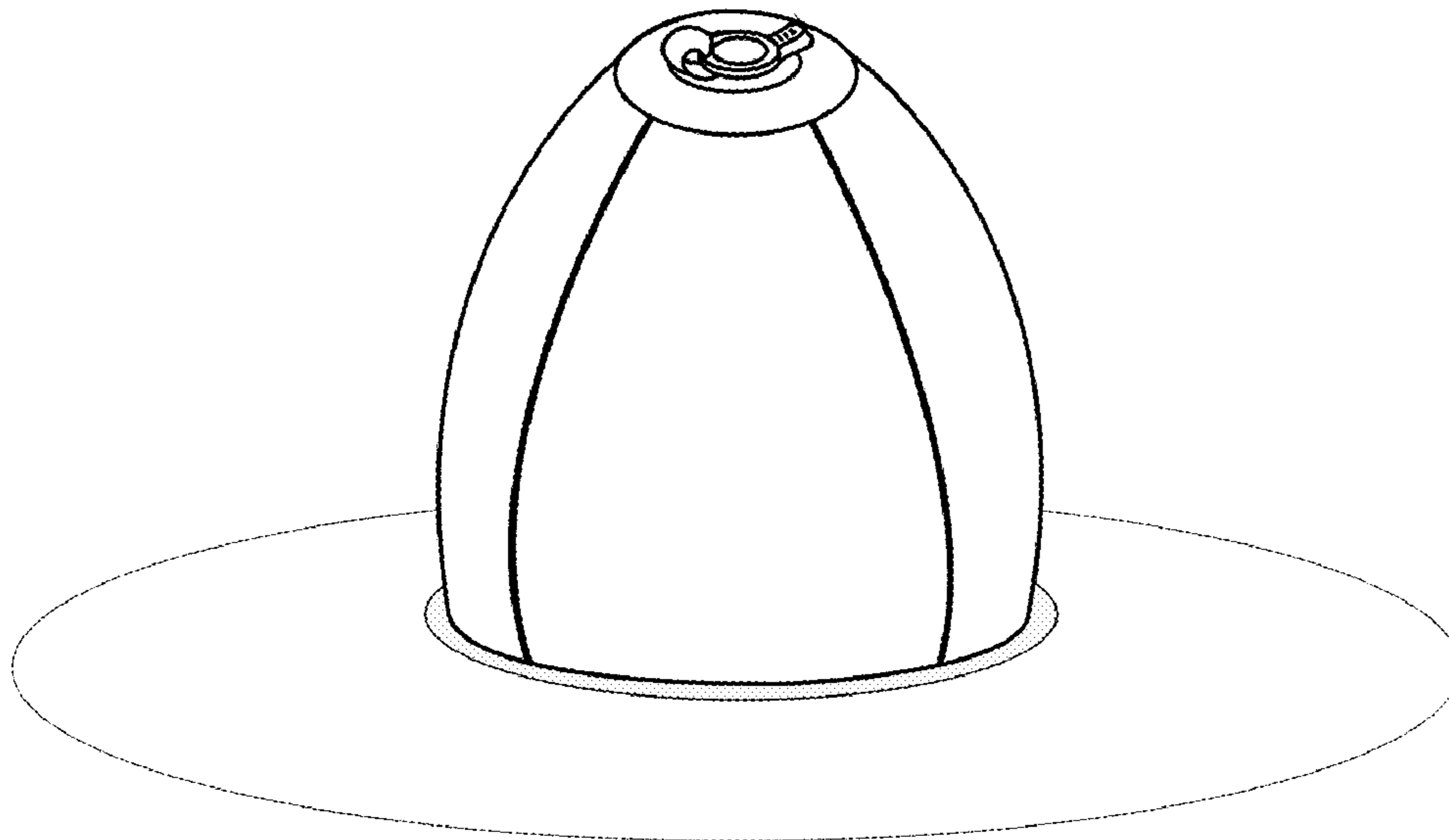
FIG. 3 is a bottom view thereof.

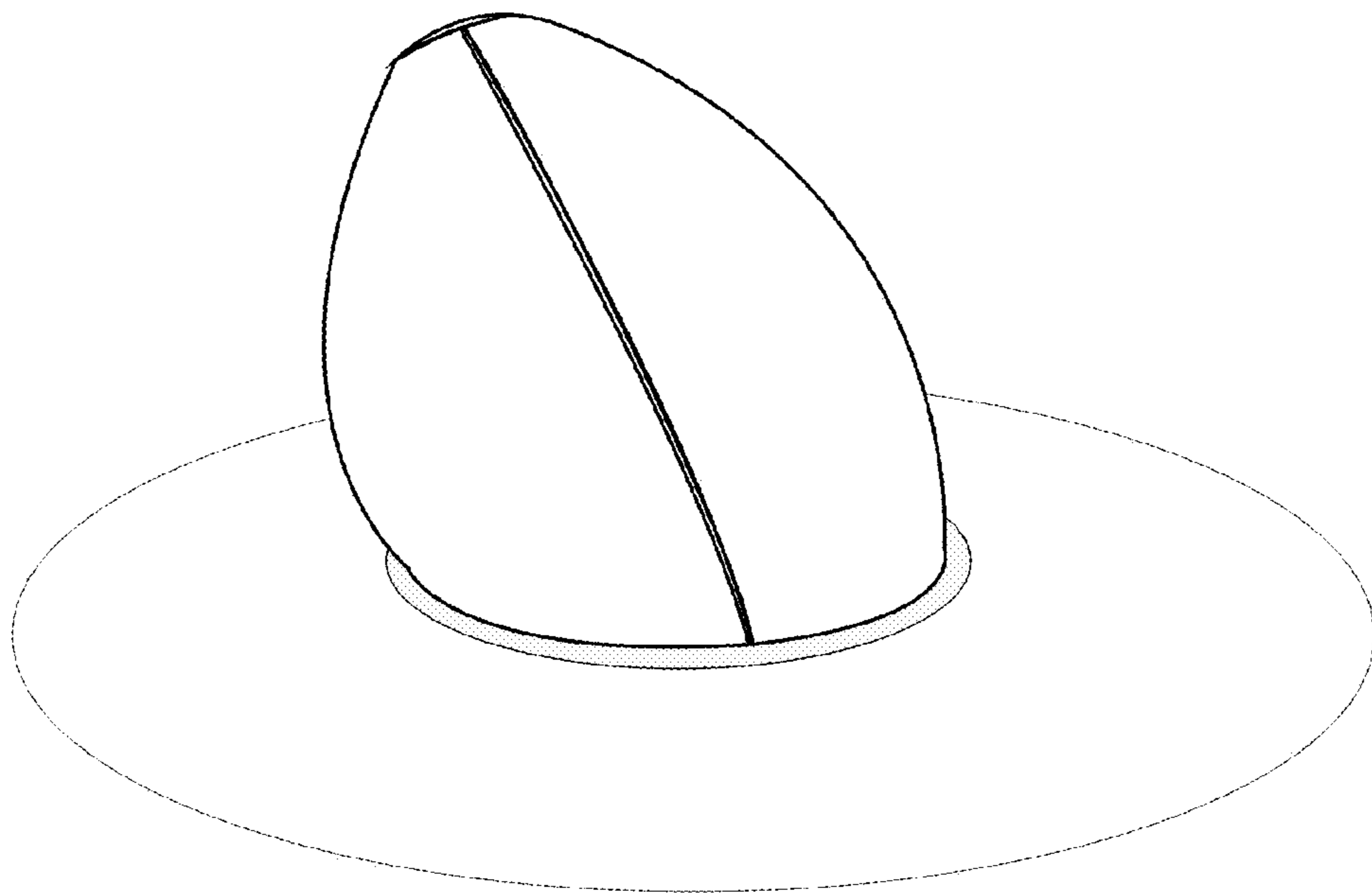

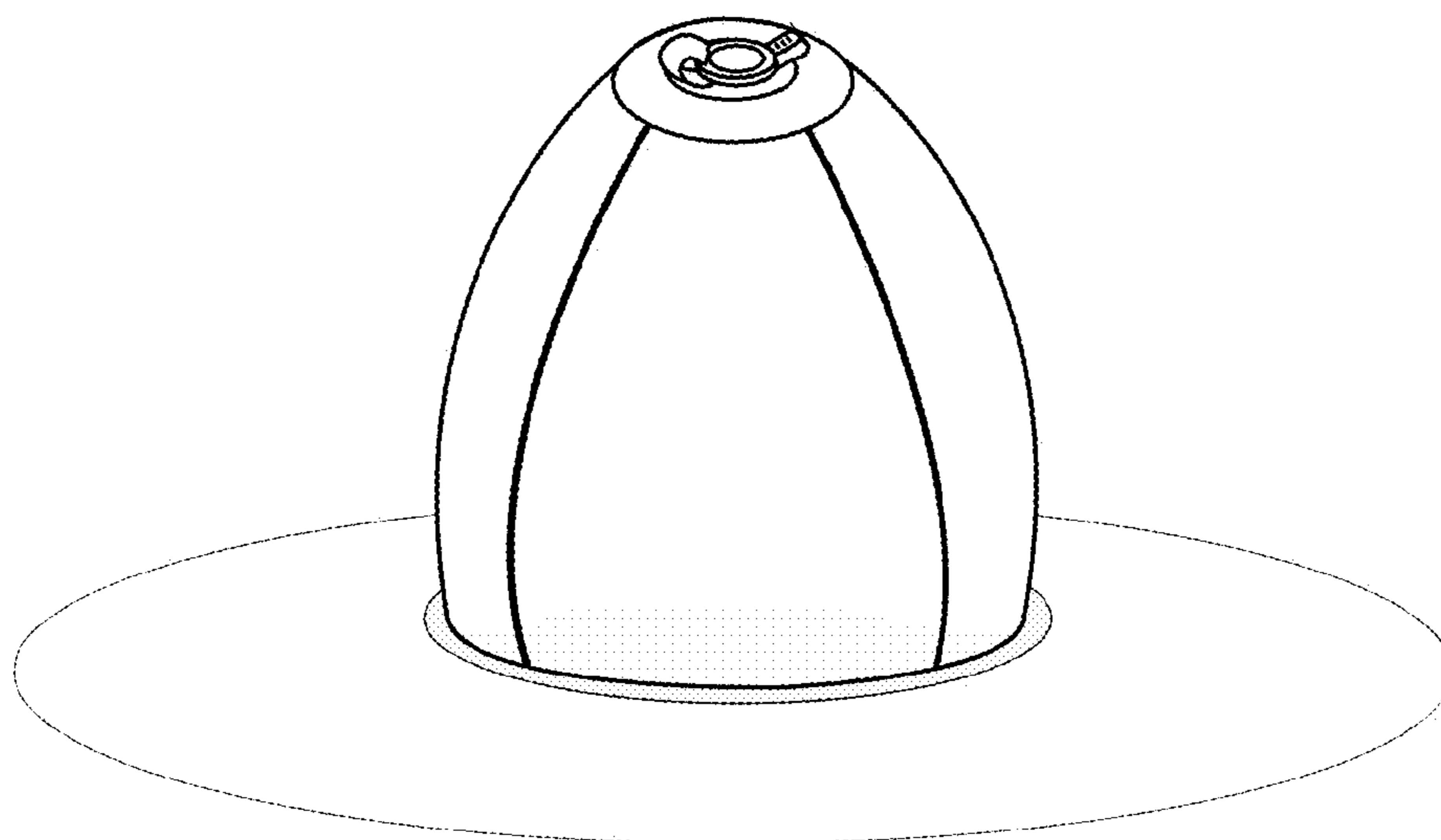
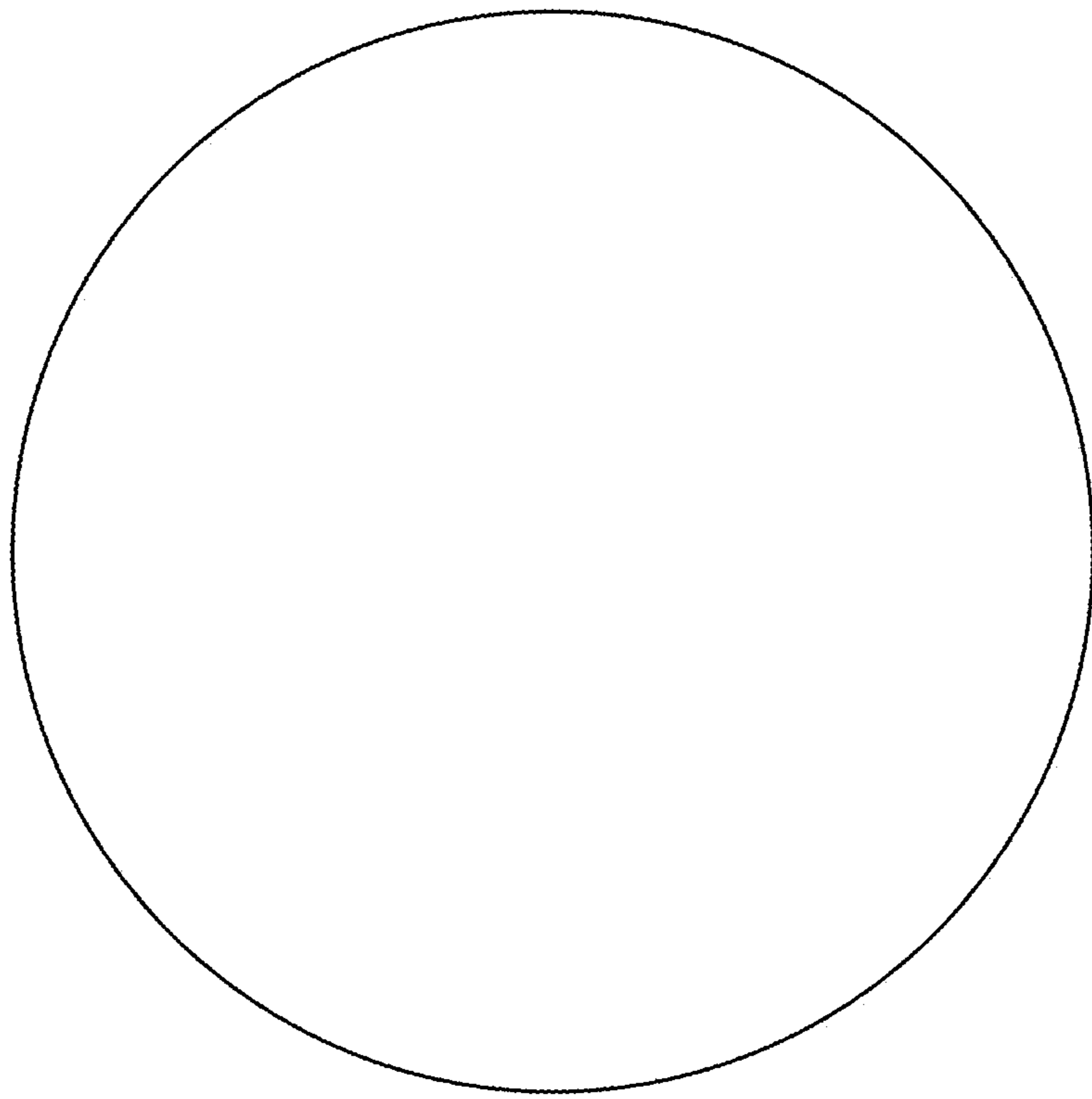

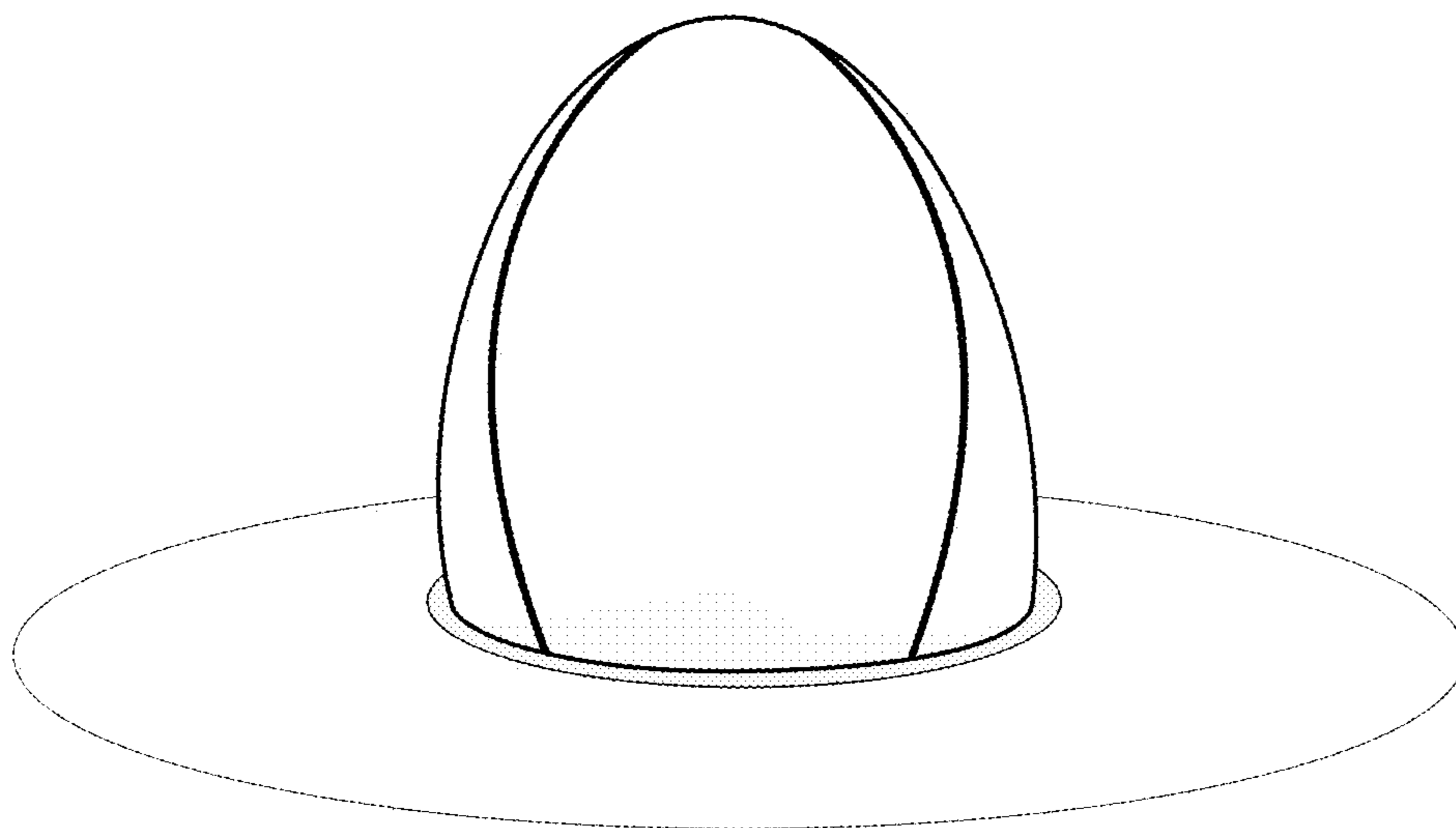

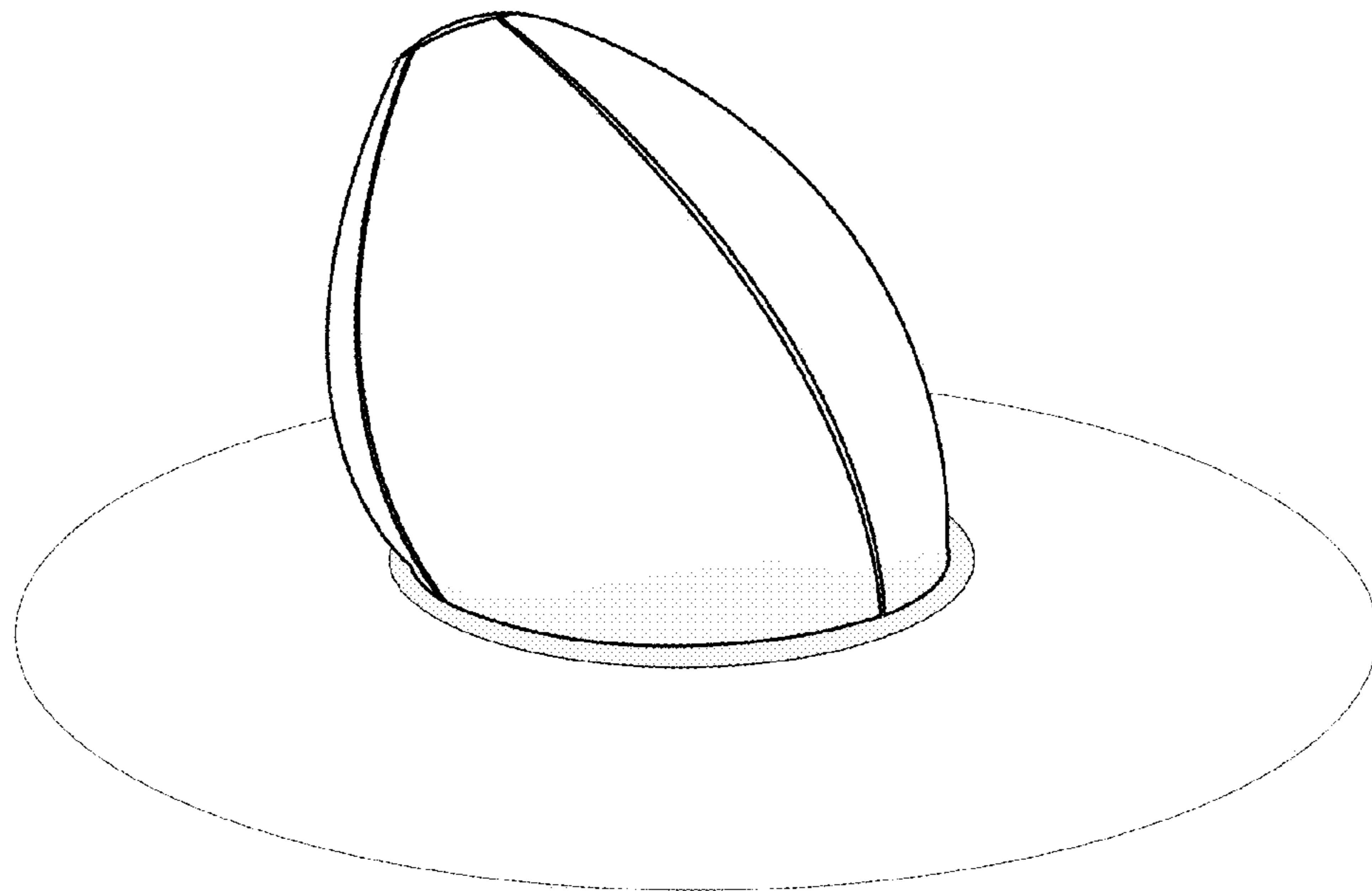

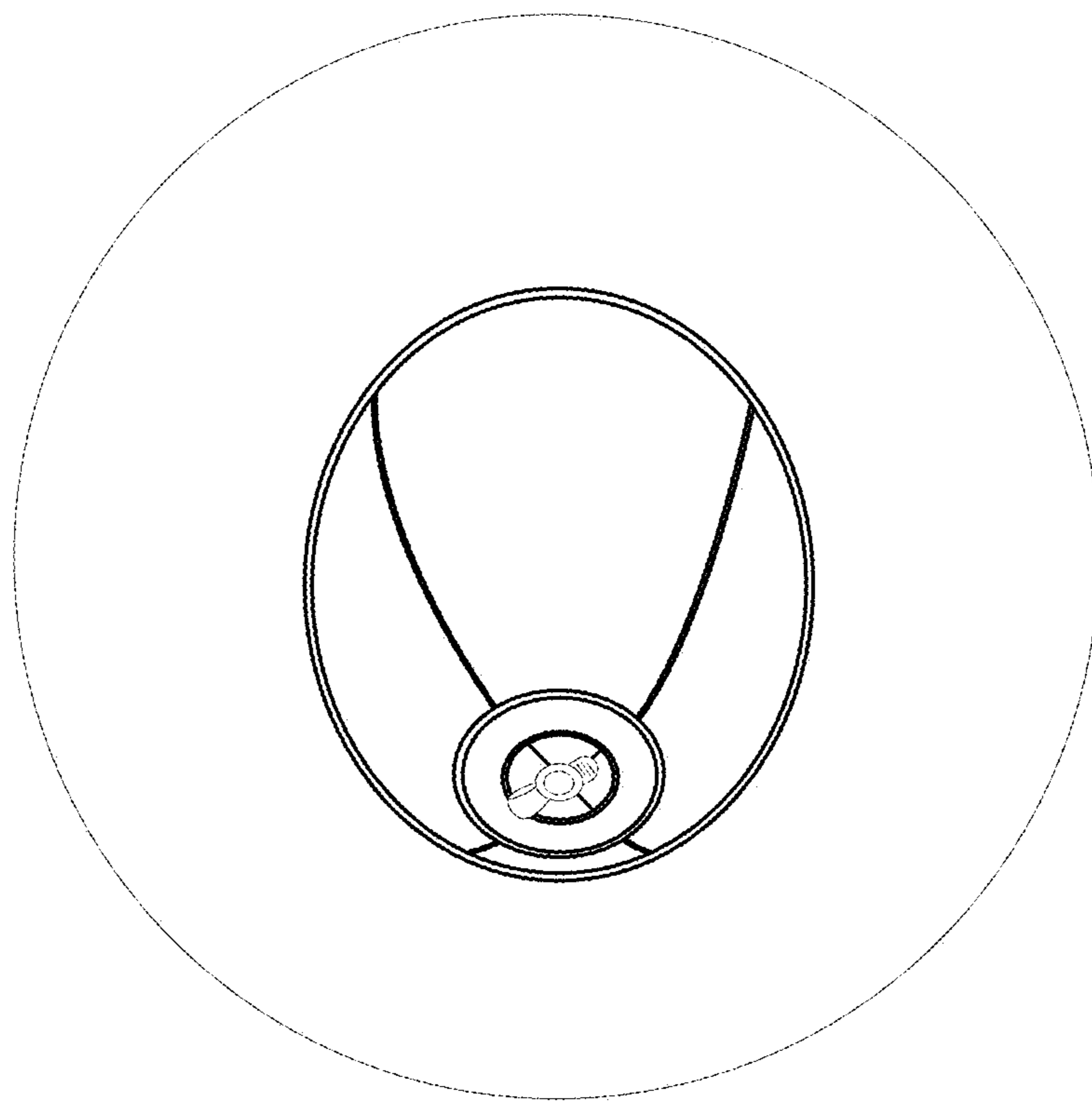
