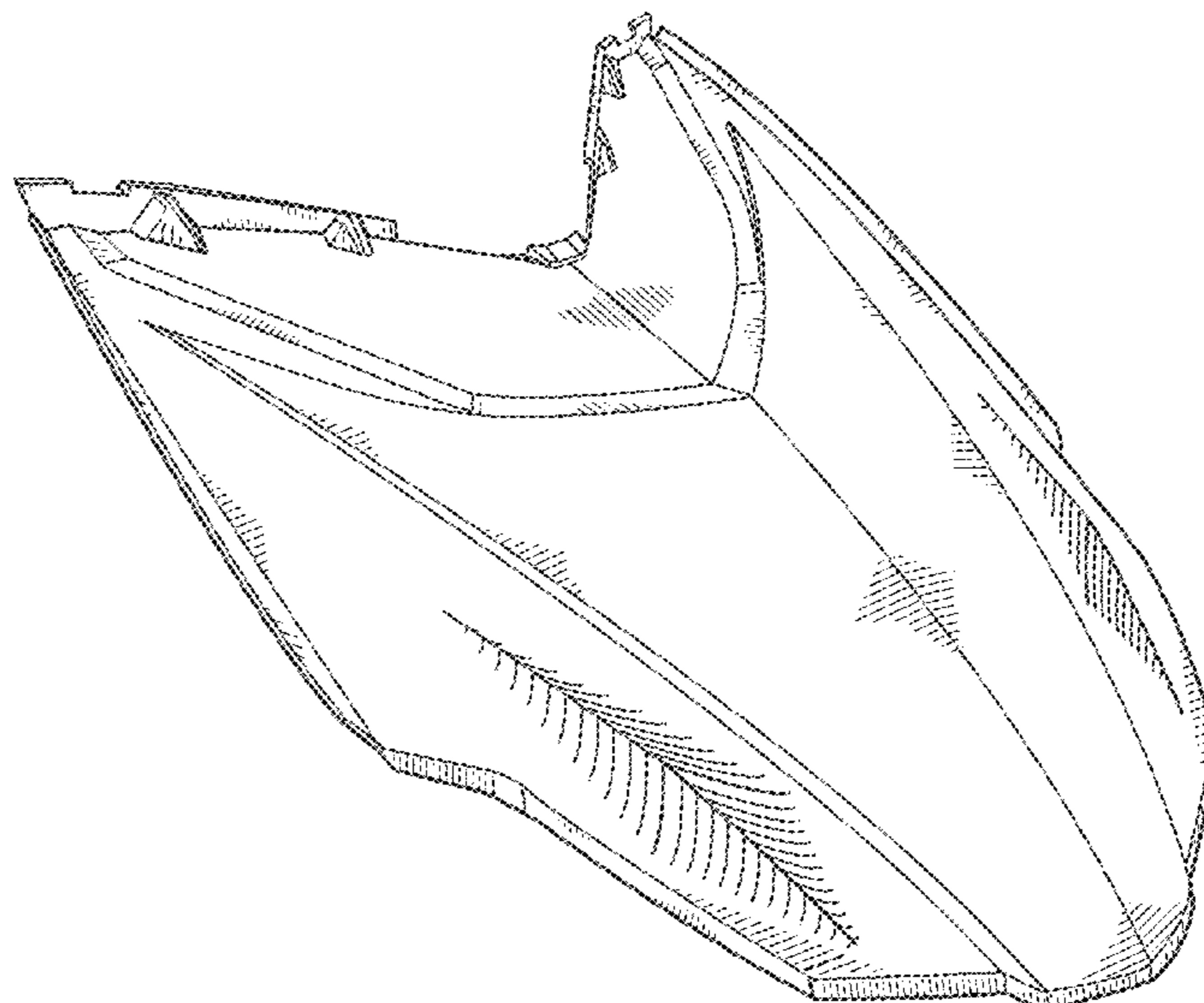
(57) **CLAIM**

The ornamental design for a snowmobile hood, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view taken from a front, right side of a snowmobile hood showing our new design; FIG. 2 is a right side elevation view thereof; FIG. 3 is a front elevation view thereof; FIG. 4 is a left side elevation view thereof; FIG. 5 is a rear elevation view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; and, FIG. 8 is a perspective view taken from a front, right side thereof shown on a snowmobile shown in dashed lines. Throughout the Figures, where shown: (i) the dashed lines showing additional structure of the snowmobile hood are for illustrative purposes only and form no part of the claimed design; and (ii) the unshaded surfaces bound by dash-dot lines form no part of the claimed design.

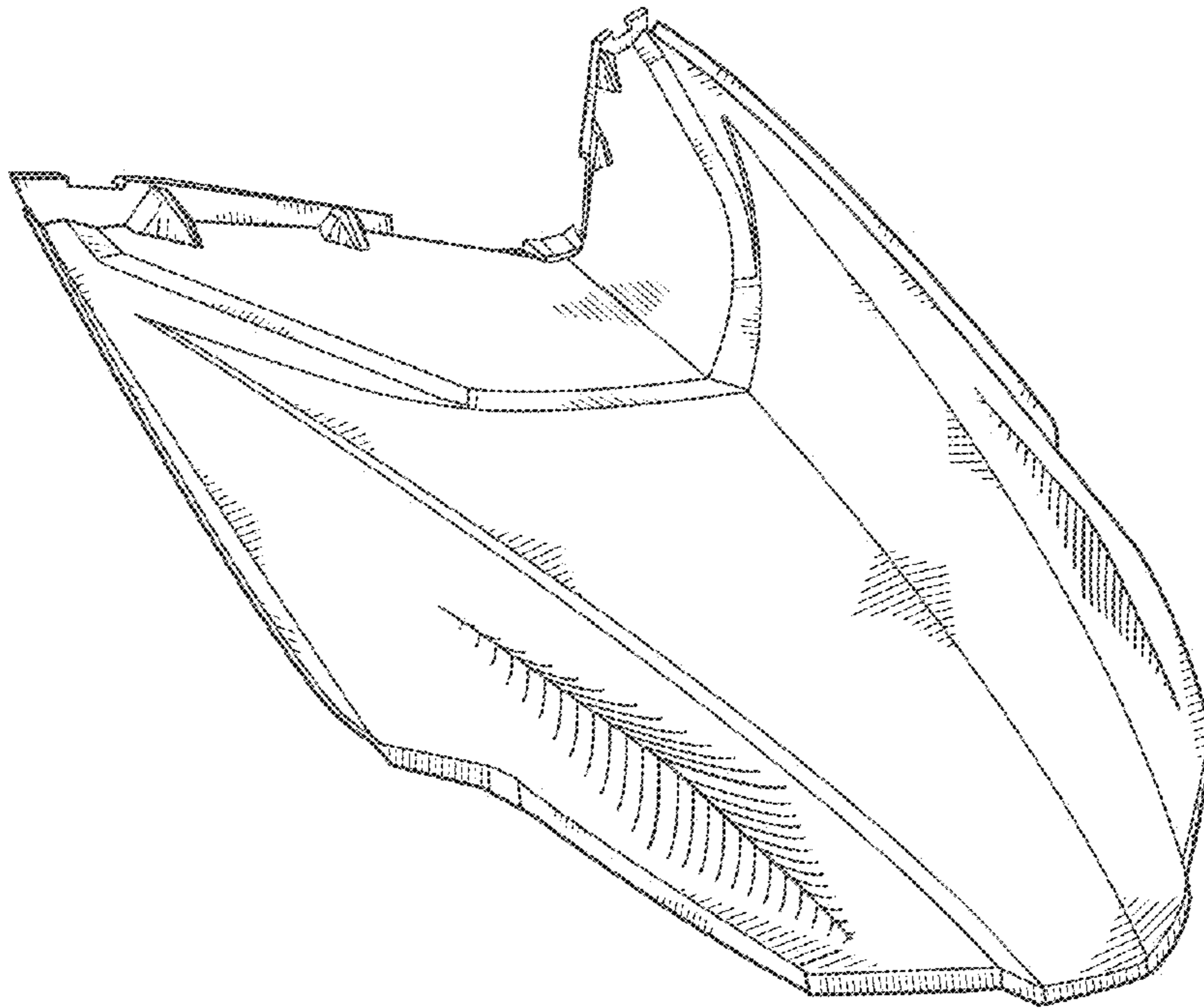

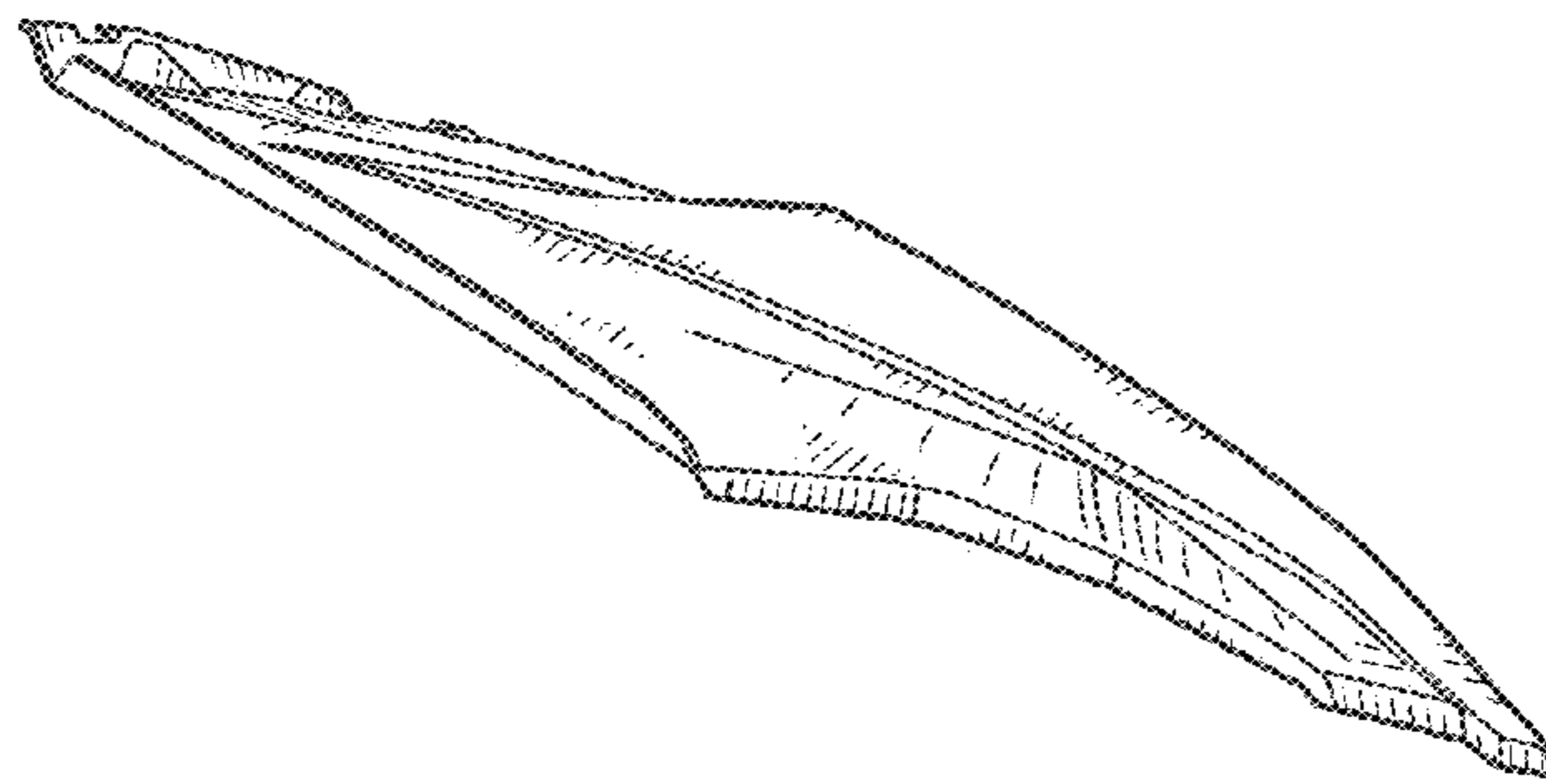

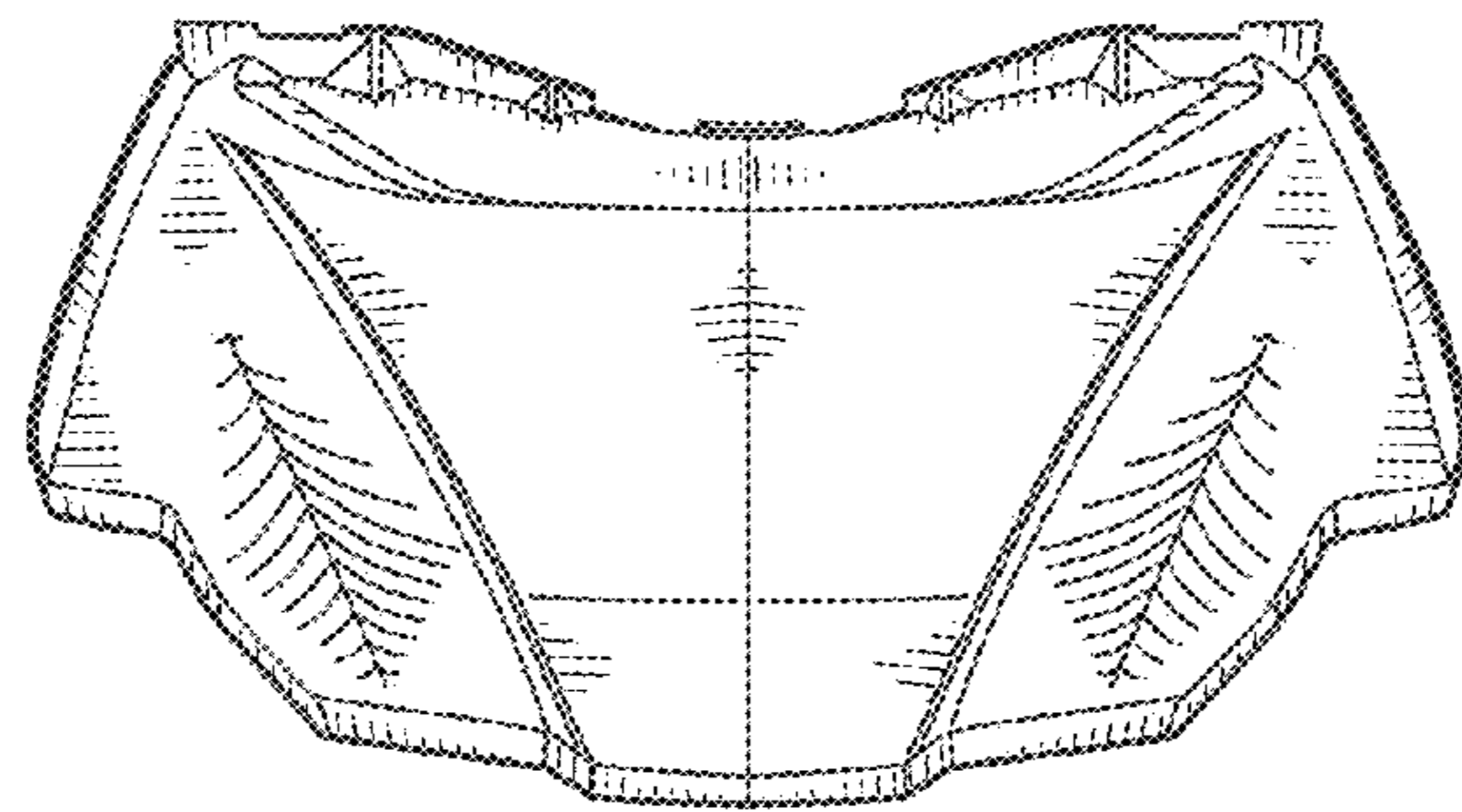

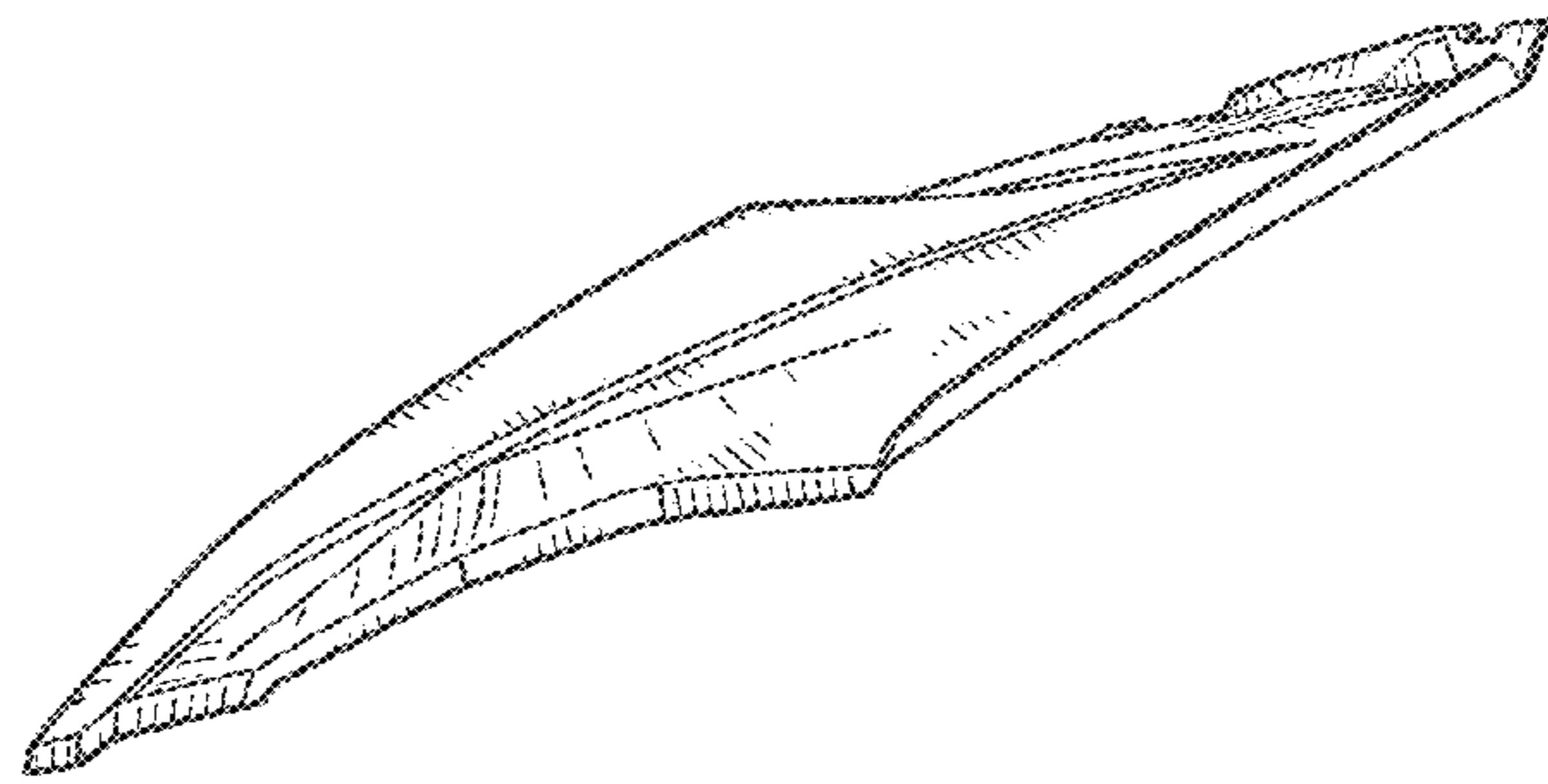

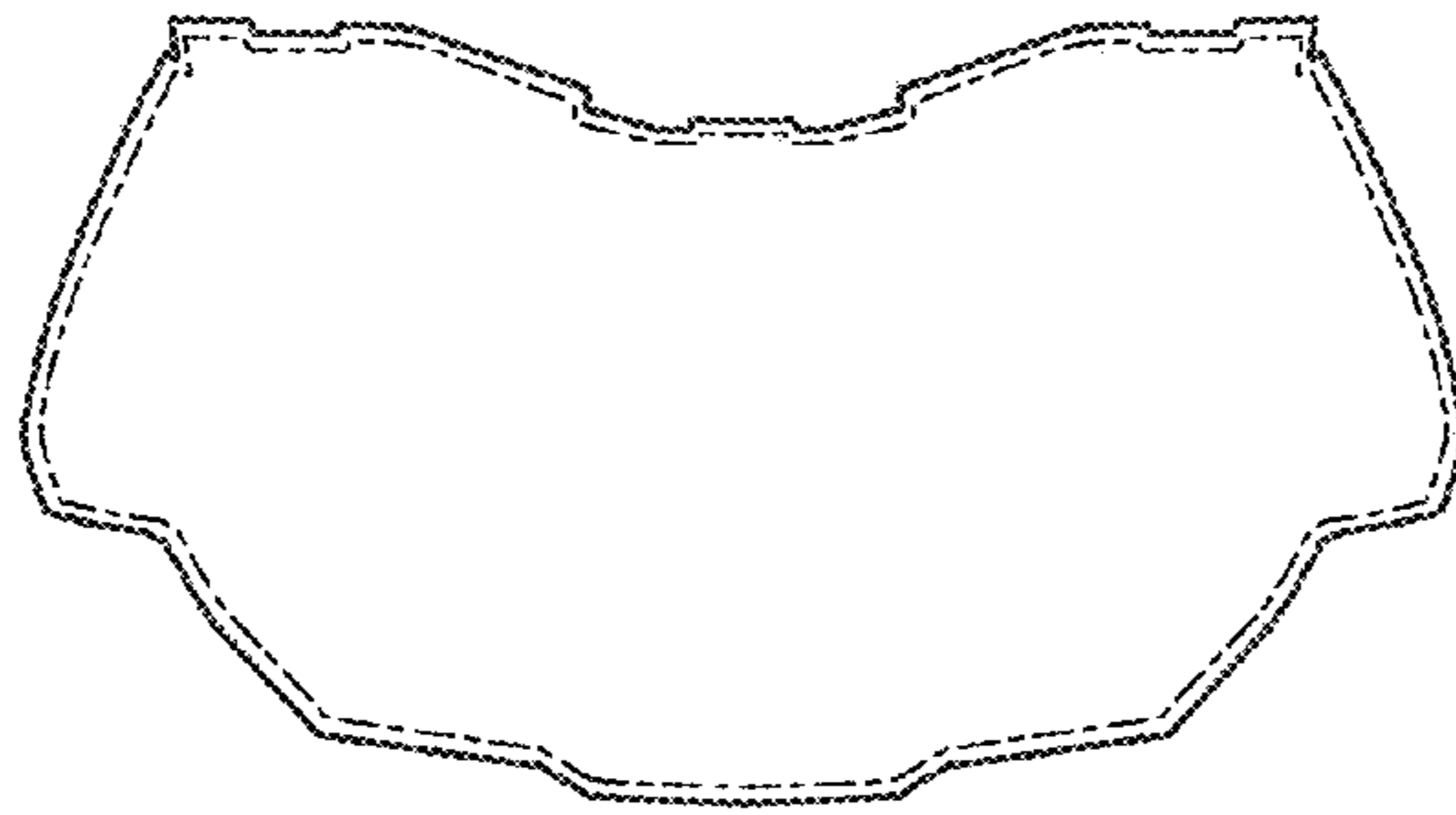

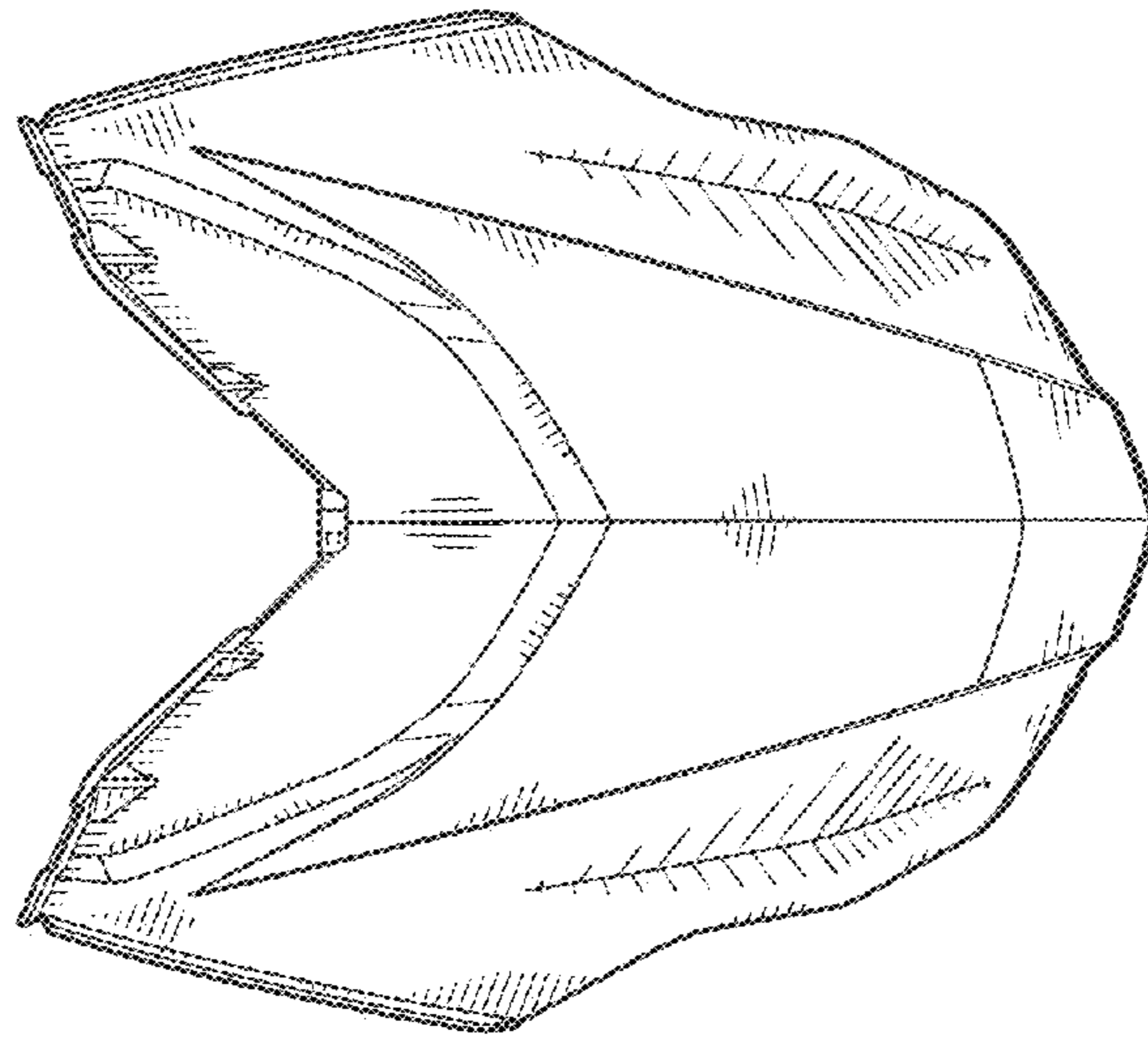

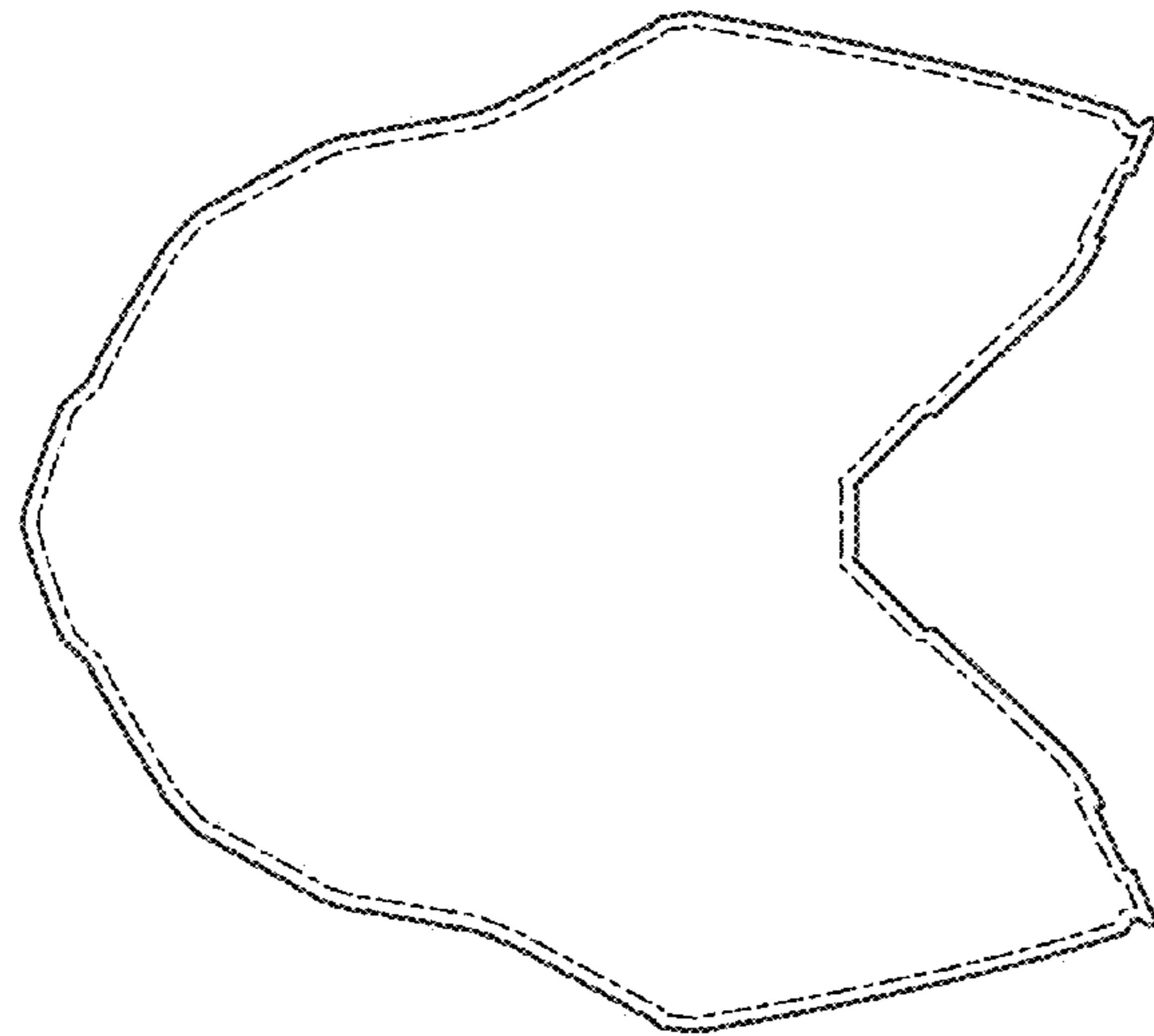

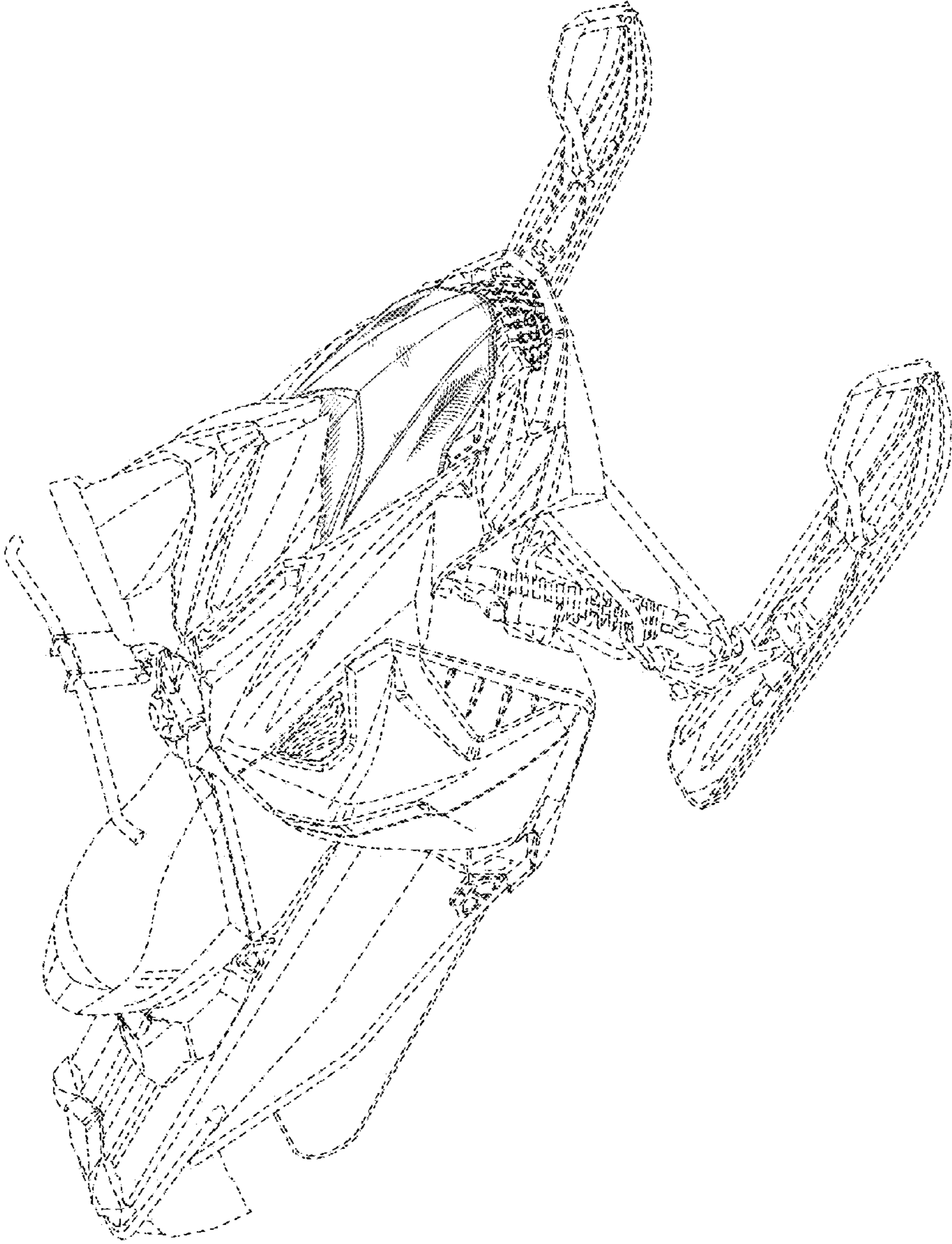
