FIG. 21 is a left side elevation view thereof;

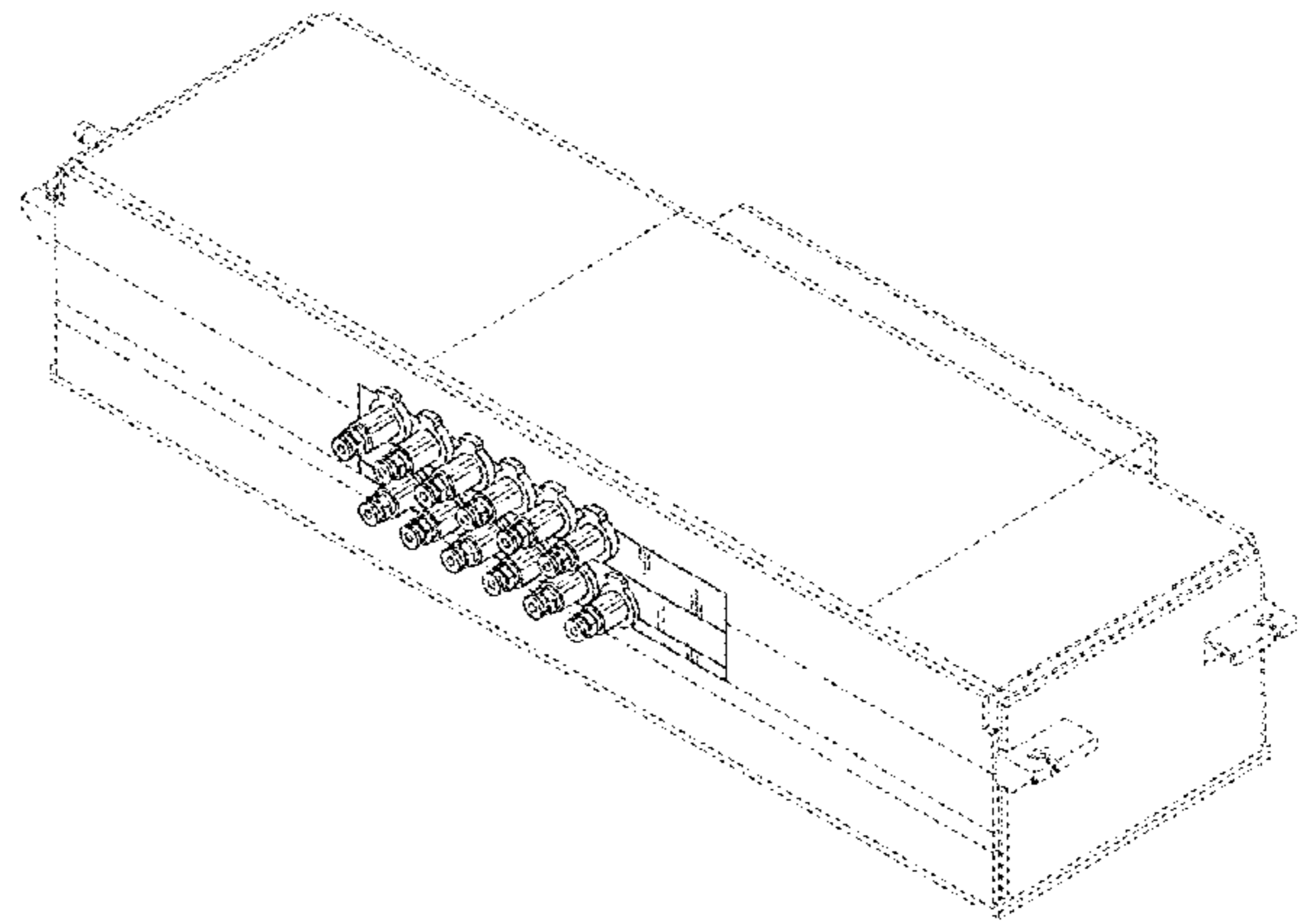
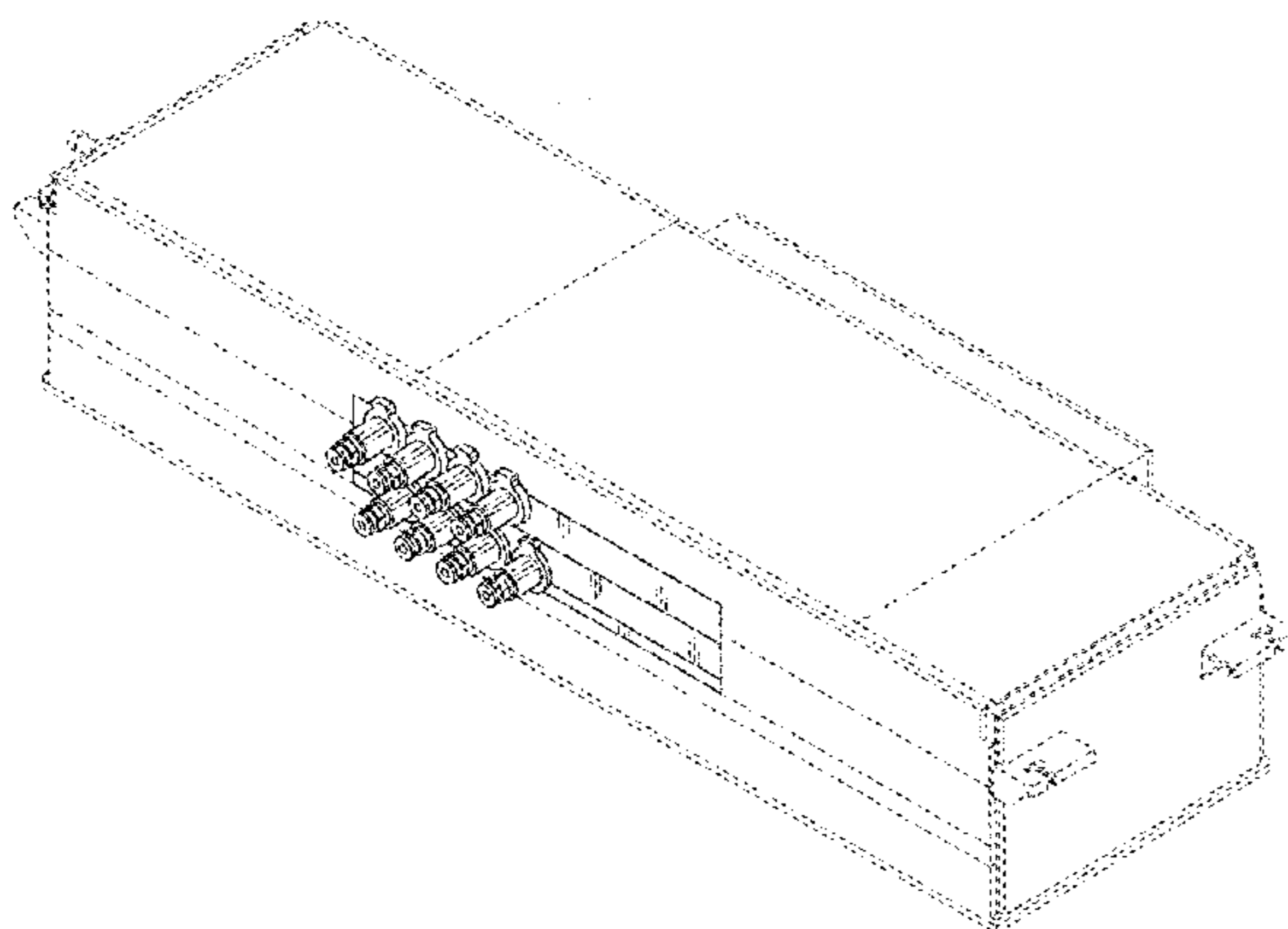
FIG. 22 is a right side elevation view thereof;

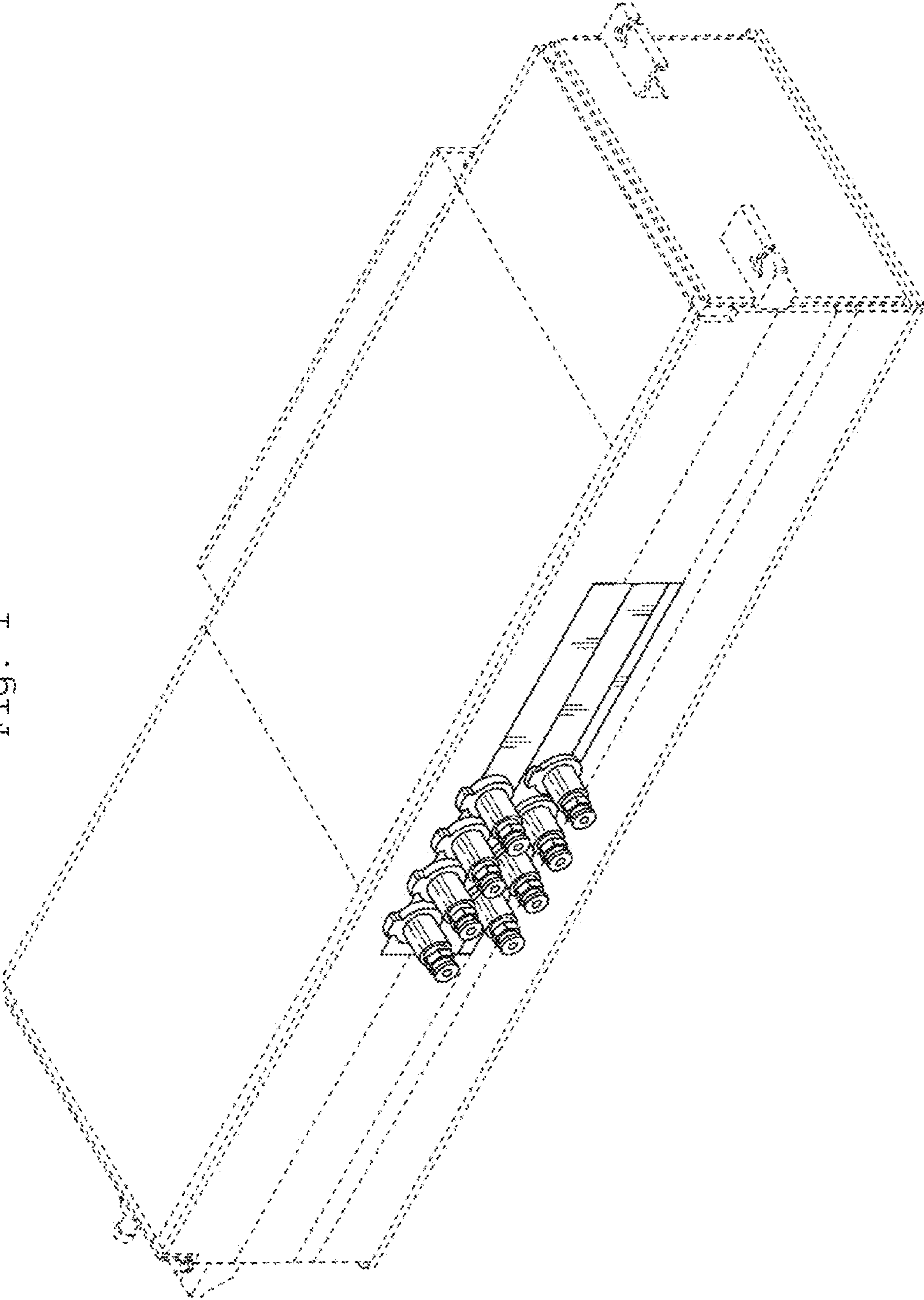

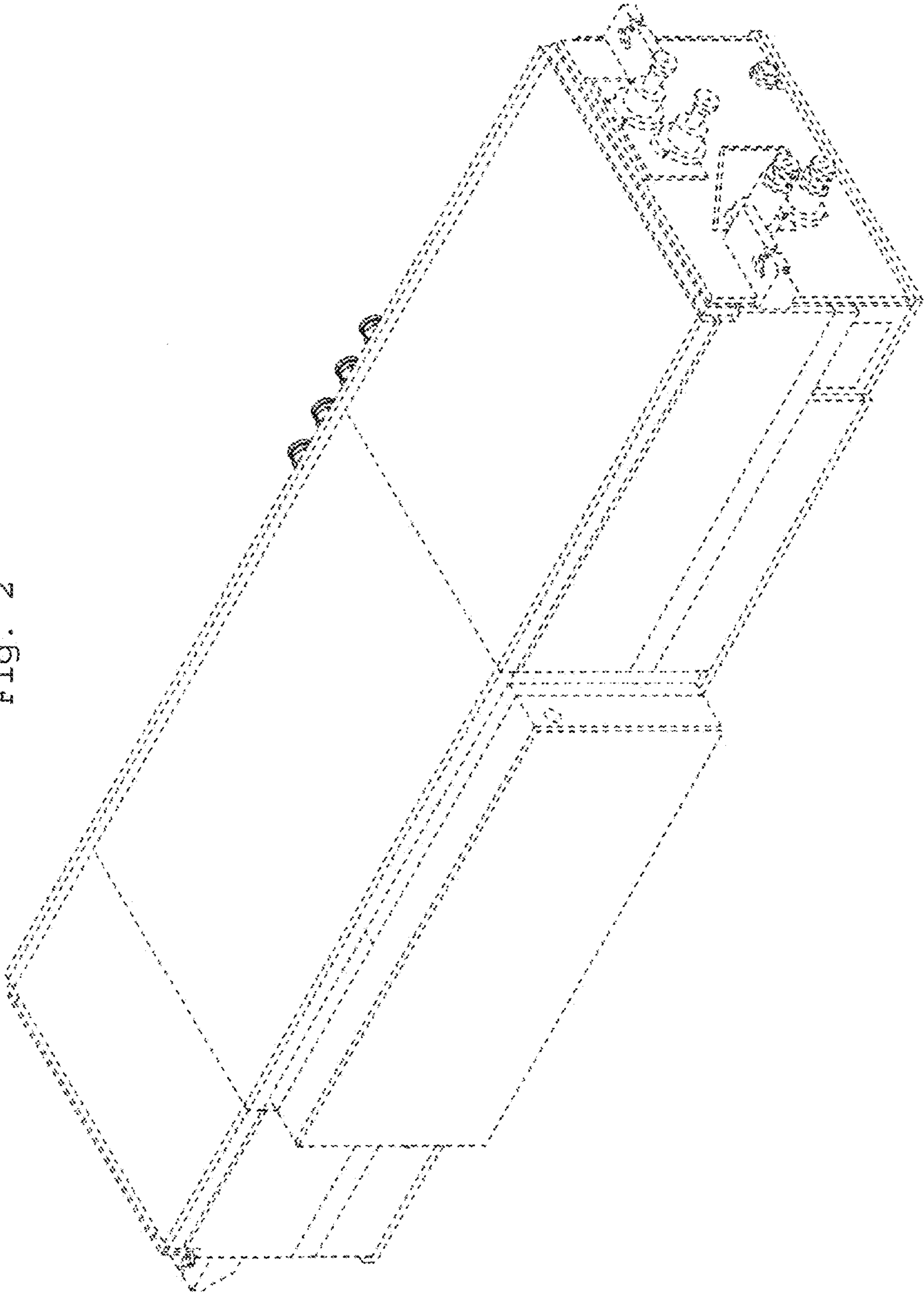

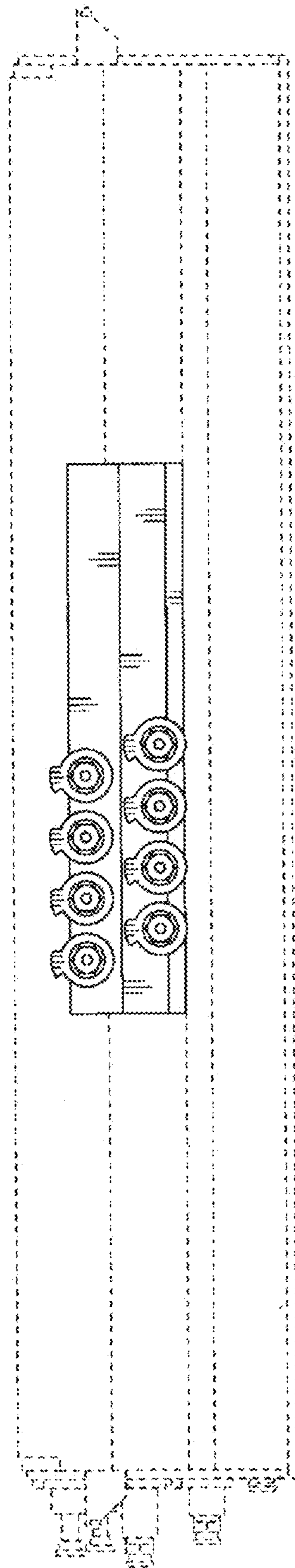

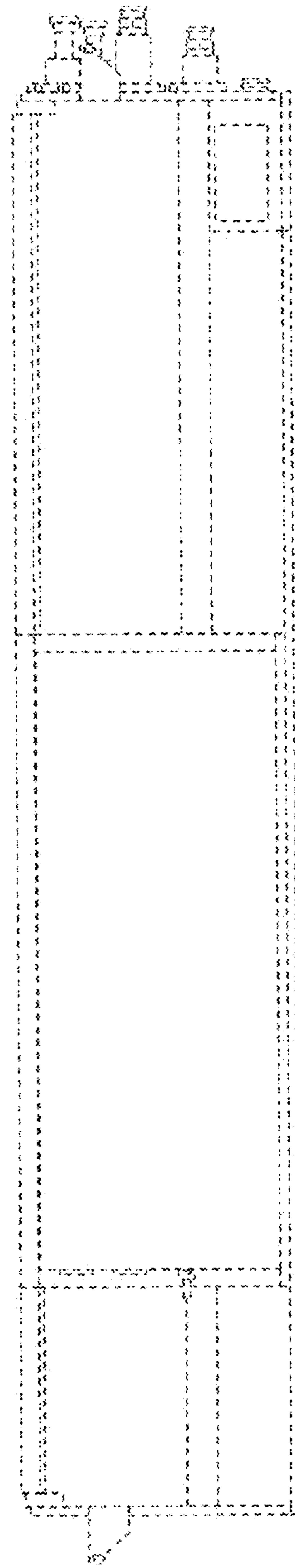

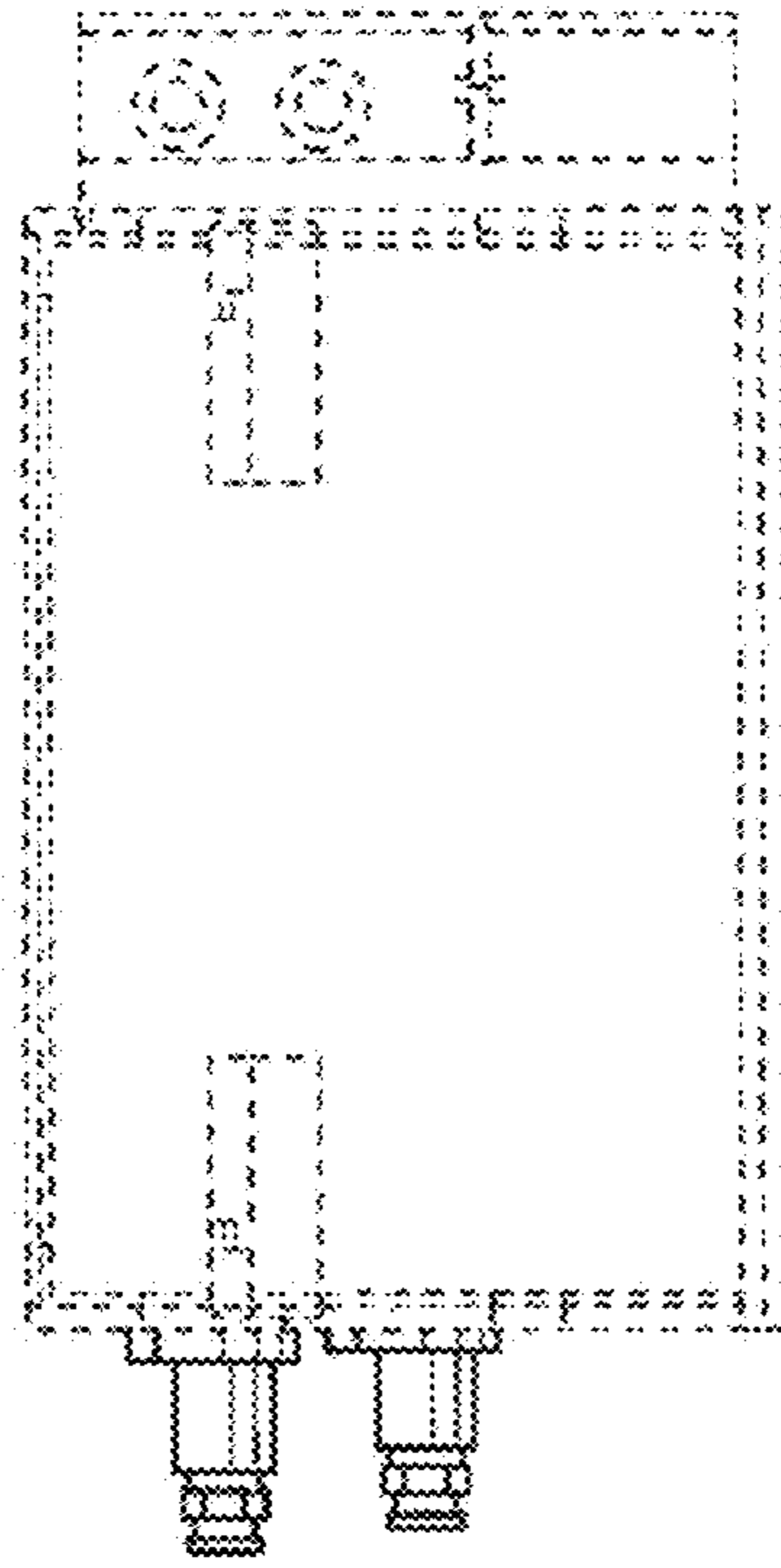

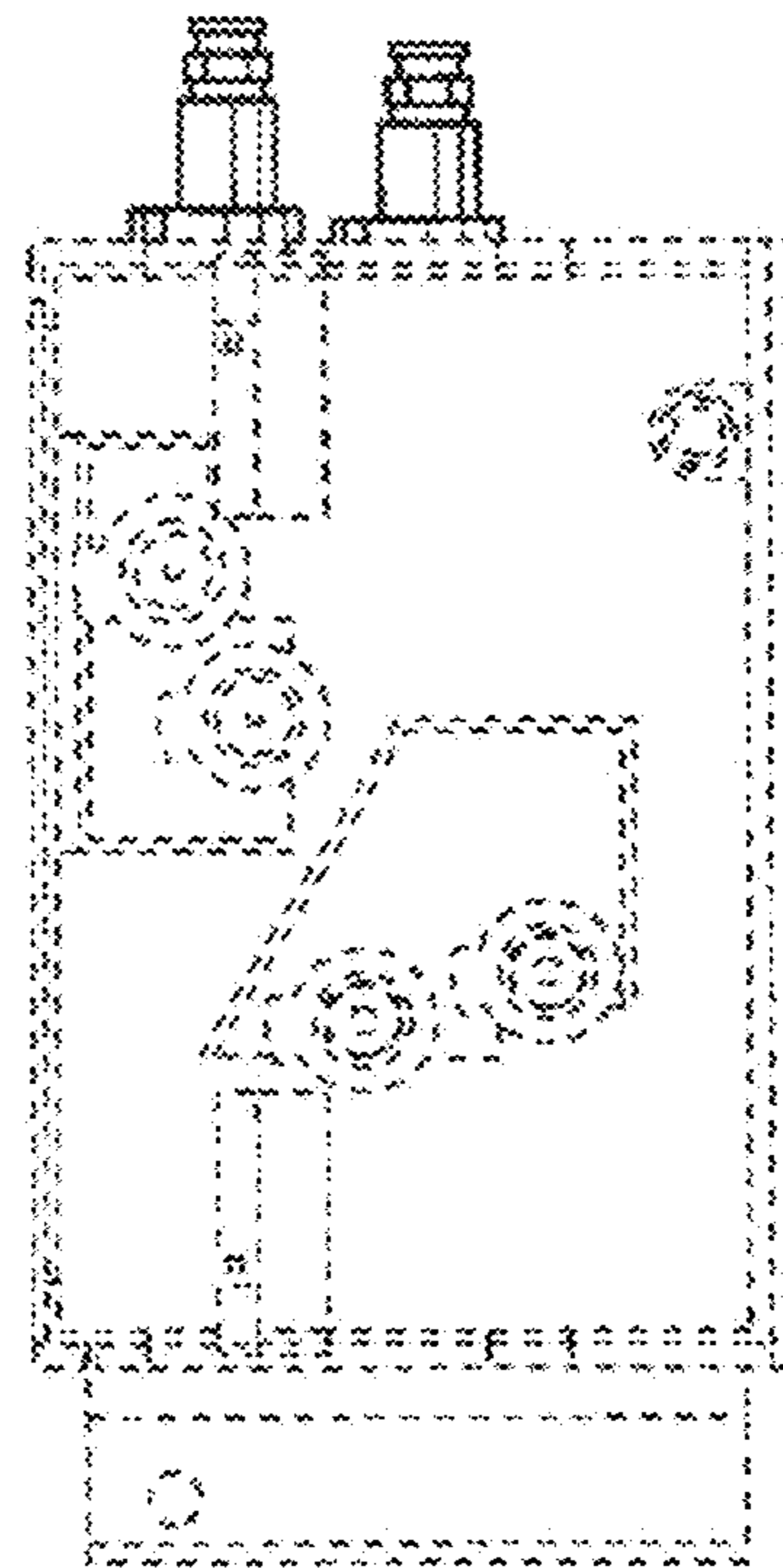

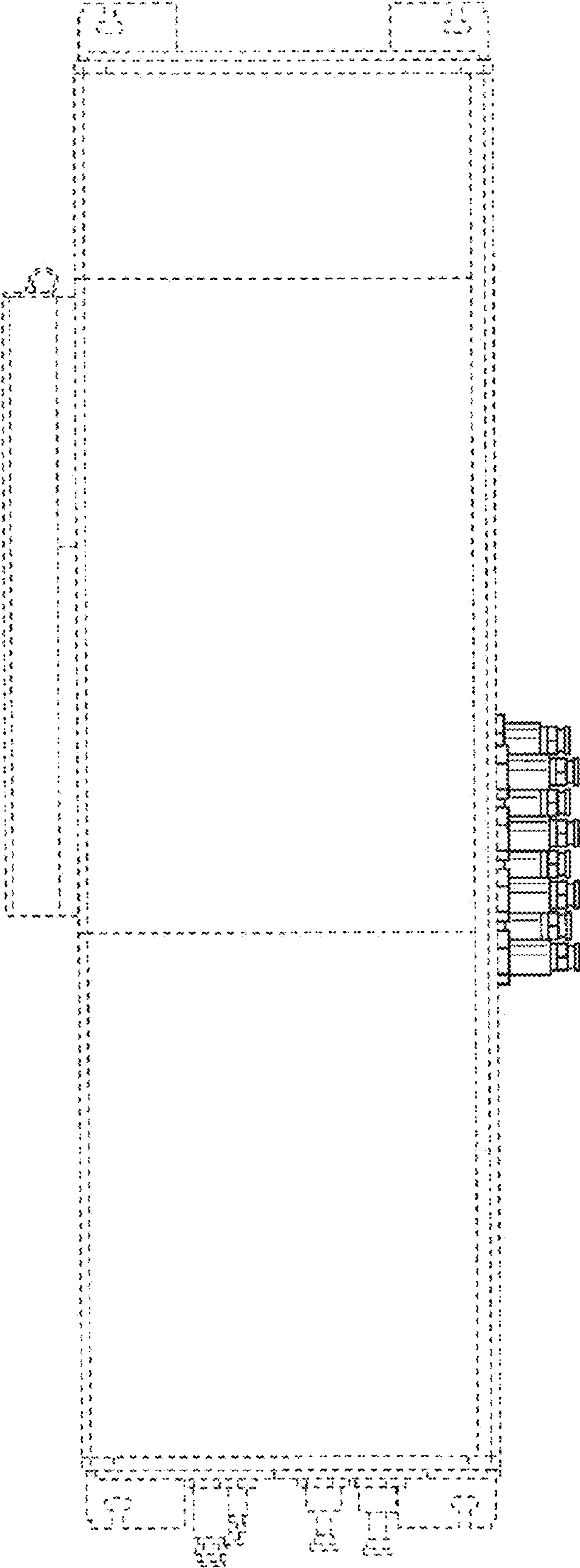

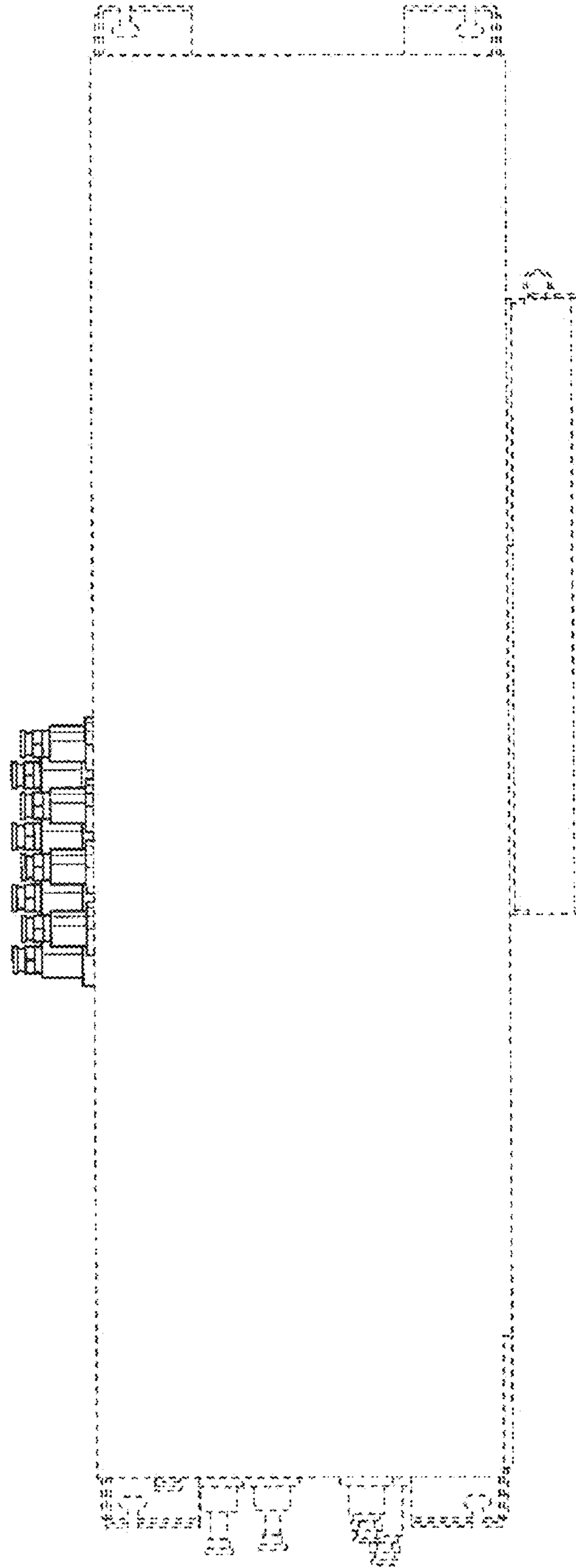

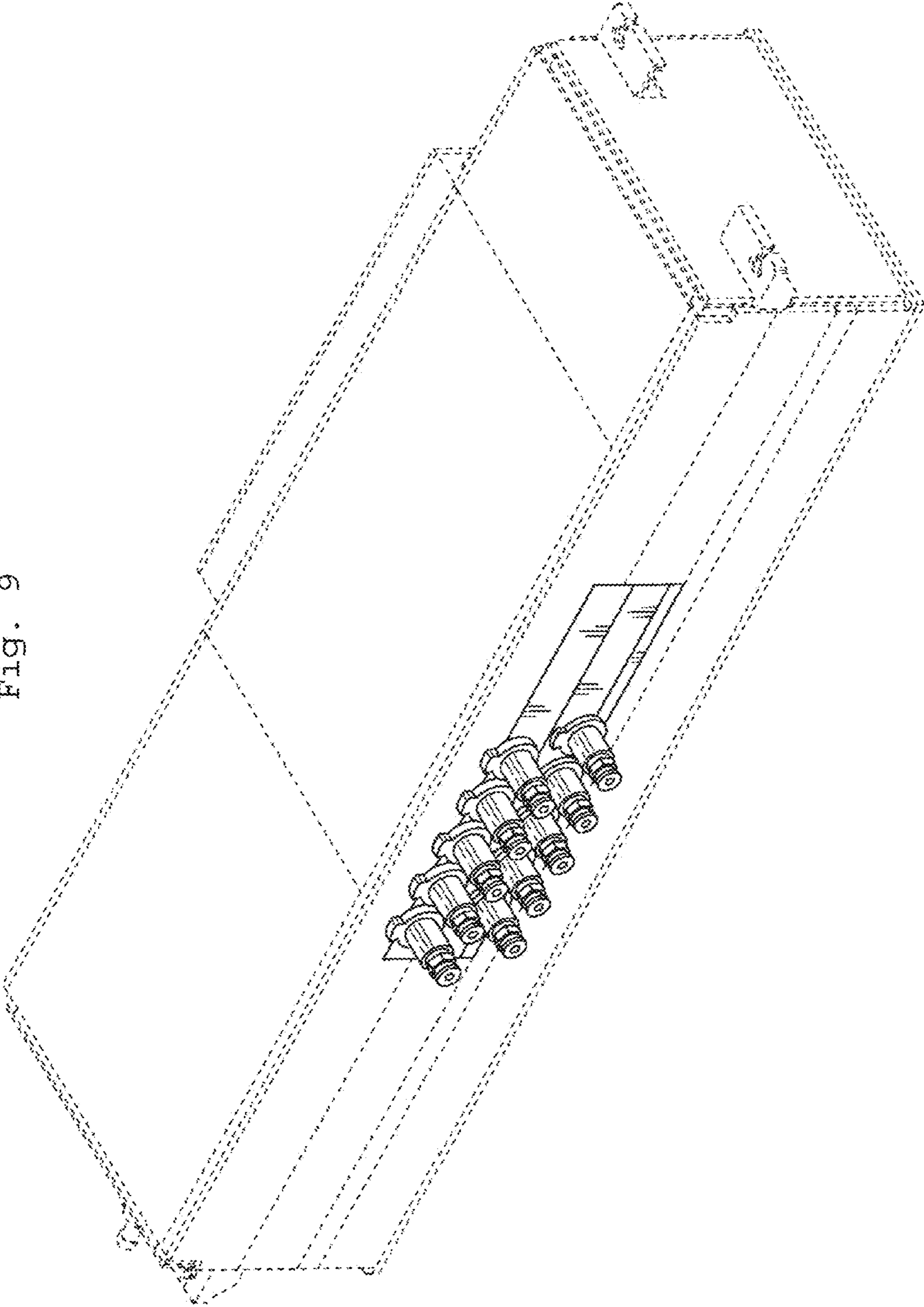

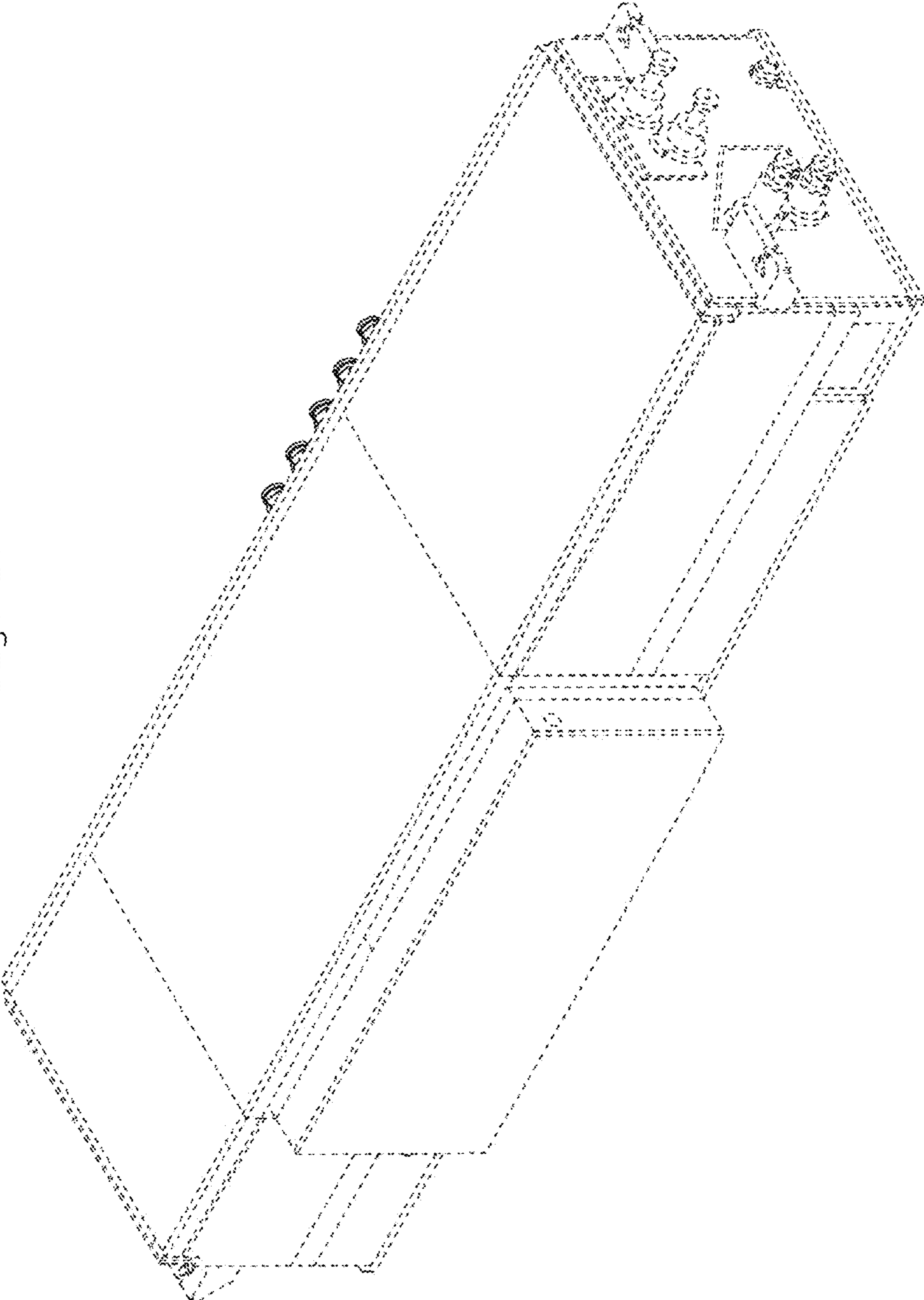

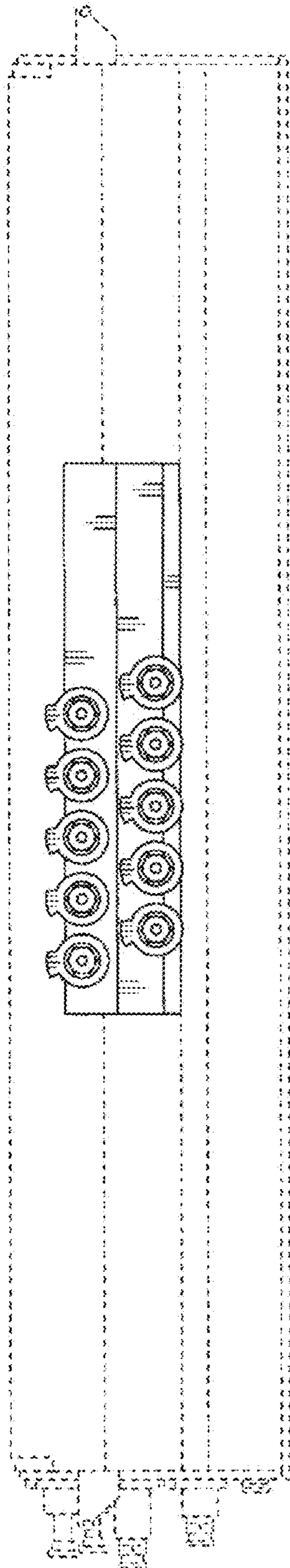

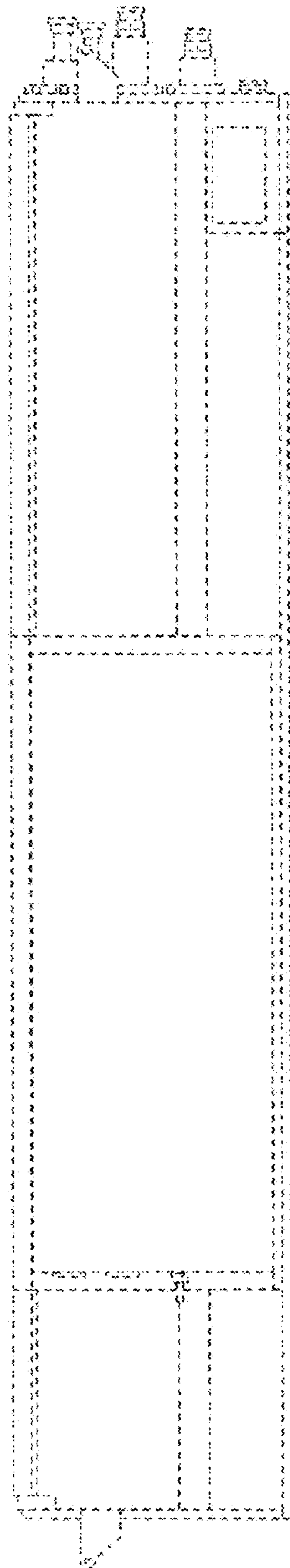

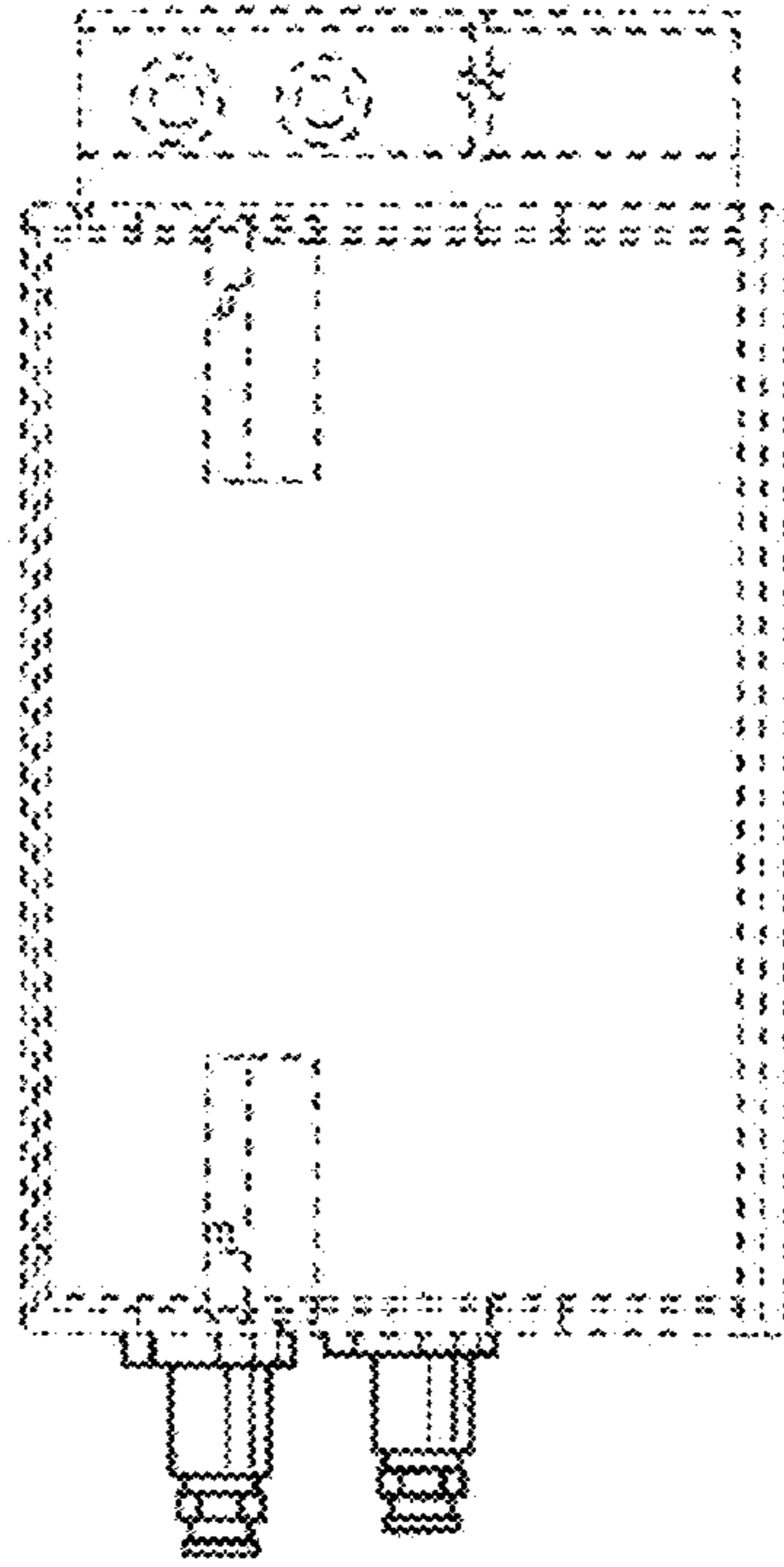

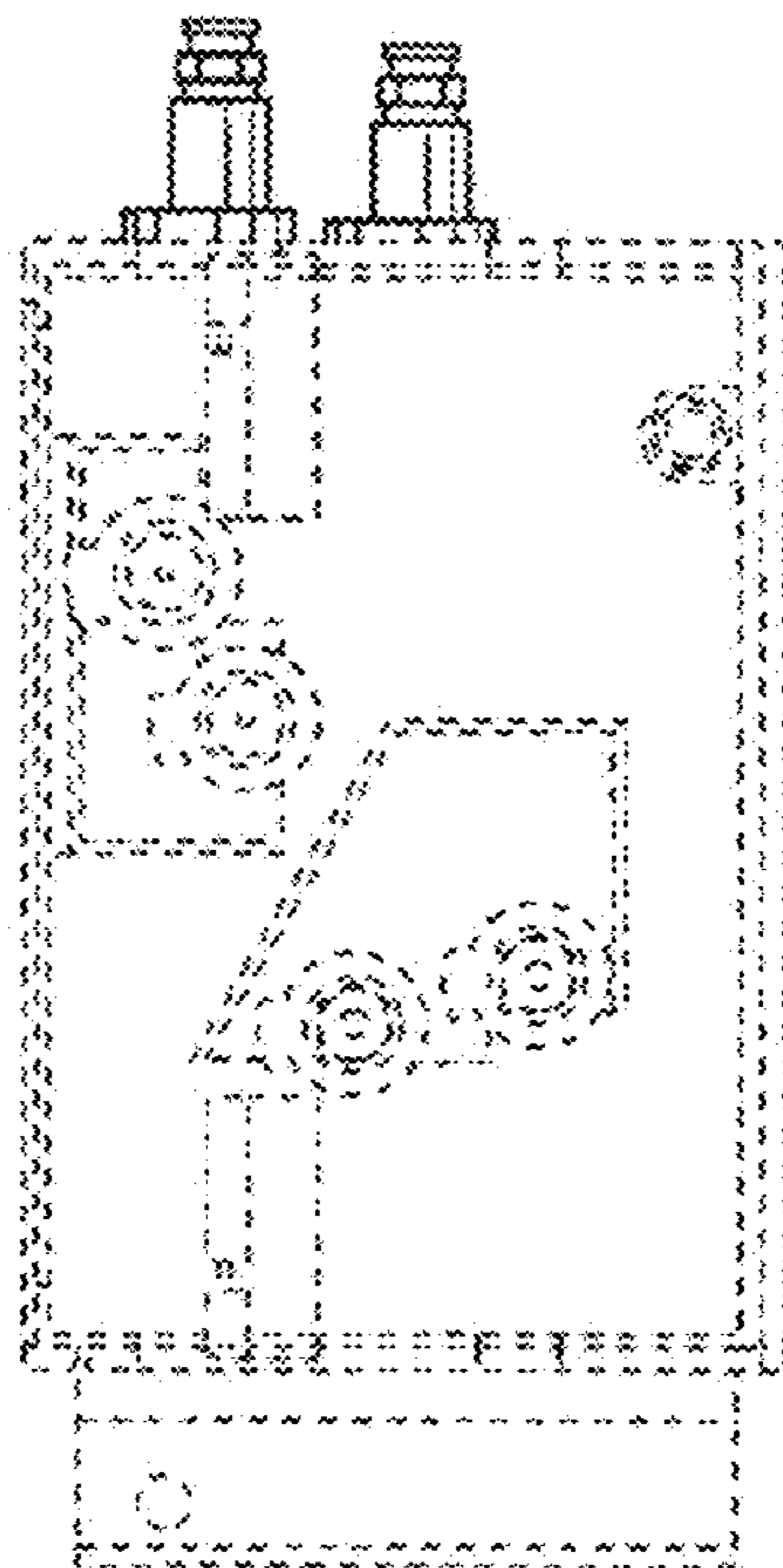

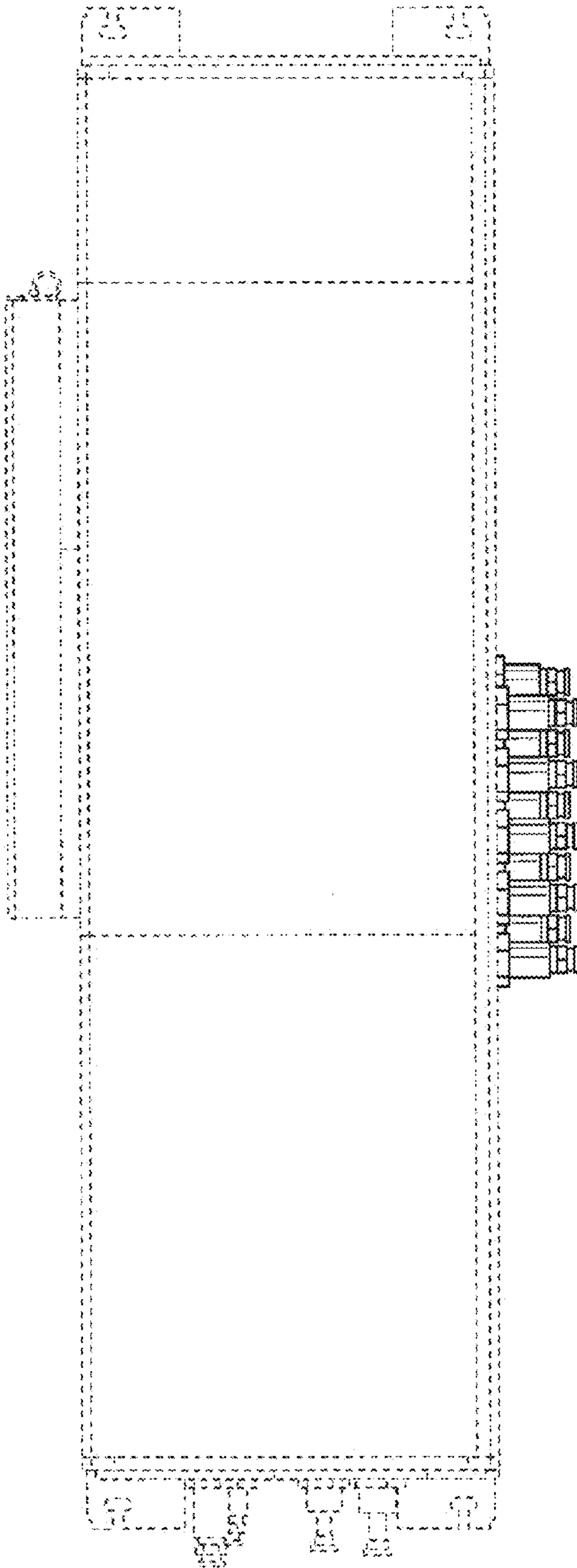

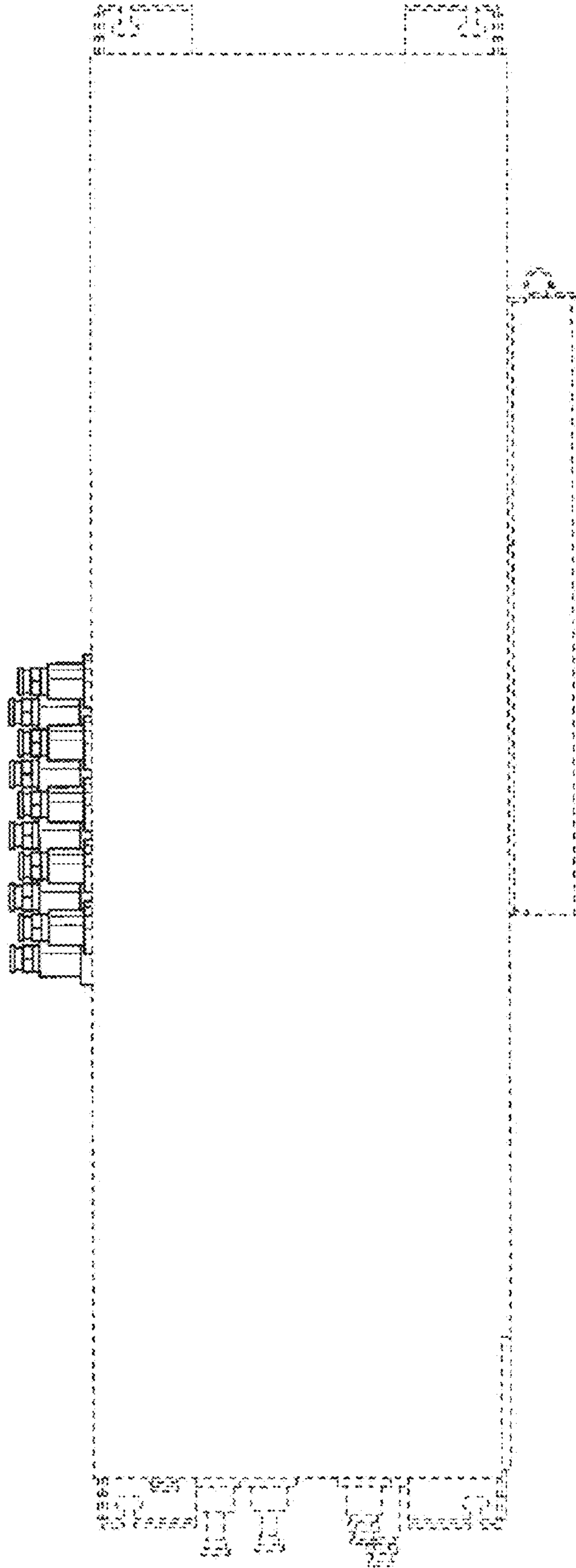

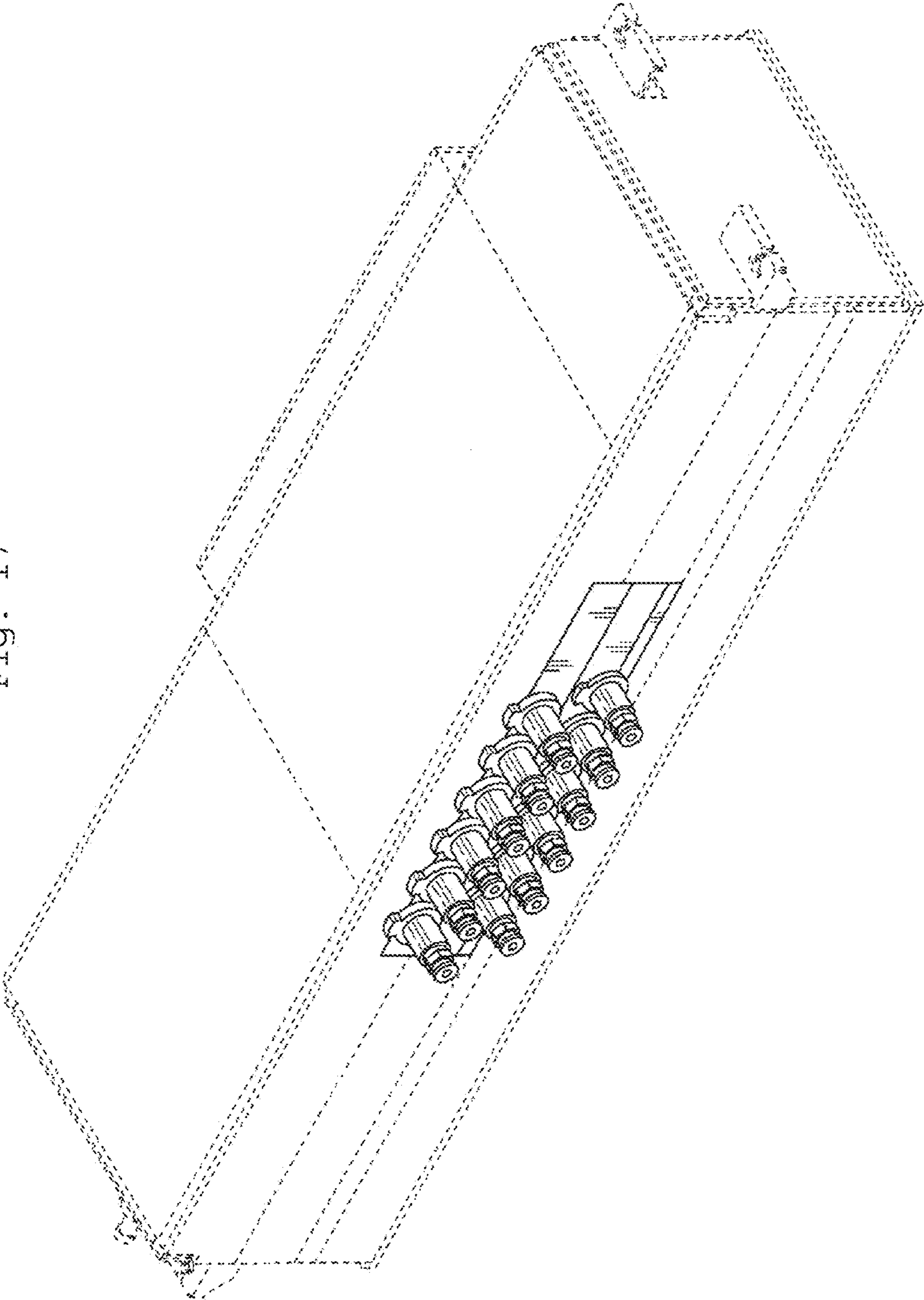

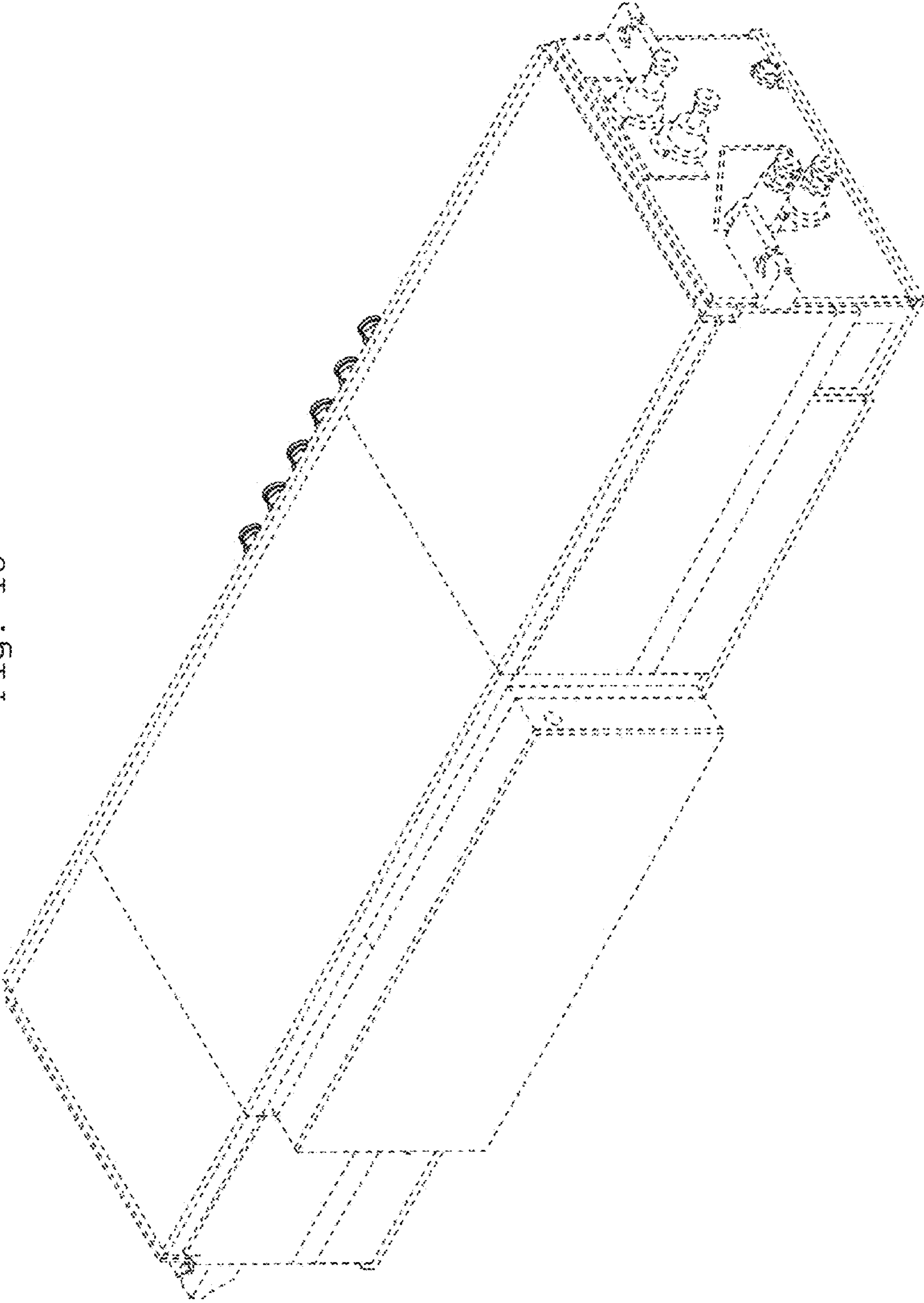

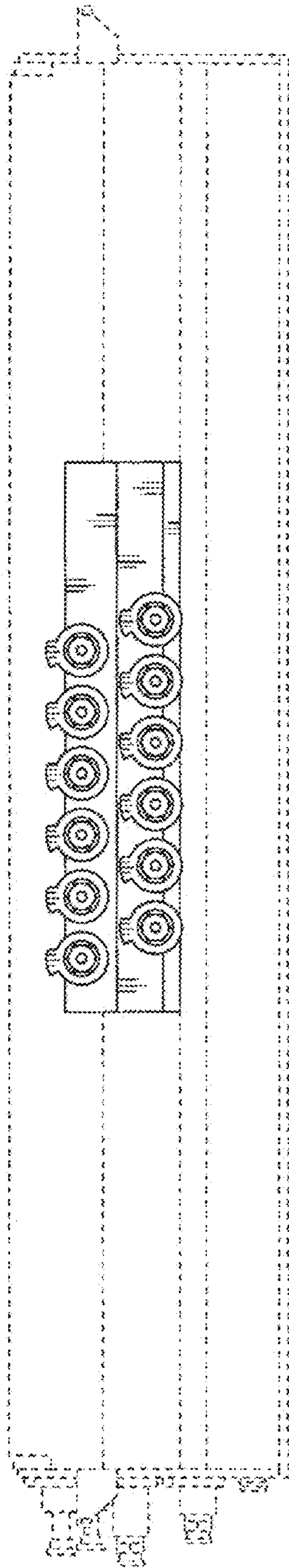

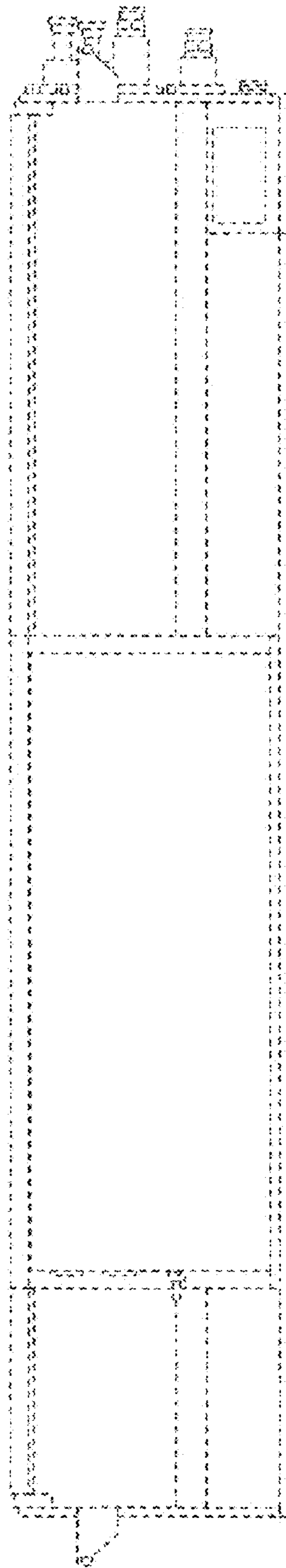

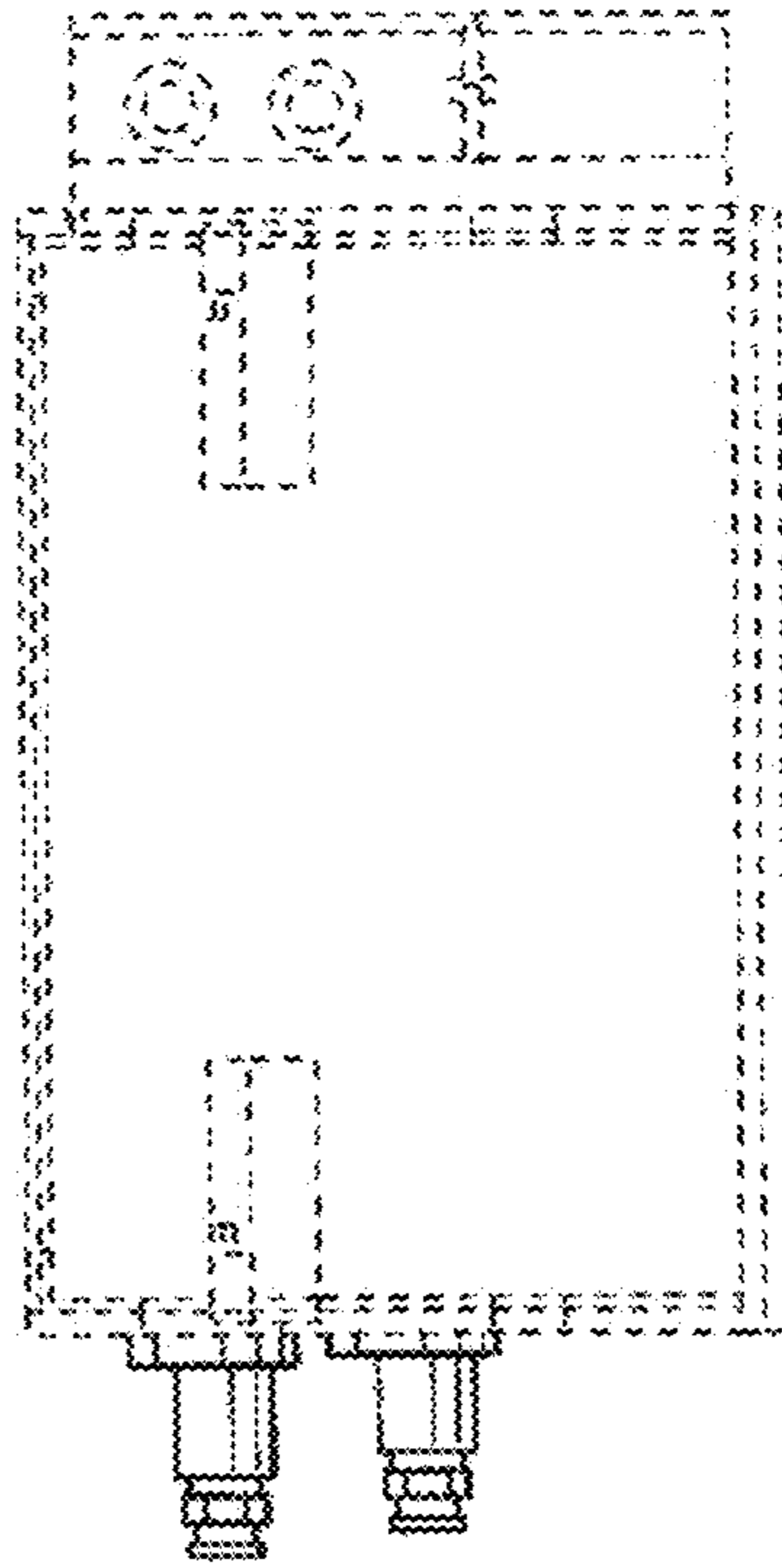

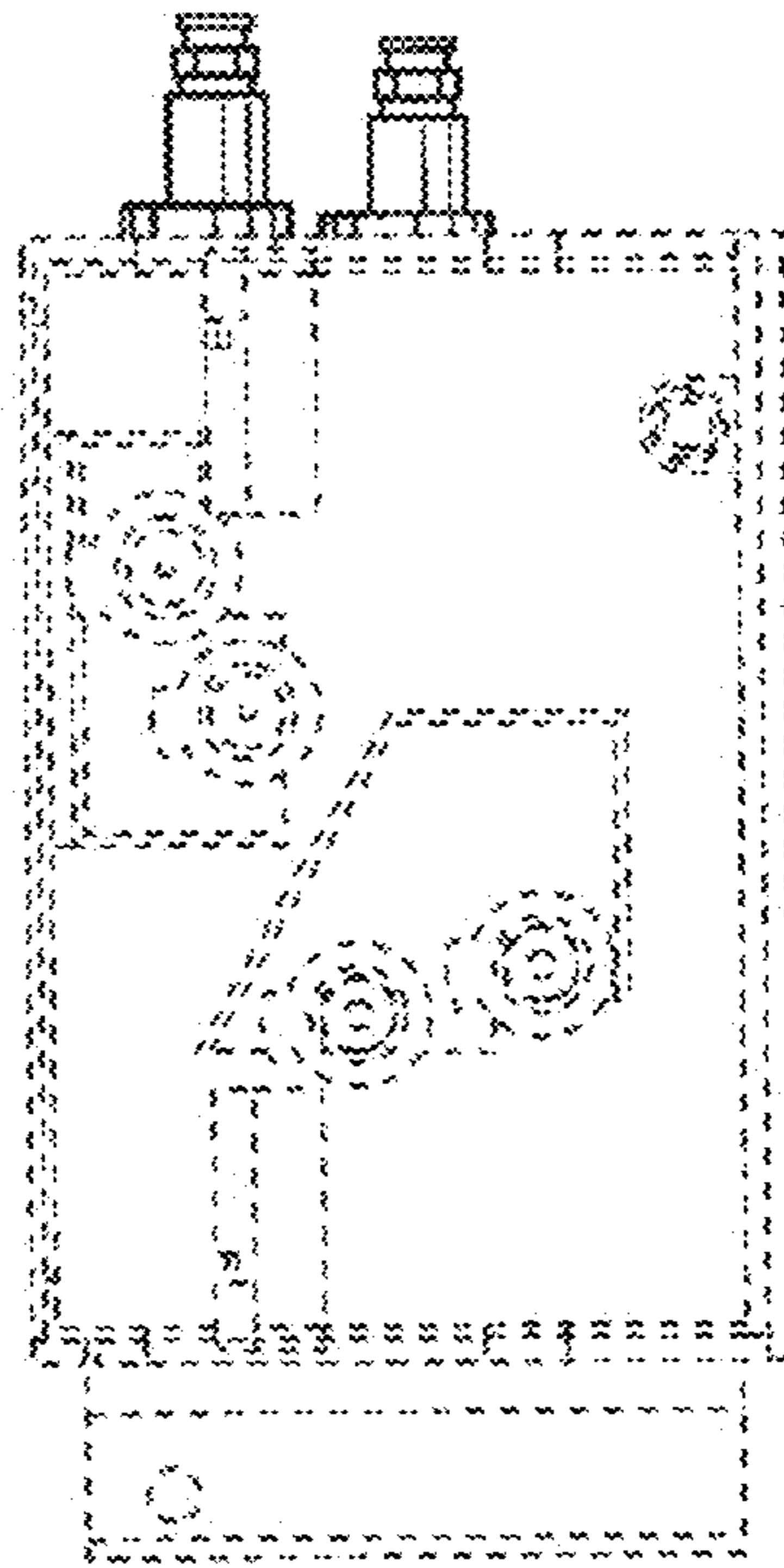

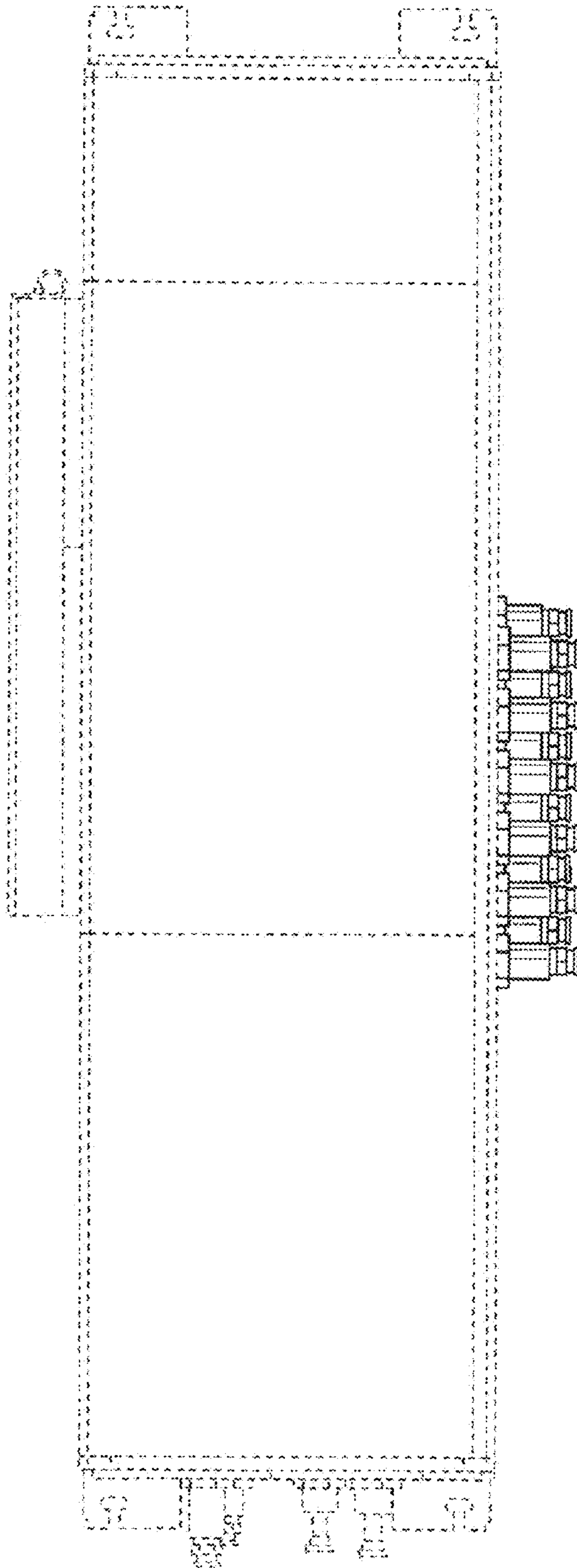
