The ornamental design for a servo amplifier, as shown and described.

DESCRIPTION

FIG. 1 is a front, top and right side perspective view of a servo amplifier, showing a first embodiment of our new design; FIG. 2 is a rear, bottom and left side perspective view of the servo amplifier, showing the first embodiment; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a right side elevational view thereof; FIG. 7 is a top plan view thereof; and, FIG. 8 is a bottom plan view thereof.

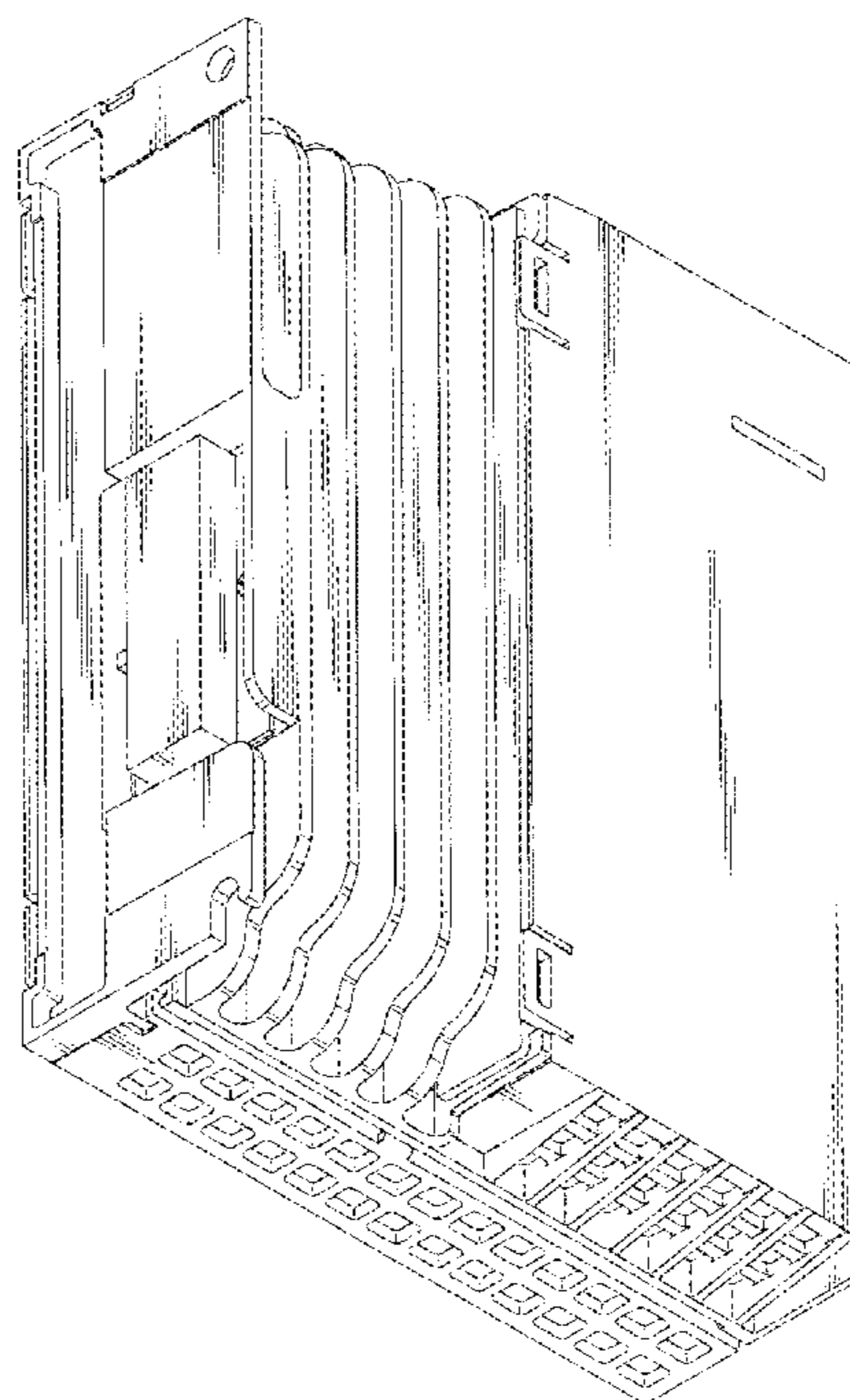
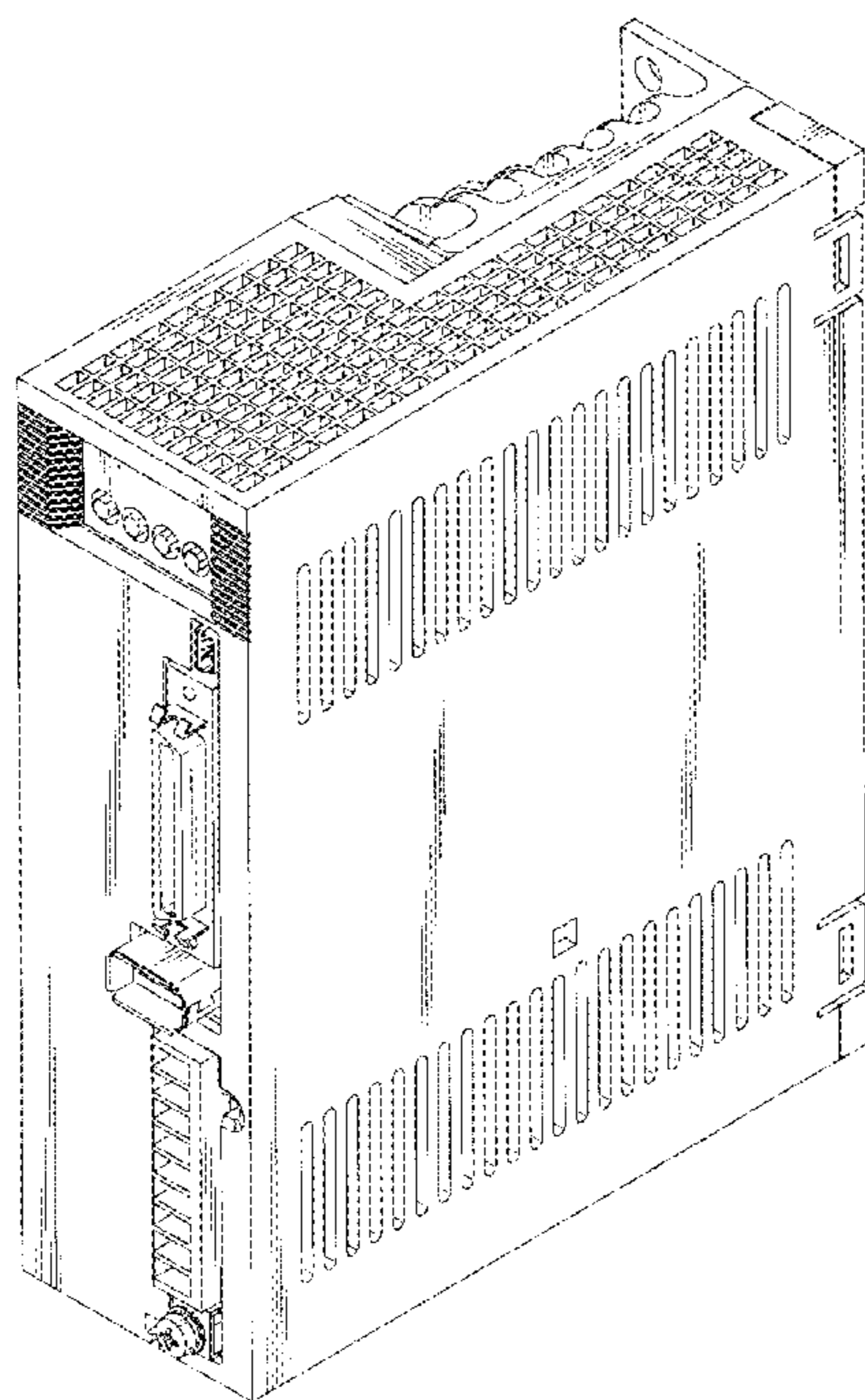

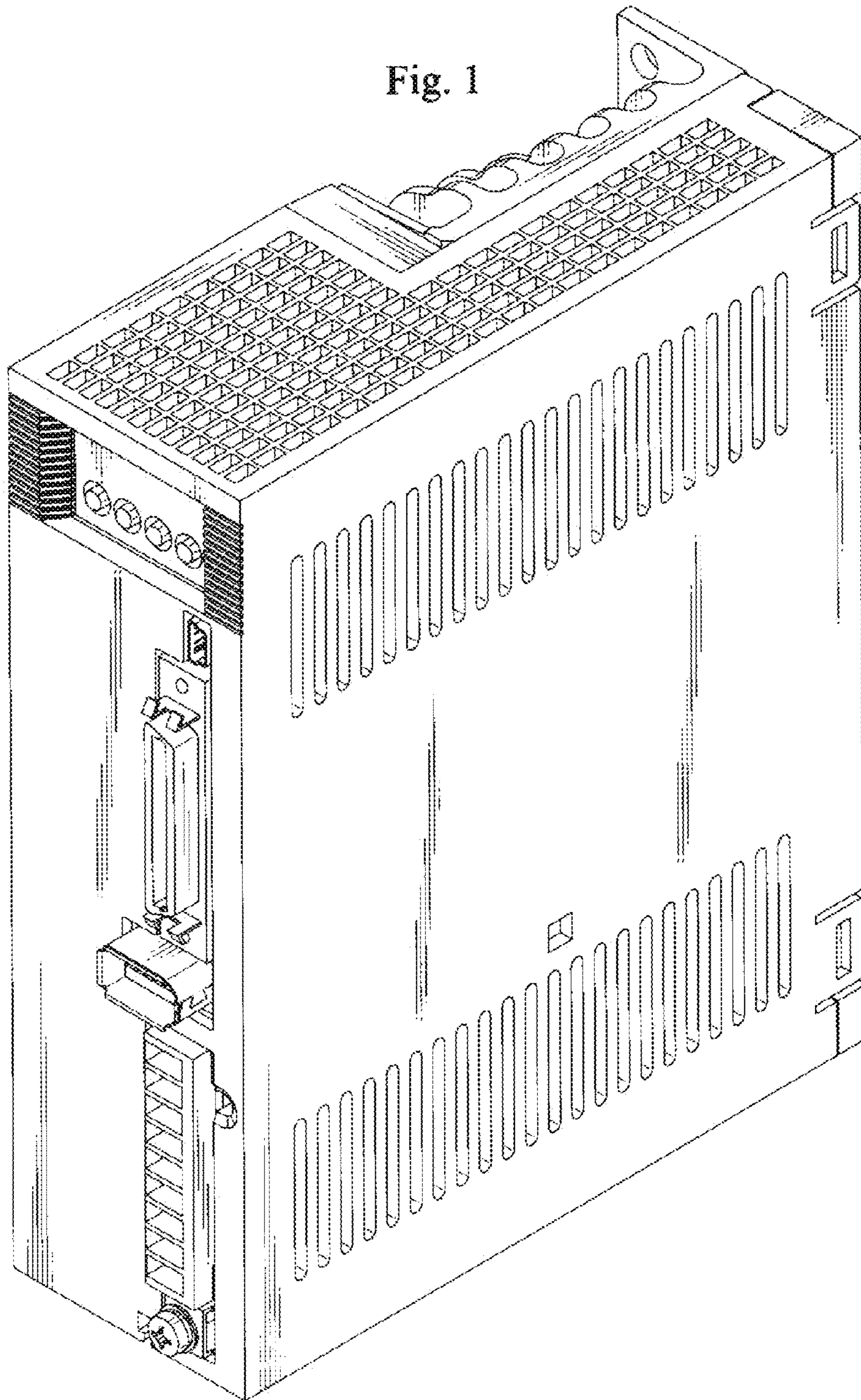

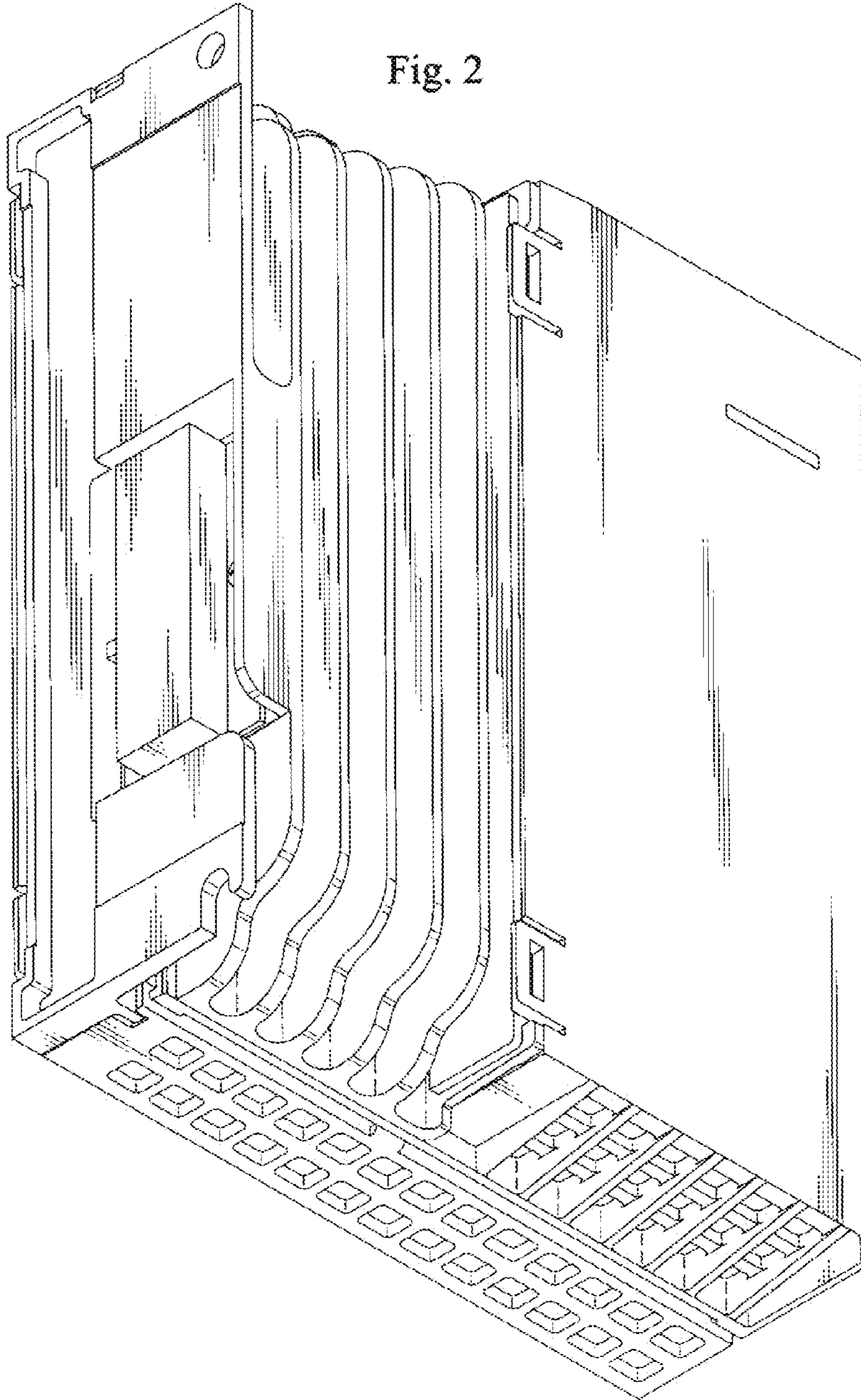

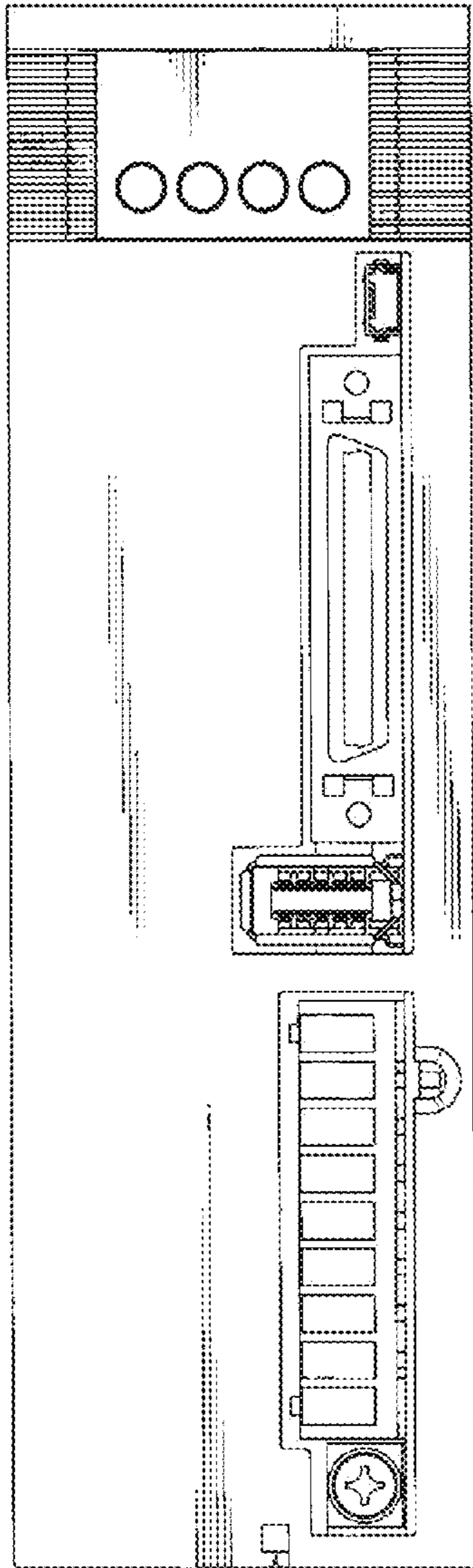

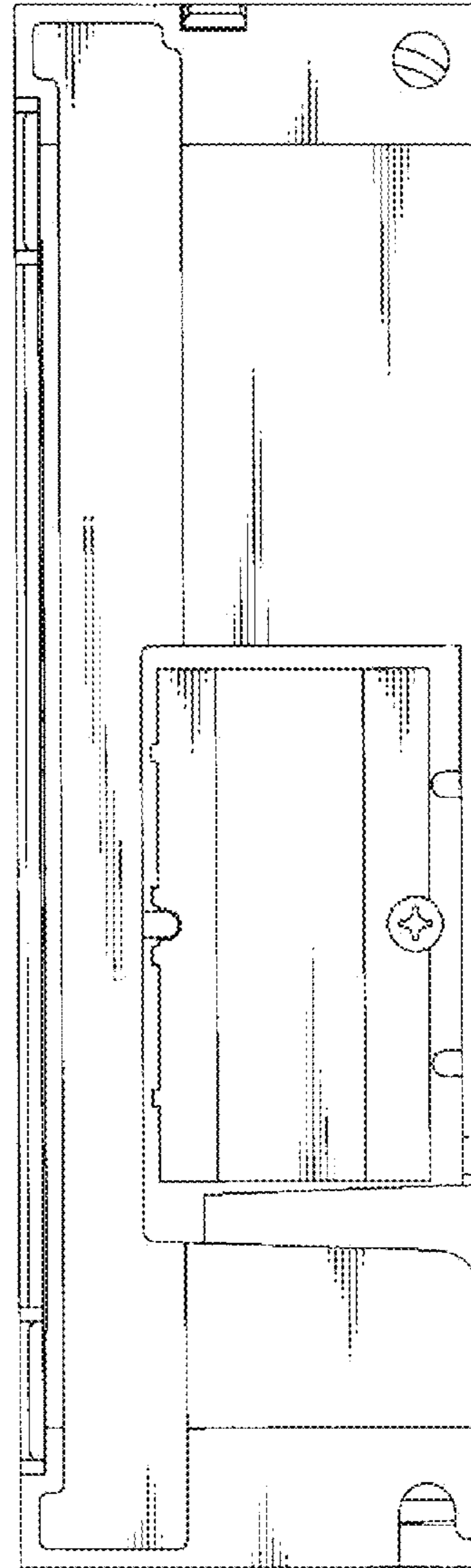

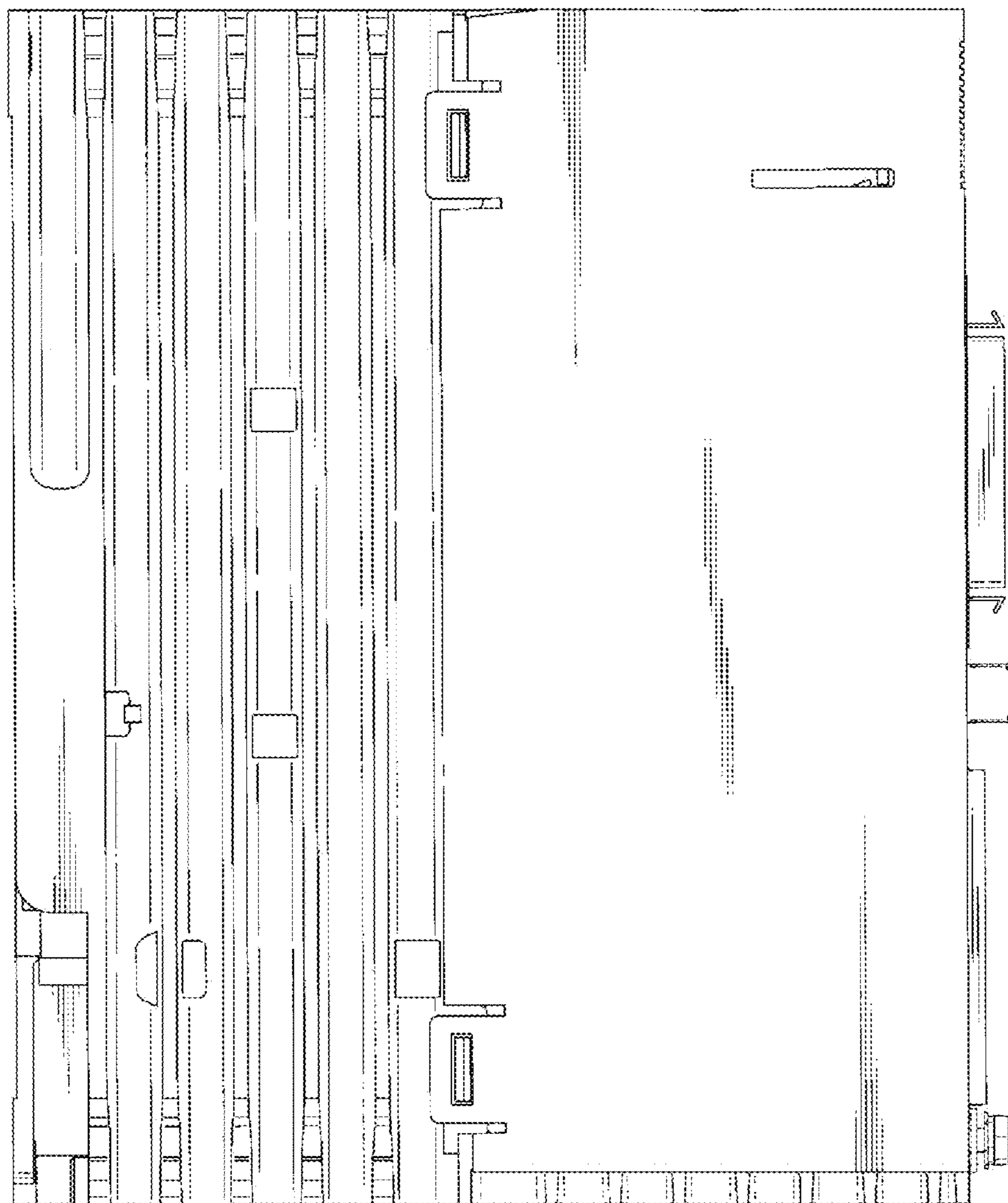

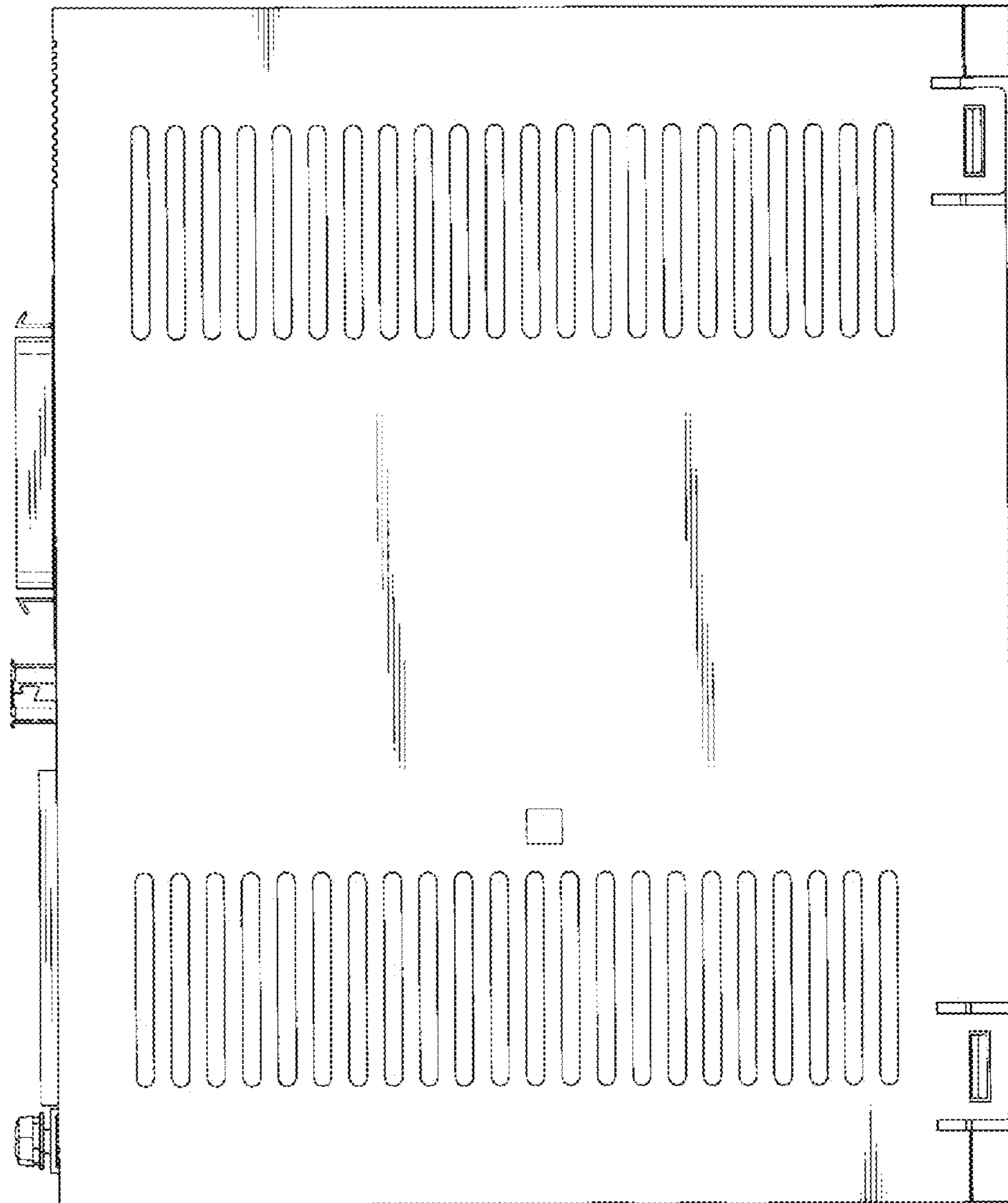

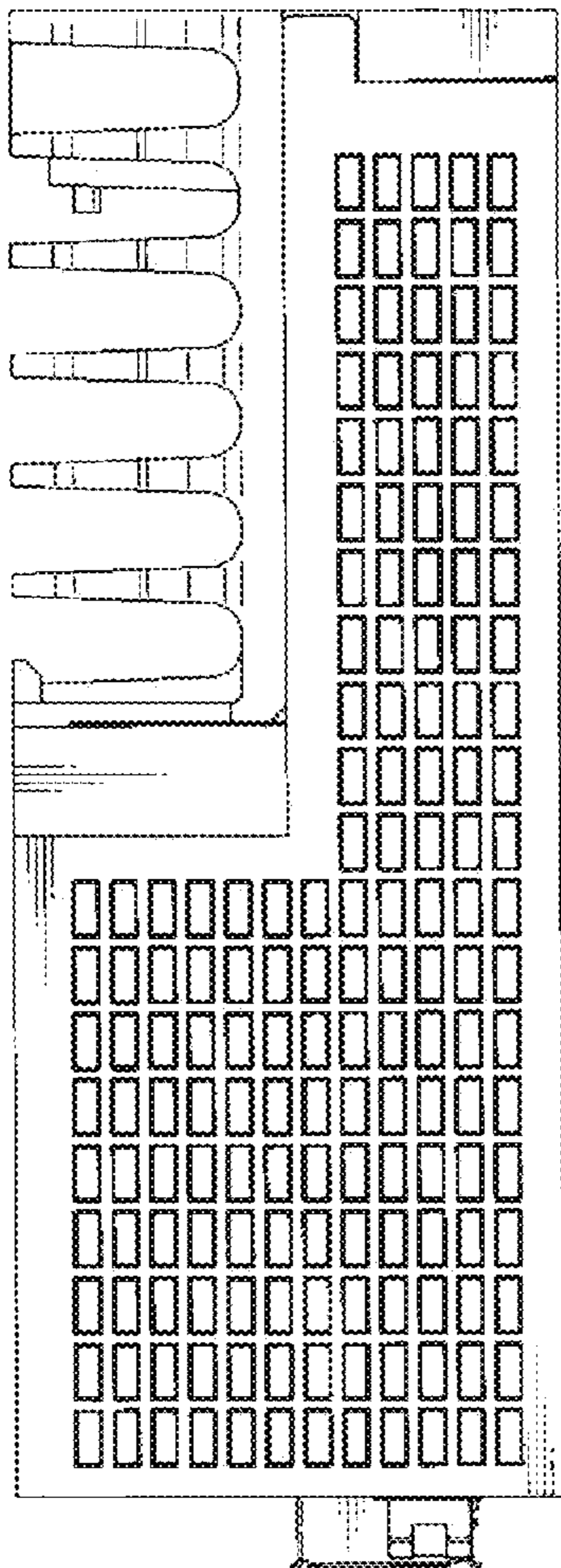
