(57) **CLAIM**

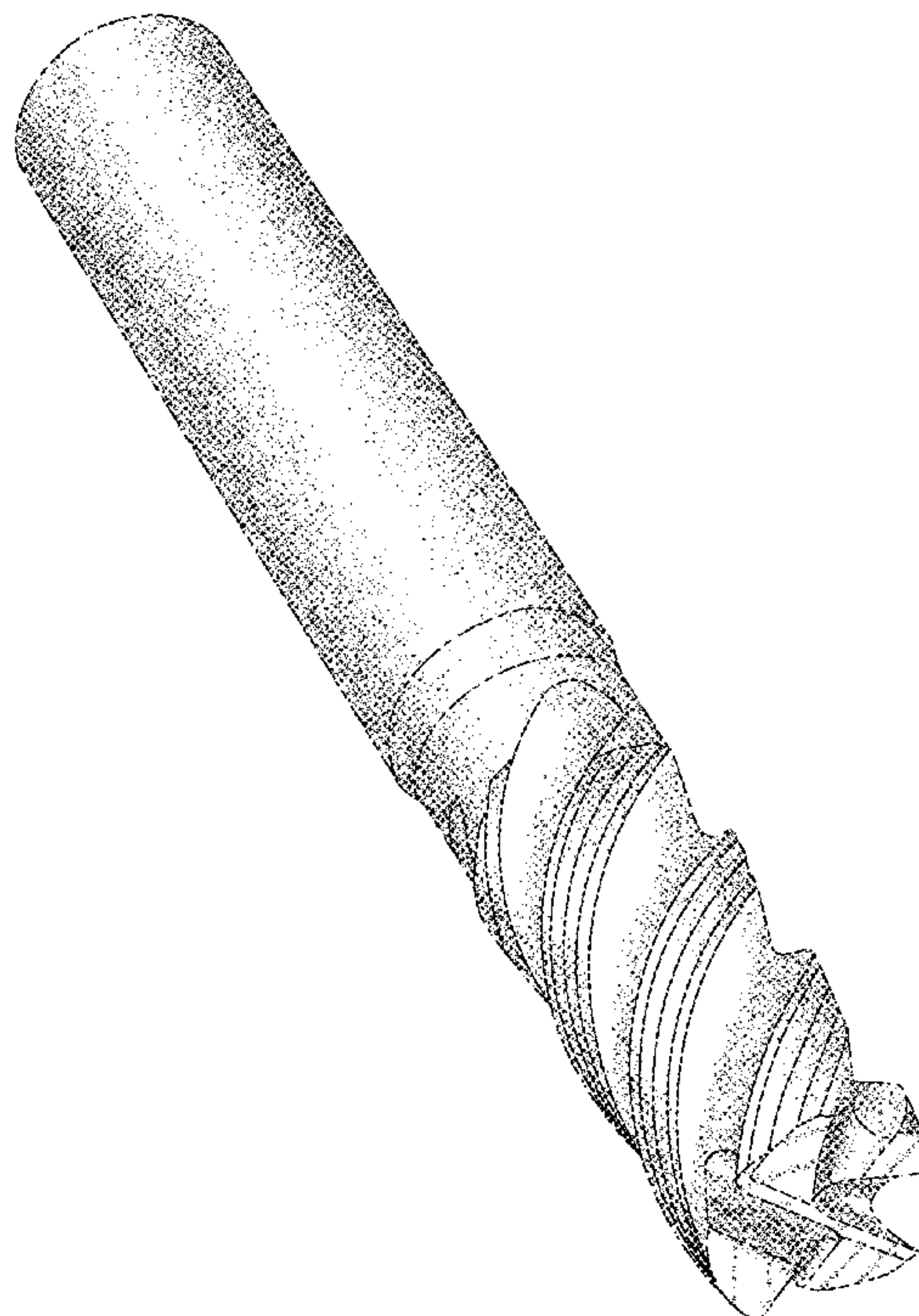
The ornamental design for a drilling and milling device, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a drilling and milling device; FIG. 2 is a top view of the drilling and milling device of FIG. 1; FIG. 3 is a bottom view of the drilling and milling device of FIG. 1; FIG. 4 is side view of the drilling and milling device of FIG. 1; FIG. 5 is another side view of the of the drilling and milling device of FIG. 1; and, FIG. 6 is another perspective view of the drilling and milling device of FIG. 1.

In FIGS. 1-6, the broken lines and stippled features of the cutting edges and shank of the drilling and milling device depict unclaimed environmental subject matter and form no part of the design.

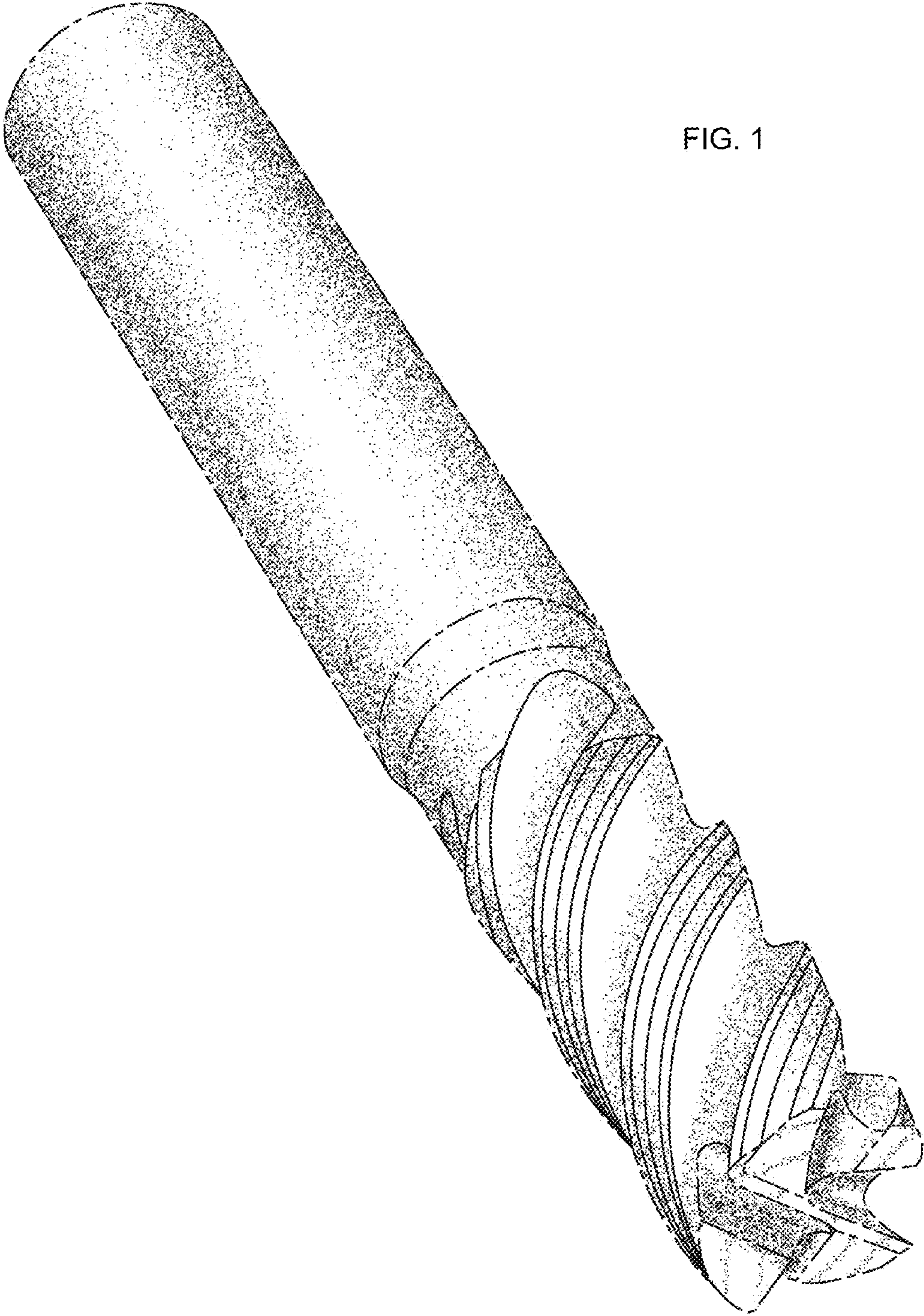

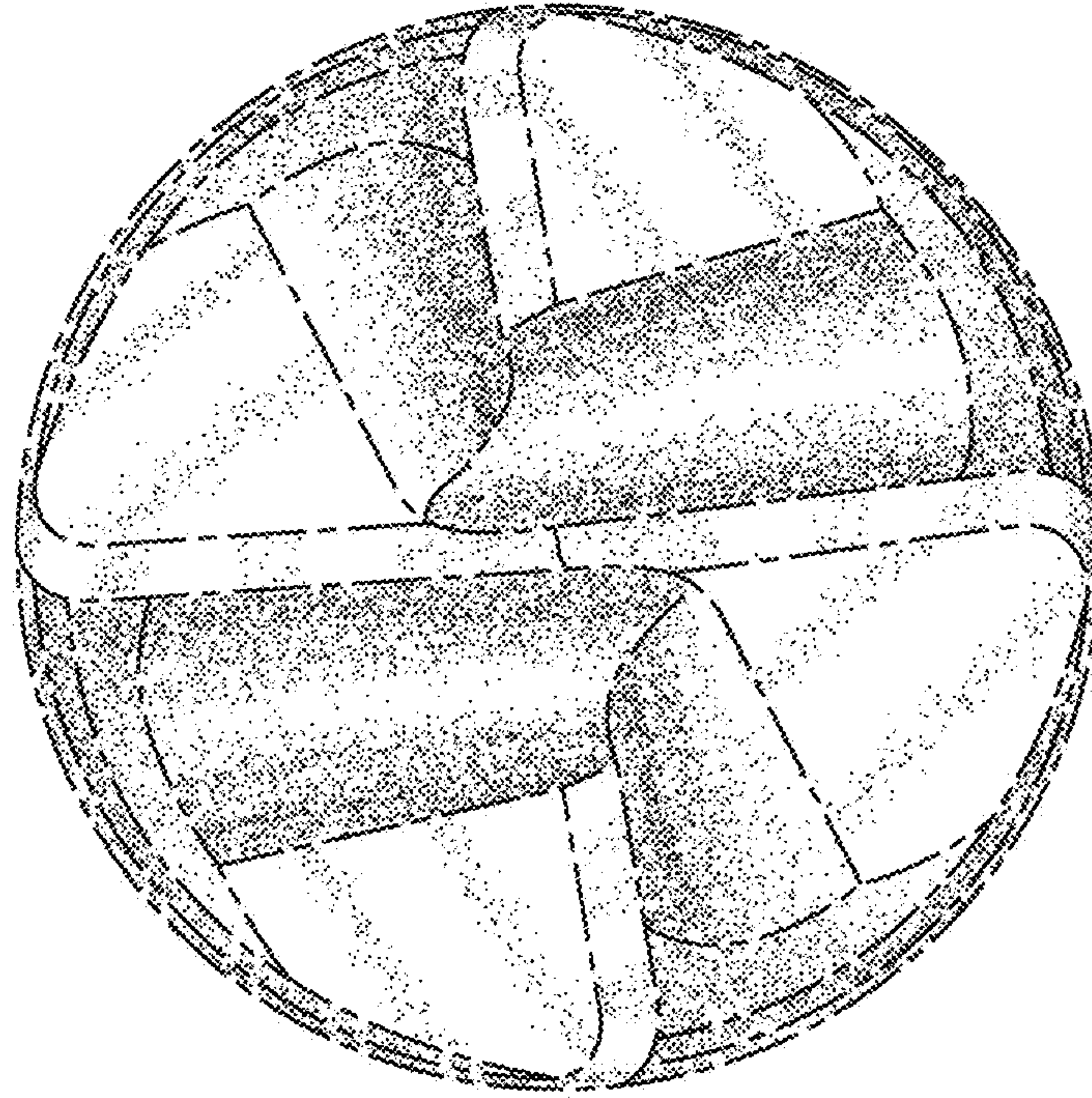

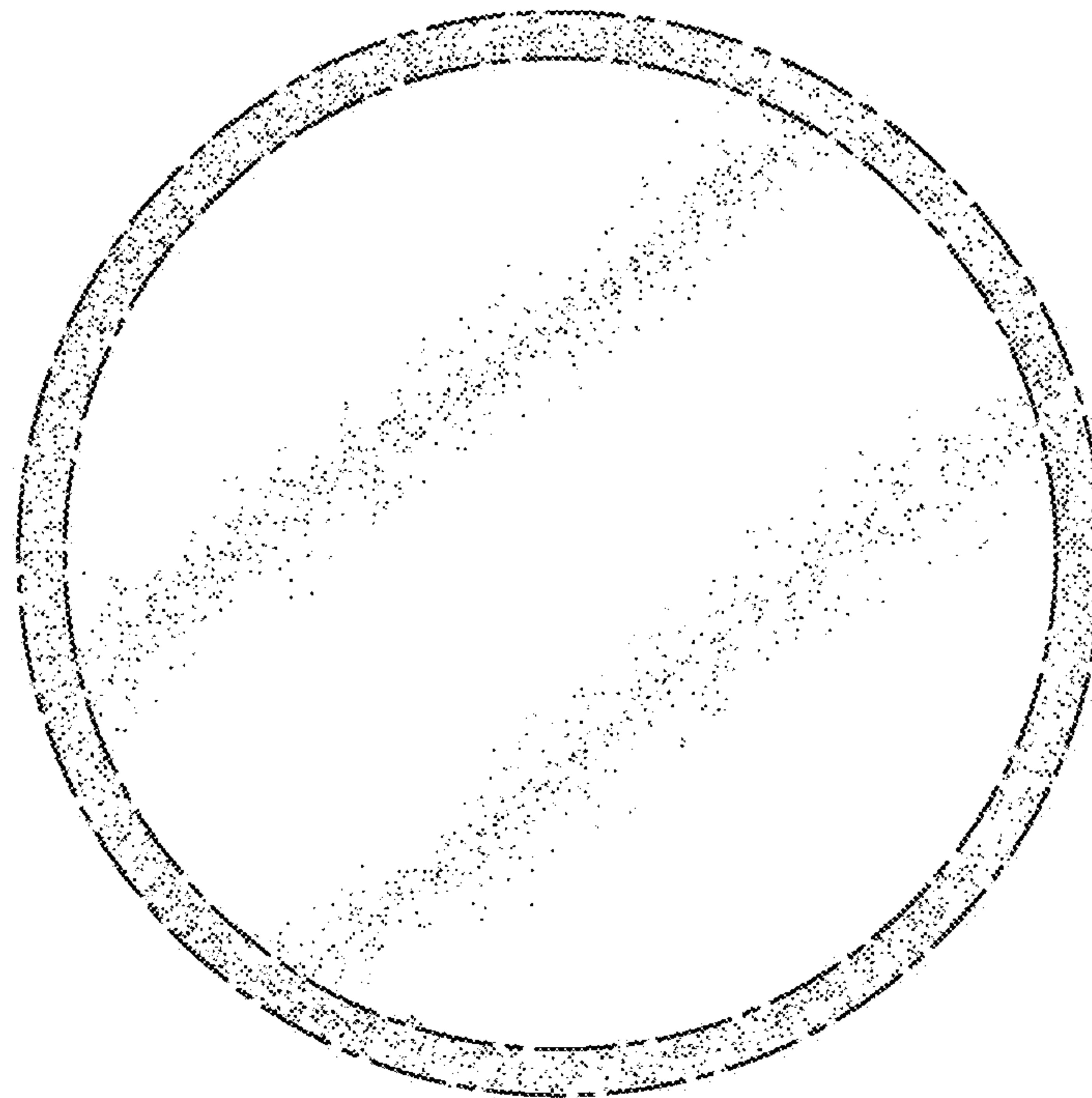

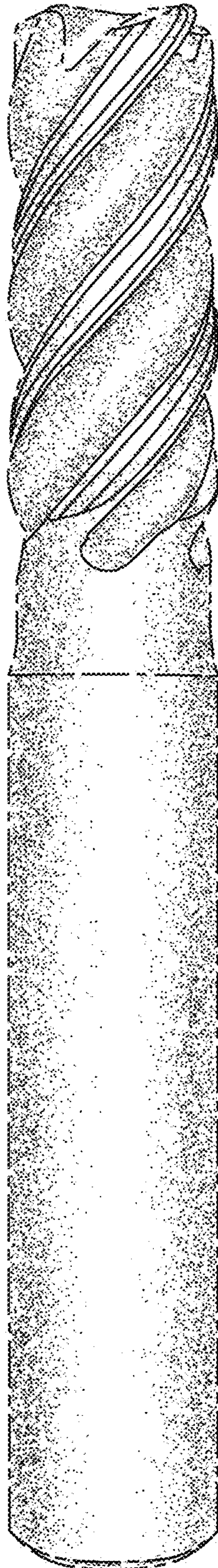

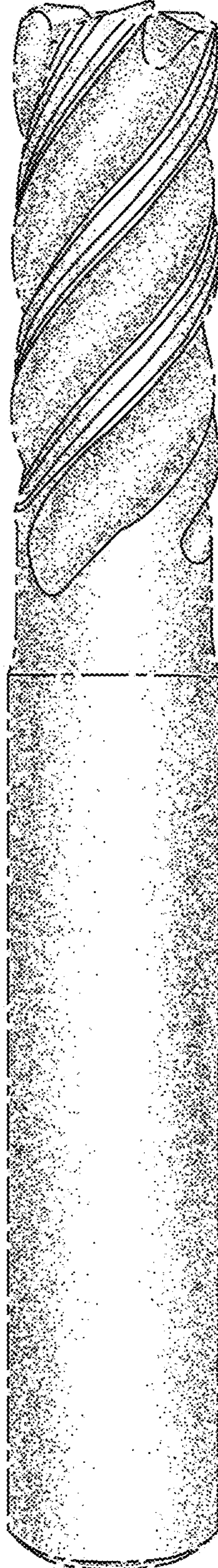
