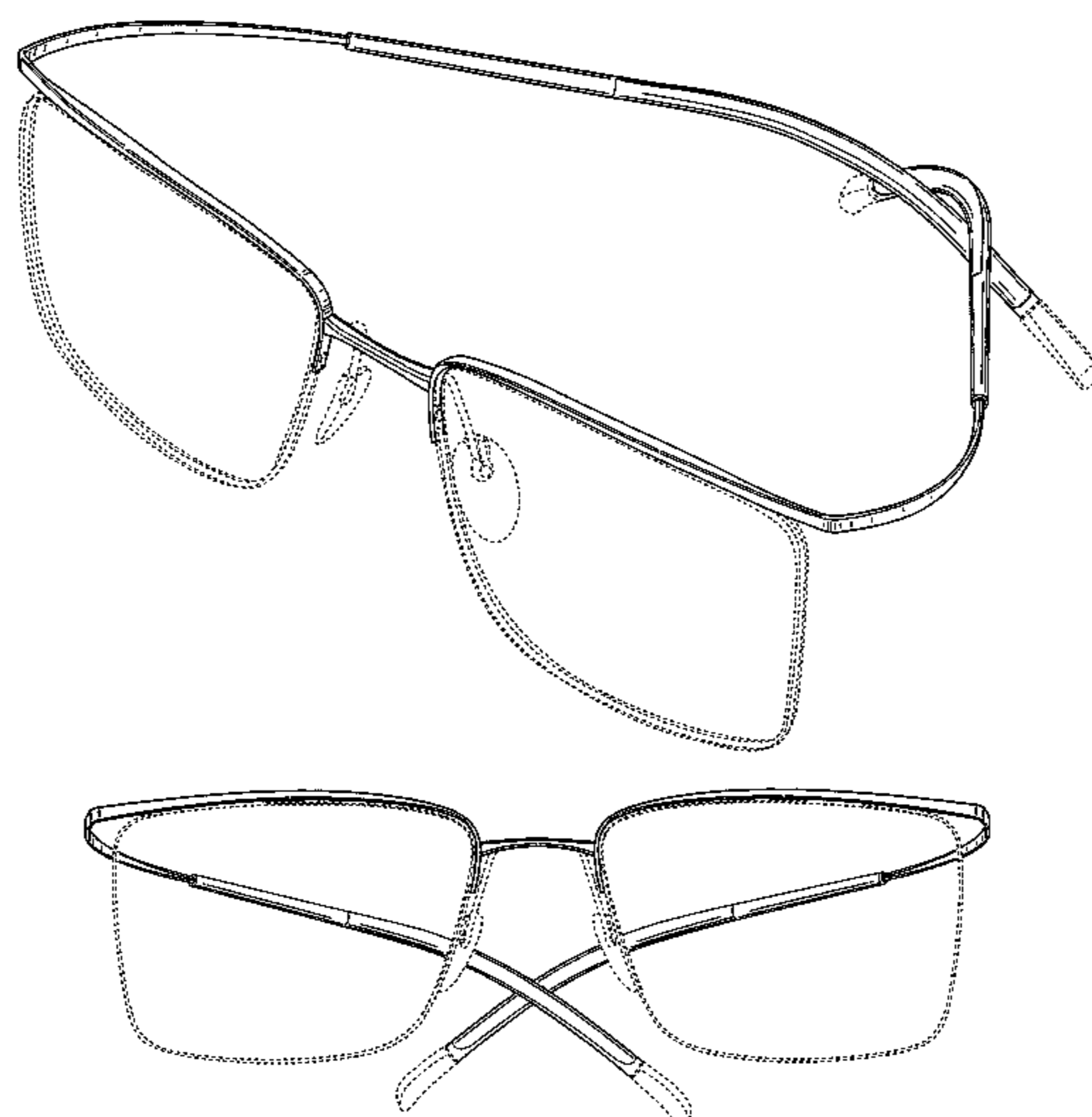

(57) **CLAIM**  
I claim the ornamental design for eyeglasses, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of eyeglasses showing my new design;  
FIG. 2 is a front elevation view thereof;  
FIG. 3 is a rear elevation view thereof;  
FIG. 4 is a top plan view thereof;  
FIG. 5 is a bottom plan view thereof;  
FIG. 6 is a left side elevation view thereof, the right side being a mirror image thereof; and,  
FIG. 7 is a side elevation cross-section view thereof taken along line 7-7 in FIG. 4.  
The broken lines are directed to unclaimed features and form no part of the claimed design.

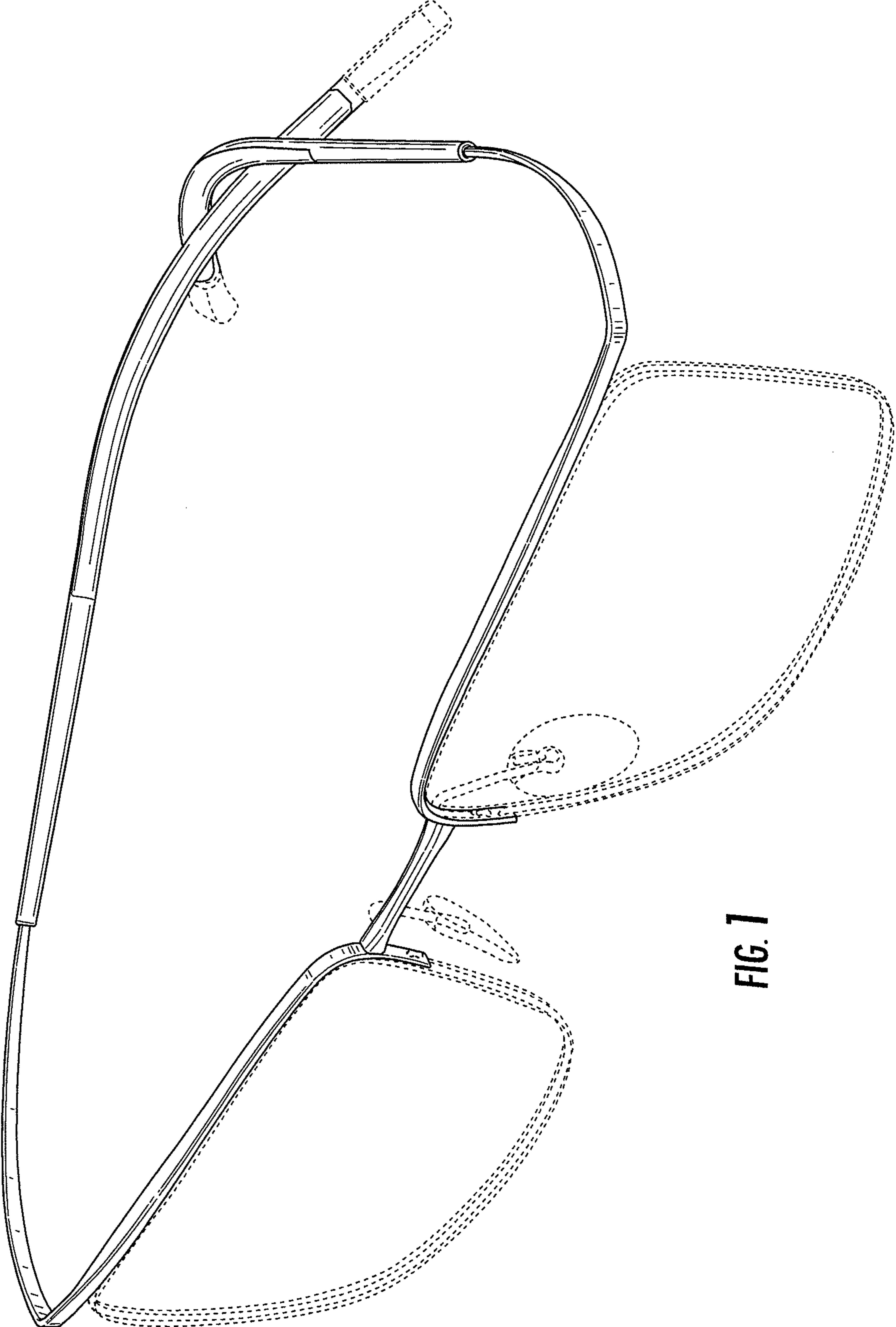

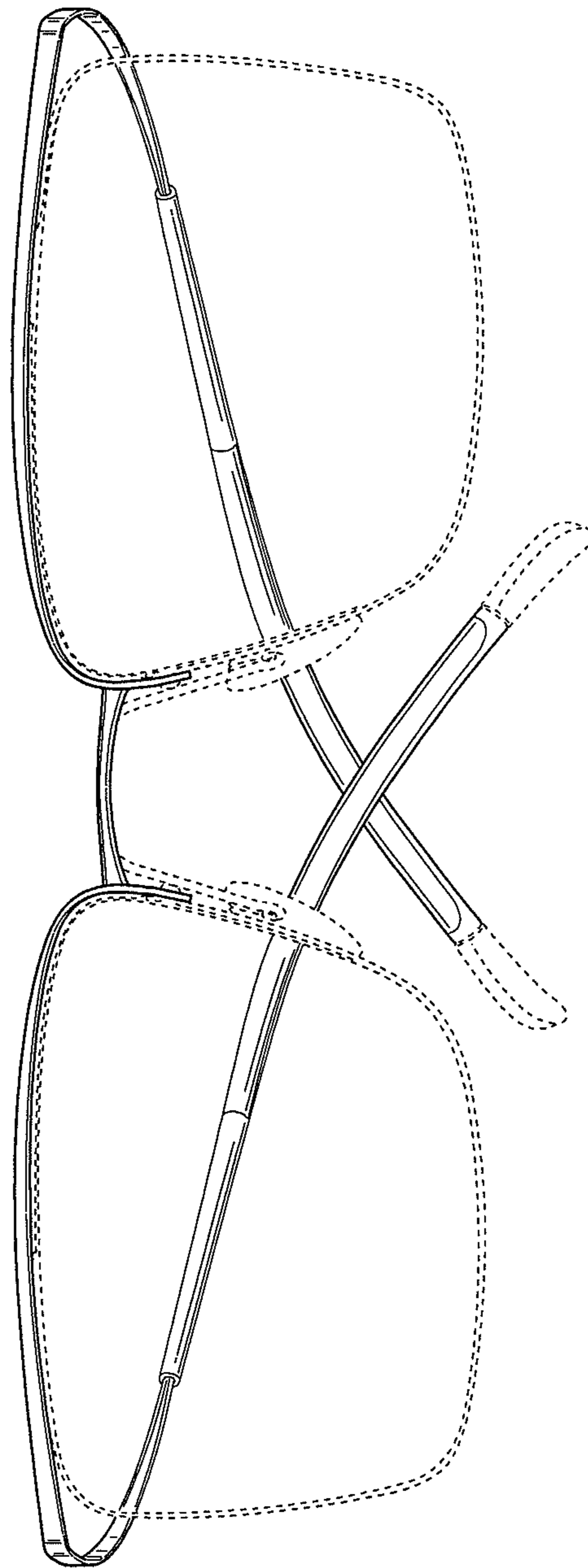

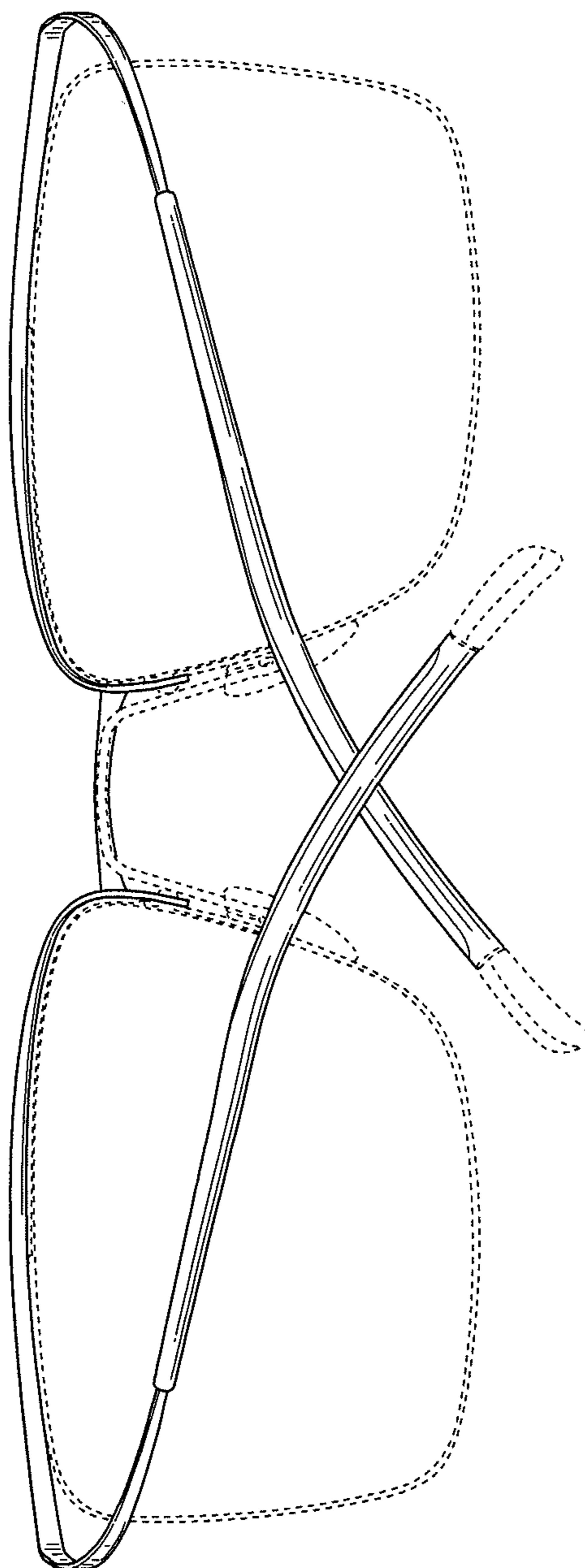

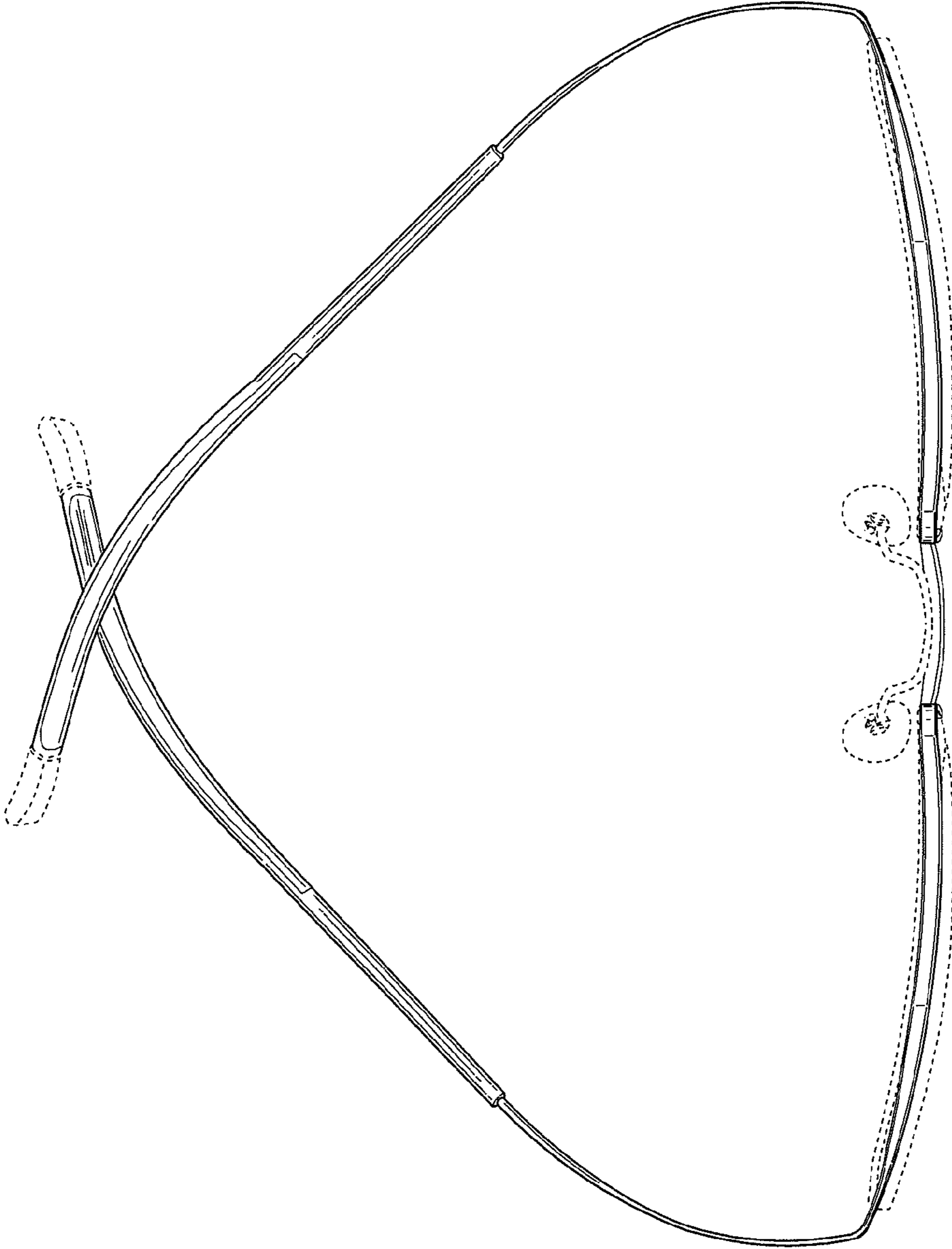

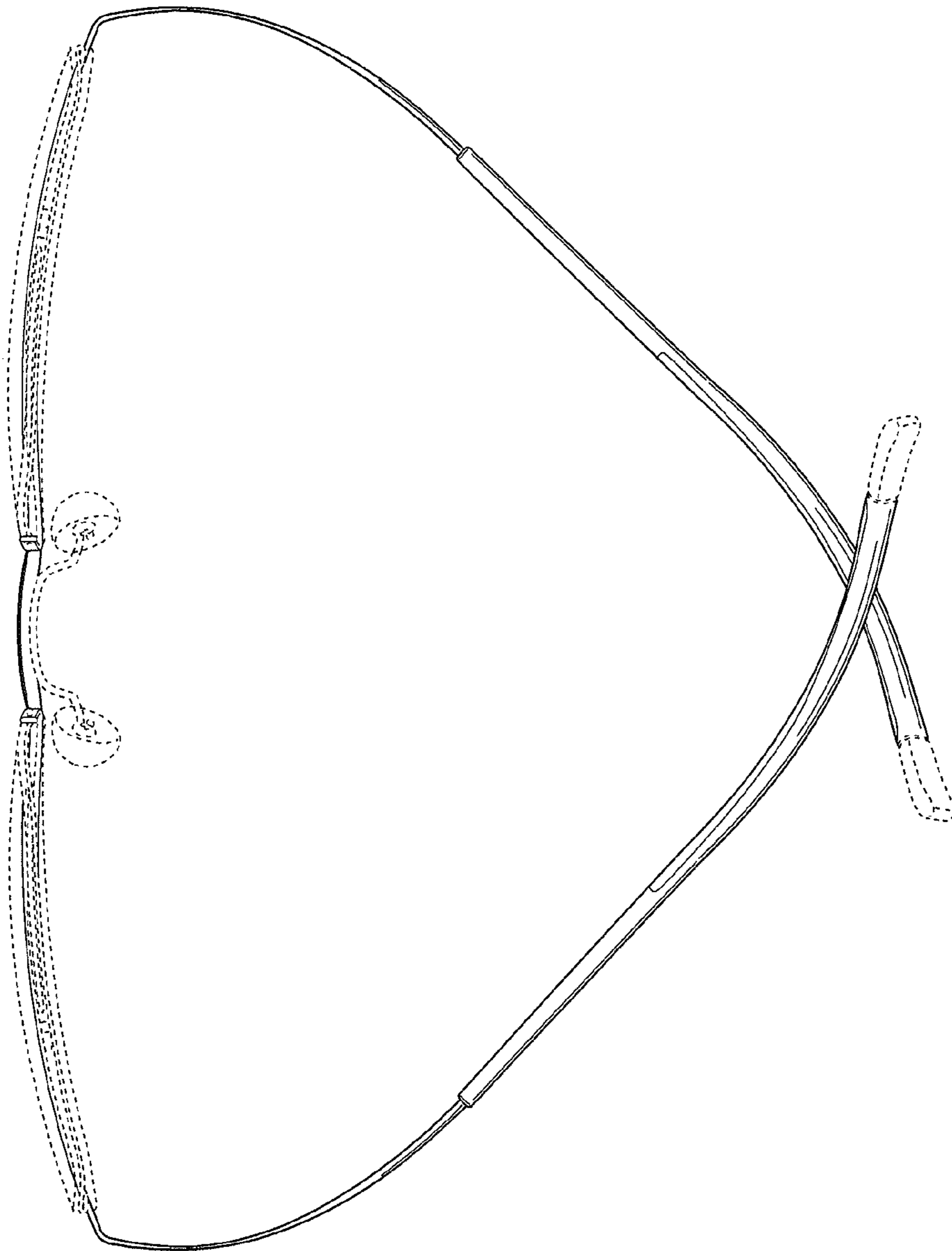

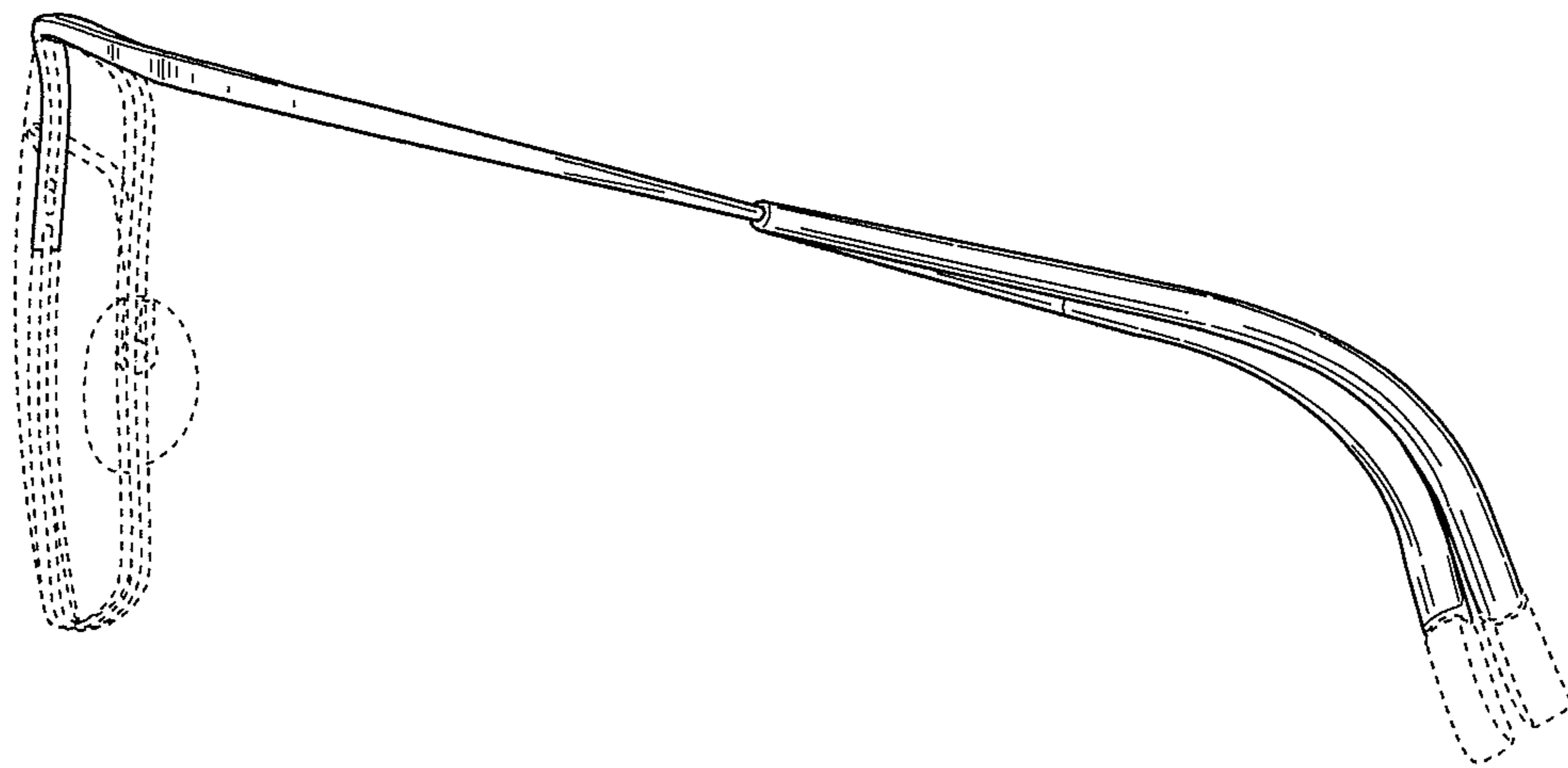

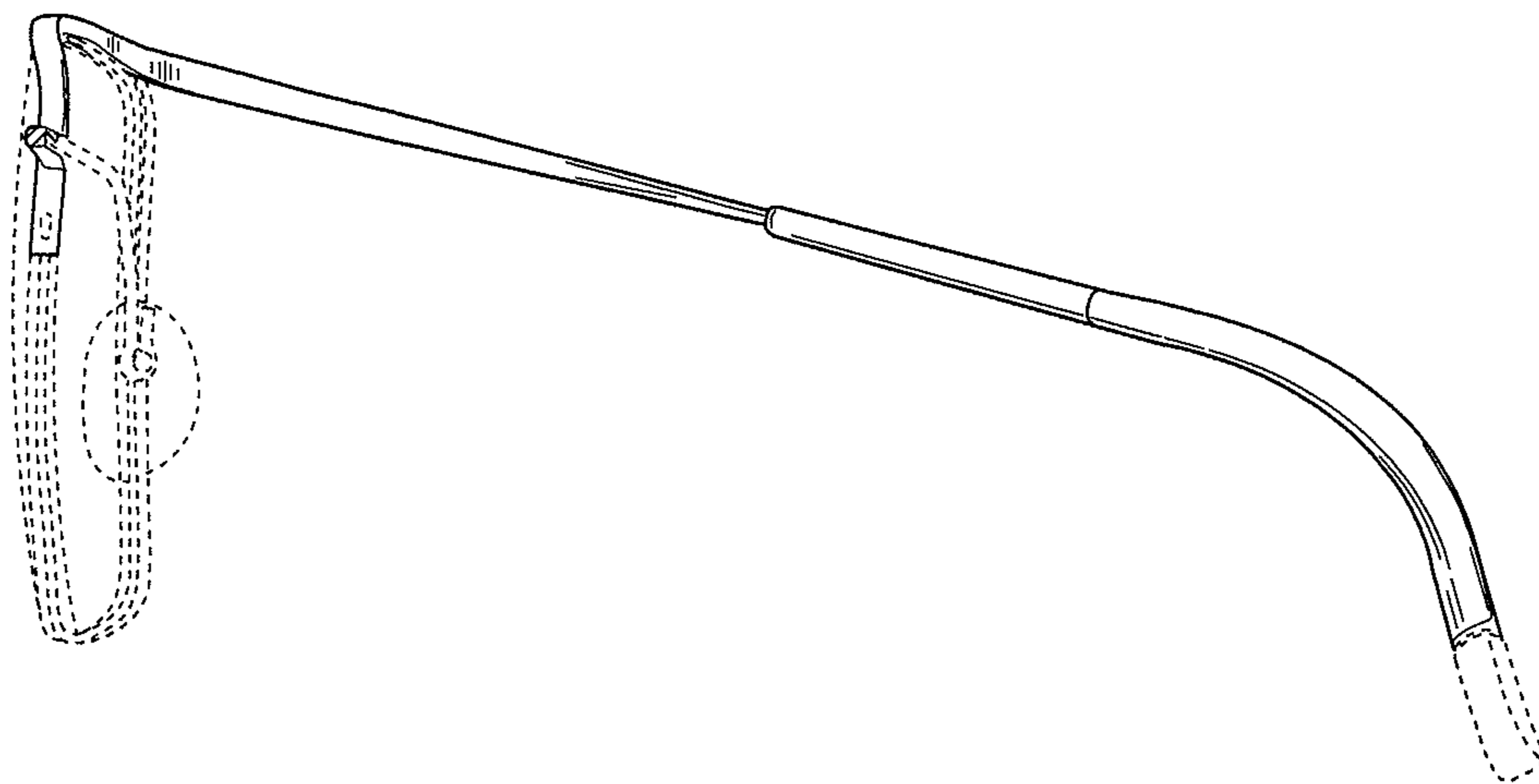
