(57) **CLAIM**

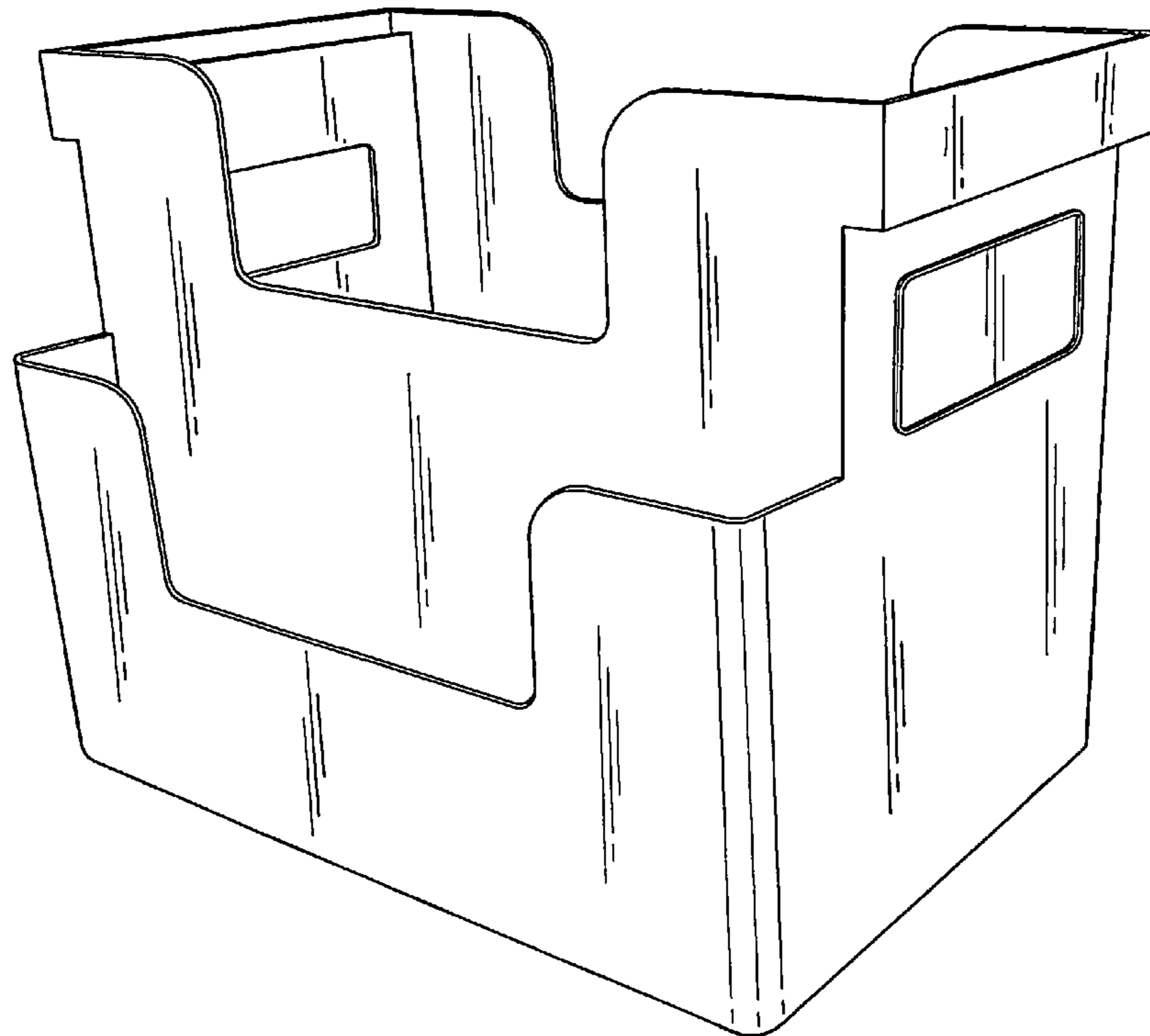
The ornamental design for a desktop file organizer, as shown and described.

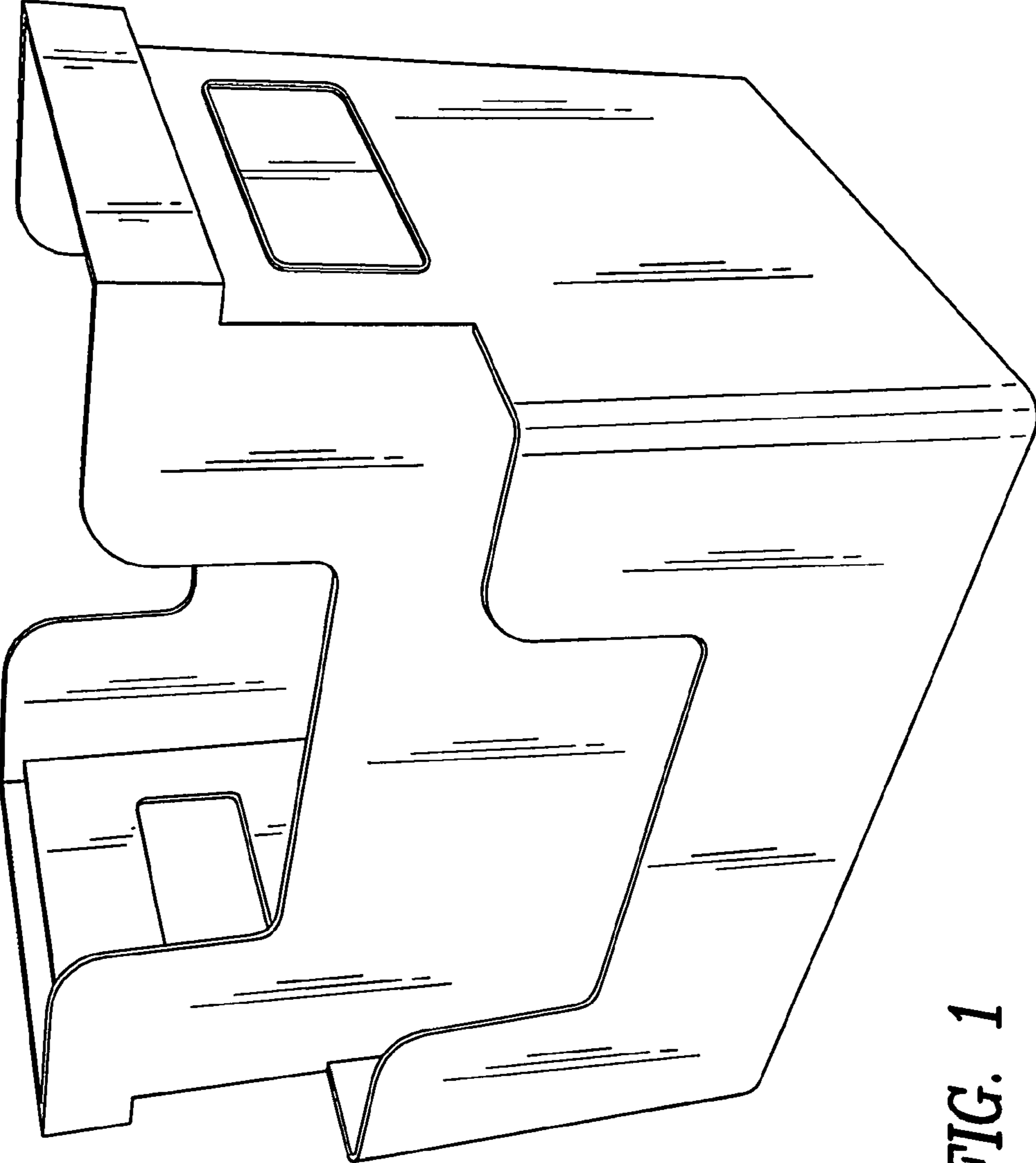

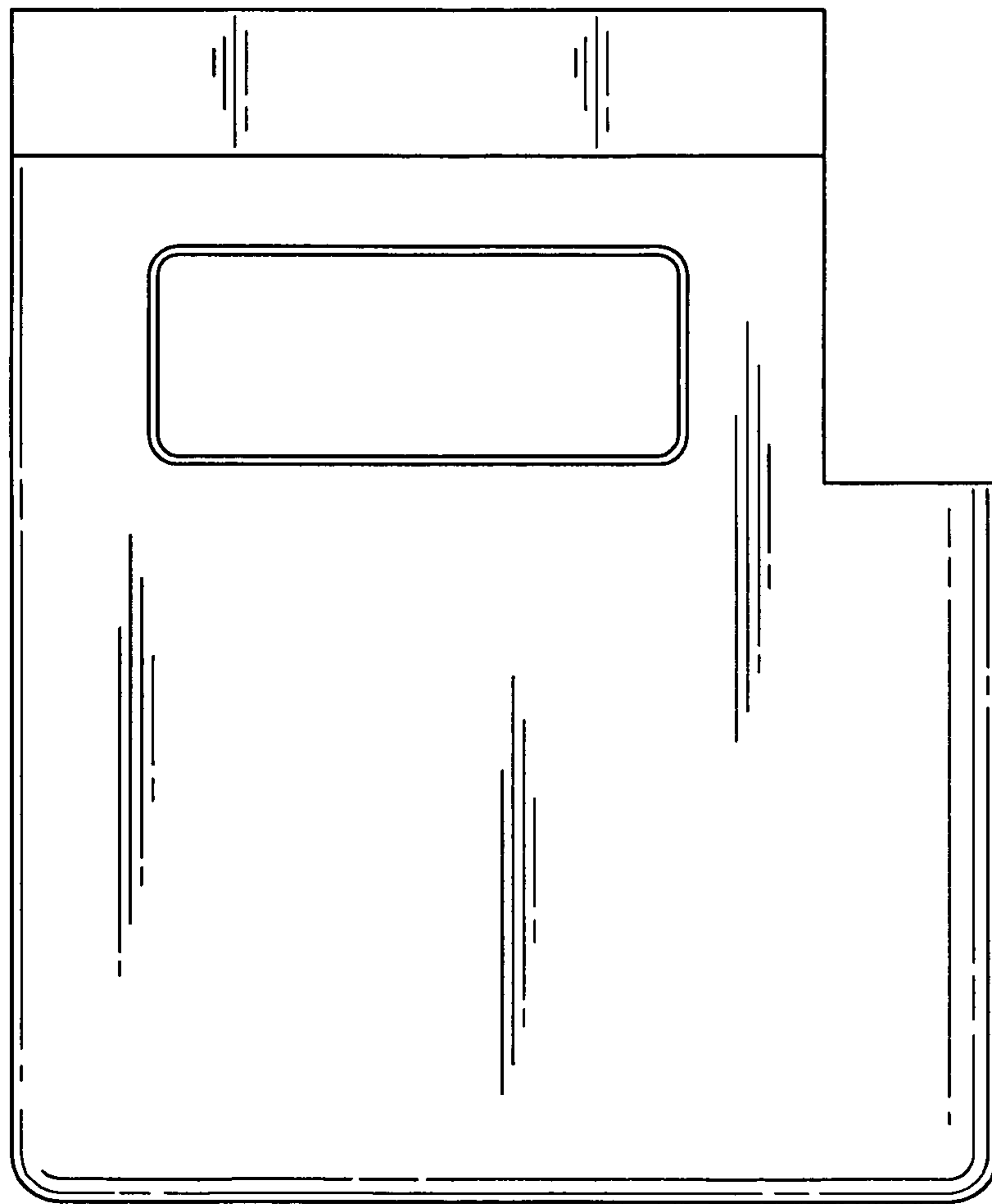

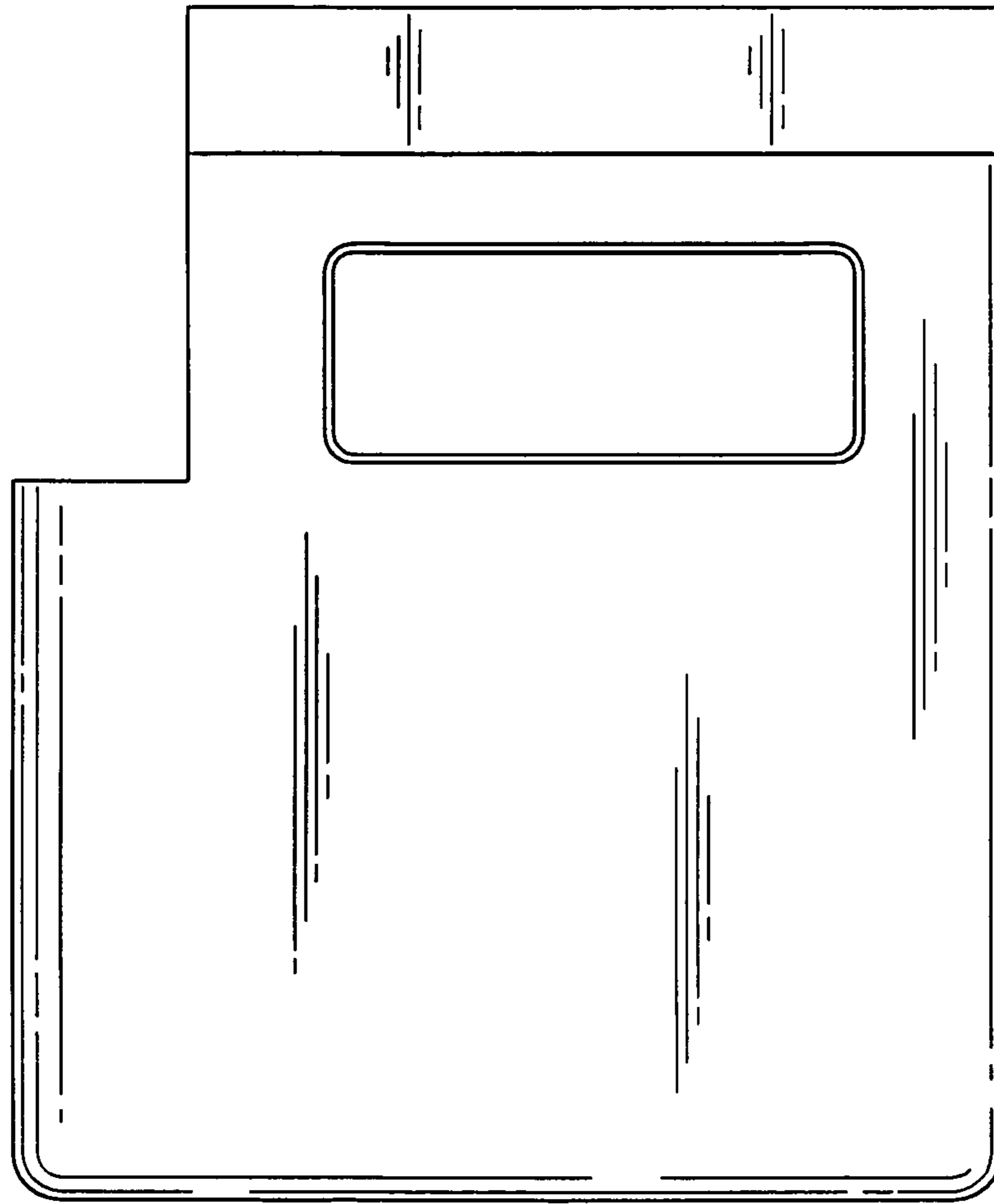

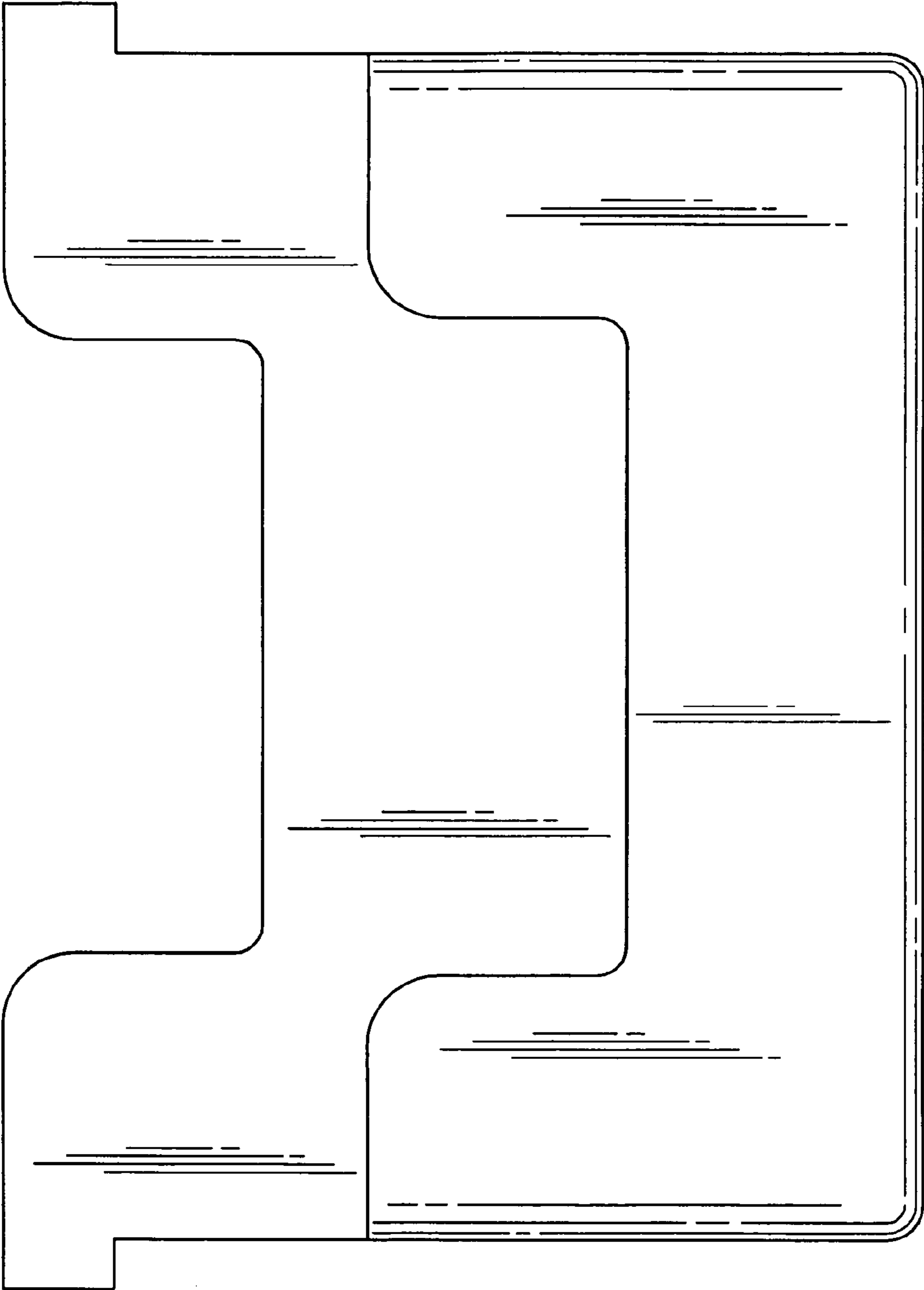

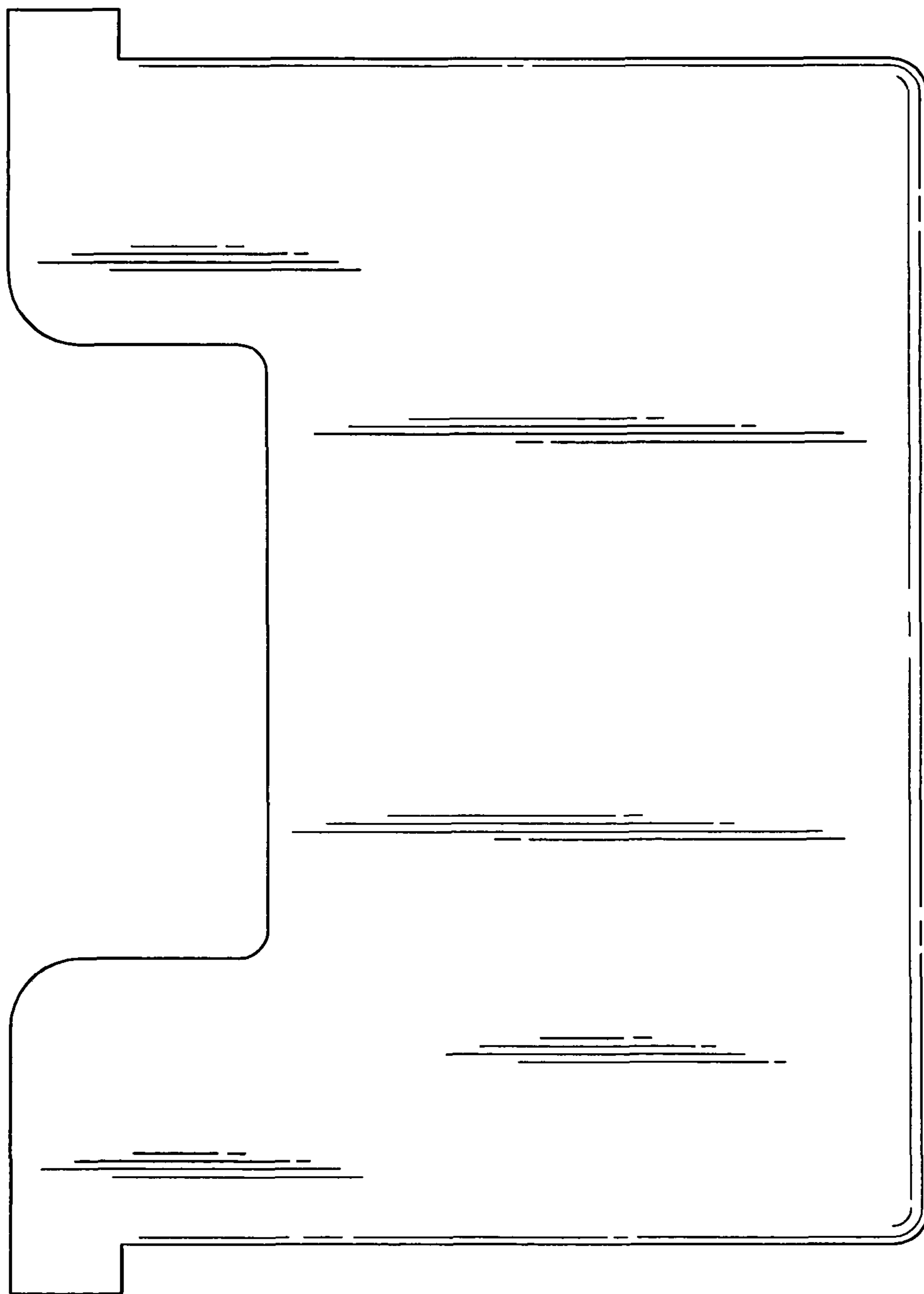

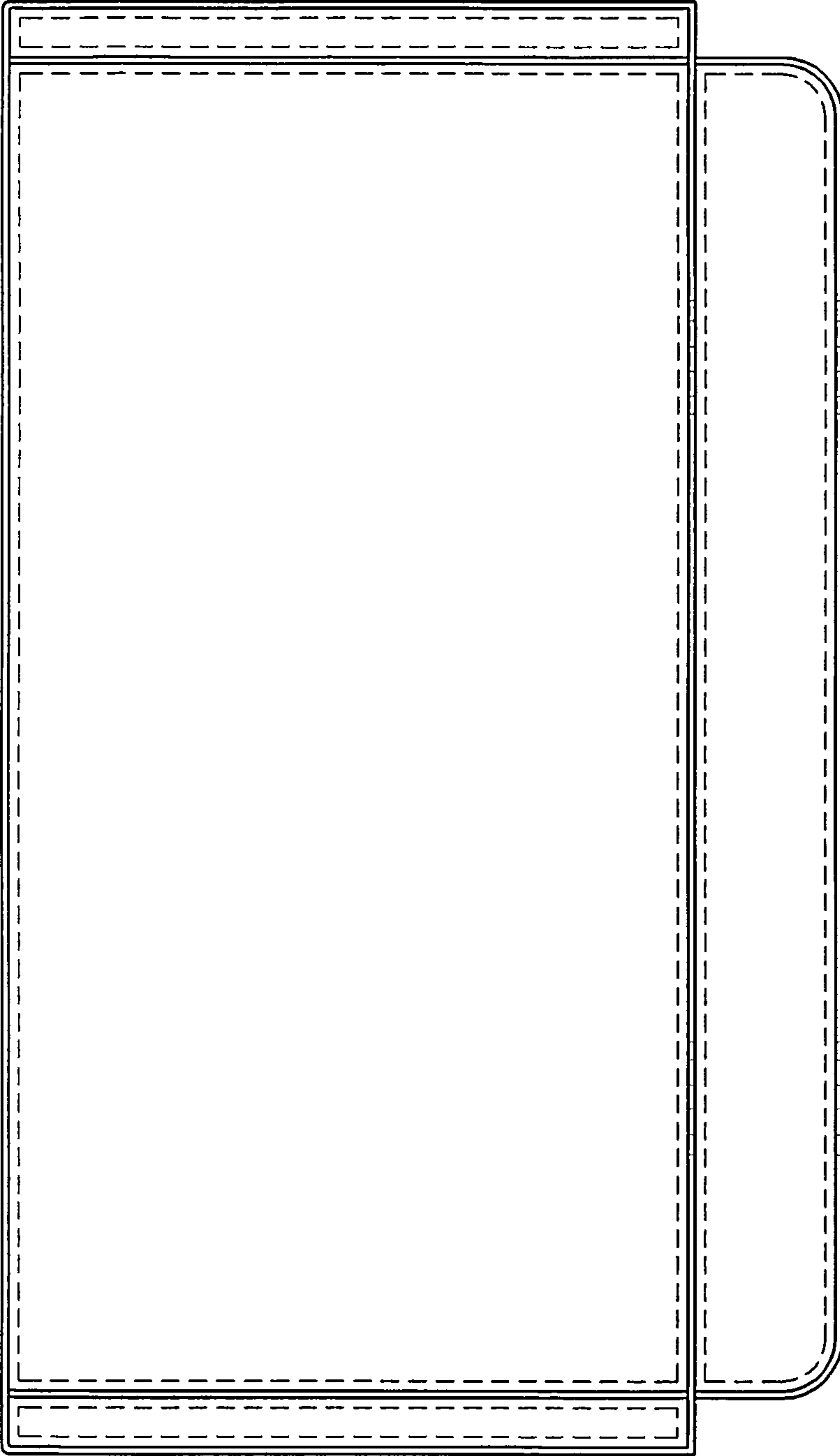

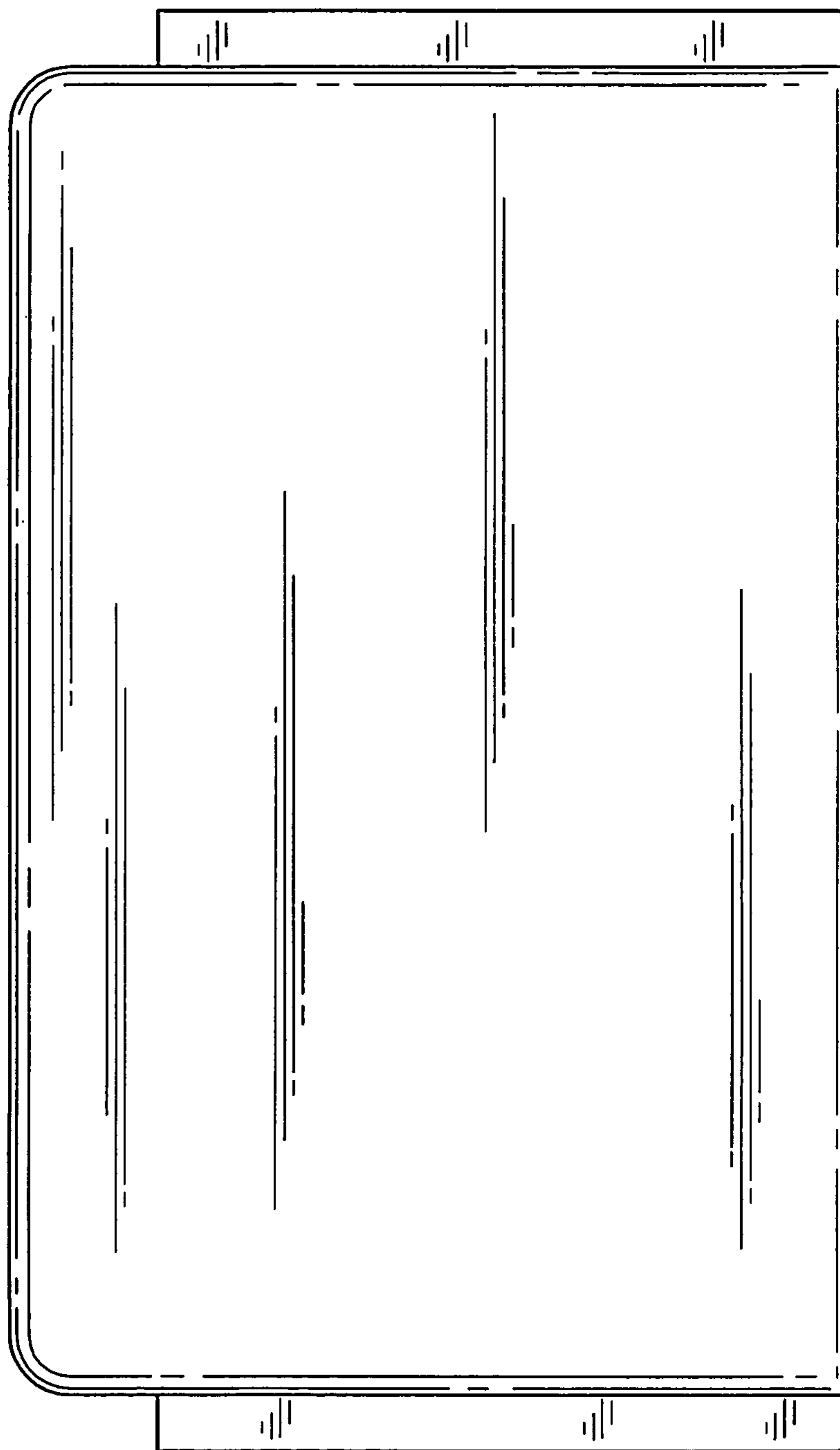
