The ornamental design for a hose support, as shown and described.

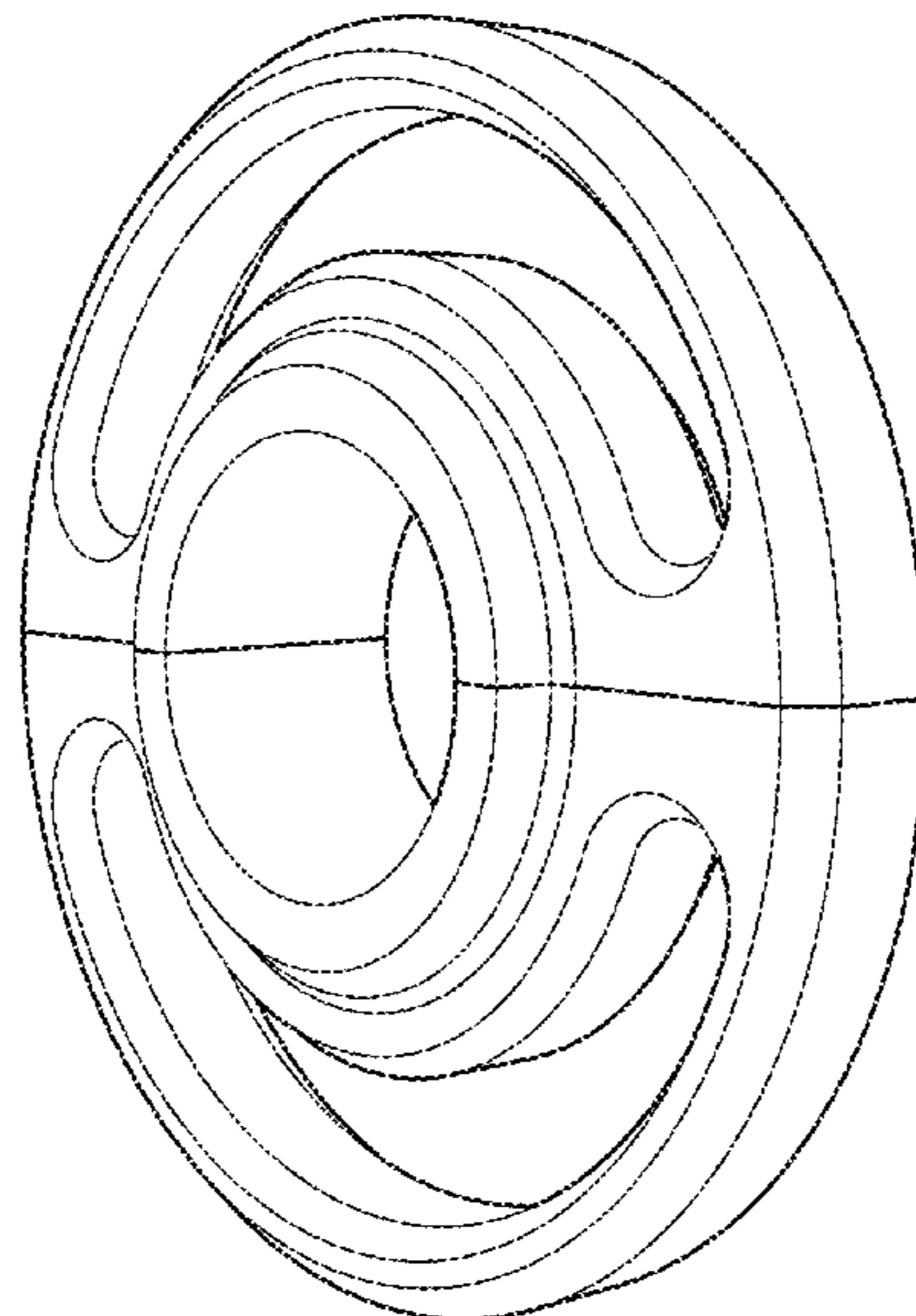
**DESCRIPTION**

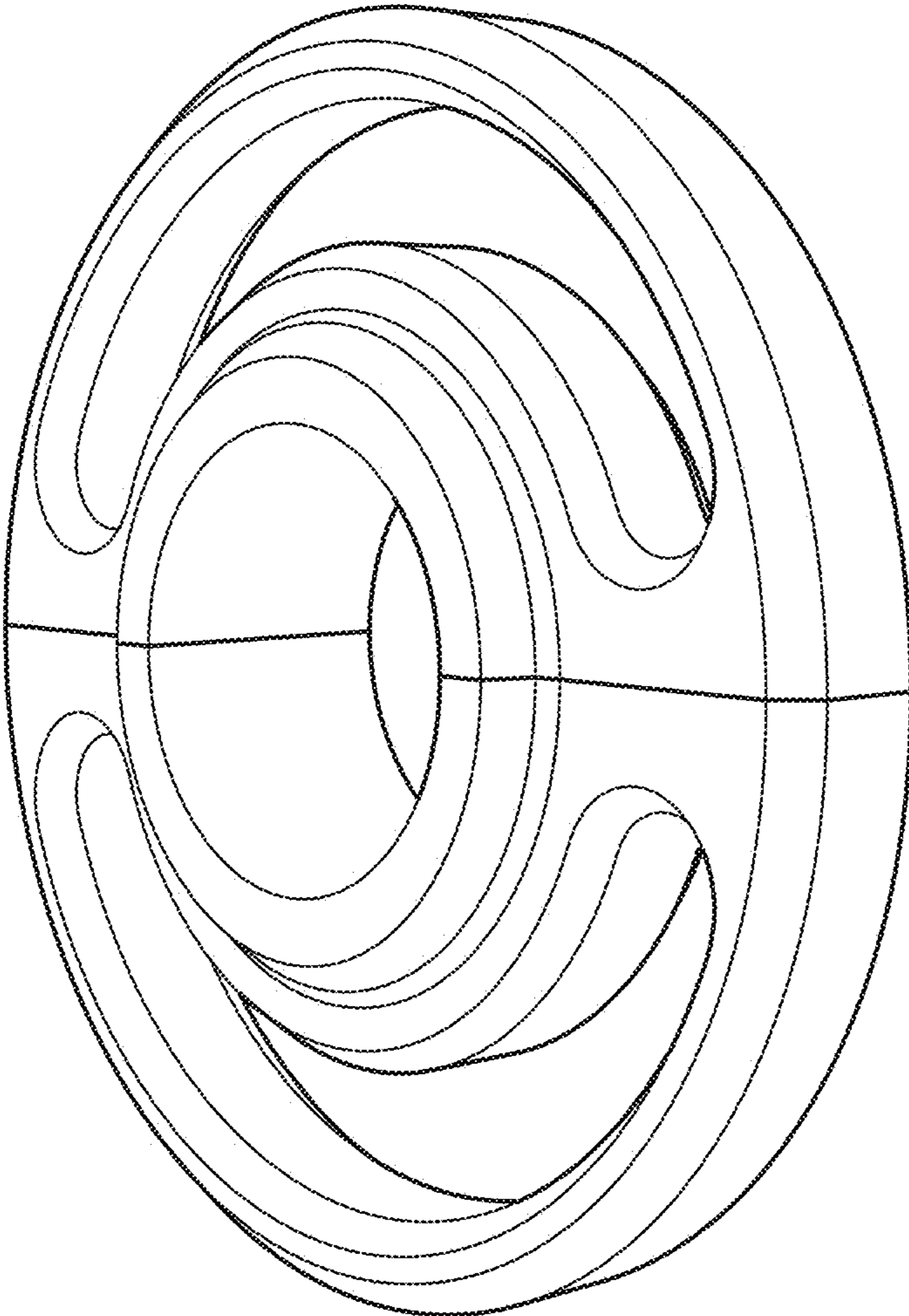

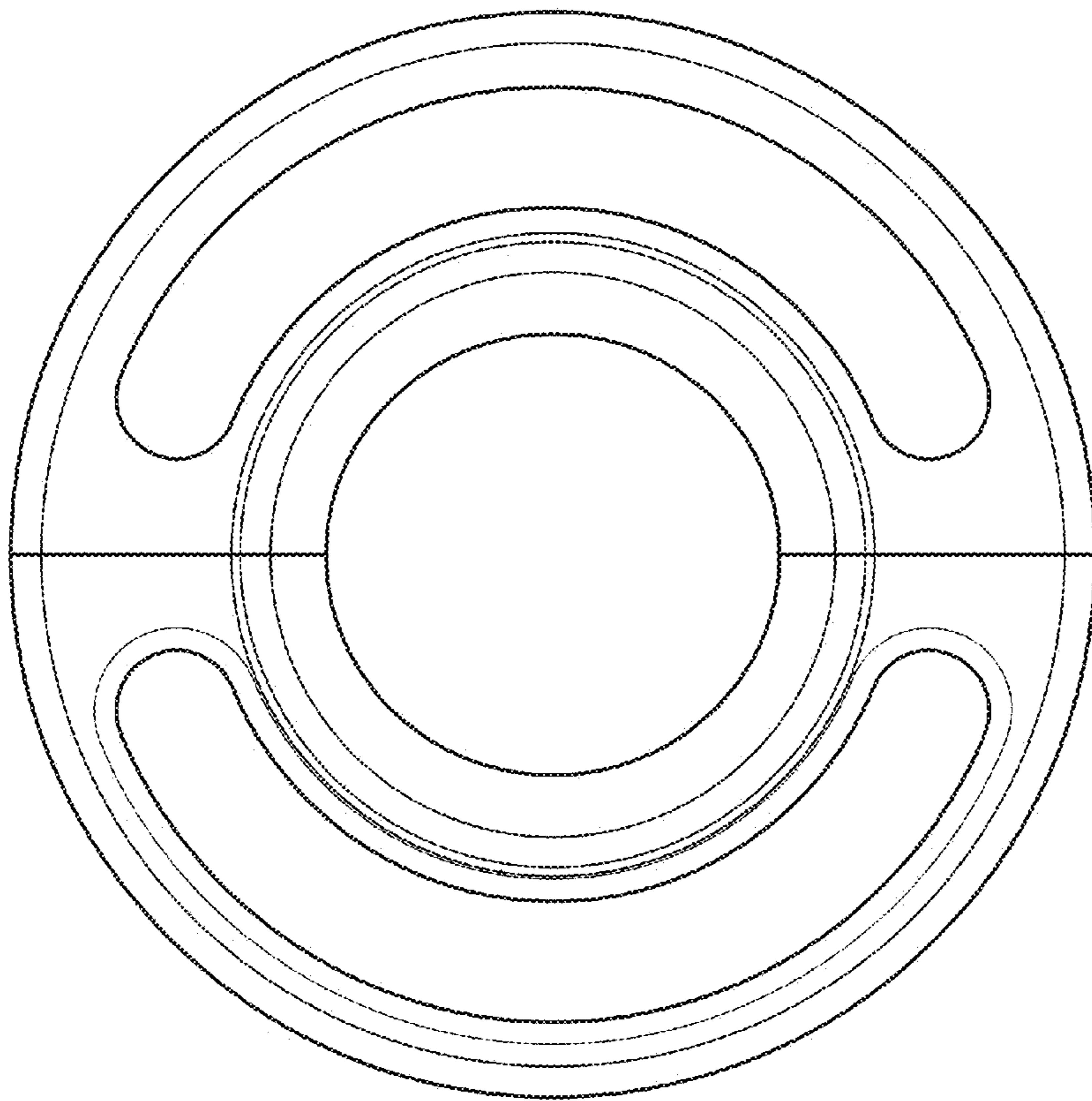

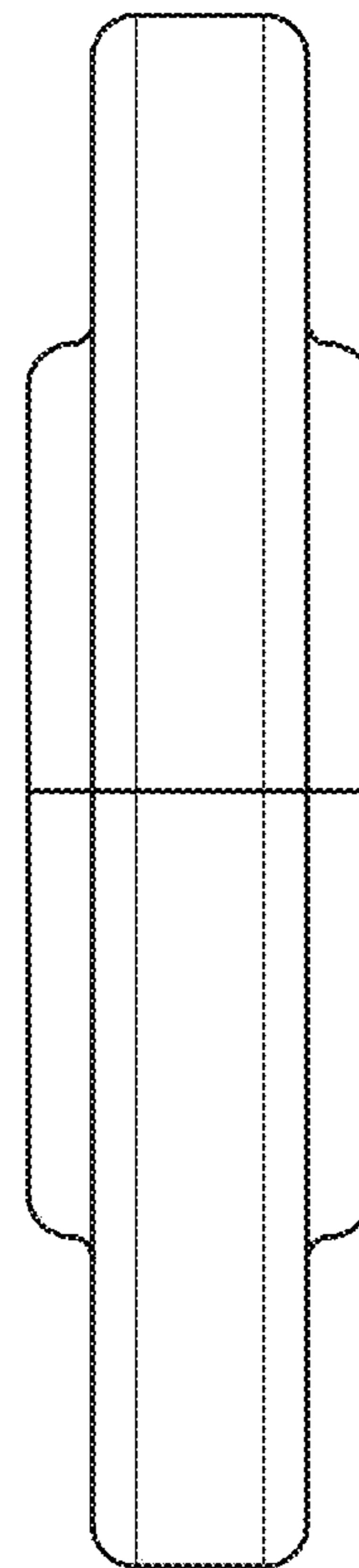
