(57) **CLAIM**

The ornamental design for a dental tool, as shown and described.

**DESCRIPTION**

FIG. 1 is a top view of a dental tool, showing my new design.  
FIG. 2 is a right side view of FIG. 1, the left side view being a mirror image of the right side view.

FIG. 3 is a bottom view of FIG. 1.

FIG. 4 is a front view of FIG. 1.

FIG. 5 is a rear view of FIG. 1.

FIG. 6 is a top view of a second embodiment of the dental tool in FIG. 1.

FIG. 7 is a right side view of FIG. 6, the left side view being a mirror image of the right side view.

FIG. 8 is a bottom view of FIG. 6.

FIG. 9 is a front view of FIG. 6.

FIG. 10 is a rear view of FIG. 6.

FIG. 11 is a top view of a third embodiment of the dental tool in FIG. 1.

FIG. 12 is a right side view of FIG. 11, the left side view being a mirror image of the right side view.

FIG. 13 is a bottom view of FIG. 11.

FIG. 14 is a front view of FIG. 11.

FIG. 15 is a rear view of FIG. 11.

FIG. 16 is a top view of a fourth embodiment of the dental tool in FIG. 1.

FIG. 17 is a right side view of FIG. 16, the left side view being a mirror image of the right side view.

FIG. 18 is a bottom view of FIG. 16.

FIG. 19 is a front view of FIG. 16.

FIG. 20 is a rear view of FIG. 16.

FIG. 21 is a top view of a fifth embodiment of the dental tool in FIG. 1.

FIG. 22 is a right side view of FIG. 21, the left side view being a mirror image of the right side view.

FIG. 23 is a bottom view of FIG. 21.

FIG. 24 is a front view of FIG. 21.

FIG. 25 is a rear view of FIG. 21.

FIG. 26 is a top view of a sixth embodiment of the dental tool in FIG. 1.

FIG. 27 is a right side view of FIG. 26, the left side view being a mirror image of the right side view.

FIG. 28 is a bottom view of FIG. 26.

FIG. 29 is a front view of FIG. 26; and,

FIG. 30 is a rear view of FIG. 26.

The broken lines shown in the figures are included for the purpose of illustrating portions of the dental tool and form no part of the claimed design.

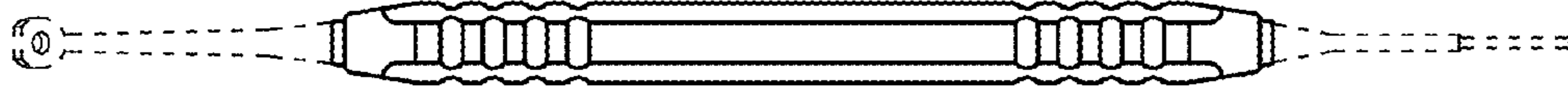

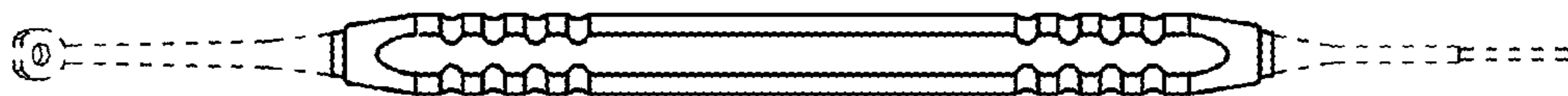

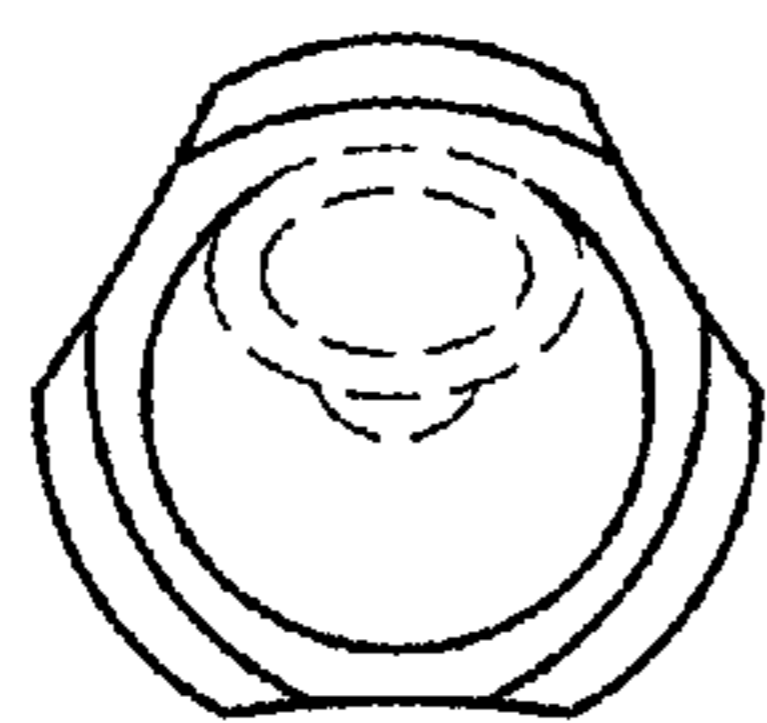

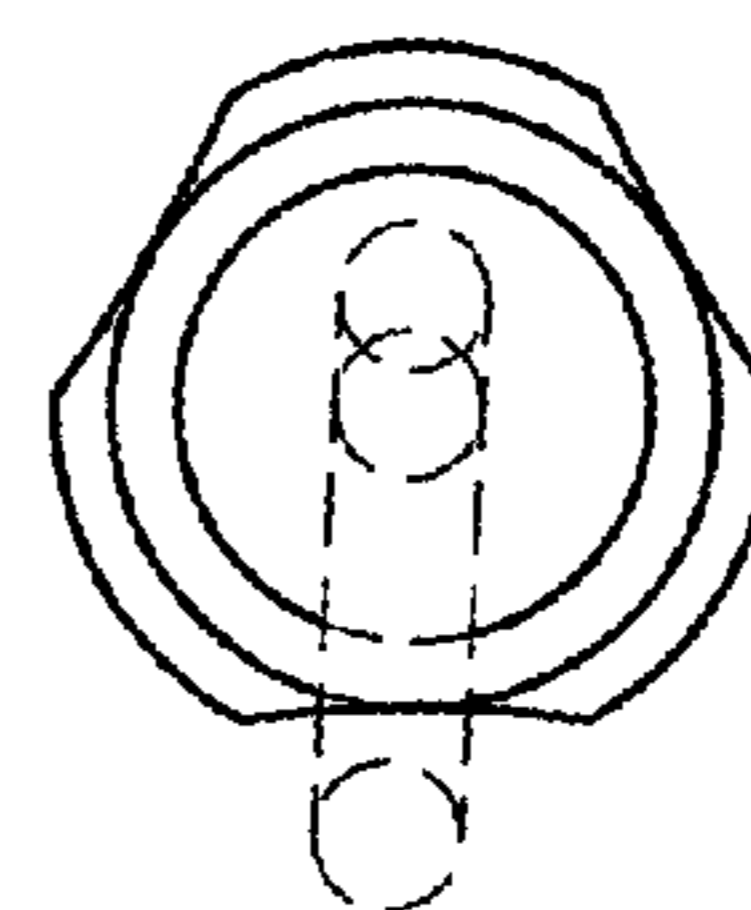

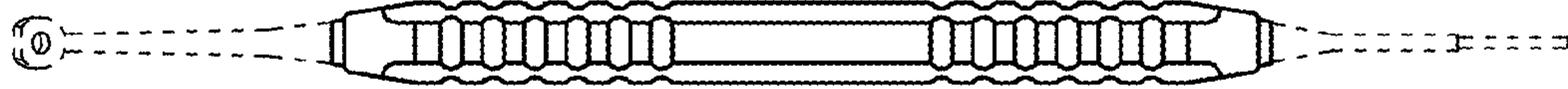

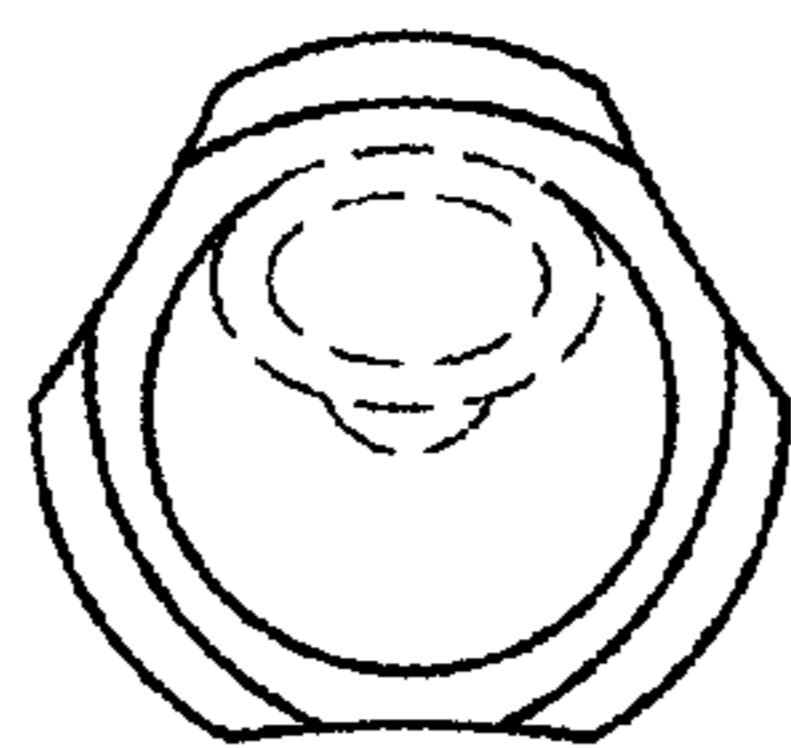

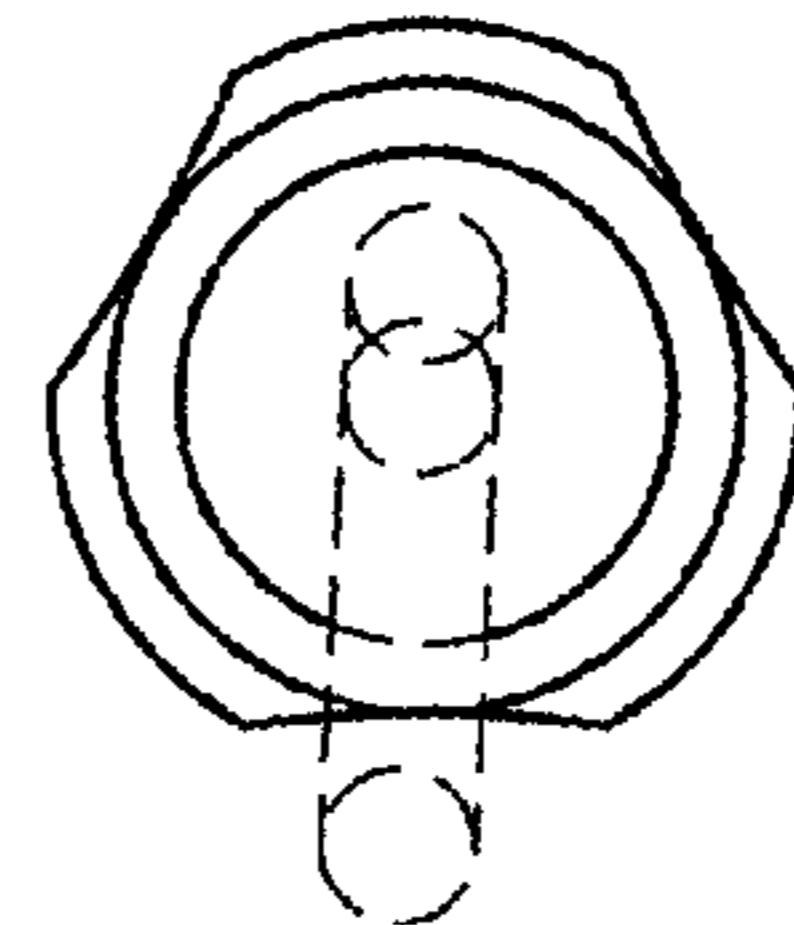

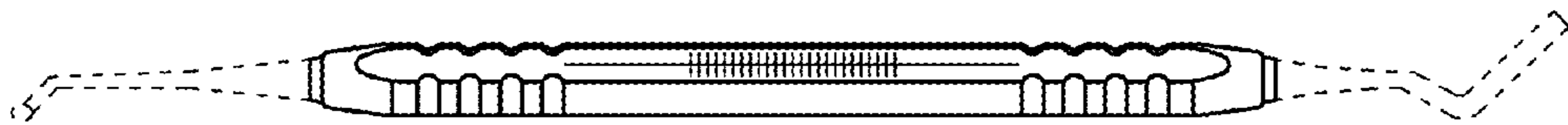

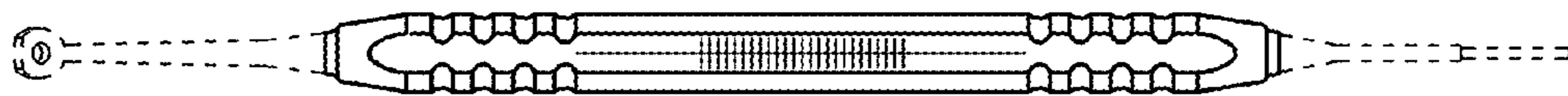

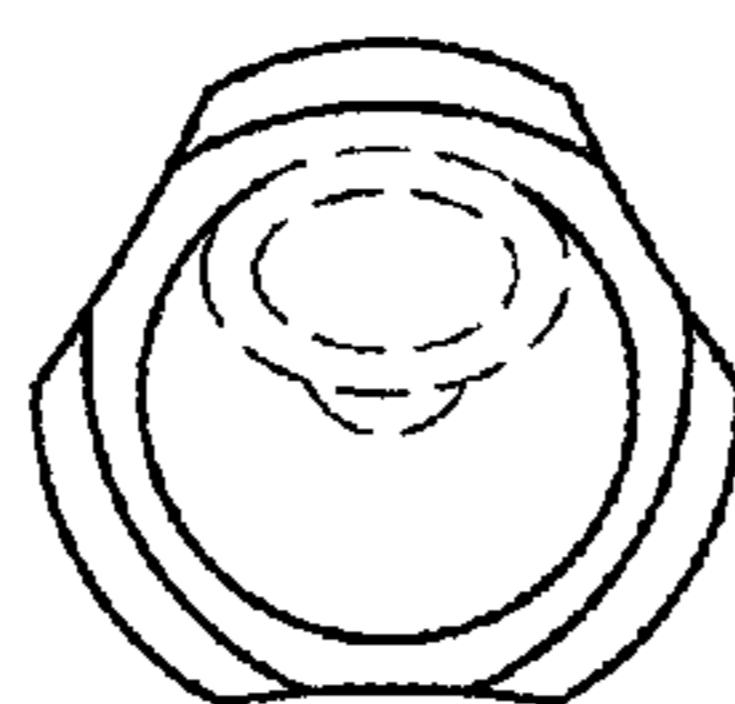

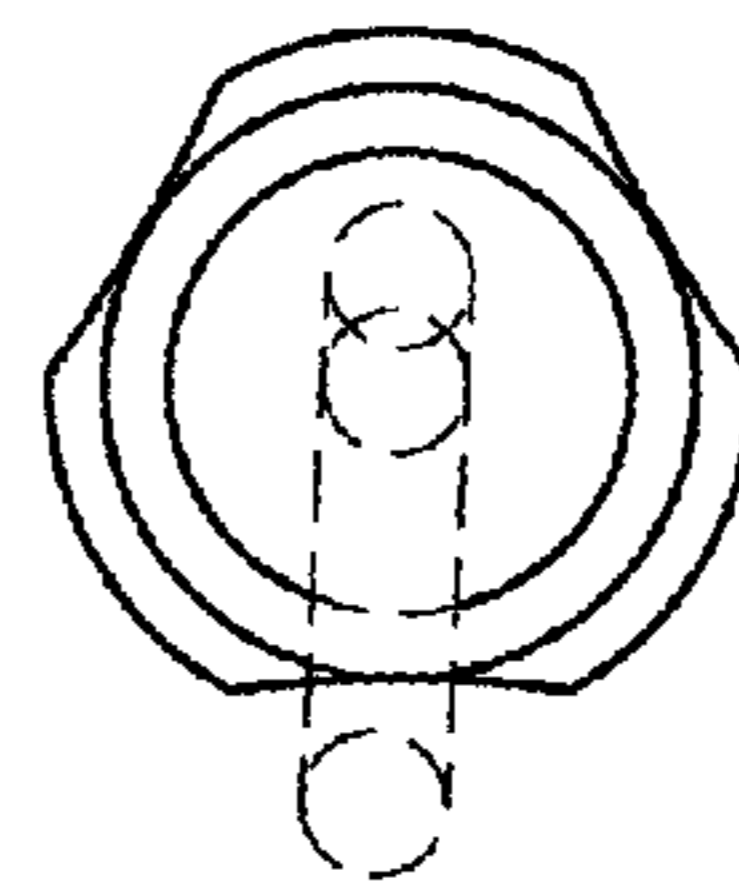

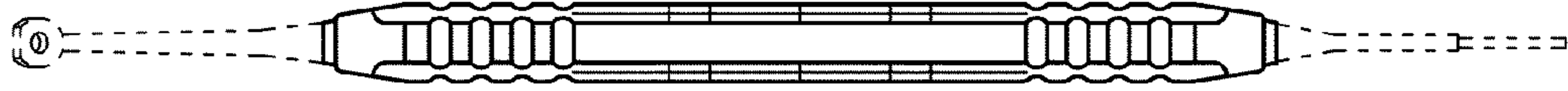

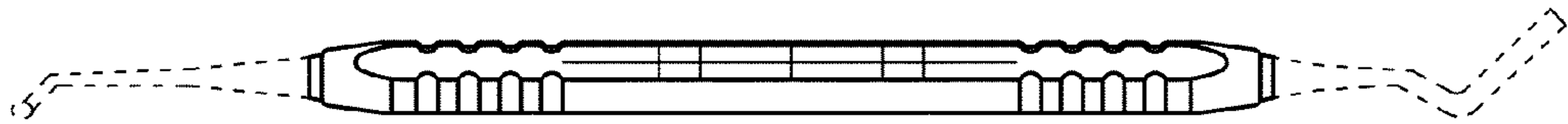

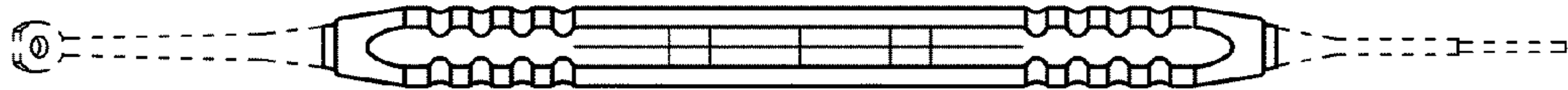

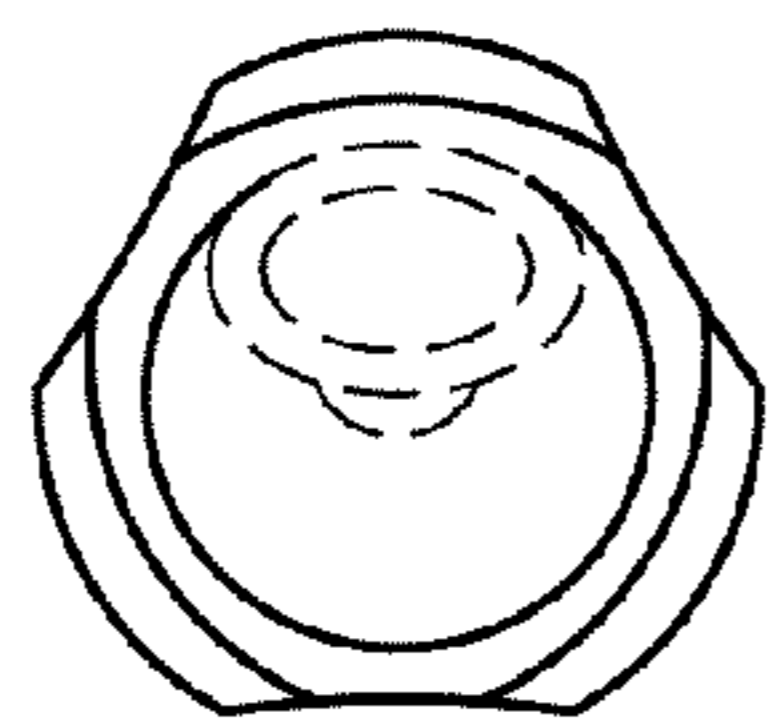

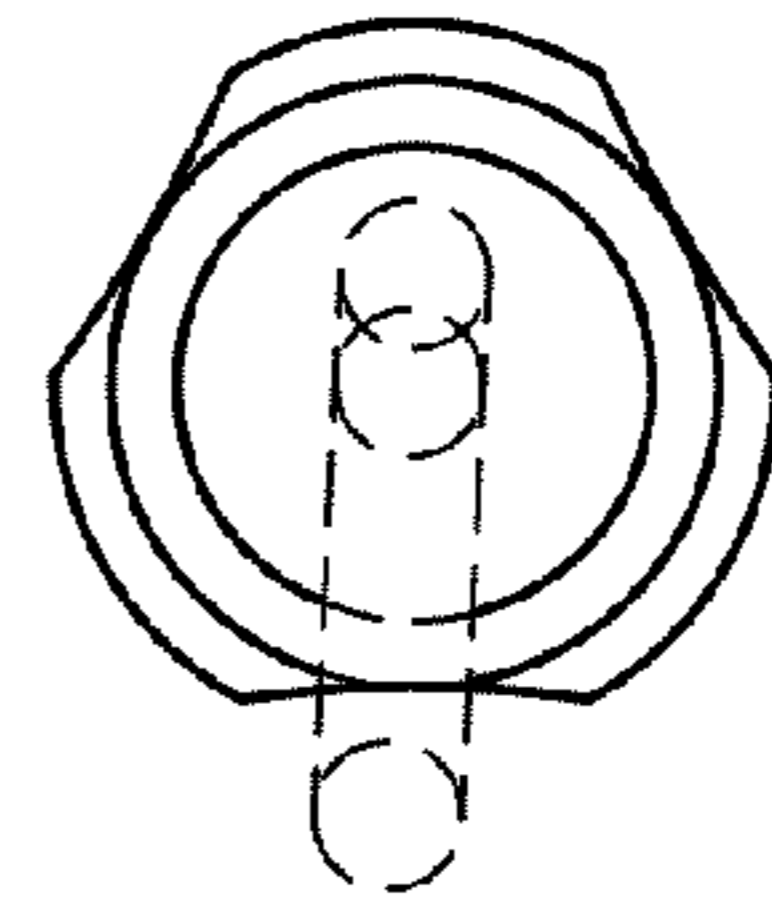

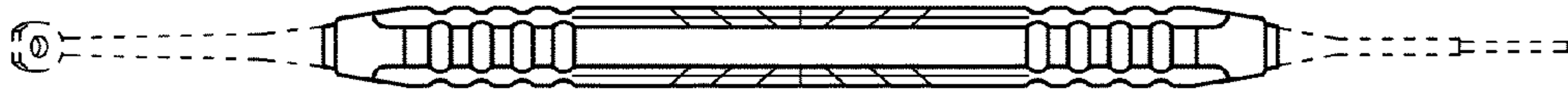

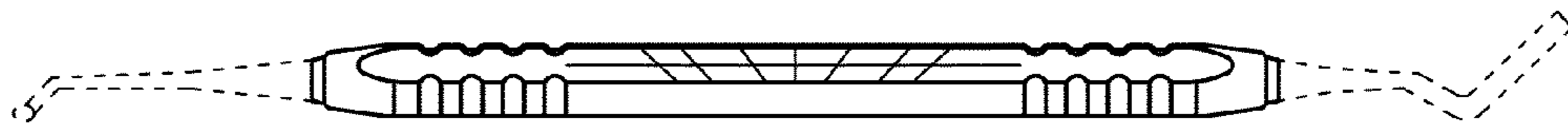

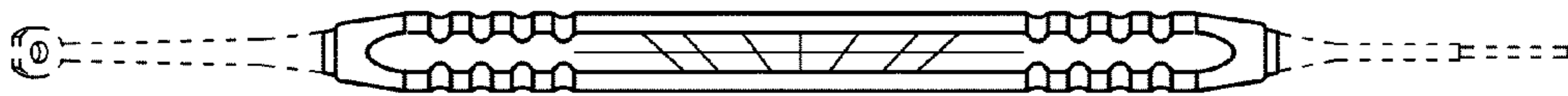

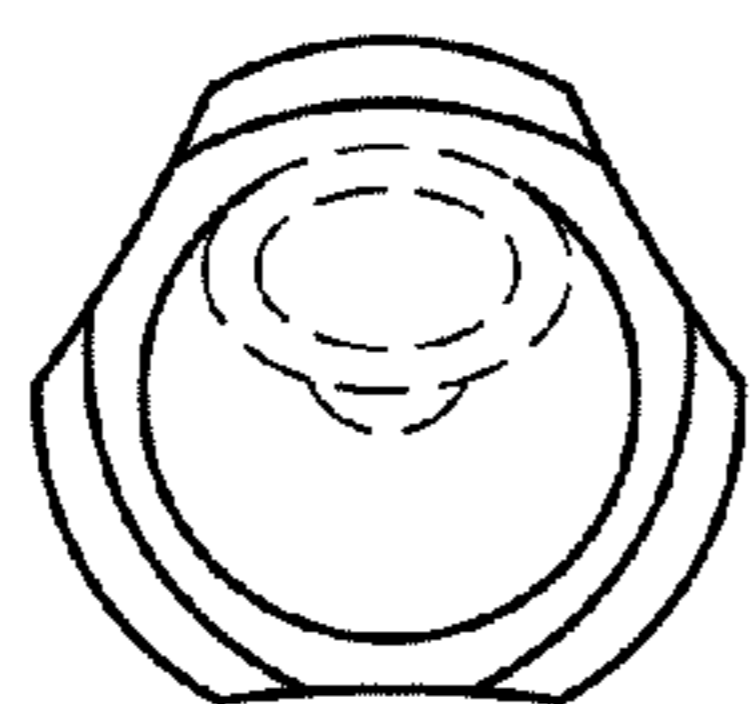

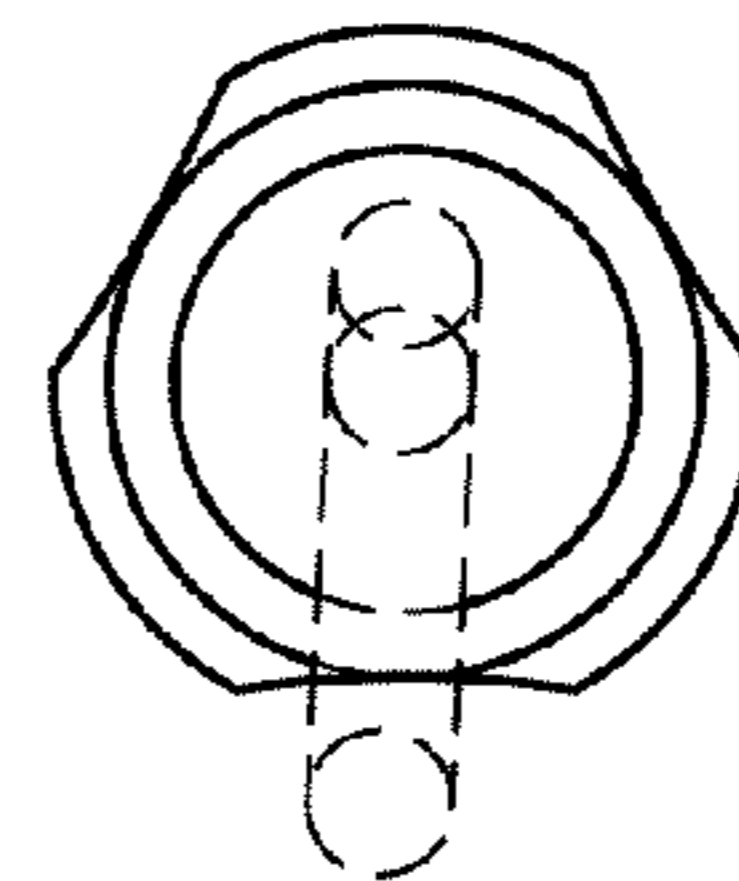

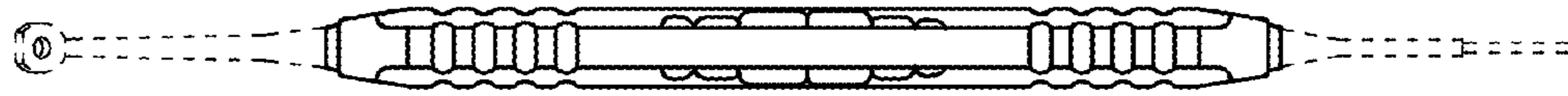

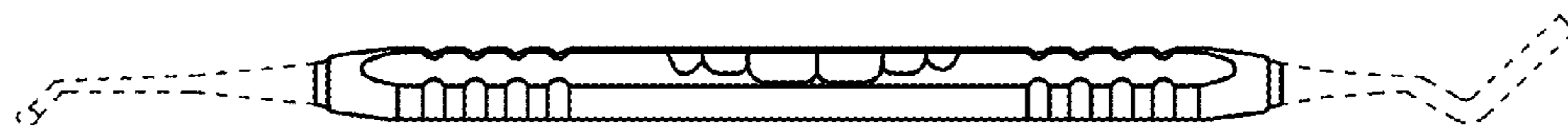

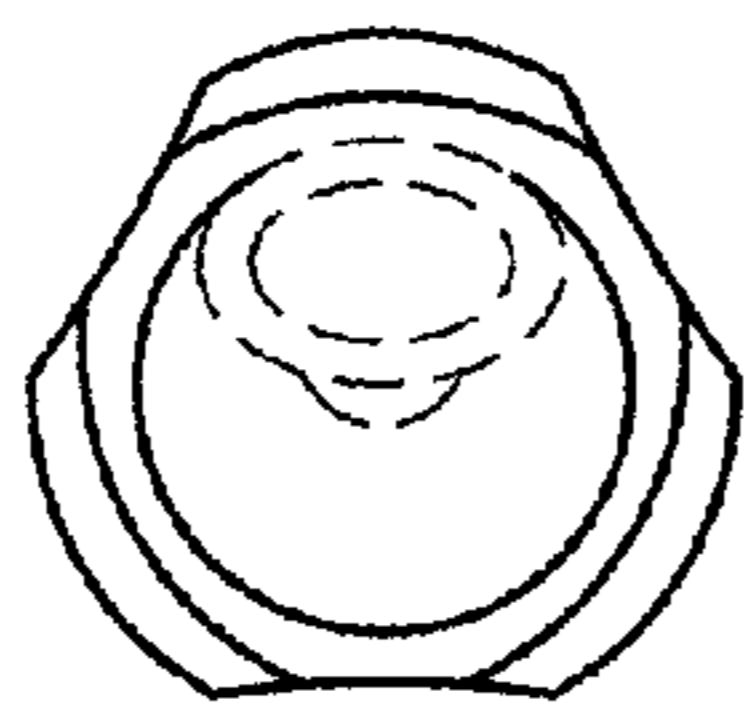
