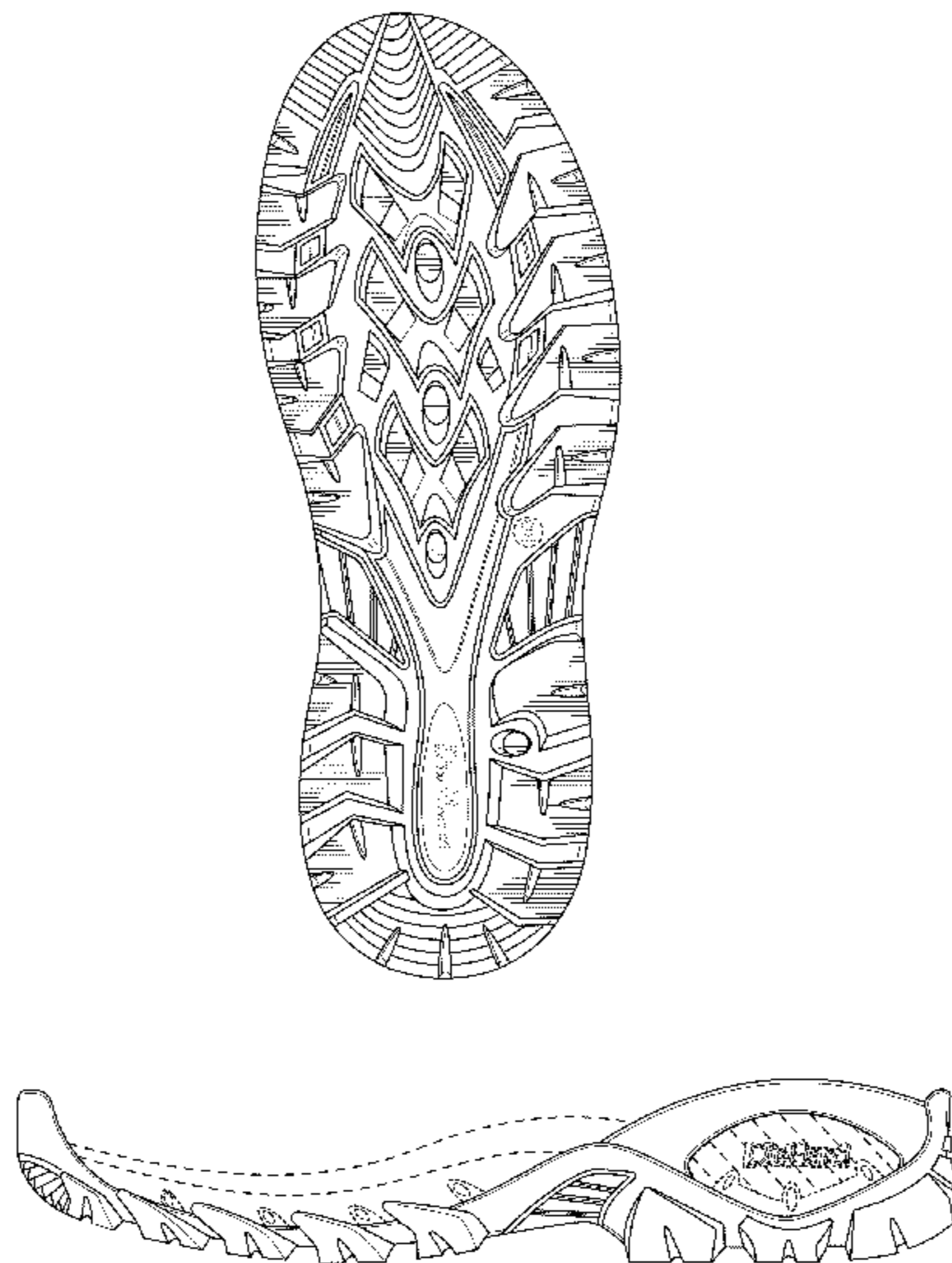

What is claimed is the ornamental design for a shoe outsole,  
as shown and described.

**DESCRIPTION**

FIG. 1 is a bottom front perspective view of a shoe outsole  
showing the new design;  
FIG. 2 is a bottom plan view thereof;  
FIG. 3 is a right side elevational view thereof;  
FIG. 4 is a left side elevational view thereof;  
FIG. 5 is a front side view thereof; and,  
FIG. 6 is a rear side view thereof.  
Any elements shown in dotted lines are provided for purposes  
of illustrating portions of the shoe outsole that form no part of  
the claimed design.

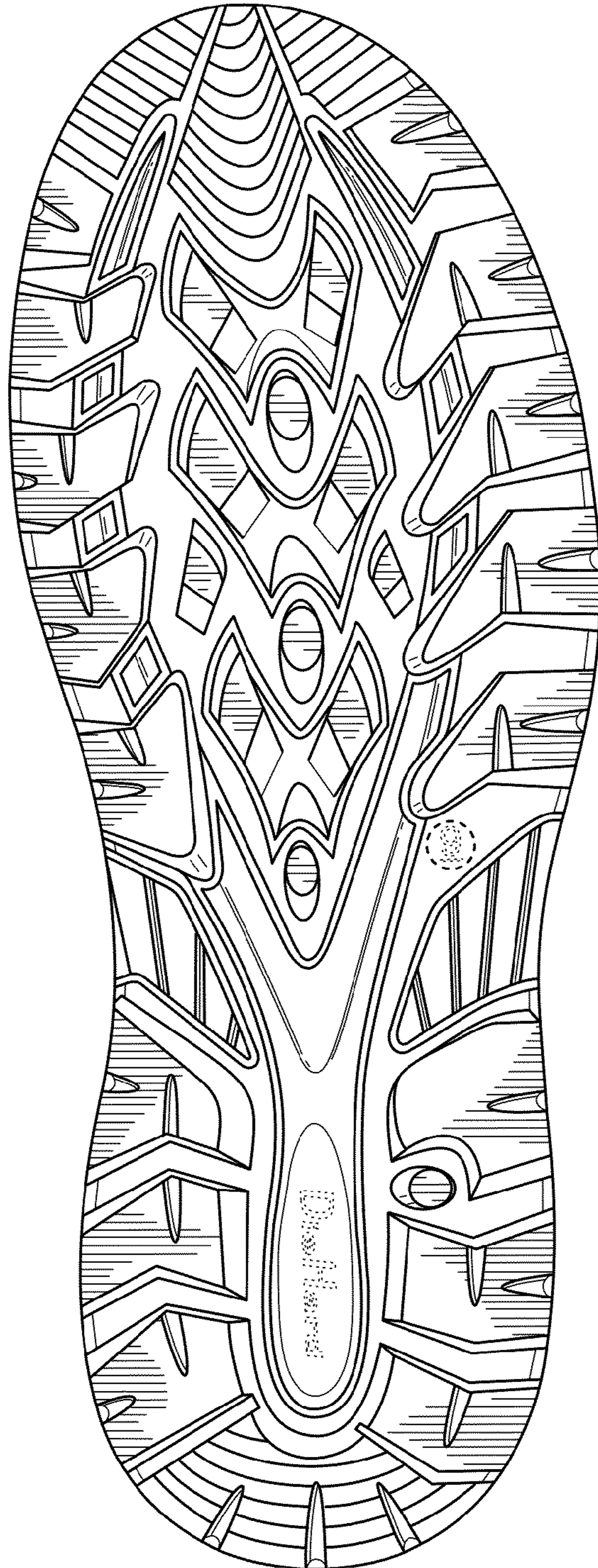

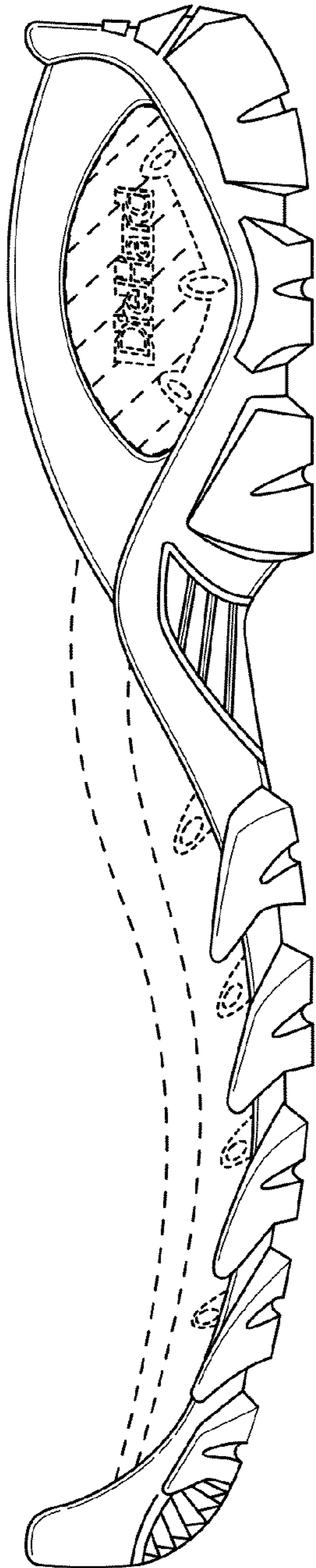

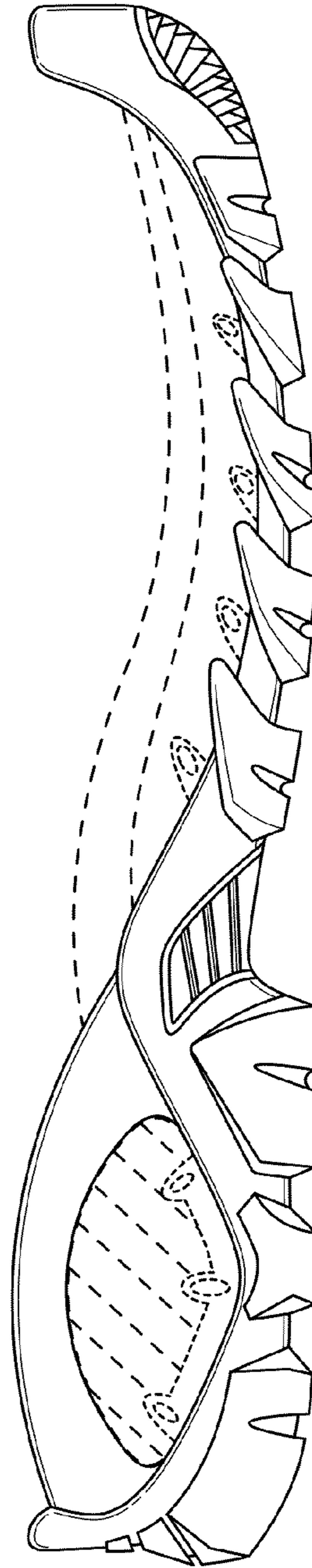

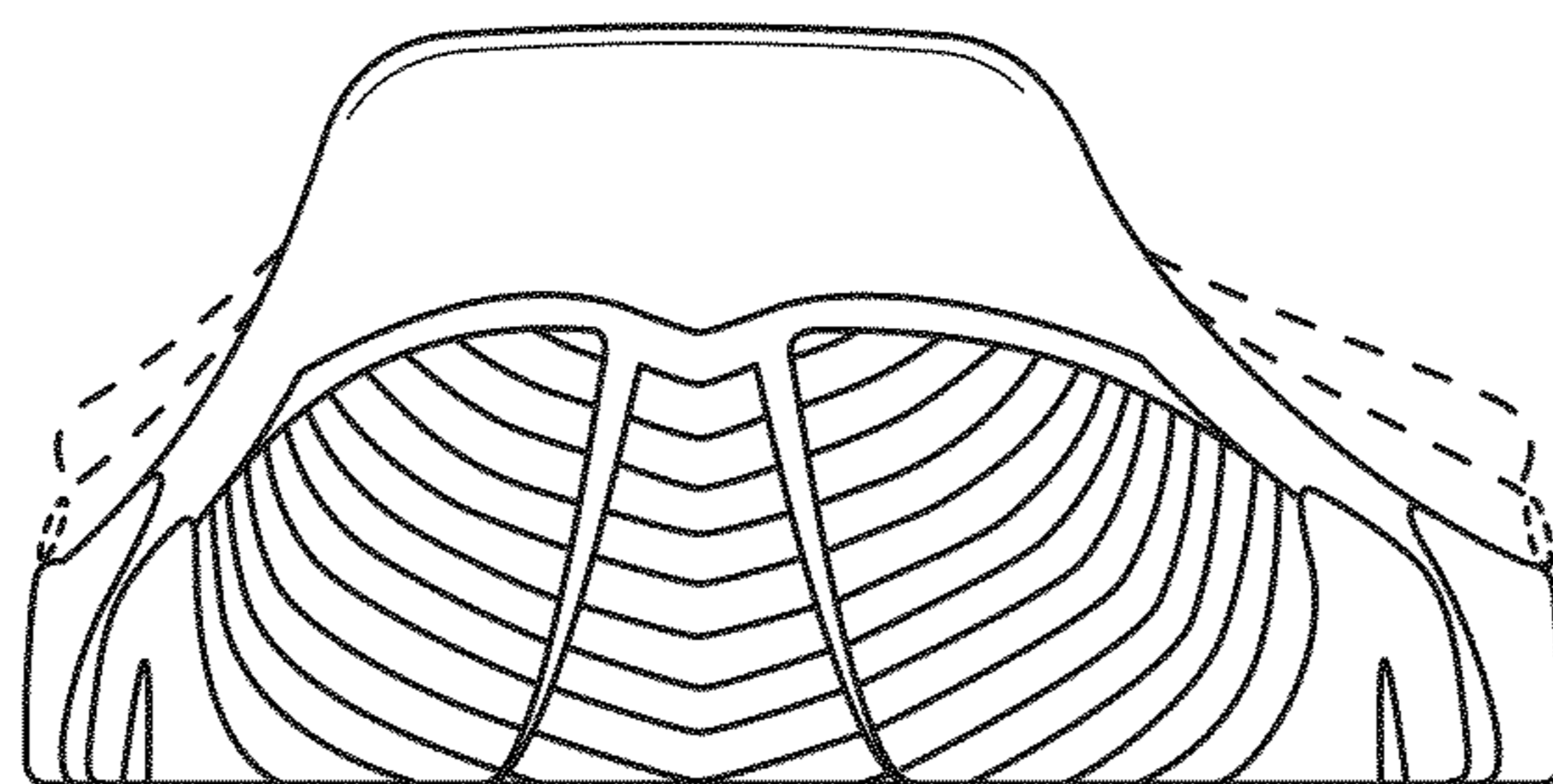

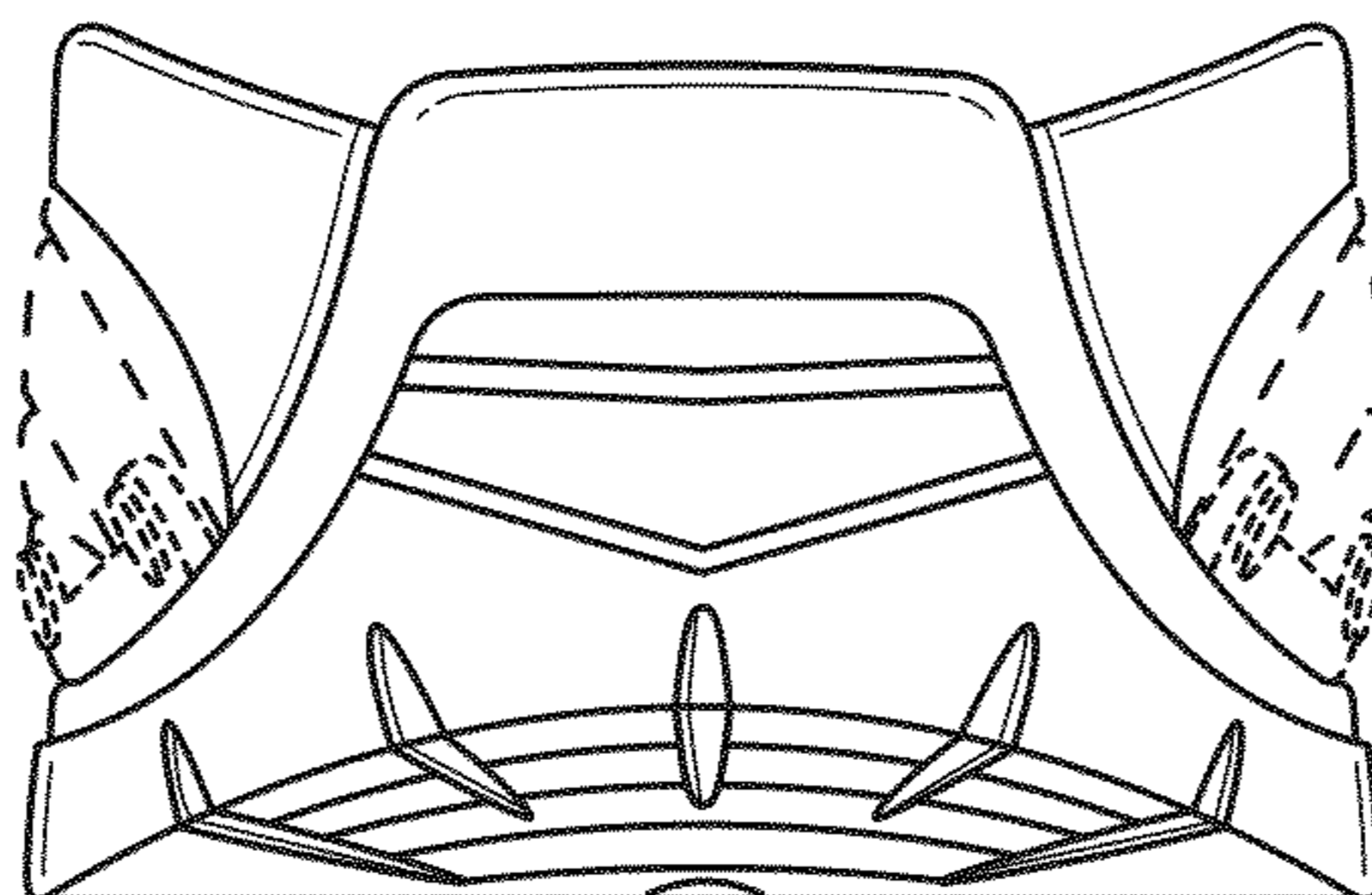
