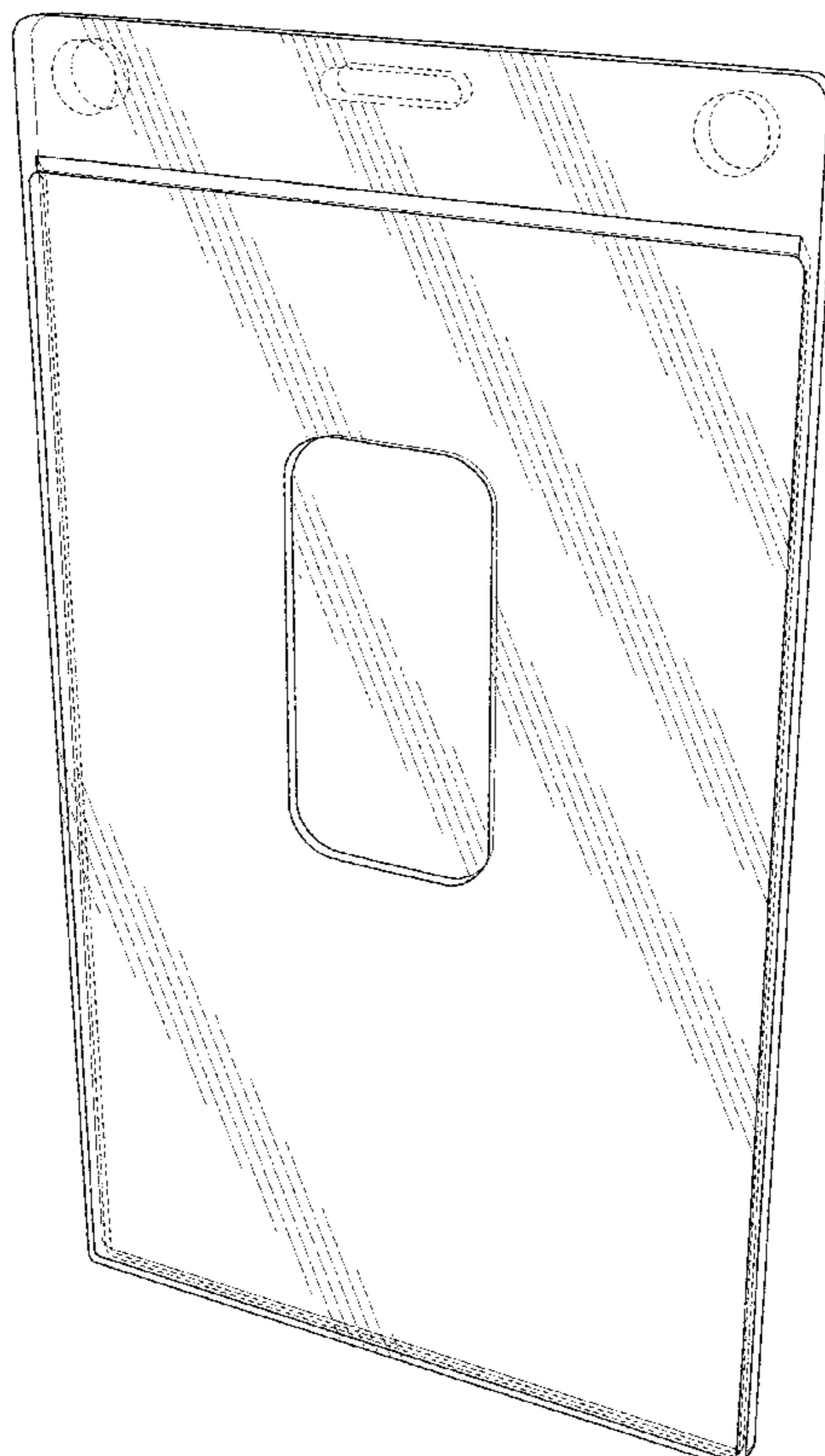
(57) **CLAIM**  
 The ornamental design for a single slot badge holder, as shown and described.

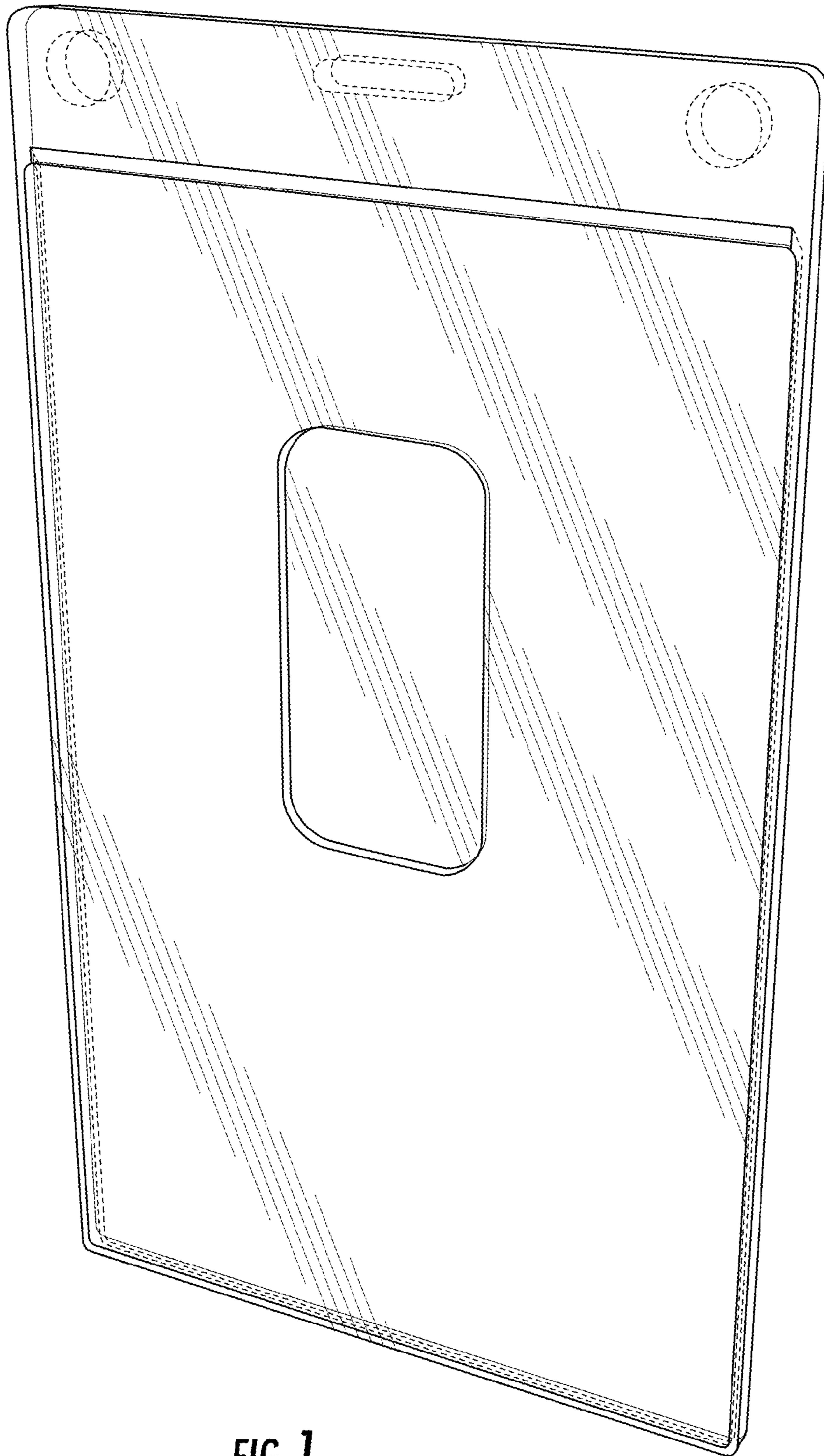
**DESCRIPTION**

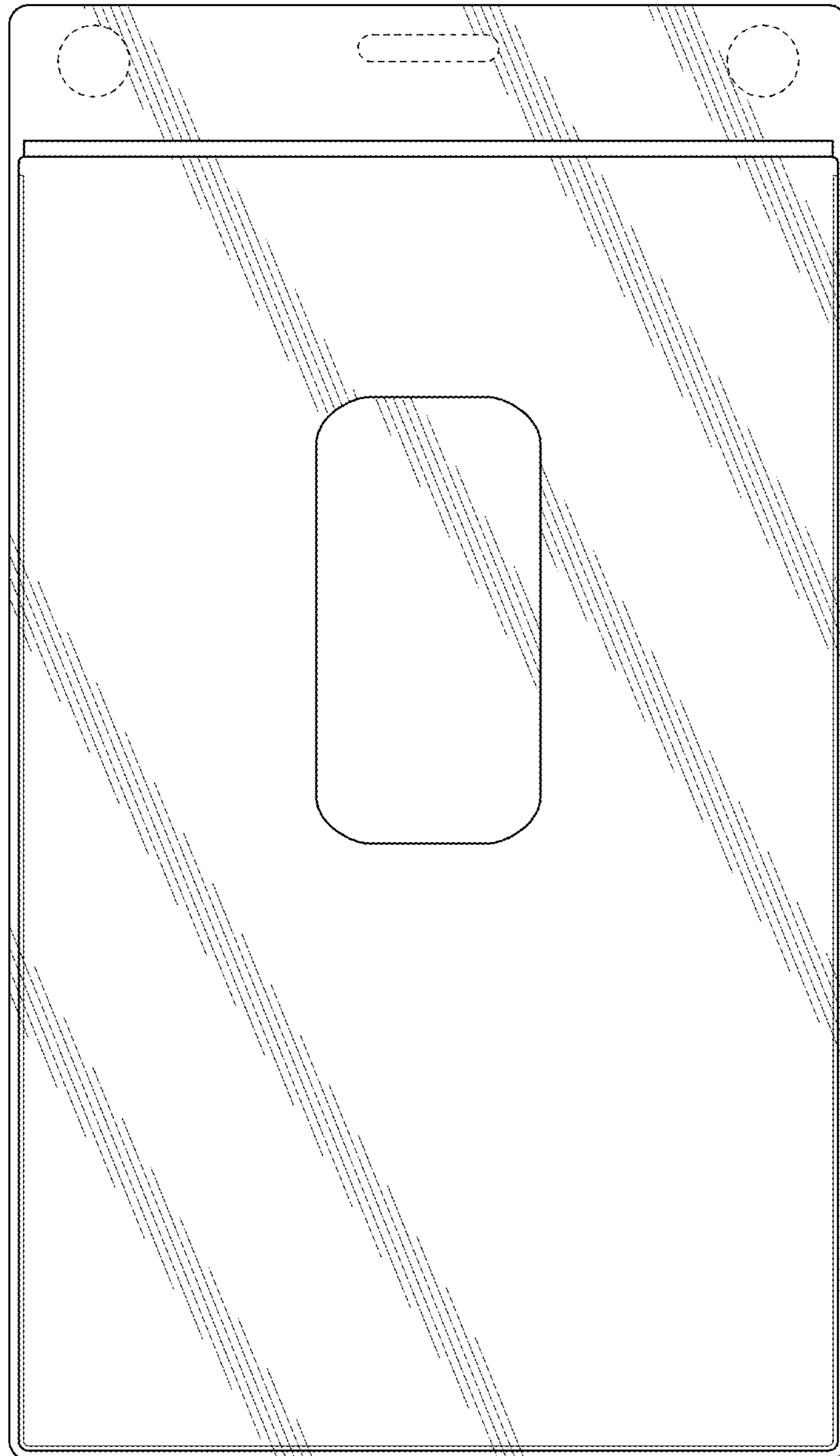
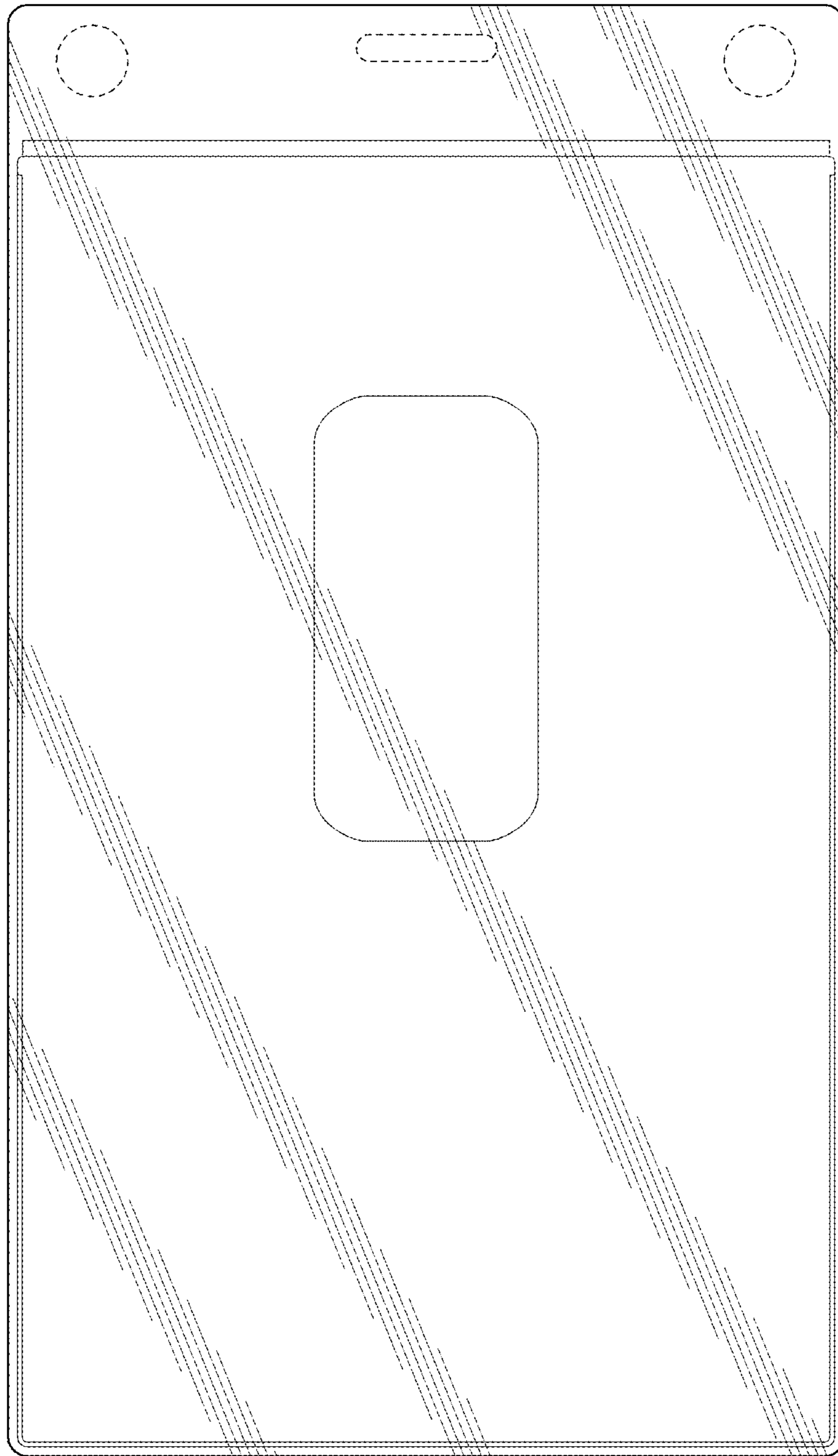

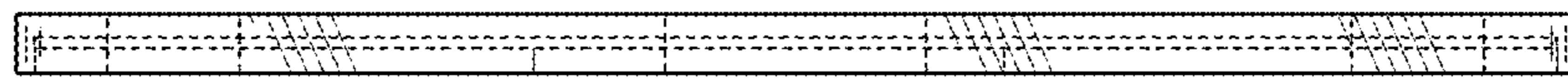

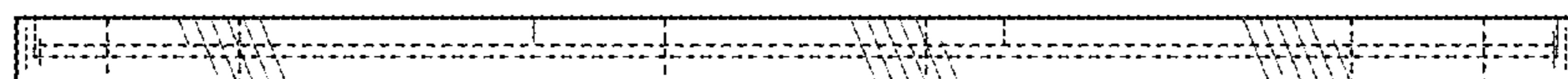
