The ornamental design for a split clothing hanger, as shown and described.

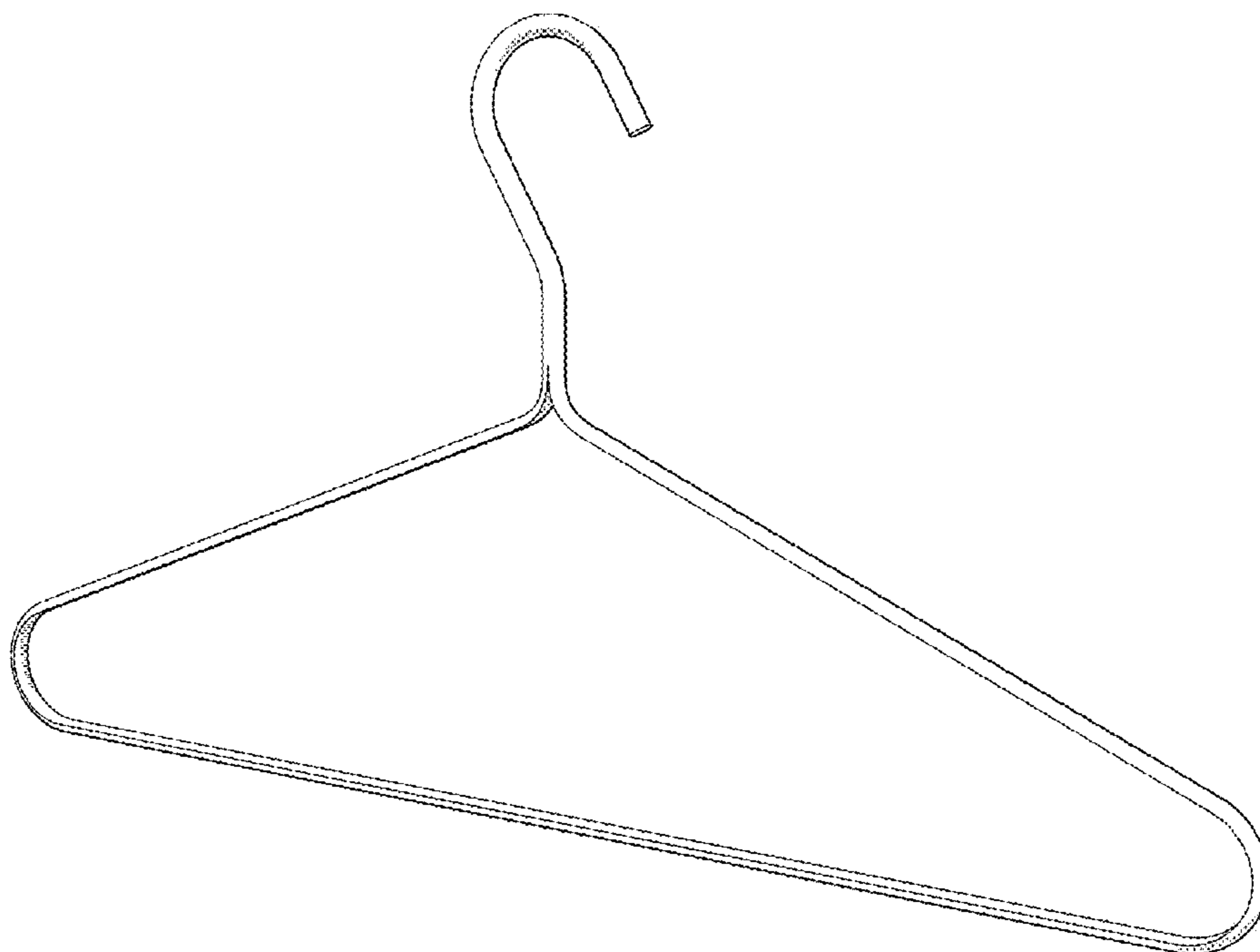

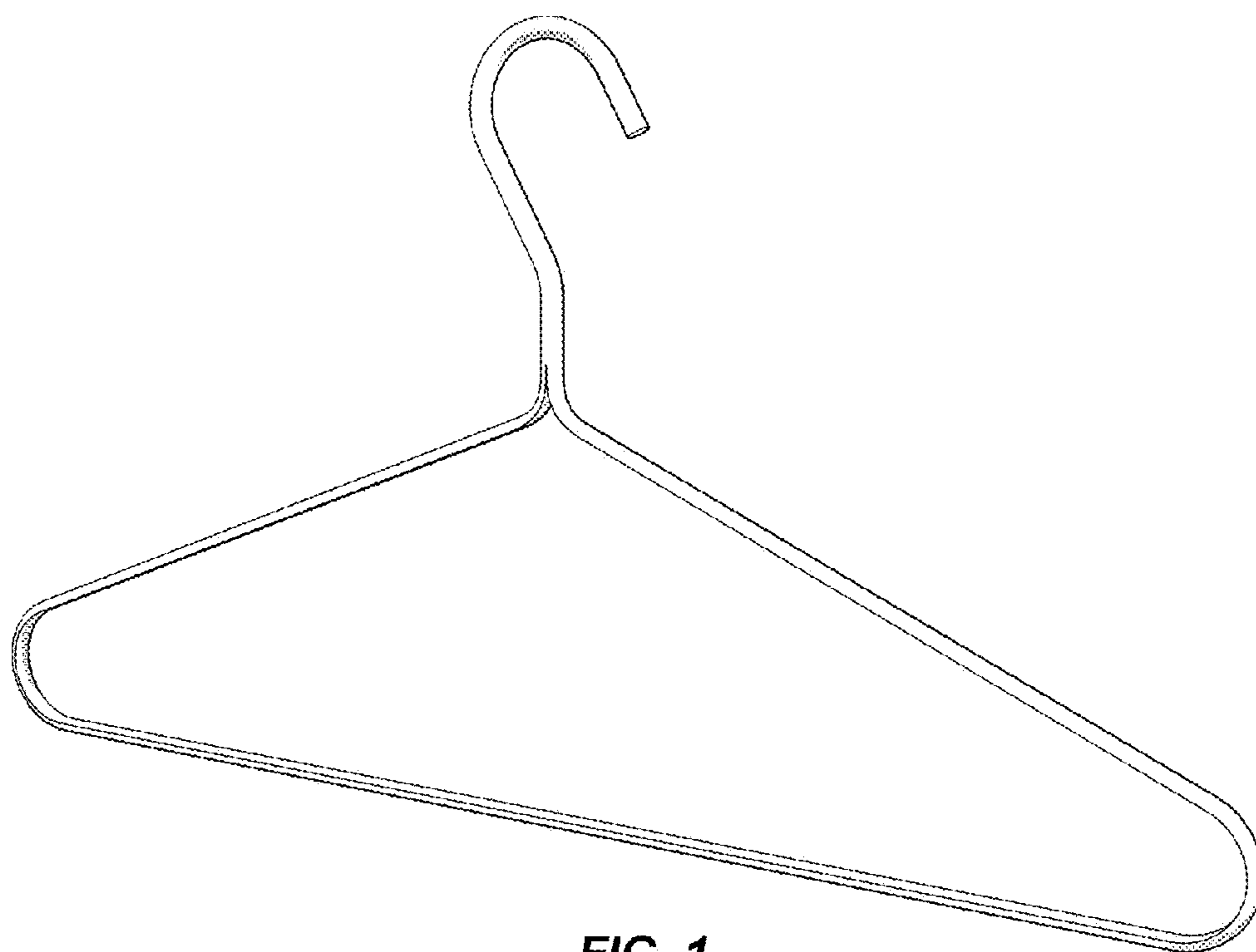

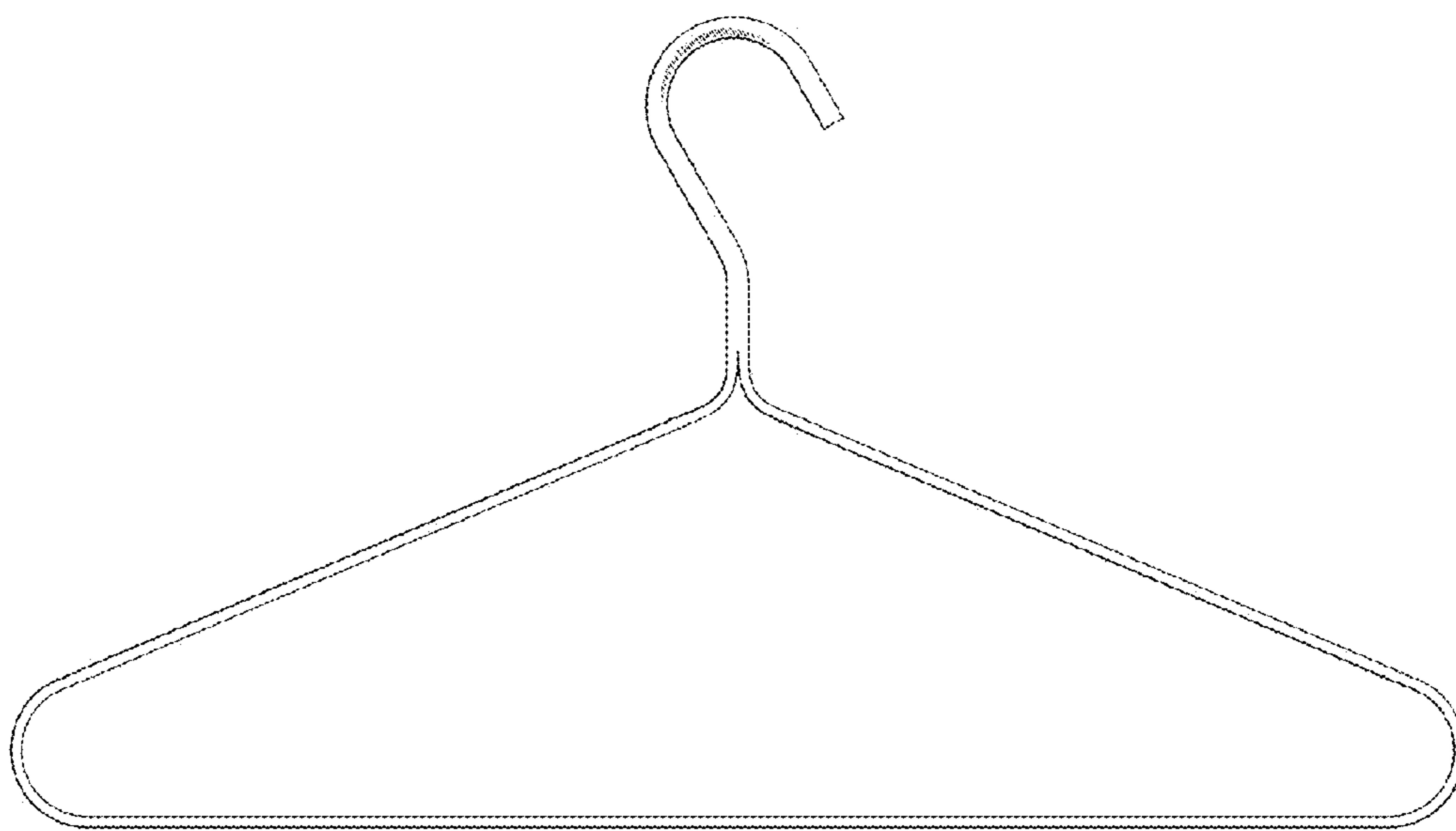

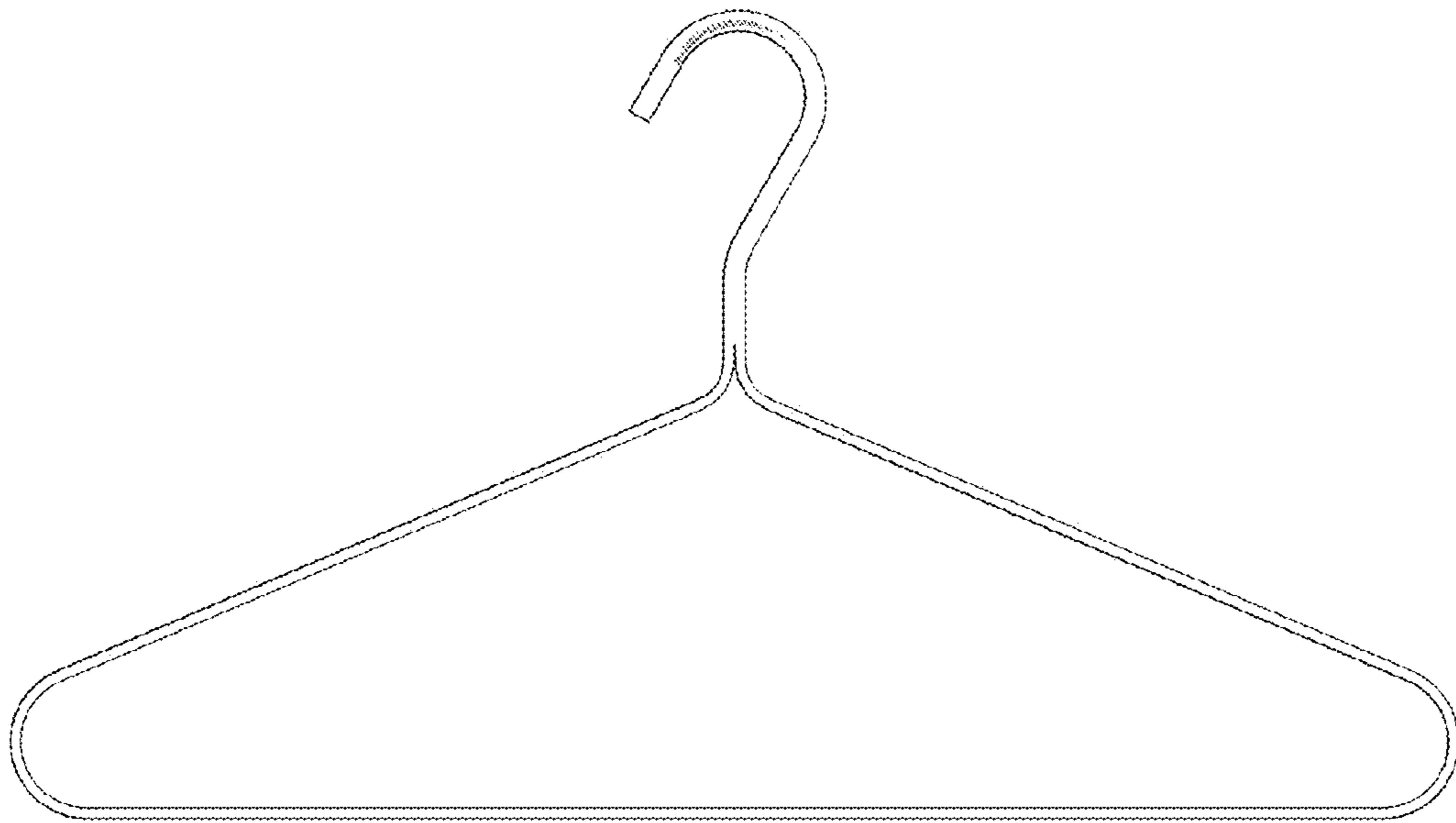

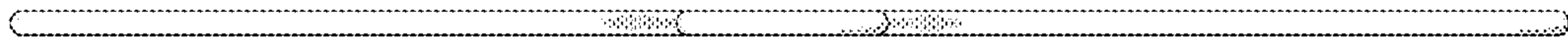

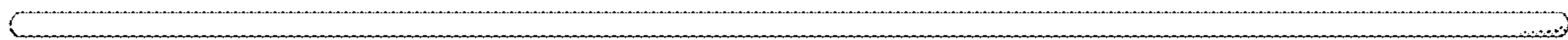

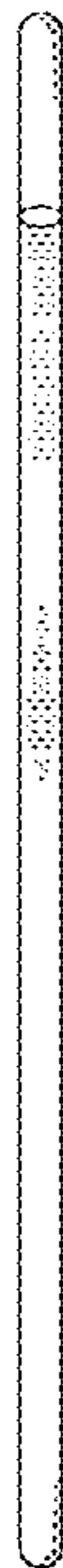

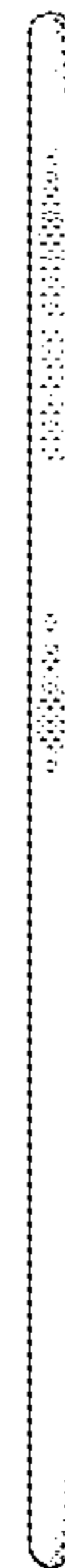
