(57) **CLAIM**

I claim the ornamental design for a car seat foam, as shown and described.

DESCRIPTION

FIG. 1 depicts a perspective three quarter elevational view of a car seat foam backrest, according to the invention.

FIG. 2 depicts a front elevational view of a car seat foam backrest thereof;

FIG. 3 depicts a left side elevational view of a car seat foam (backrest and bottom) thereof;

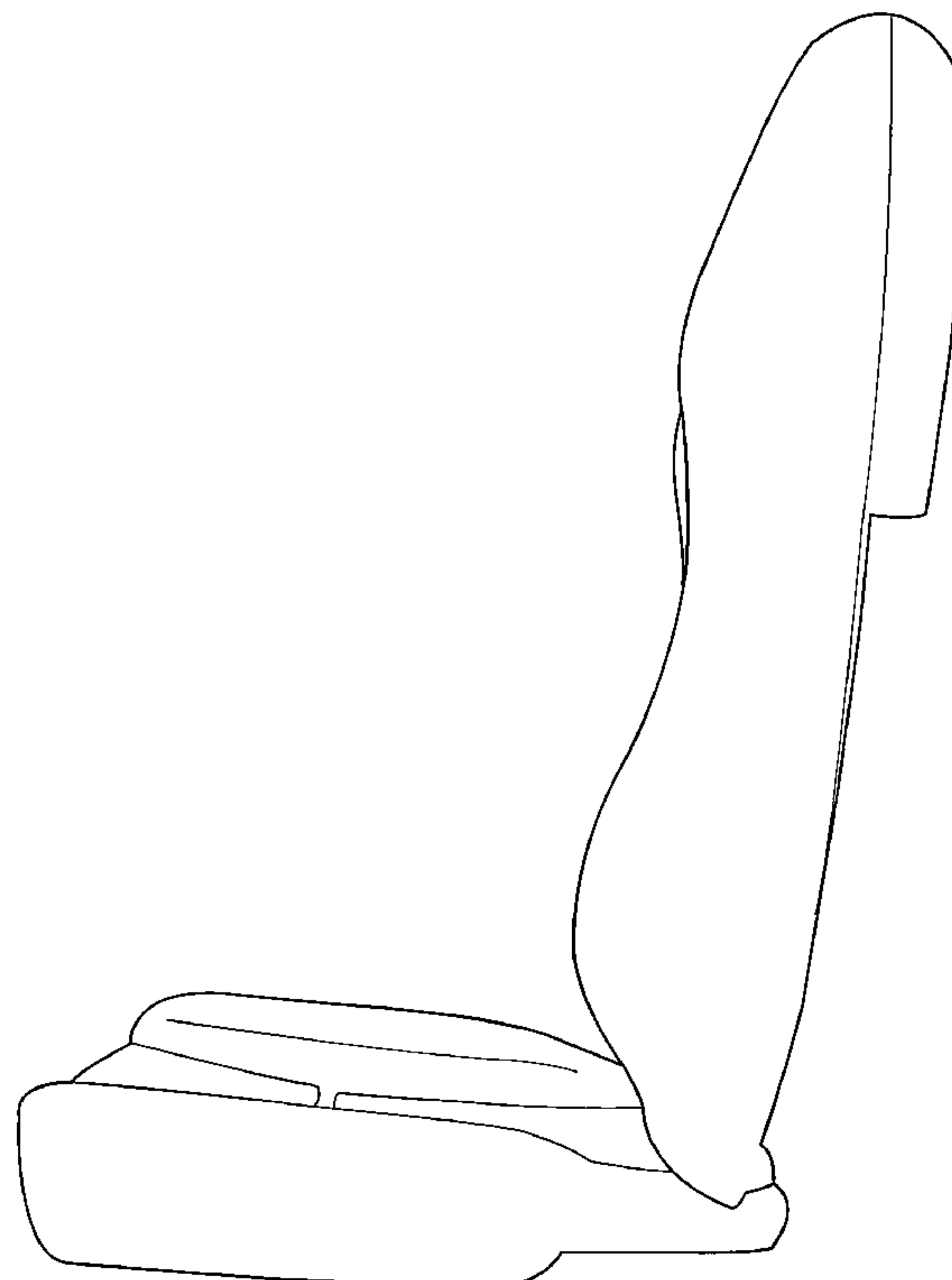
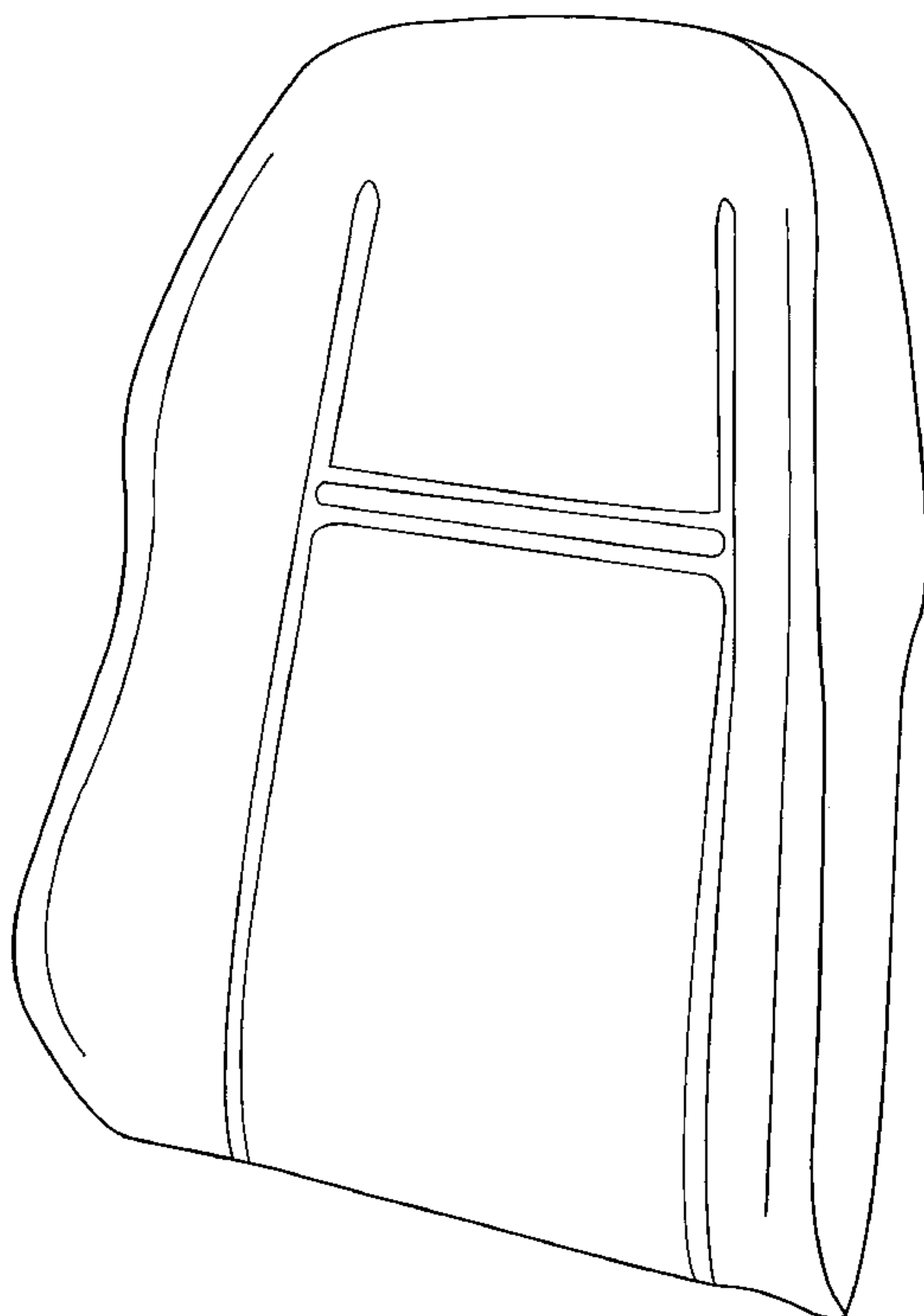
FIG. 4 depicts a right side elevational view of a car seat foam (backrest and bottom) thereof;

FIG. 5 depicts a perspective front view of a car seat foam bottom thereof; and,

FIG. 6 depicts a perspective three quarter elevational view of a car seat foam bottom thereof.

FIGS. 1, 2, 5 and 6 show the car seat foam bottom or the car seat foam backrest separately for ease of illustration.

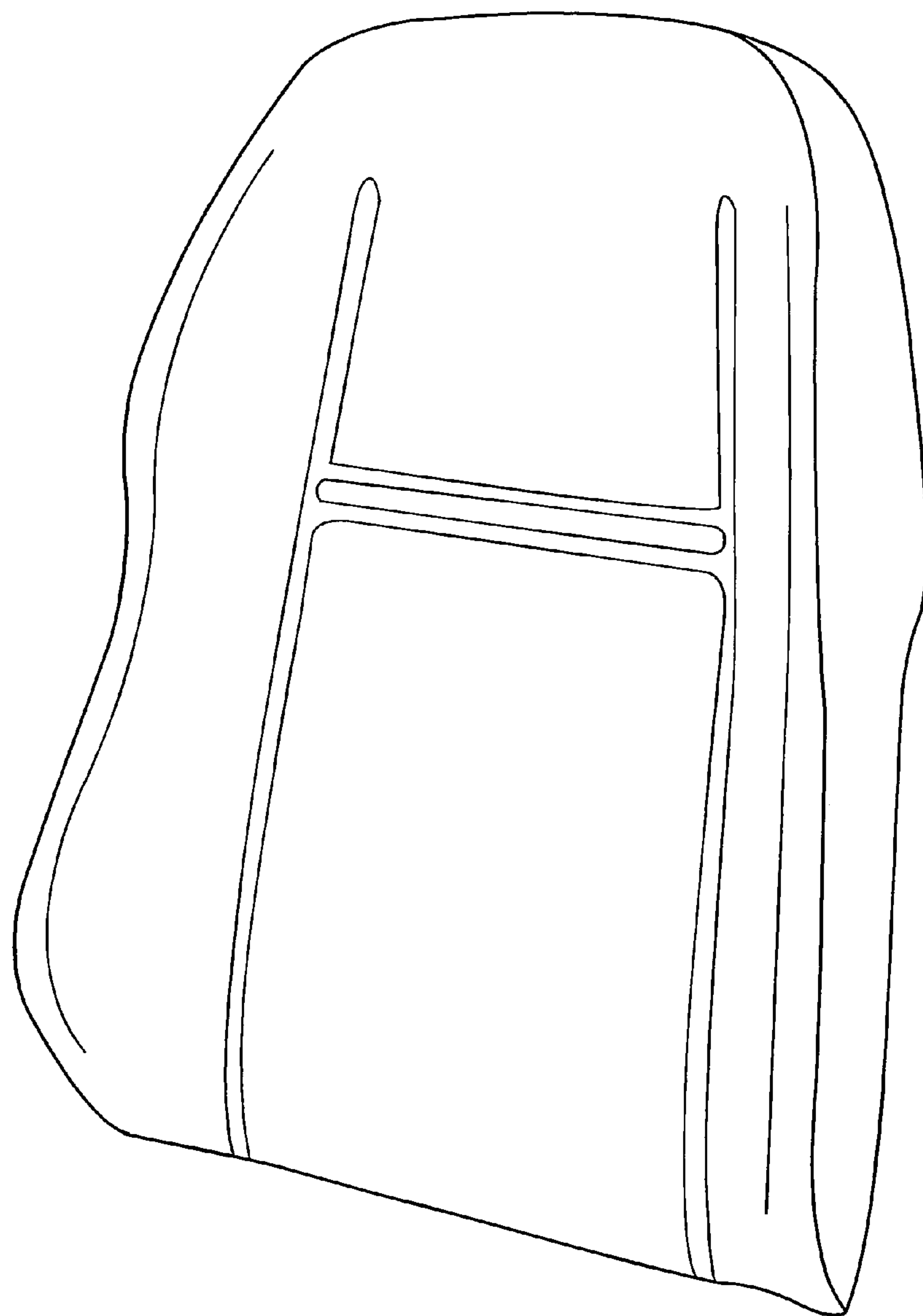

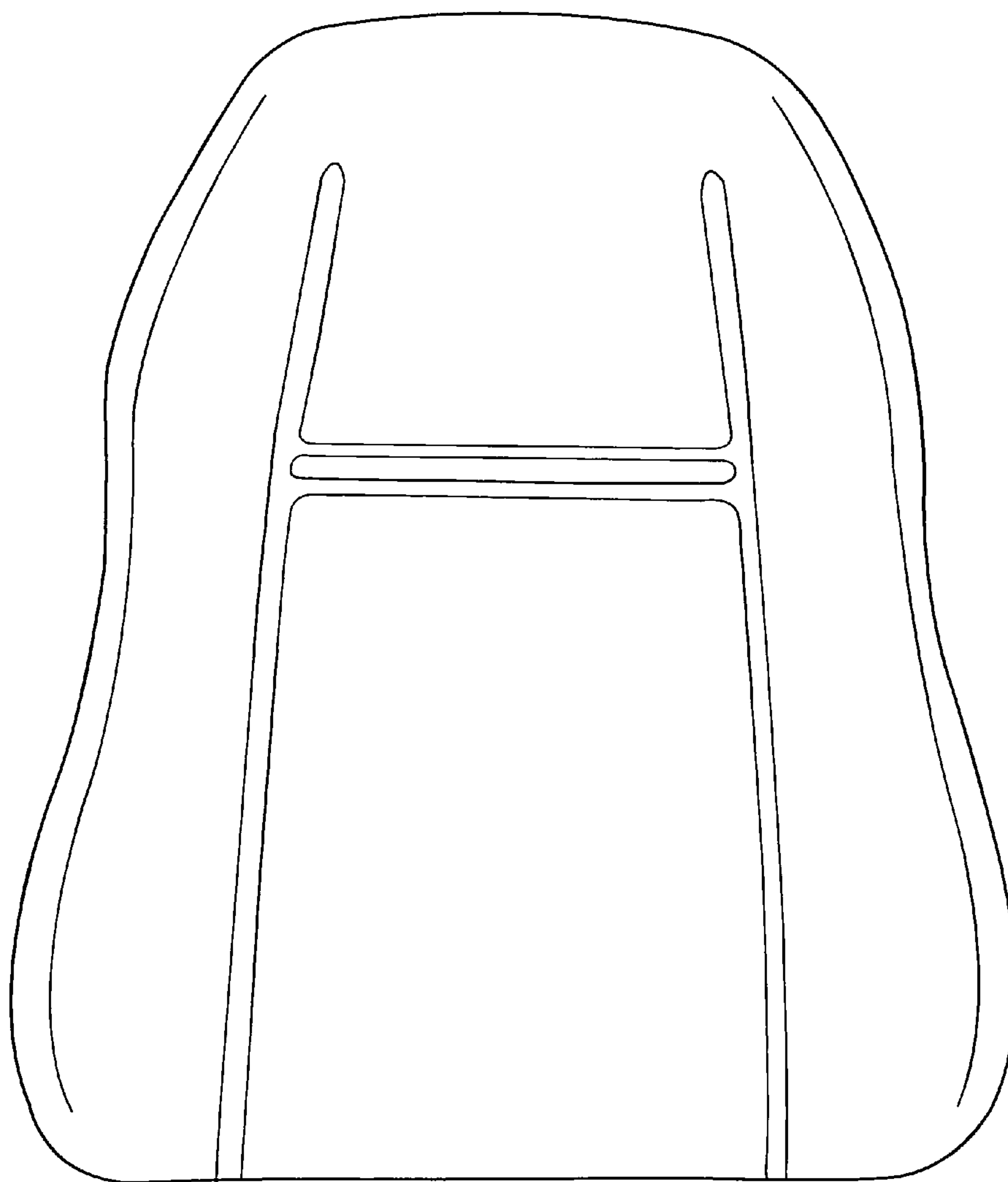

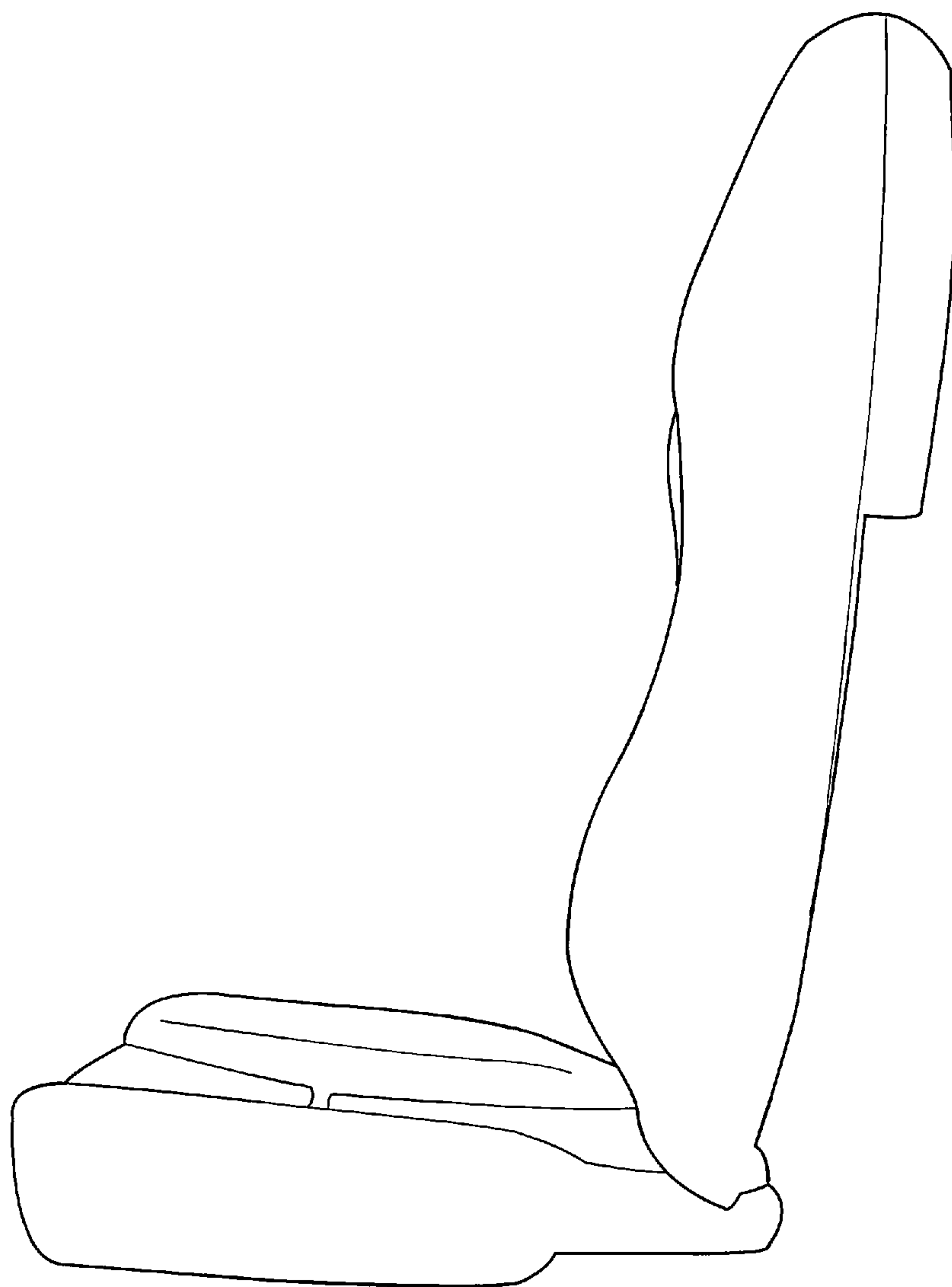

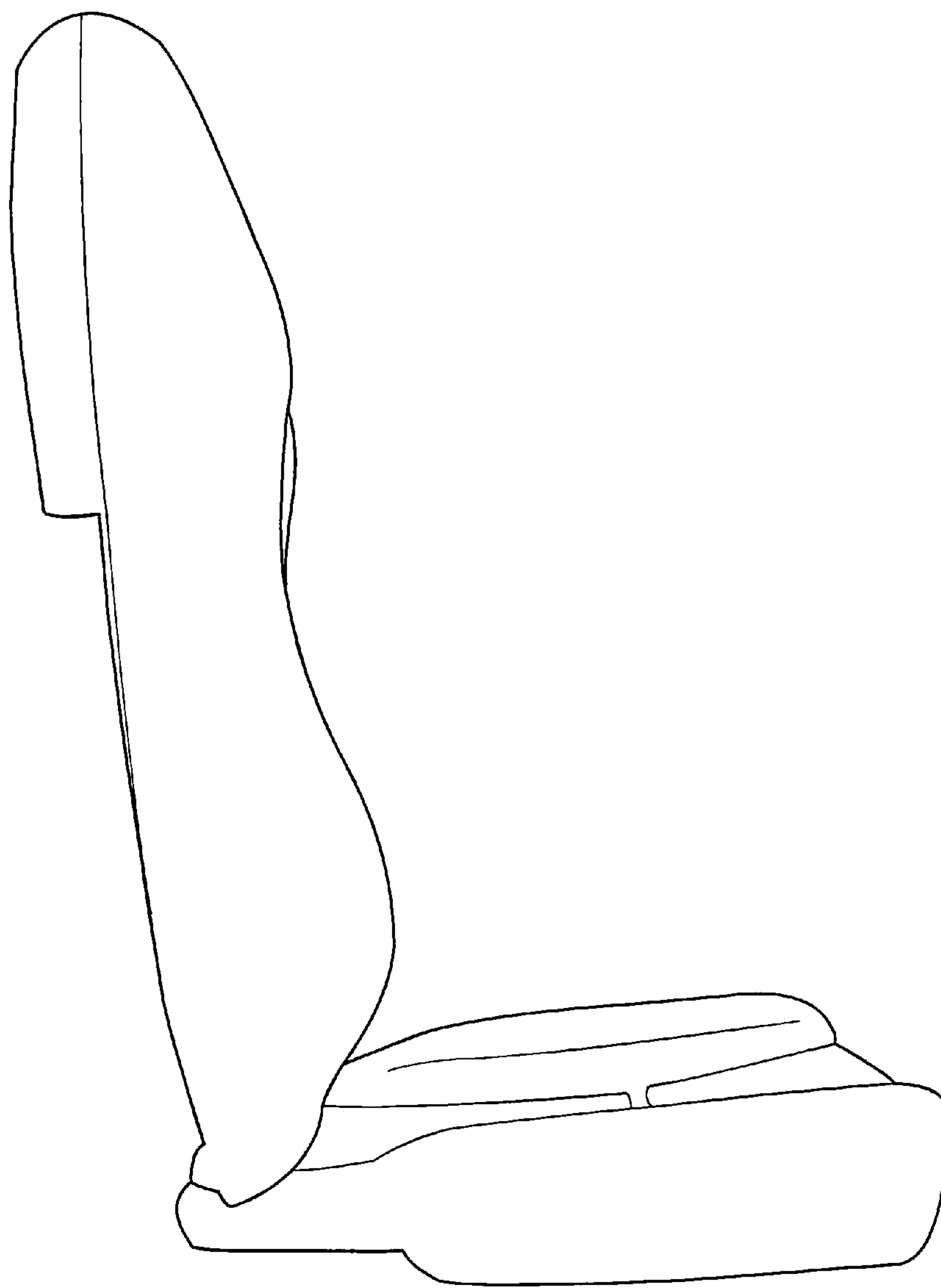

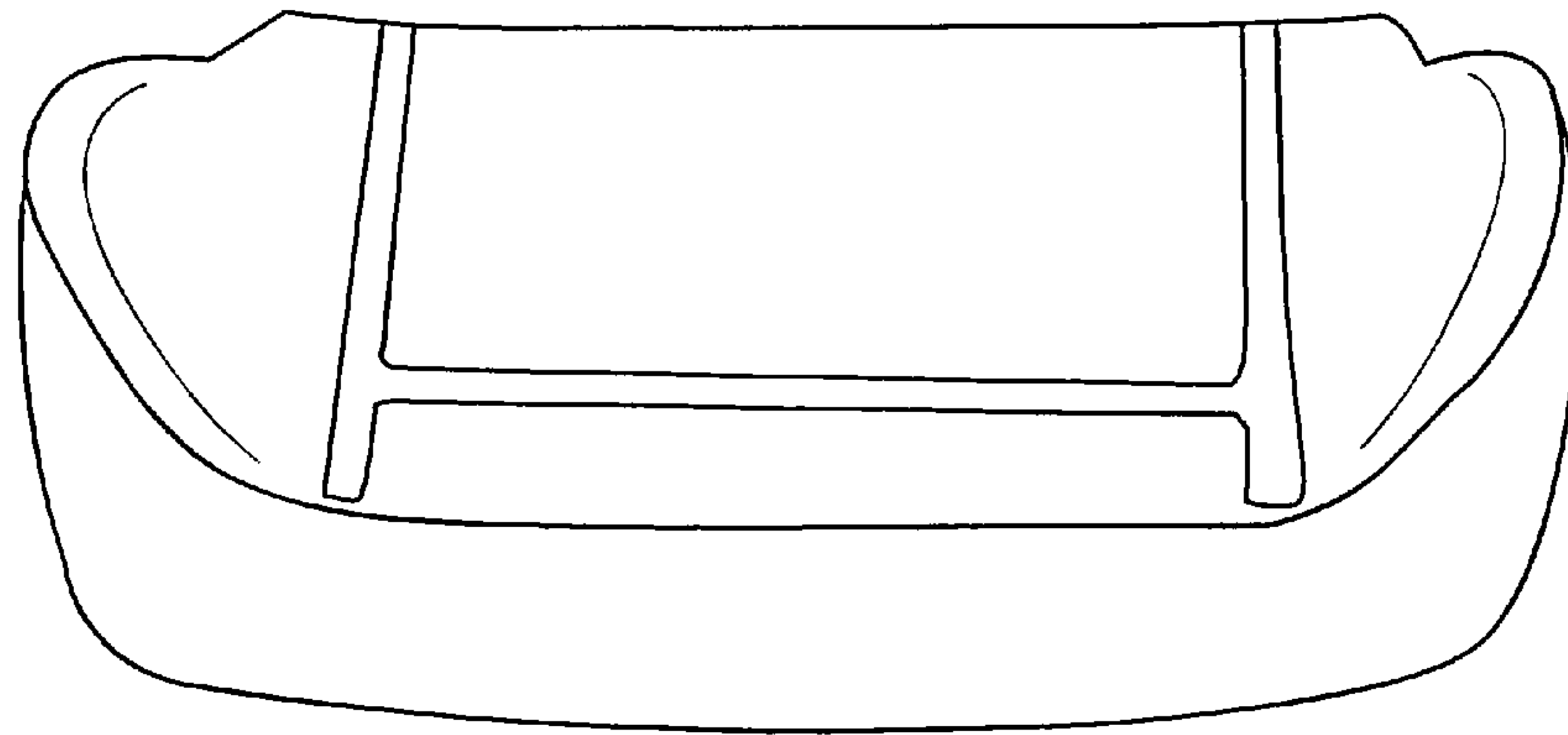

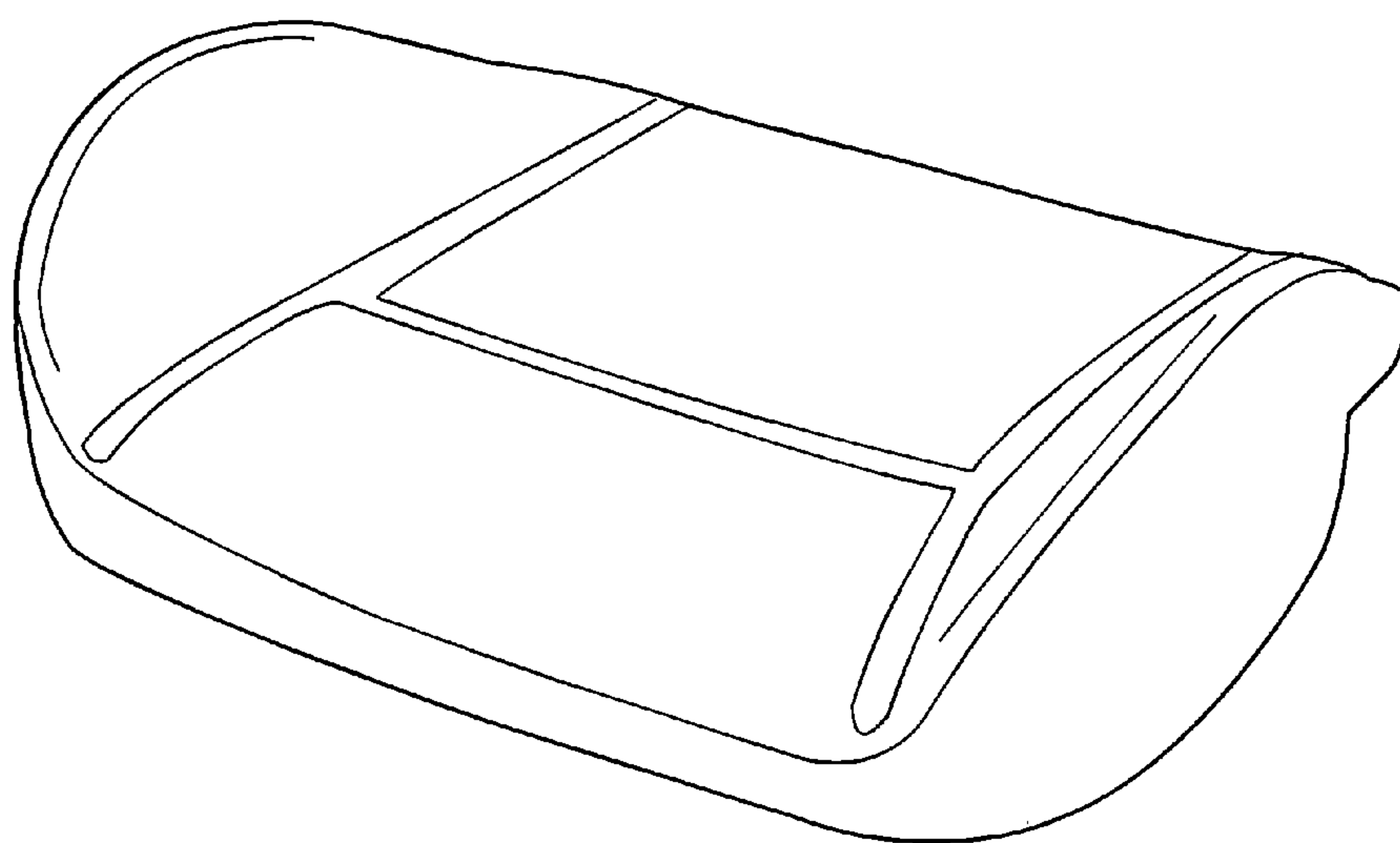
