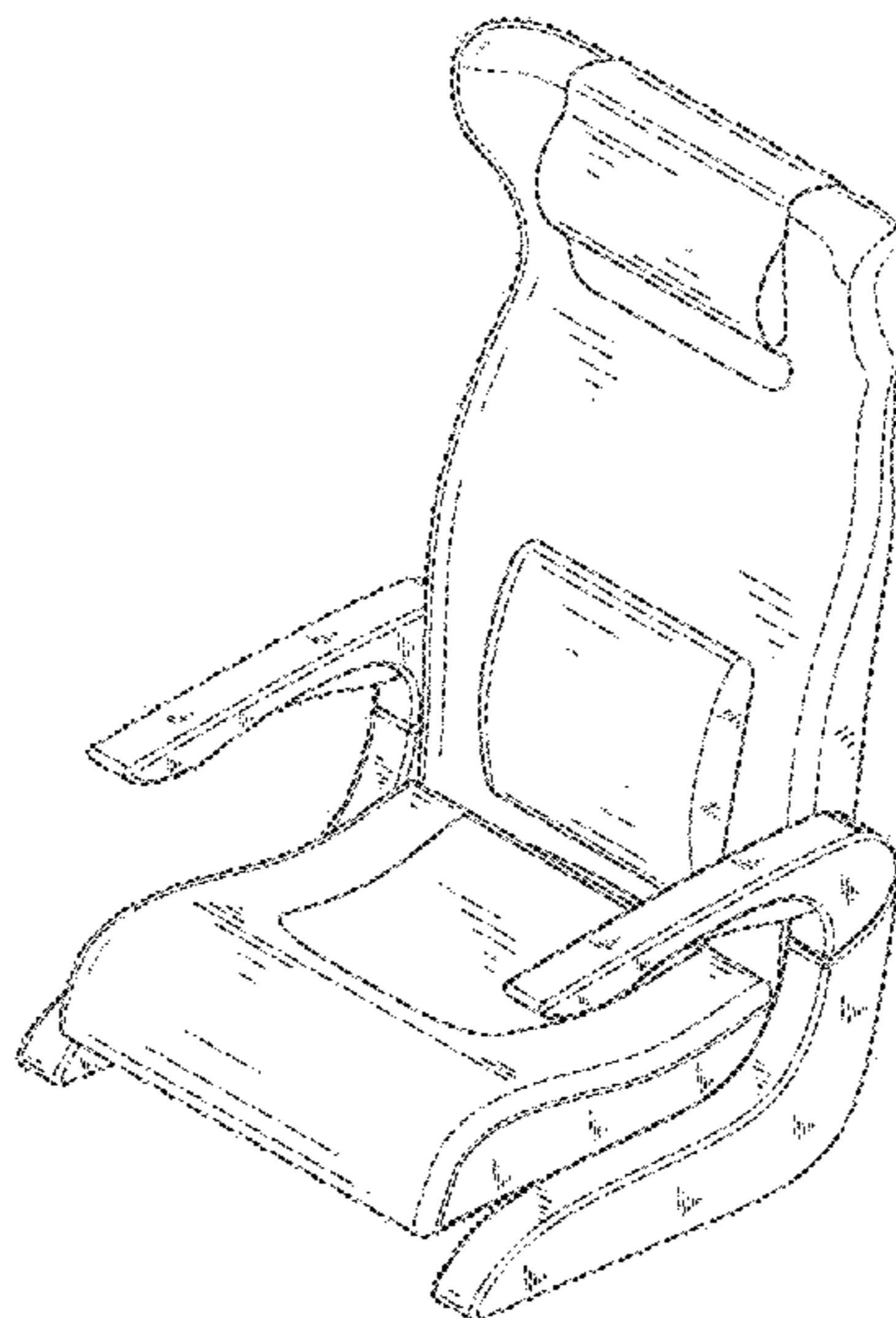
(57) **CLAIM**

The ornamental design for an aircraft seat, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the aircraft seat;  
FIG. 2 is a front elevation view thereof;  
FIG. 3 is a rear elevation view thereof;  
FIG. 4 is a left side elevation view thereof;  
FIG. 5 is a right side elevation view thereof;  
FIG. 6 is a top plan view thereof;  
FIG. 7 is a bottom plan view thereof;  
FIG. 8 is a left rear perspective view thereof; and,  
FIG. 9 is an additional perspective view thereof, taken from front, right side, showing the aircraft seat unit in accordance with our design.  
The broken line shown in FIG. 9 is included for the purpose of illustrating environment of the article and forms no part of the claimed design.

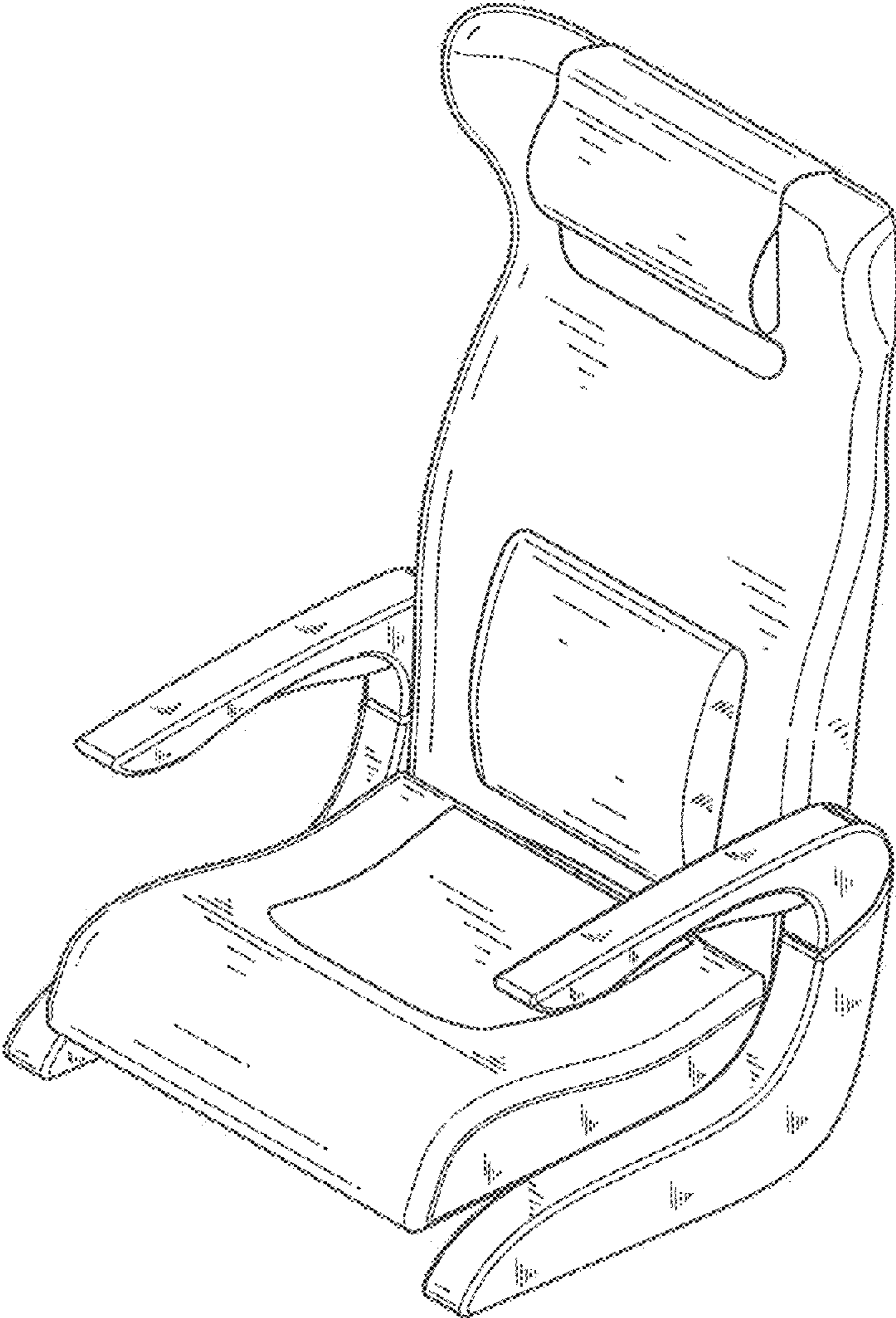

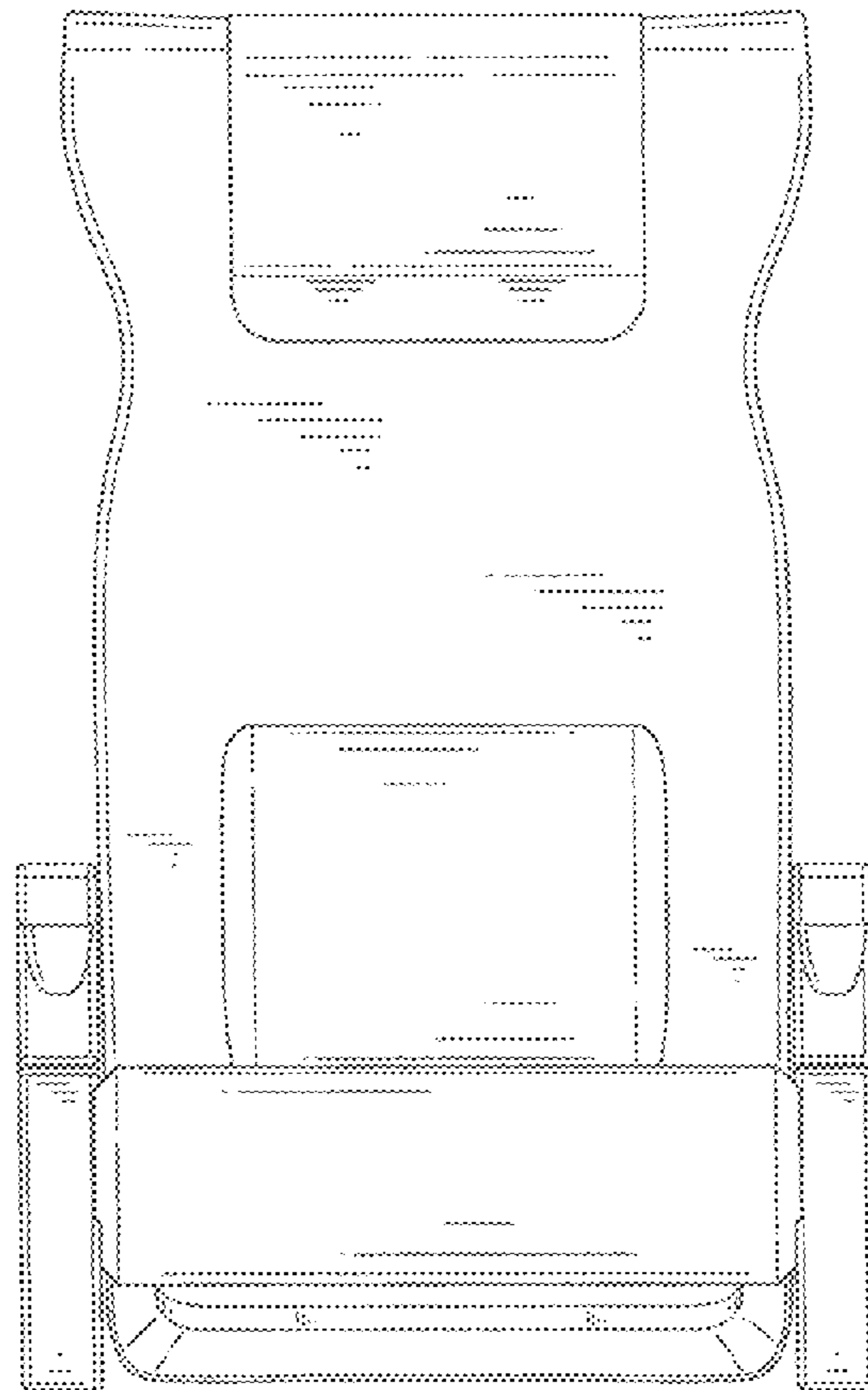

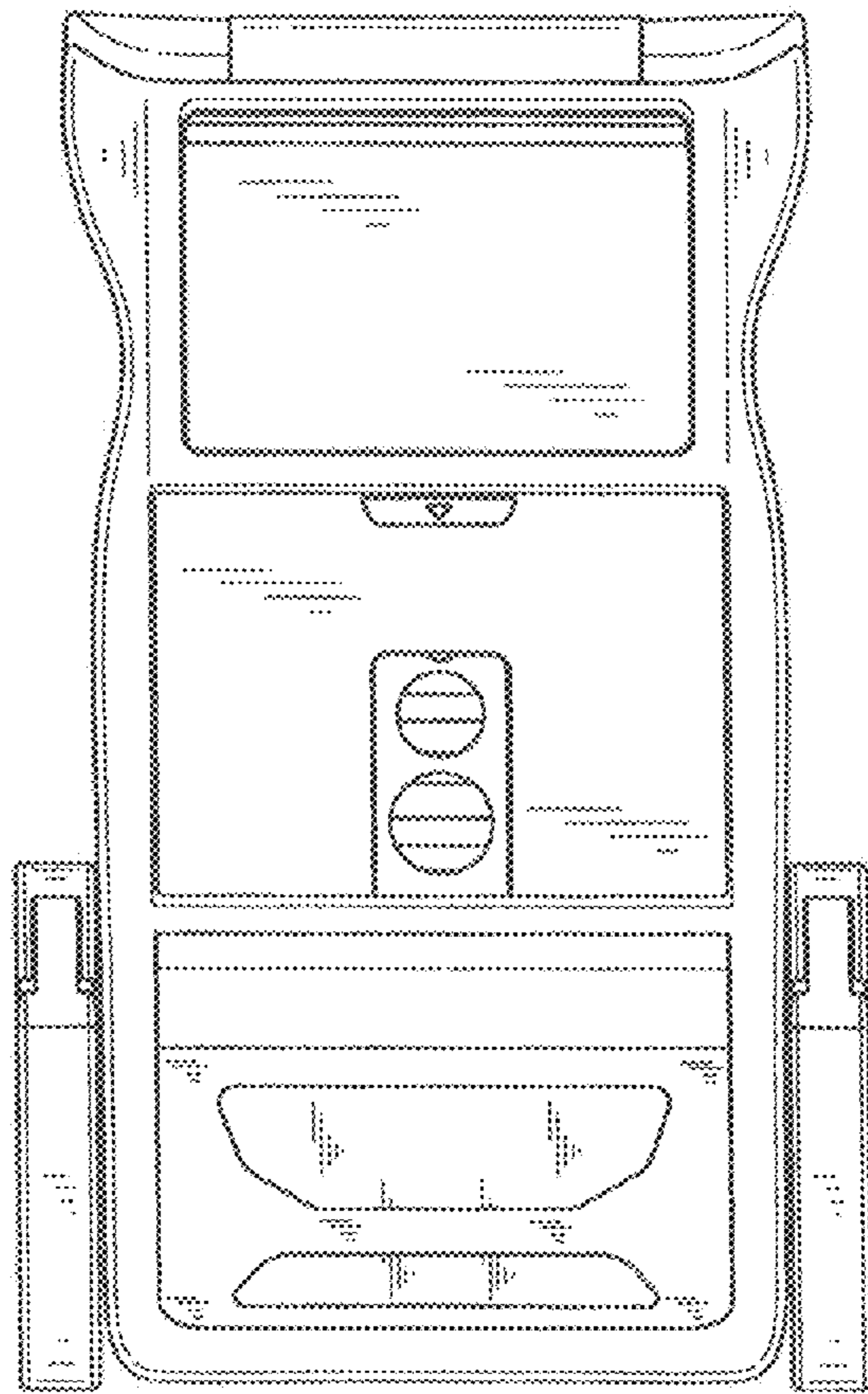

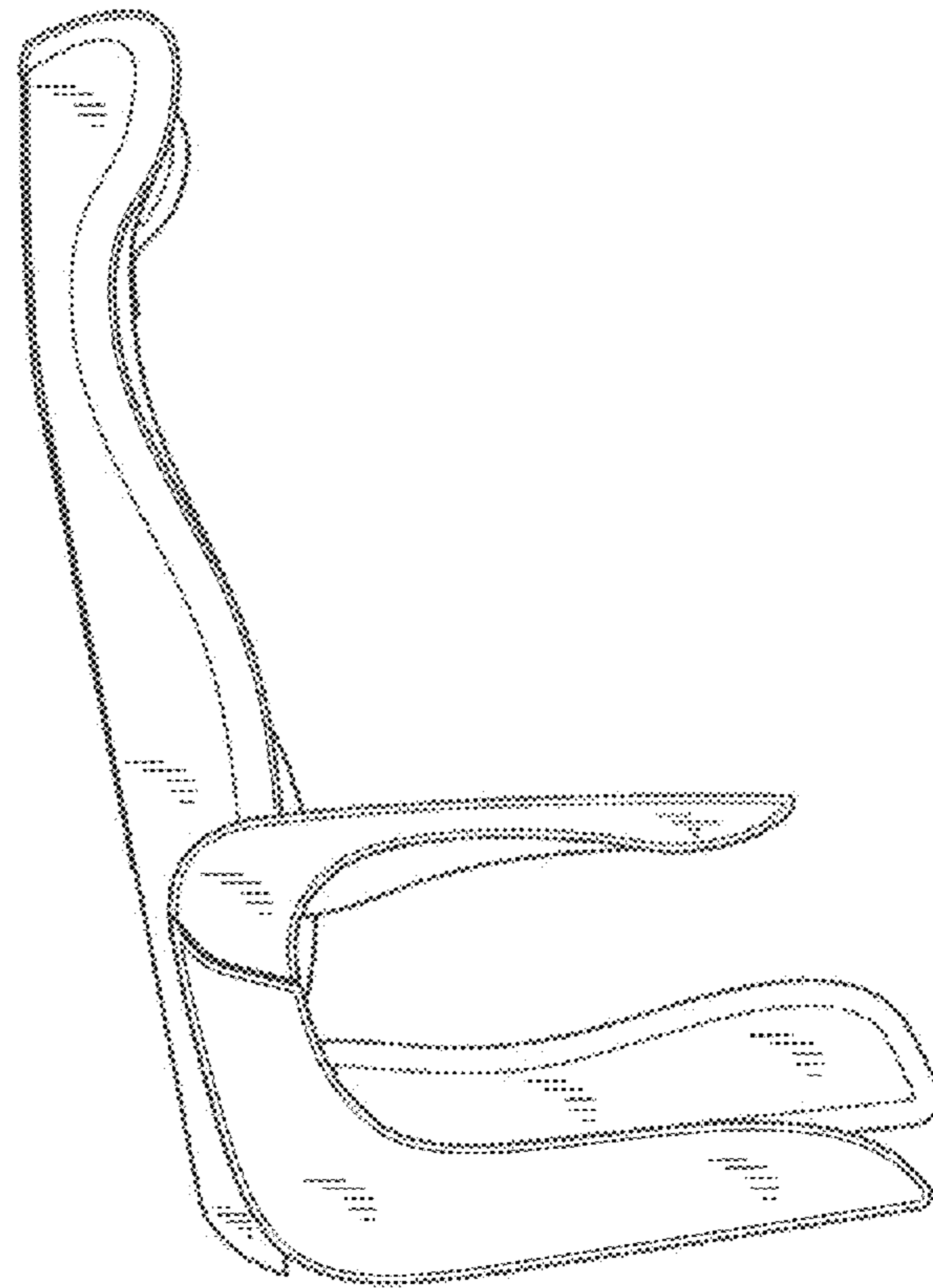

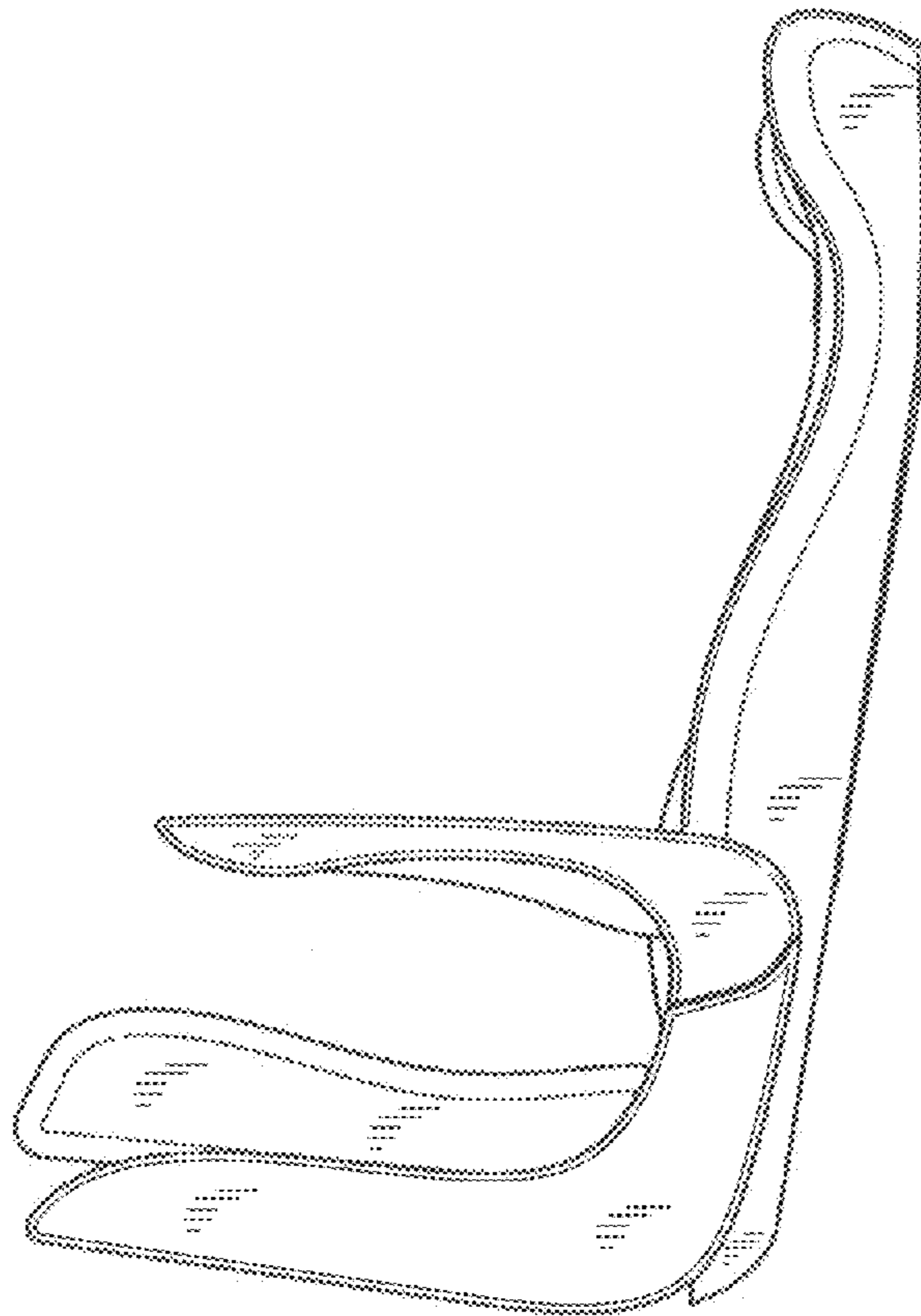

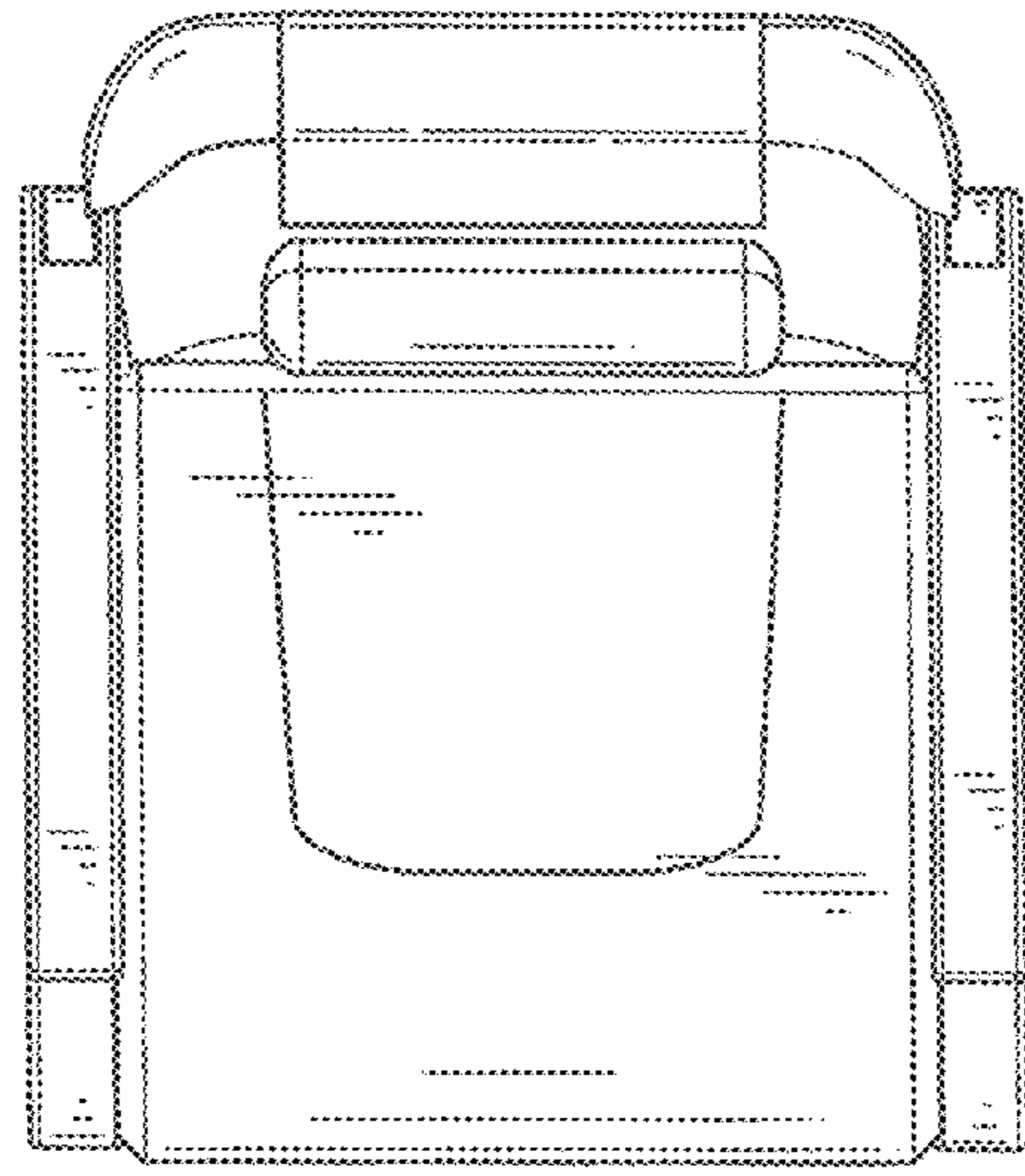

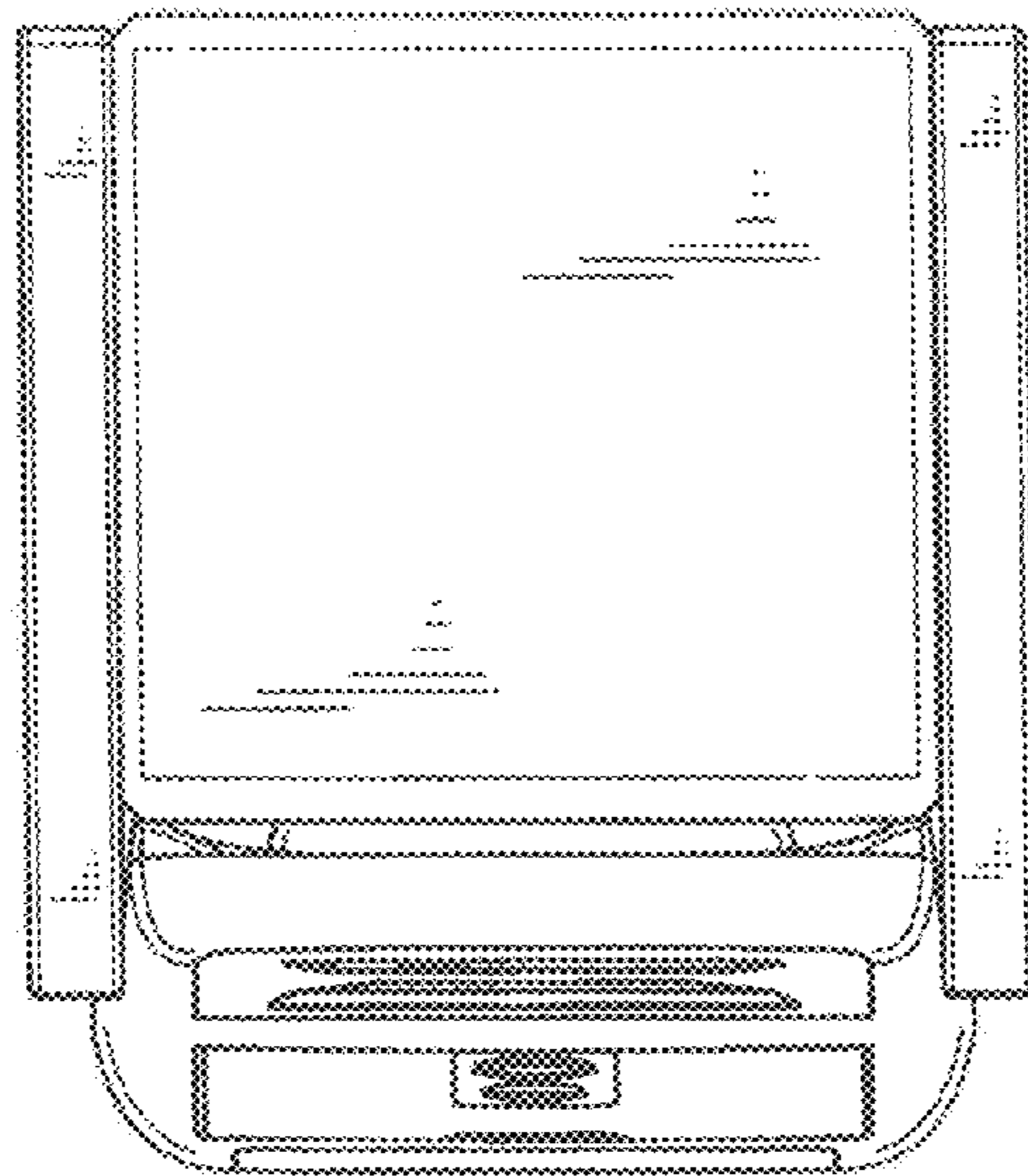

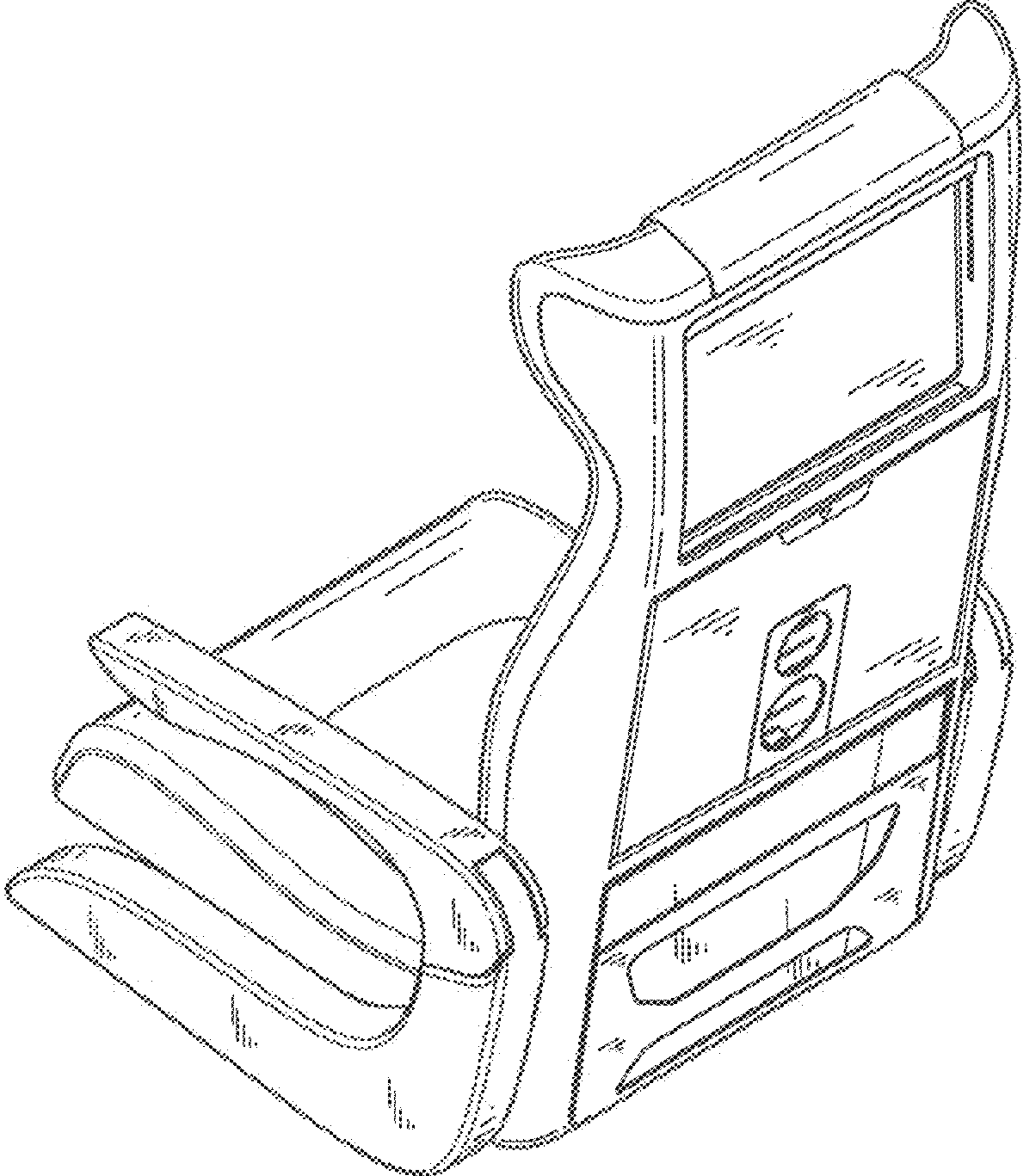

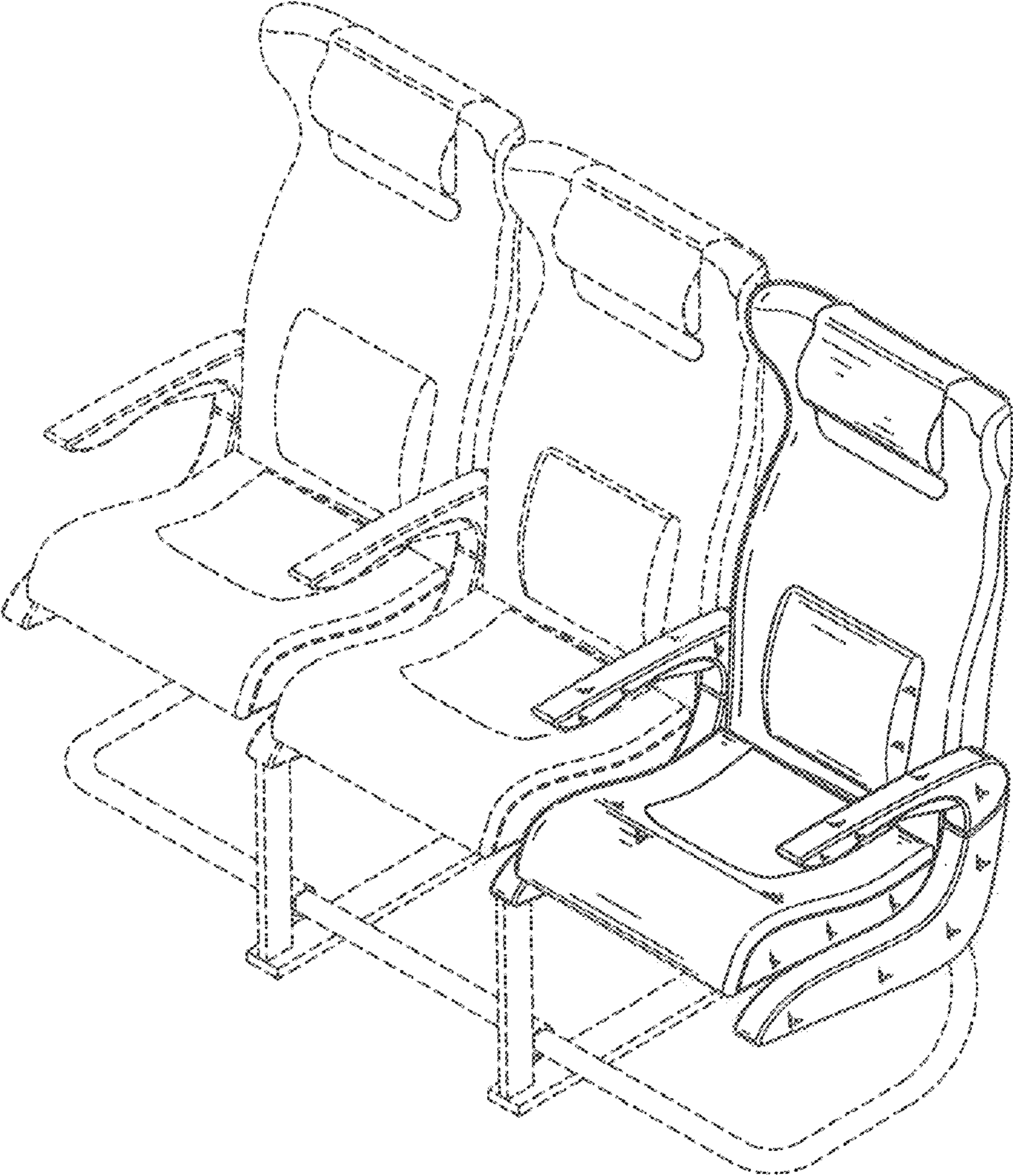
