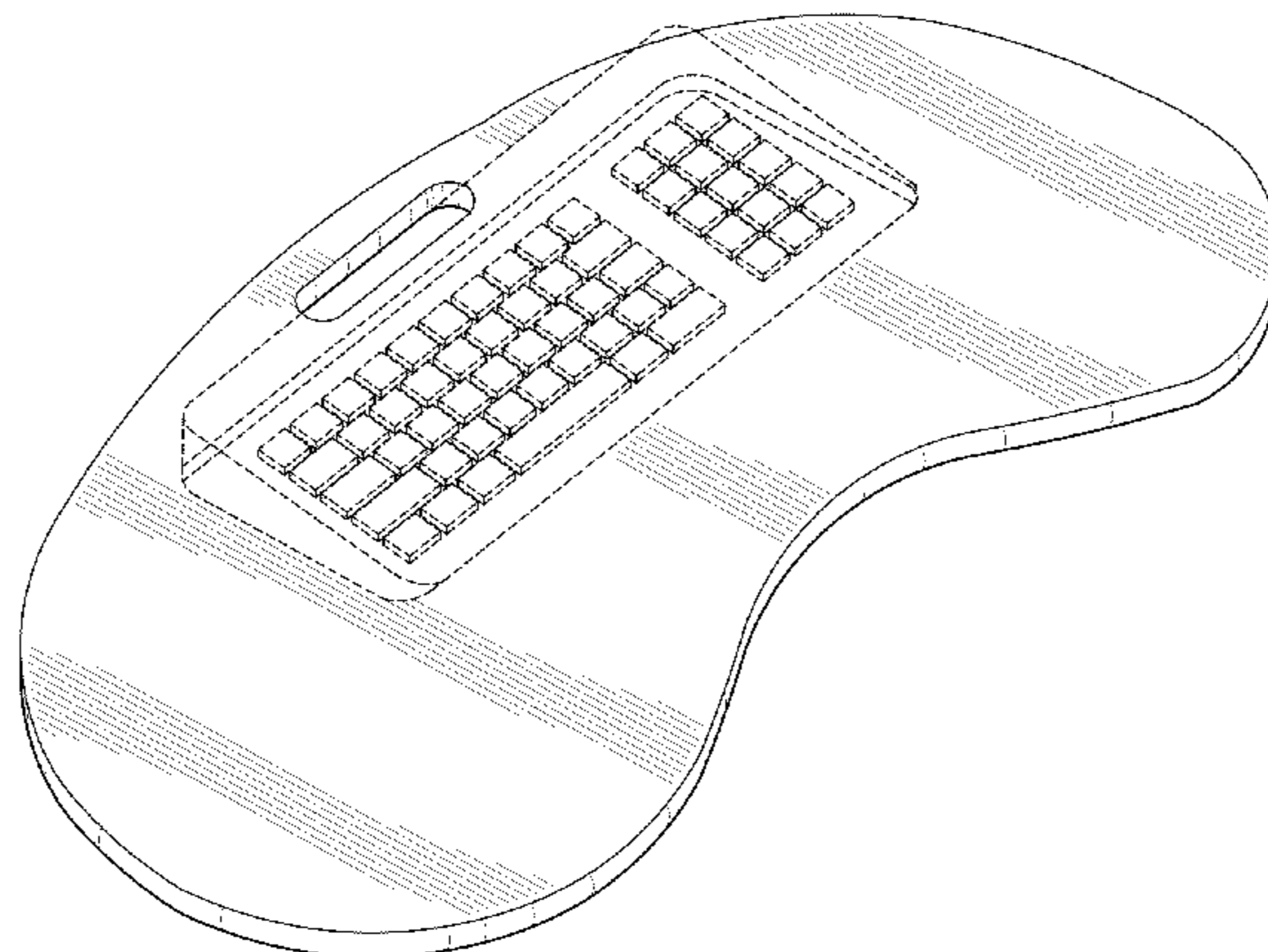
(57) **CLAIM**

The ornamental design for a combined inbuilt computer keyboard and lap desk, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a combined inbuilt computer keyboard and lap desk;
 FIG. 2 is a bottom perspective view of the combined inbuilt computer keyboard and lap desk of FIG. 1;
 FIG. 3 is a top plan view of the combined inbuilt computer keyboard and lap desk of FIG. 1;
 FIG. 4 is a bottom plan view of the combined inbuilt computer keyboard and lap desk of FIG. 1;
 FIG. 5 is a front elevational view thereof;
 FIG. 6 is a rear elevational view thereof;
 FIG. 7 is a right side elevational view thereof; and,
 FIG. 8 is a left side elevational view thereof.

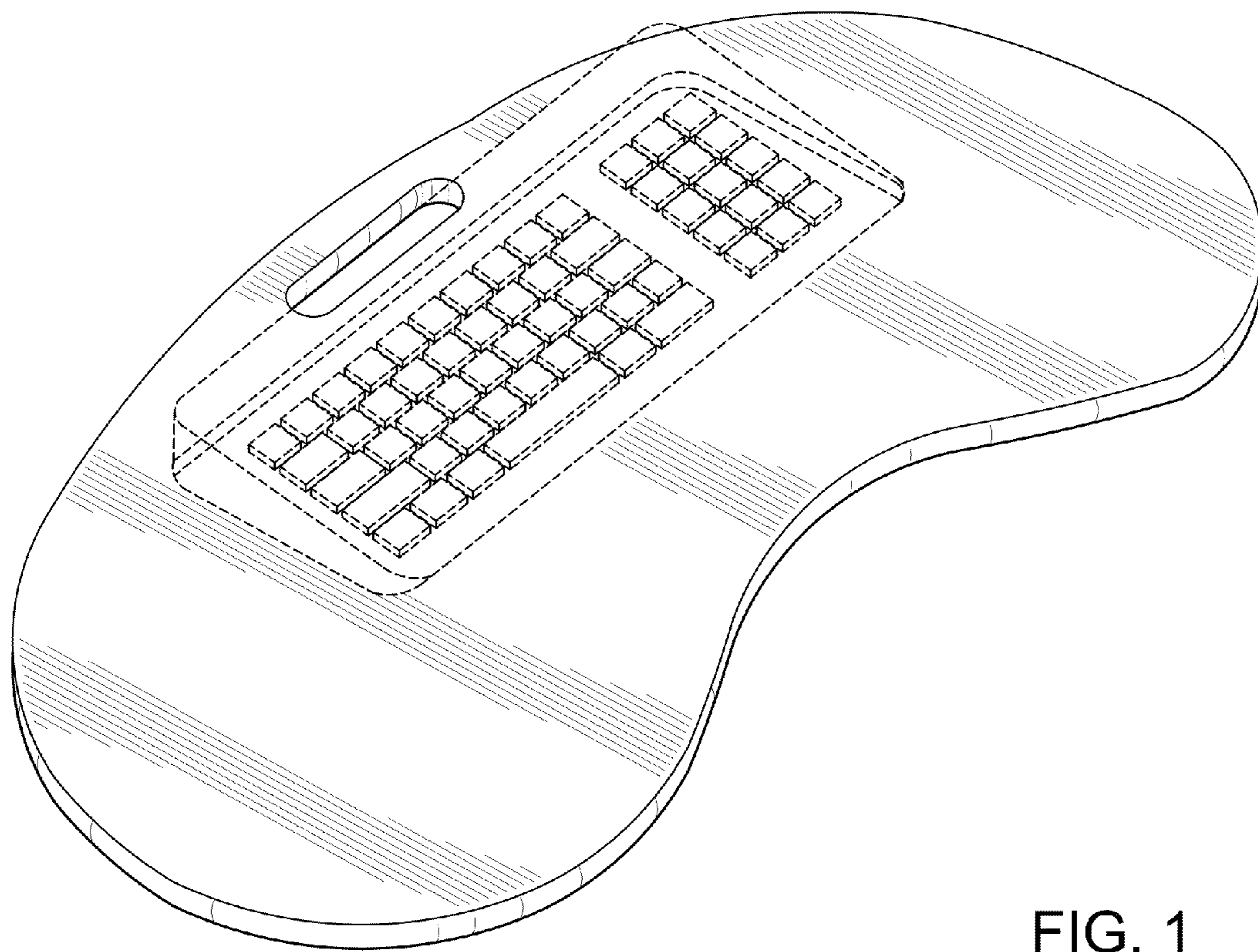

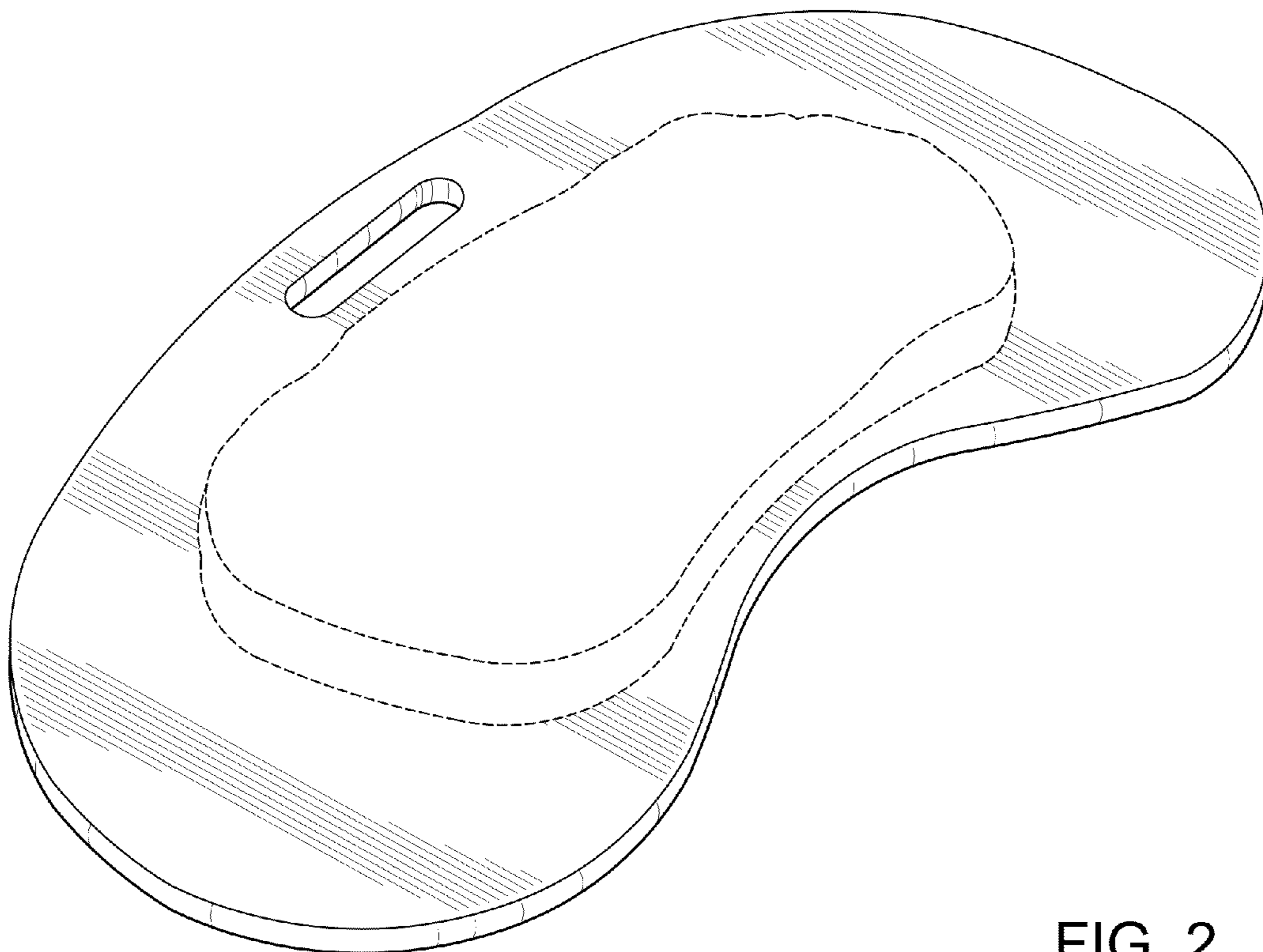

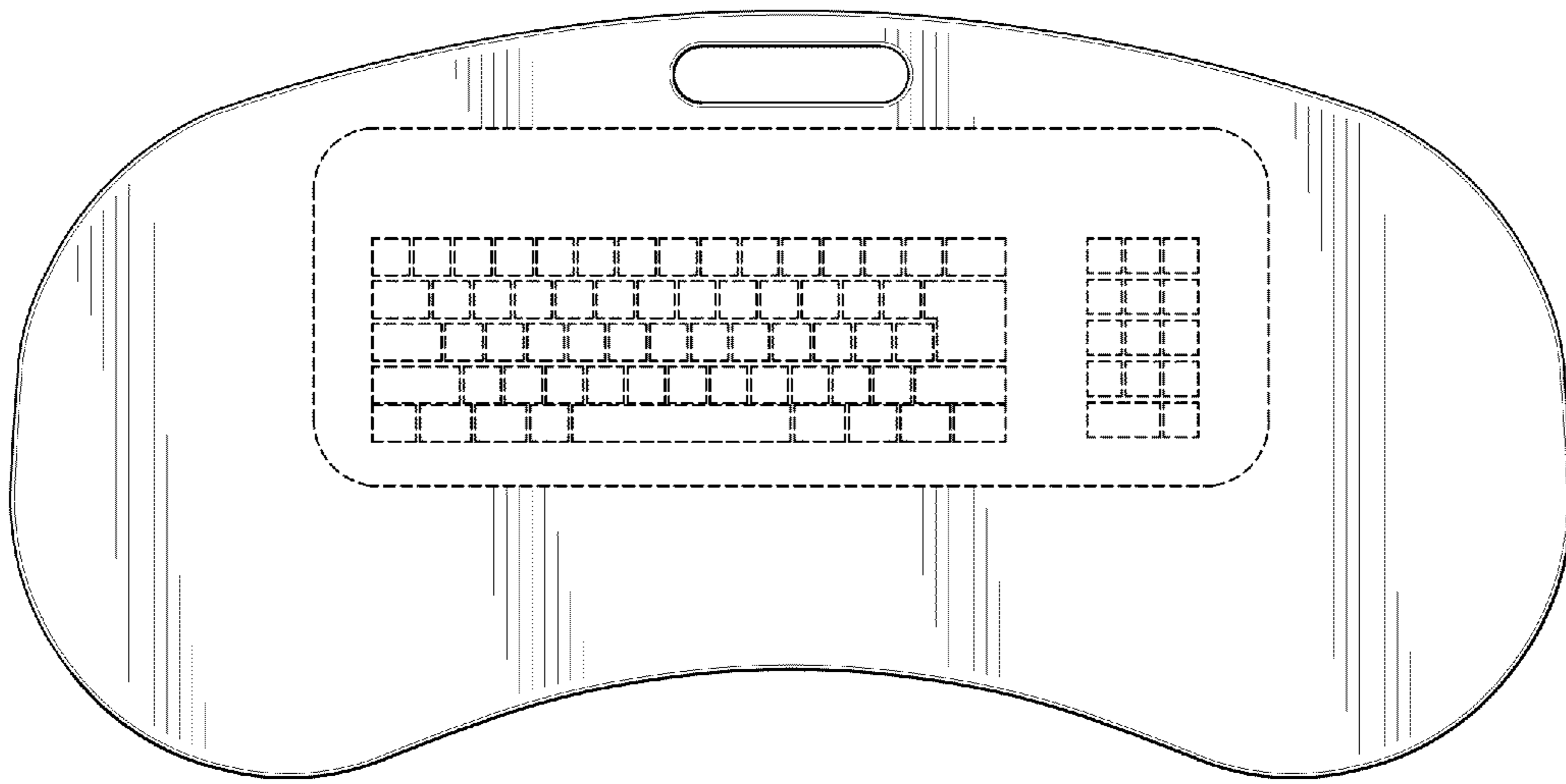

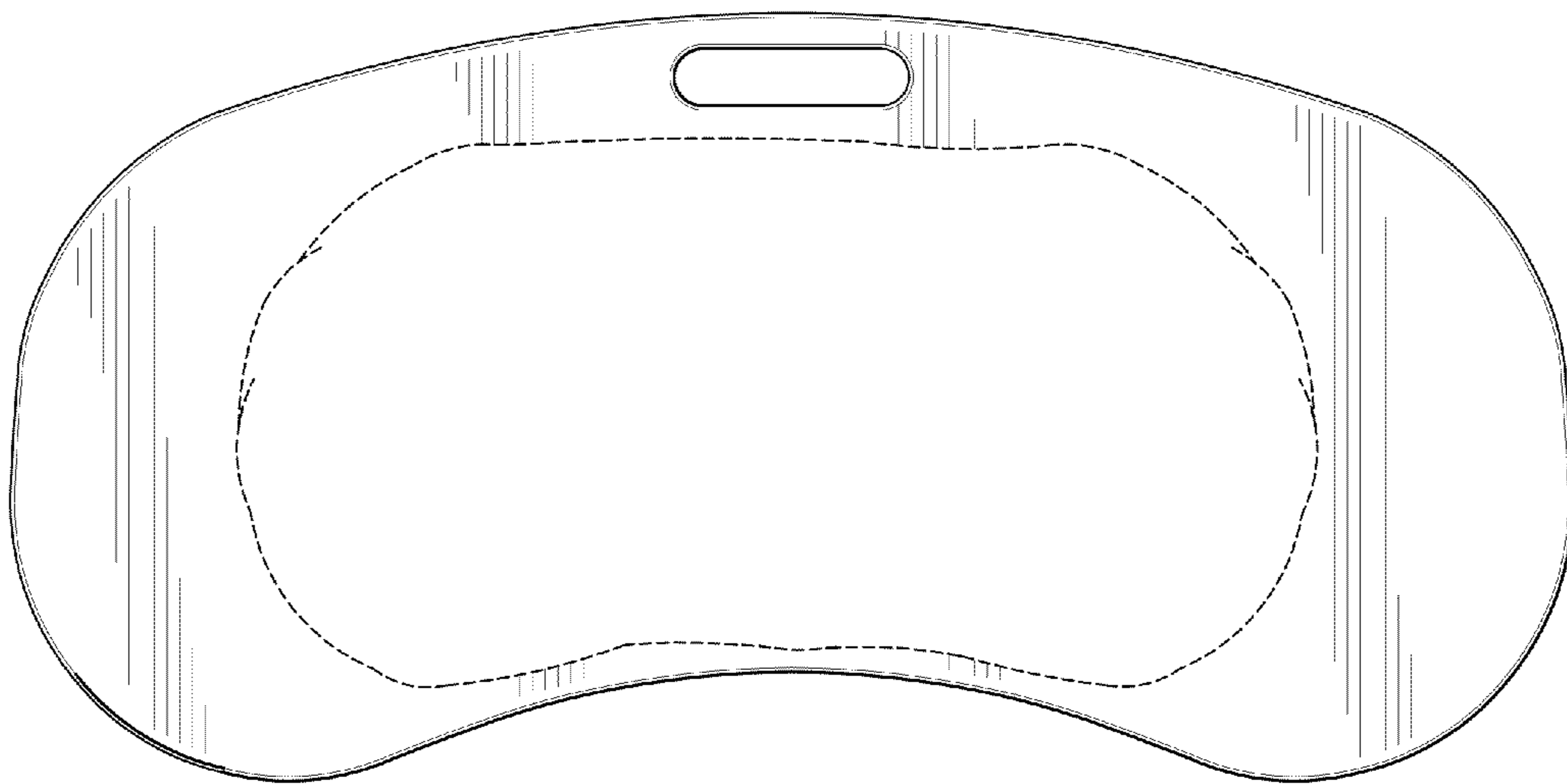

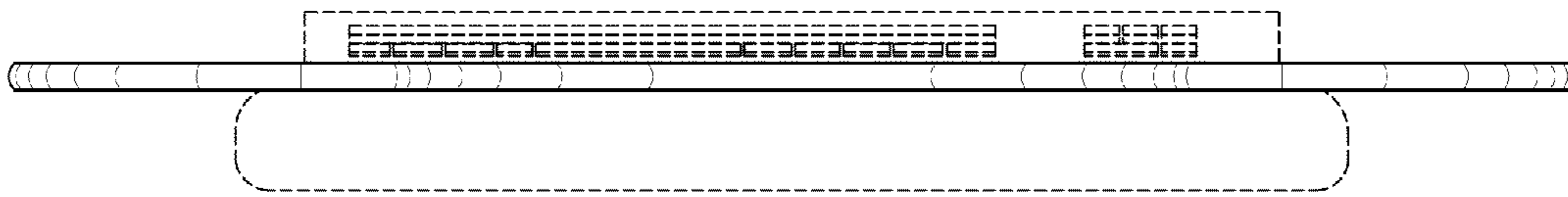

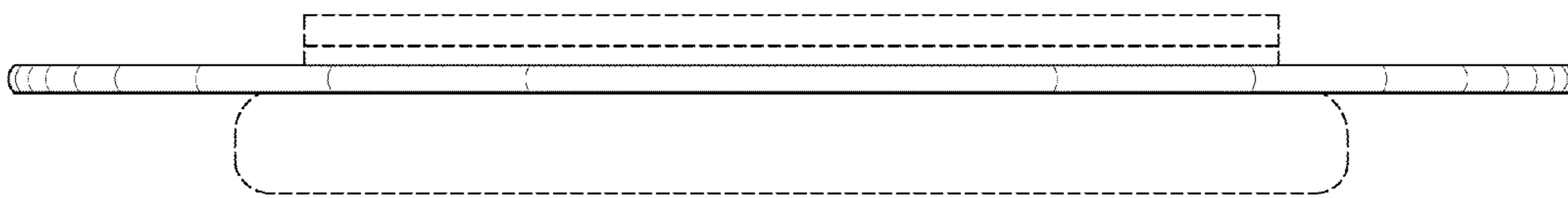

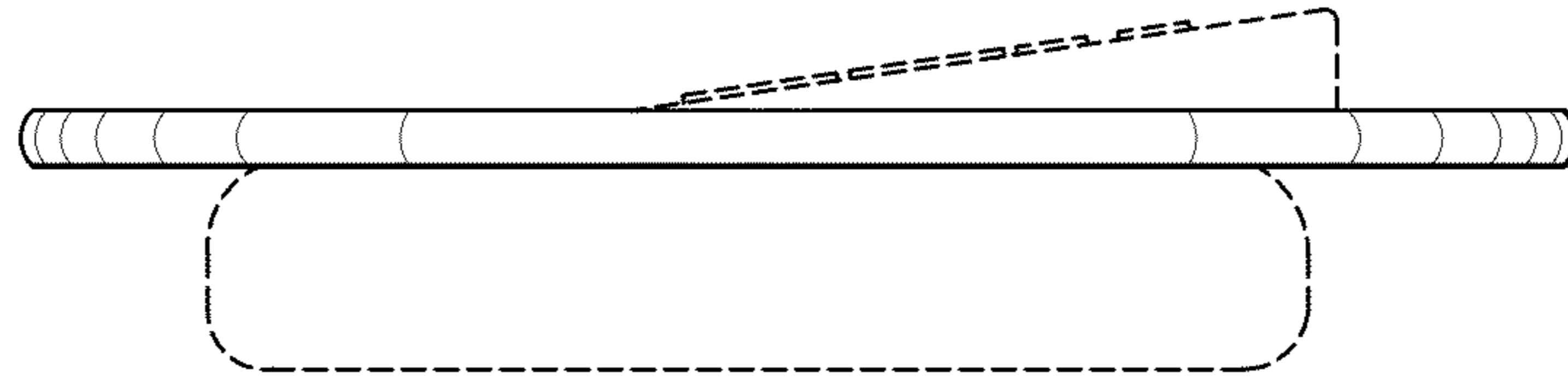

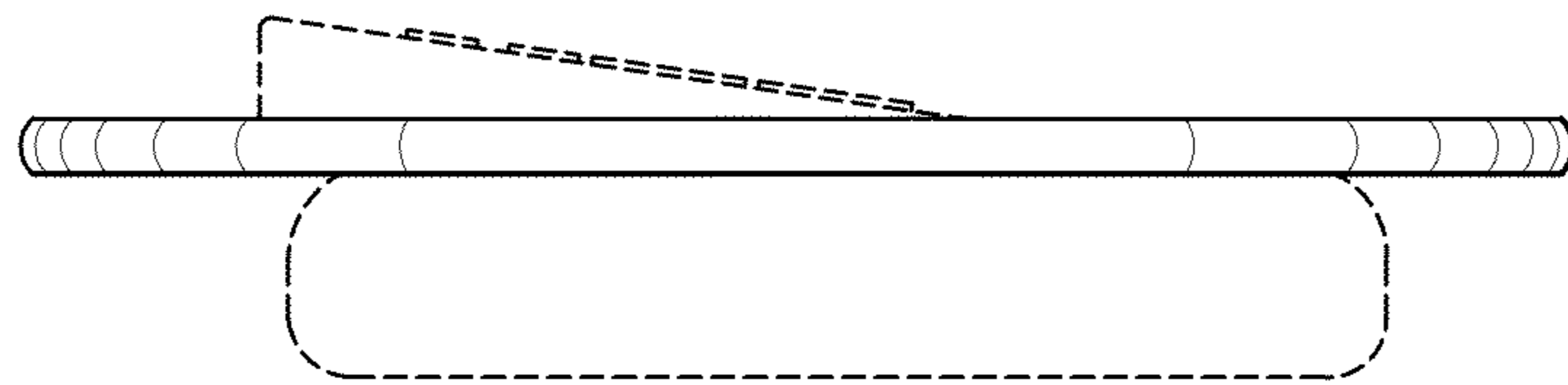
