DESCRIPTION

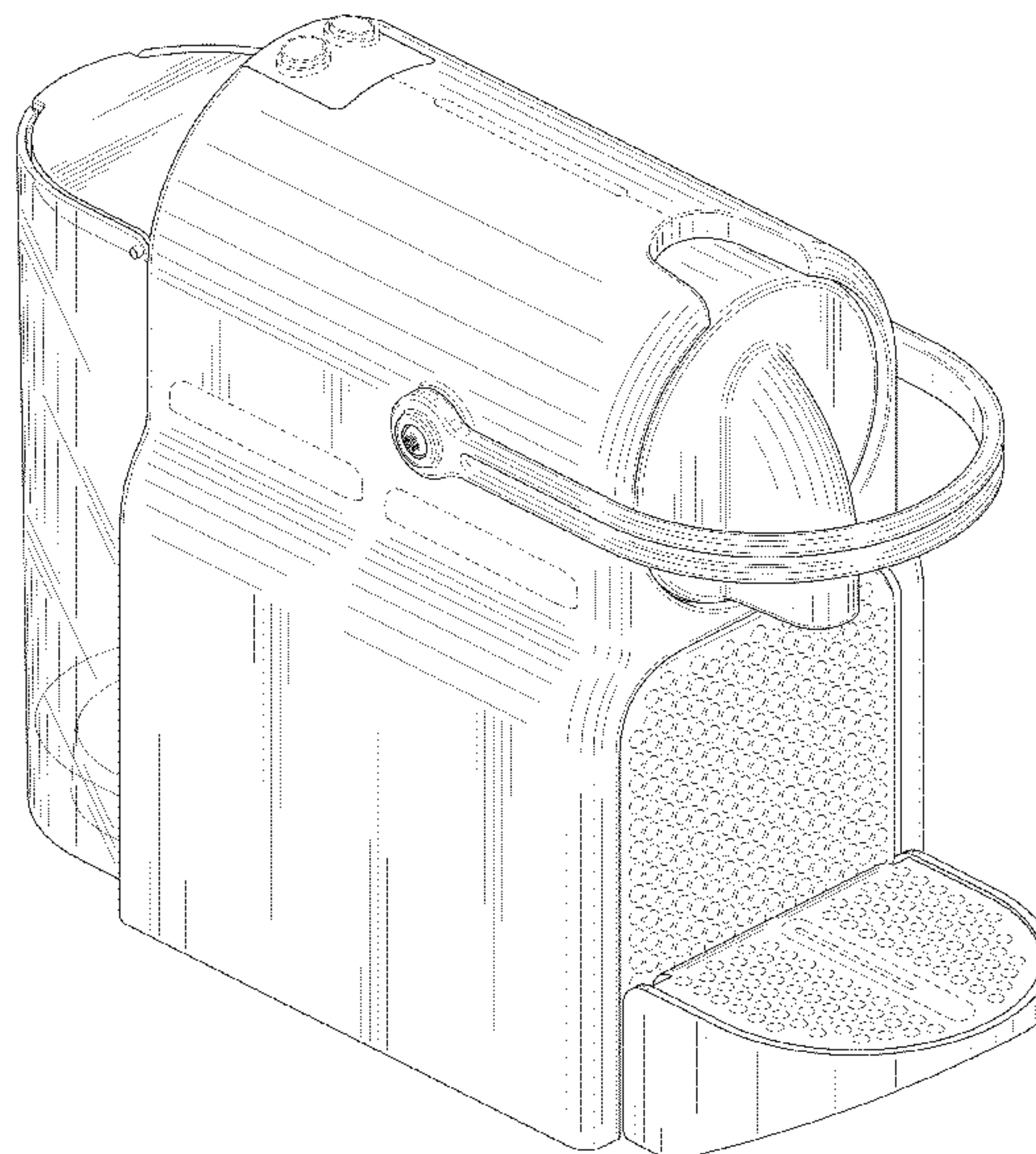

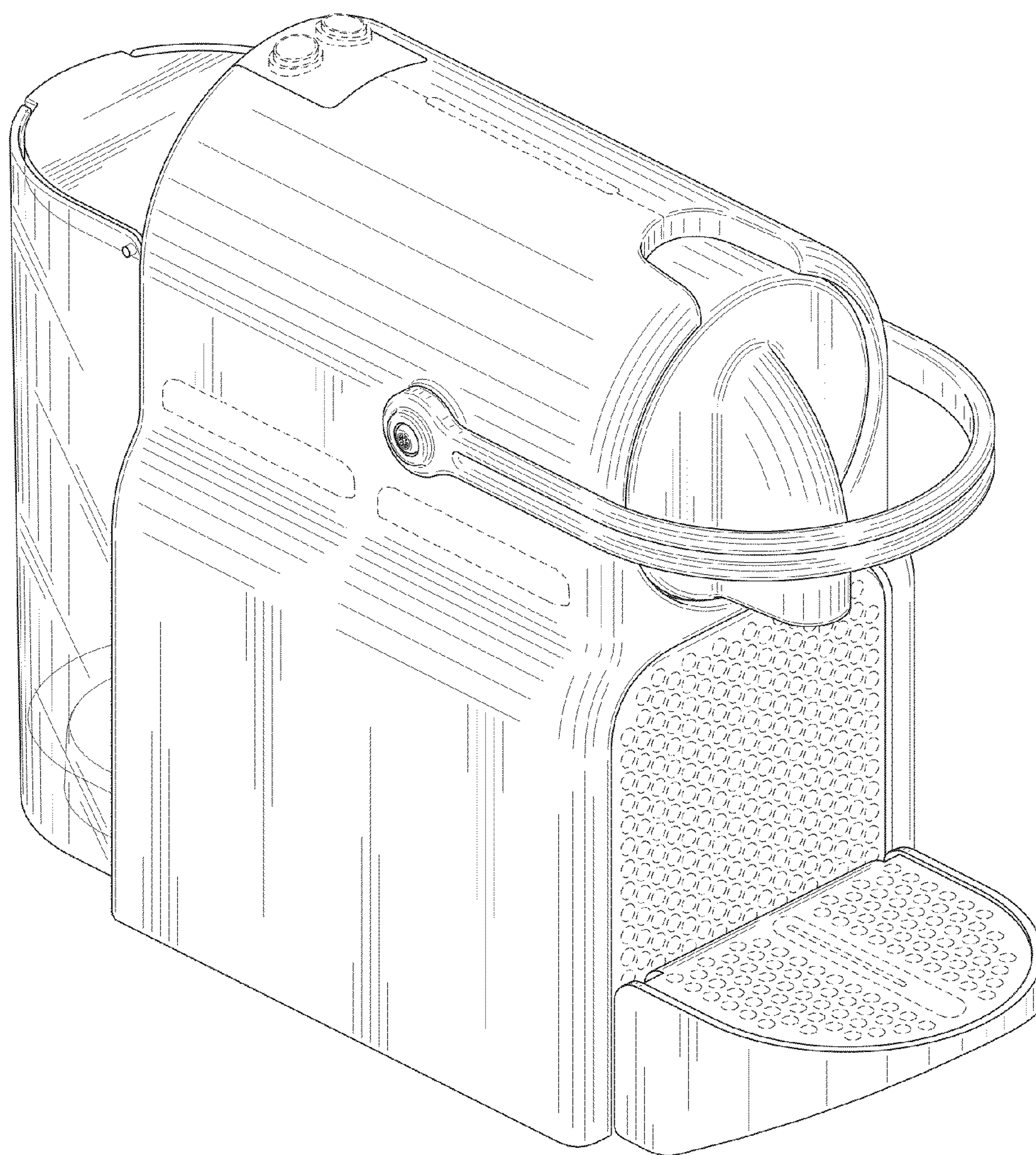

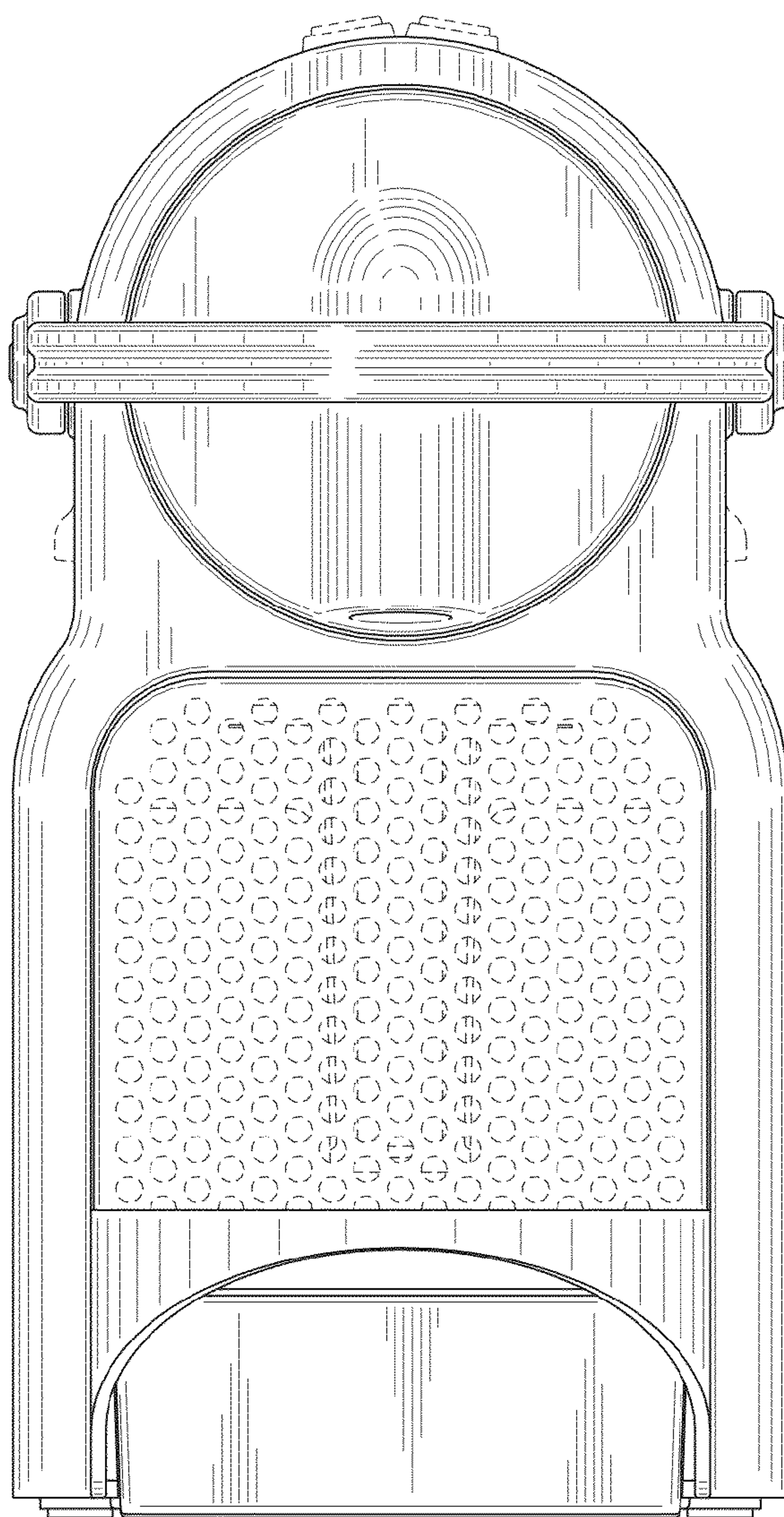
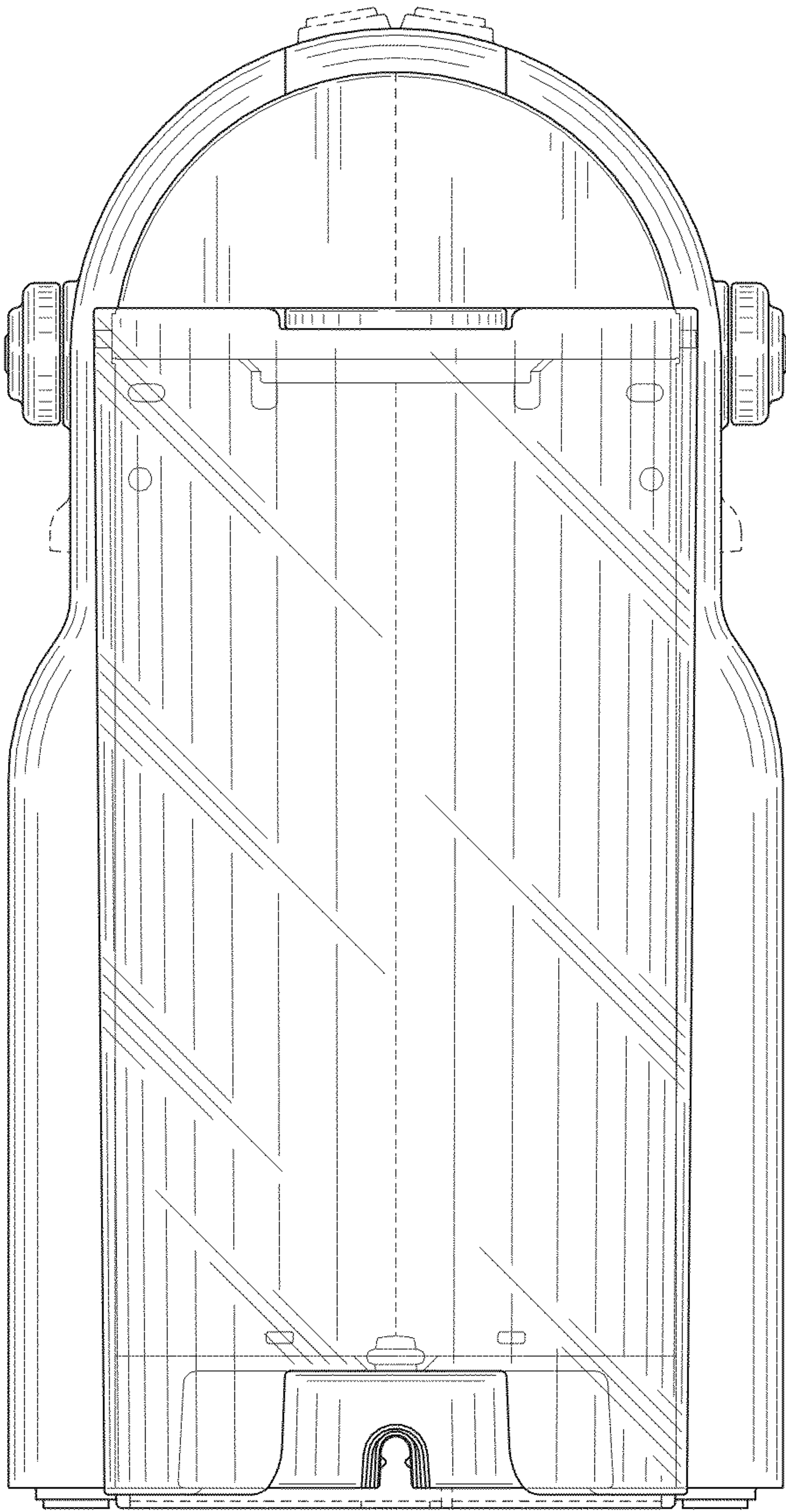

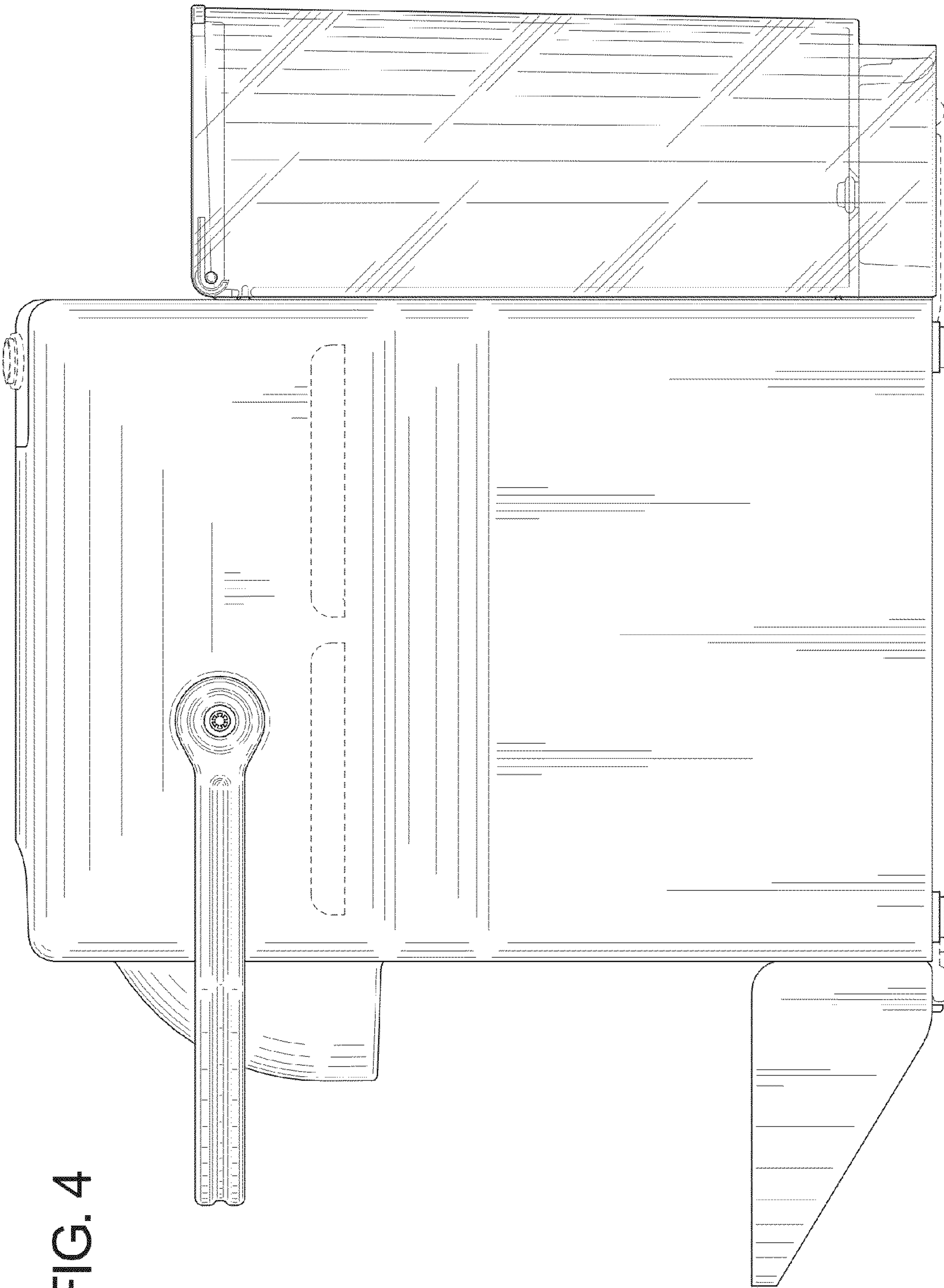

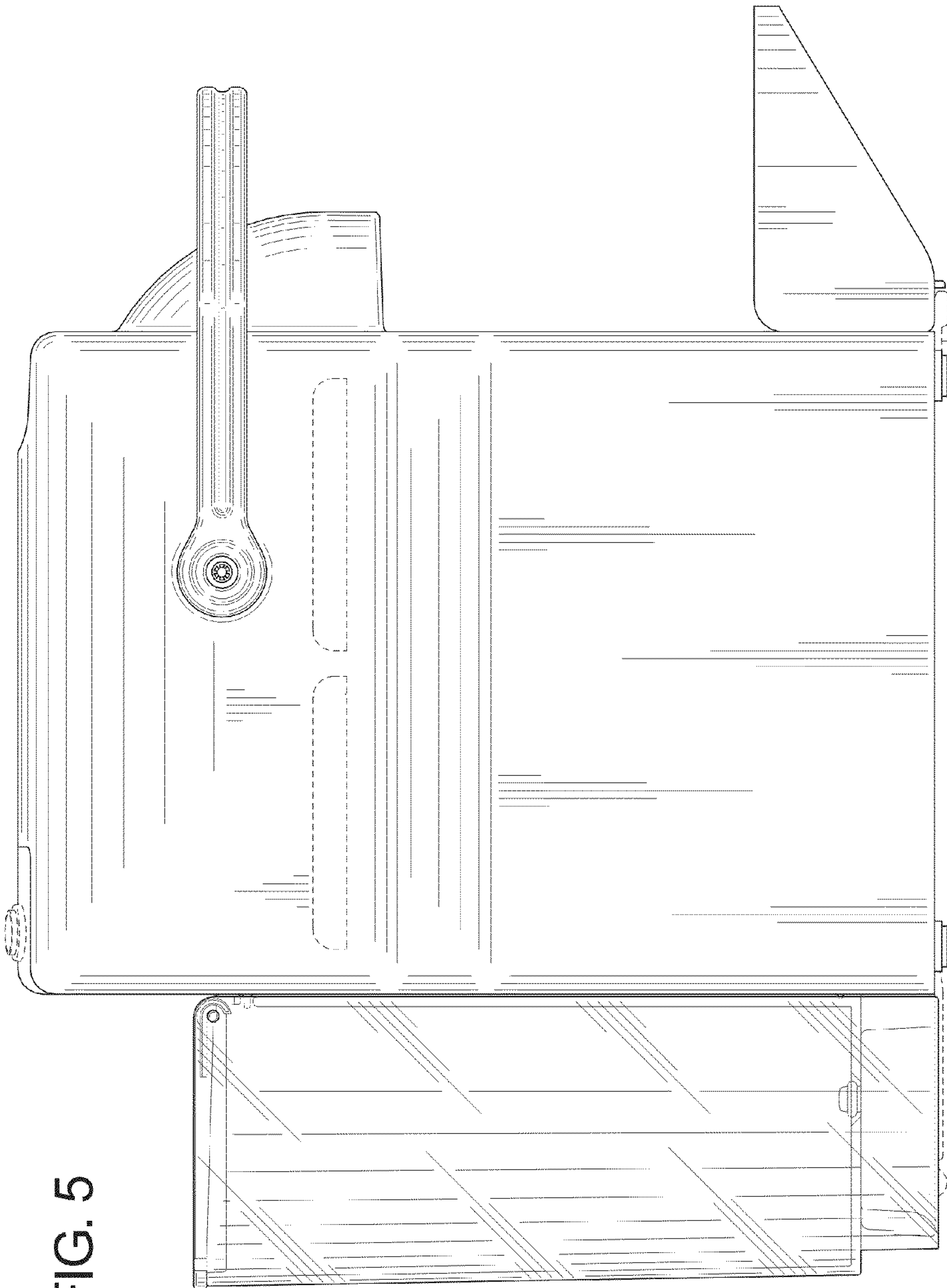

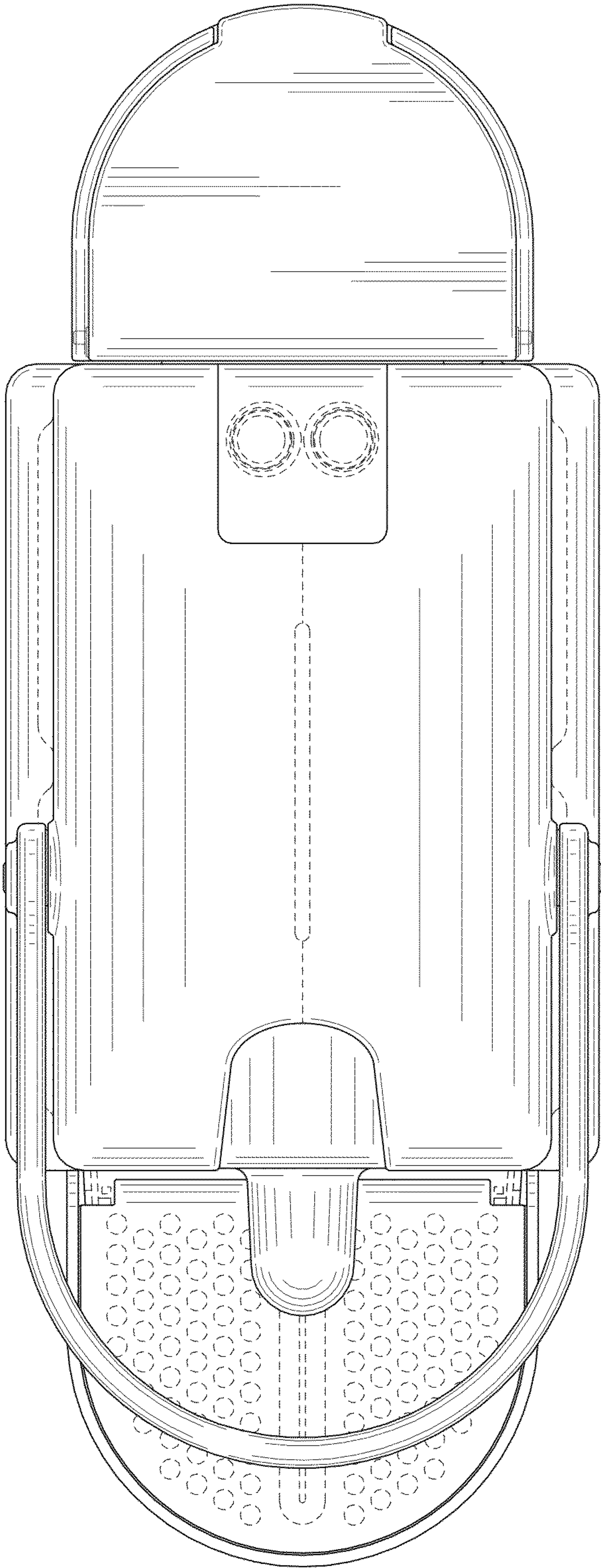
