FIG. 4 shows a left side view of the present design

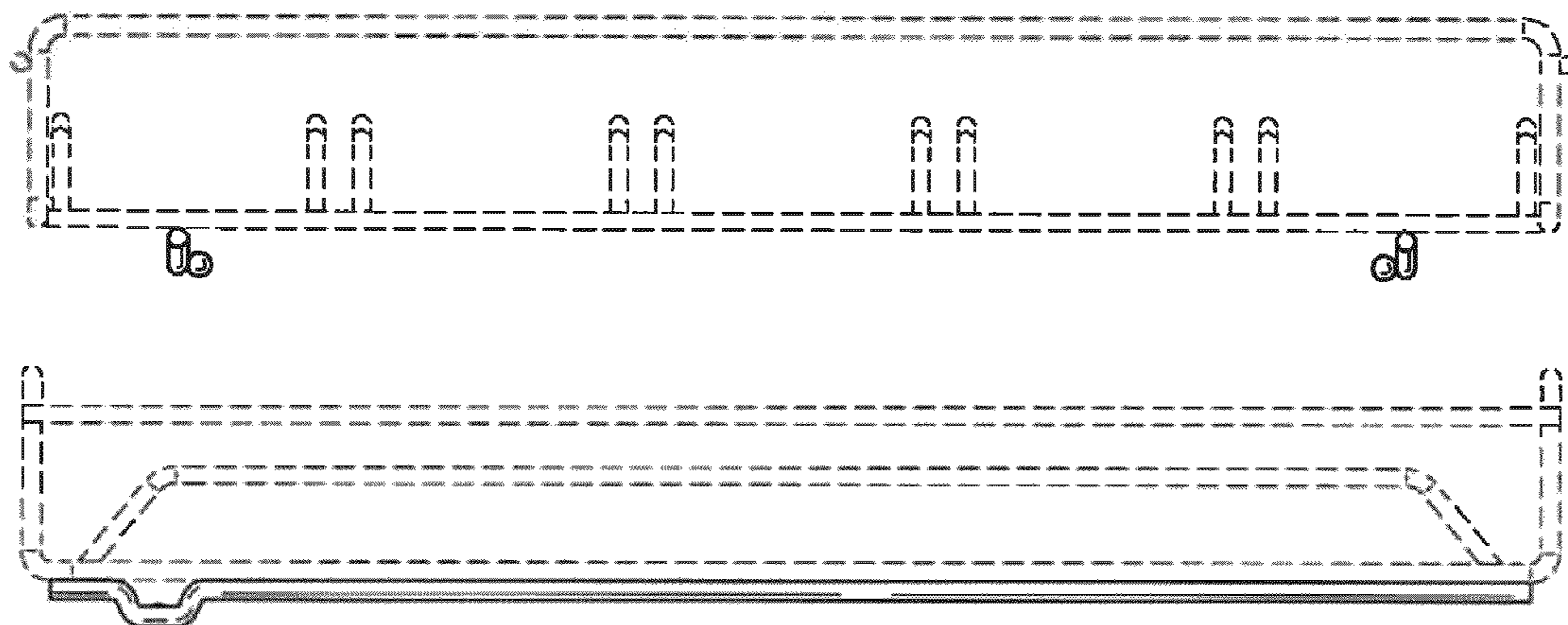
FIG. 5 shows a right side view of the present design.

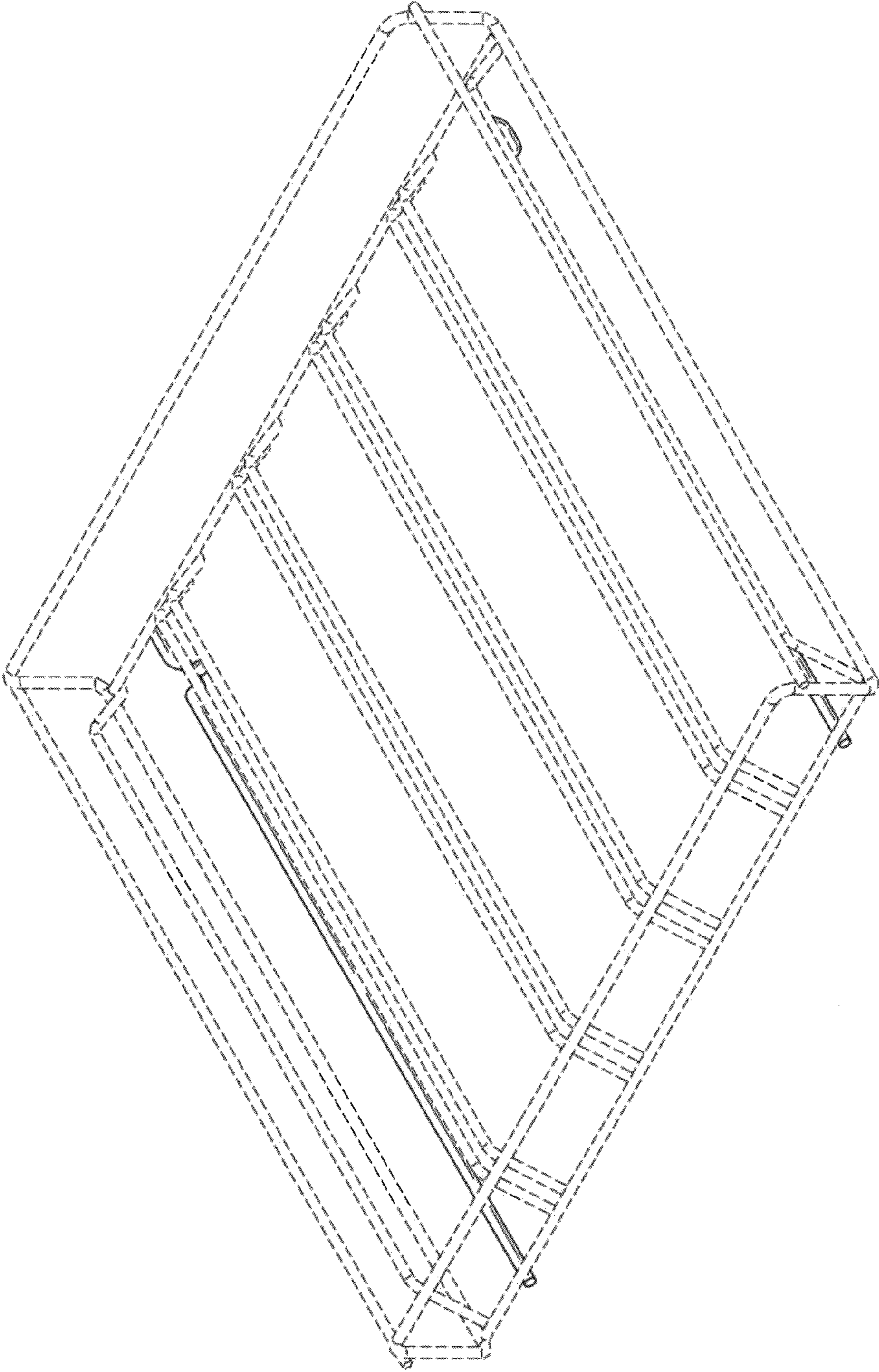

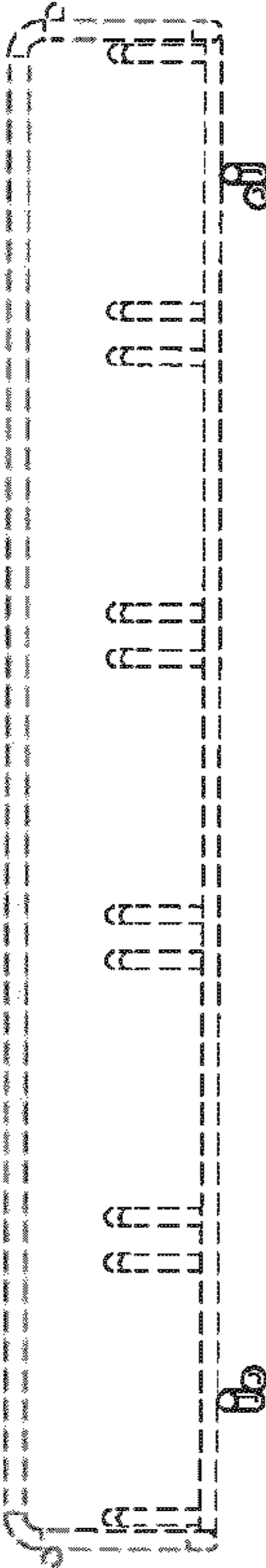

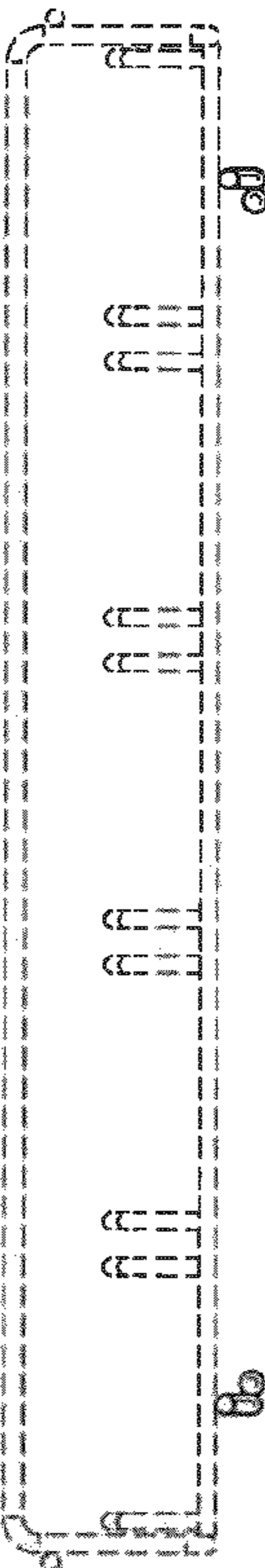

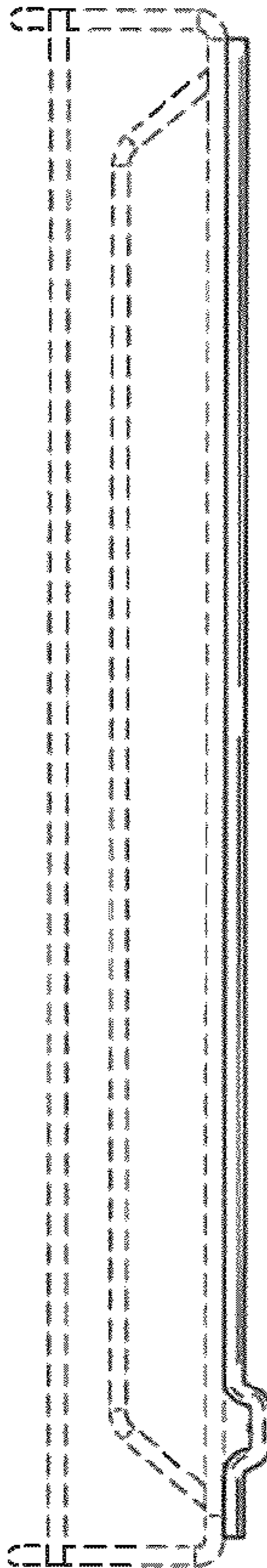

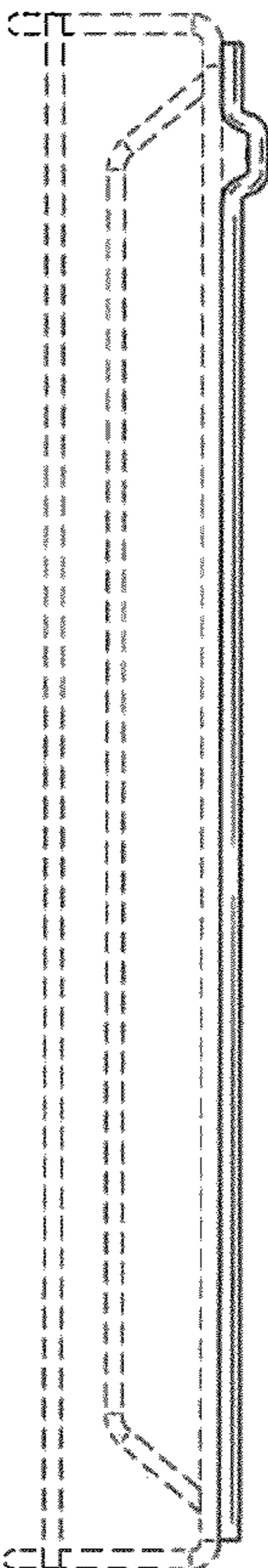

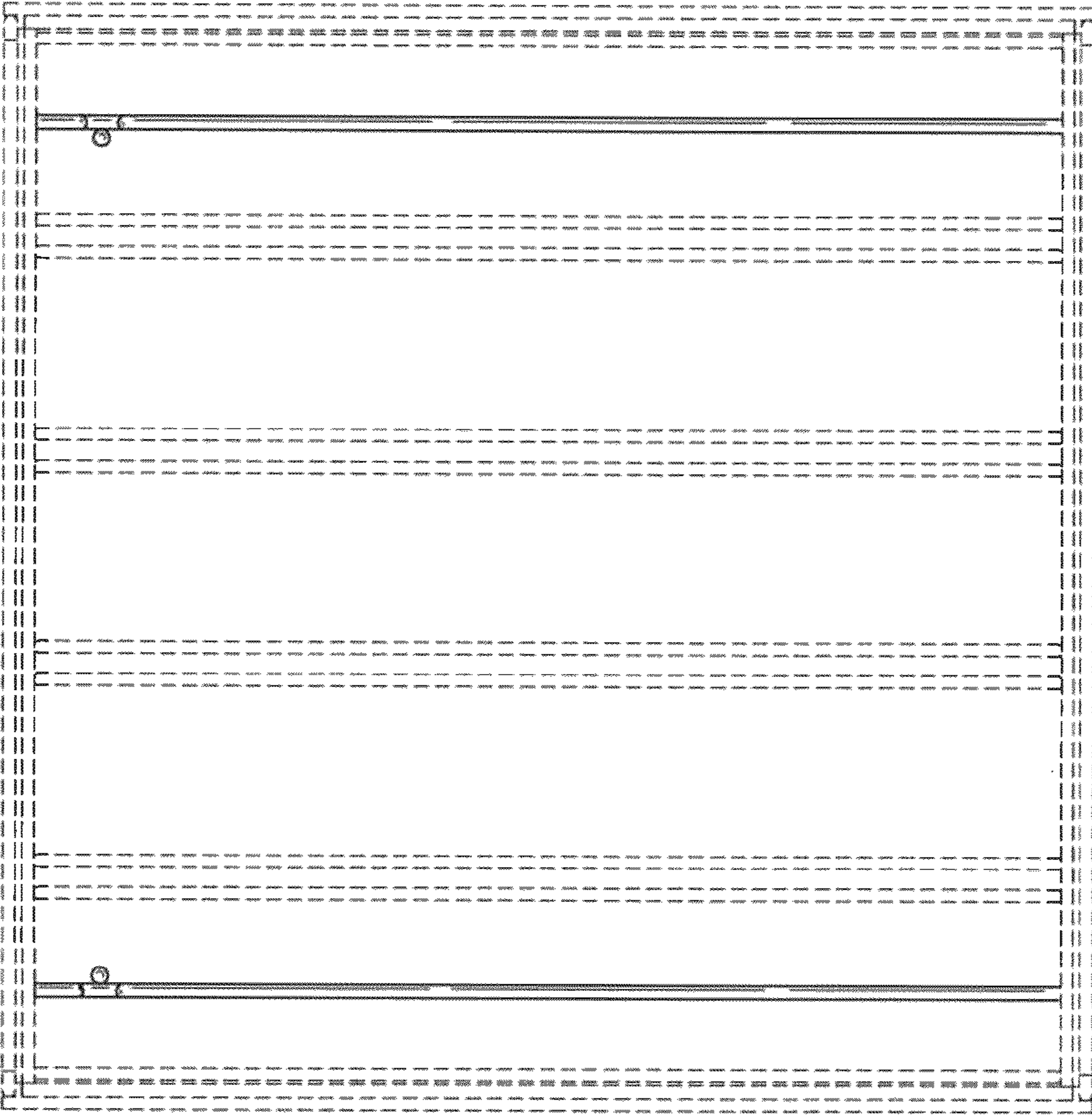

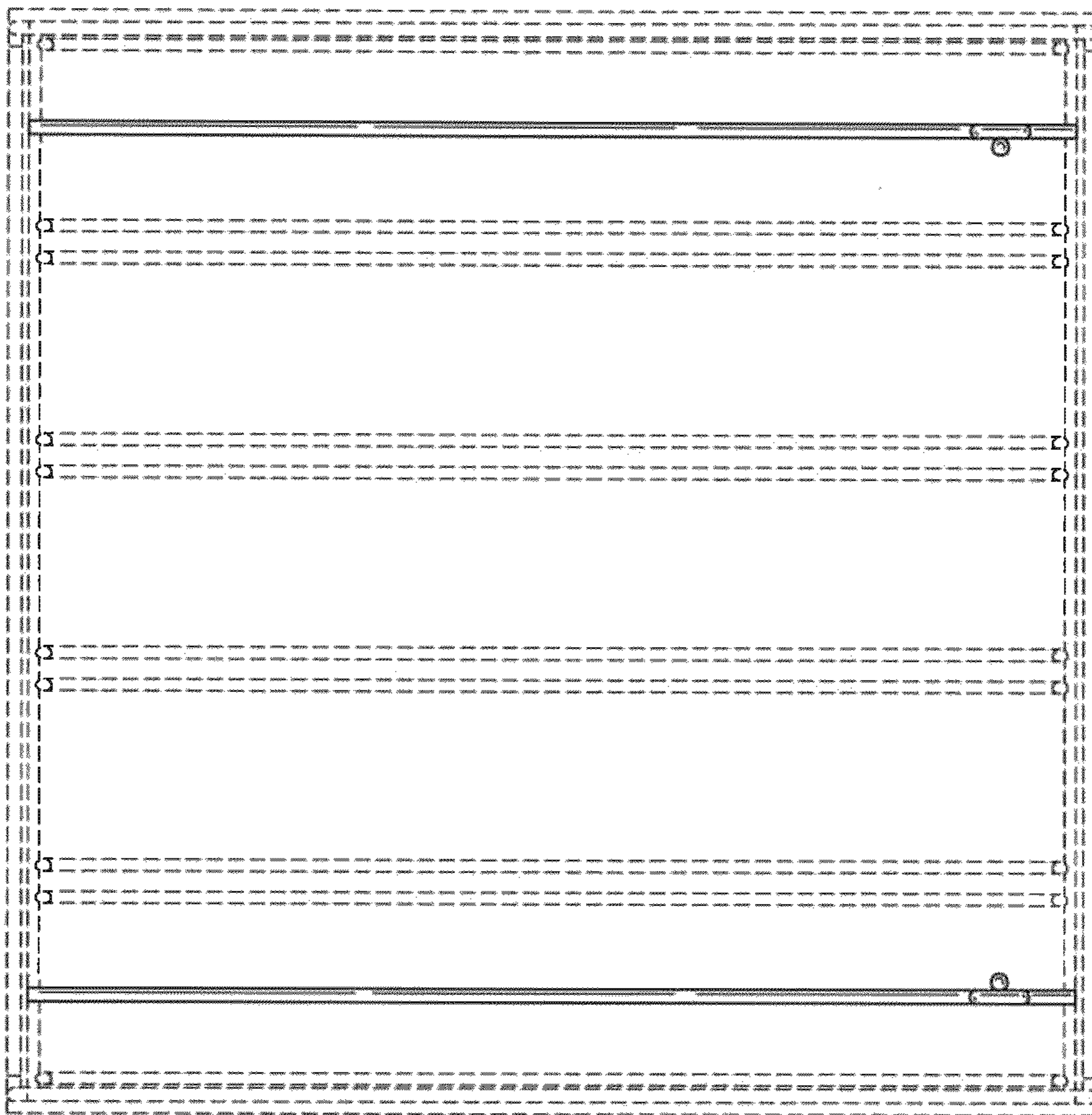
