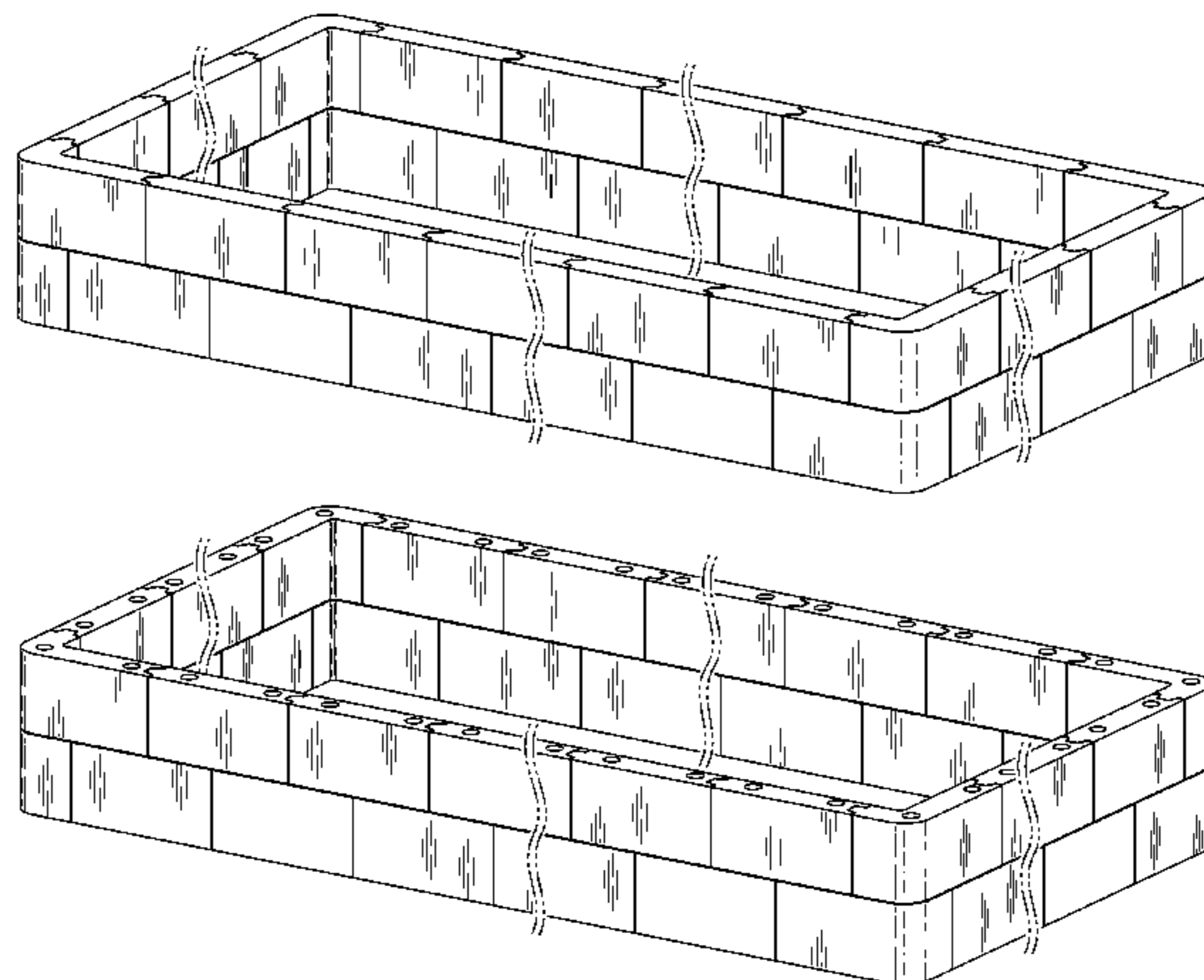
The ornamental design for a garden planter box, as shown and described.

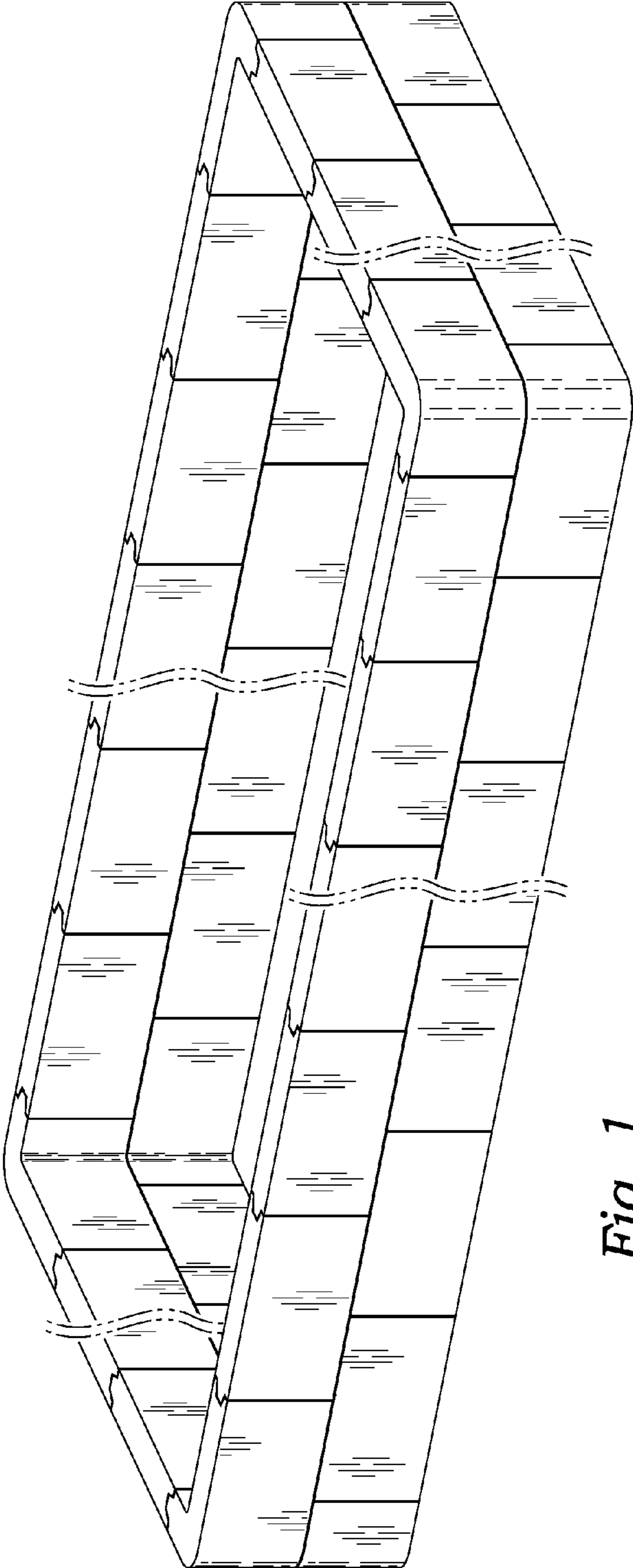

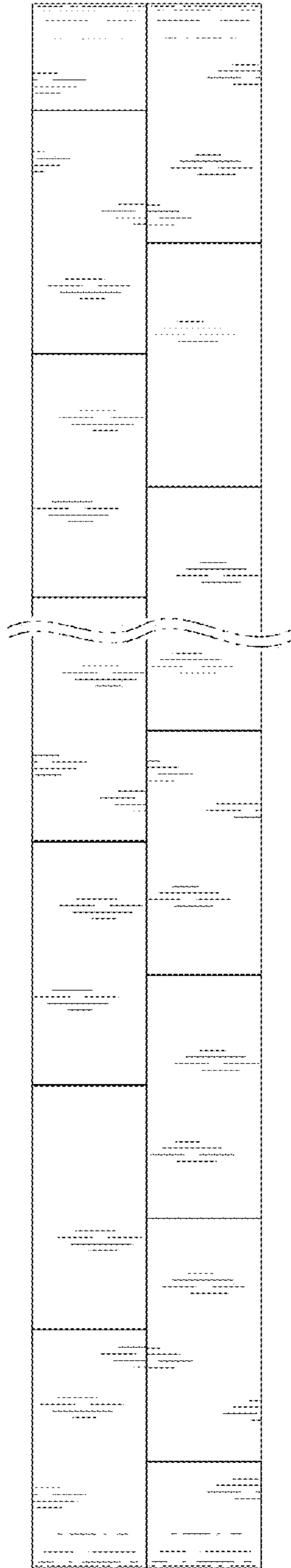

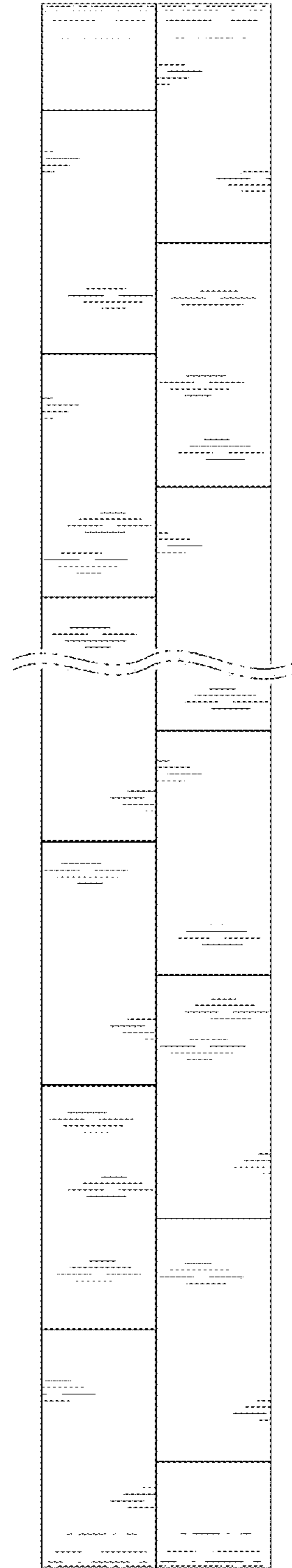

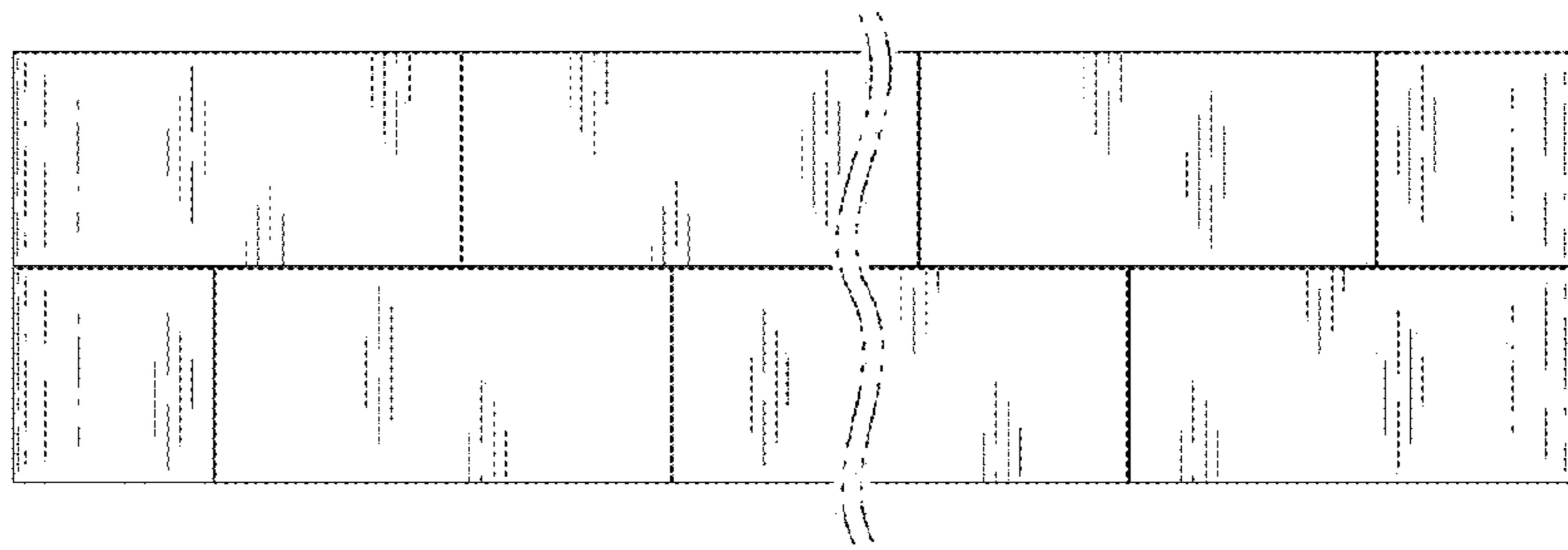

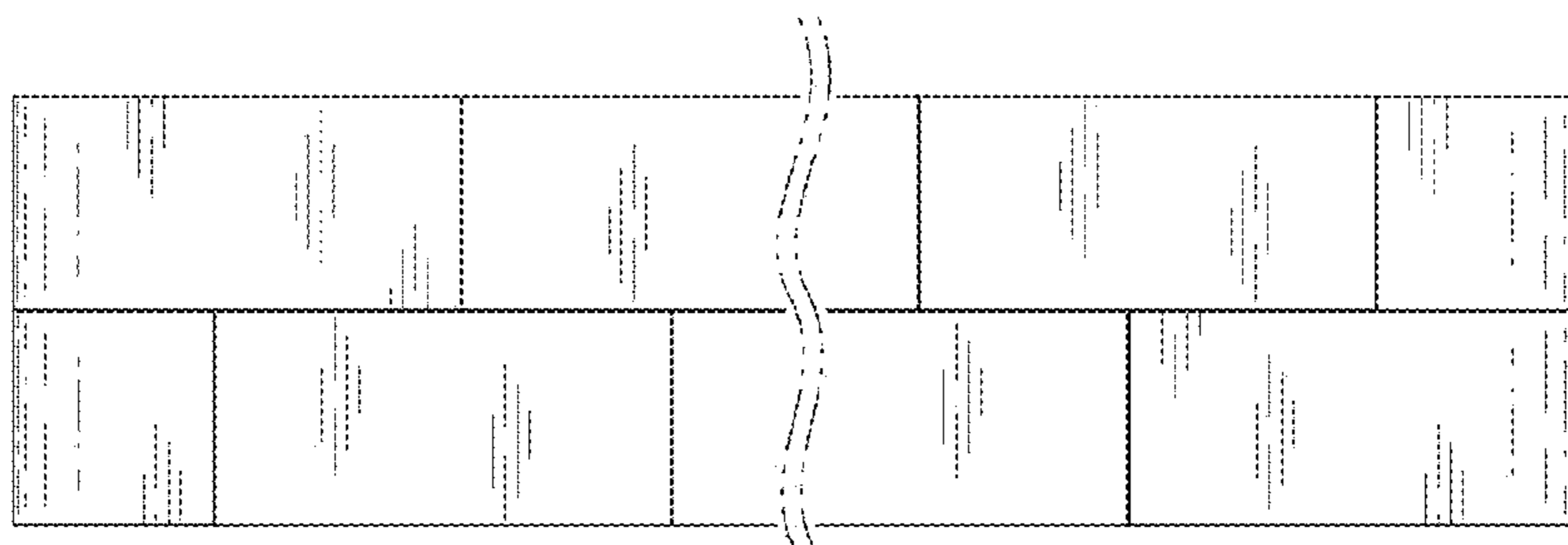

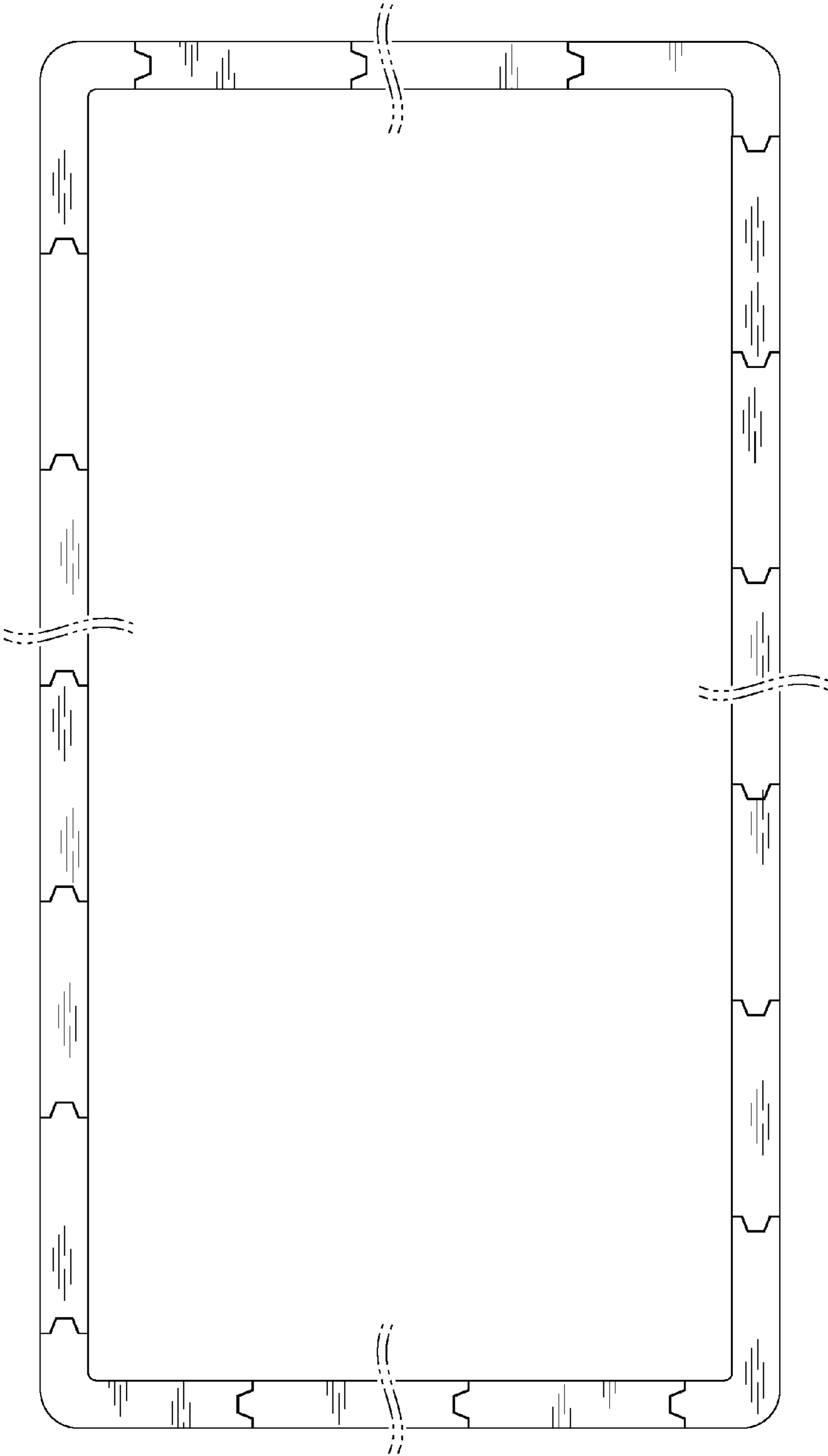

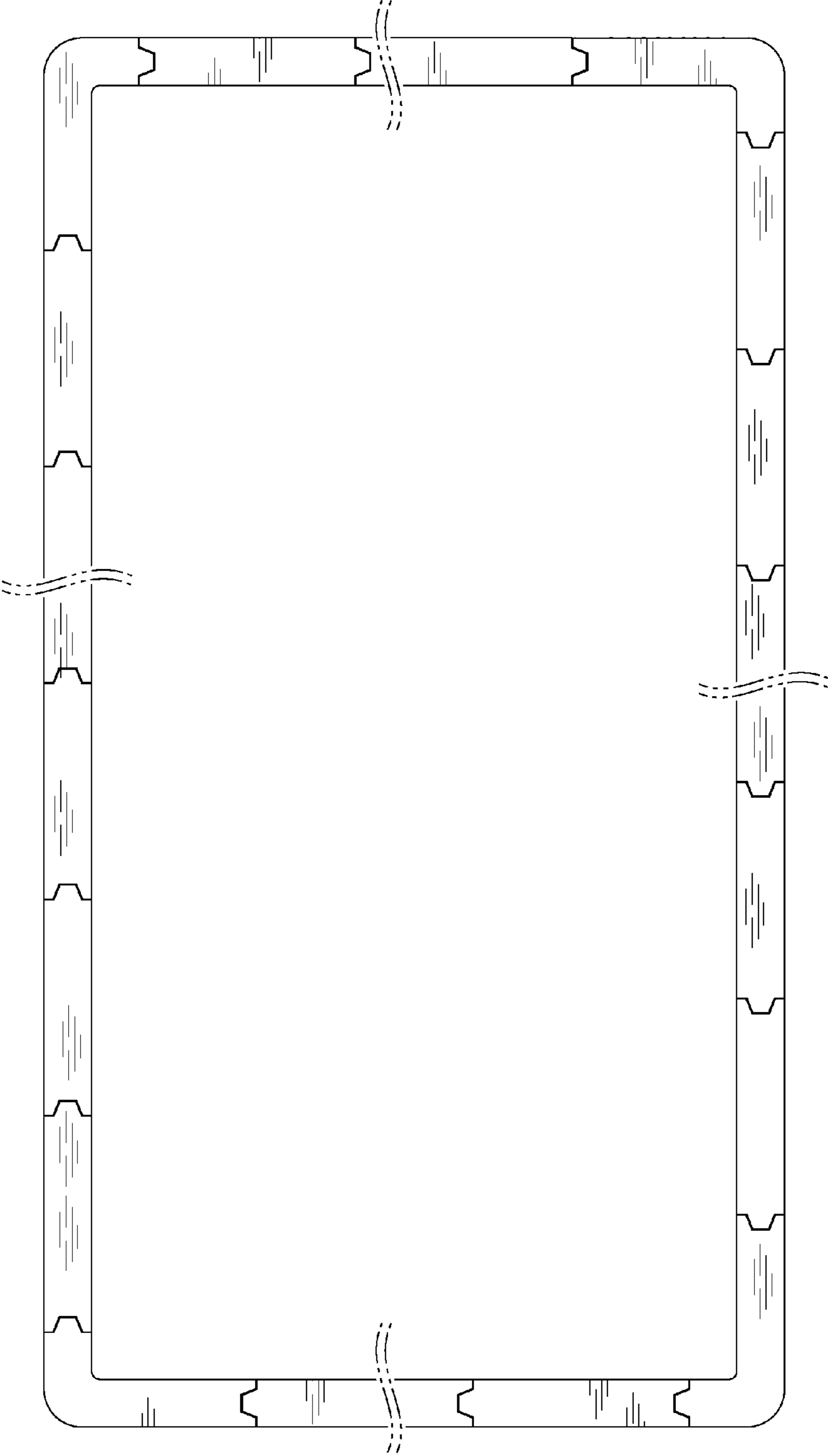

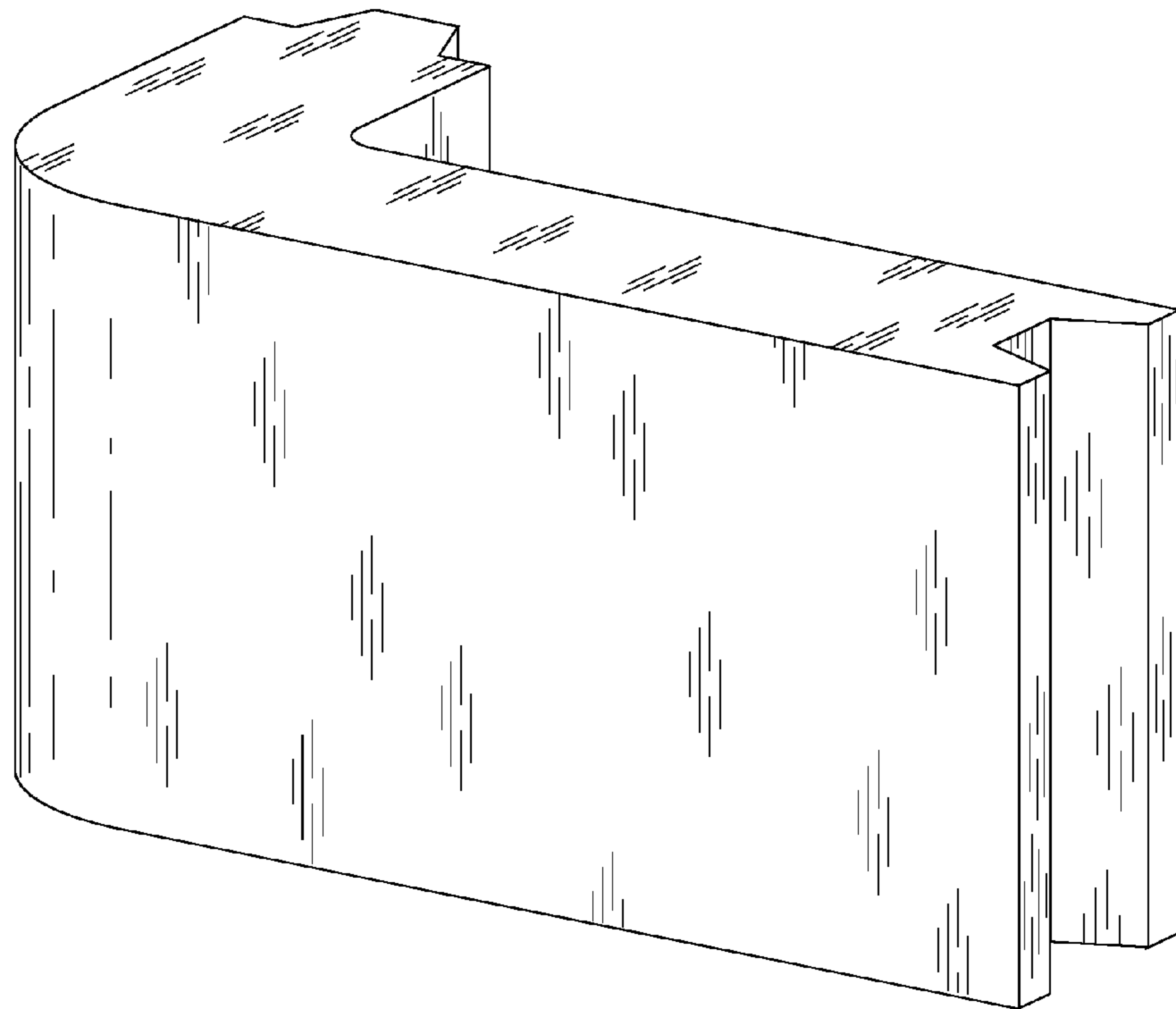

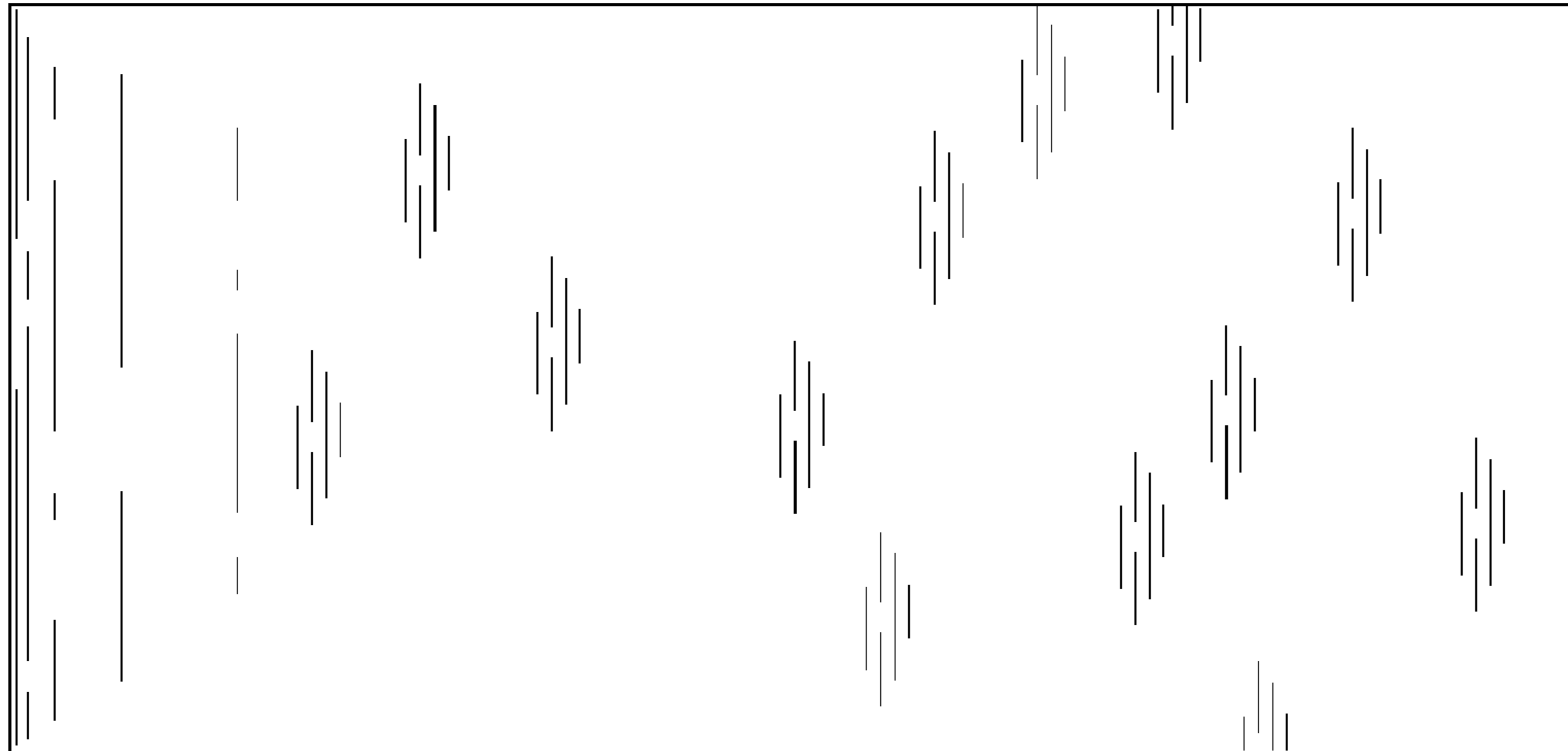

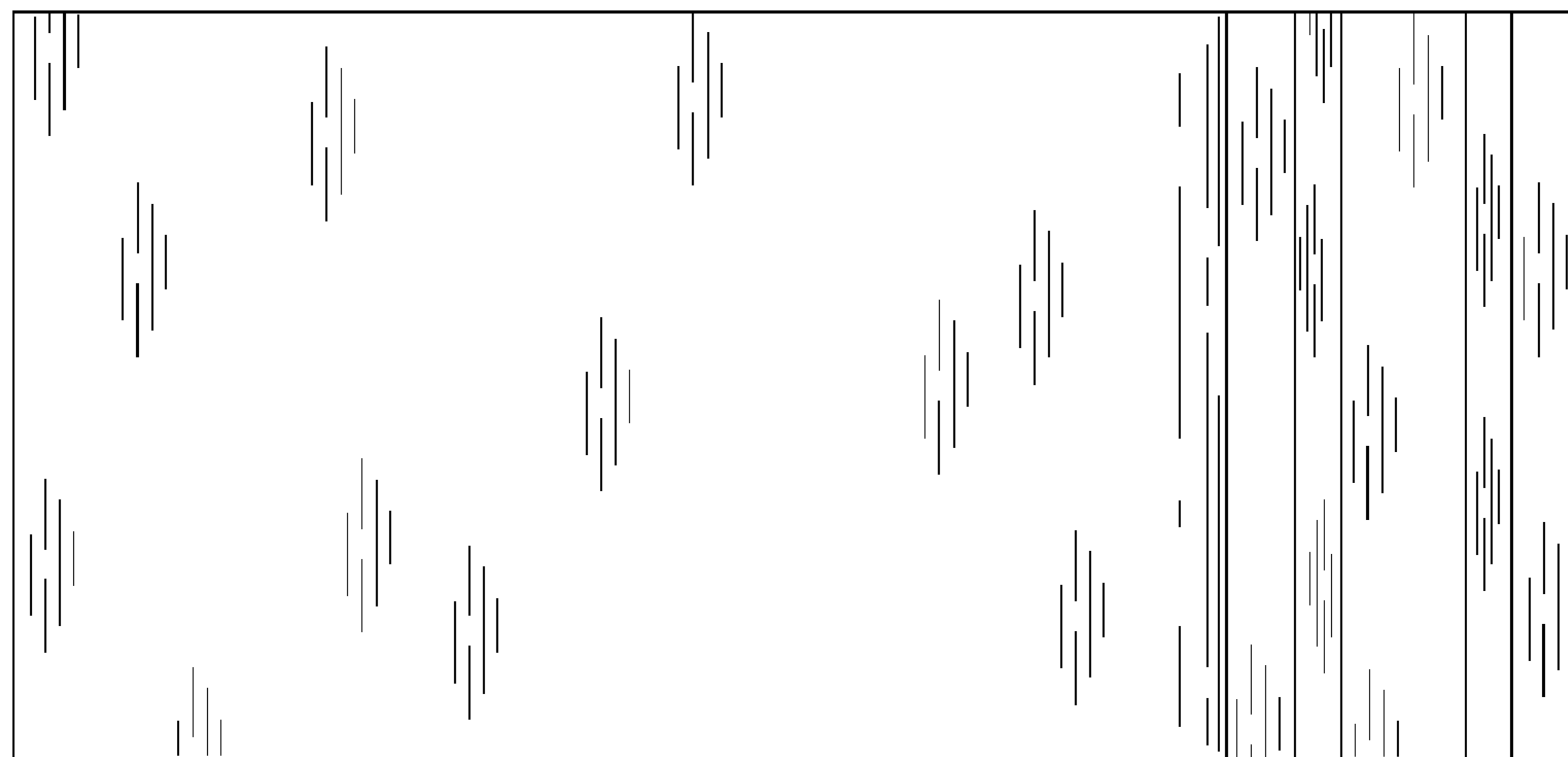

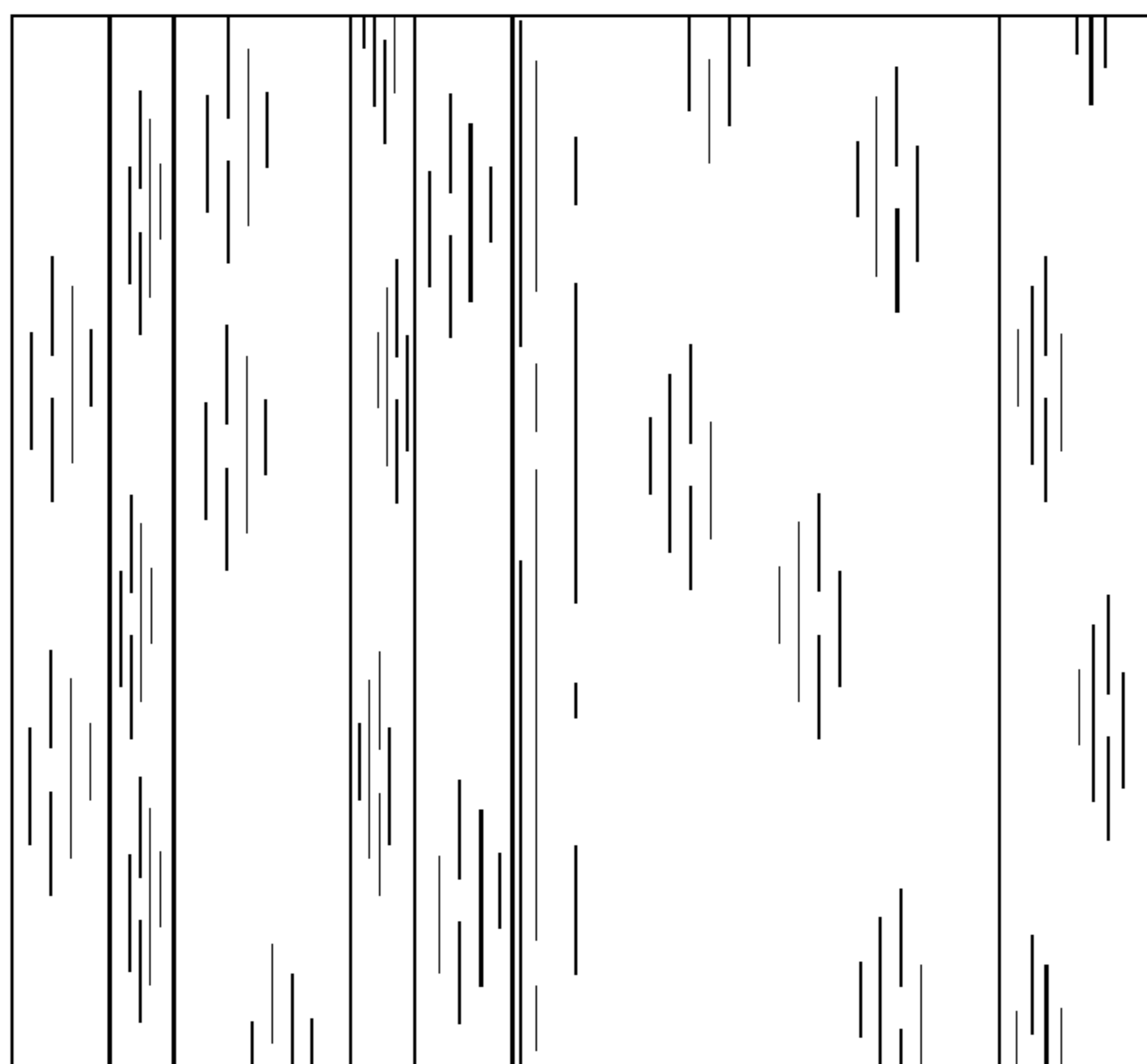

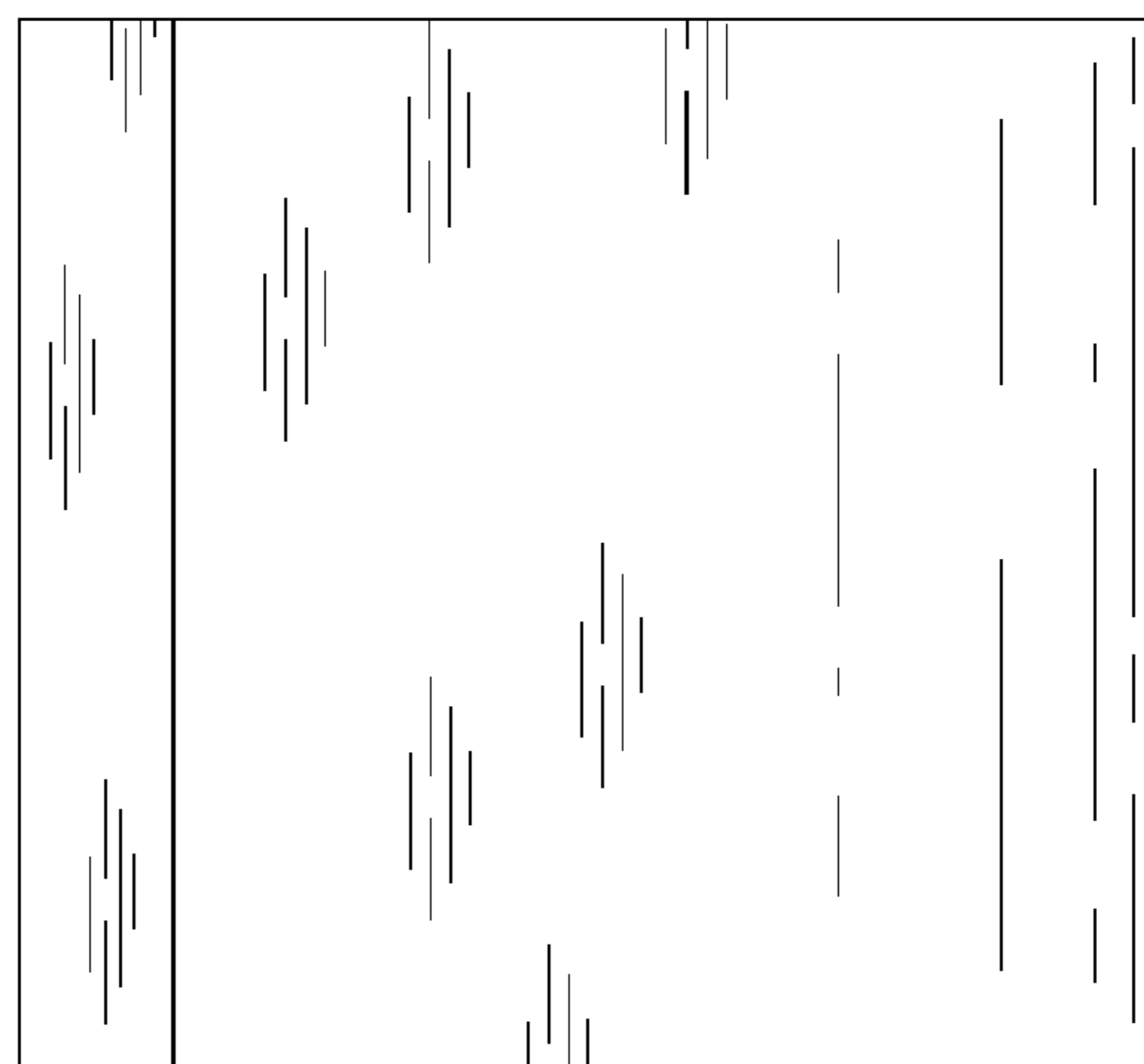

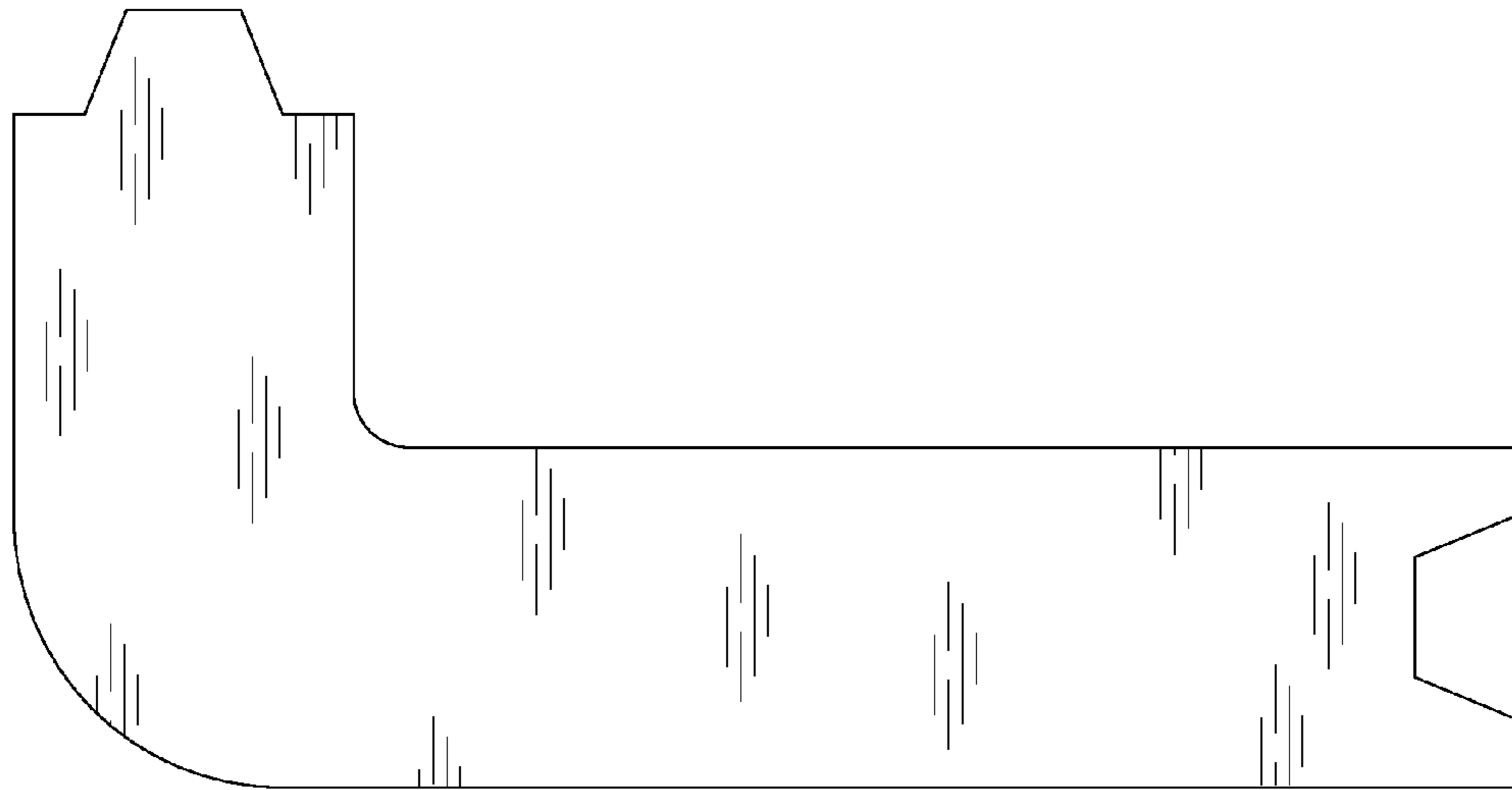

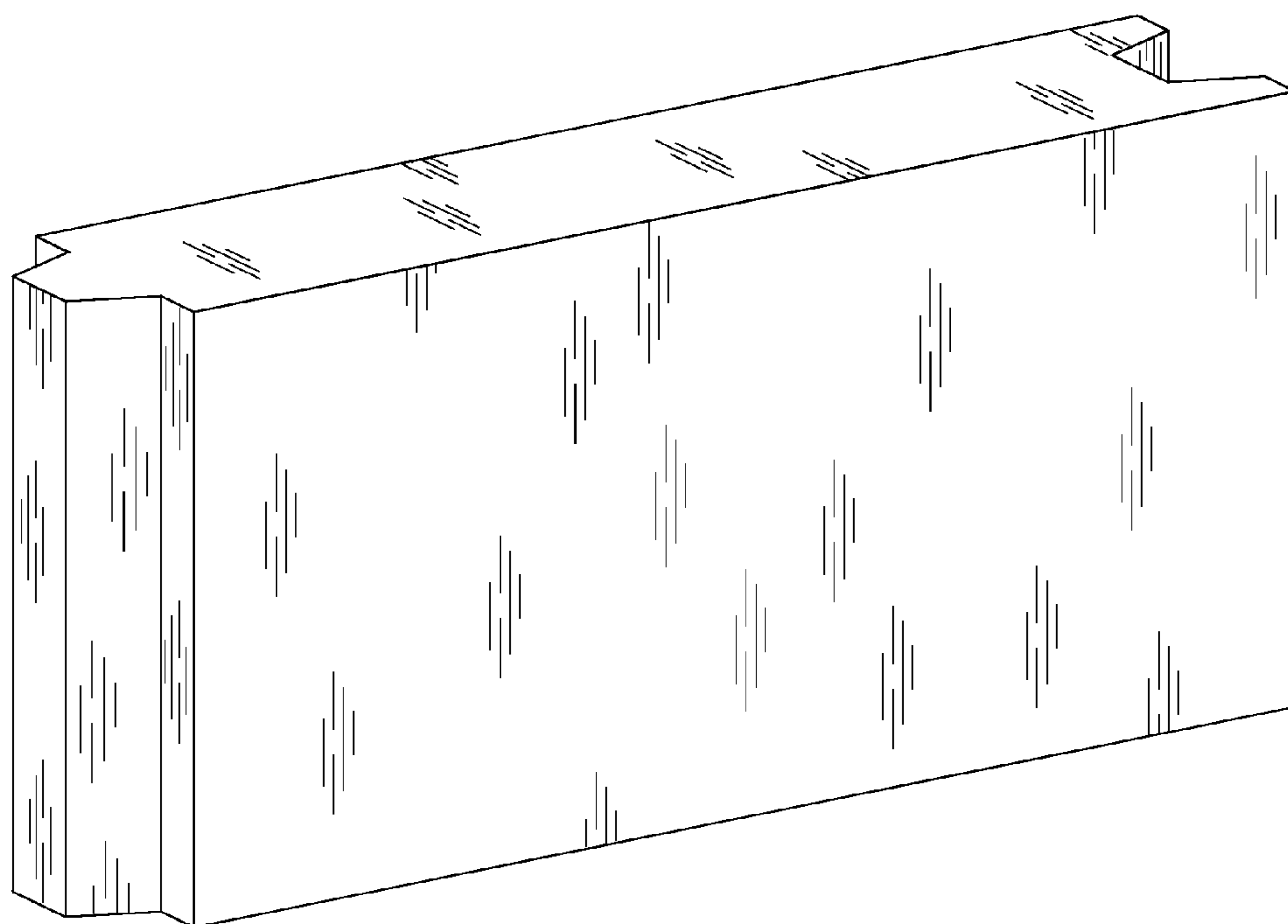

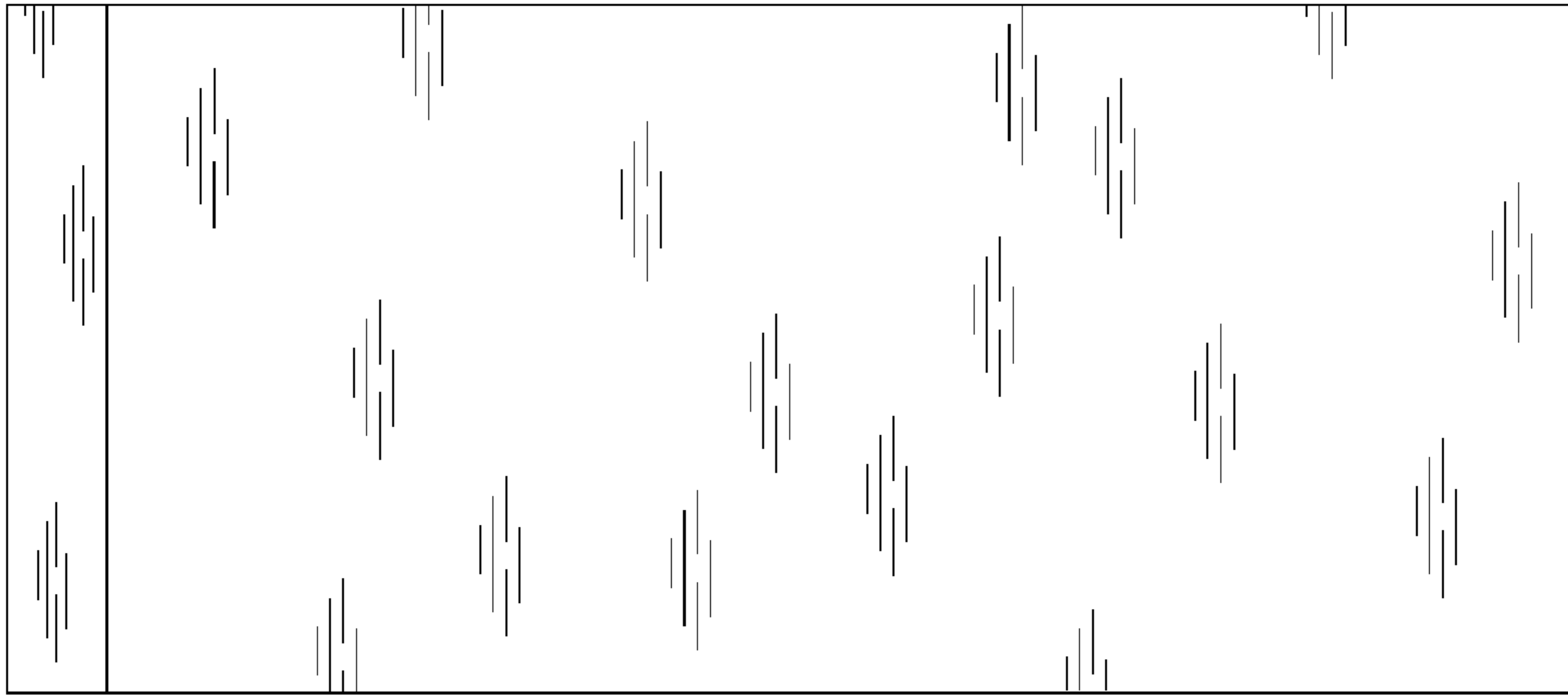

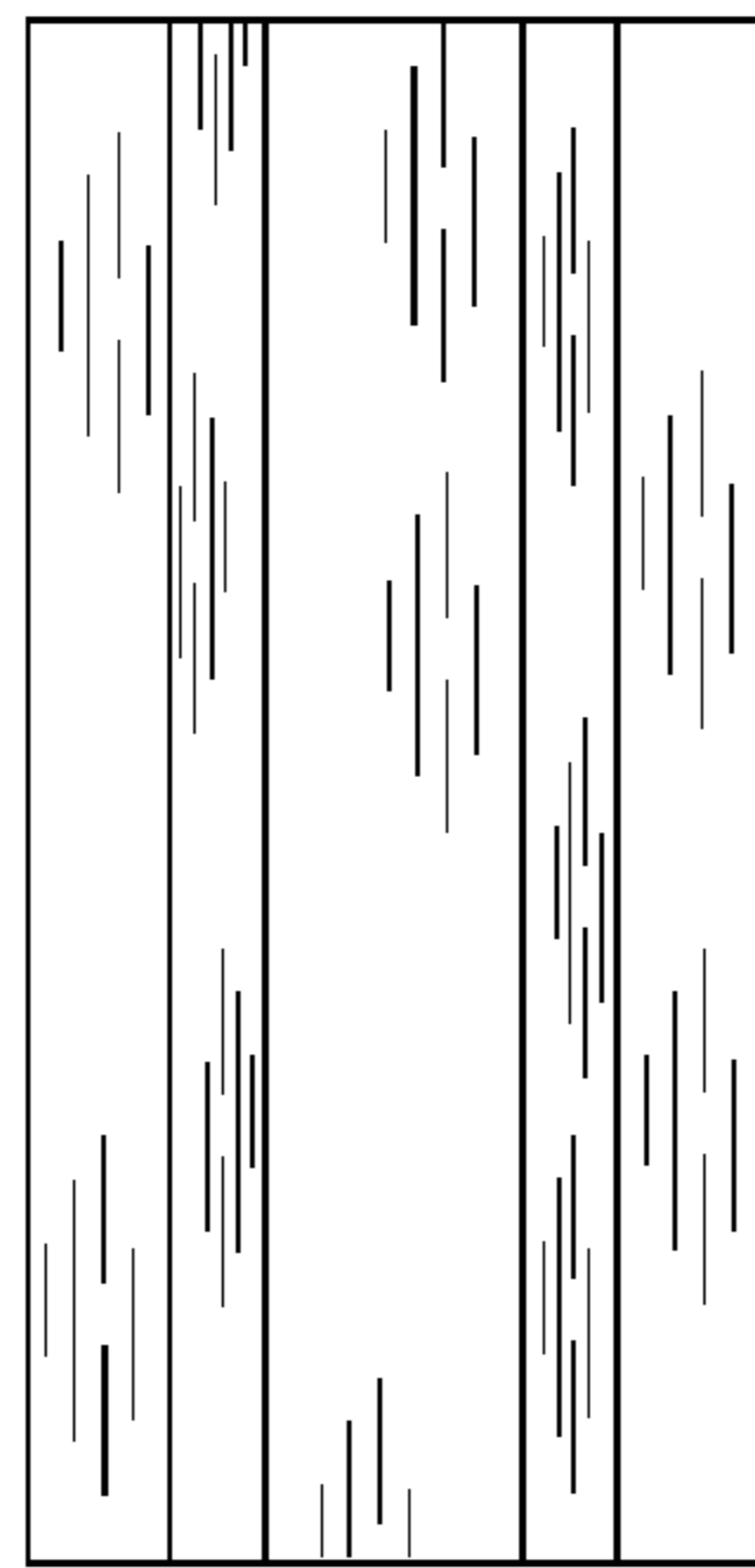

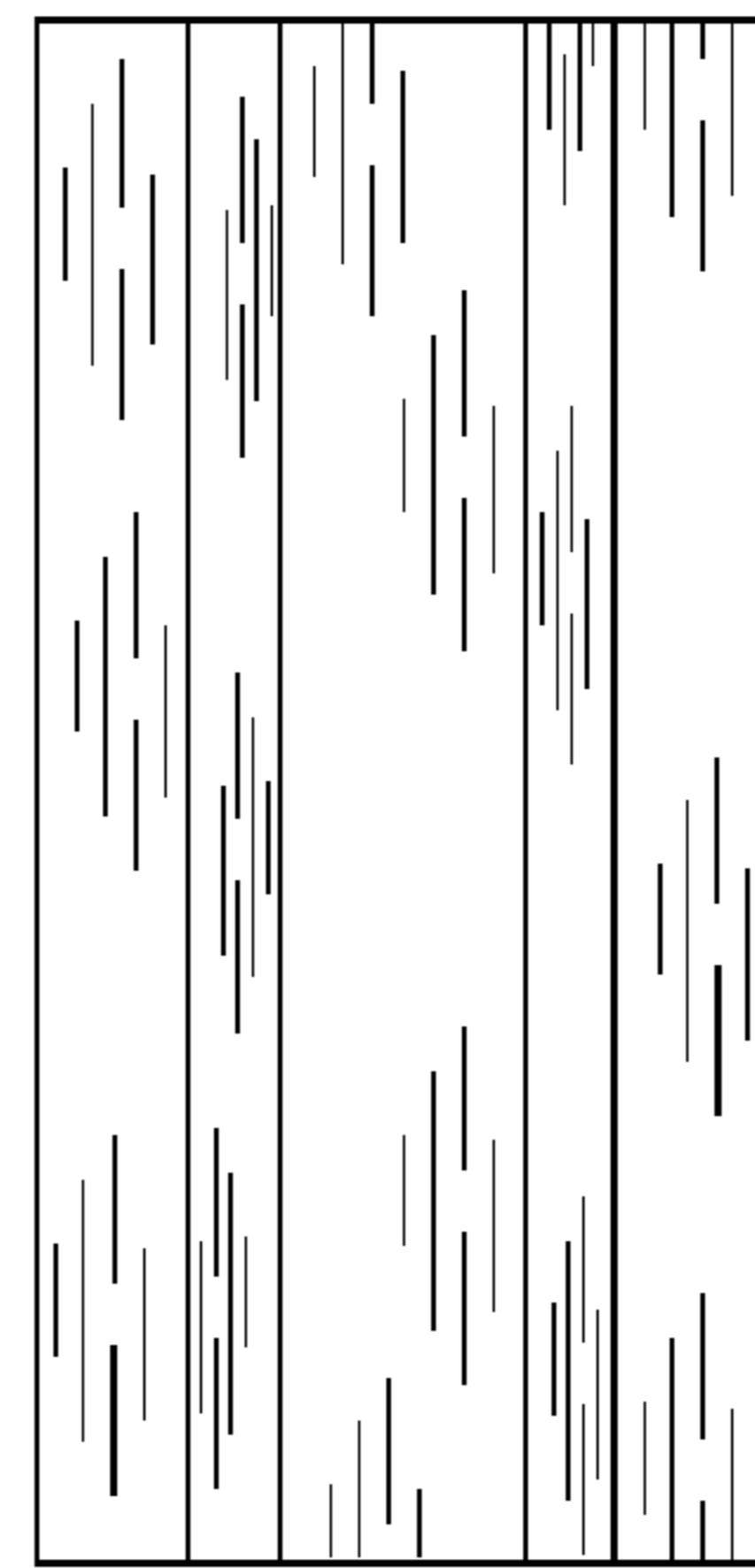

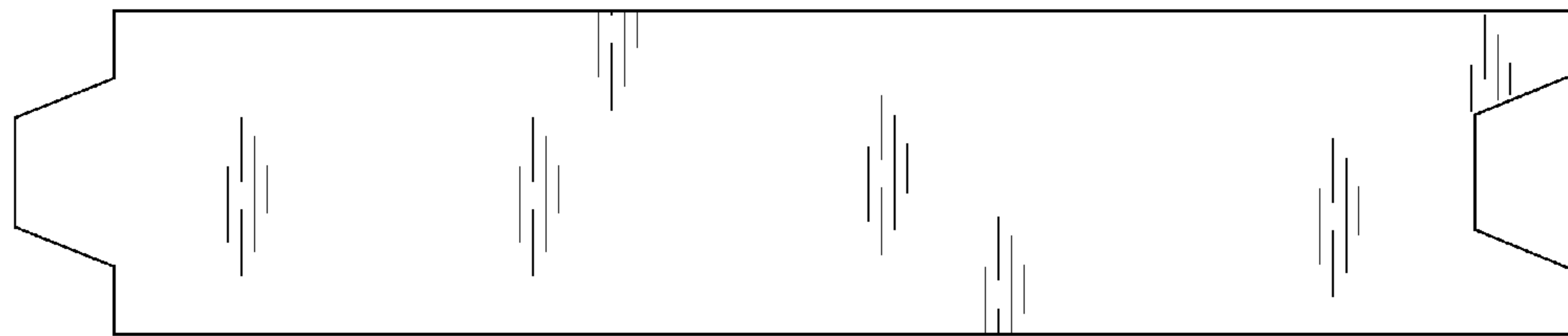

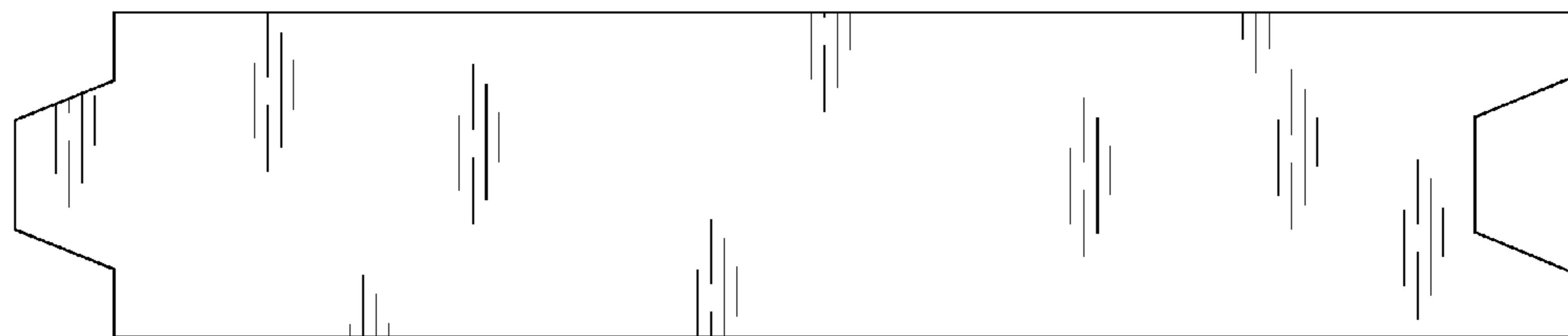

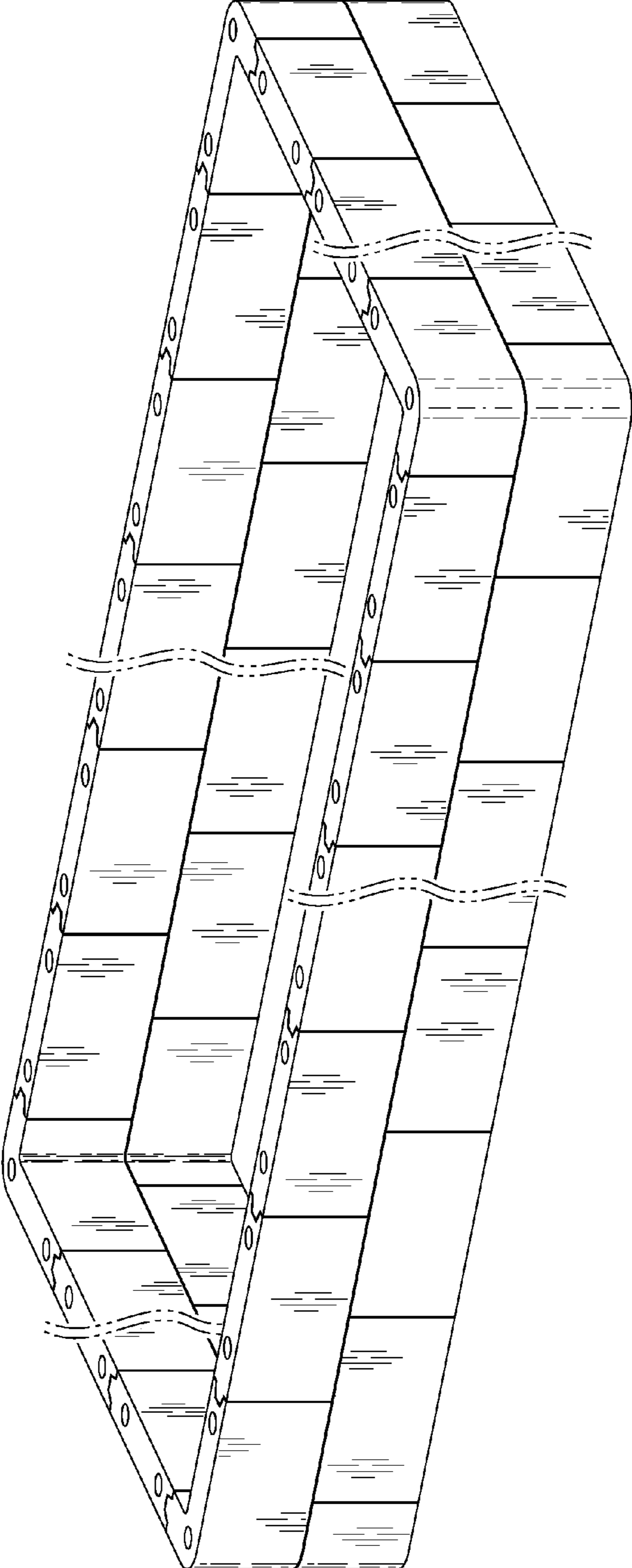

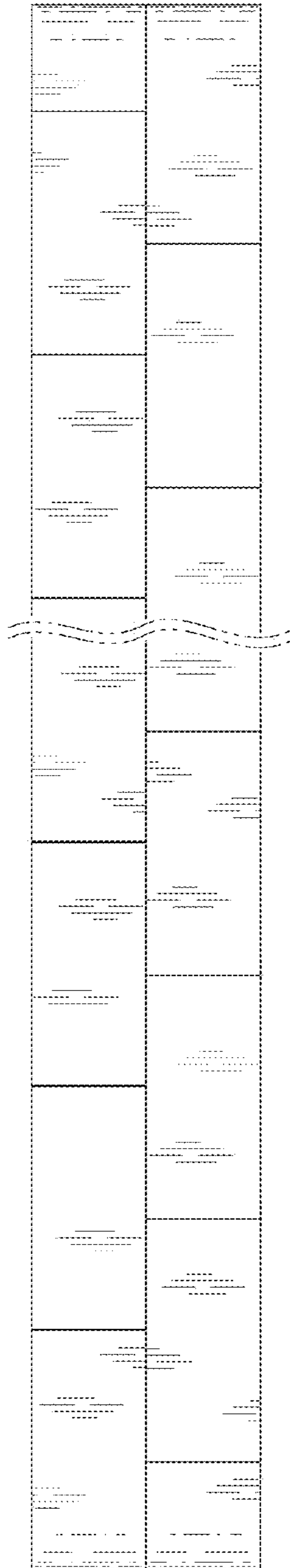

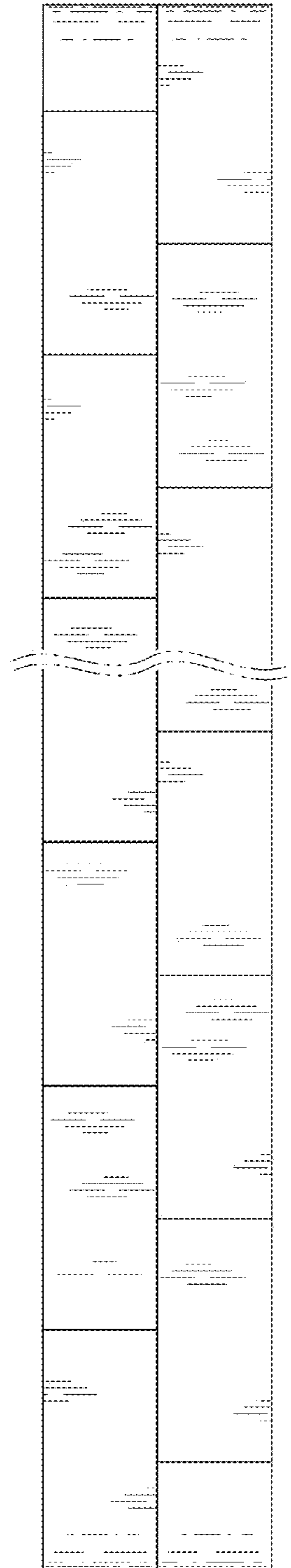

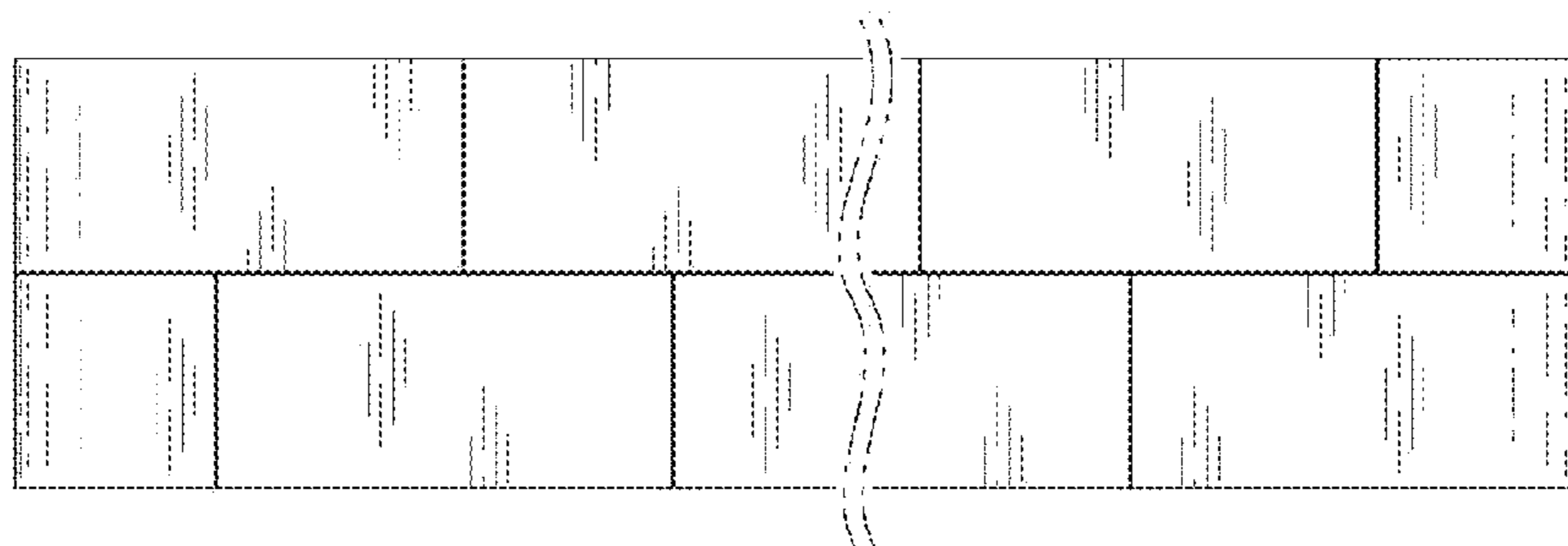

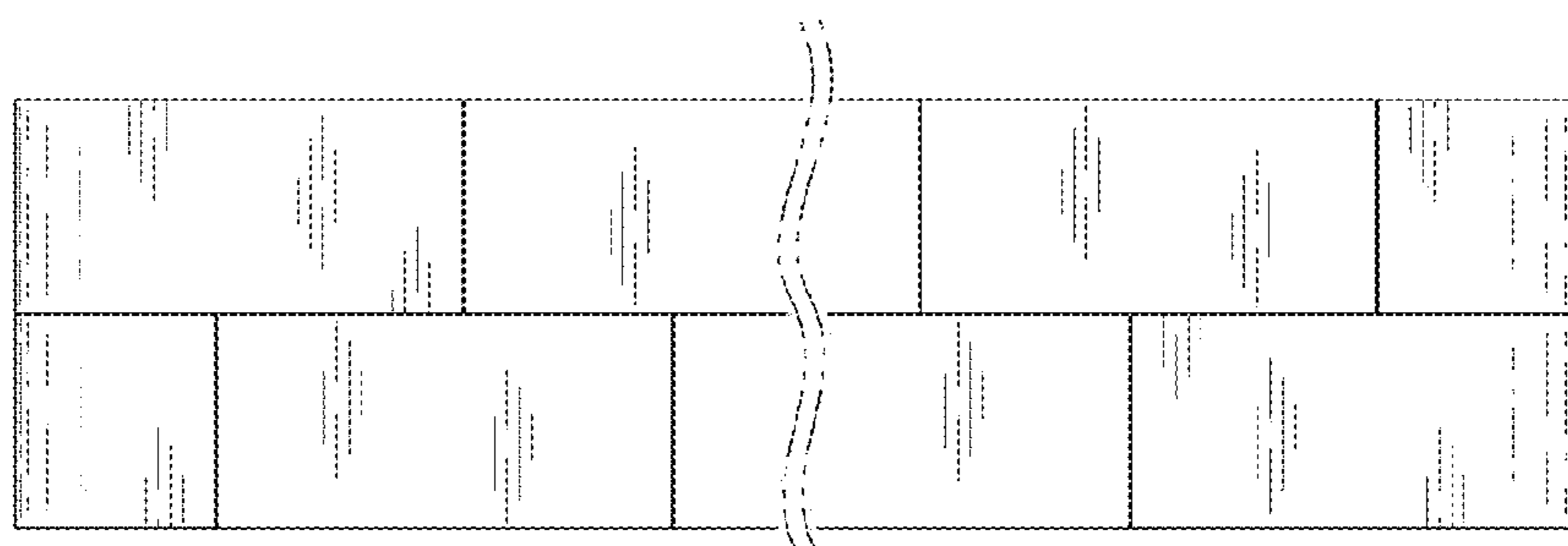

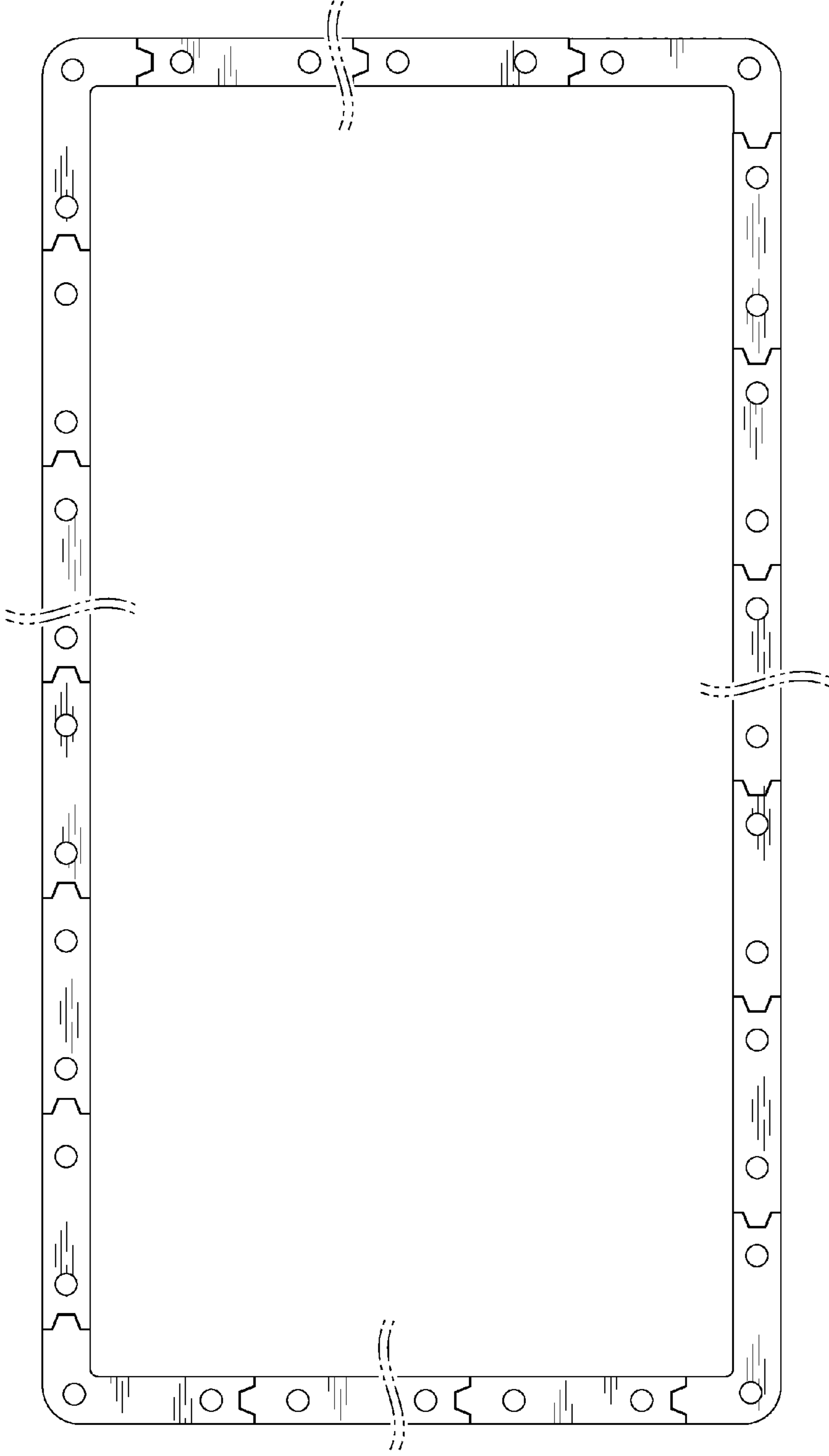

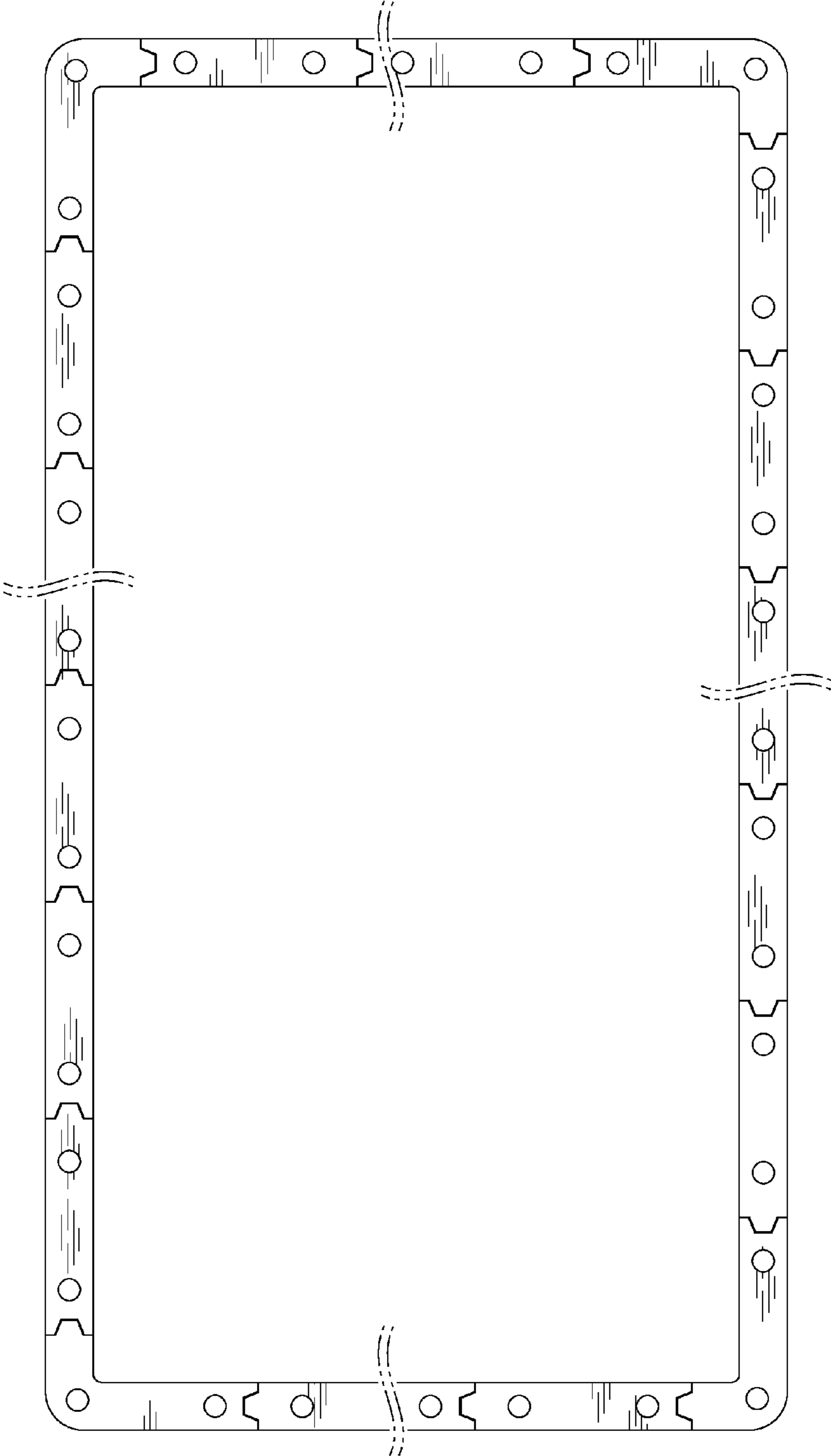

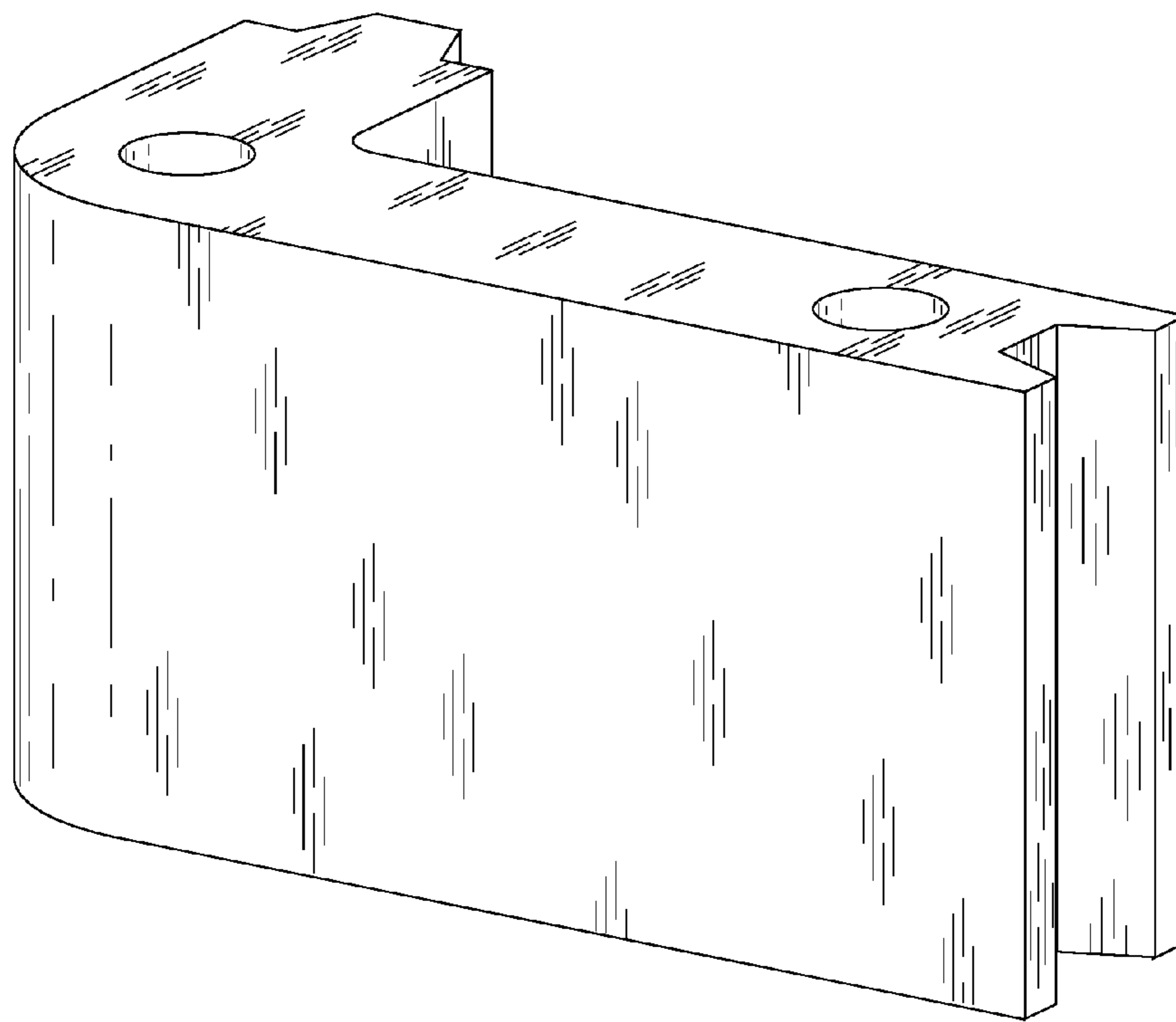

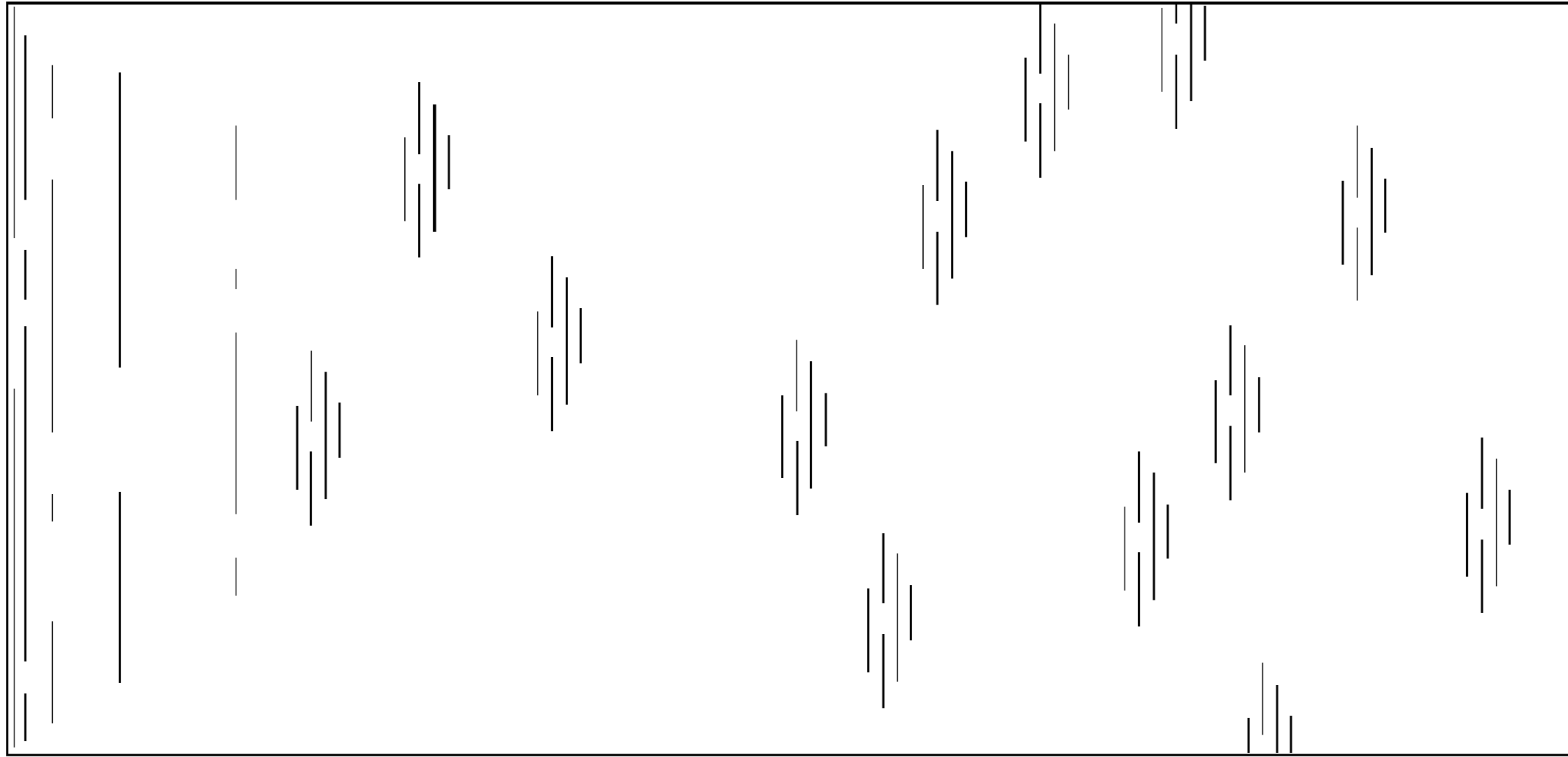

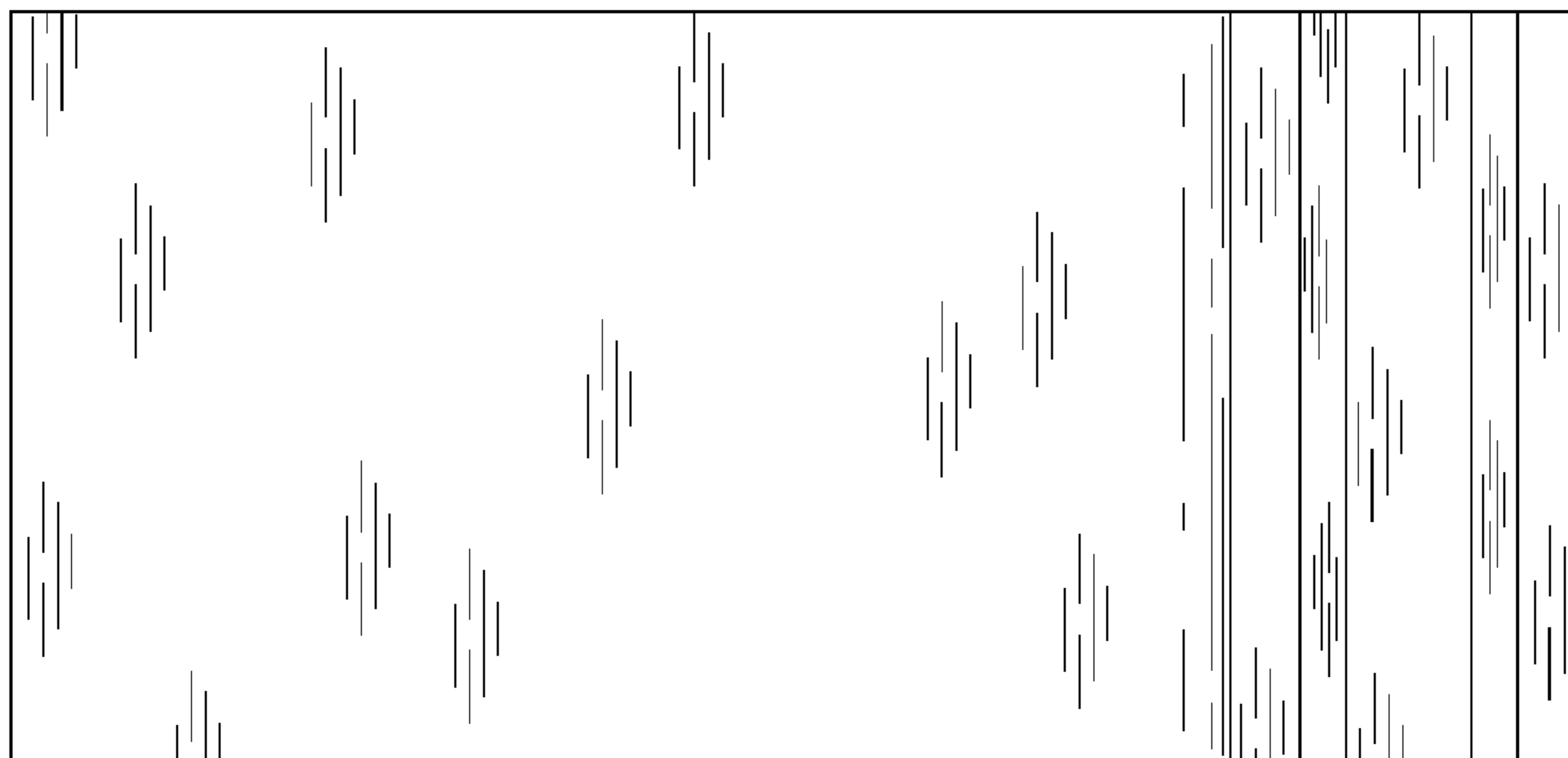

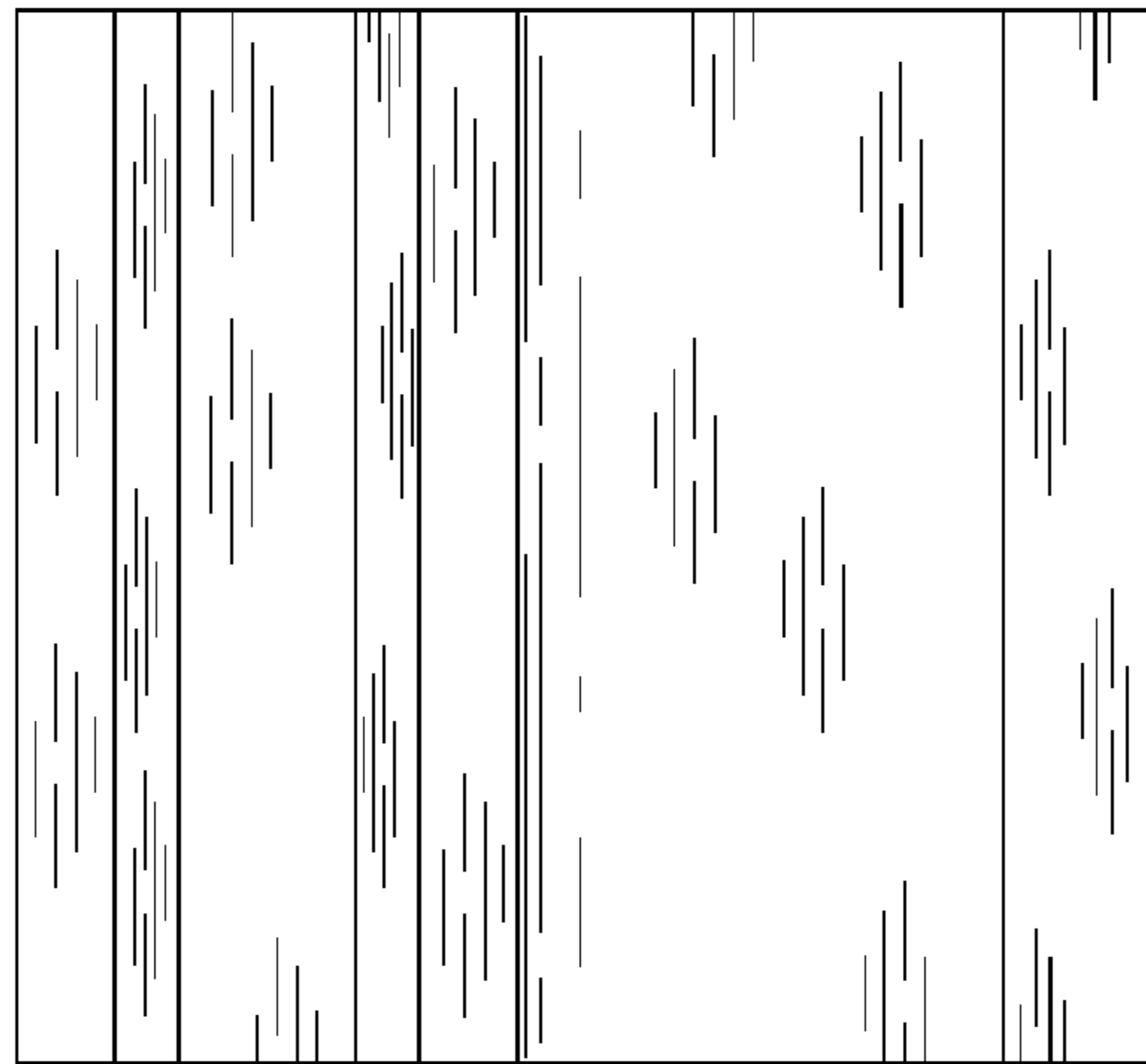

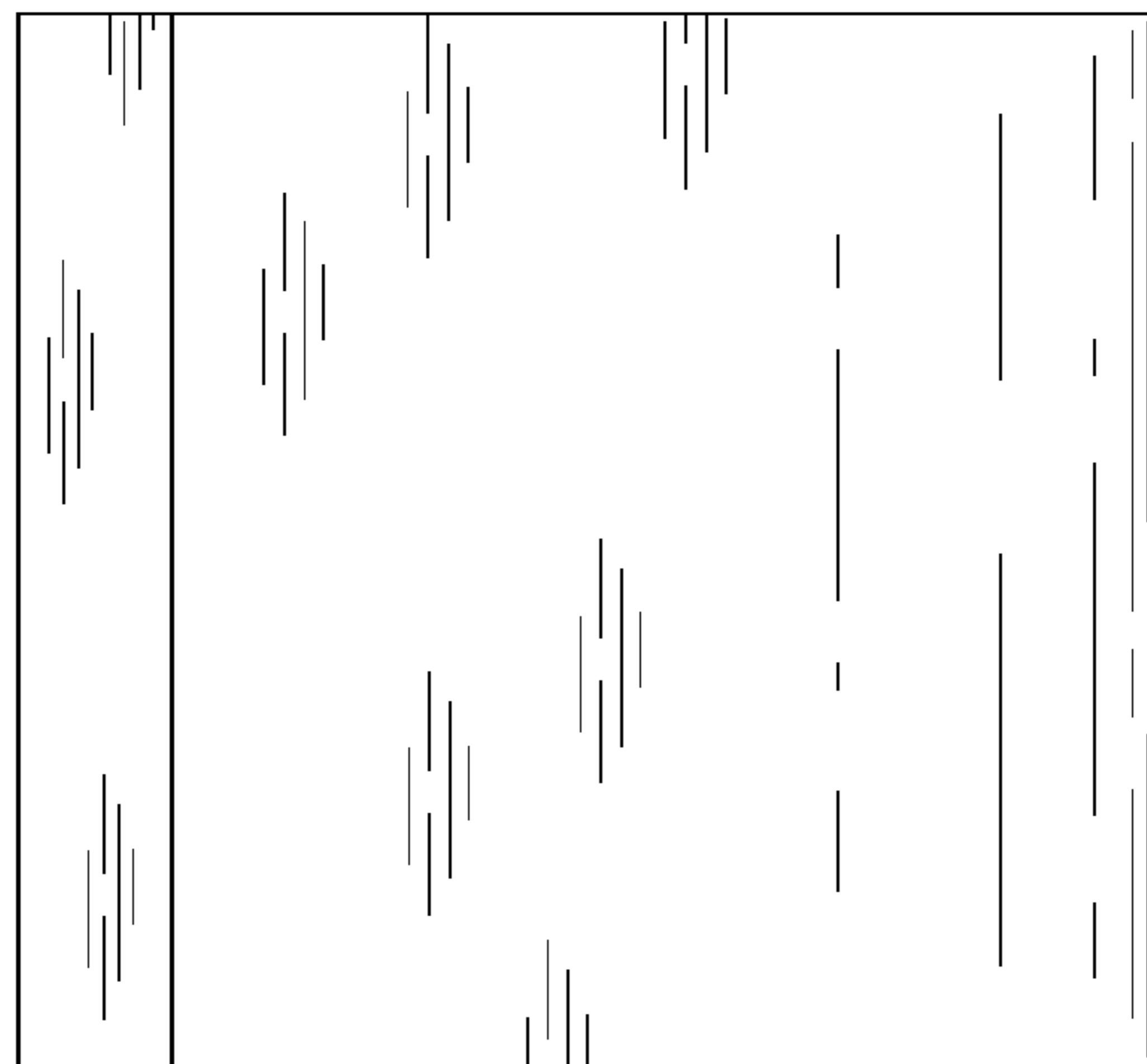

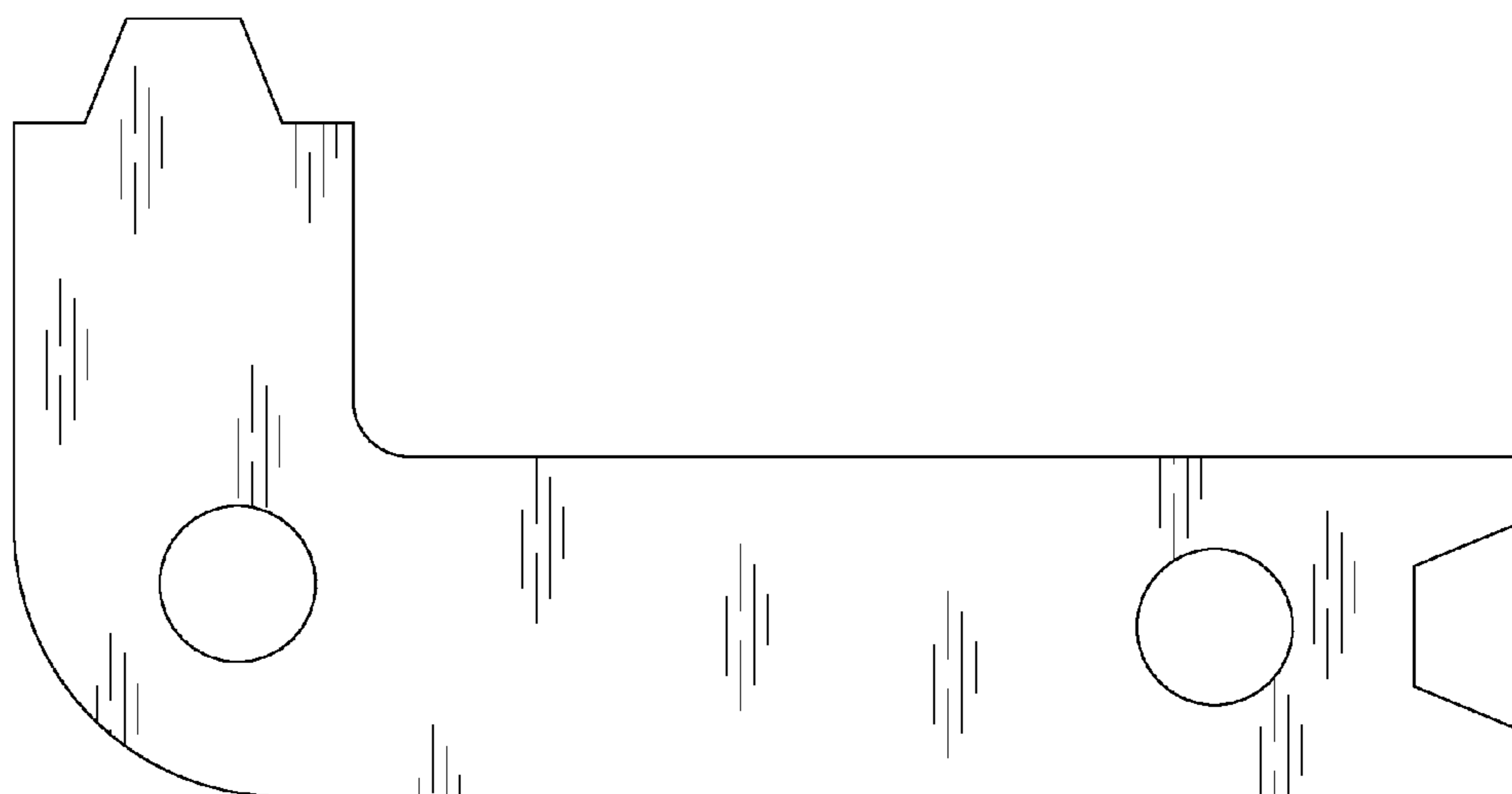

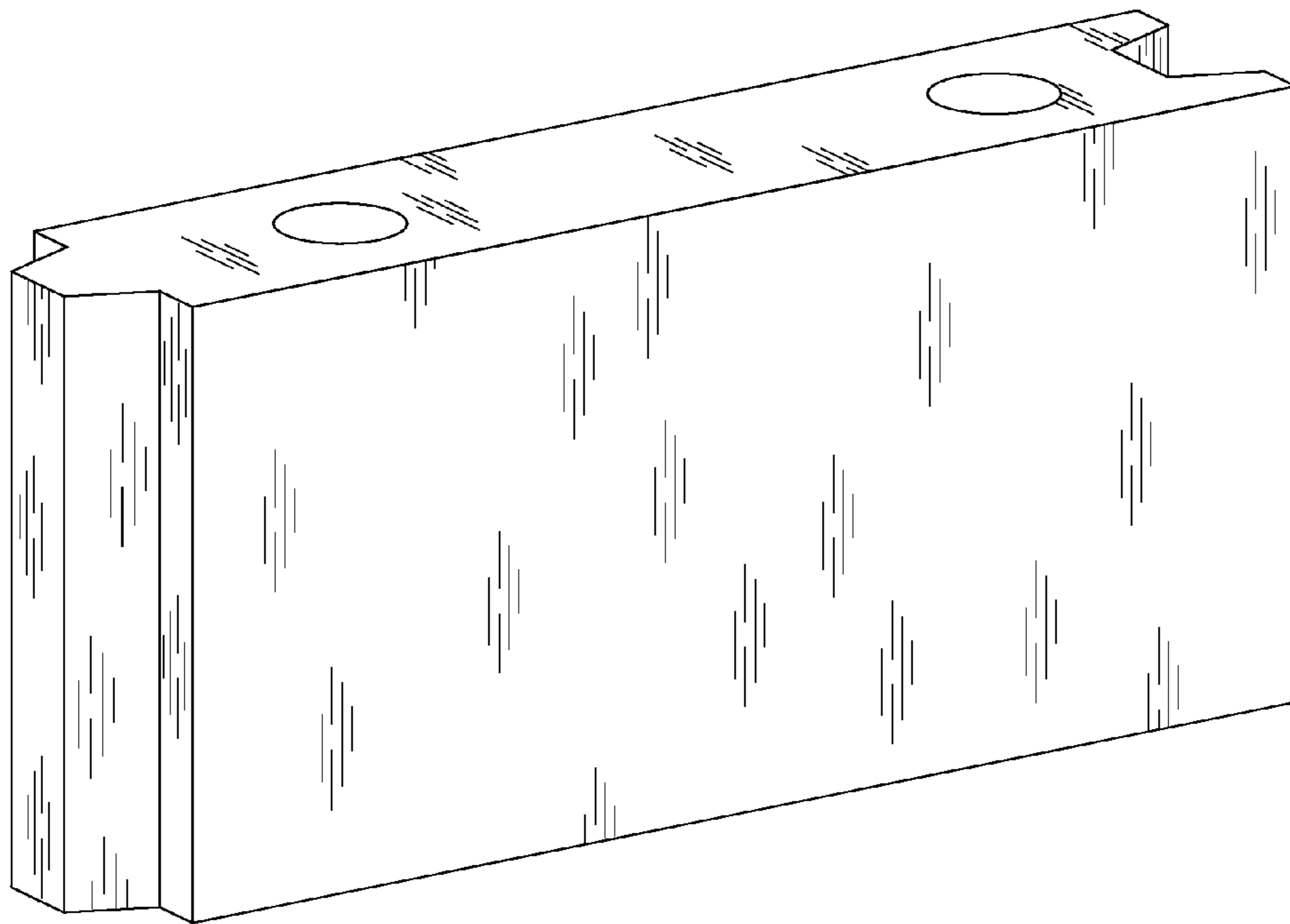

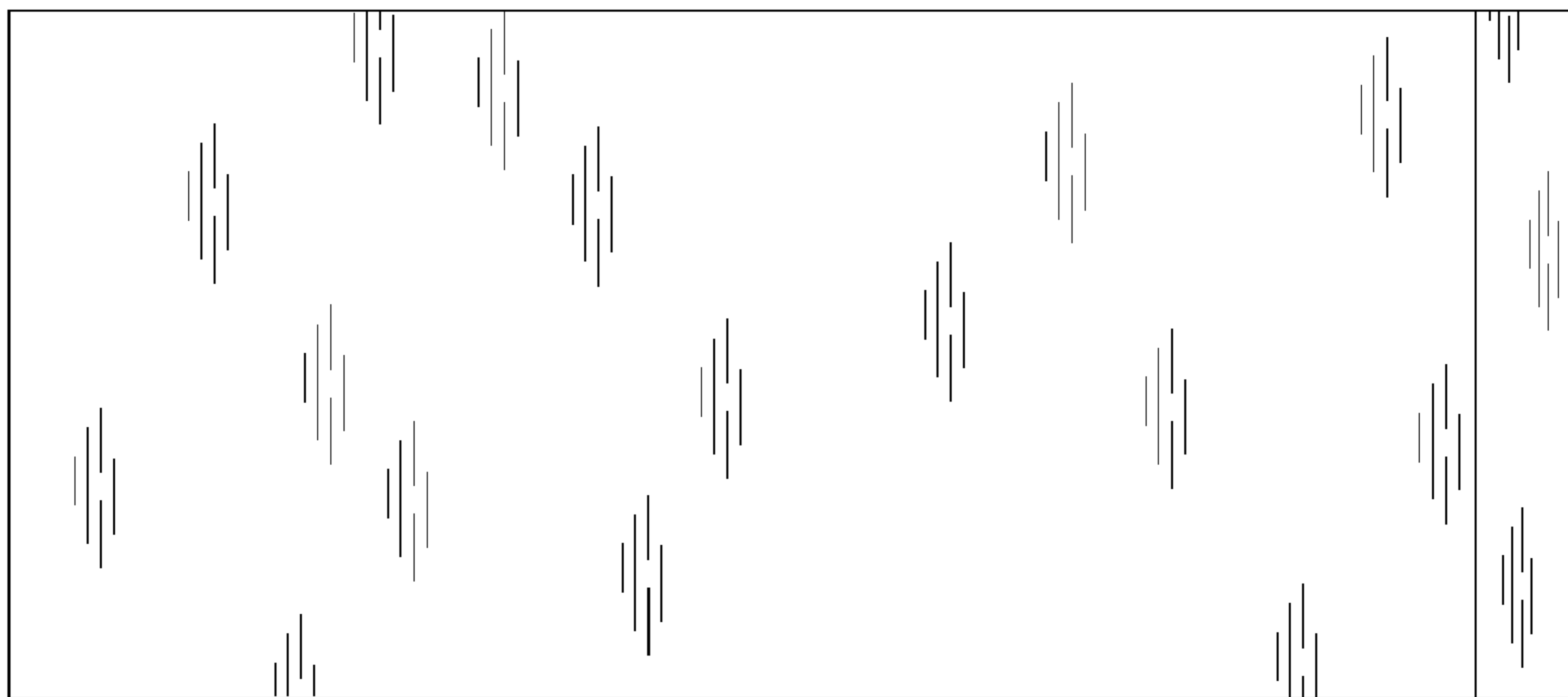

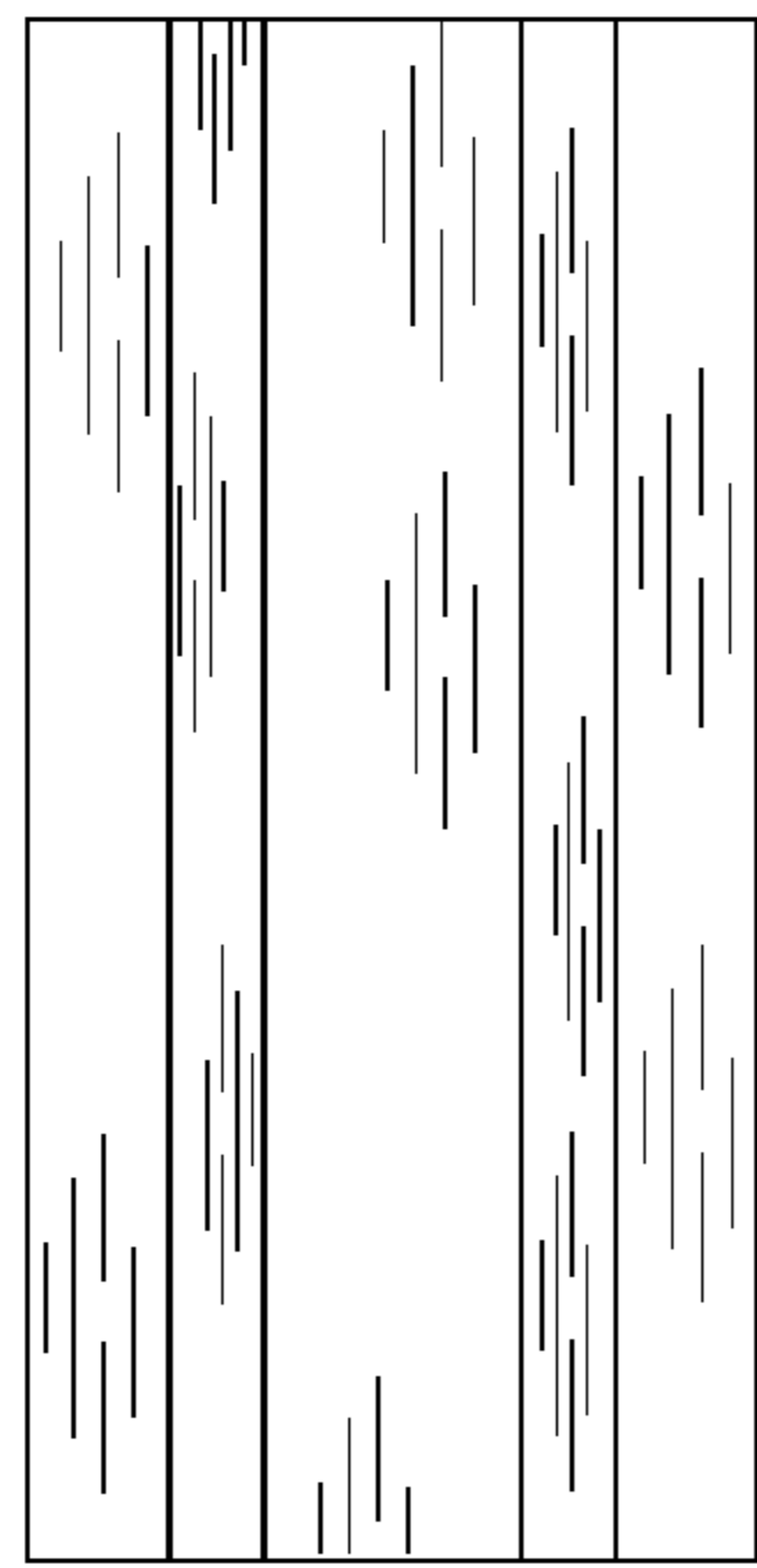

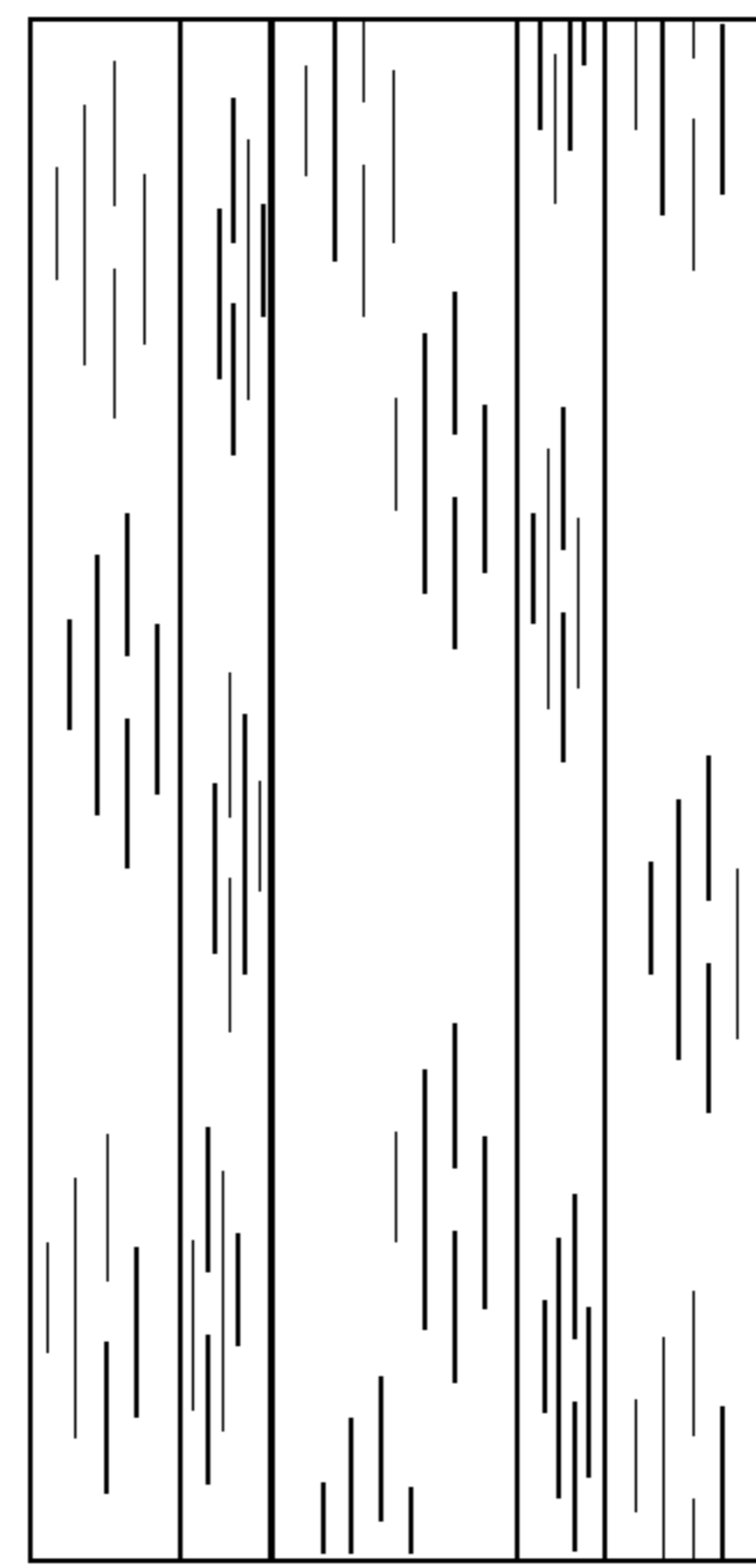

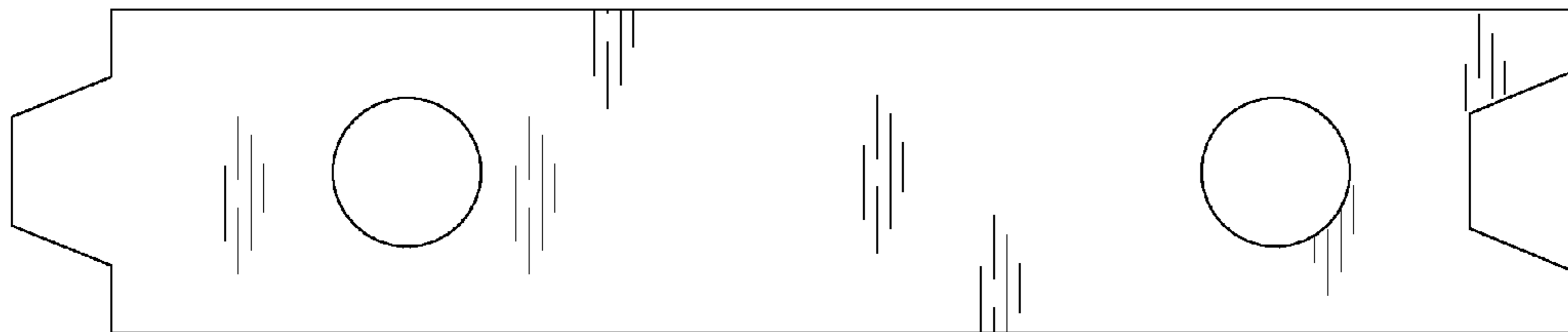

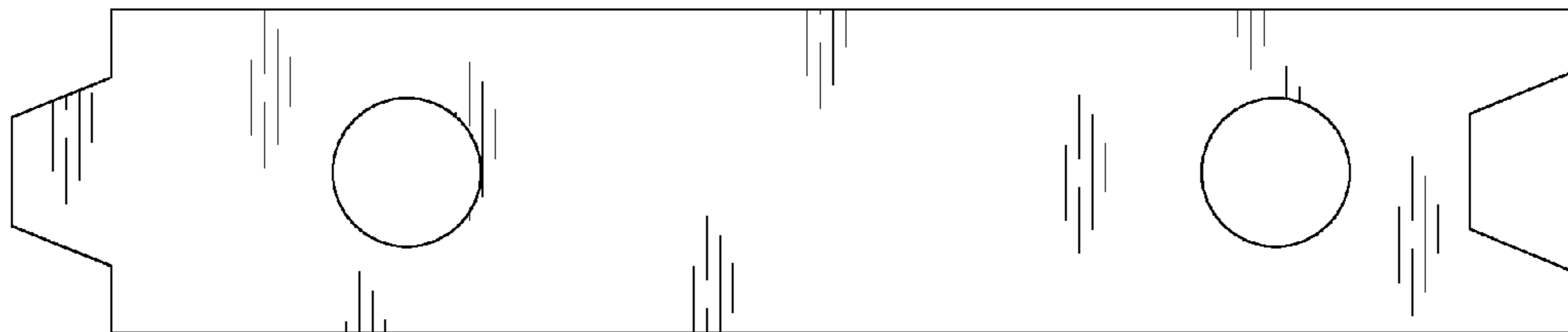
