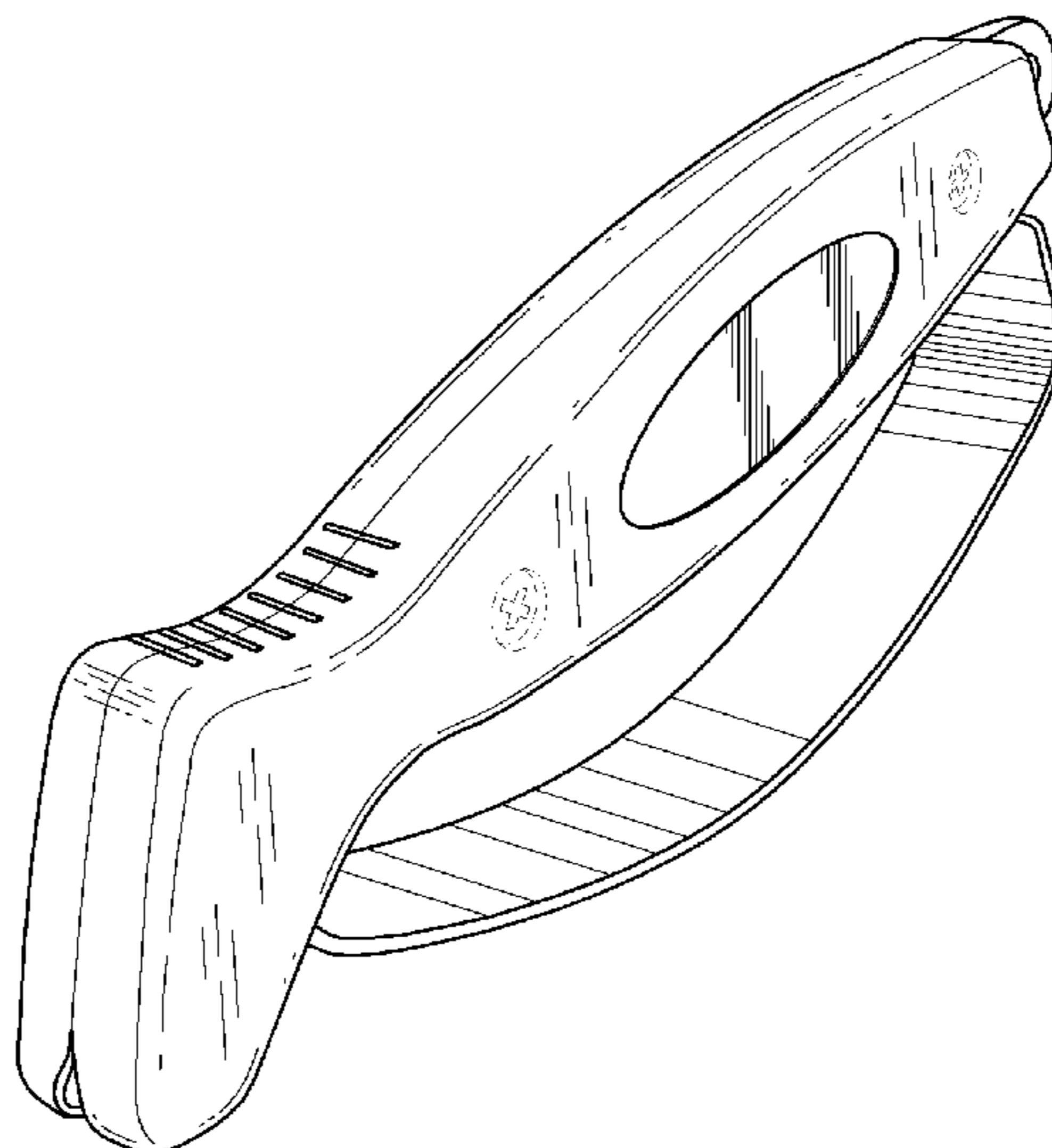

(57) **CLAIM**  
 The ornamental design for a blade sharpener, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a blade sharpener; FIG. 2 is a front view of the blade sharpener of FIG. 1; FIG. 3 is a rear view of the blade sharpener of FIG. 1; FIG. 4 is a right side view of the blade sharpener of FIG. 1; FIG. 5 is a left side view of the blade sharpener of FIG. 1; FIG. 6 is a top view of the blade sharpener of FIG. 1; and, FIG. 7 is a bottom view of the blade sharpener of FIG. 1. The broken lines in the drawings illustrate features of the blade sharpener that form no part of the claim.

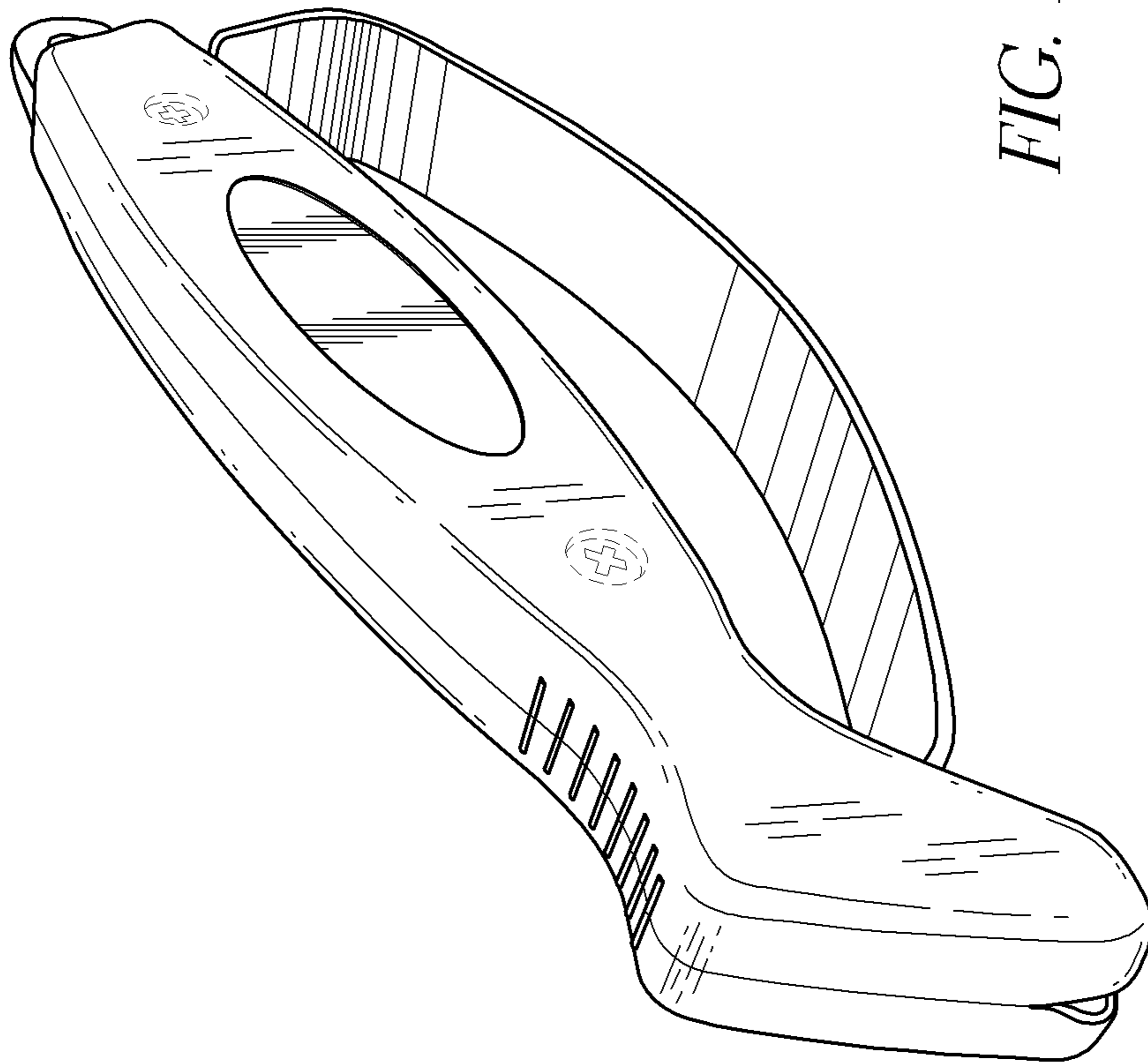

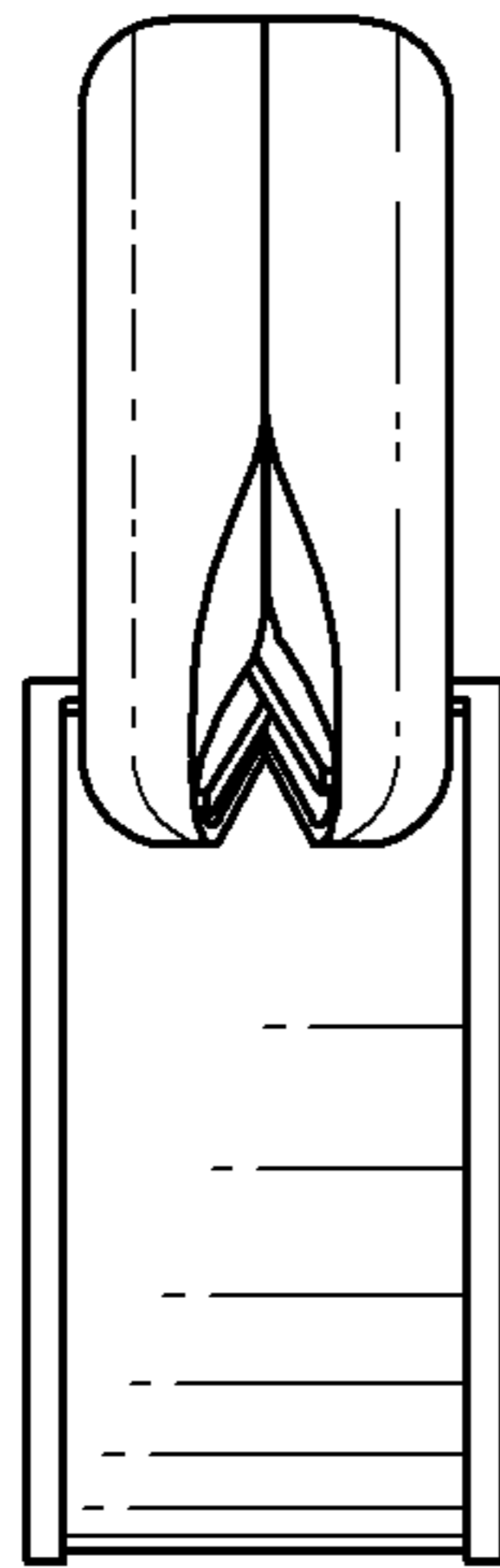

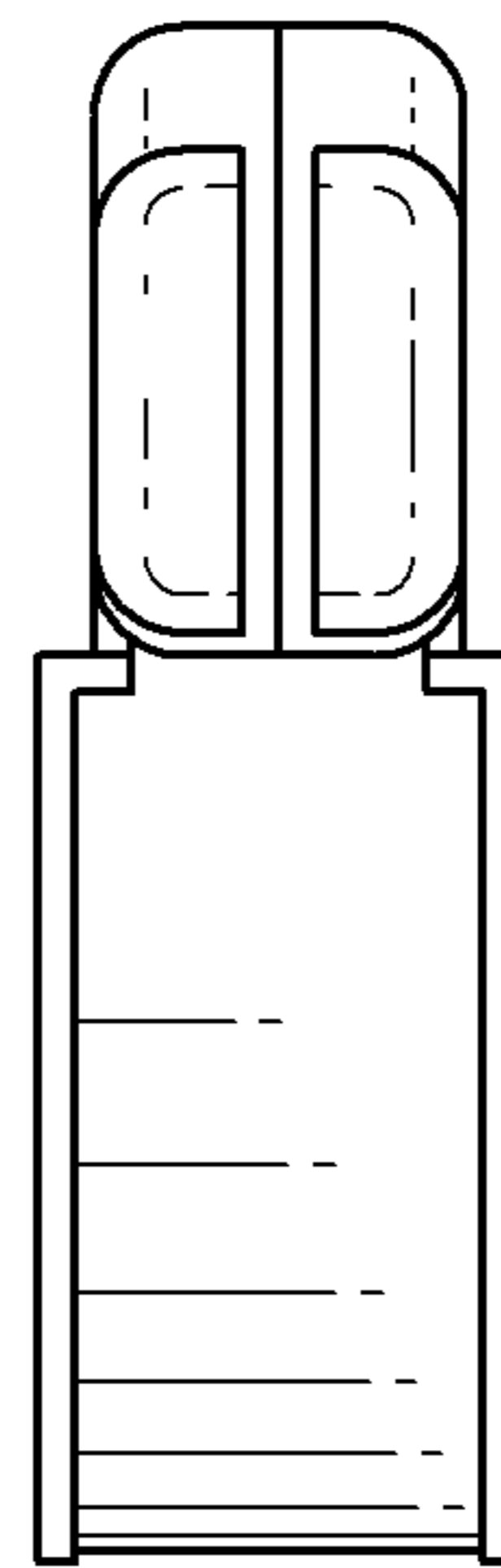

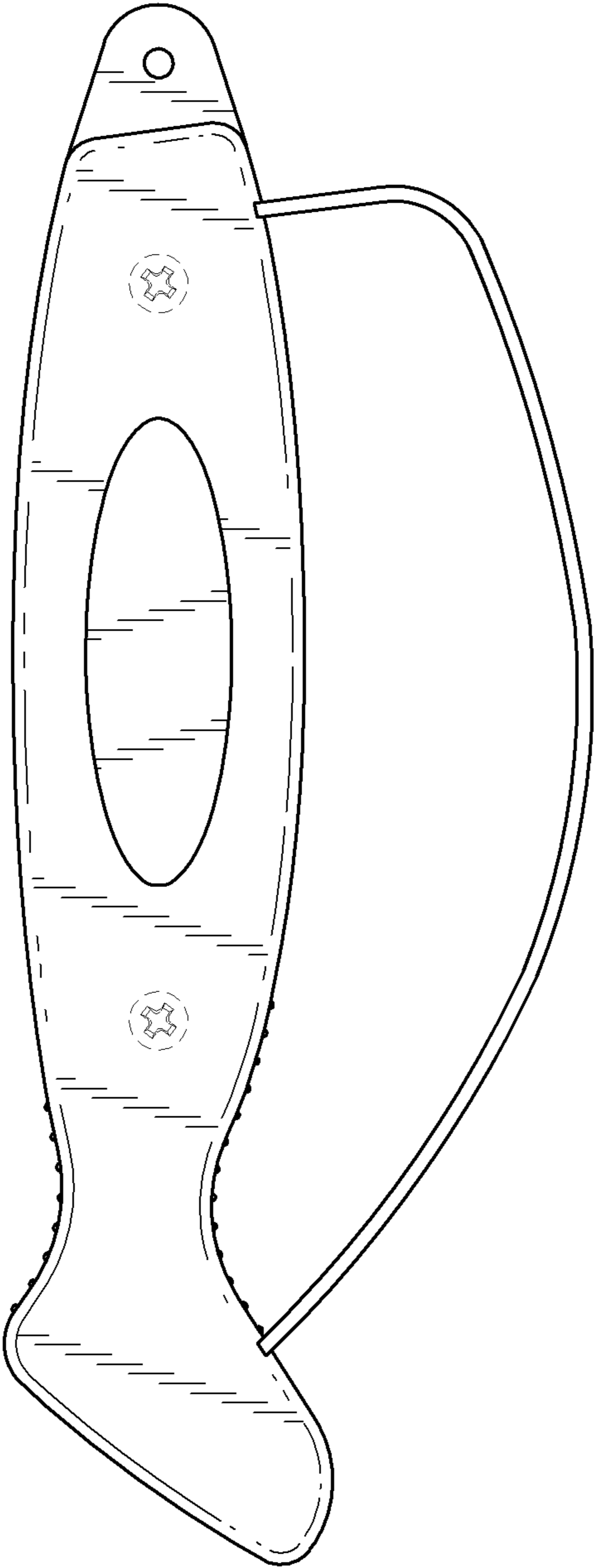

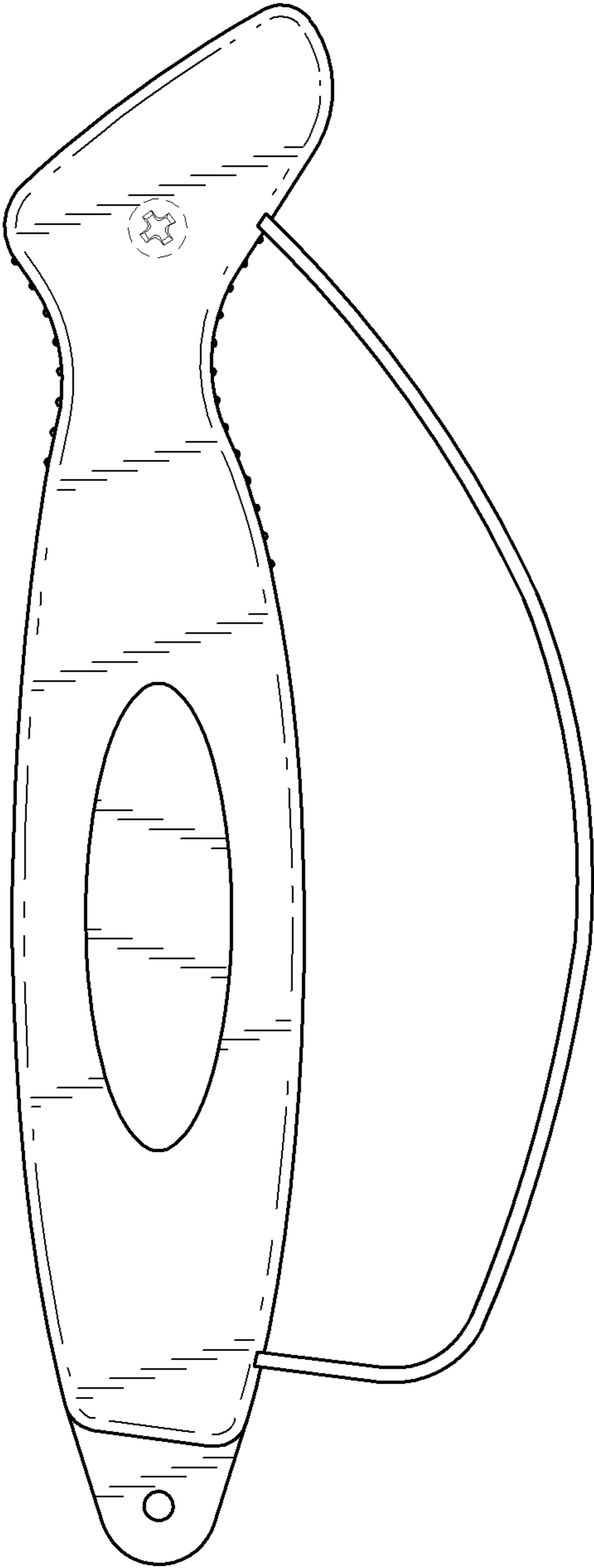

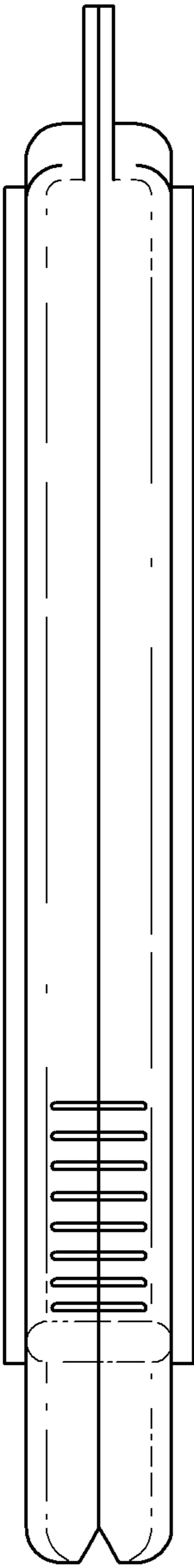

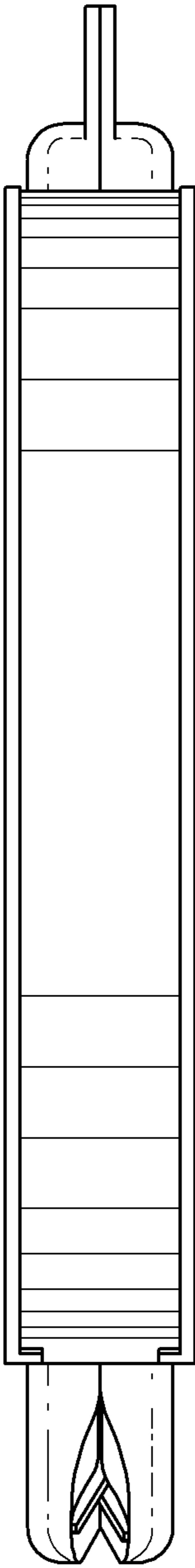
