DESCRIPTION

FIG. 1 is a perspective view of a battery, showing a new design;

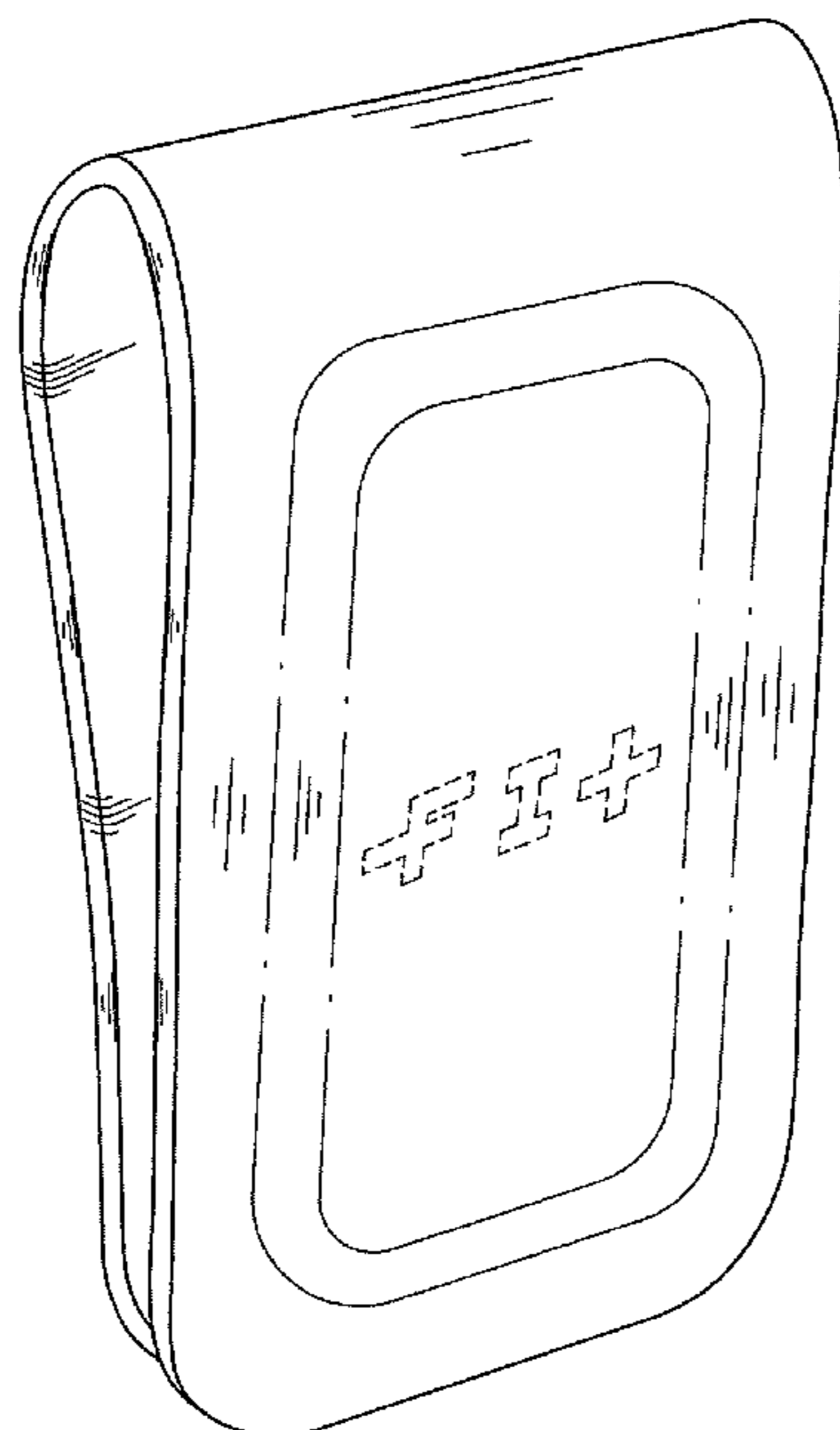

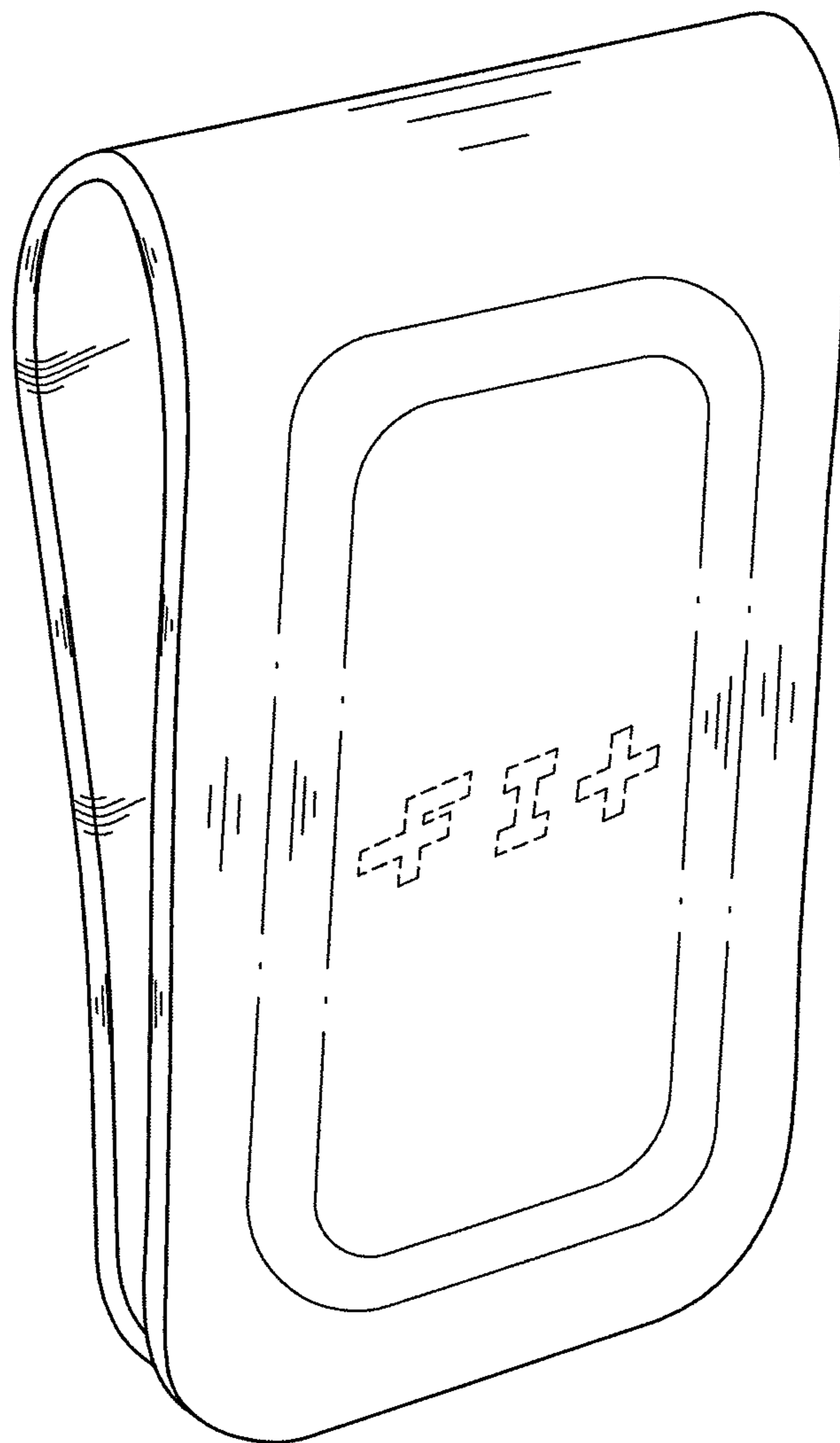

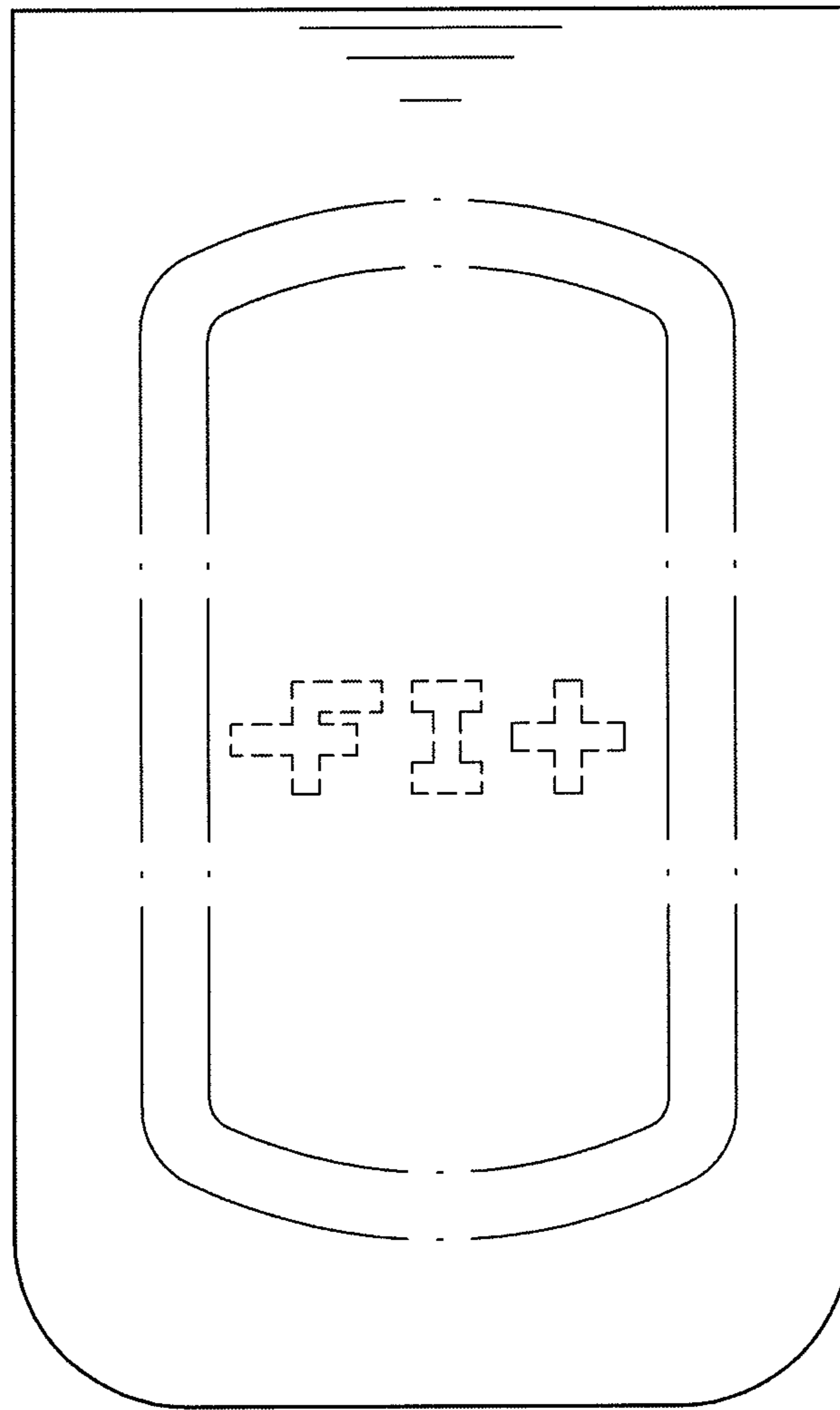

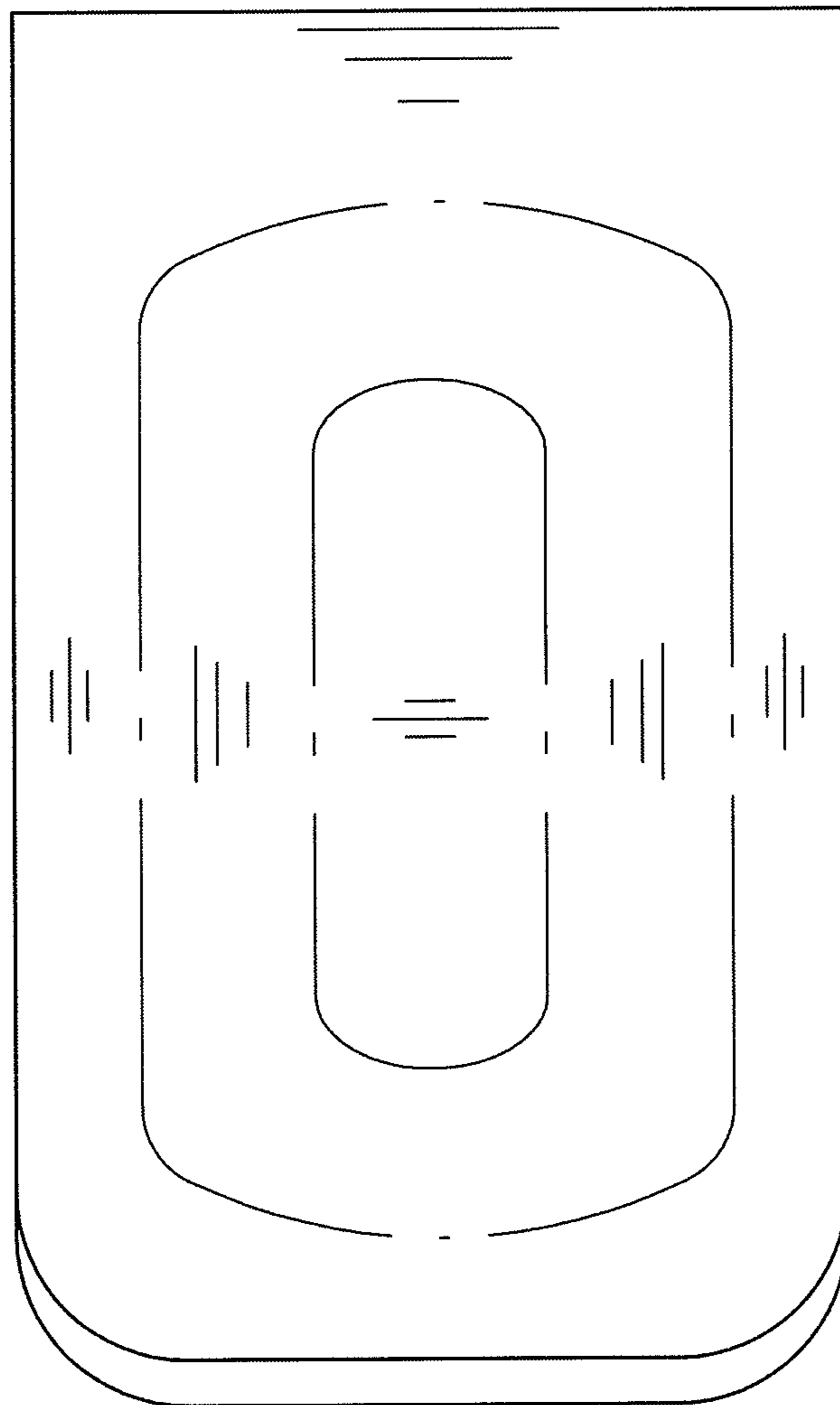

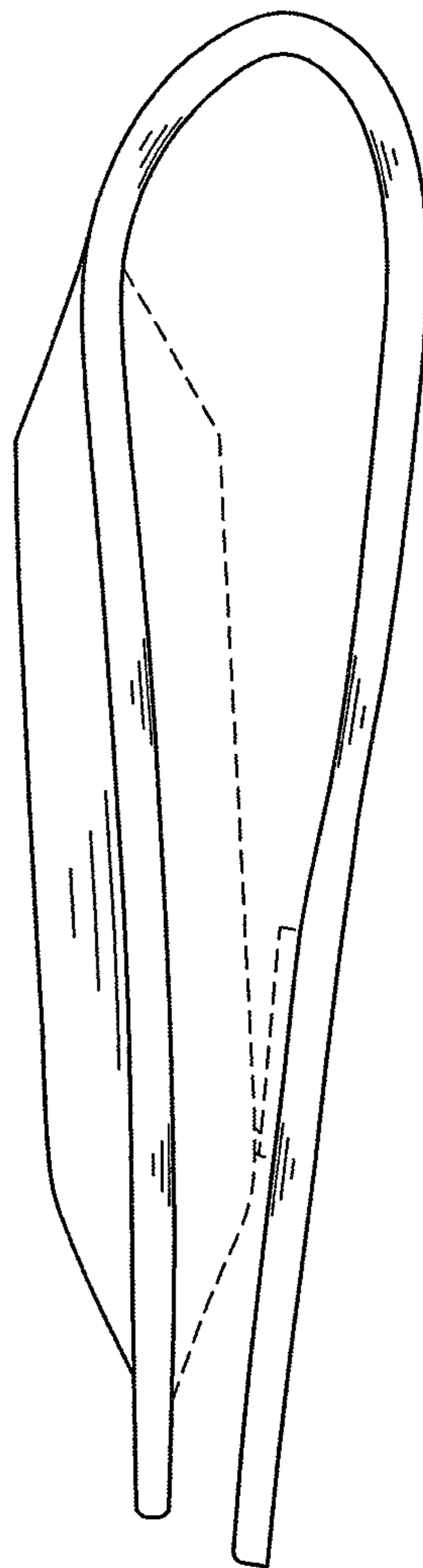

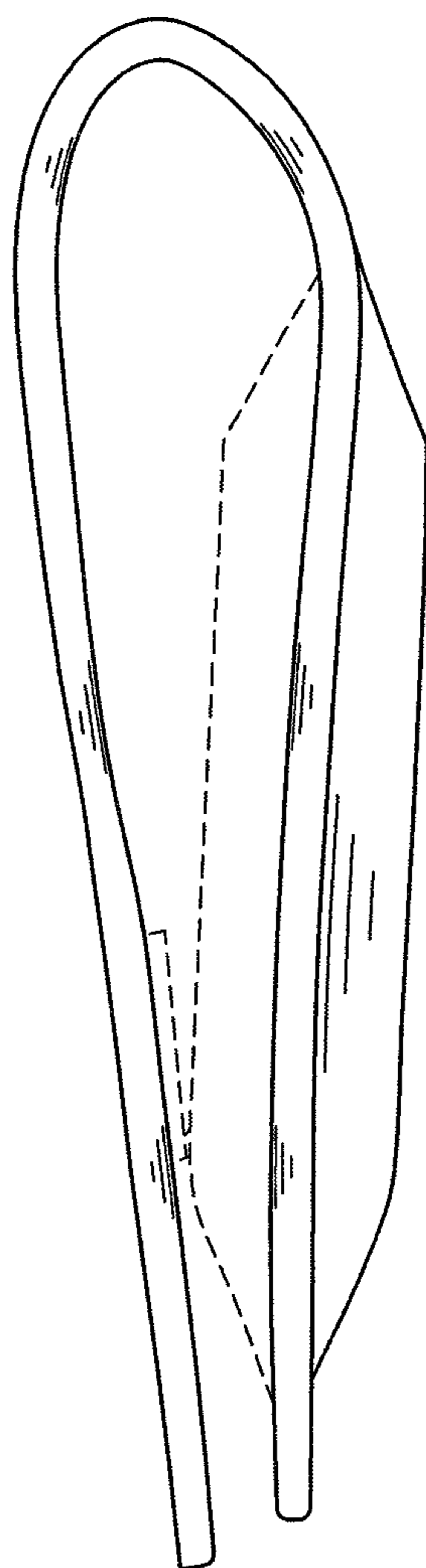

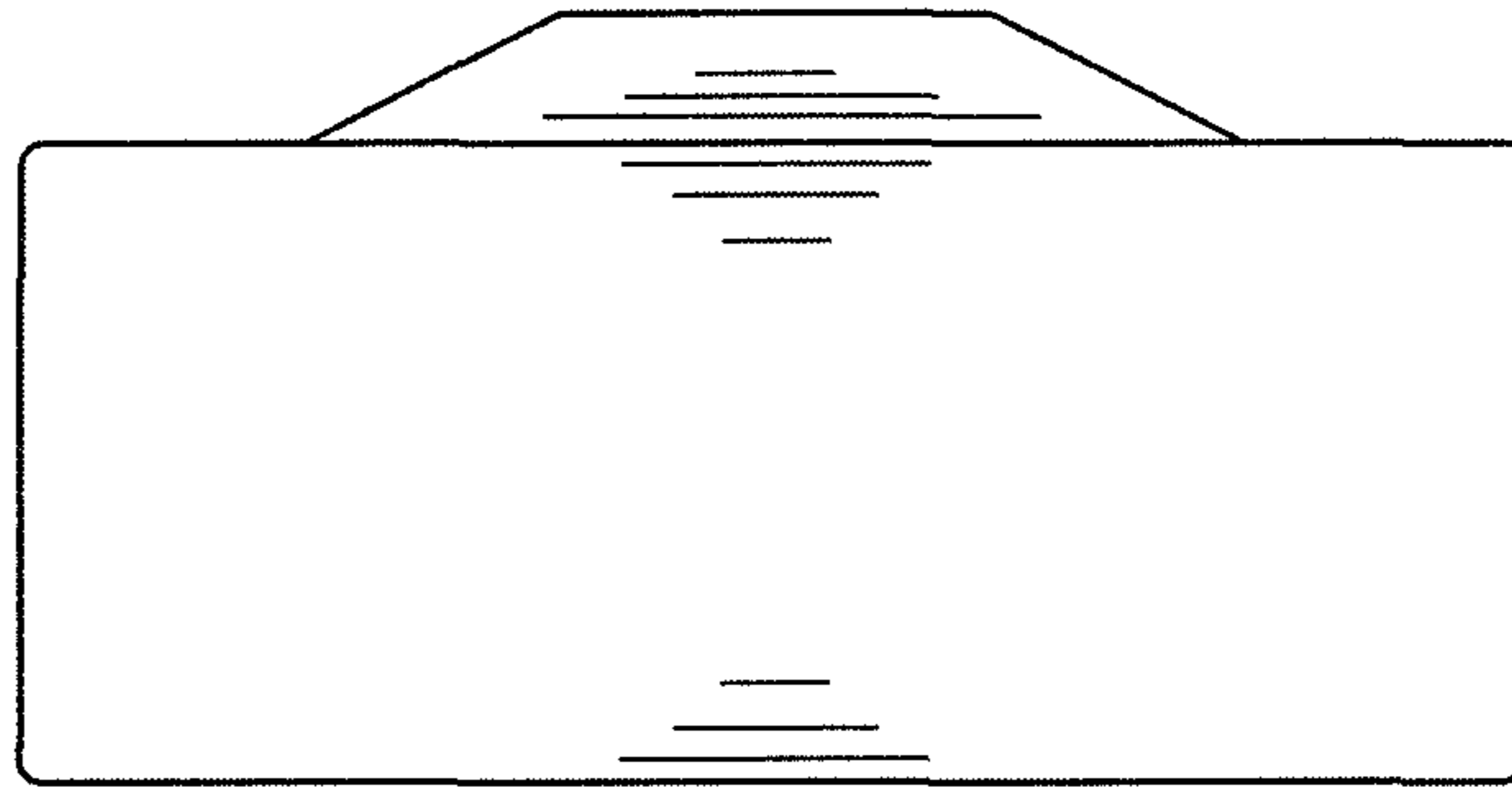
