The ornamental design for a combo side opening earphone case, as shown and described.

**DESCRIPTION**

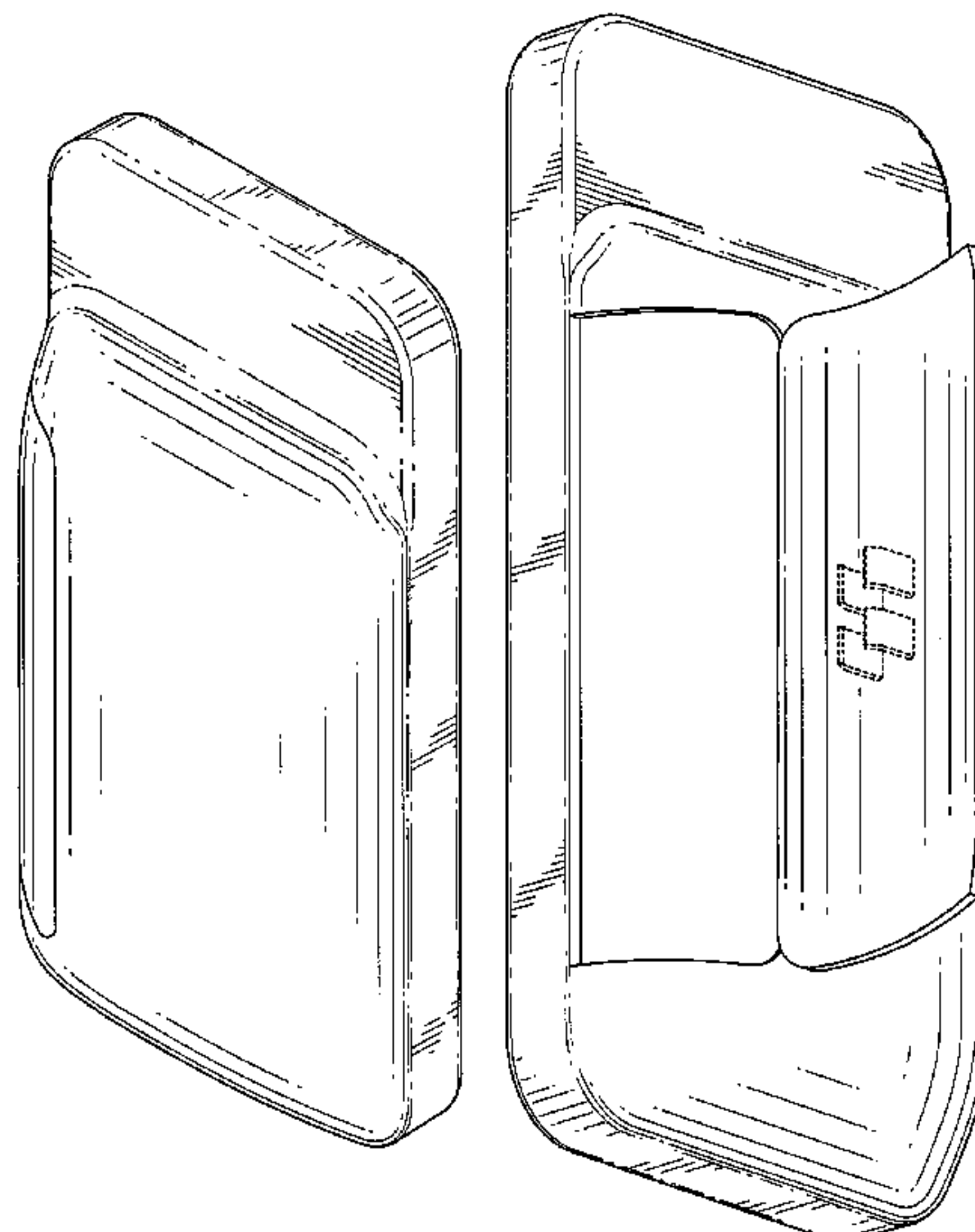
FIG. 1 is a first front side perspective view of a combo side opening earphone case, showing the new design with a door thereof in a closed position;  
 FIG. 2 is a second front side perspective view of the combo side opening earphone case, with the door in an open position;  
 FIG. 3 is a top plan view of the combo side opening earphone case;  
 FIG. 4 is a bottom plan view of the combo side opening earphone case;  
 FIG. 5 is a left side elevation of the combo side opening earphone case;  
 FIG. 6 is a right side elevation of the combo side opening earphone case;  
 FIG. 7 is a front elevation of the combo side opening earphone case;  
 FIG. 8 is a rear elevation of the combo side opening earphone case; and,  
 FIG. 9 is a rear perspective view of the combo side opening earphone case.  
 In FIGS. 2 and 8, broken lines indicate optional clips on an inner surface of the door of the combo side opening earphone case that form no part of the claimed design.

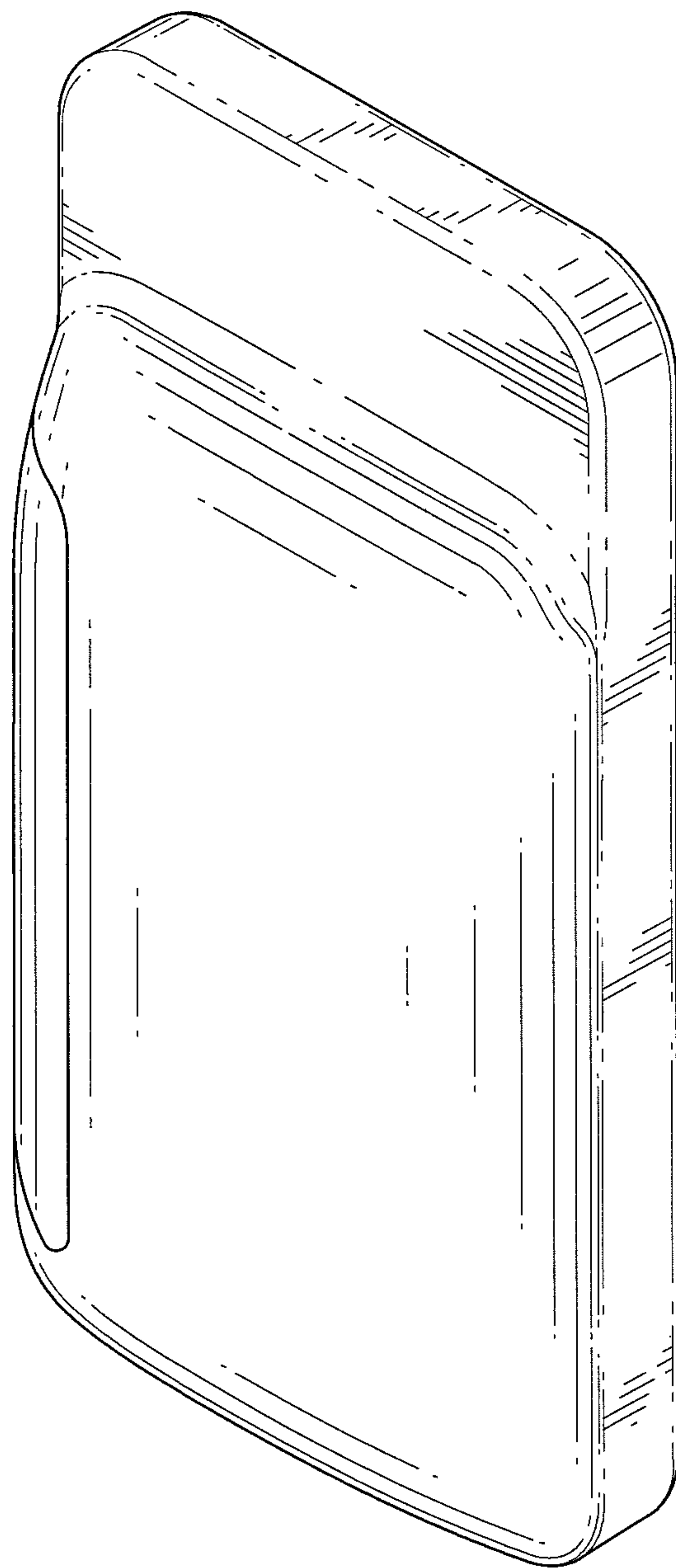

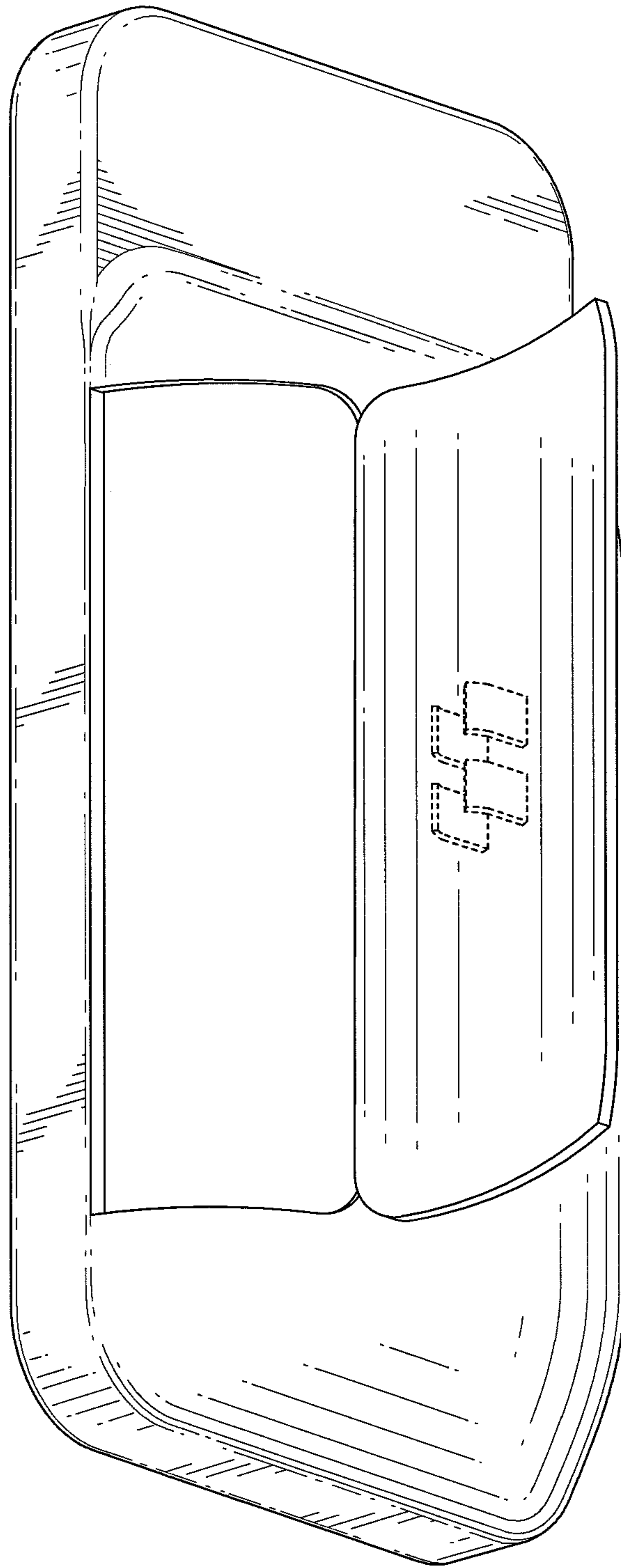
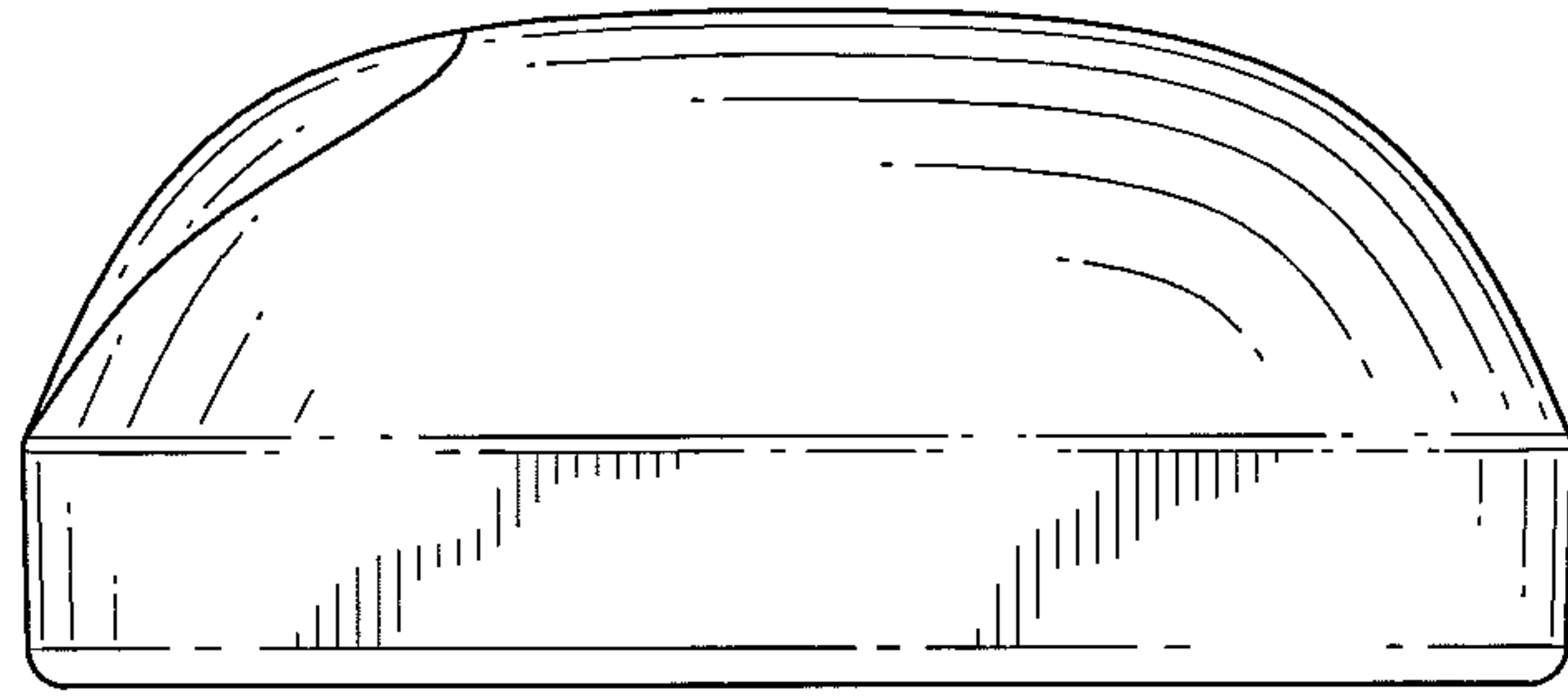

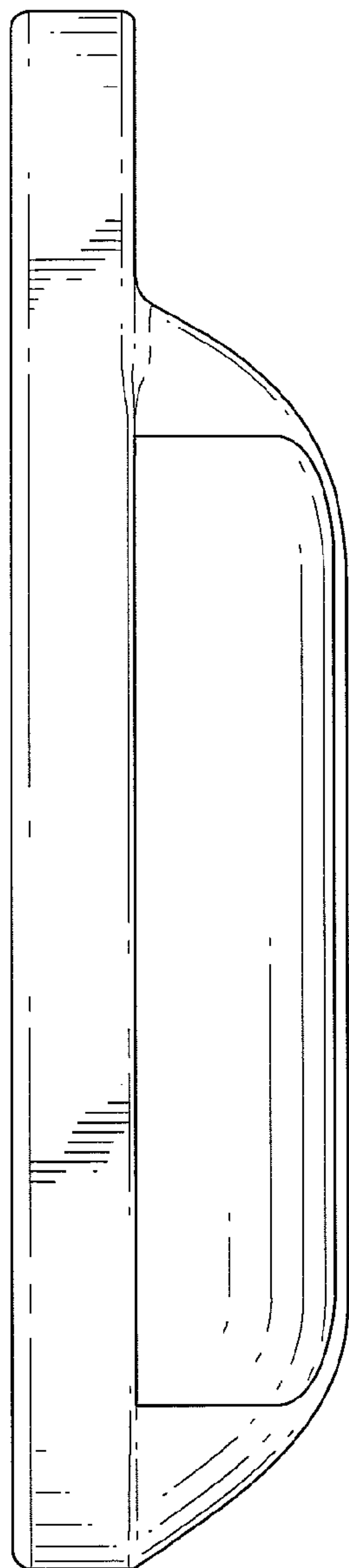

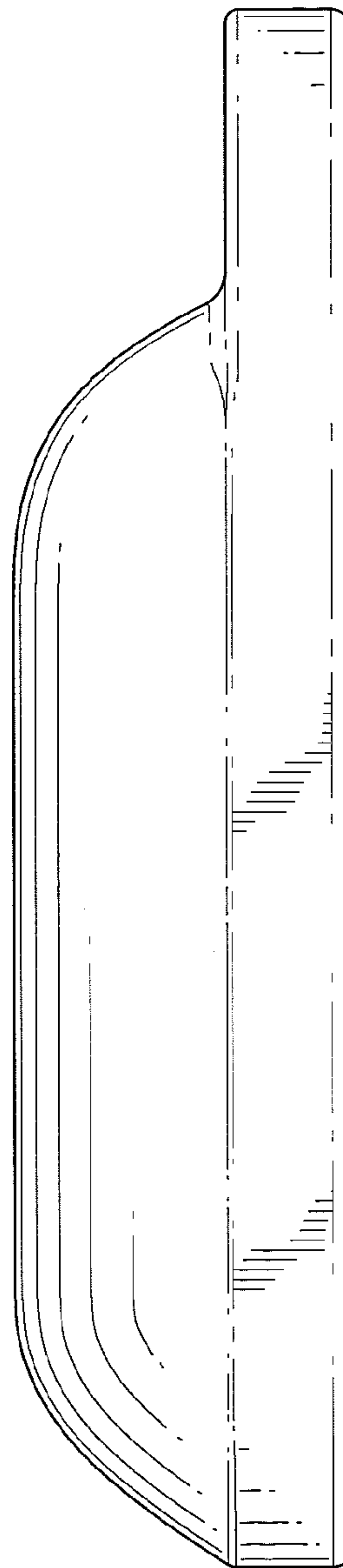

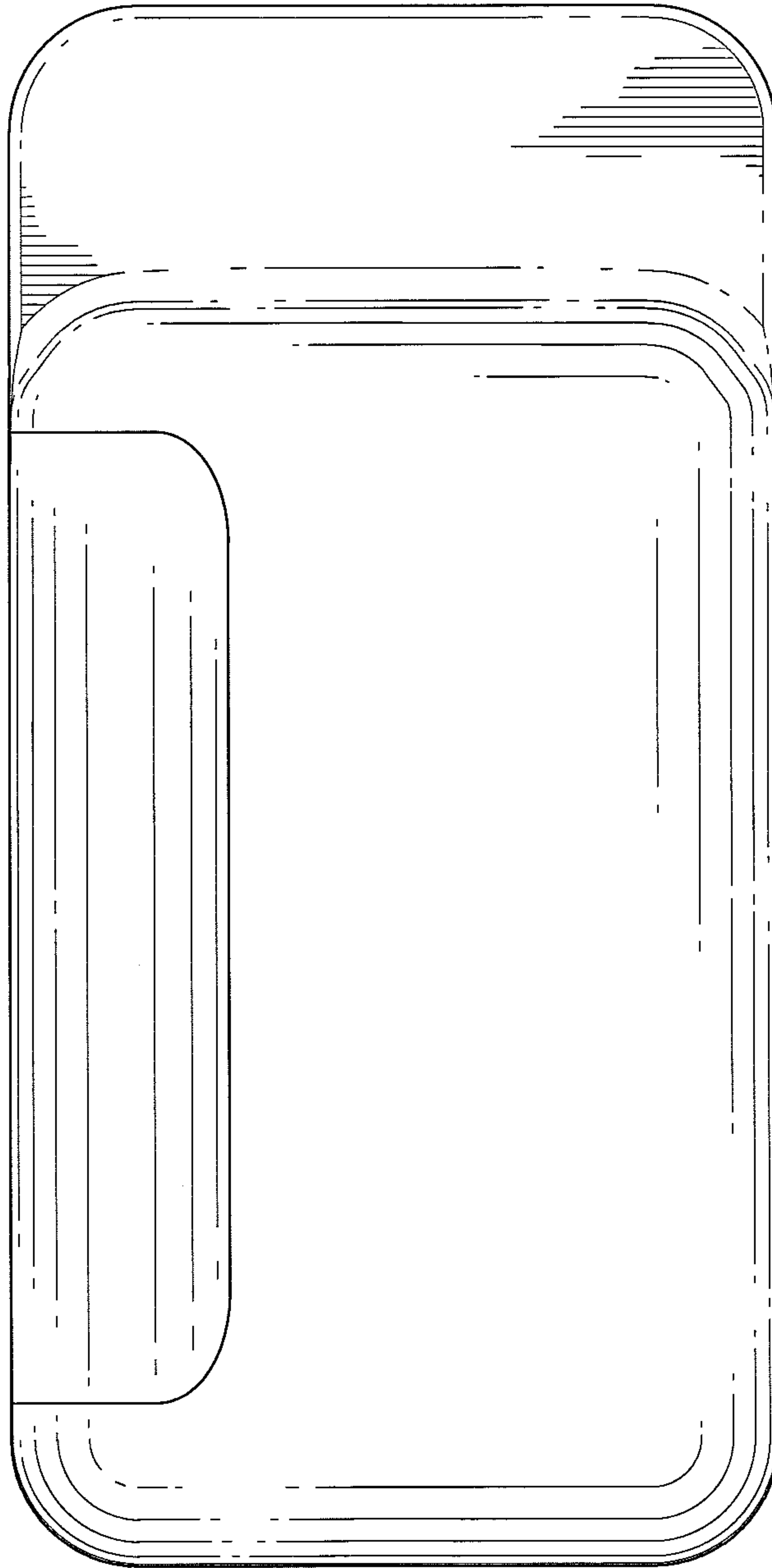

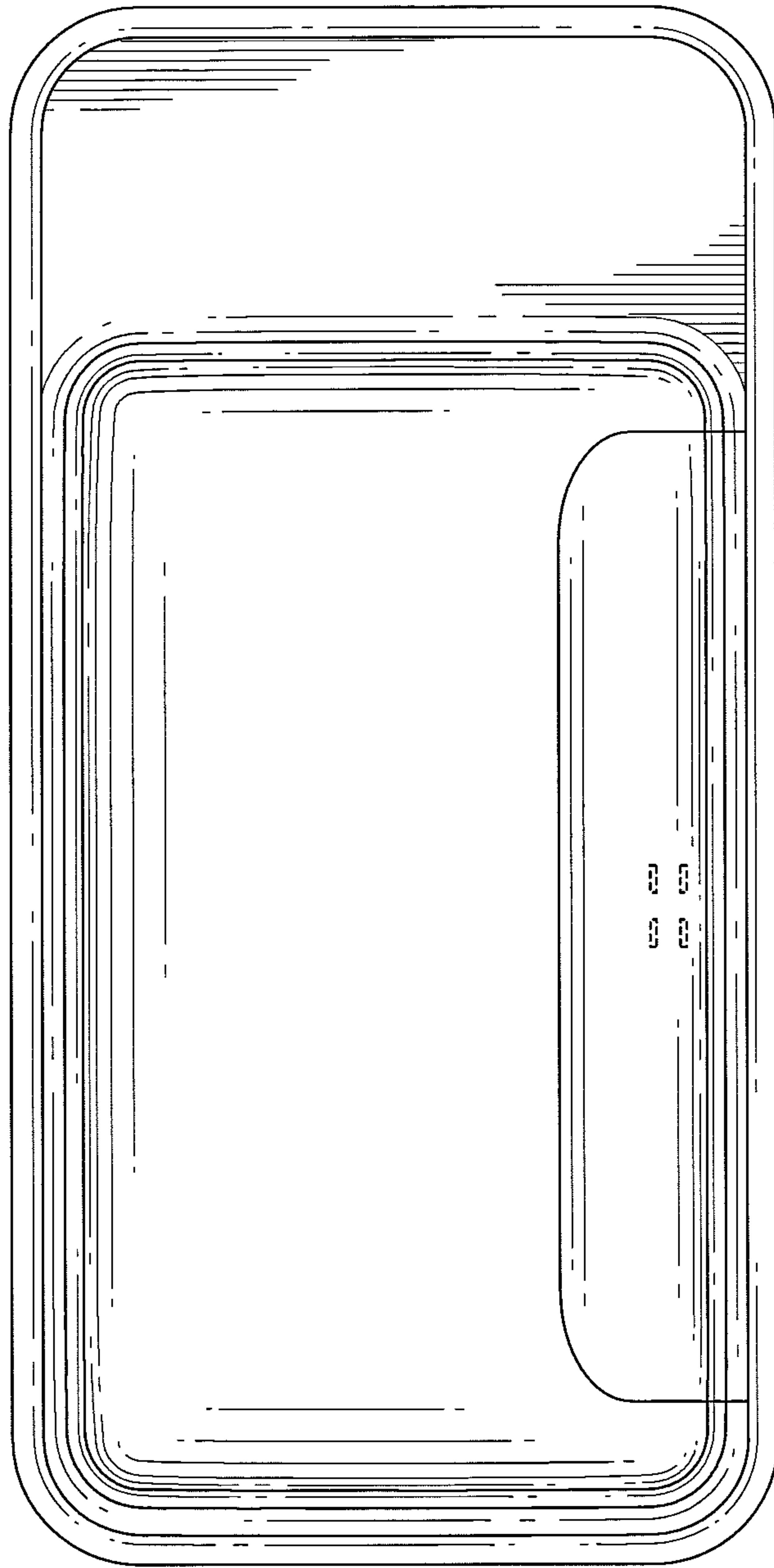

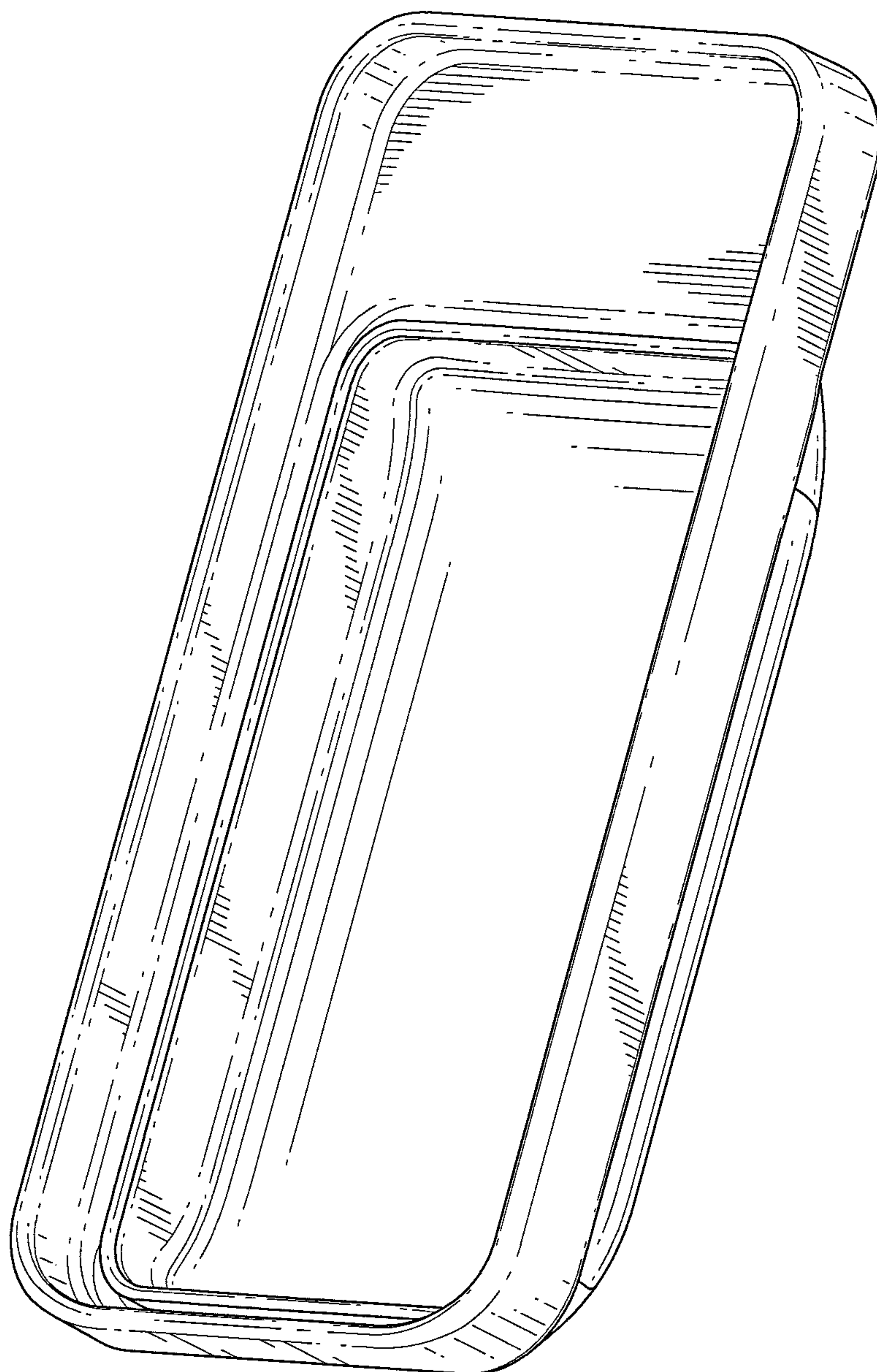
