(57) **CLAIM**

The ornamental design for an audio player, as shown and described.

DESCRIPTION

FIG. 1 is a front, left perspective view of a first embodiment of an audio player showing my new design;
 FIG. 2 is a front top, right perspective view thereof;
 FIG. 3 is a front elevational view thereof;
 FIG. 4 is a left side elevational view thereof;
 FIG. 5 is a top plan view thereof;
 FIG. 6 is a bottom plan view thereof;
 FIG. 7 is a front, left perspective view of a second embodiment of an audio player showing my new design;
 FIG. 8 is a front top, right perspective view thereof;
 FIG. 9 is a left side elevational view thereof;
 FIG. 10 is a front elevational view thereof;
 FIG. 11 is a top plan view thereof; and,
 FIG. 12 is a bottom plan view thereof.
 The dot-dash broken lines immediately adjacent the shaded areas represent the bounds of the claimed design while all other broken lines are included for the purpose of illustrating portions of the audio player; the broken lines form no part of the claimed design.

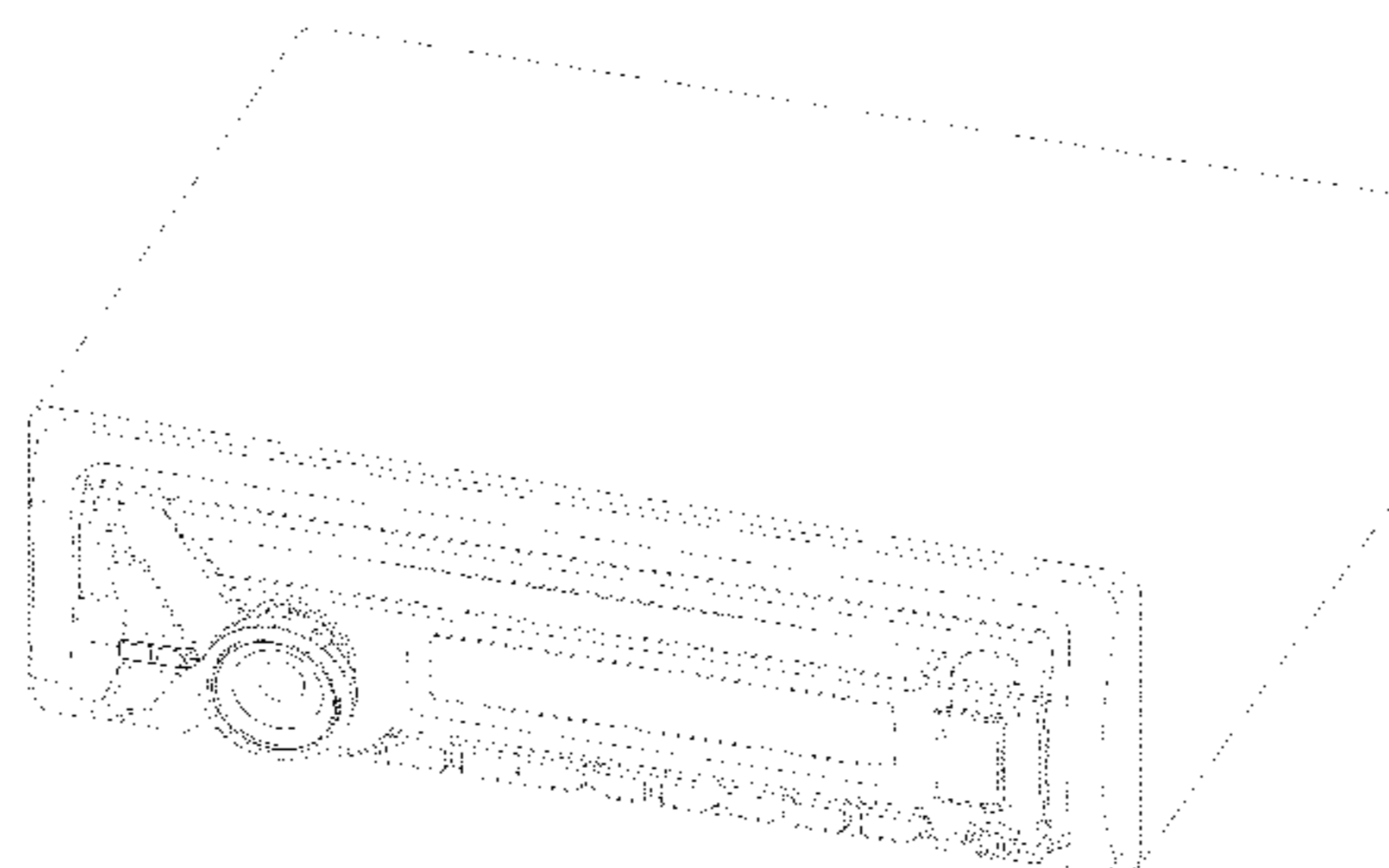
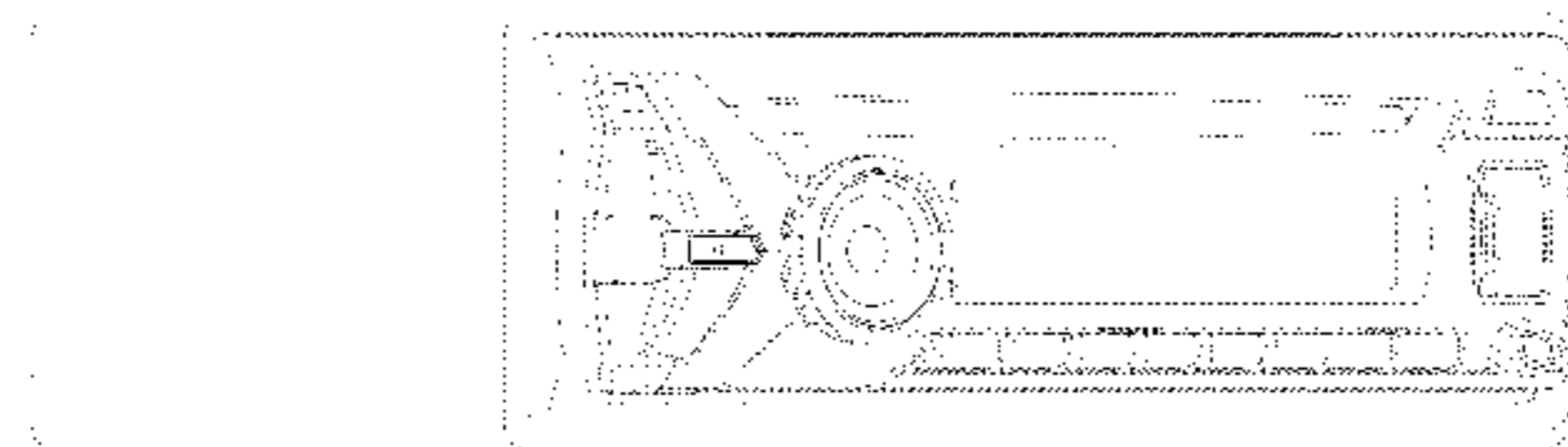

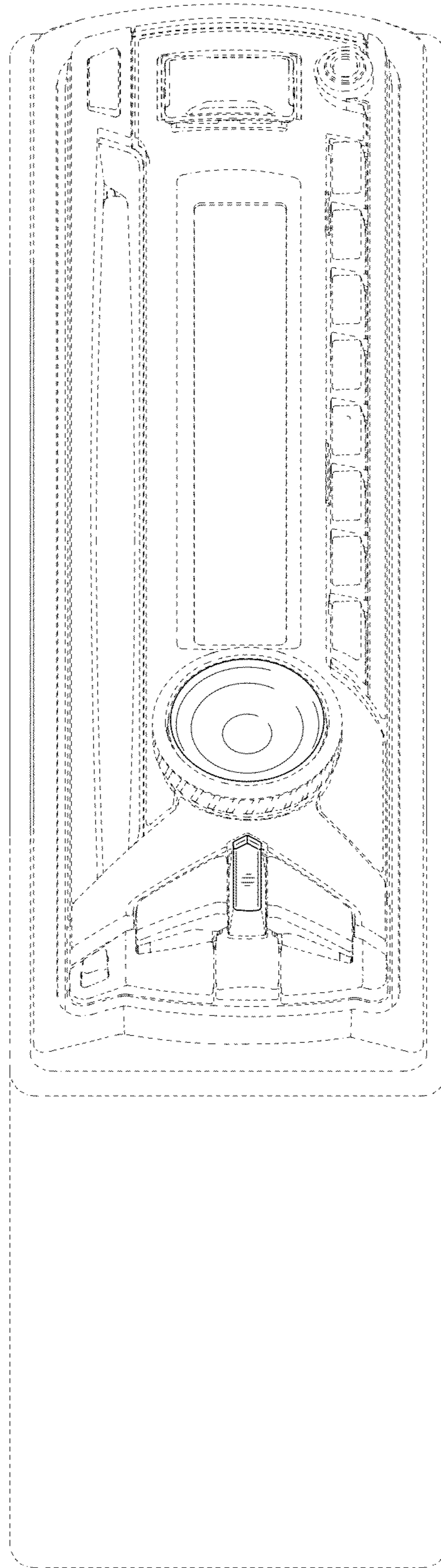

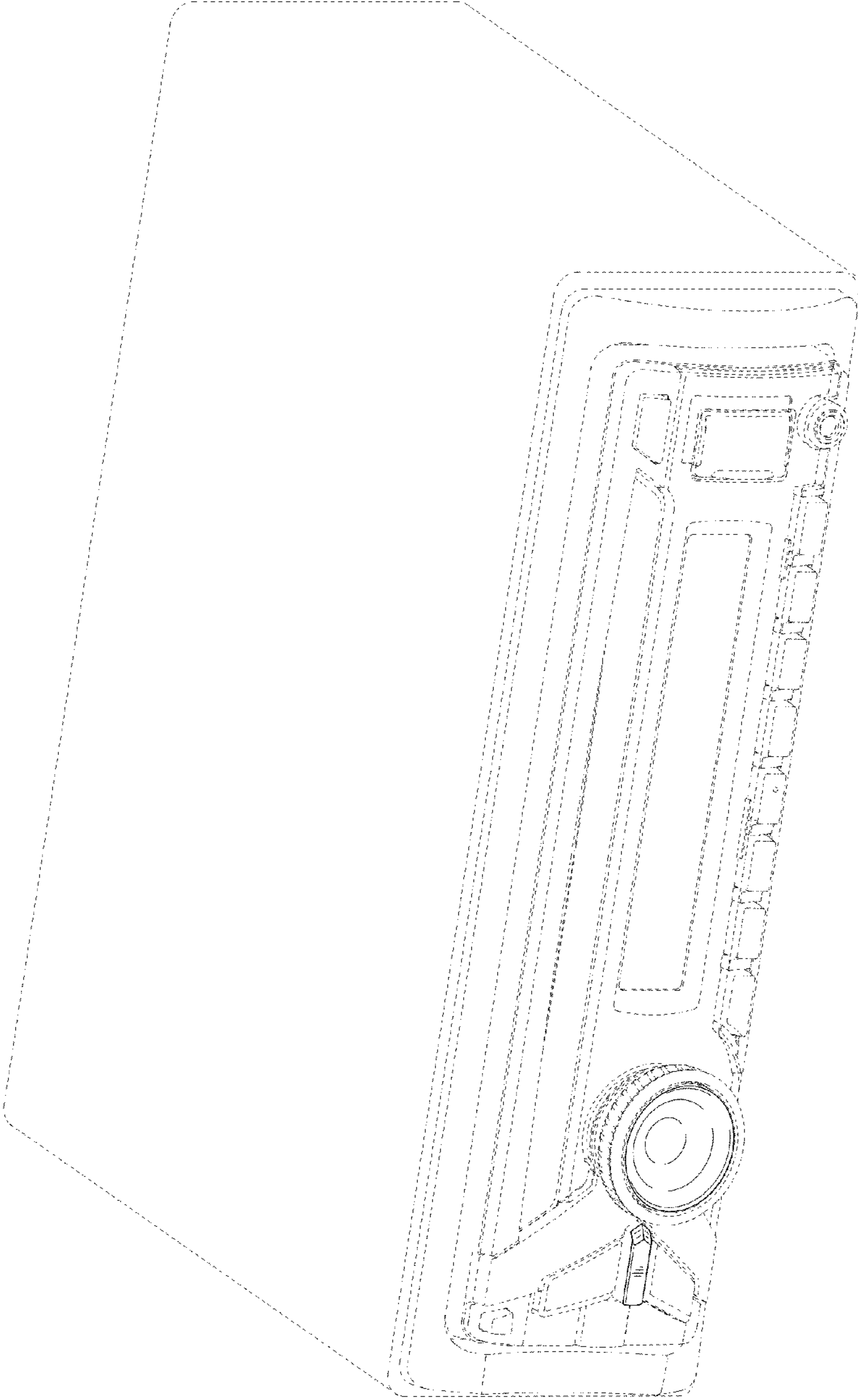

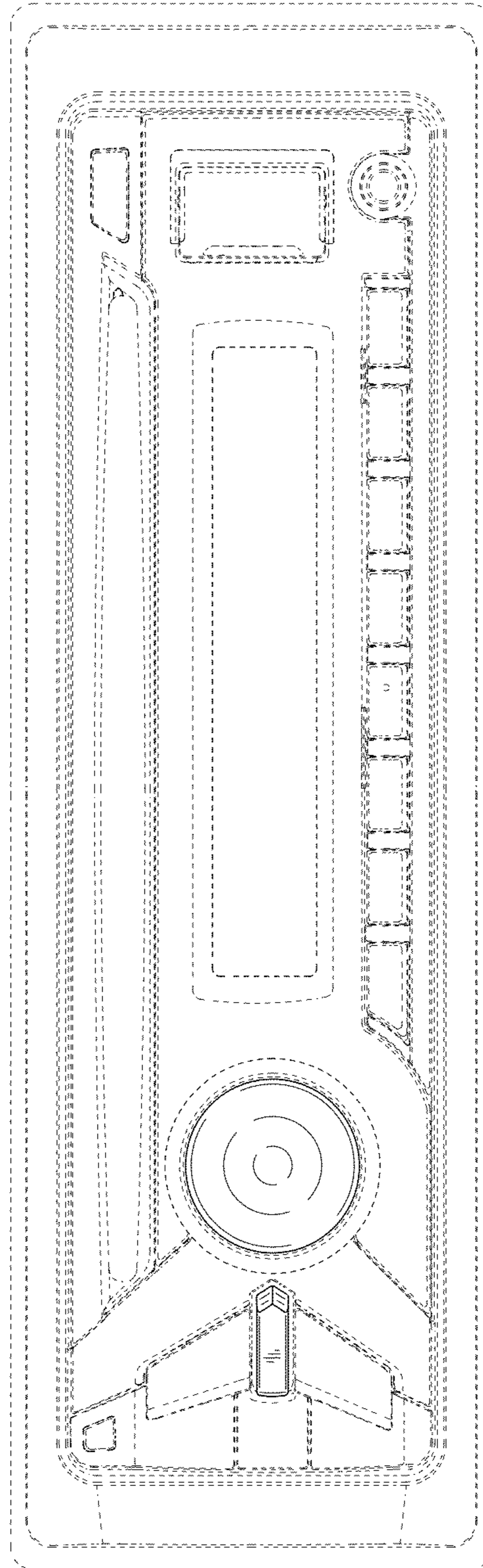

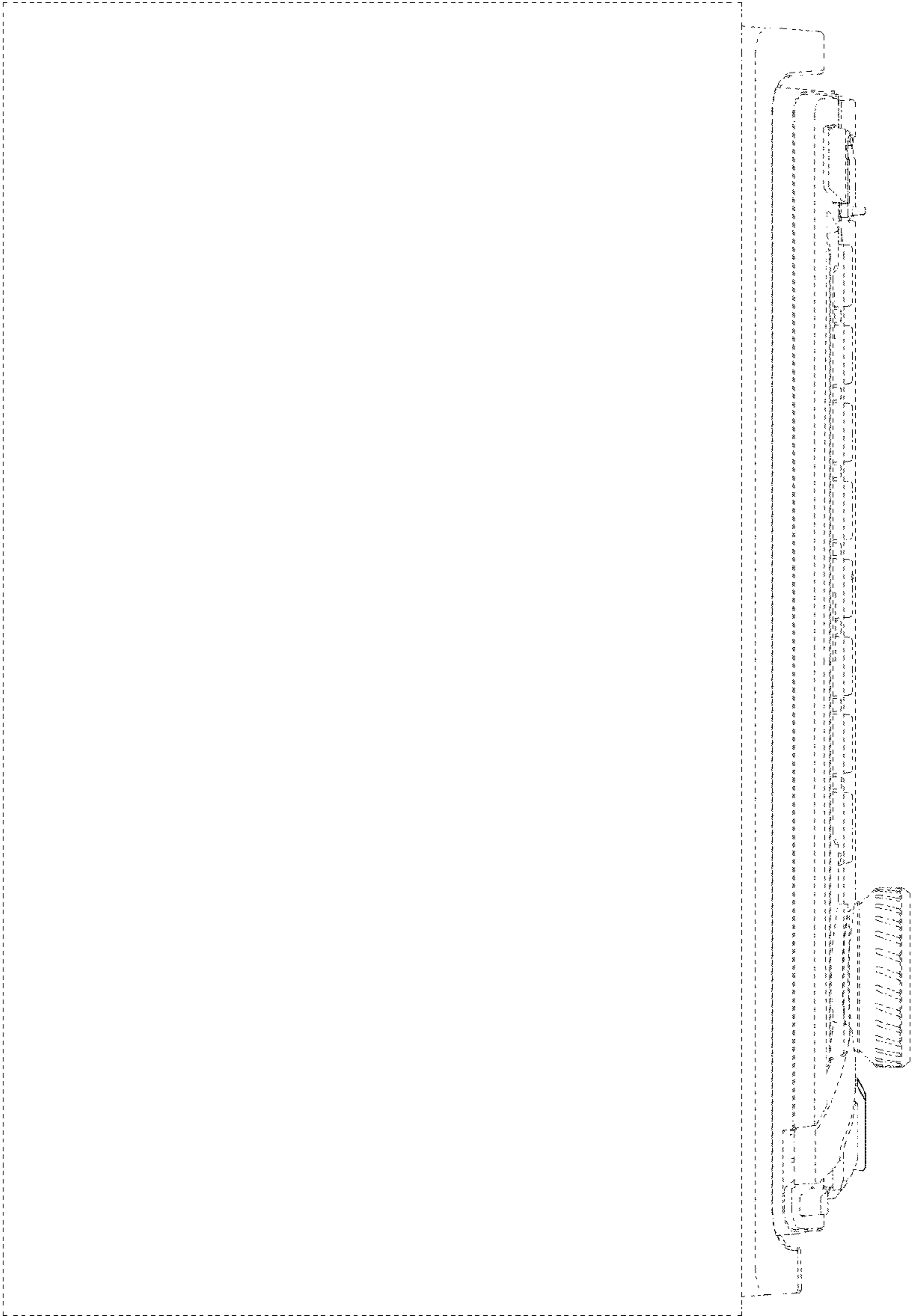

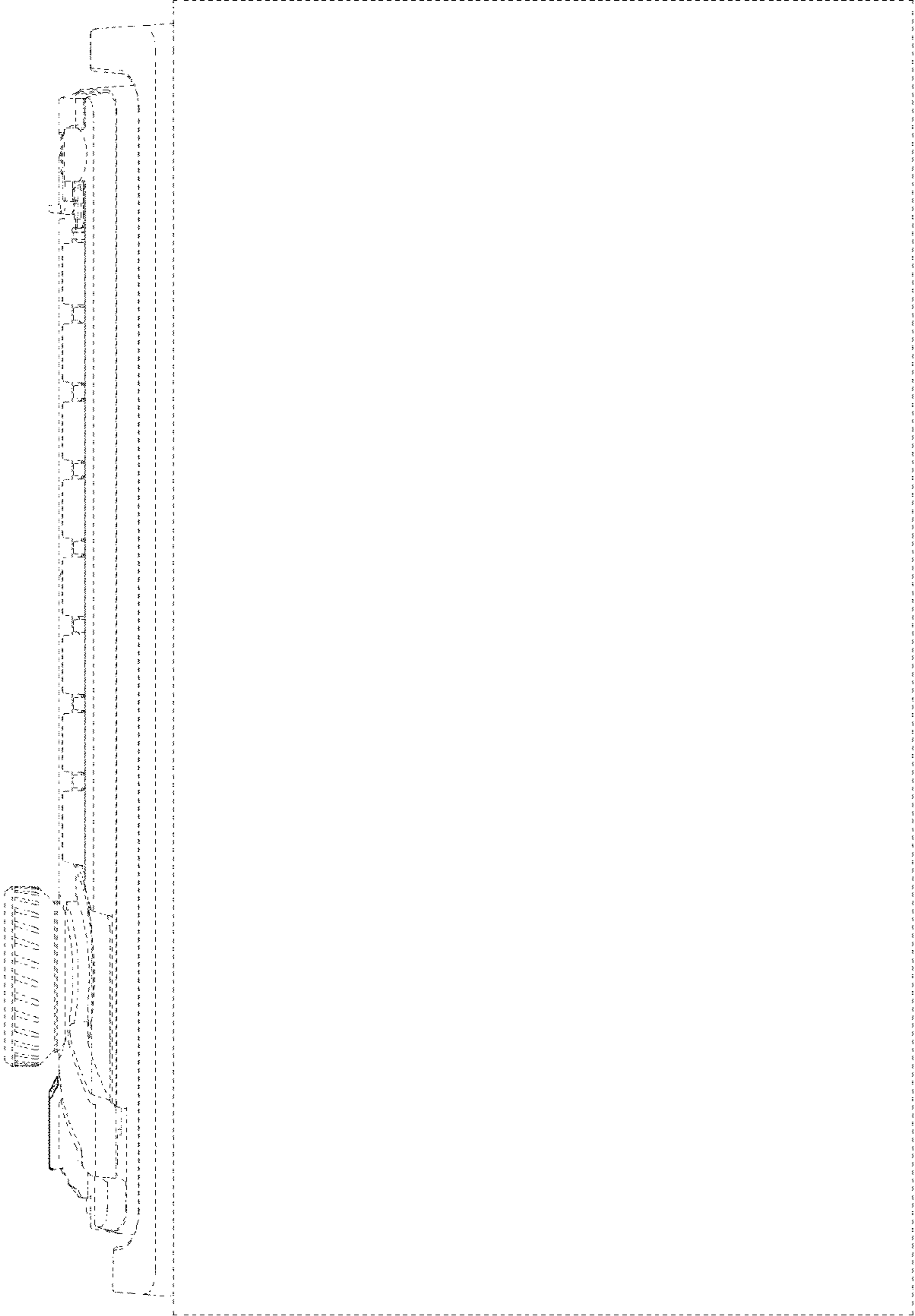

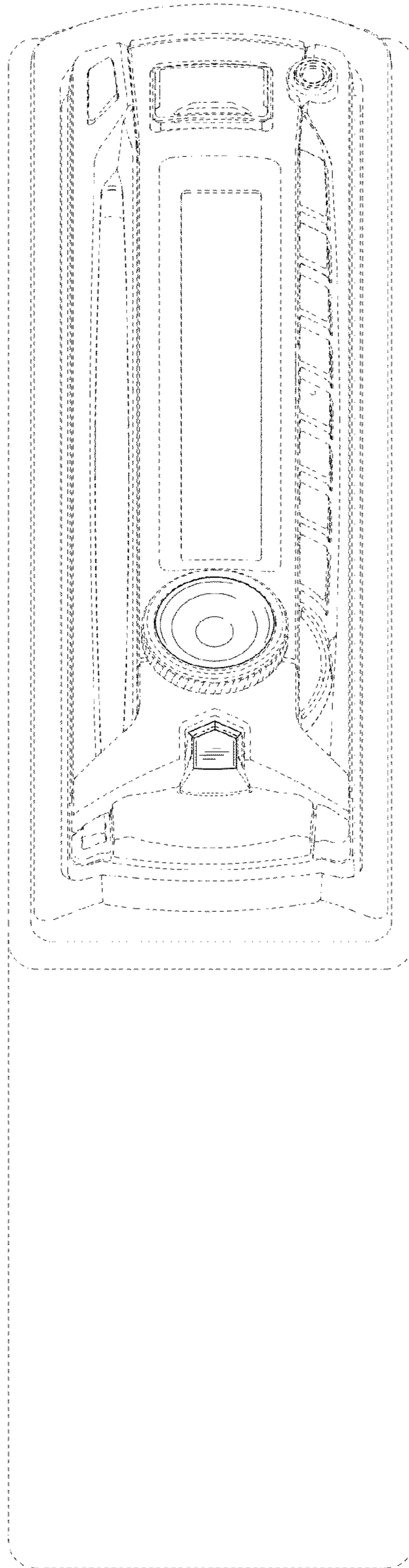

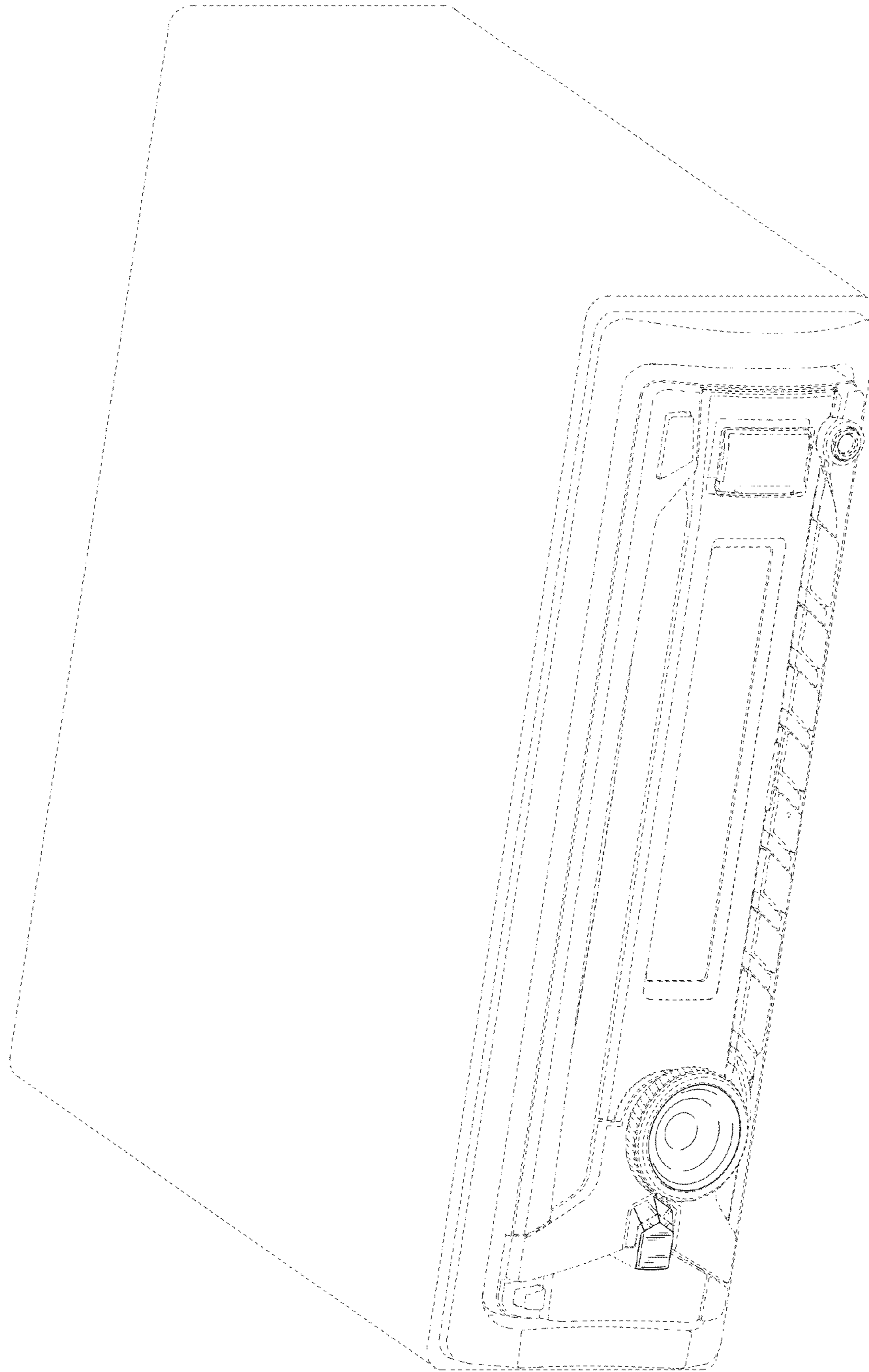

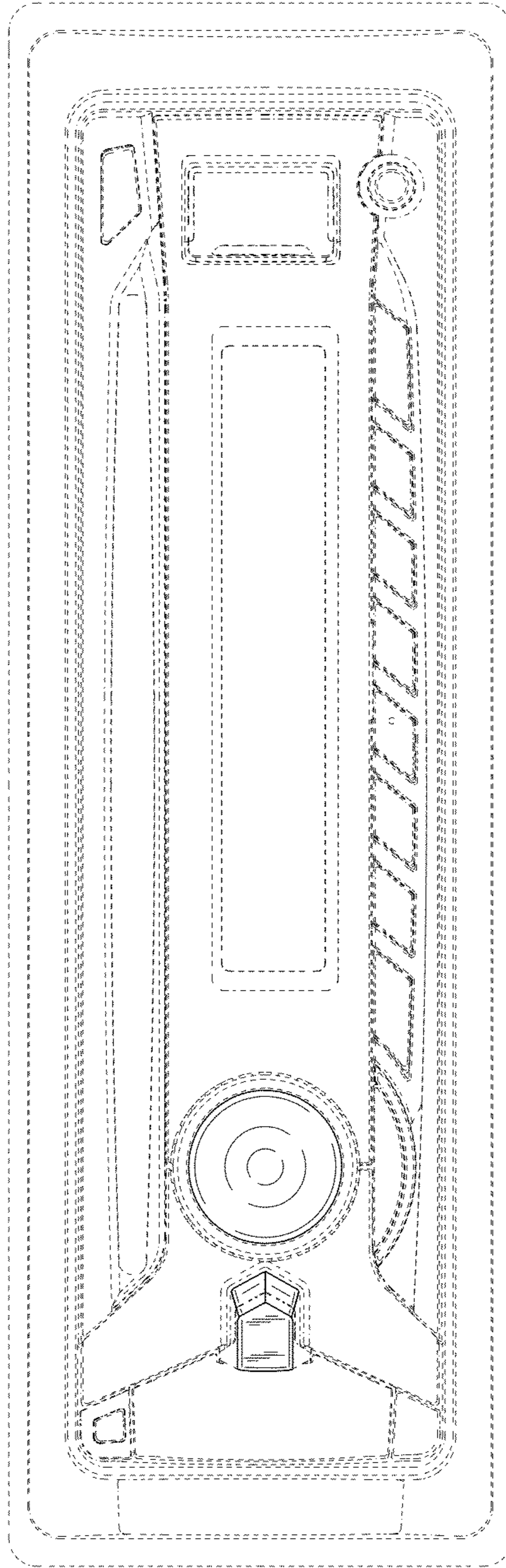

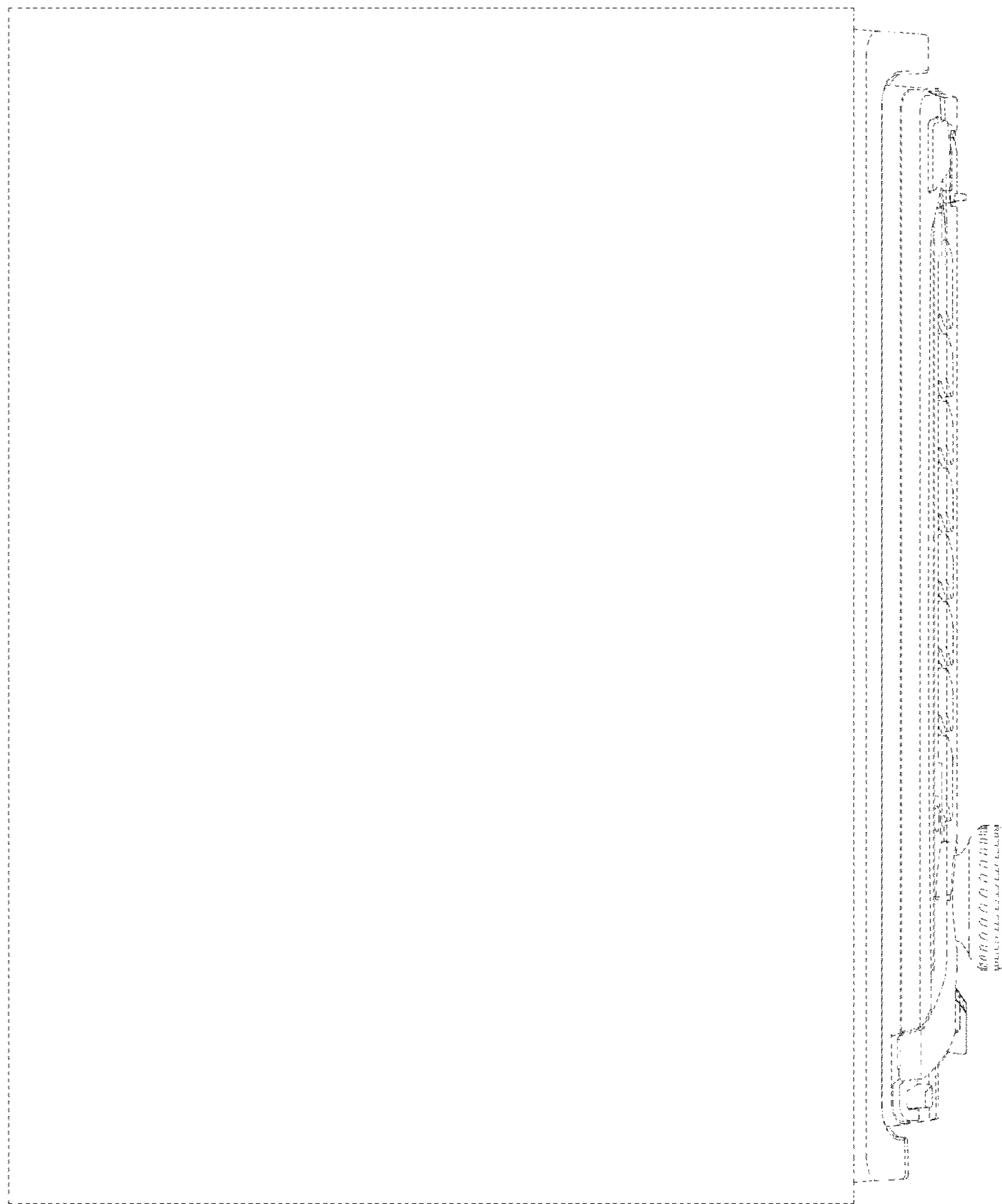
