(57) **CLAIM**

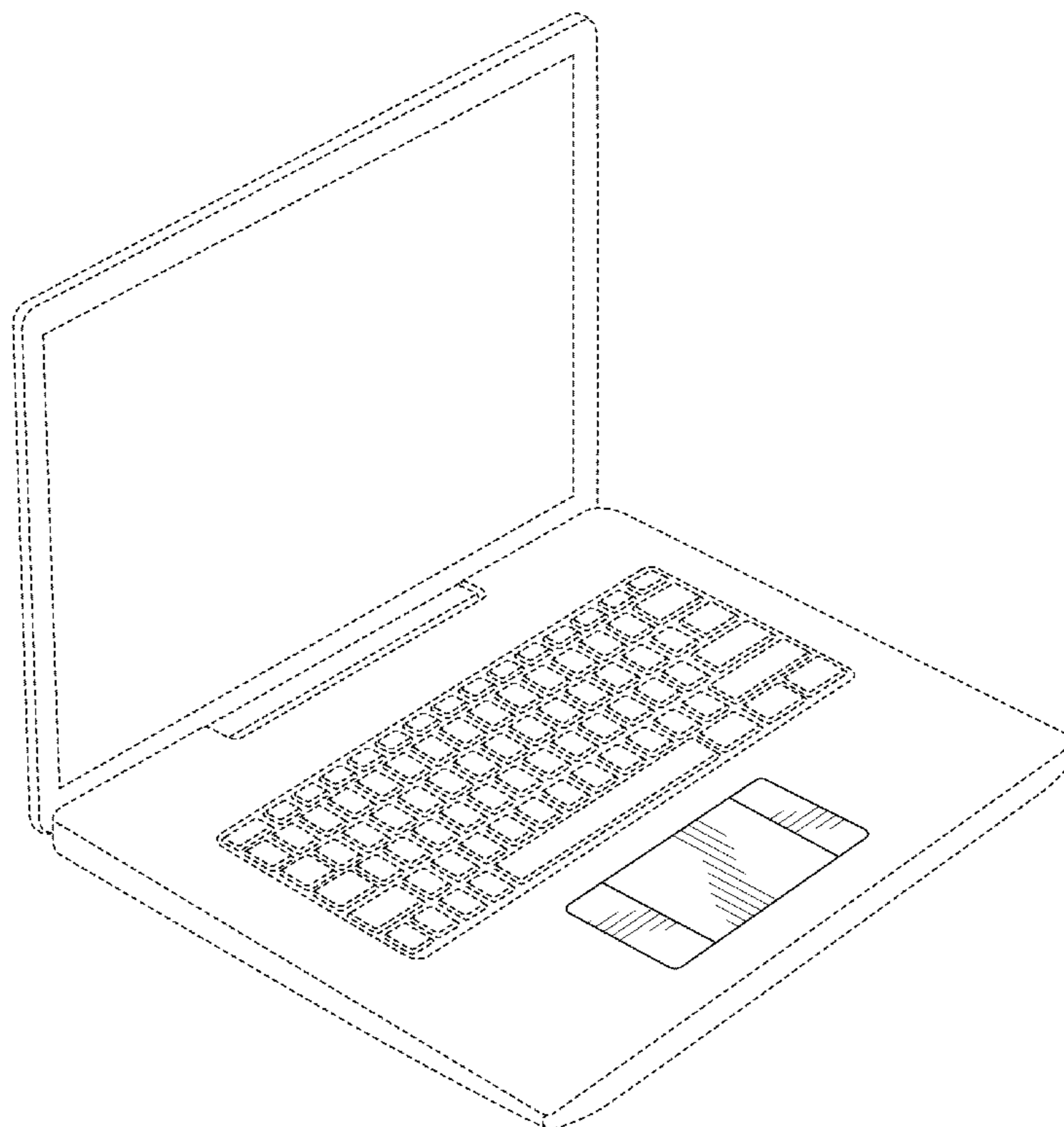
We claim the ornamental design for a computer touchpad, as shown and described.

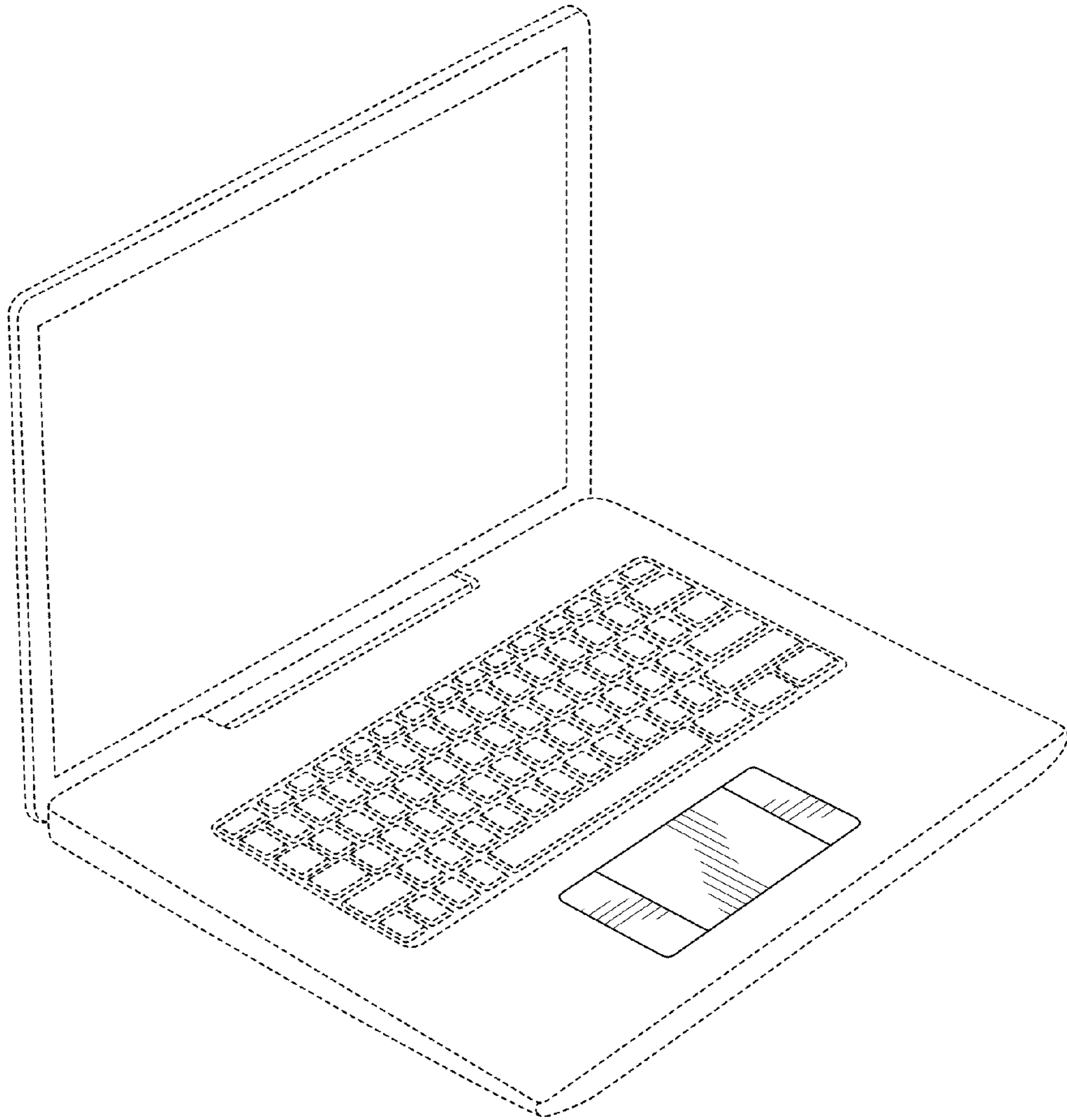

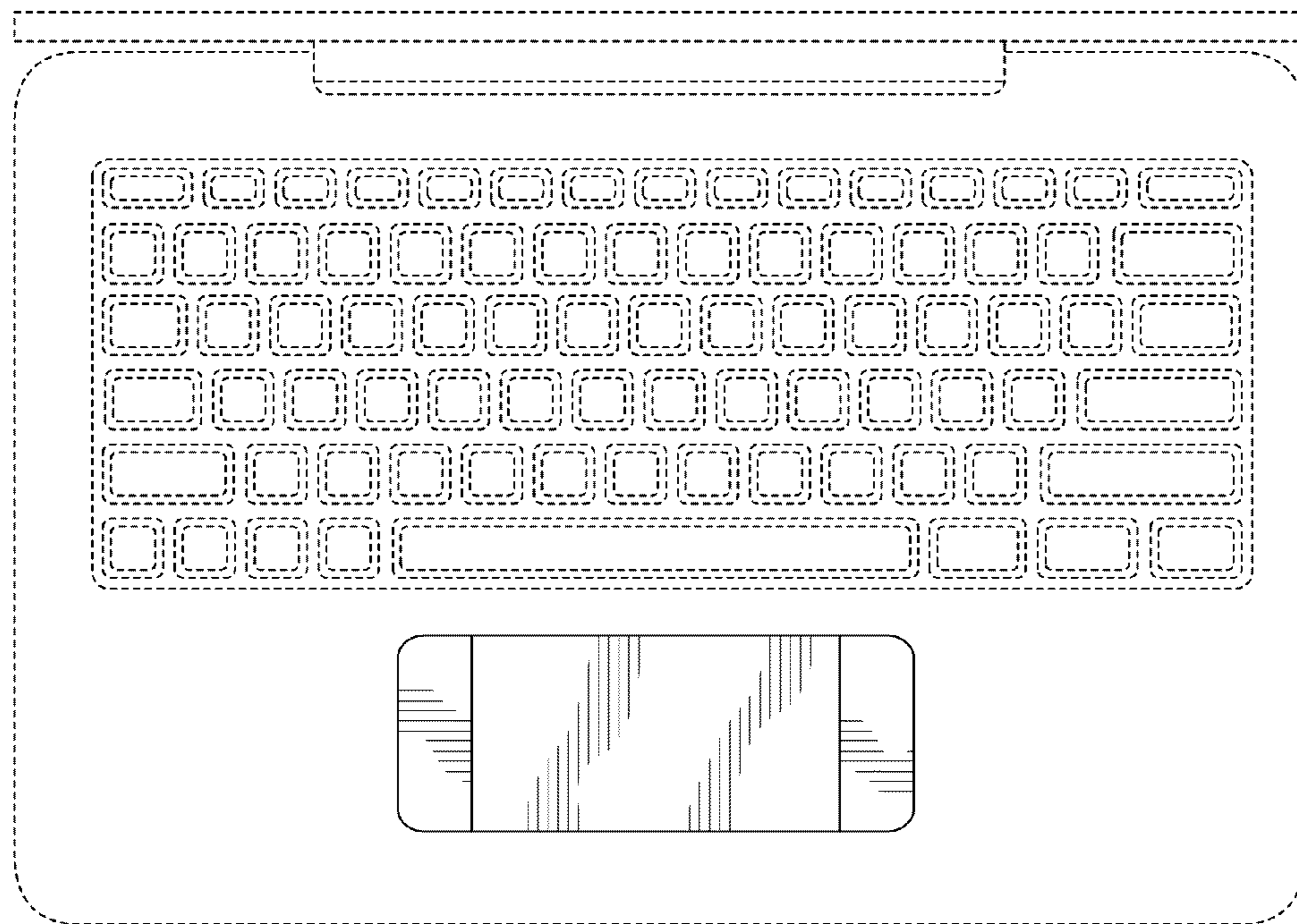

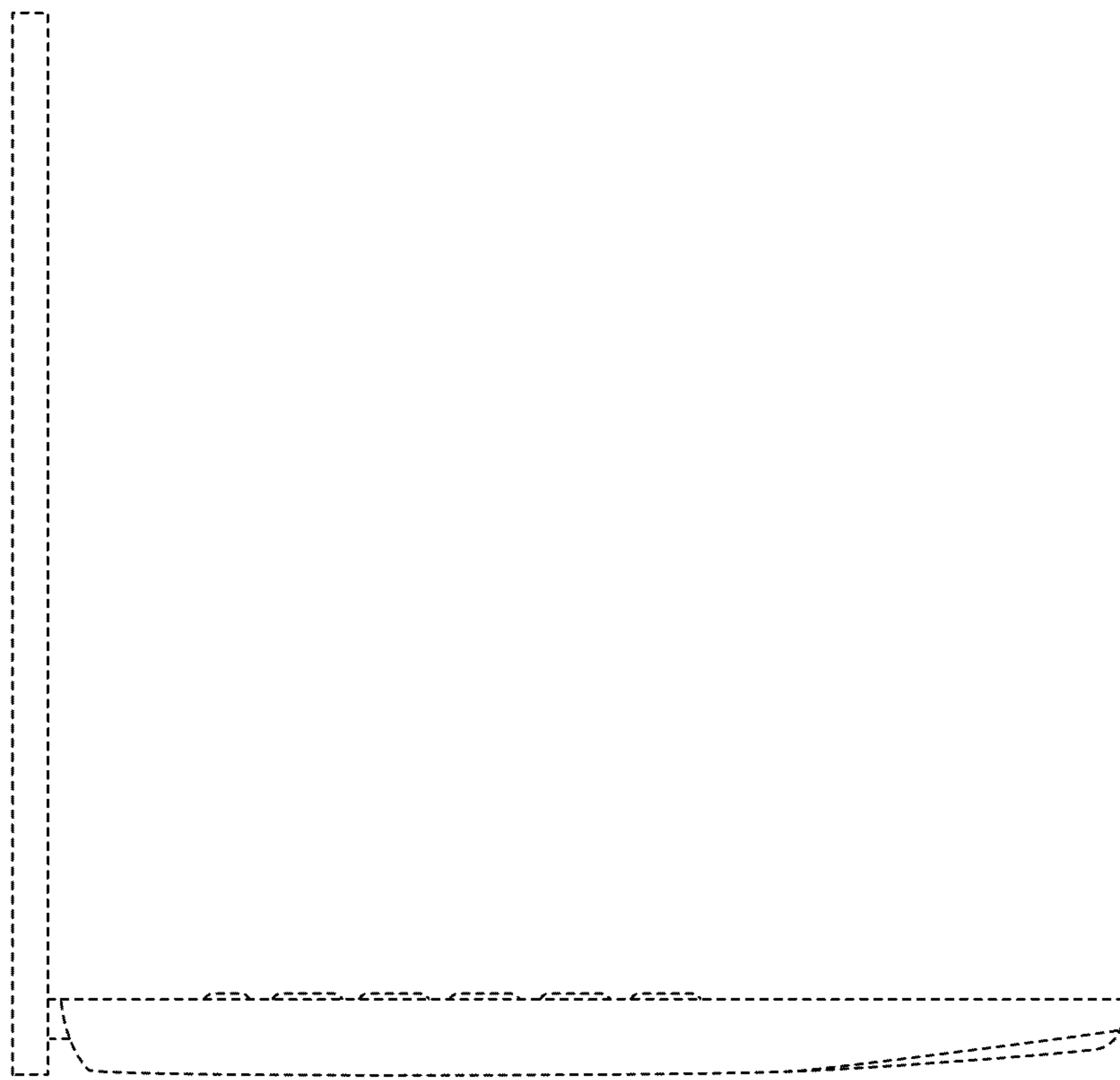

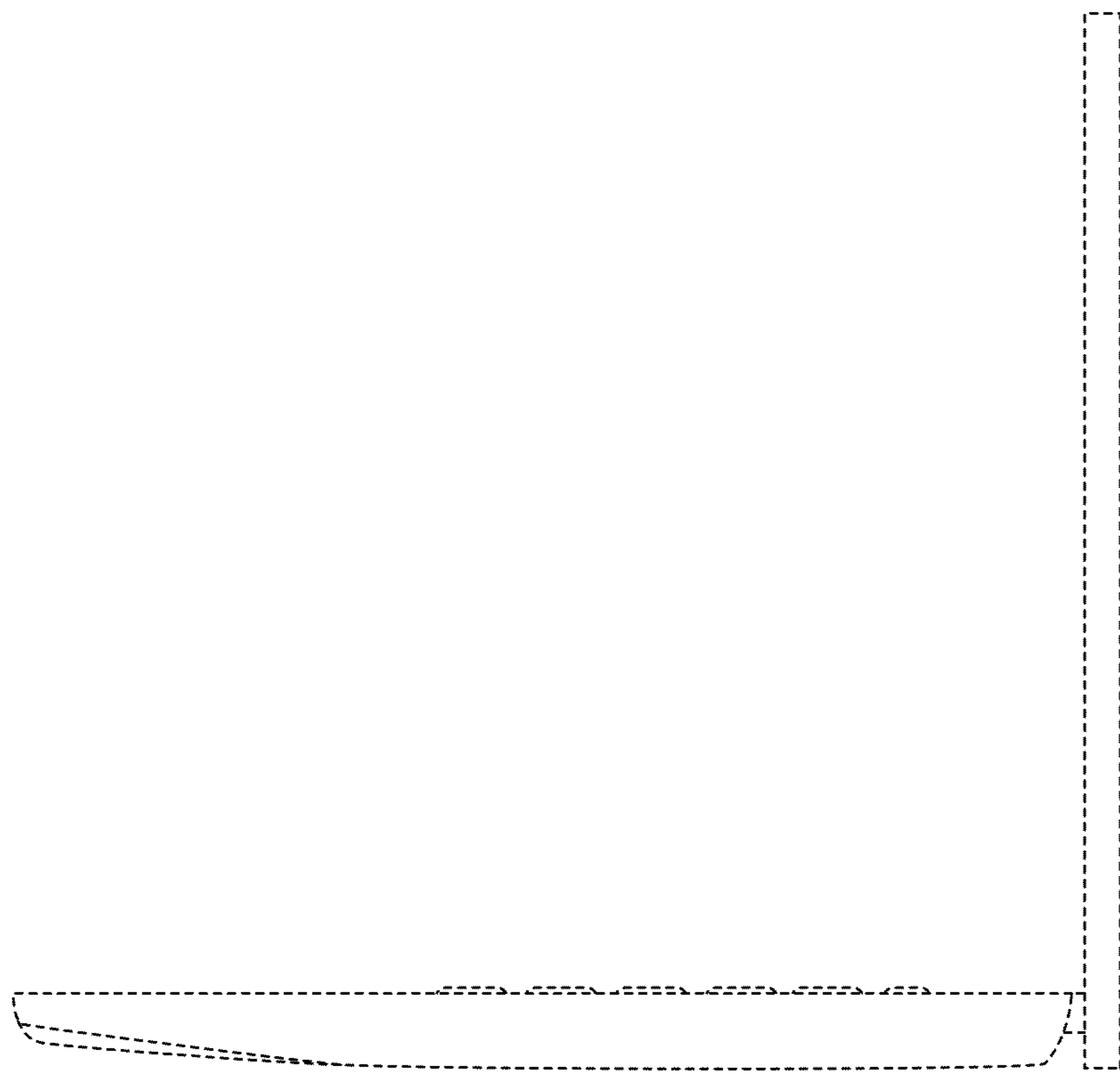

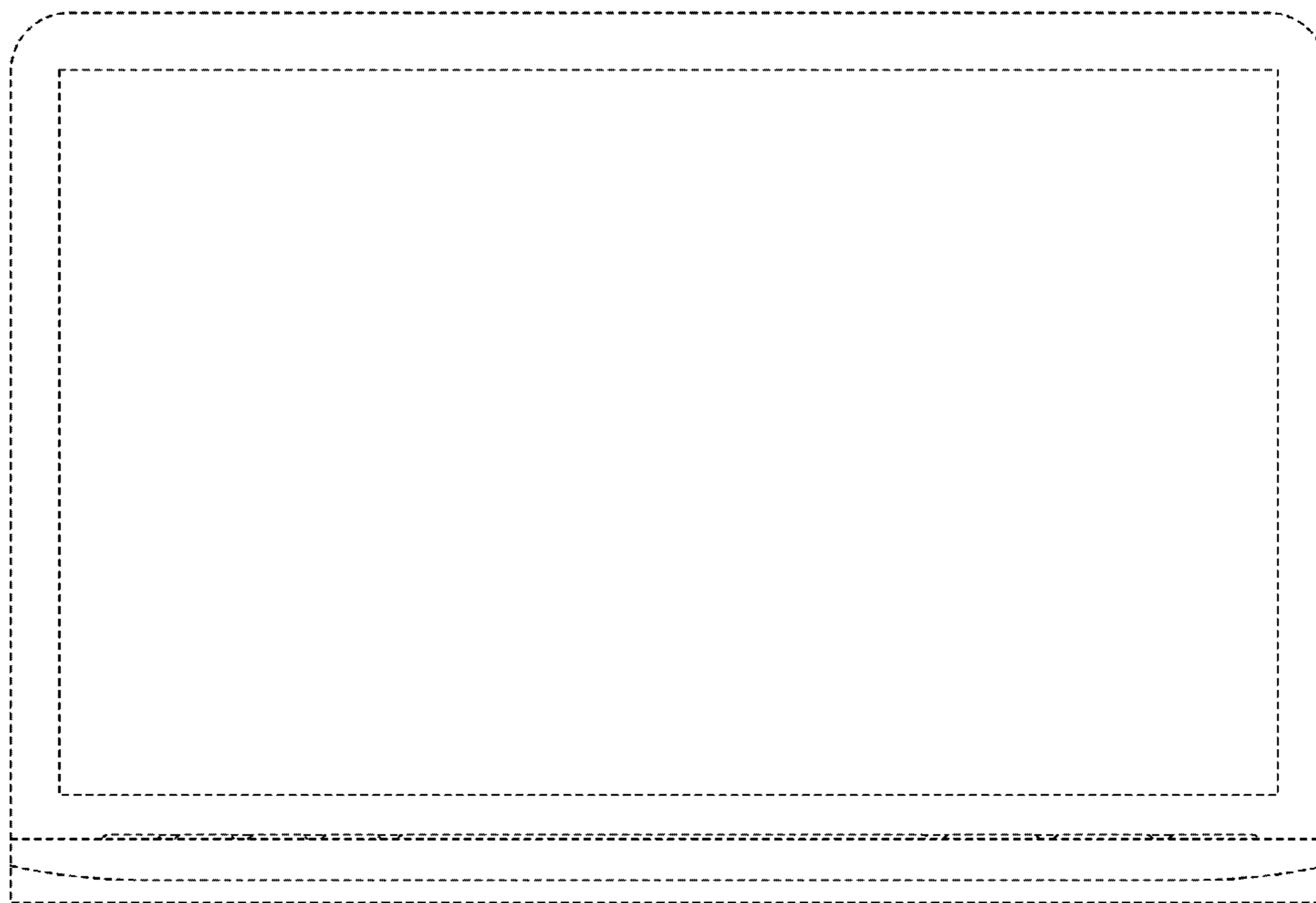
