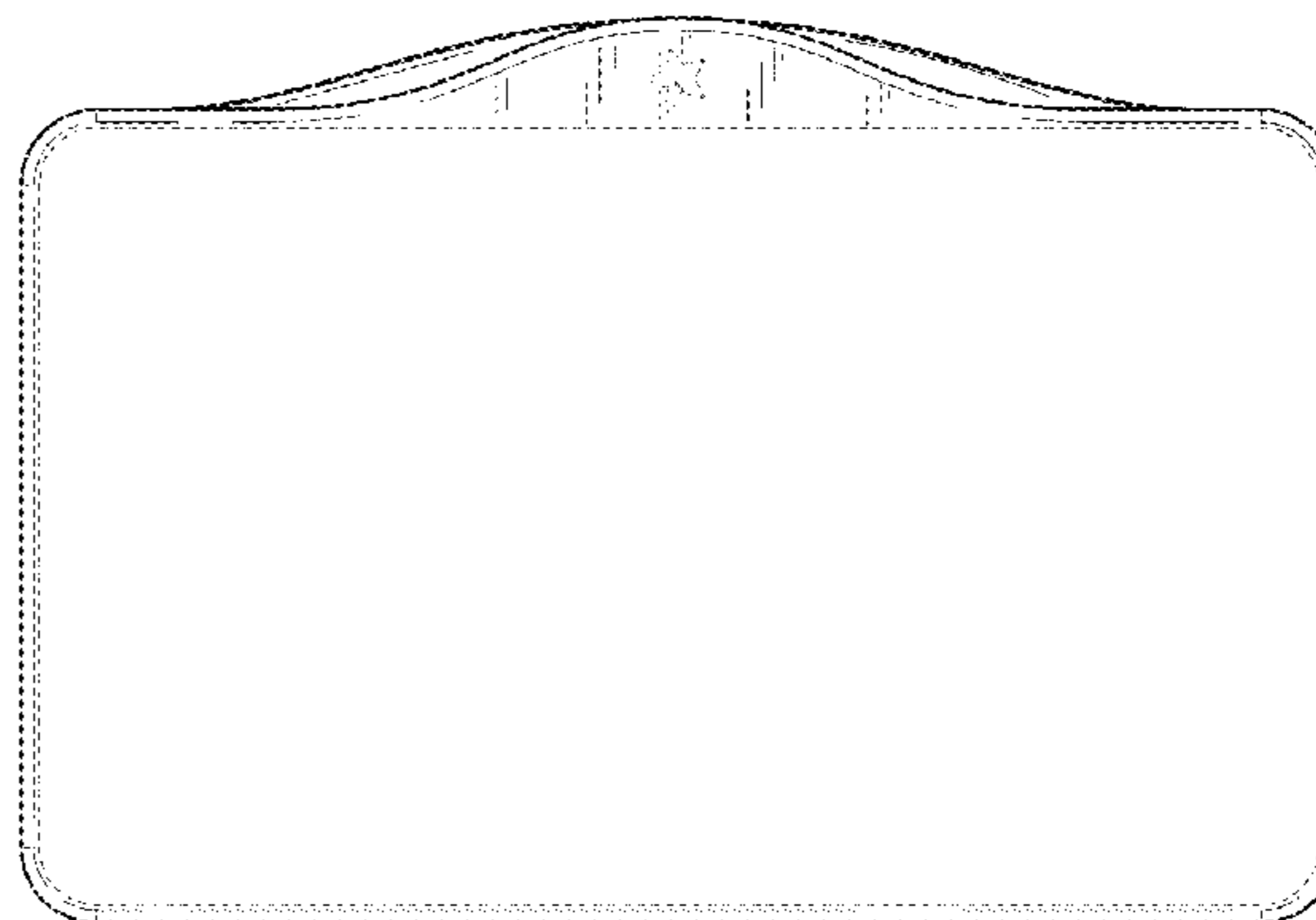
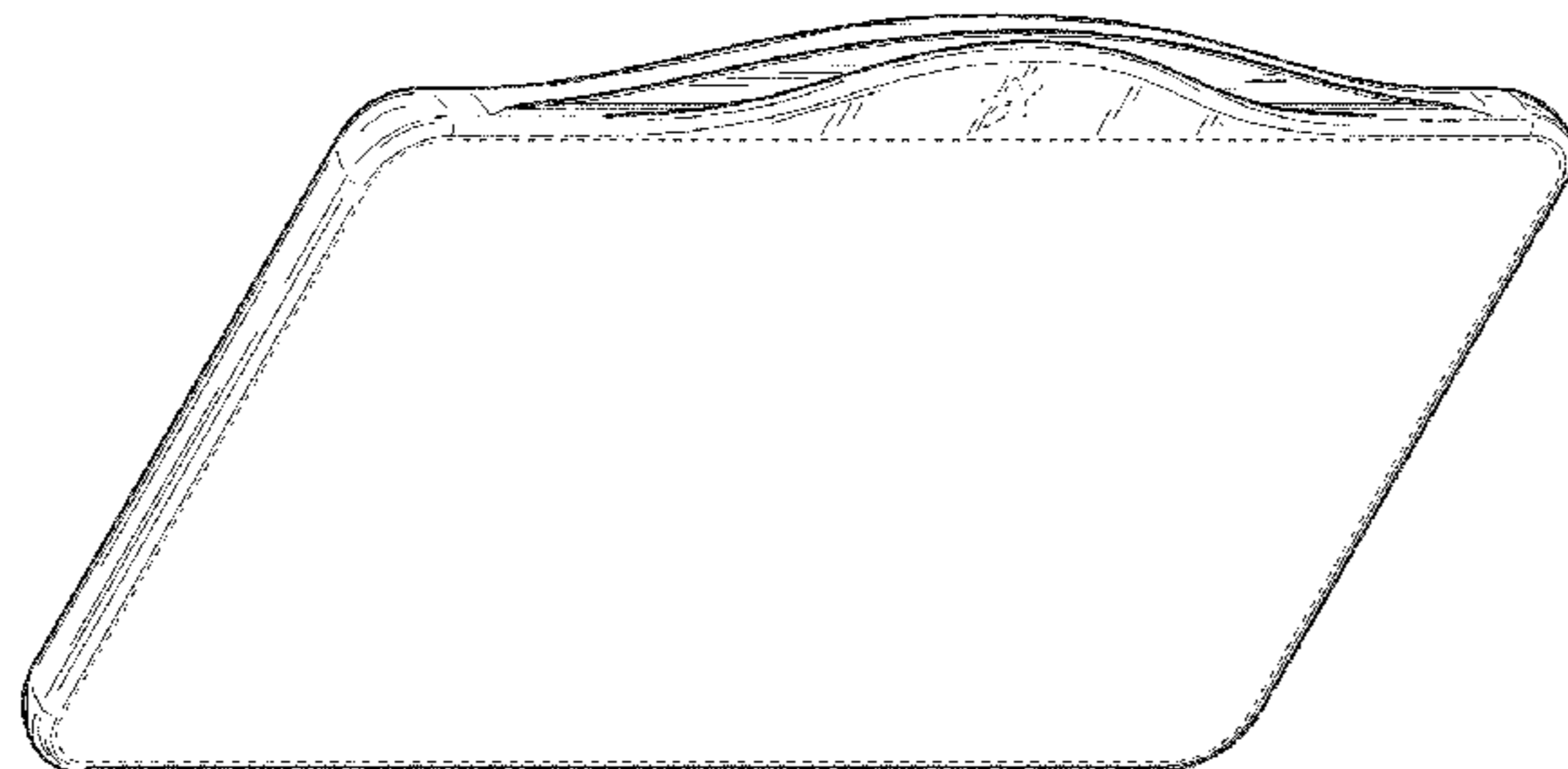
We claim the ornamental design for a tablet computing device with housing, as shown and described.

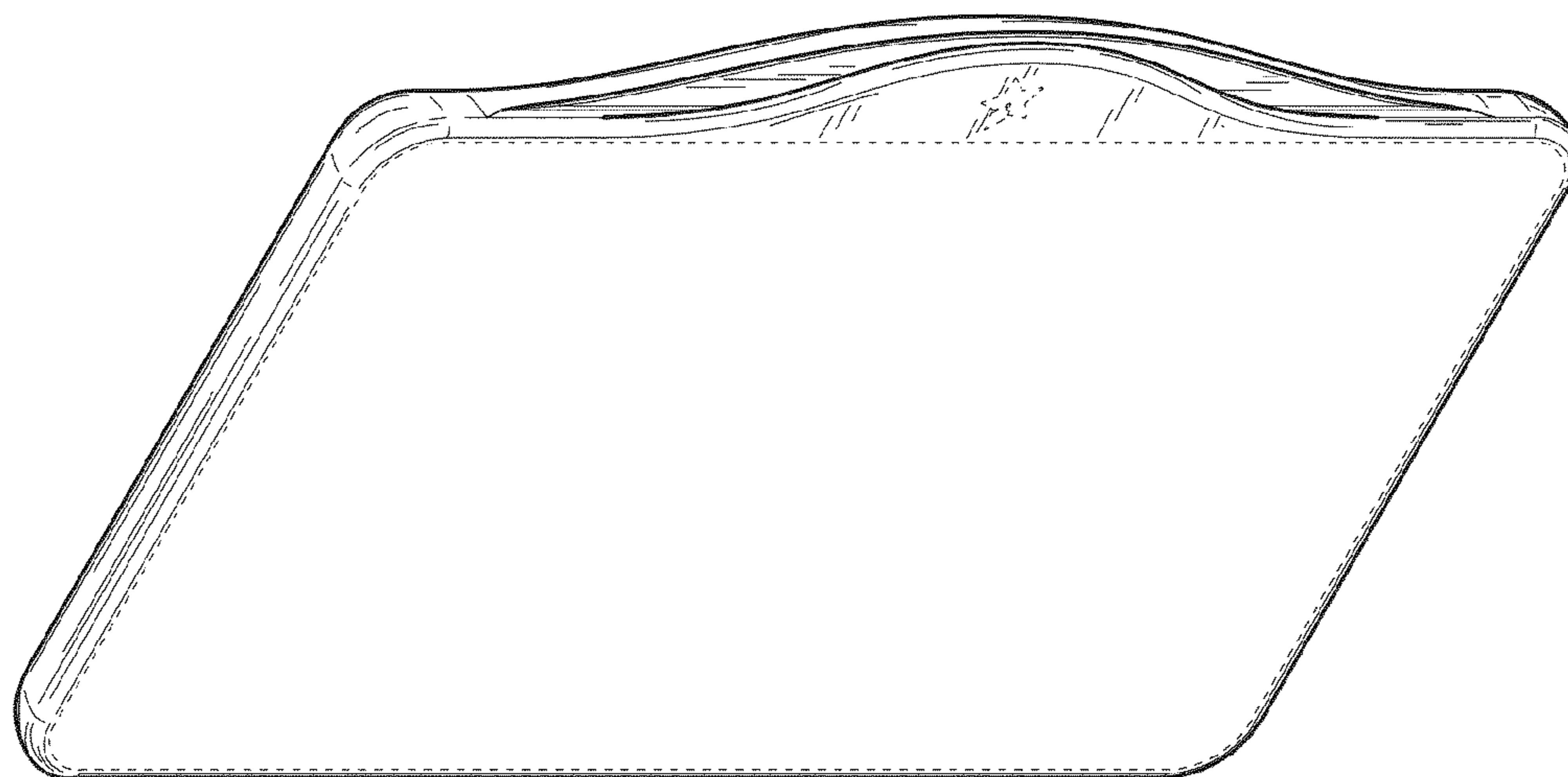

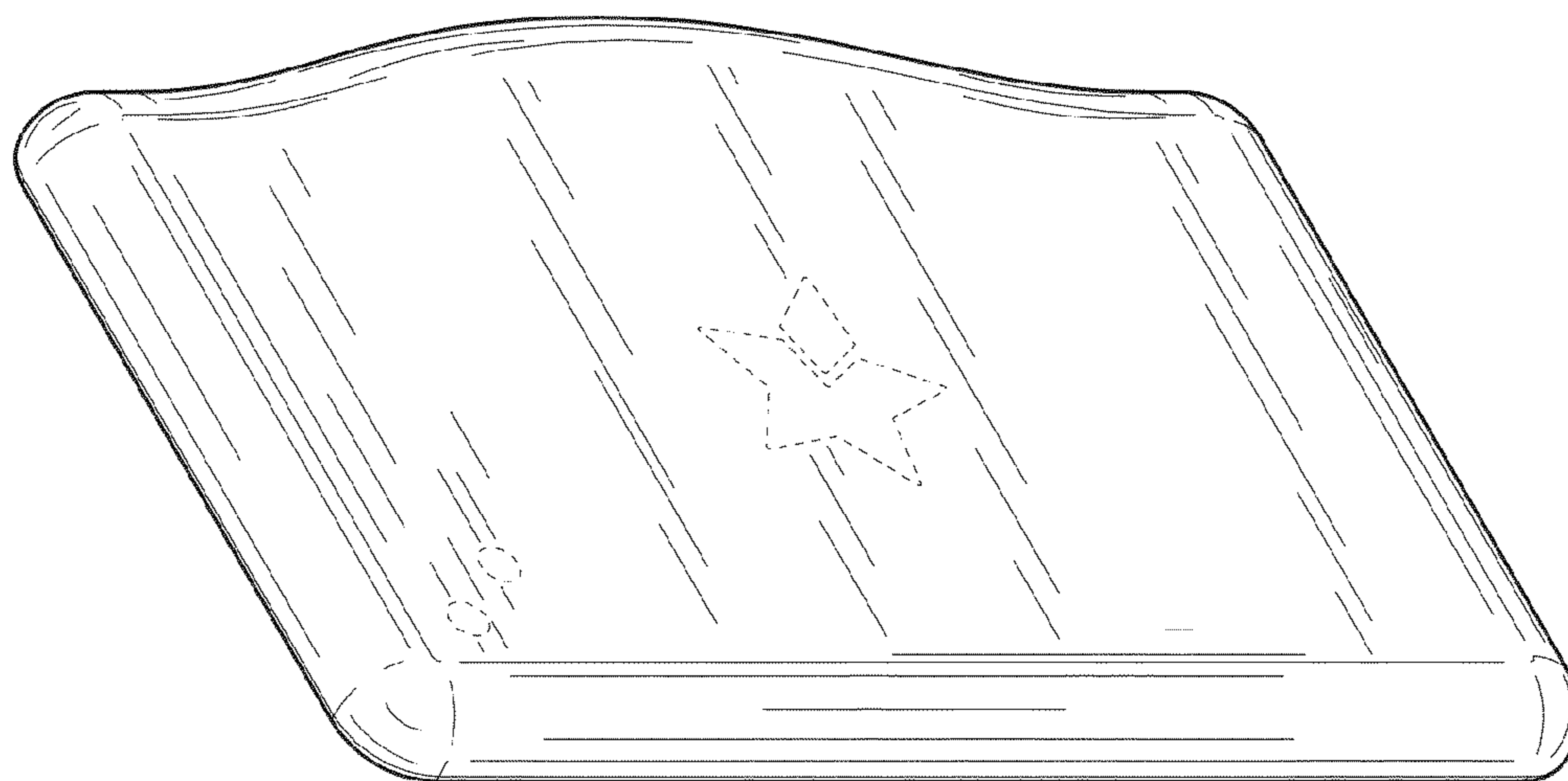

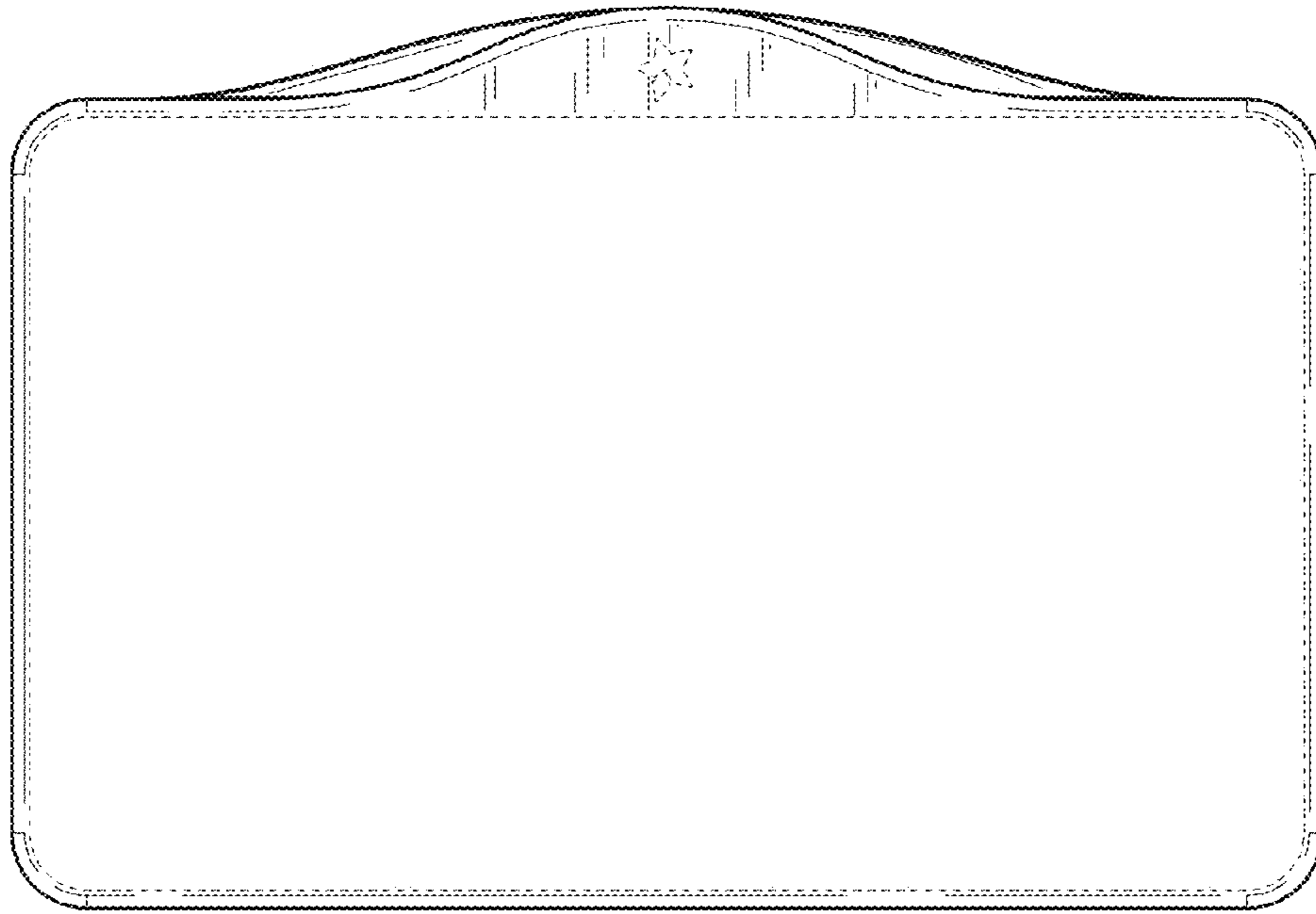

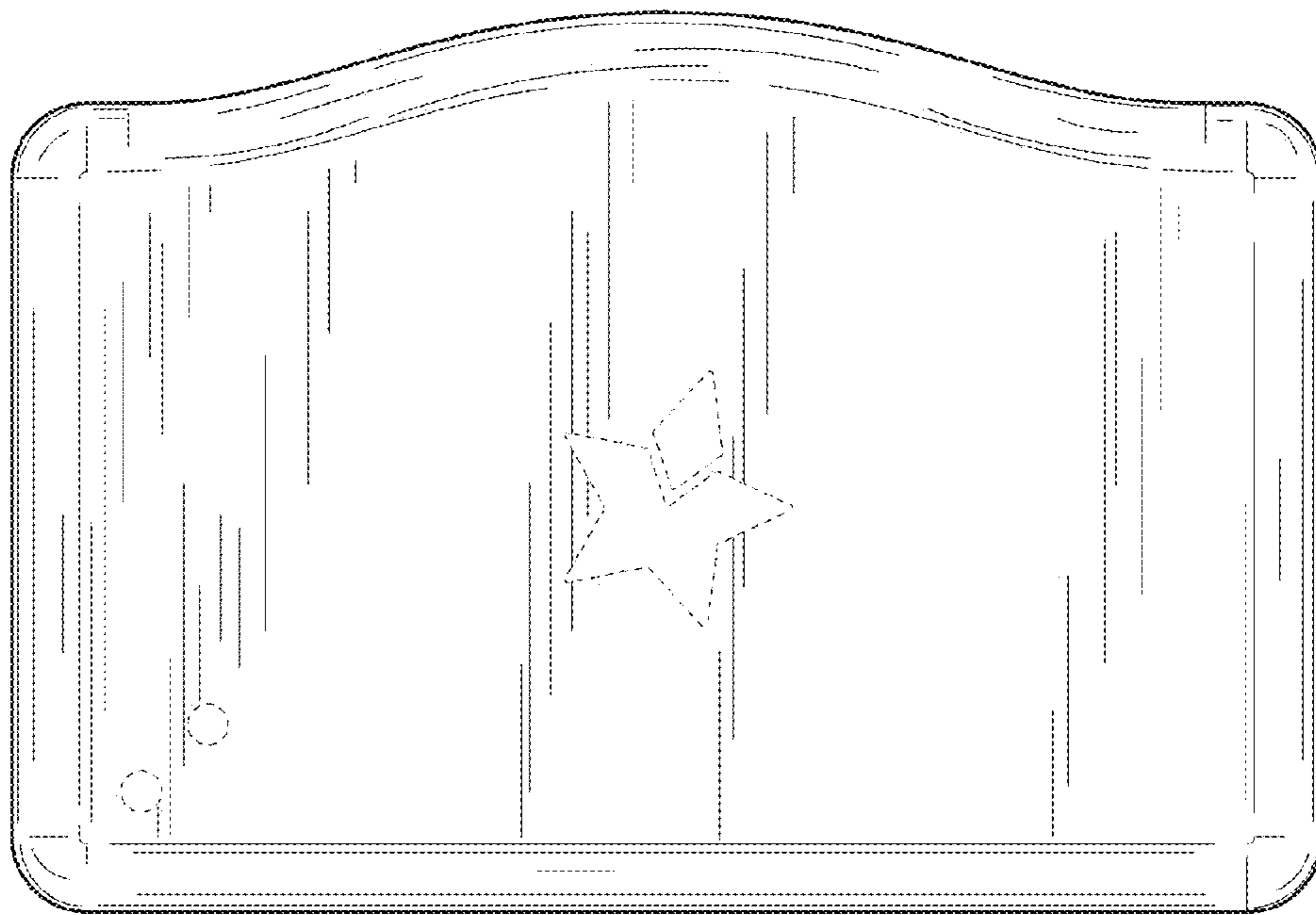

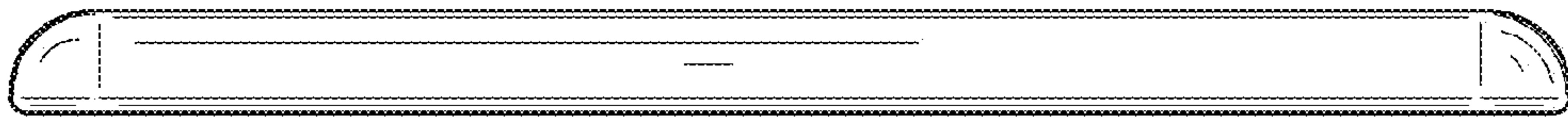
