(57) **CLAIM**

The ornamental design for the universal device-holding mechanism for a mobile communications device, as shown and described.

DESCRIPTION

FIG. 1 is an anterior plan view of the universal device-holding mechanism for a mobile communications device.

FIG. 2 is a posterior plan view of the universal device-holding mechanism for a mobile communications device, shown reduced in scale.

FIG. 3 is a bottom edge view of the universal device-holding mechanism for a mobile communications device, shown reduced in scale.

FIG. 4 is a first lateral edge view of the universal device-holding mechanism for a mobile communications device, shown reduced in scale.

FIG. 5 is a top edge view of the universal device-holding mechanism for a mobile communications device, shown reduced in scale.

FIG. 6 is a second lateral edge view of the universal device-holding mechanism for a mobile communications device, shown reduced in scale.

FIG. 7 is an anterior perspective view of the universal device-holding mechanism for a mobile communications device.

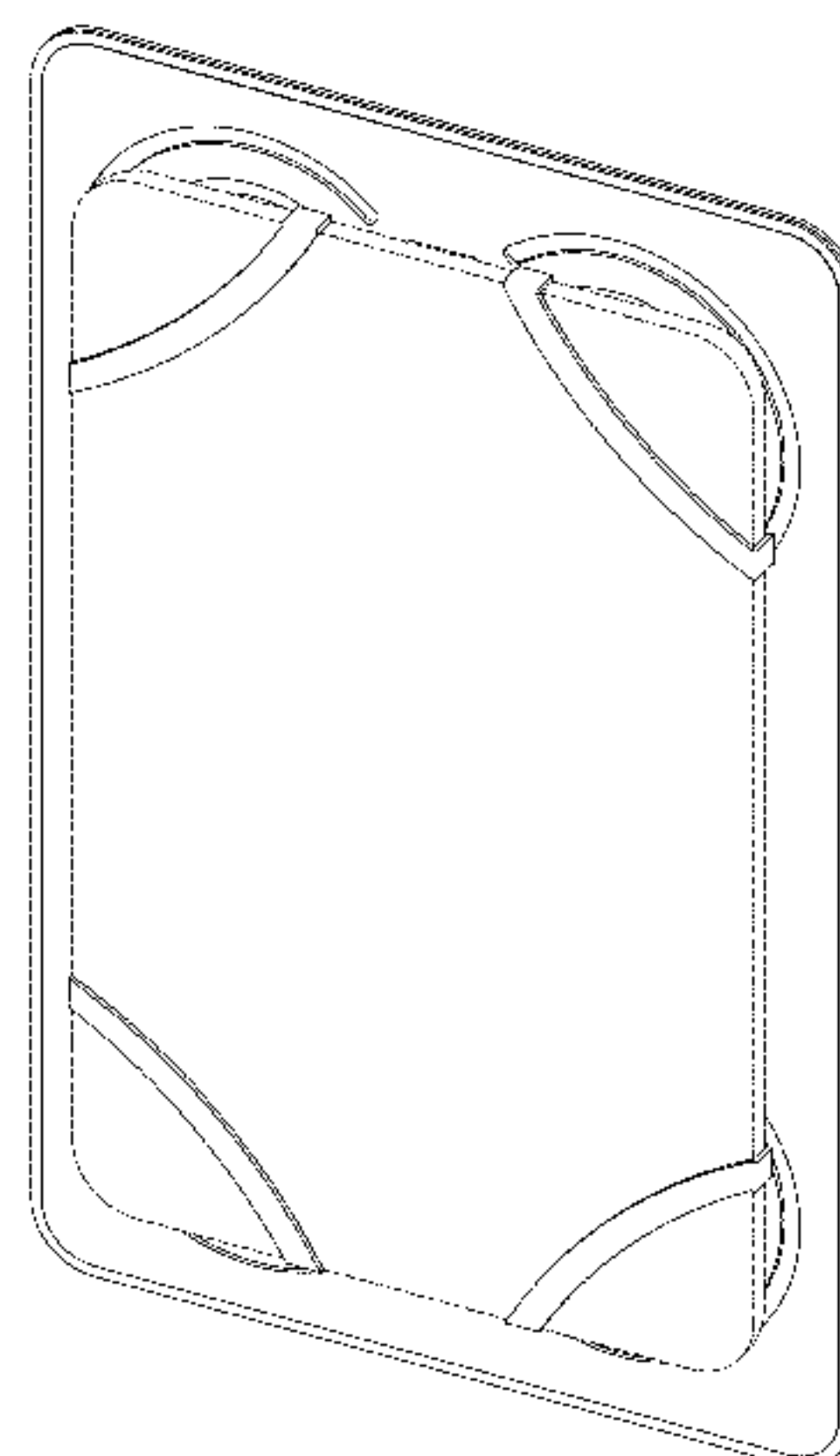
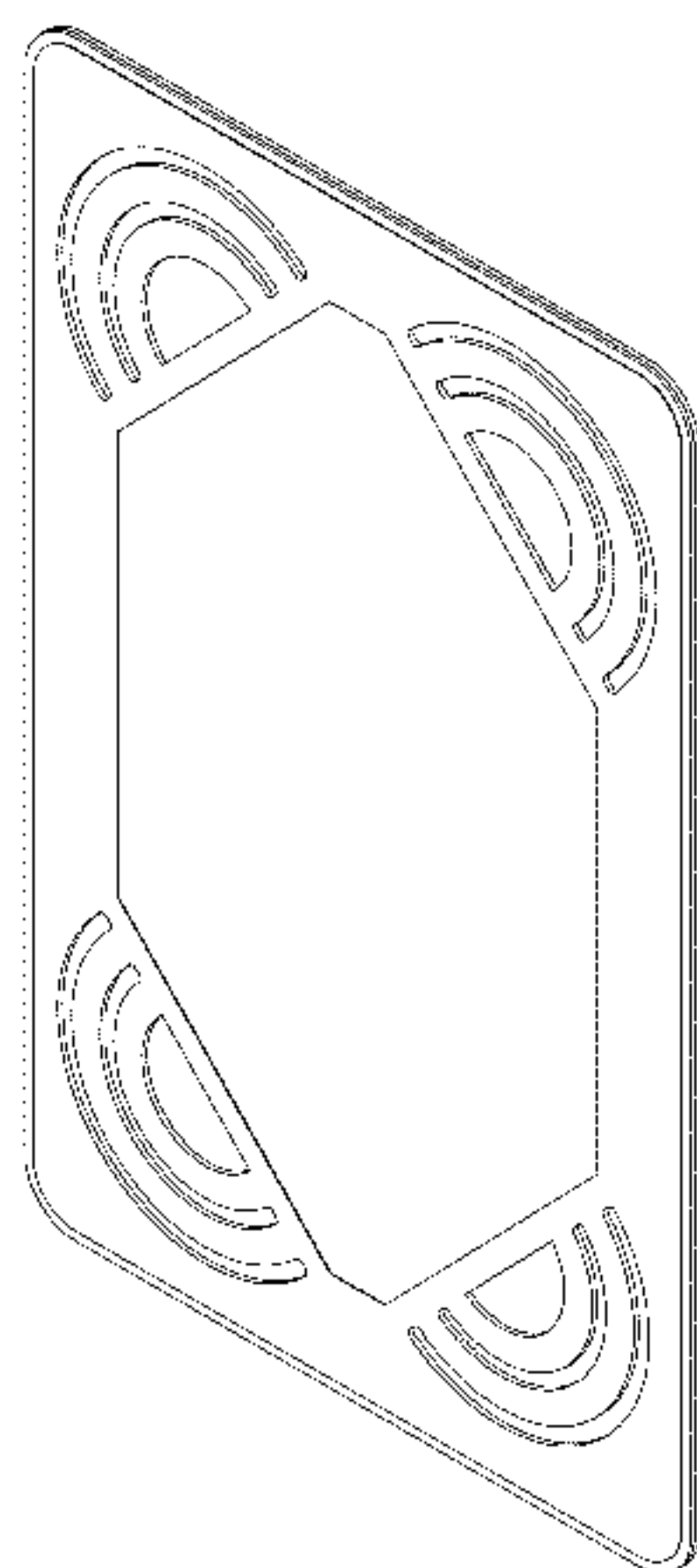
FIG. 8 is a posterior perspective view of the universal device-holding mechanism for a mobile communications device.

FIG. 9 is an anterior perspective view of the universal device-holding mechanism for a mobile communications device shown in a first condition of use; and,

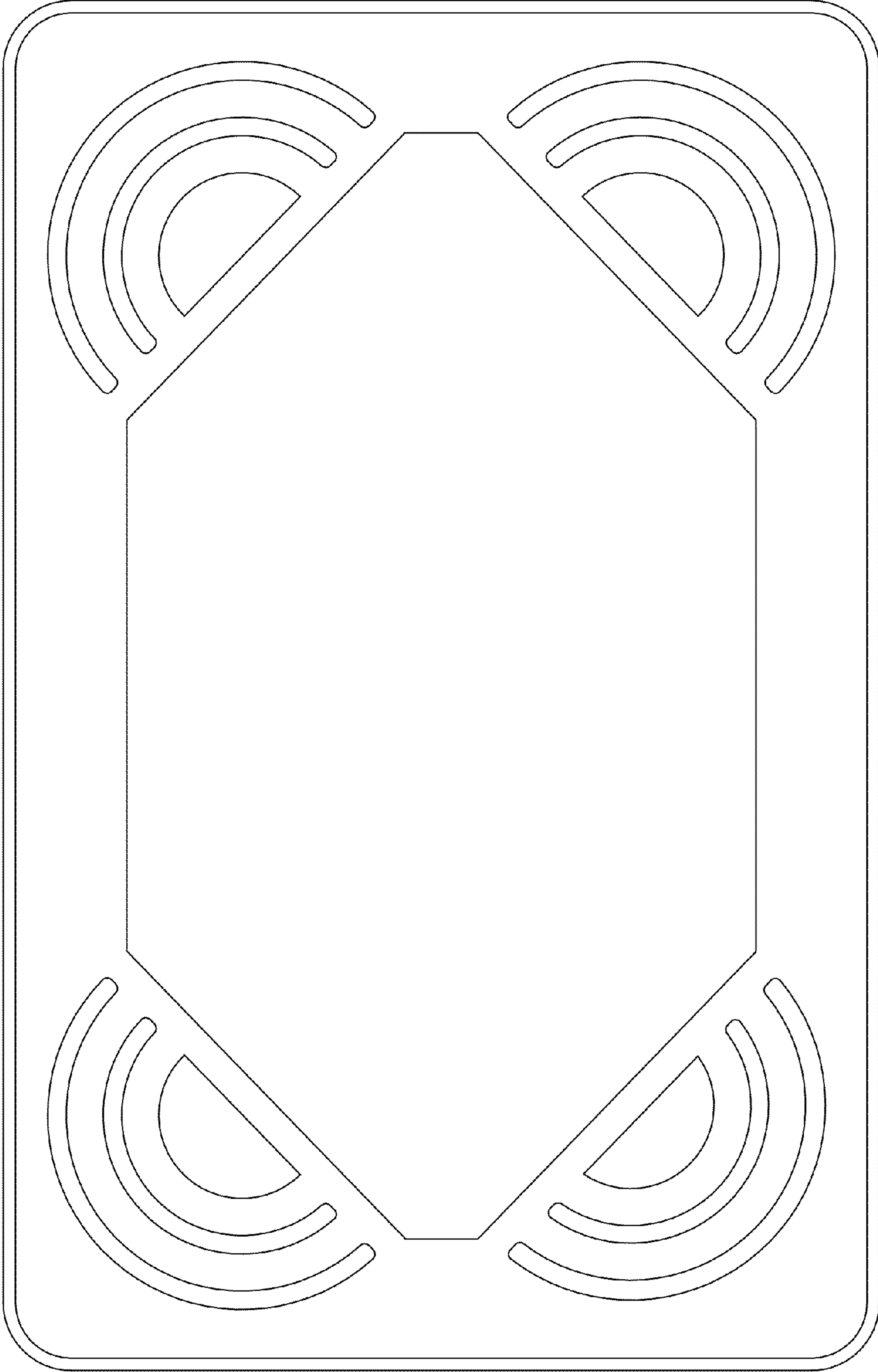

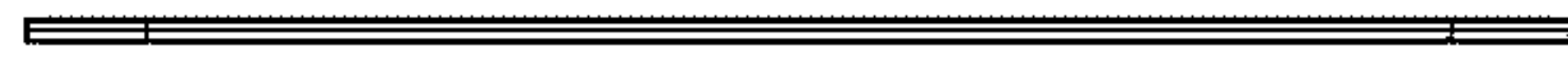

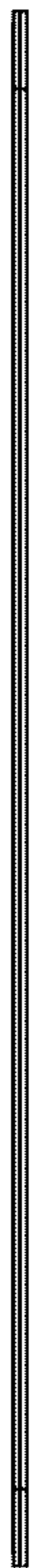

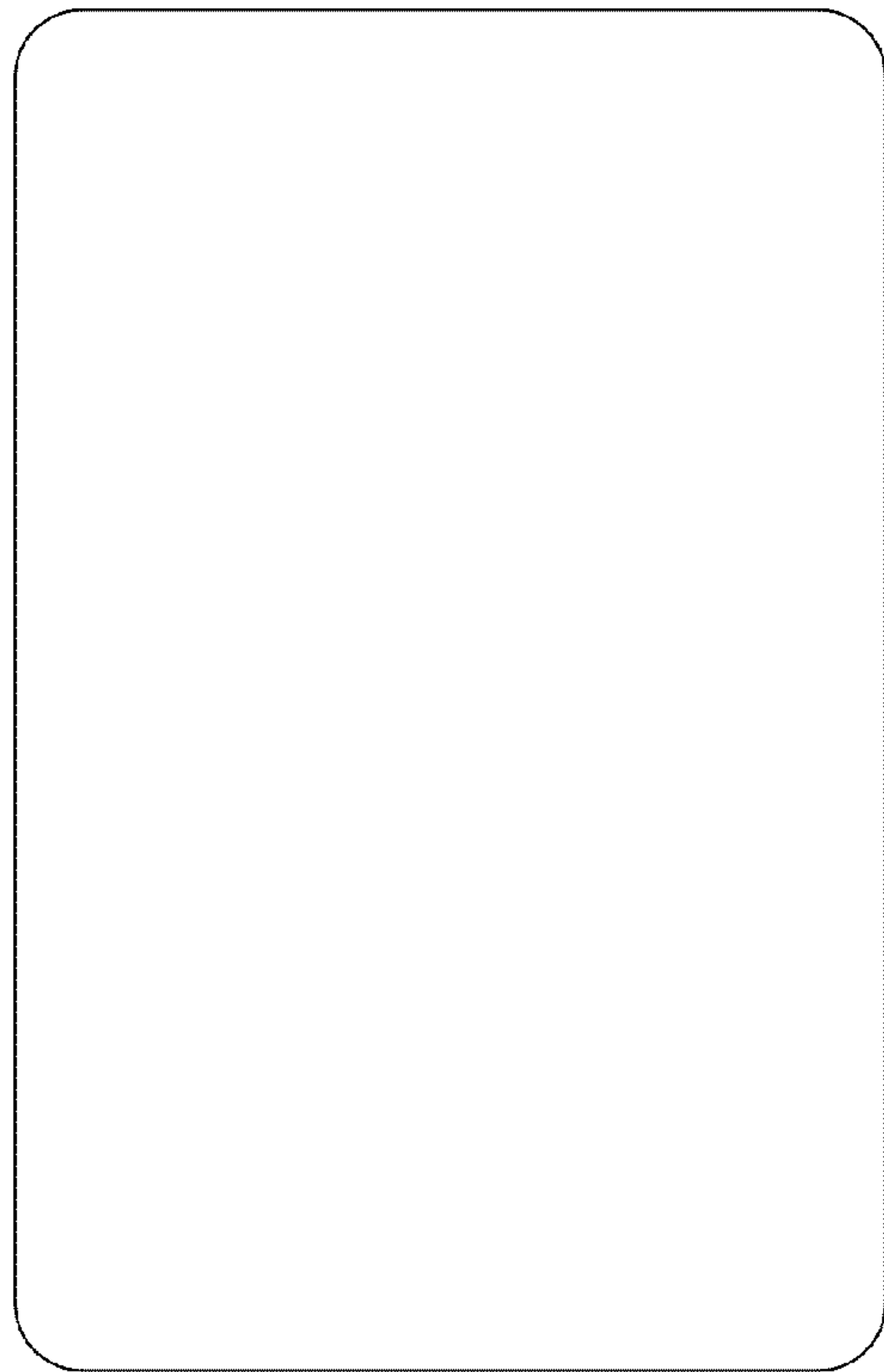

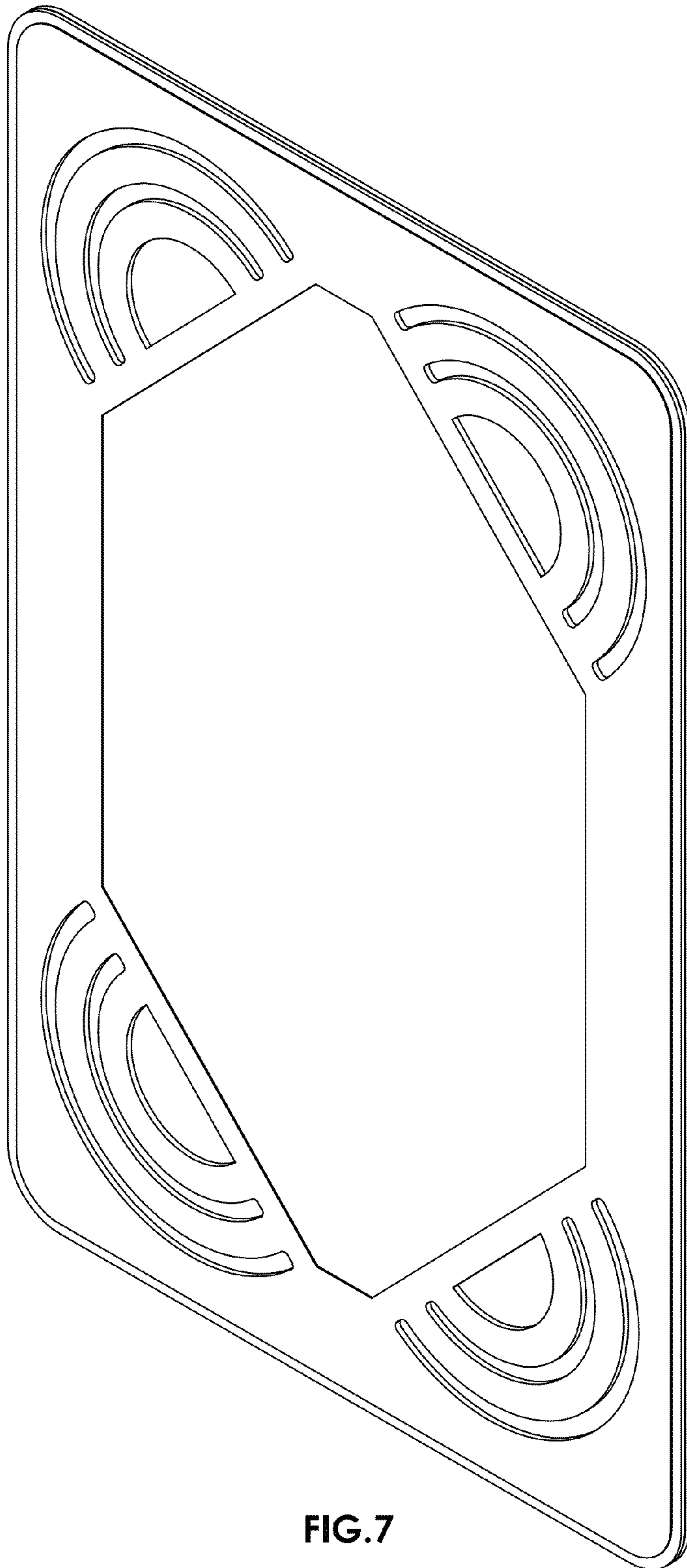

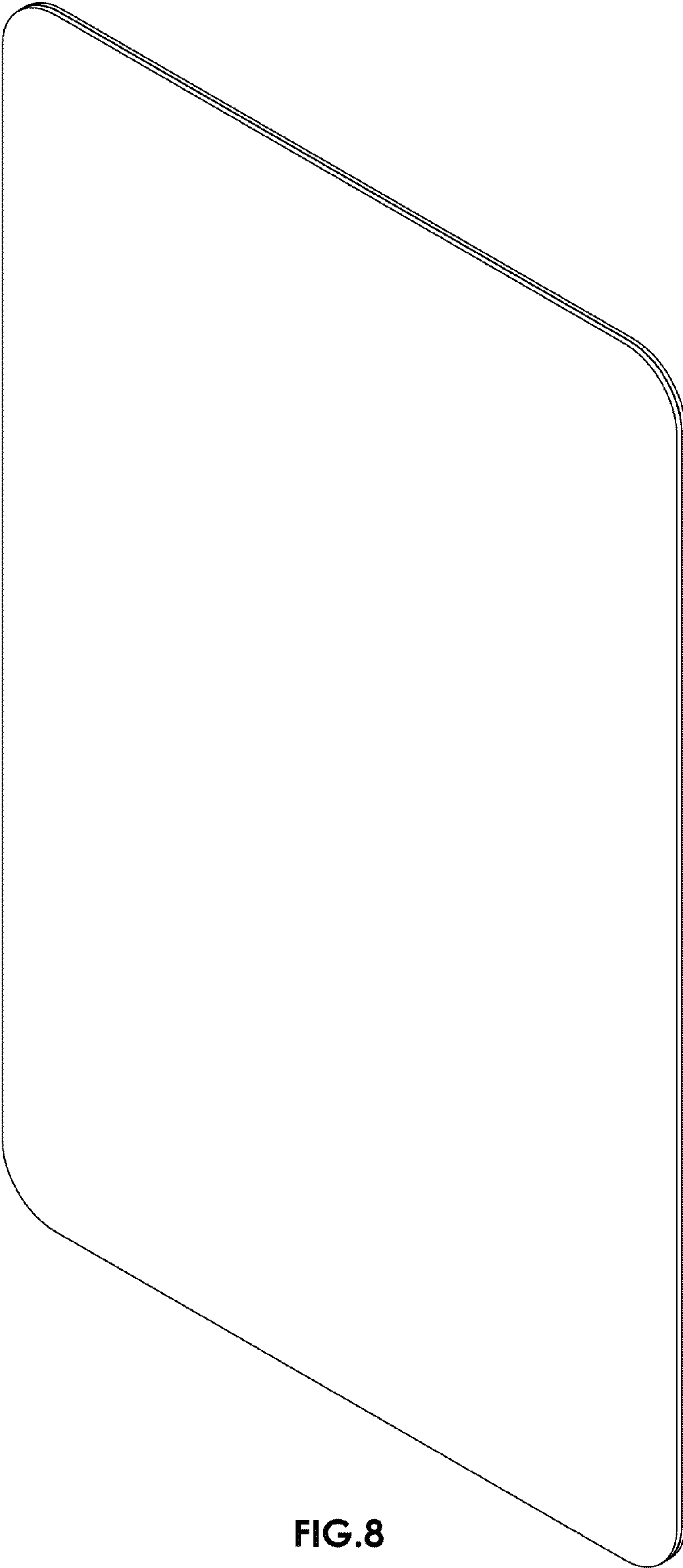

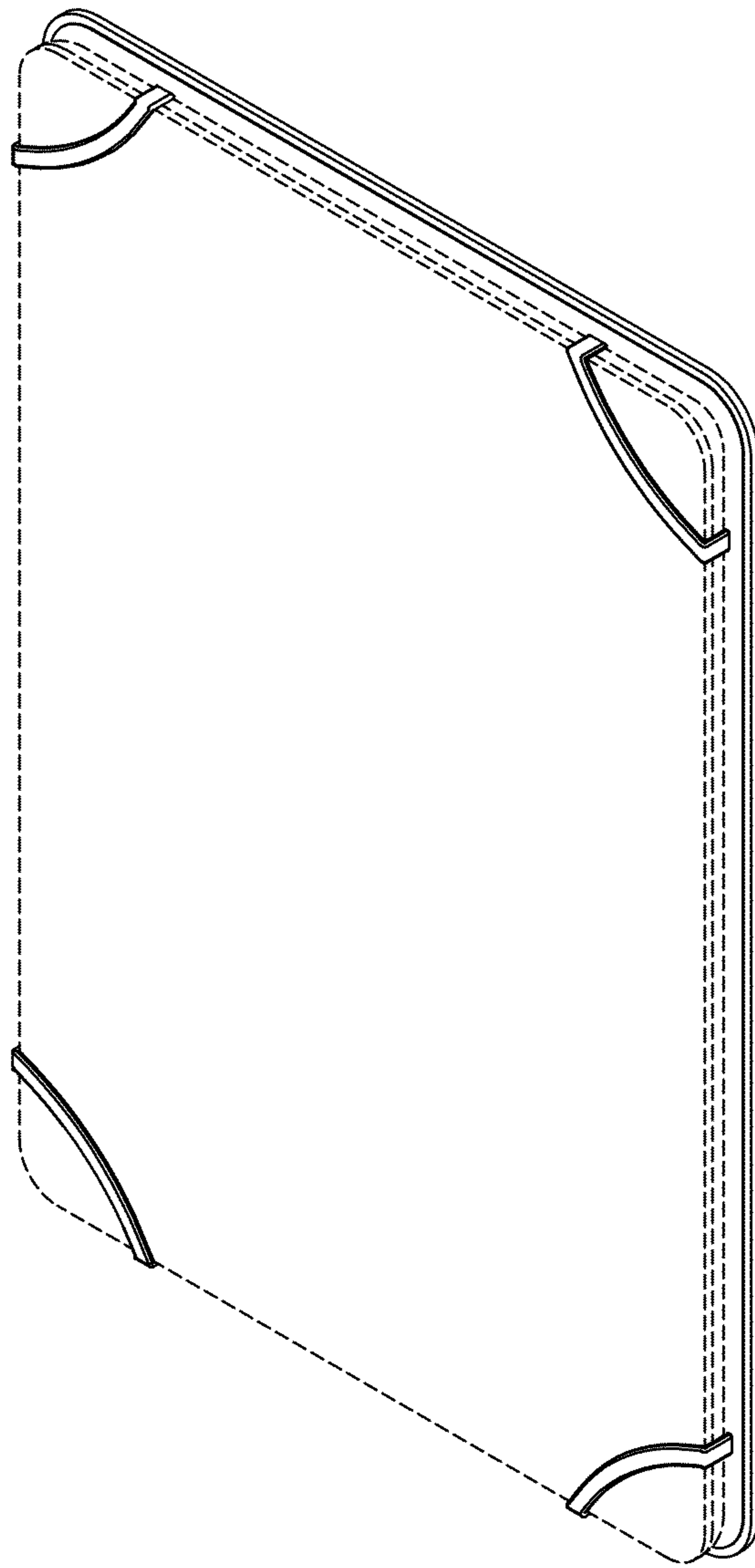

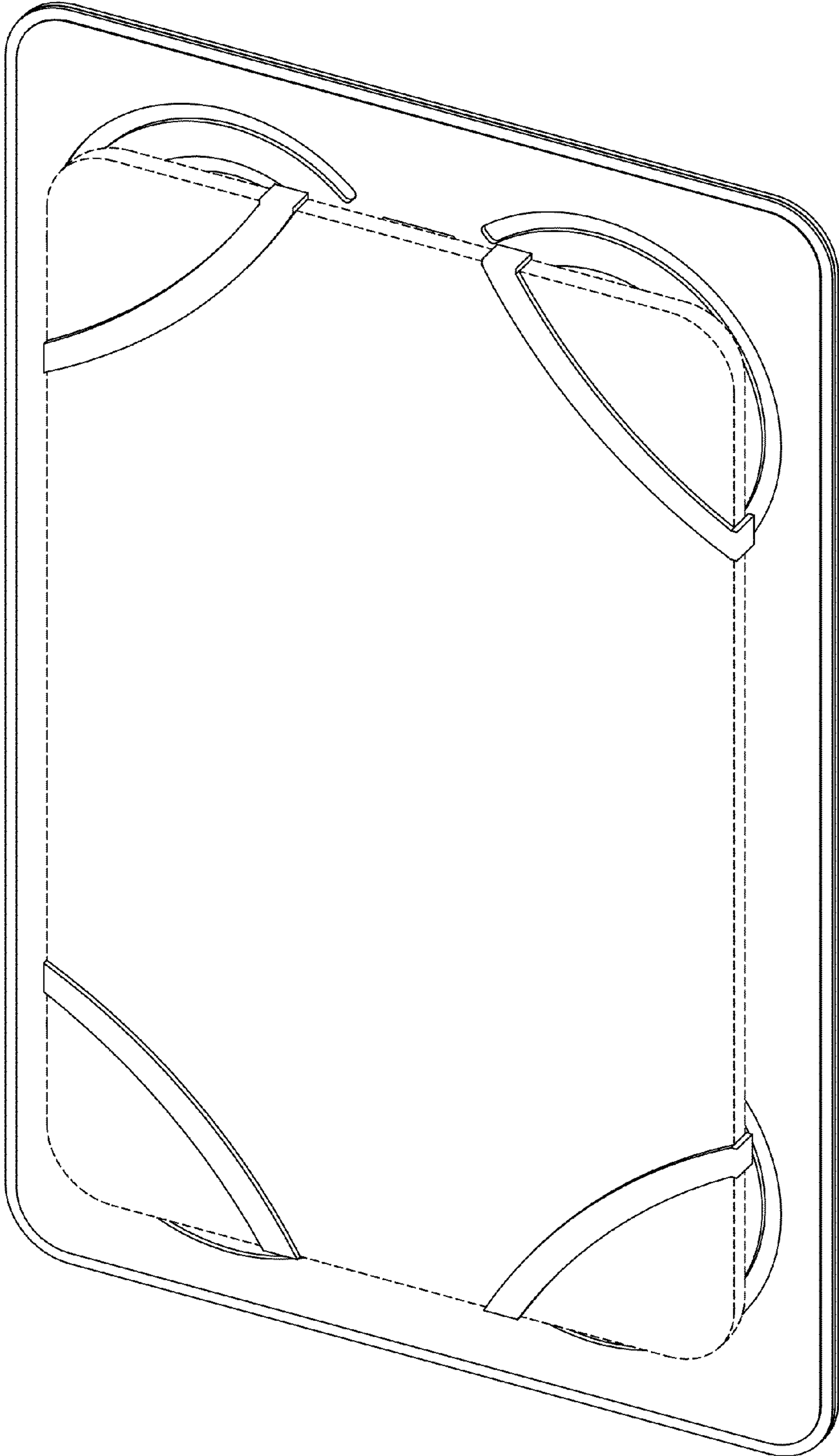
