(57) **CLAIM**

We claim the ornamental design for a clipboard, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a clipboard according to the present invention in a closed state.

FIG. 2 is a front view of the clipboard of FIG. 1.

FIG. 3 is a rear view of the clipboard of FIG. 1.

FIG. 4 is a right-side view of the clipboard of FIG. 1.

FIG. 5 is a left-side view of the clipboard of FIG. 1.

FIG. 6 is a bottom view of the clipboard of FIG. 1.

FIG. 7 is a top view of the clipboard of FIG. 1.

FIG. 8 is a front perspective view of the clipboard of FIG. 1 in an open state.

FIG. 10 is a rear view of the clipboard of FIG. 8.

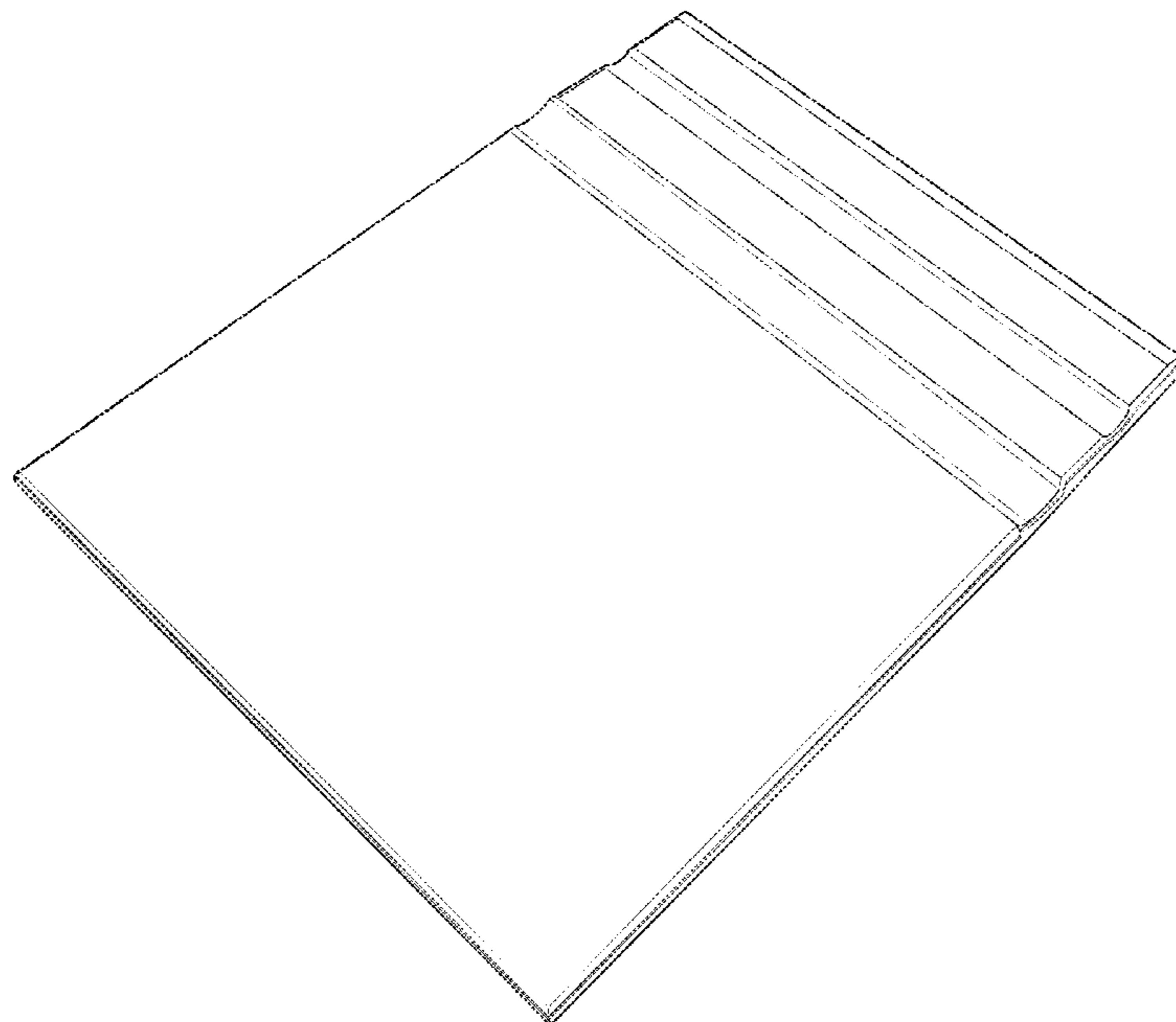
FIG. 11 is a right-side view of the clipboard of FIG. 8.

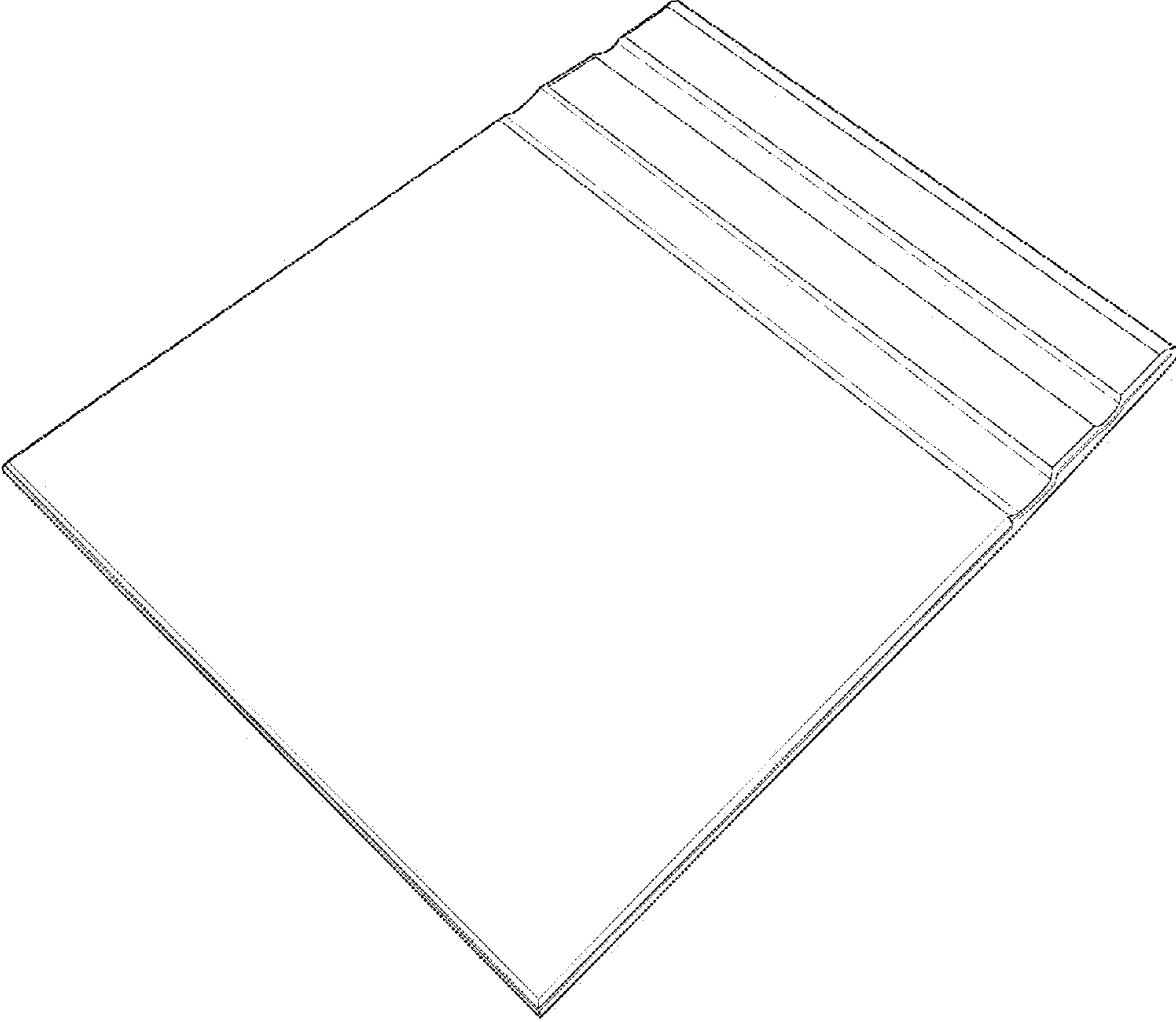

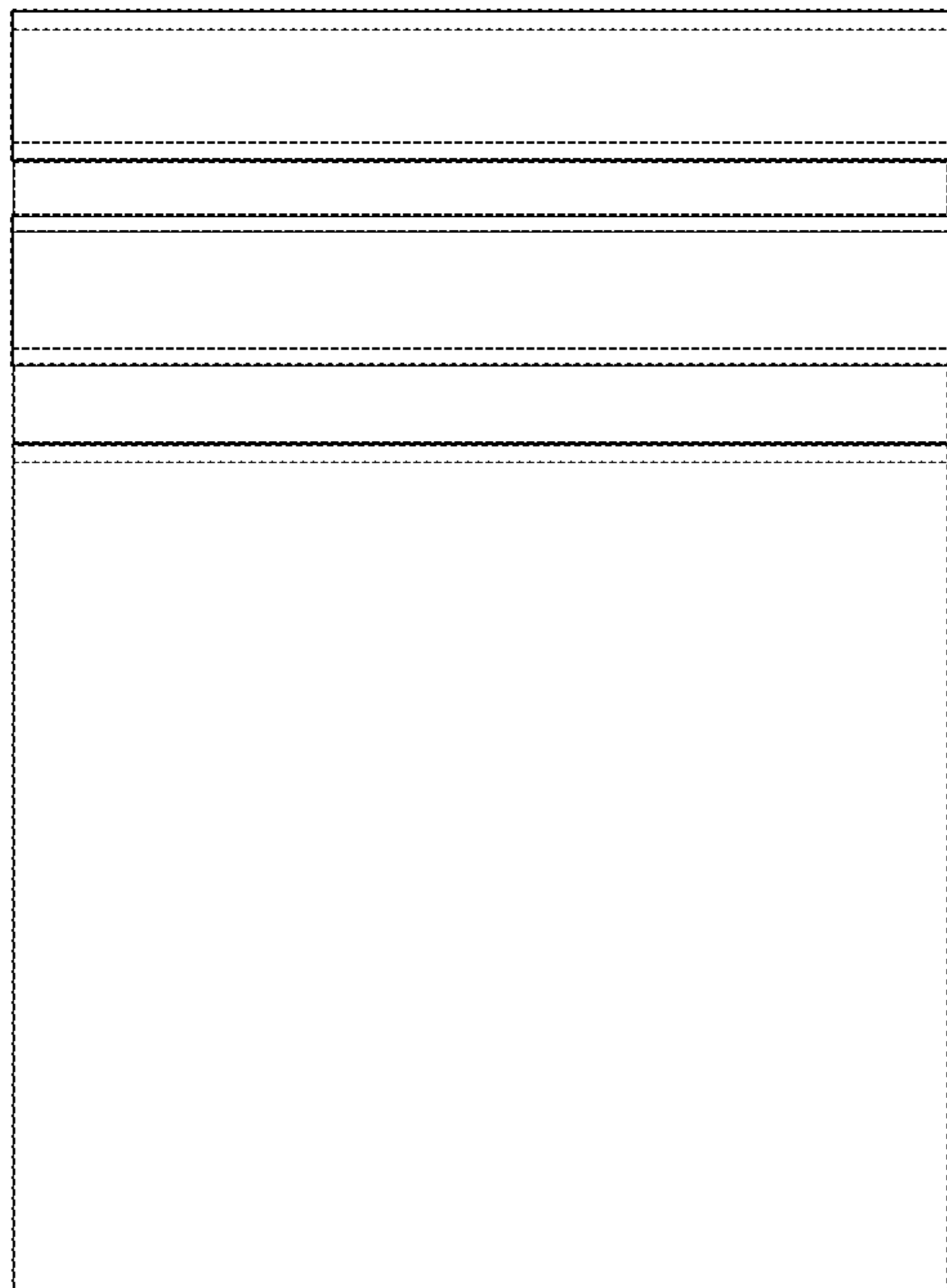

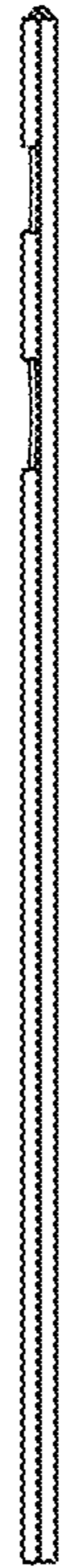
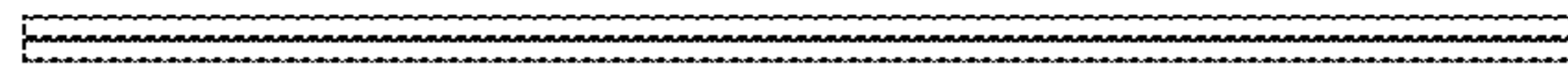


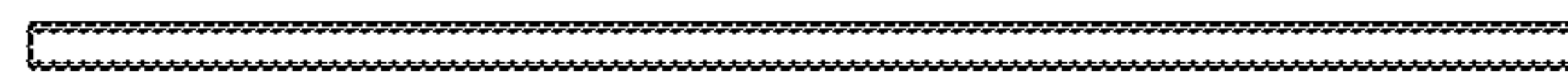

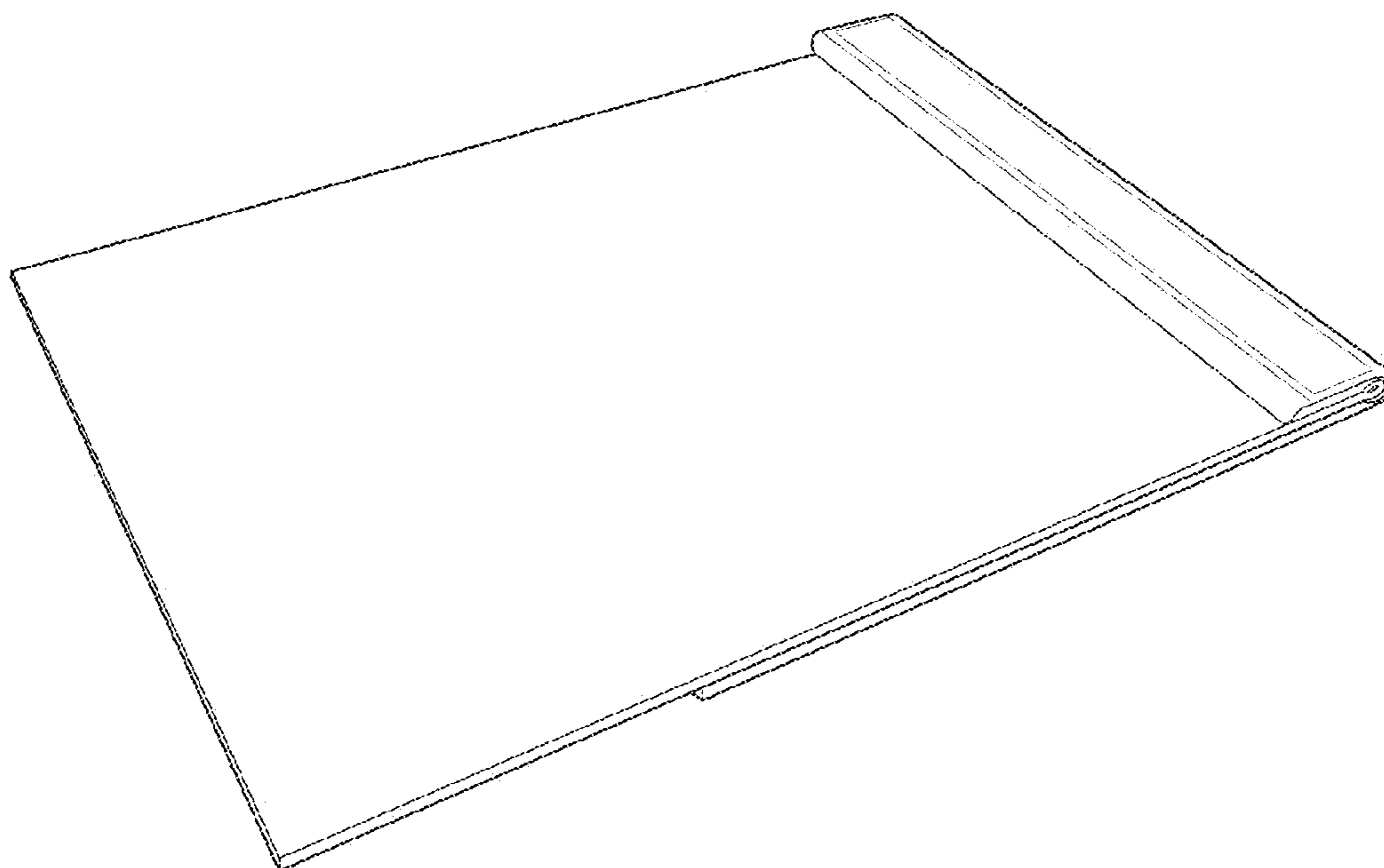

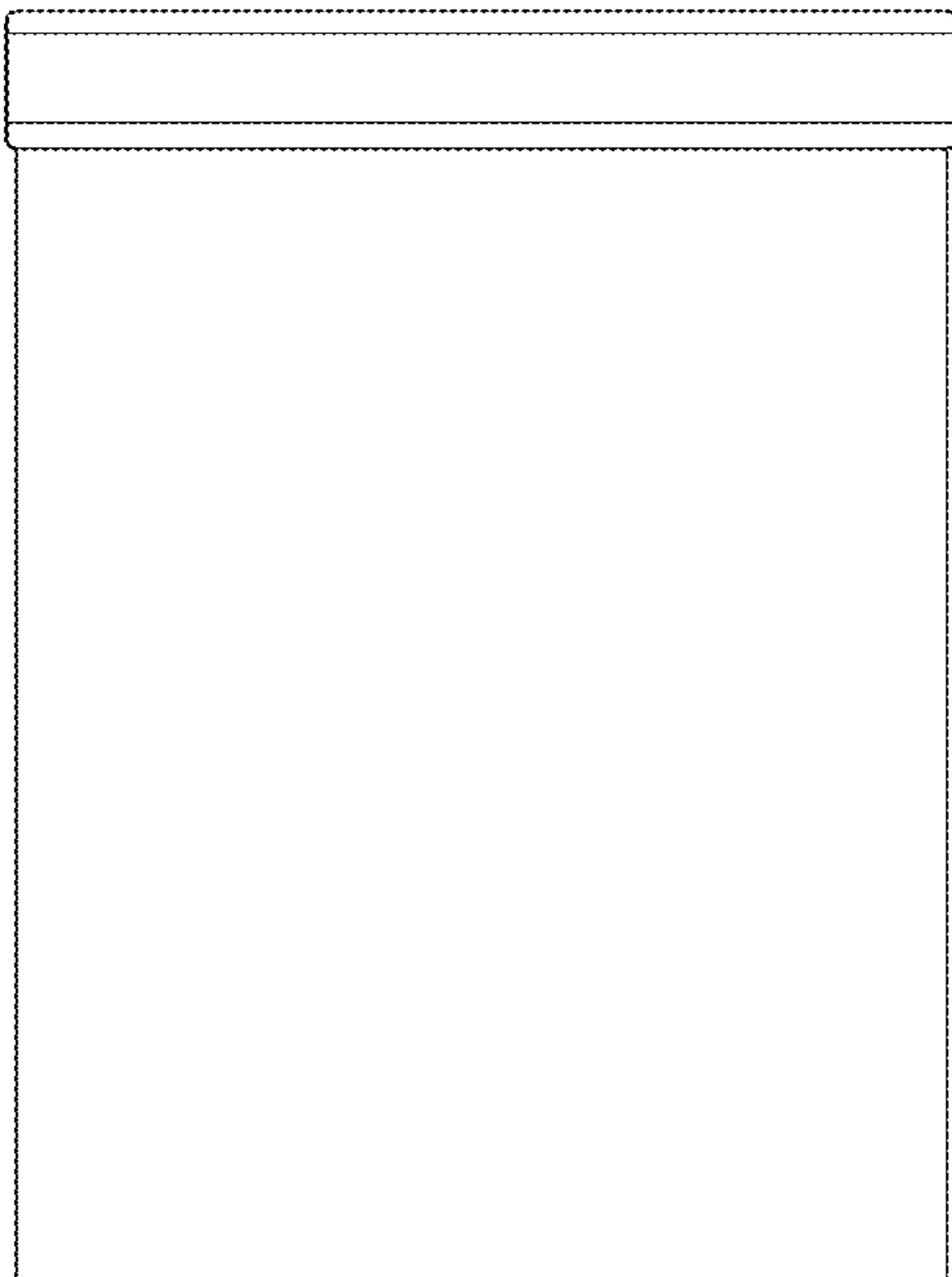

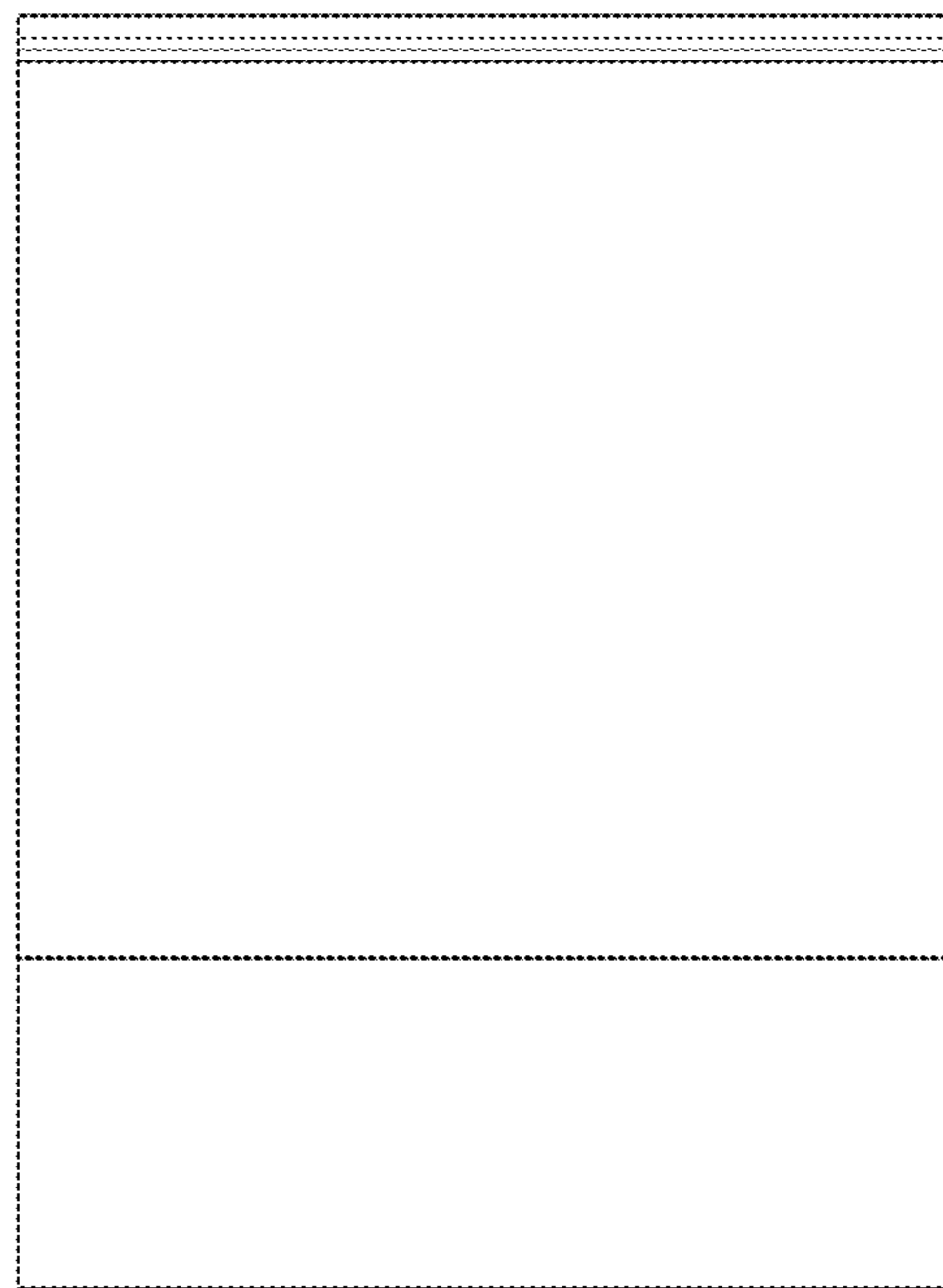

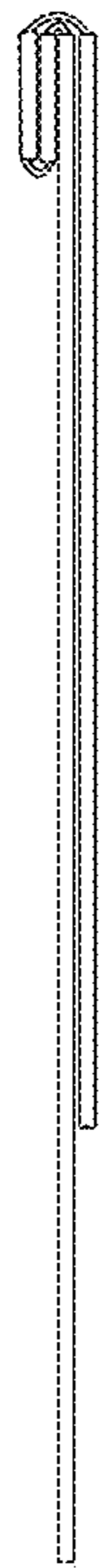

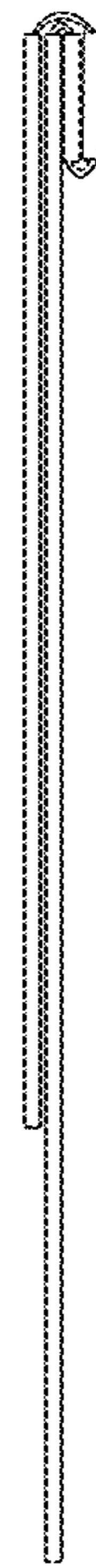

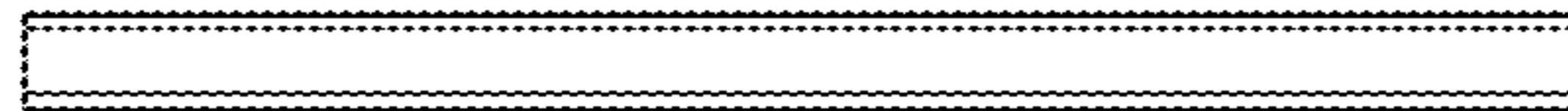
