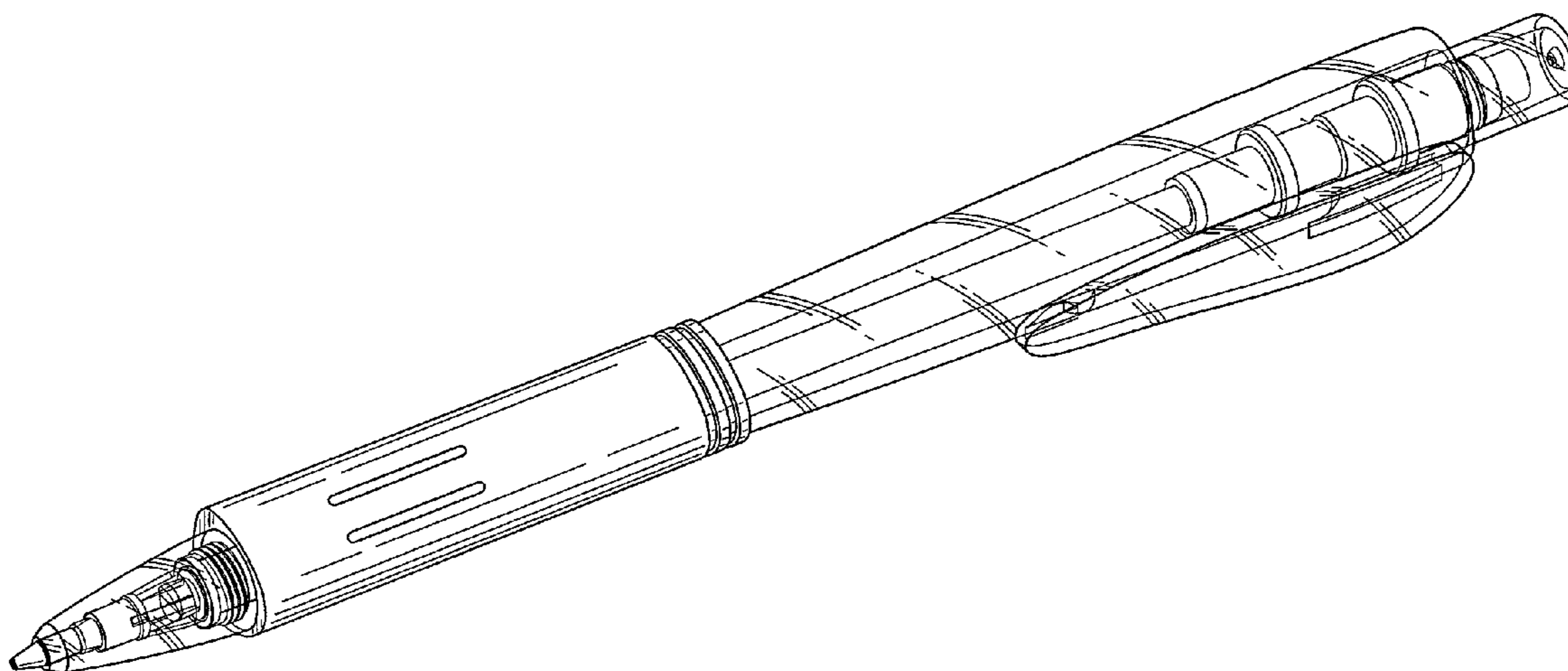

The ornamental design for a mechanical pencil, as shown and described.

DESCRIPTION
FIG. 1 is a perspective view of front, top and left side of a mechanical pencil showing our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a bottom view thereof;
FIG. 6 is a left side view thereof;
FIG. 7 is an enlarged left side view thereof;

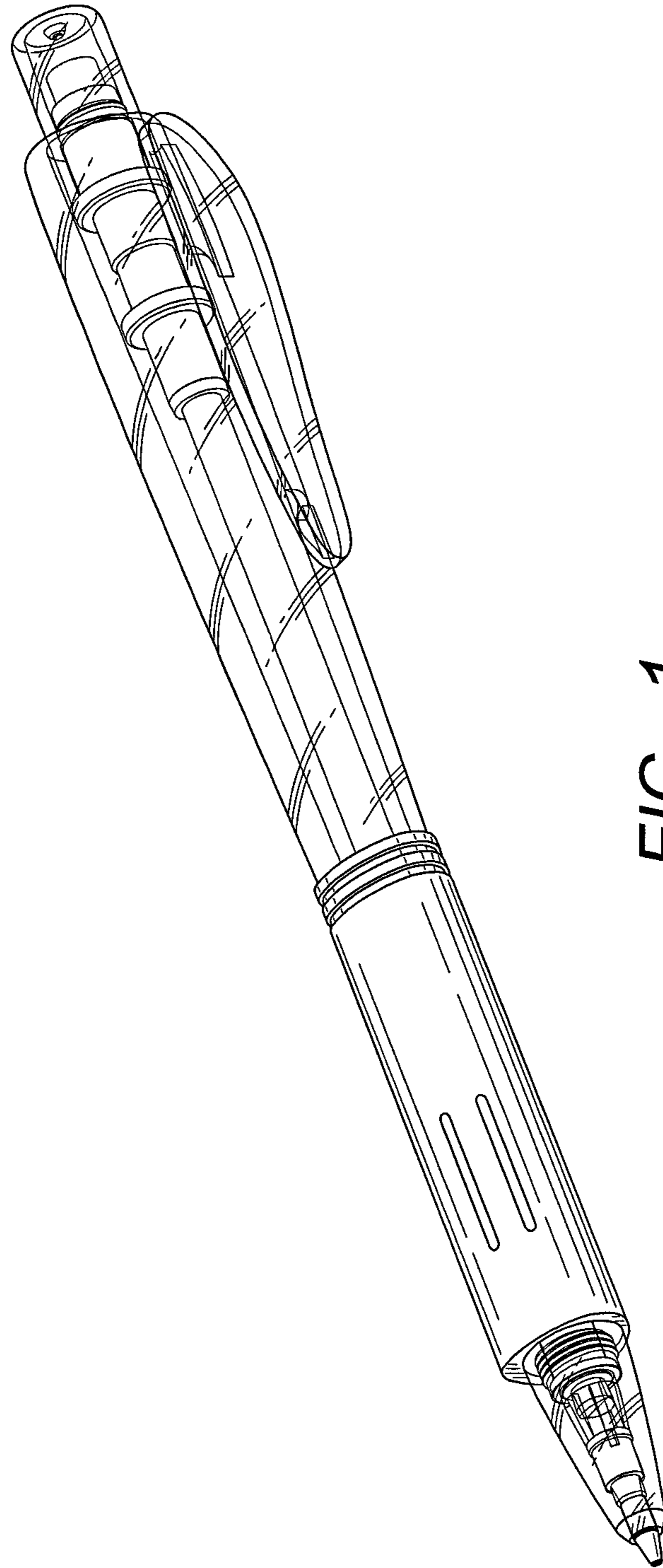

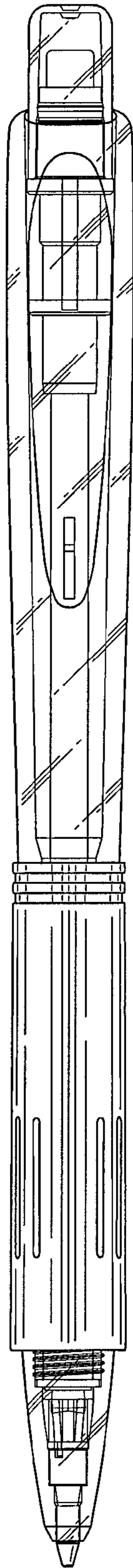

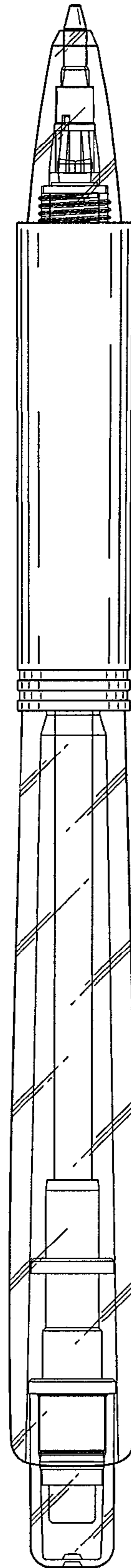

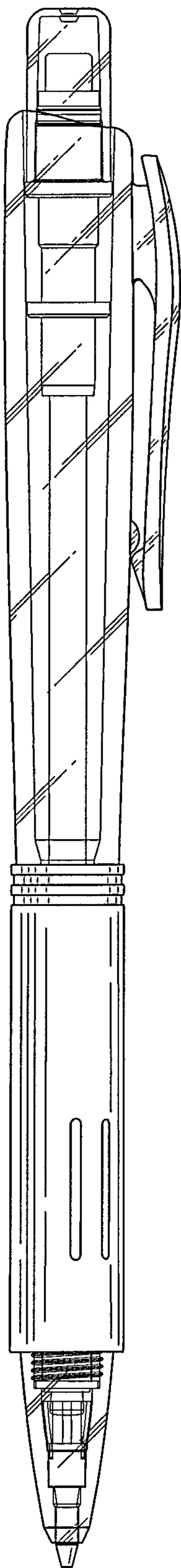

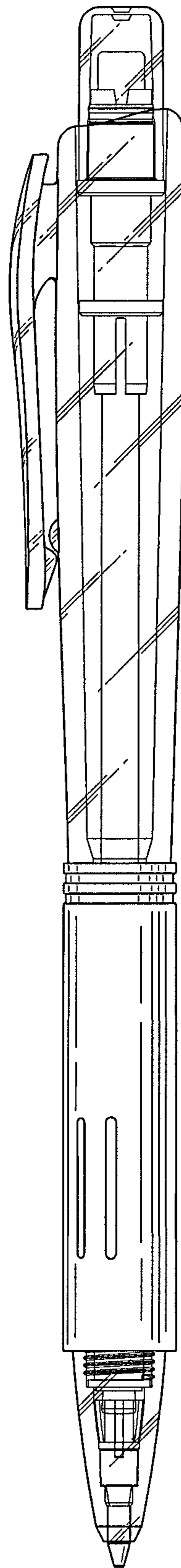

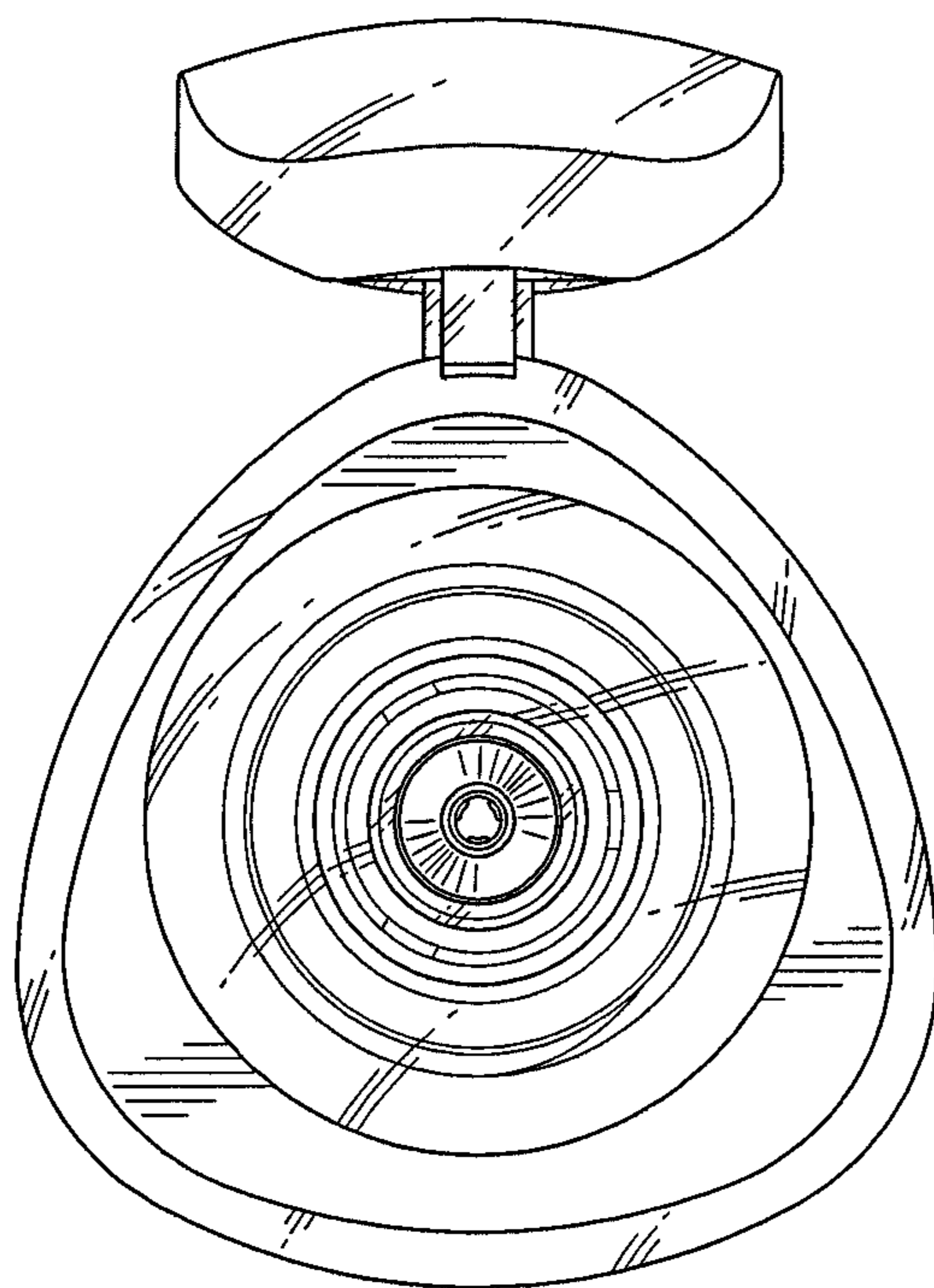

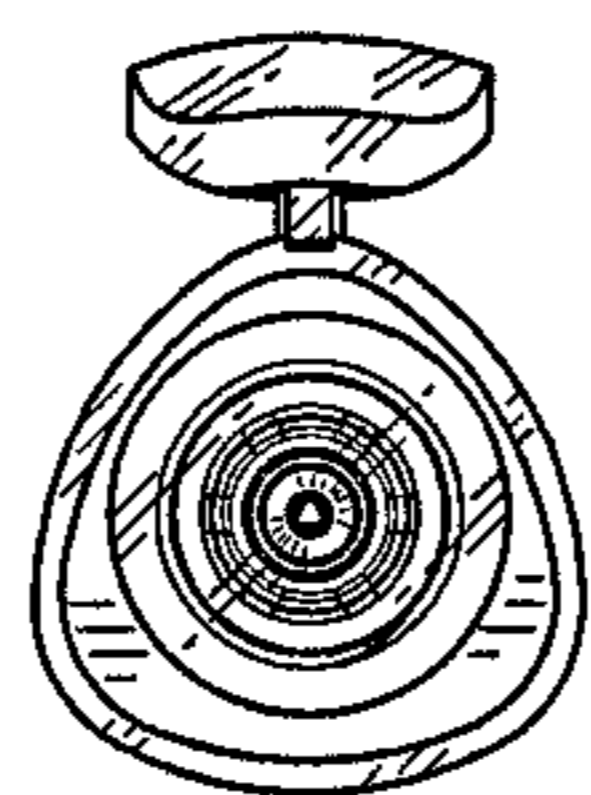

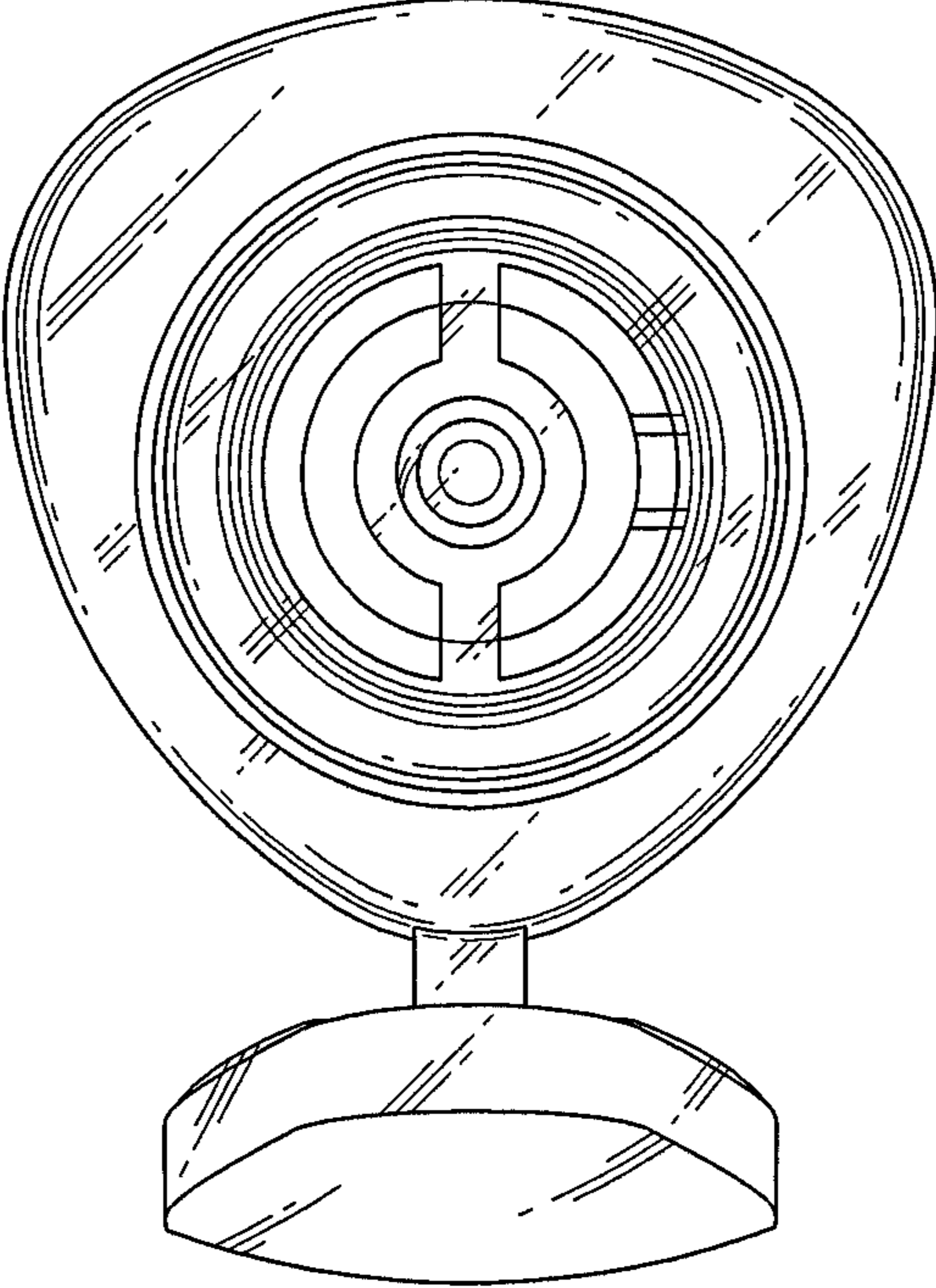

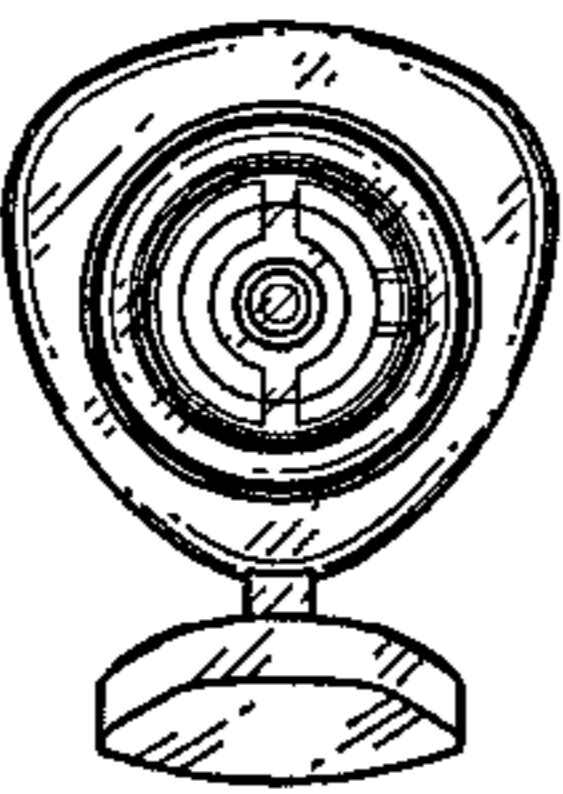

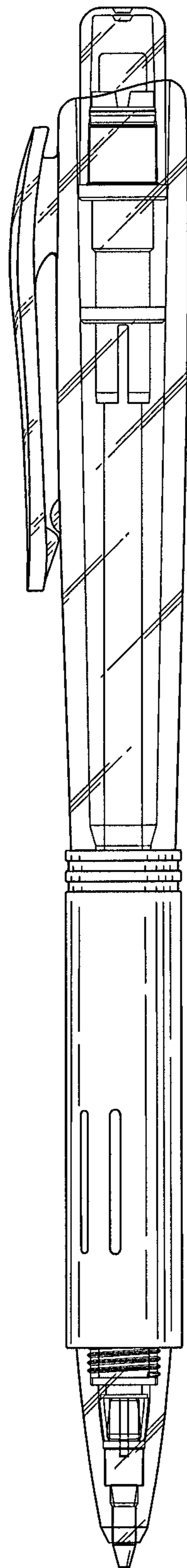
