(57) **CLAIM**

The ornamental design for a power unit attachable to a folded paper airplane, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view from below and one side of a power unit attachable to folded paper airplane showing my new design;

FIG. 2 is an perspective view of FIG. 1 taken from above and one side;

FIG. 3 is a bottom plan view drawn to a reduced scale with respect to FIGS. 1 and 2;

FIG. 4 is a side elevational view of FIG. 3;

FIG. 5 is a rear elevational view of FIG. 3;

FIG. 6 is front elevational view of FIG. 3;

FIG. 7 is a top plan view of FIG. 3;

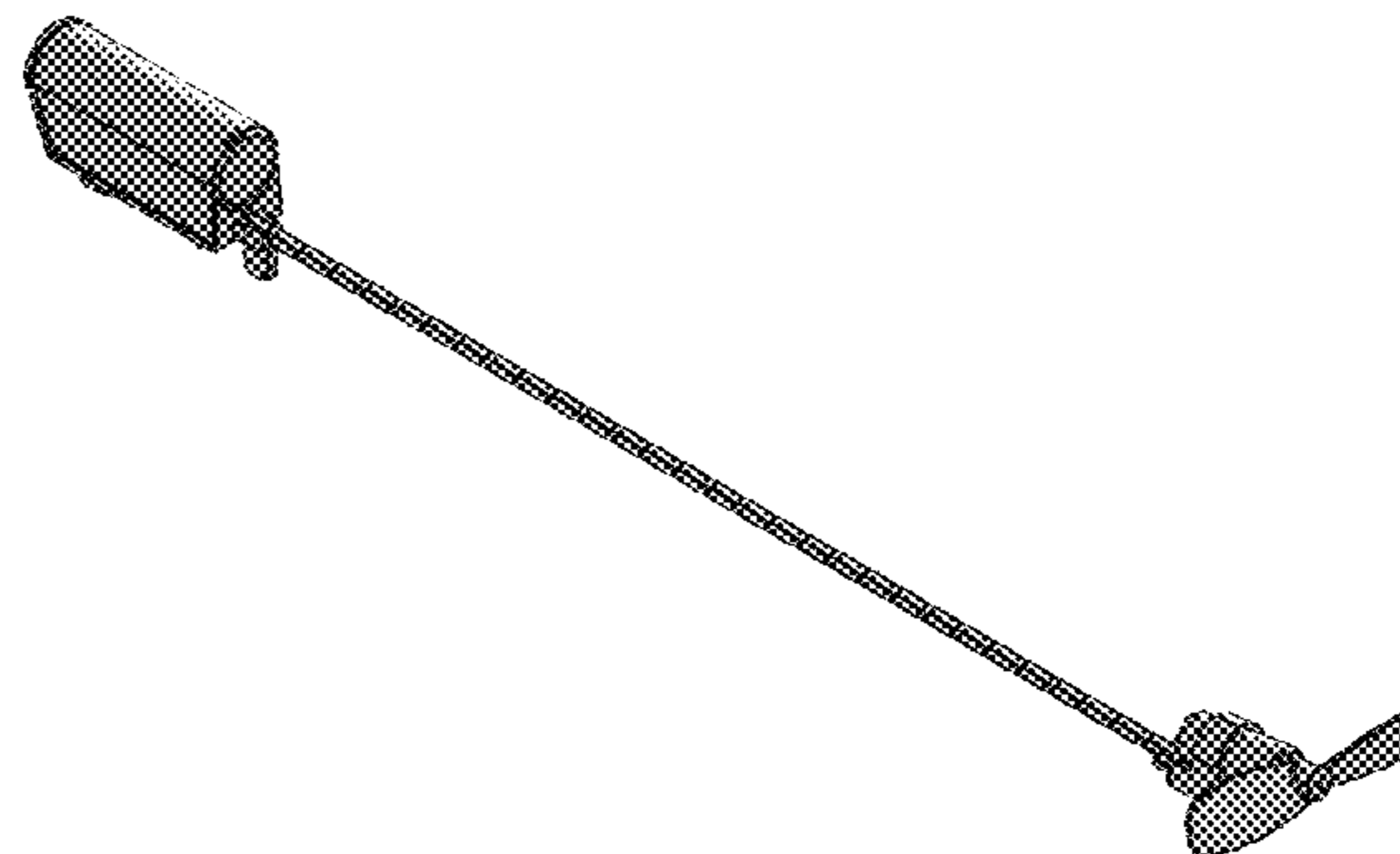
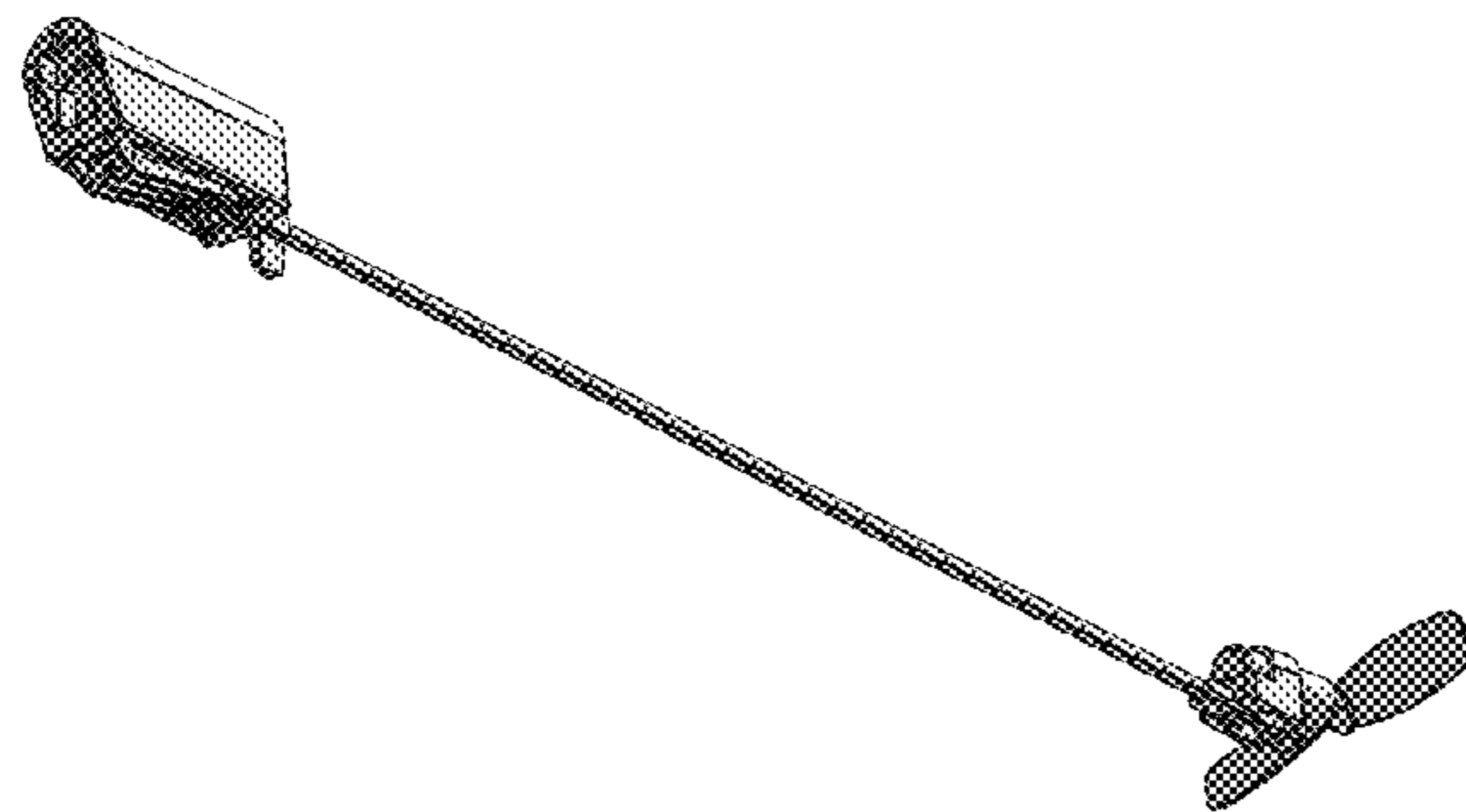
FIG. 8 is a side elevational view thereof drawn to an enlarged scale with respect to FIGS. 3 through 7;

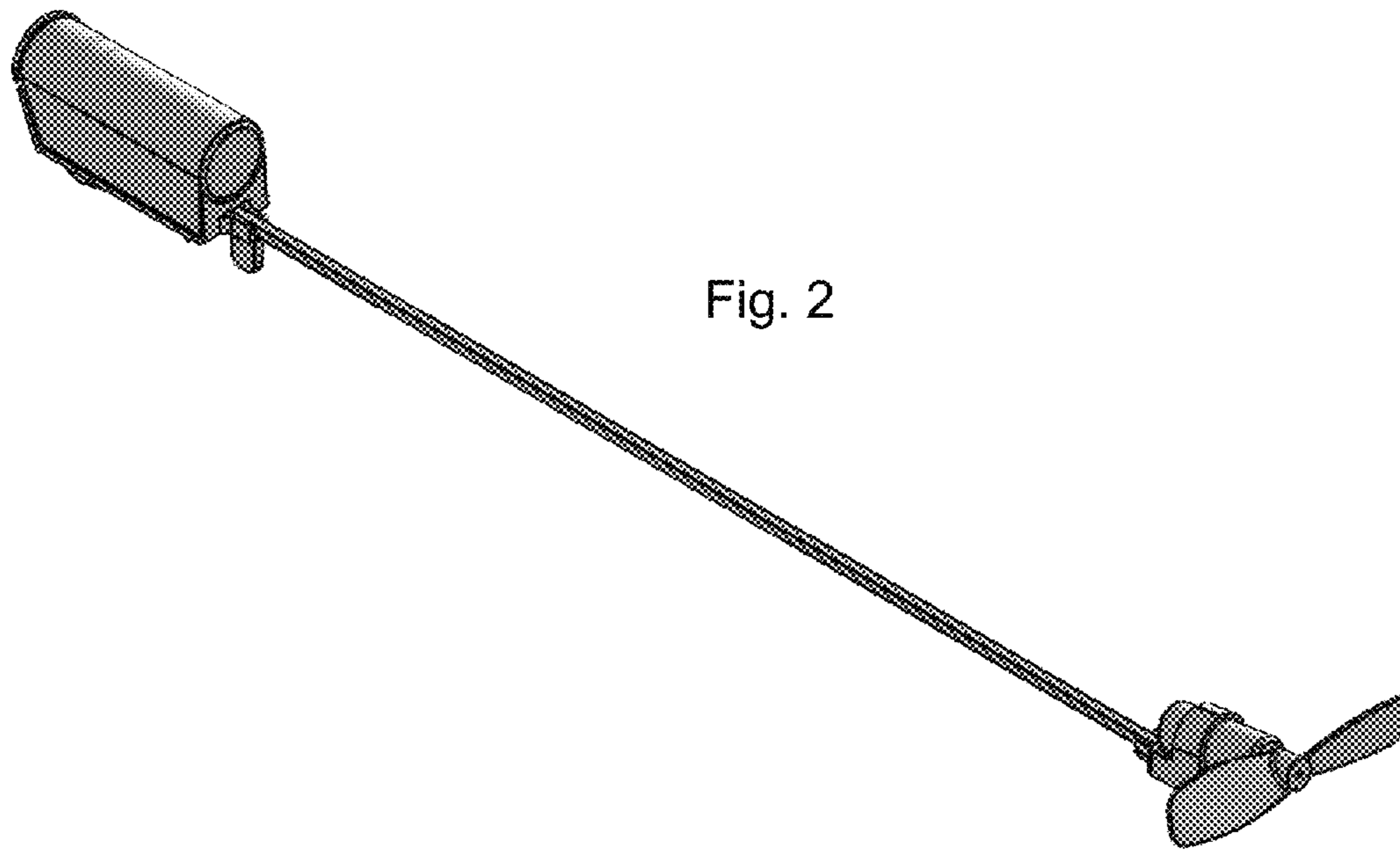
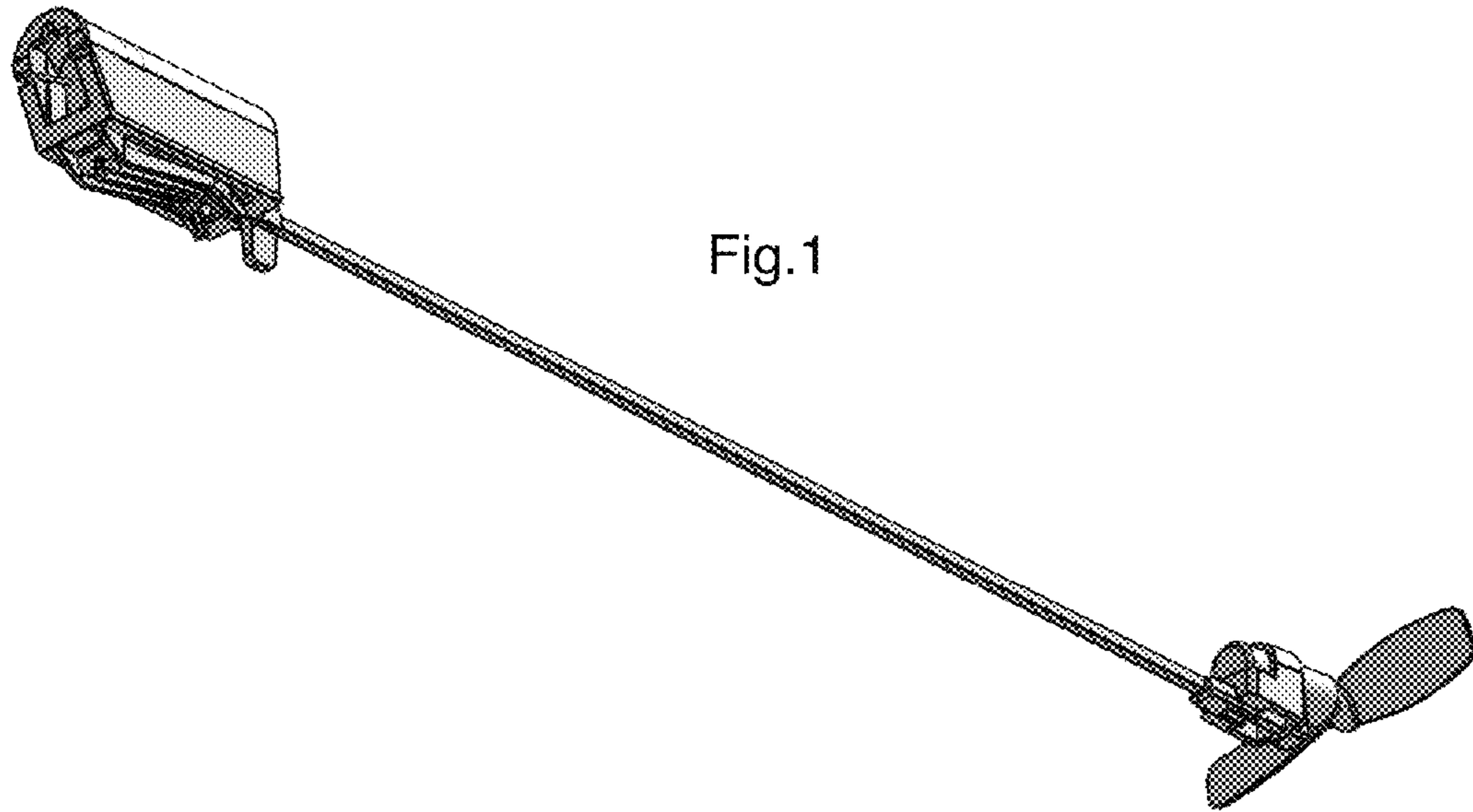
FIG. 9 is a side elevational view of the side opposite that shown in FIG. 8; and,

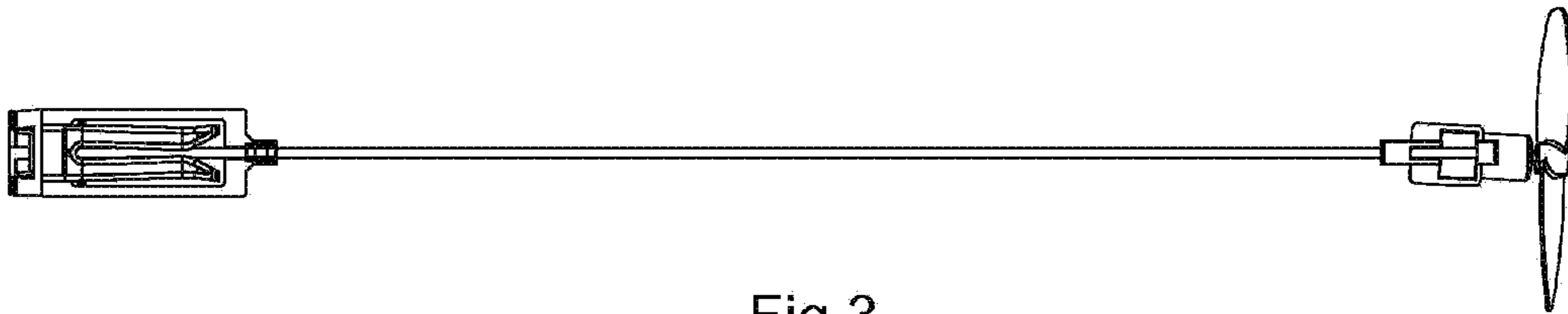

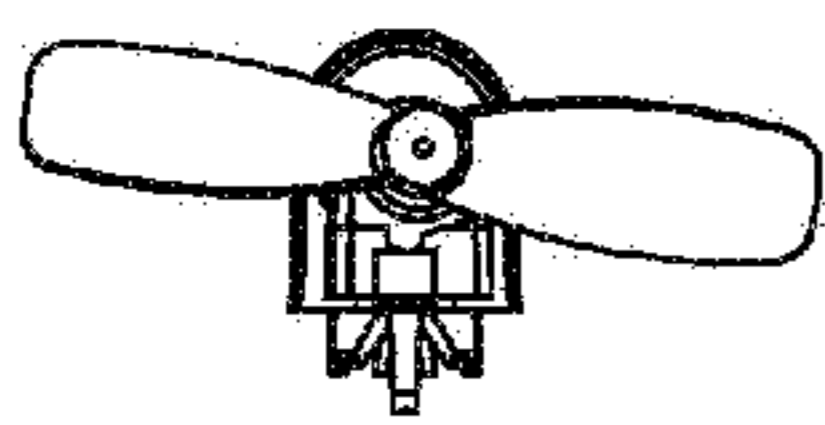

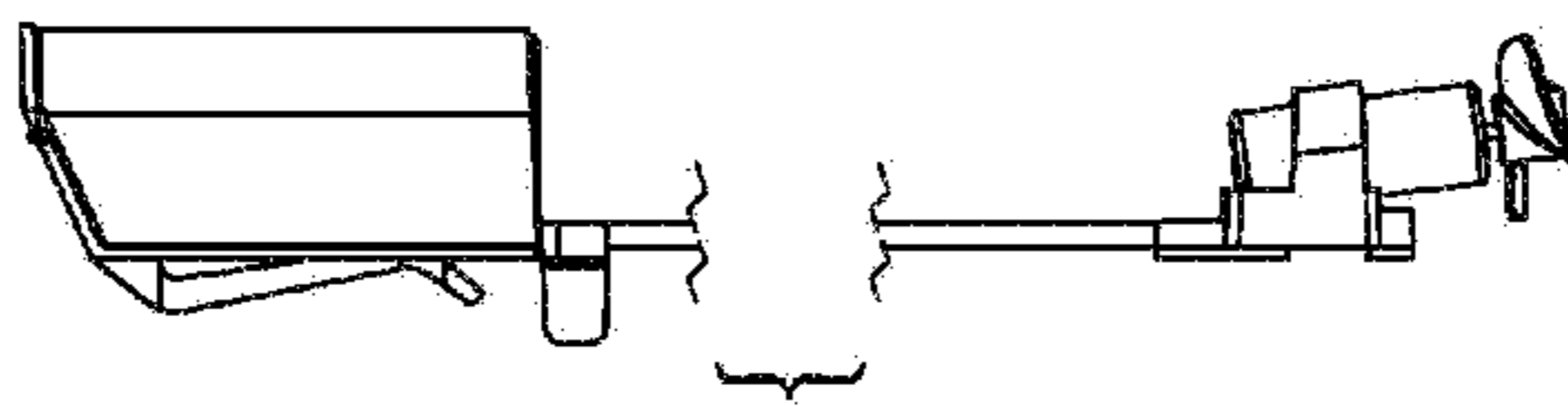

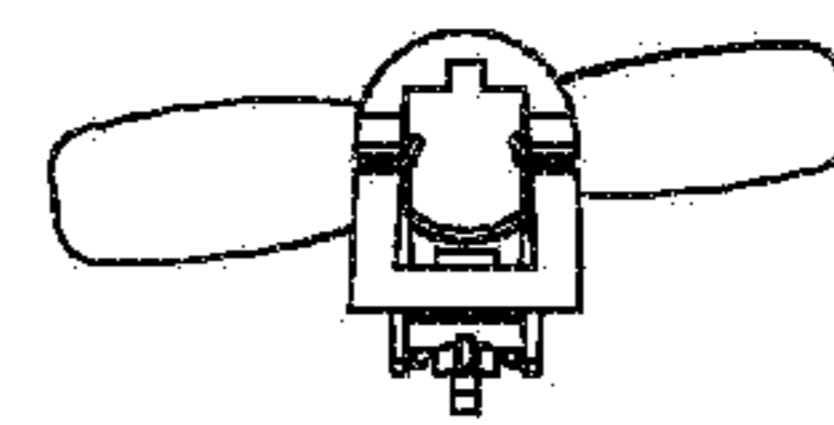

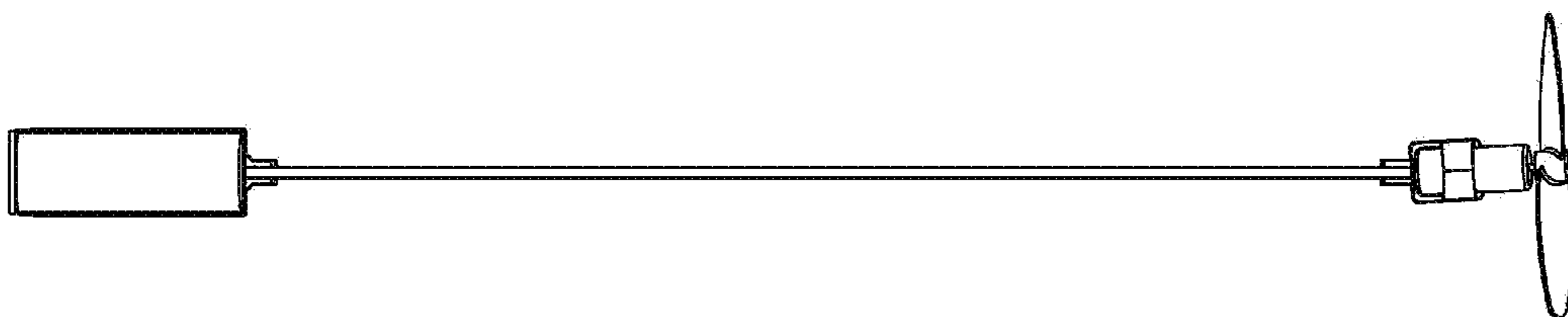

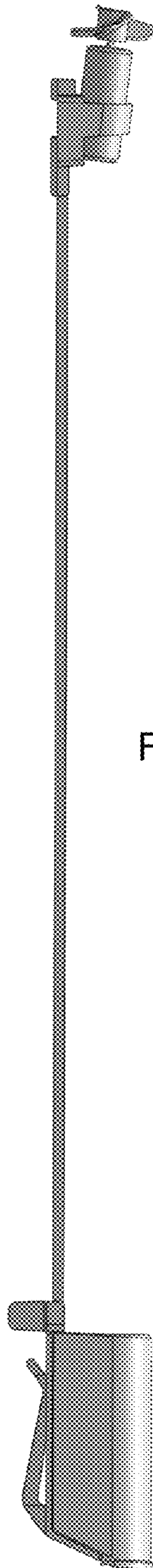

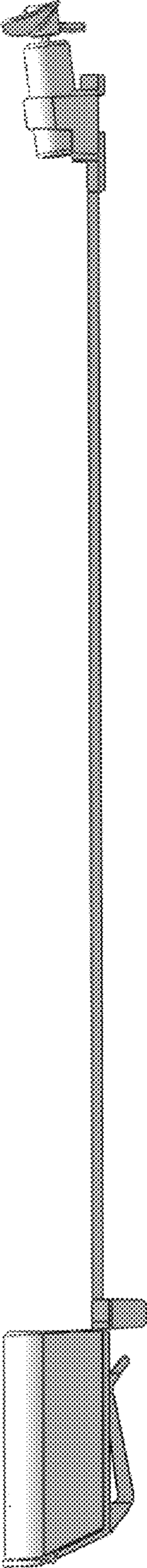

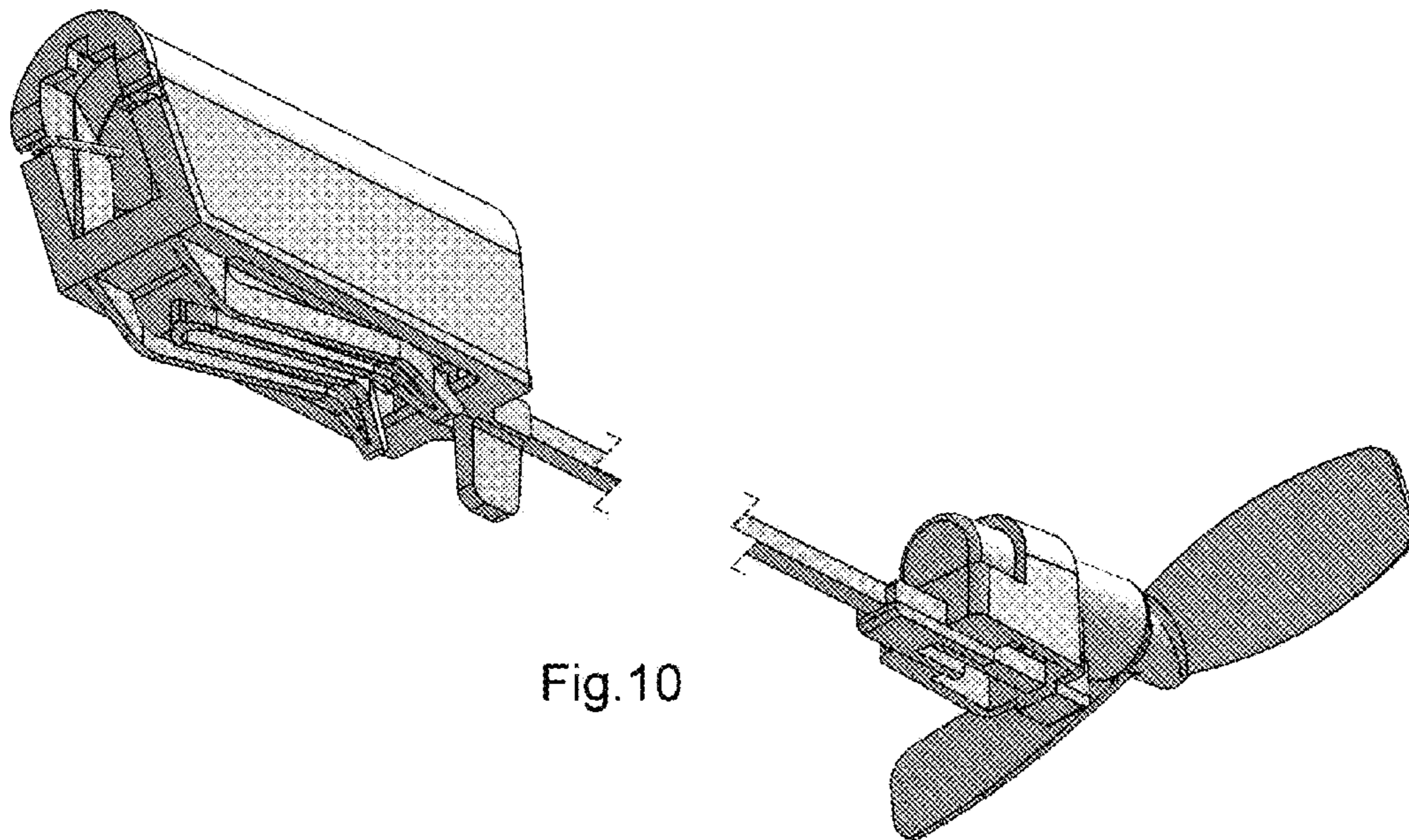
