FIG. 3 shows a bottom view of the same, with the broken line illustrating portions of the article and forming no part of the claimed design; and,

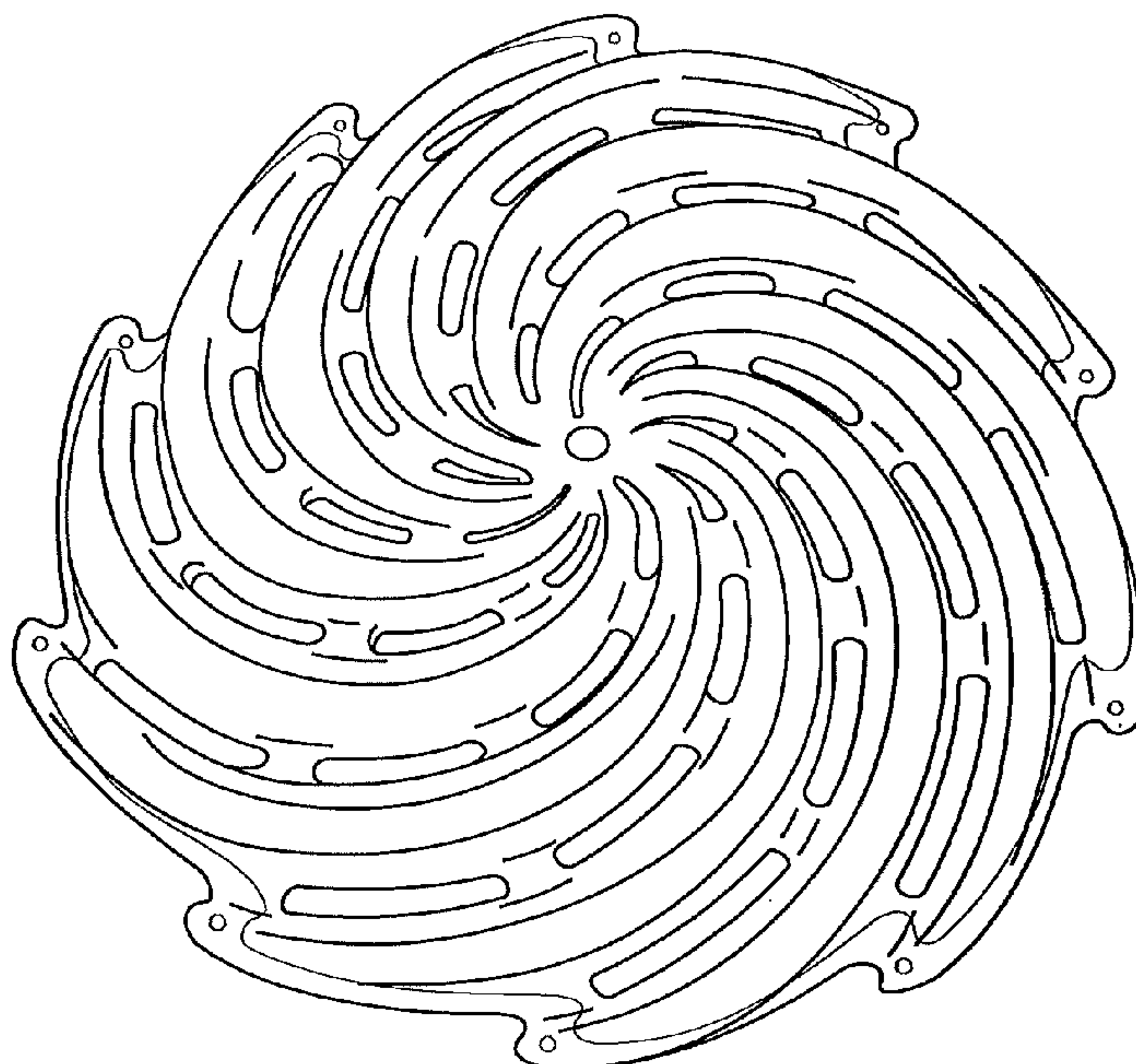
FIG. 4 shows a side view of the same.

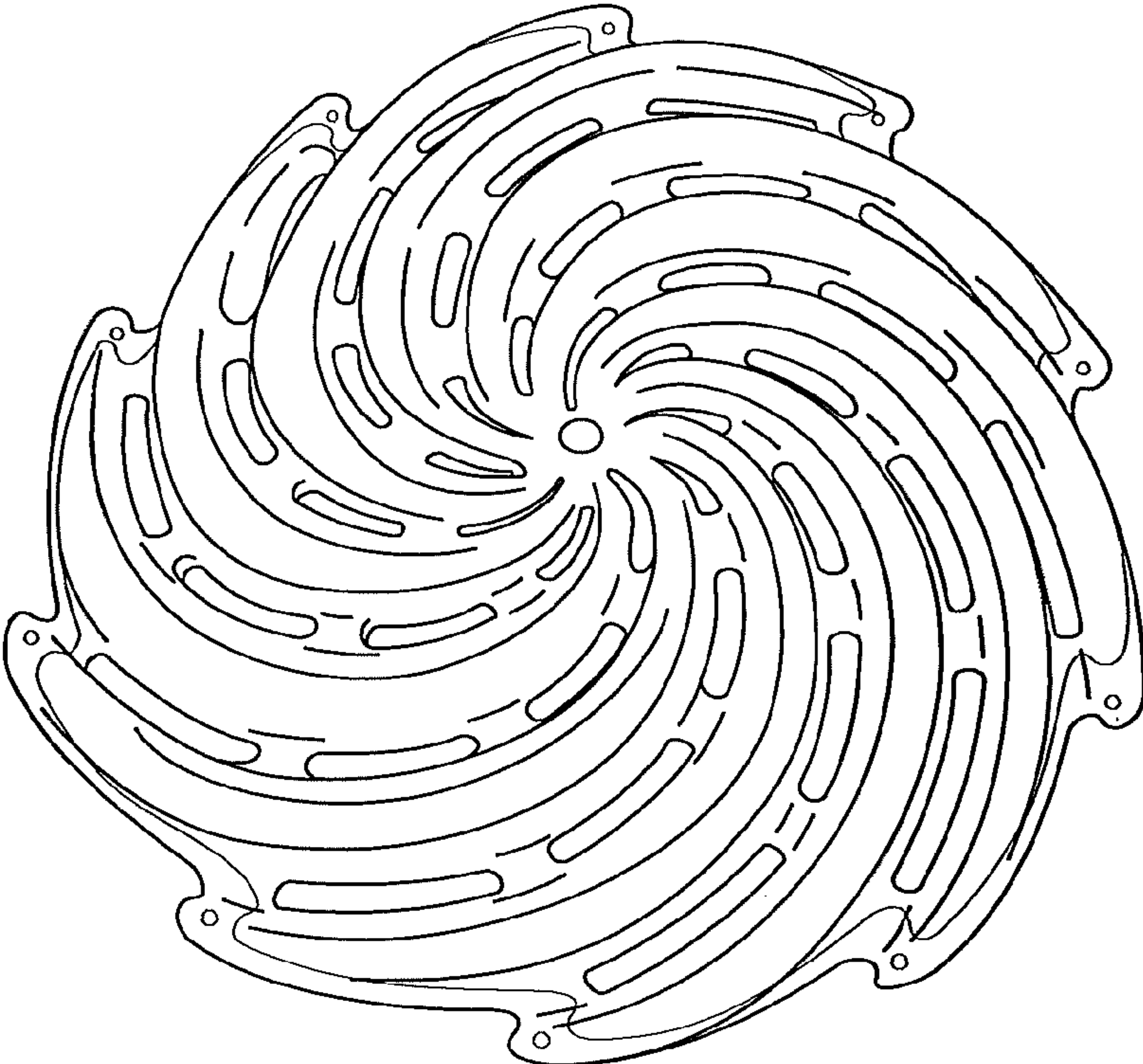

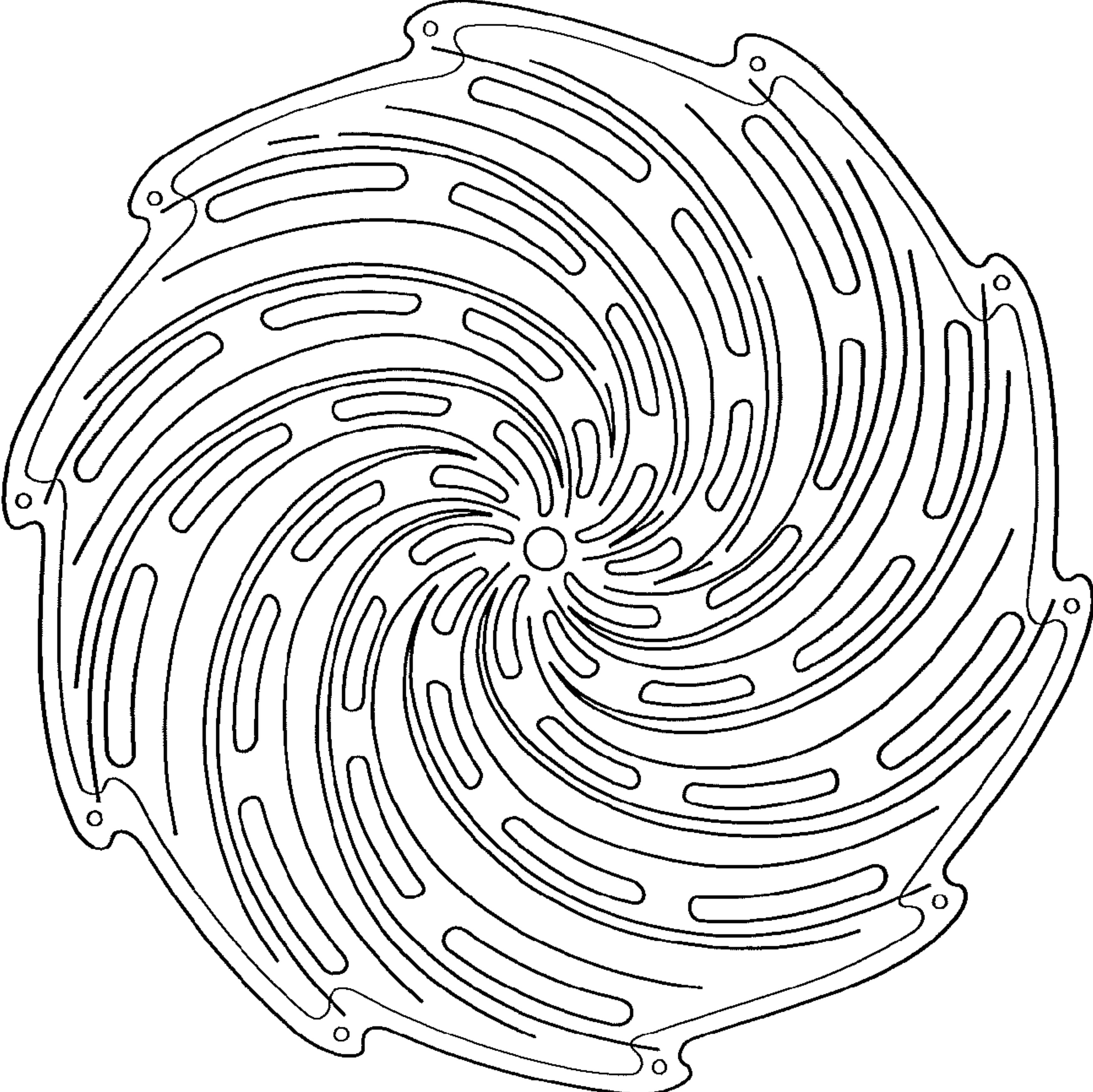

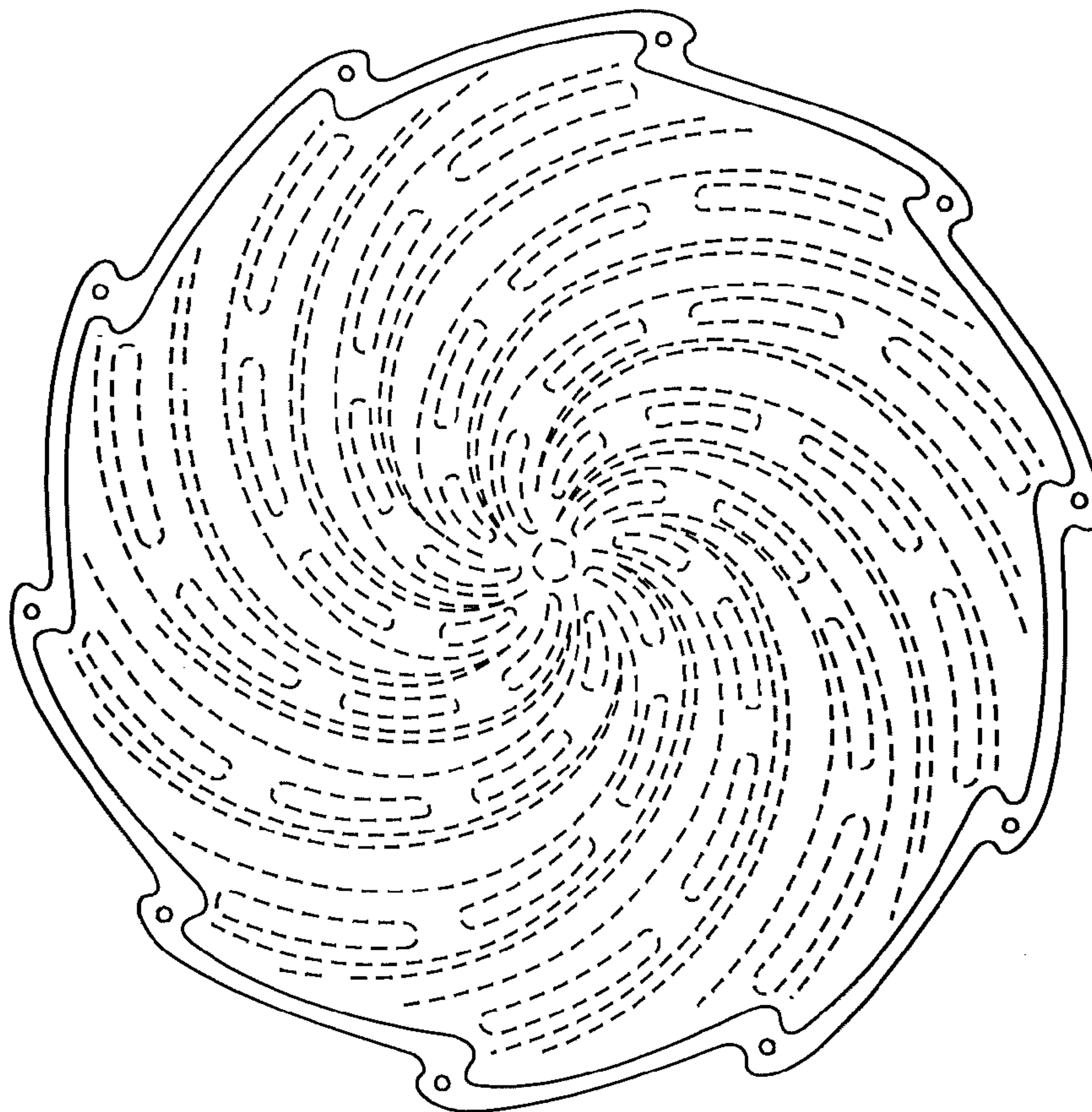

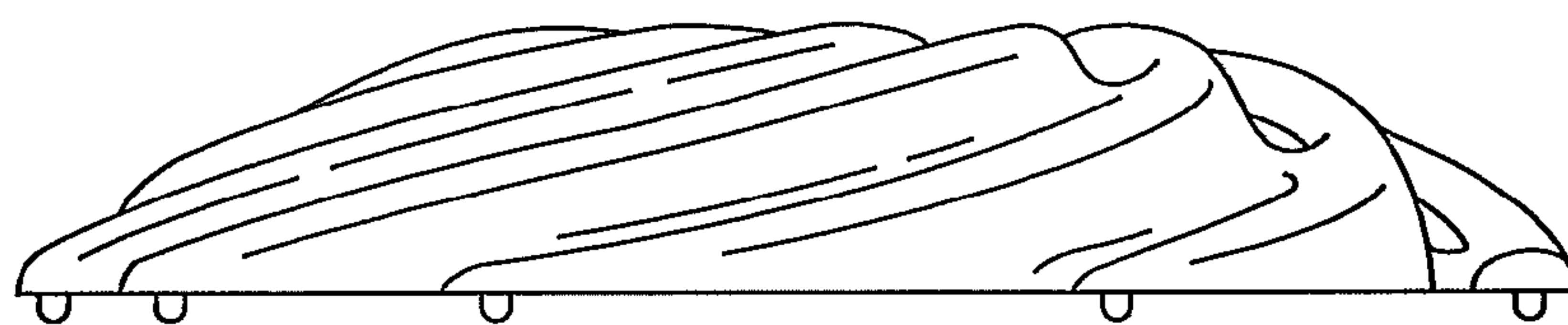
