(57) **CLAIM**

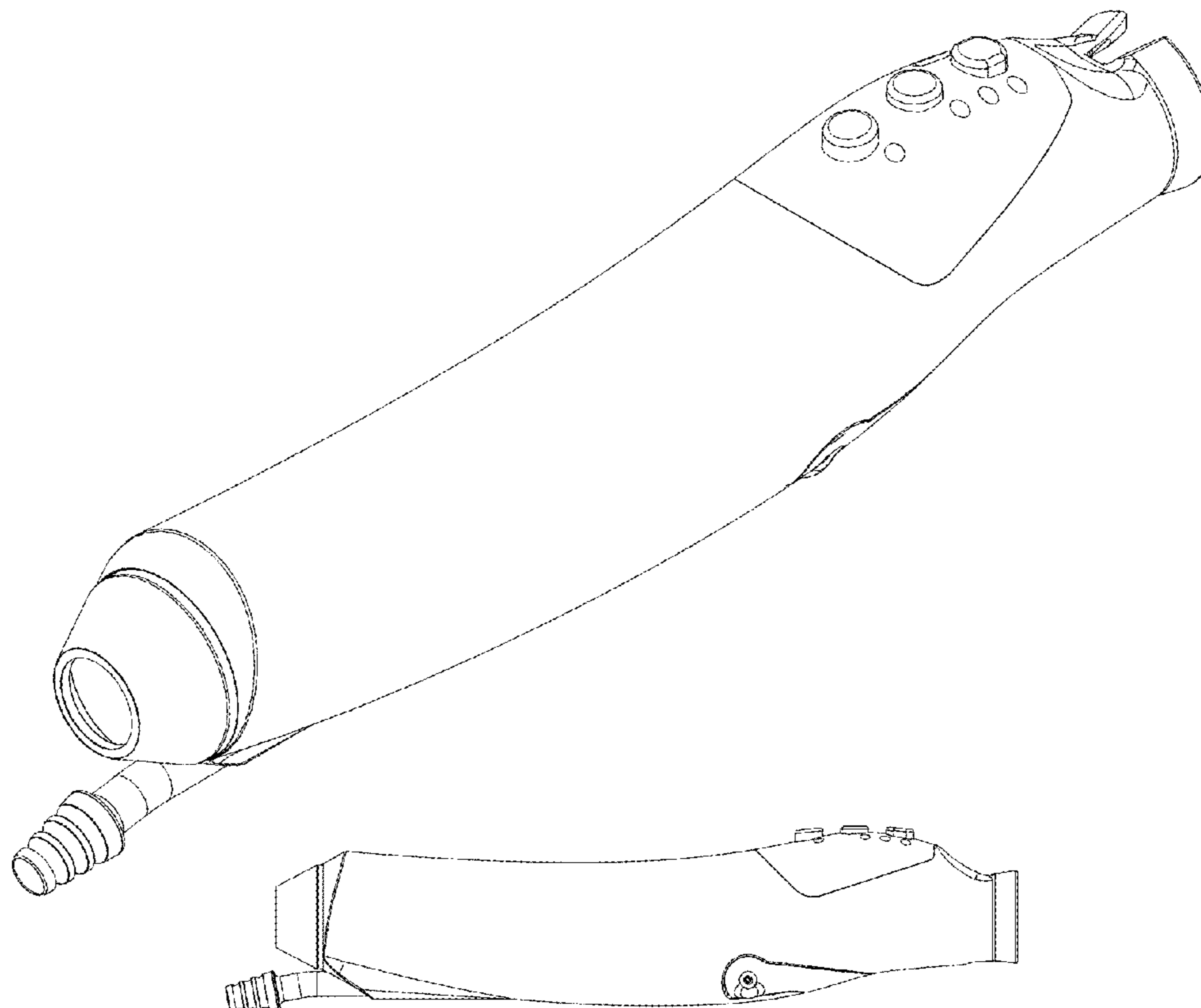
The ornamental design for a surgical handpiece, substantially as shown.

**DESCRIPTION**

FIG. 1 is a perspective view of the surgical handpiece; FIG. 2 is a top view of the surgical handpiece; FIG. 3 is a side elevation of the surgical handpiece; FIG. 4 is a bottom view of the surgical handpiece; FIG. 5 is a front elevation of the surgical handpiece; FIG. 6 is a rear elevation of the surgical handpiece; FIG. 7 is a bottom right perspective view of the surgical handpiece; and, FIG. 8 is a bottom left perspective view of the surgical handpiece.

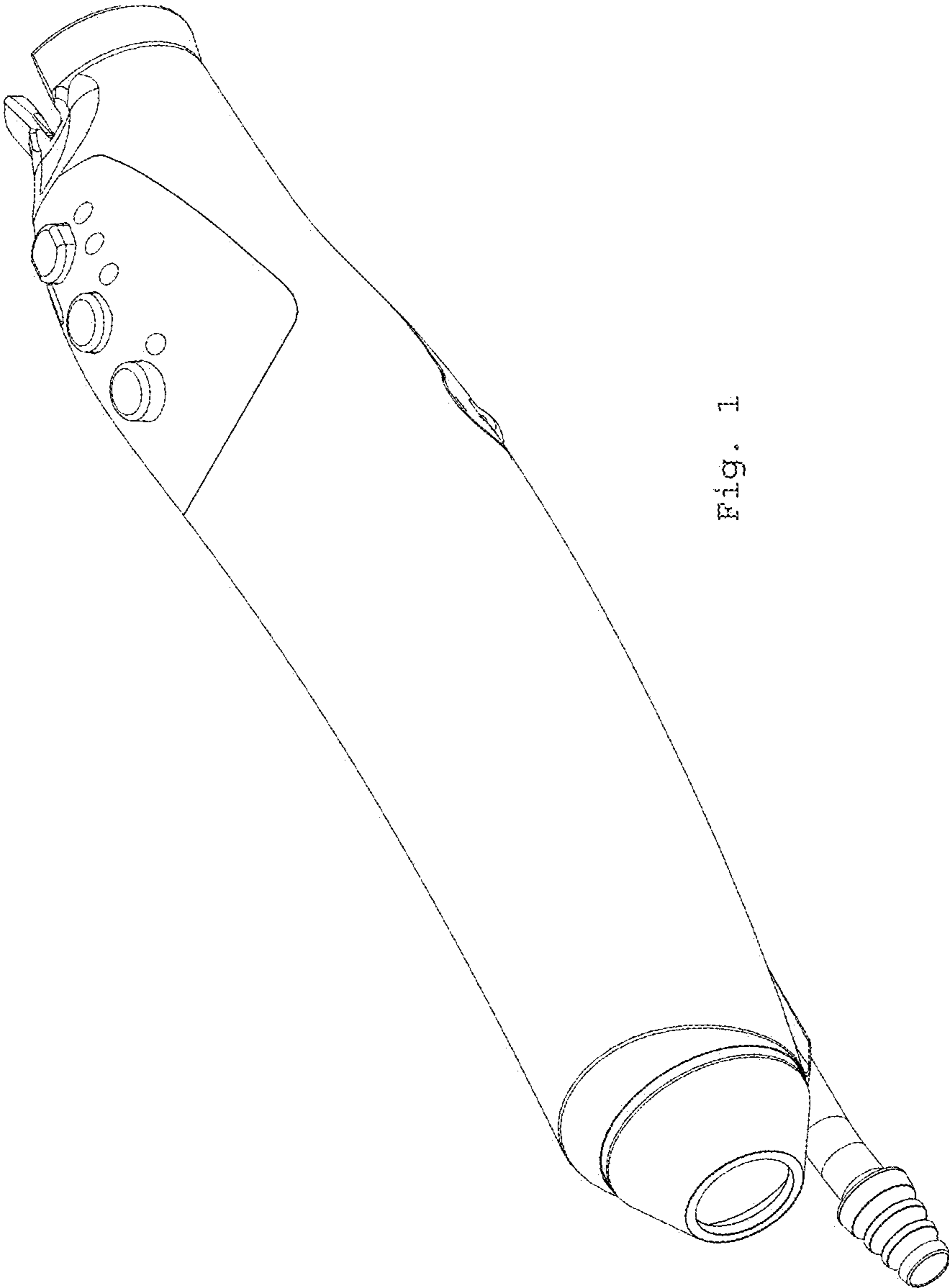

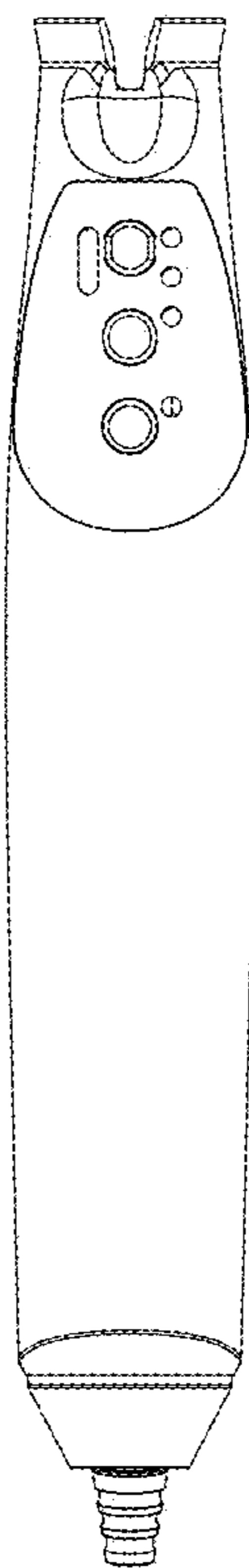

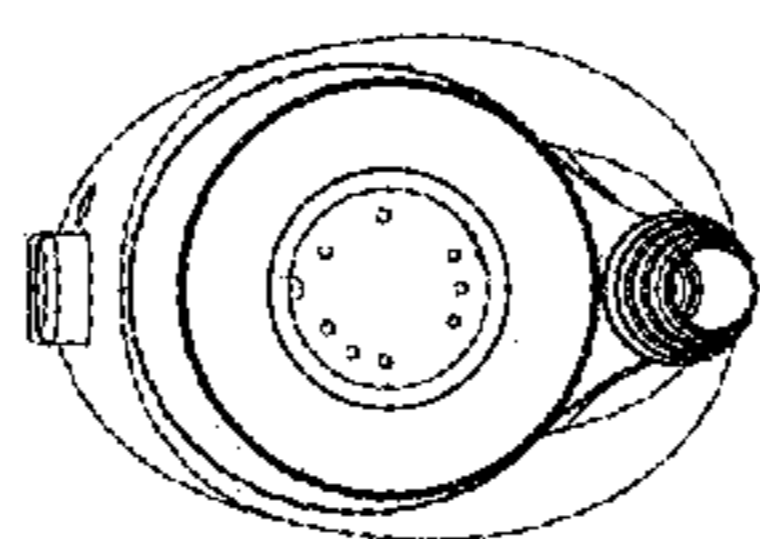

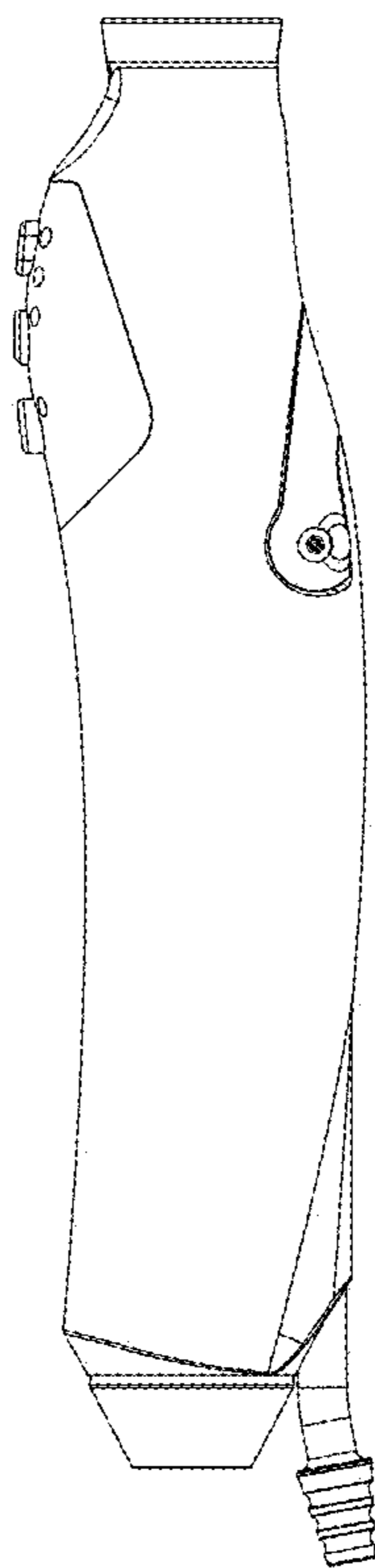

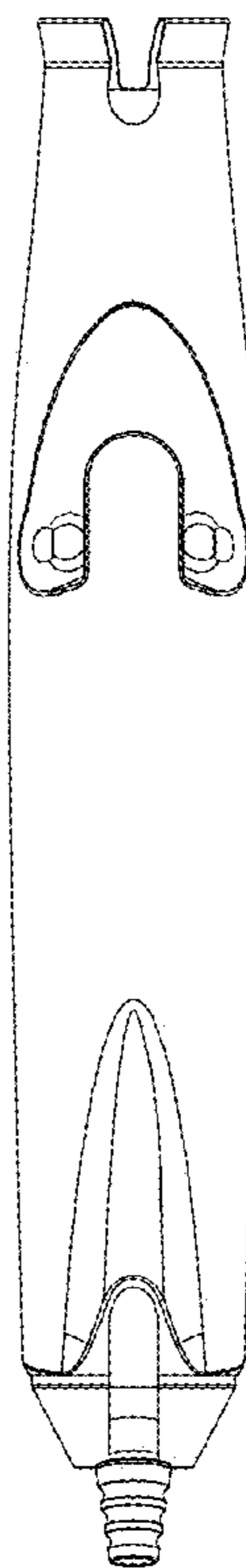

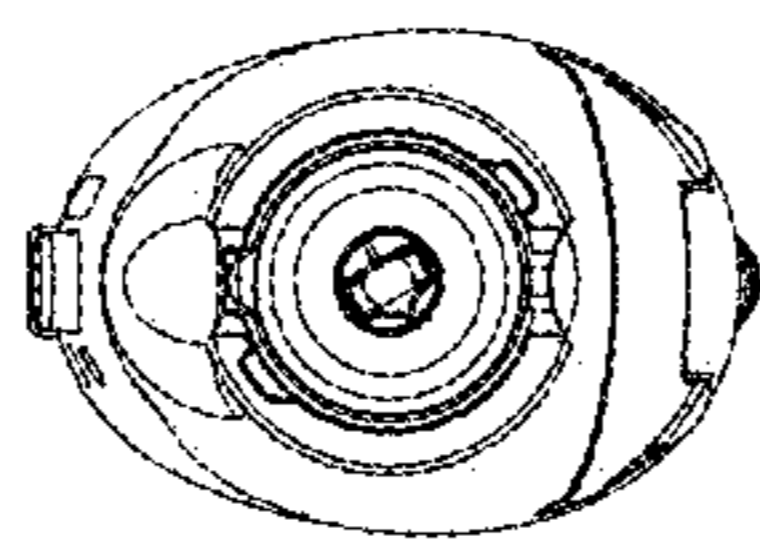

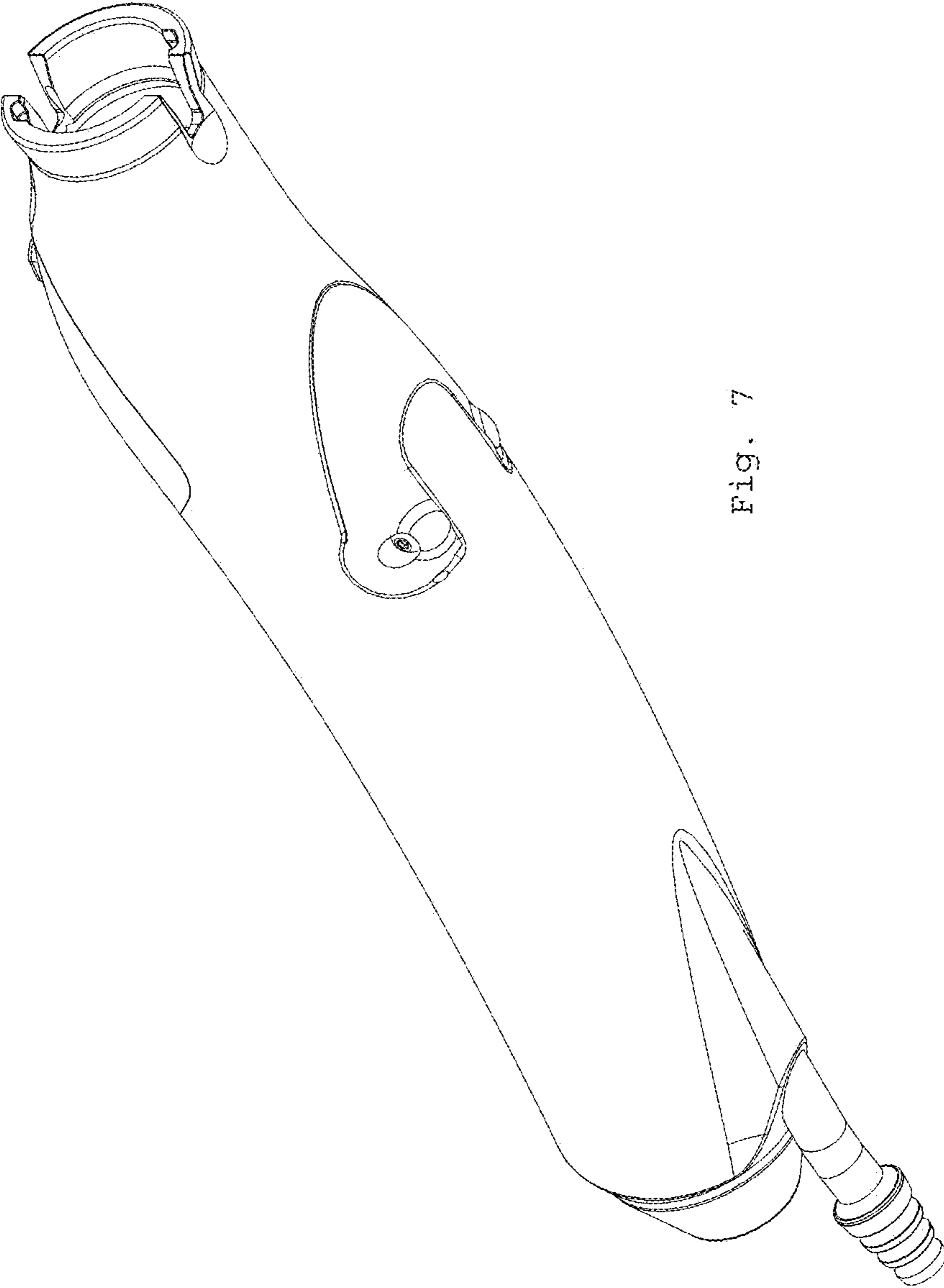

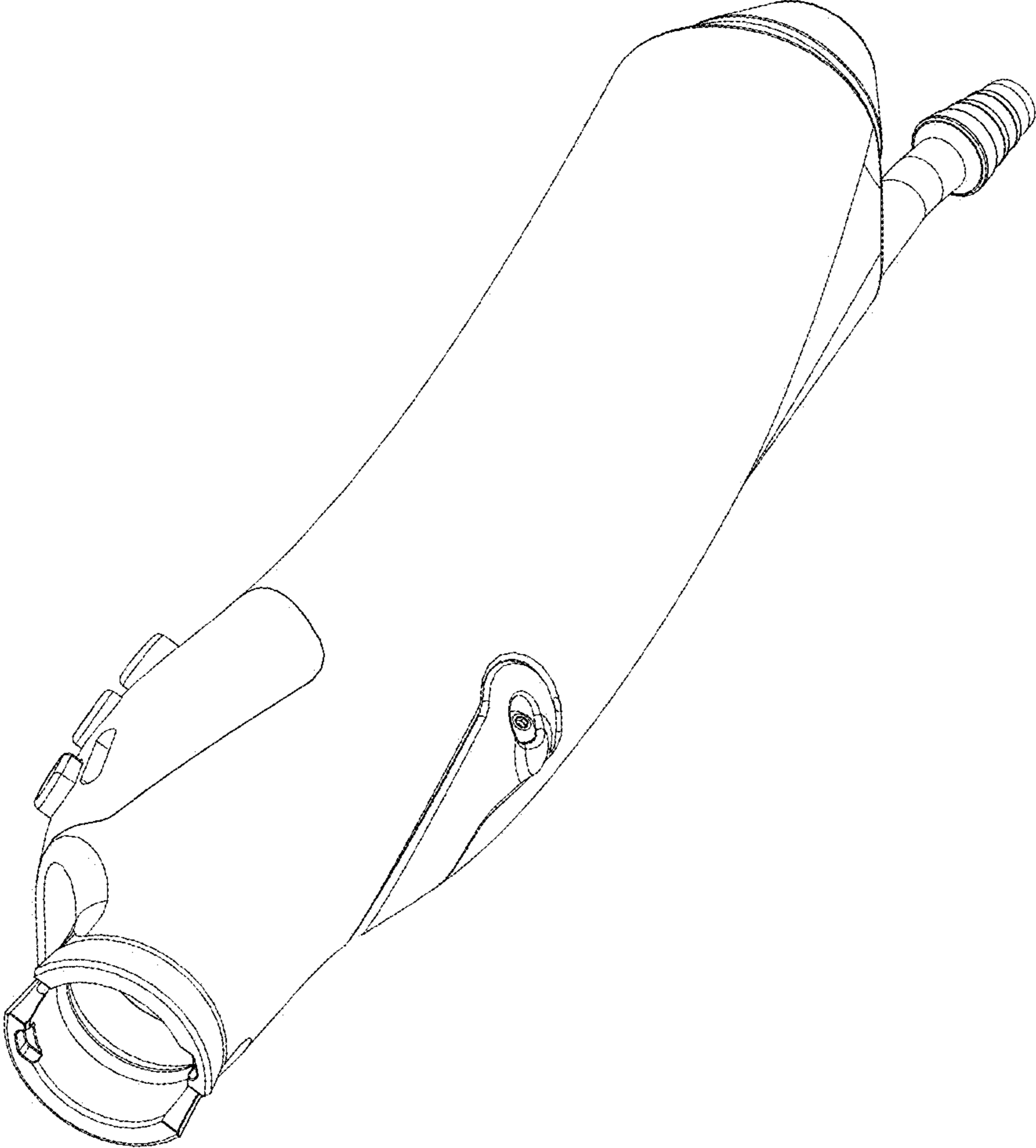
