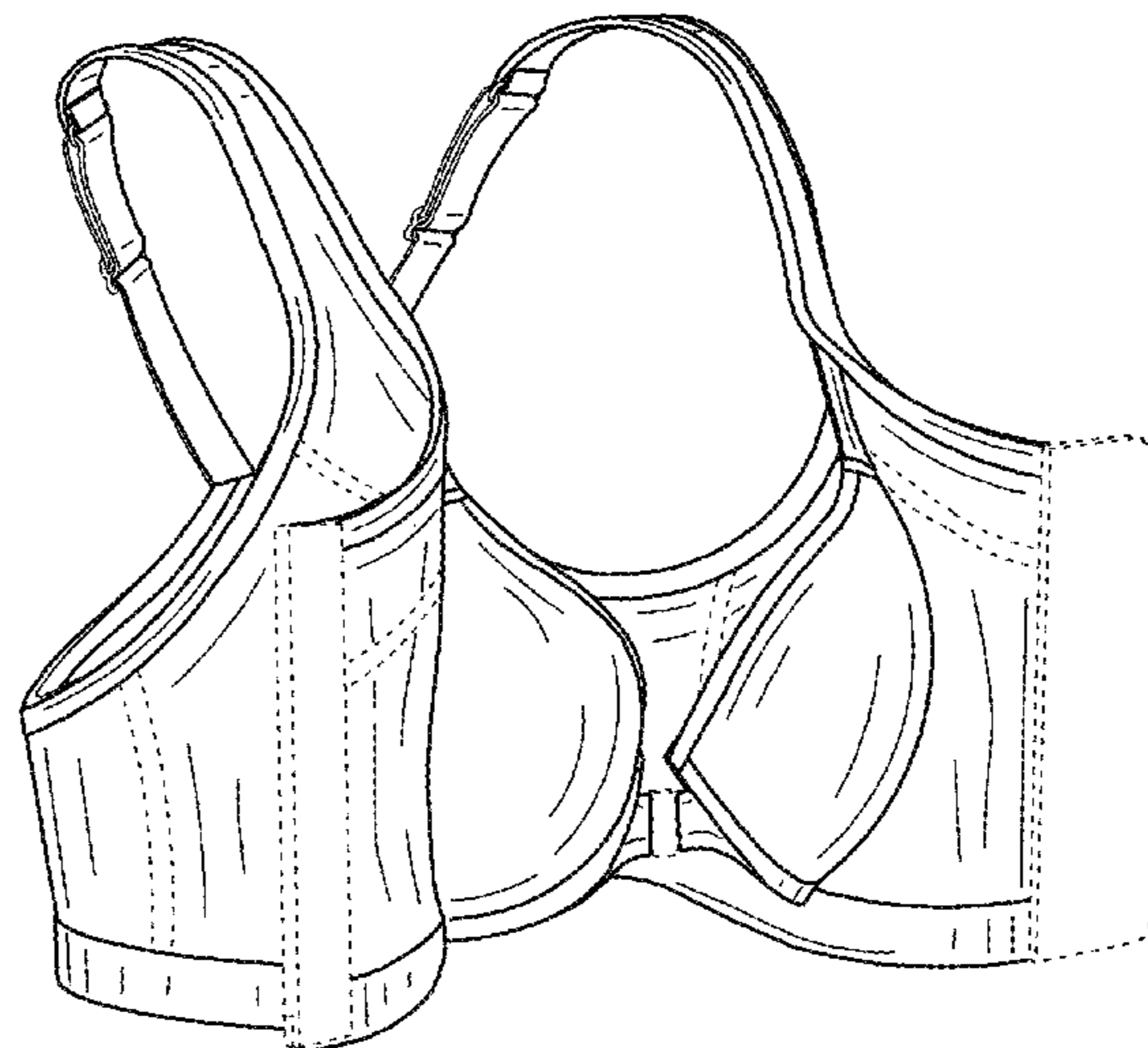
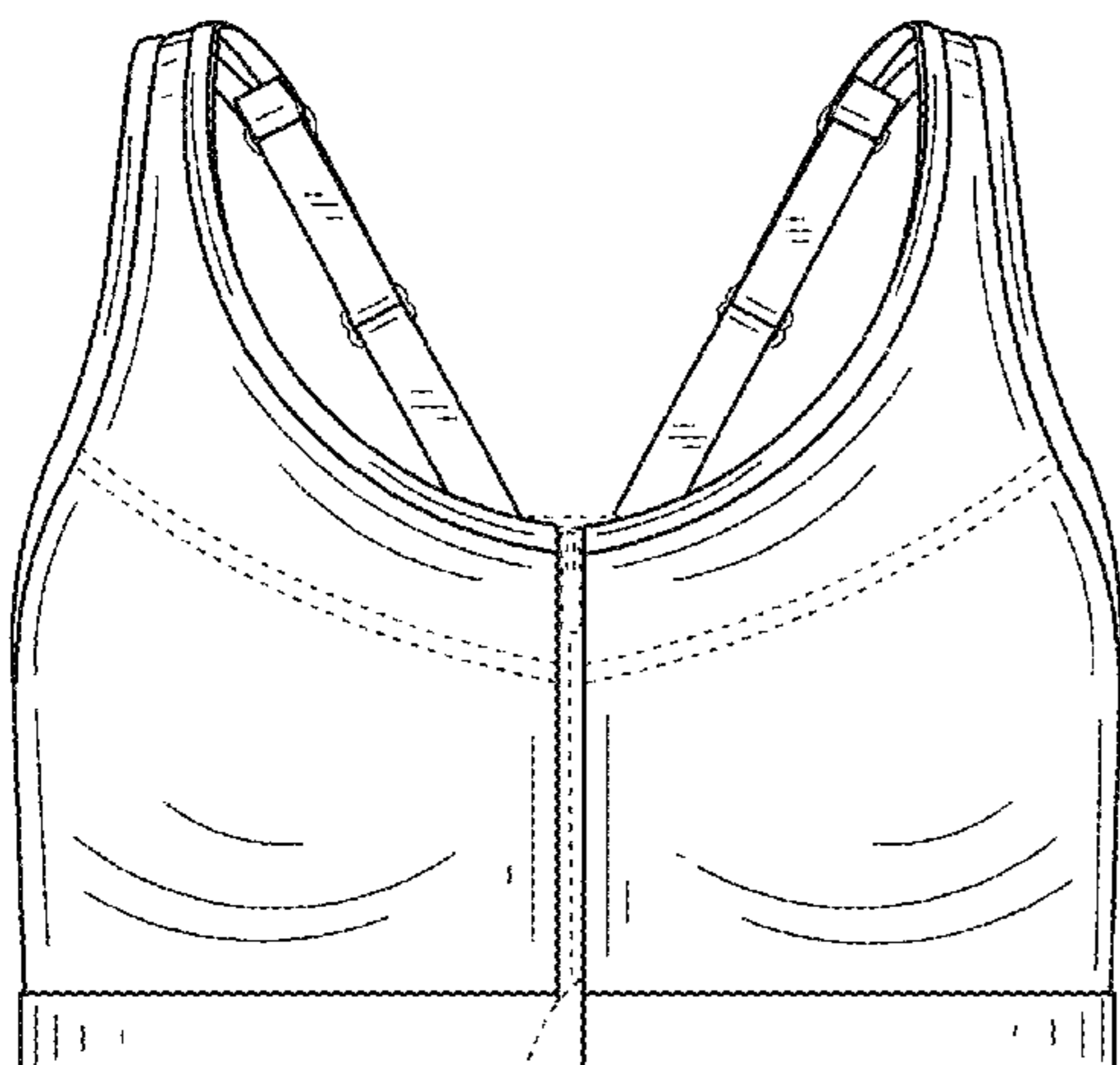
The ornamental design for a brassiere, as shown and described.

**DESCRIPTION**

FIG. 1 is a left side perspective view of an embodiment of a brassiere;  
 FIG. 2 is a front elevation view thereof;  
 FIG. 3 is a rear elevation view thereof;  
 FIG. 4 is a left side elevation view thereof;  
 FIG. 5 is a right side elevation view thereof;  
 FIG. 6 is a top plan view thereof;  
 FIG. 7 is a bottom plan view thereof;  
 FIG. 8 is a left side perspective view of the brassiere of FIGS. 1-7 shown in an alternate position;  
 FIG. 9 is a front elevation view thereof in the alternate position; and,  
 FIG. 10 is a rear elevation view thereof in the alternate position.

The broken line showings of stitching, a zipper, cloth flaps behind and at the bottom of the zipper, and a clasp in FIGS. 1-10 are for the purpose of illustrating portions of the brassiere that form no part of the claimed design.

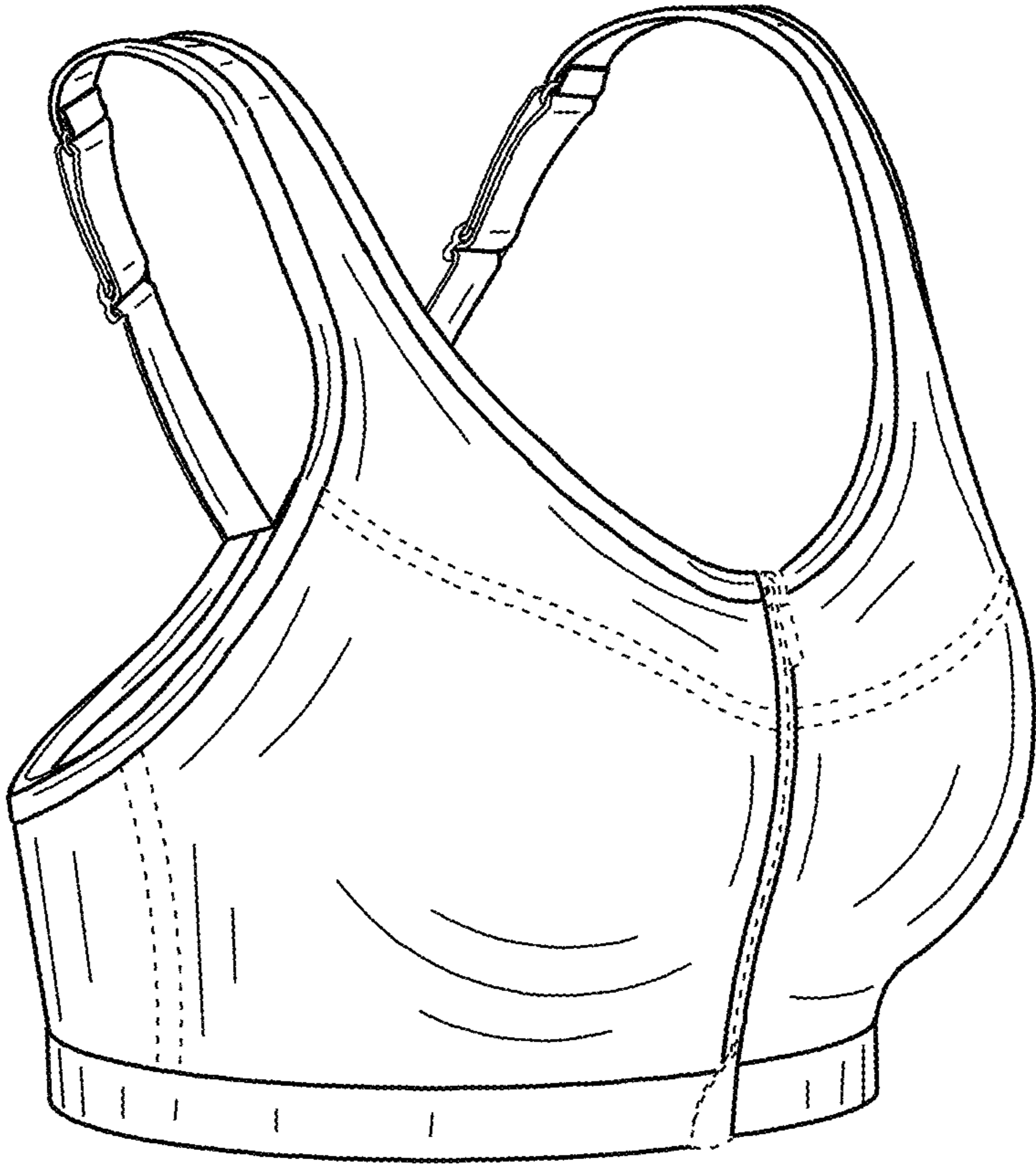

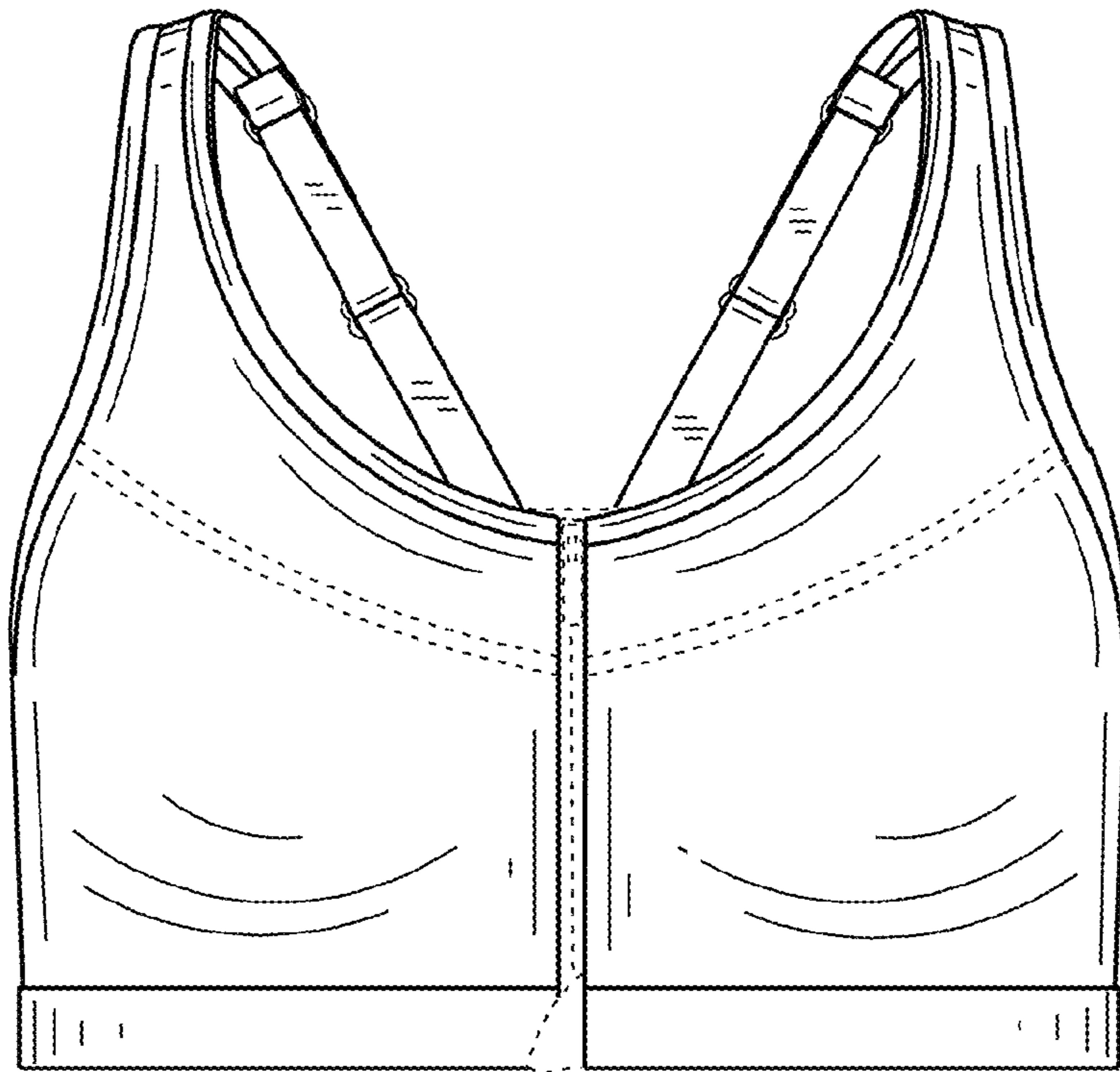

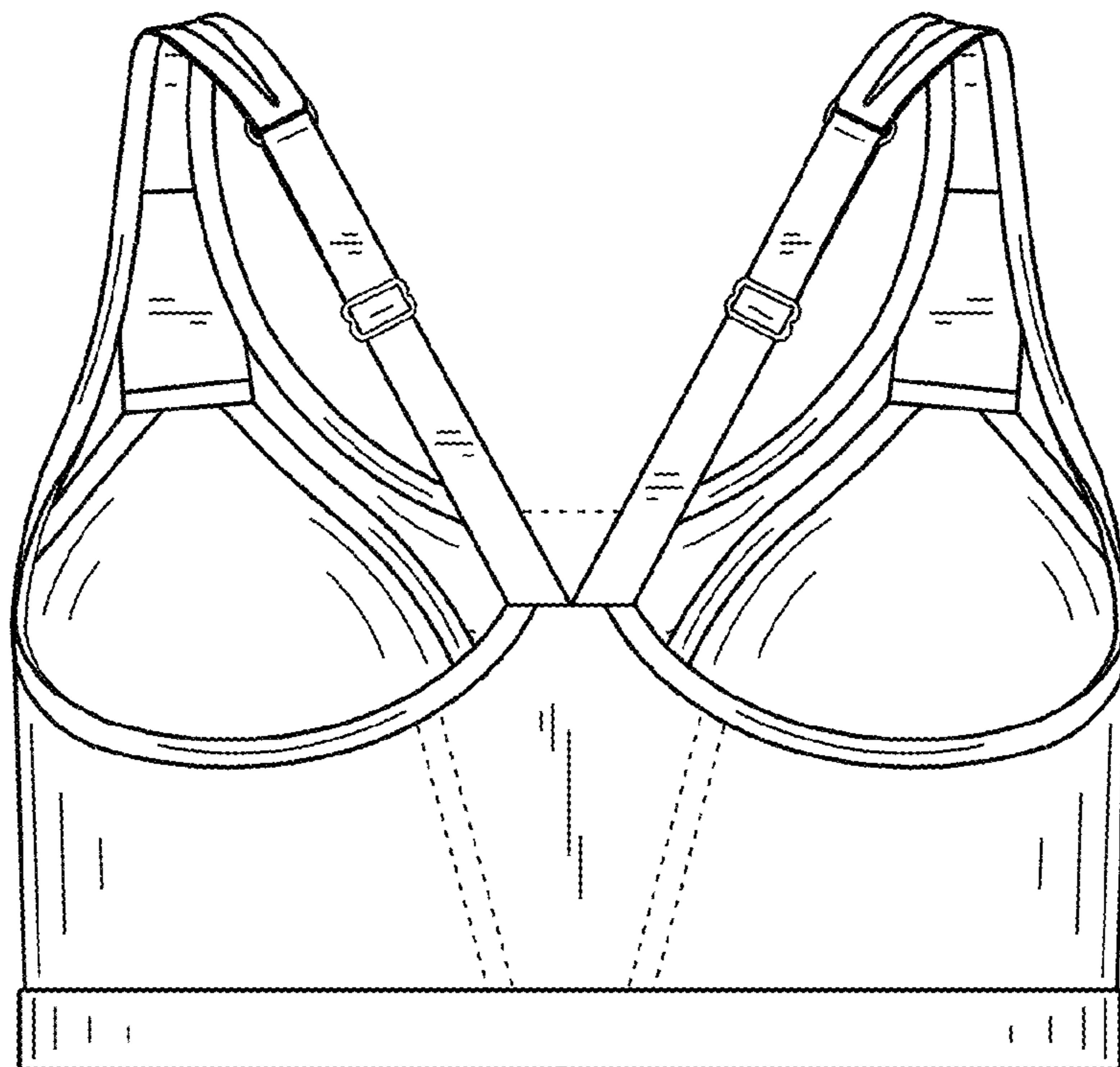

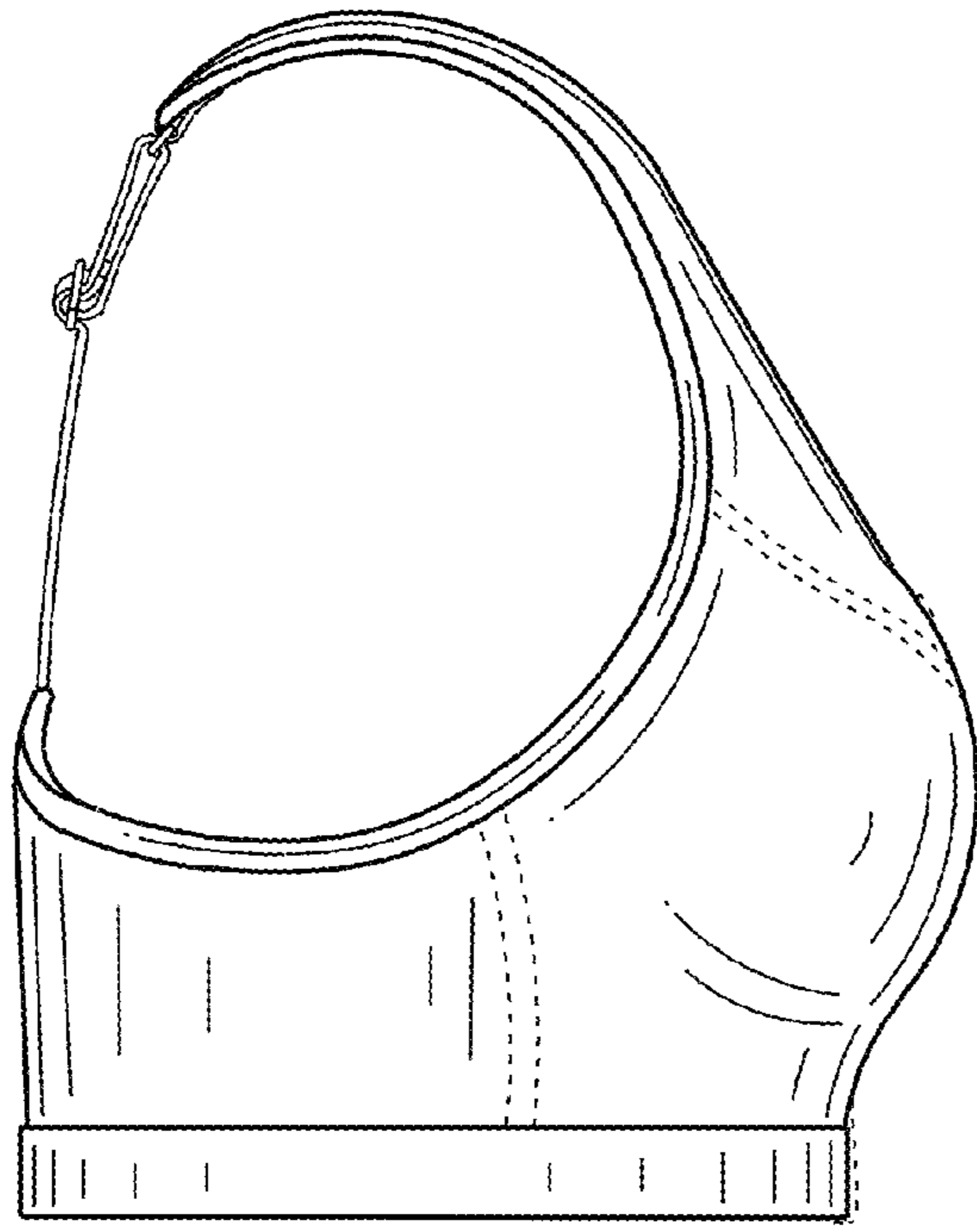

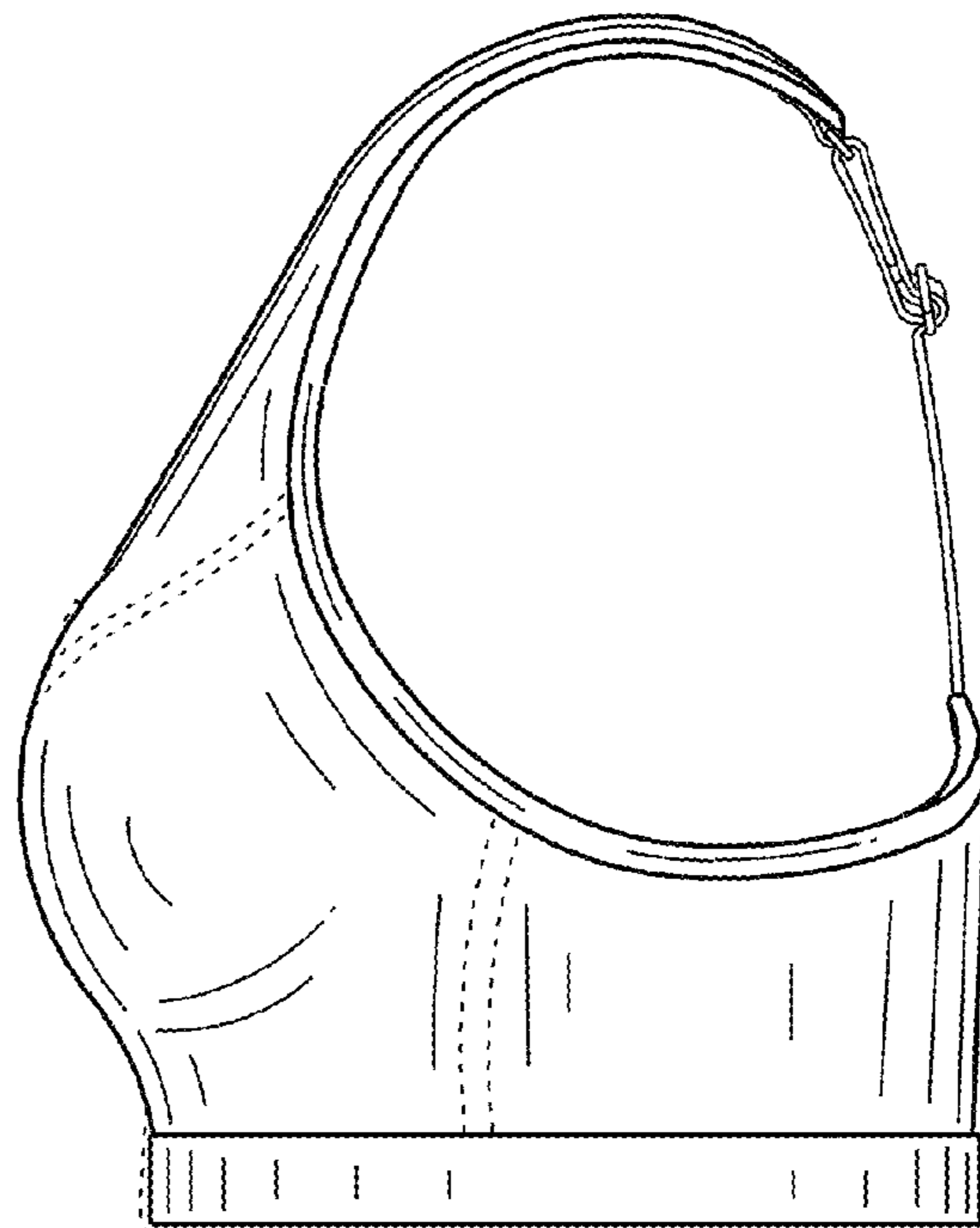

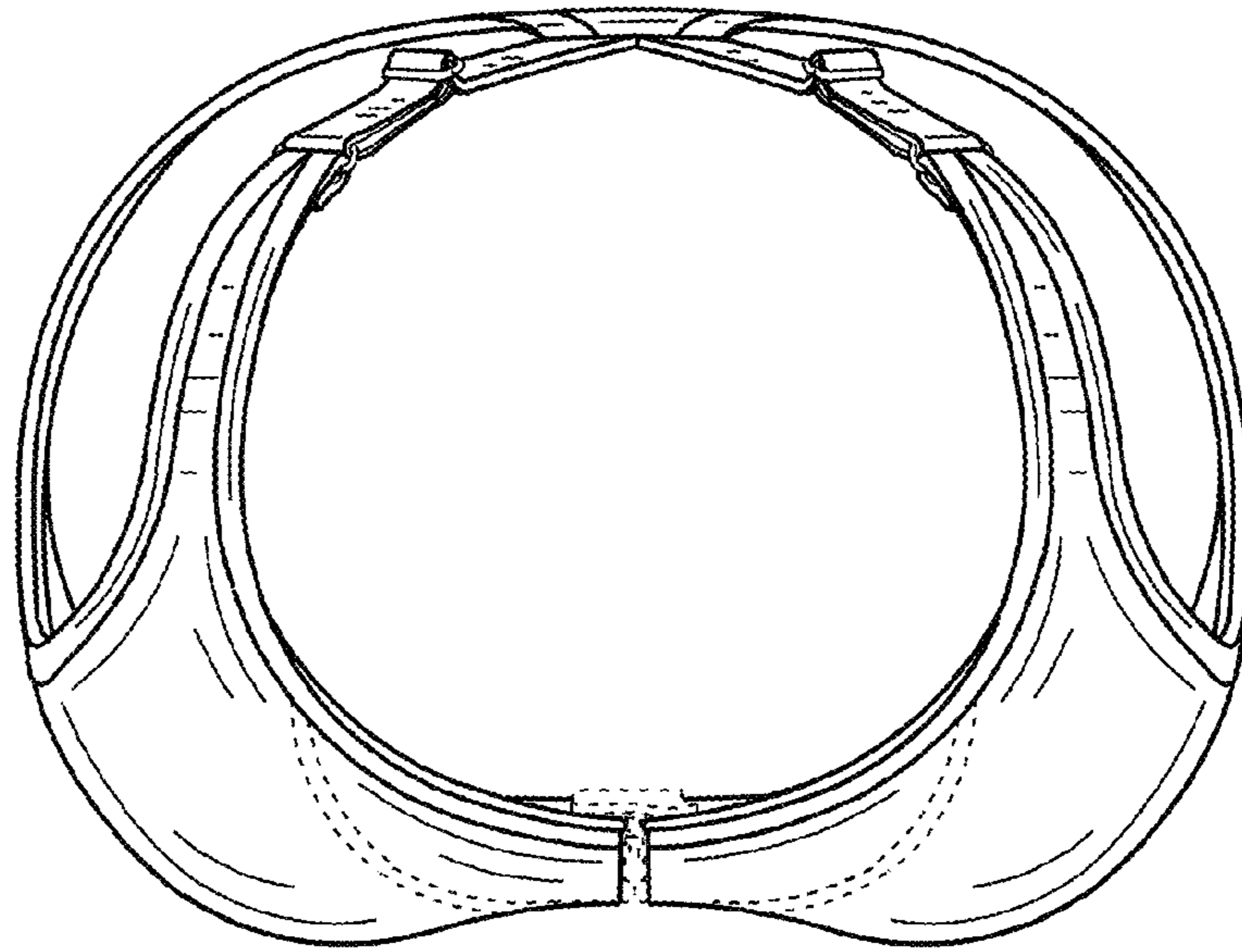

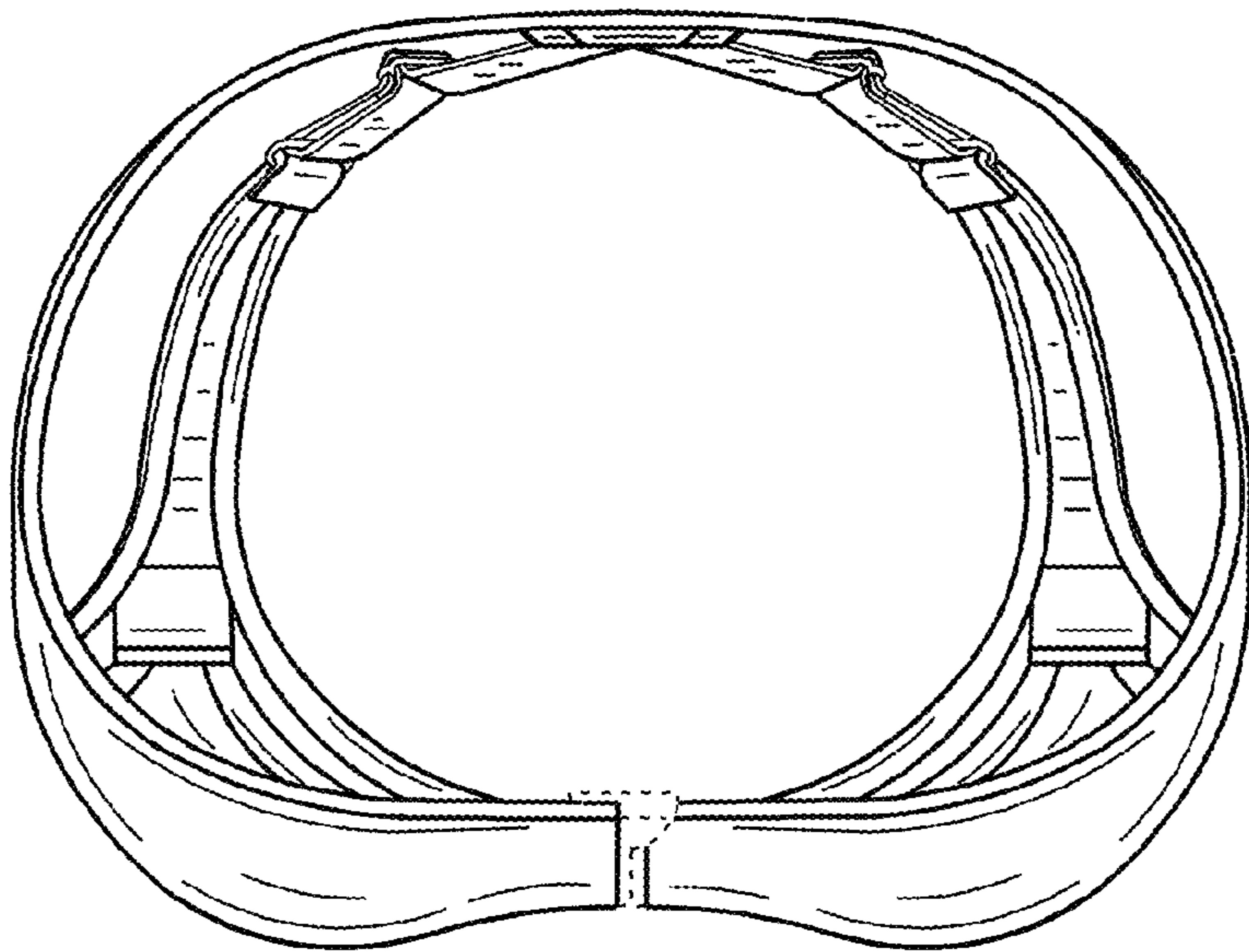

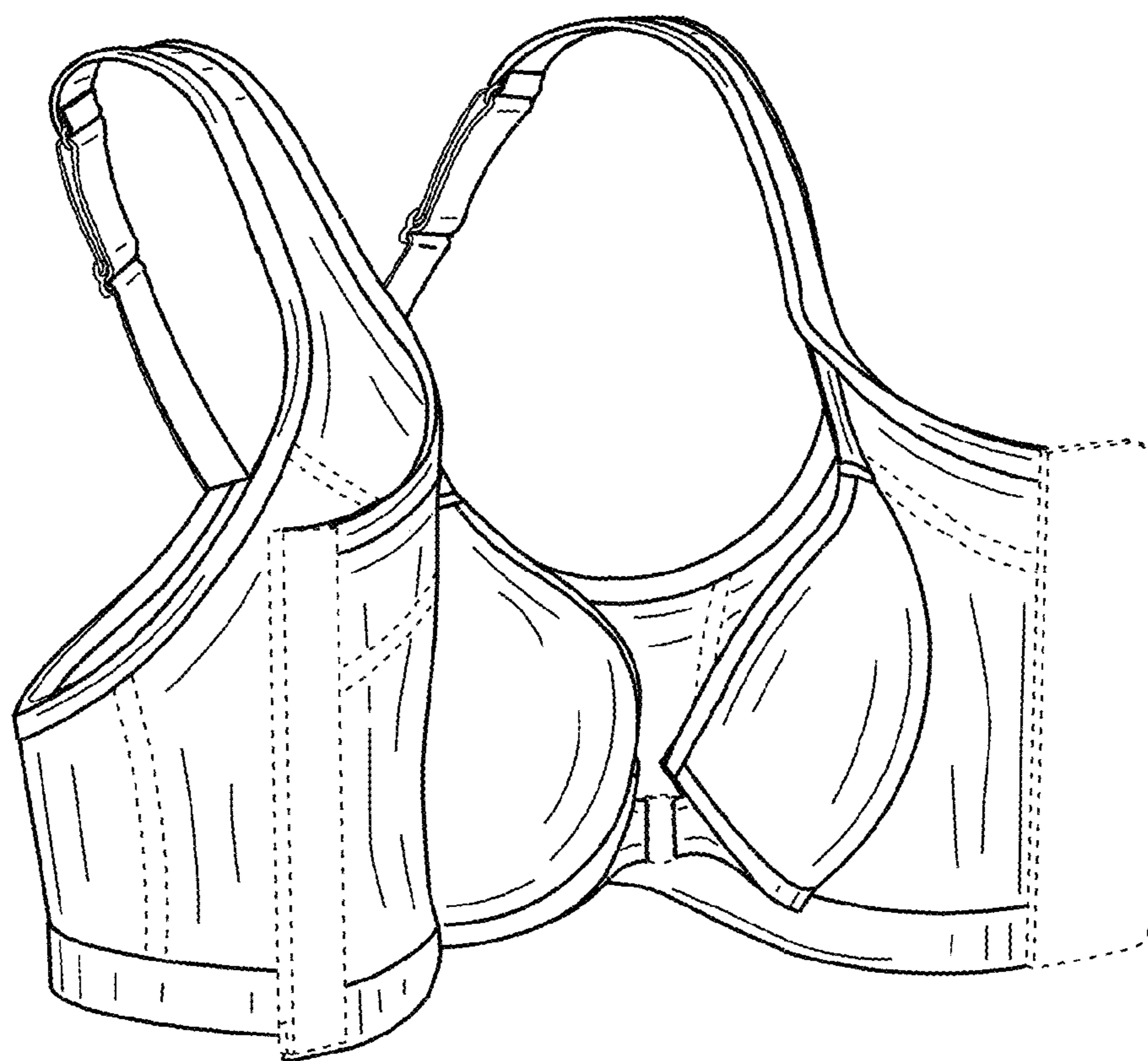

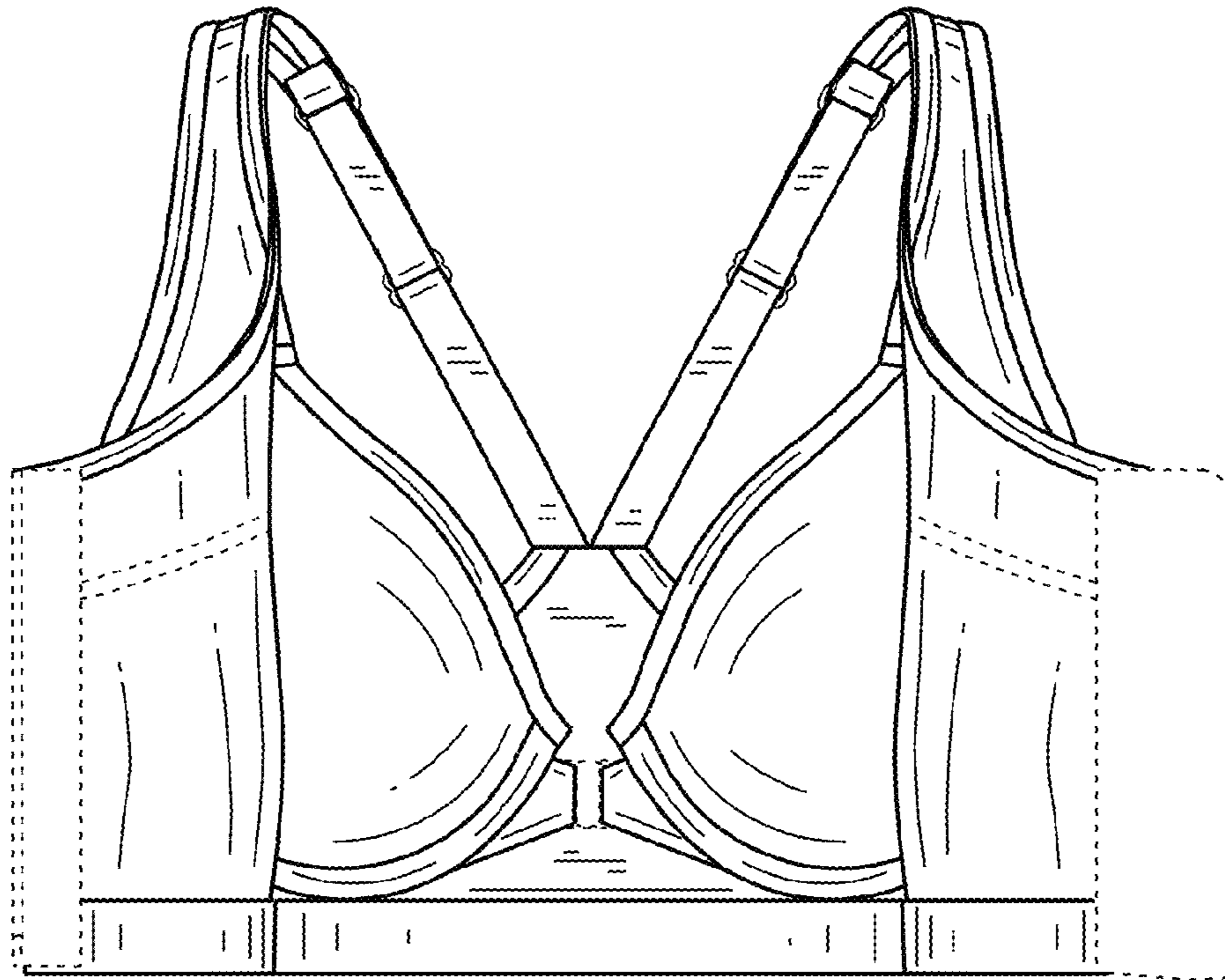

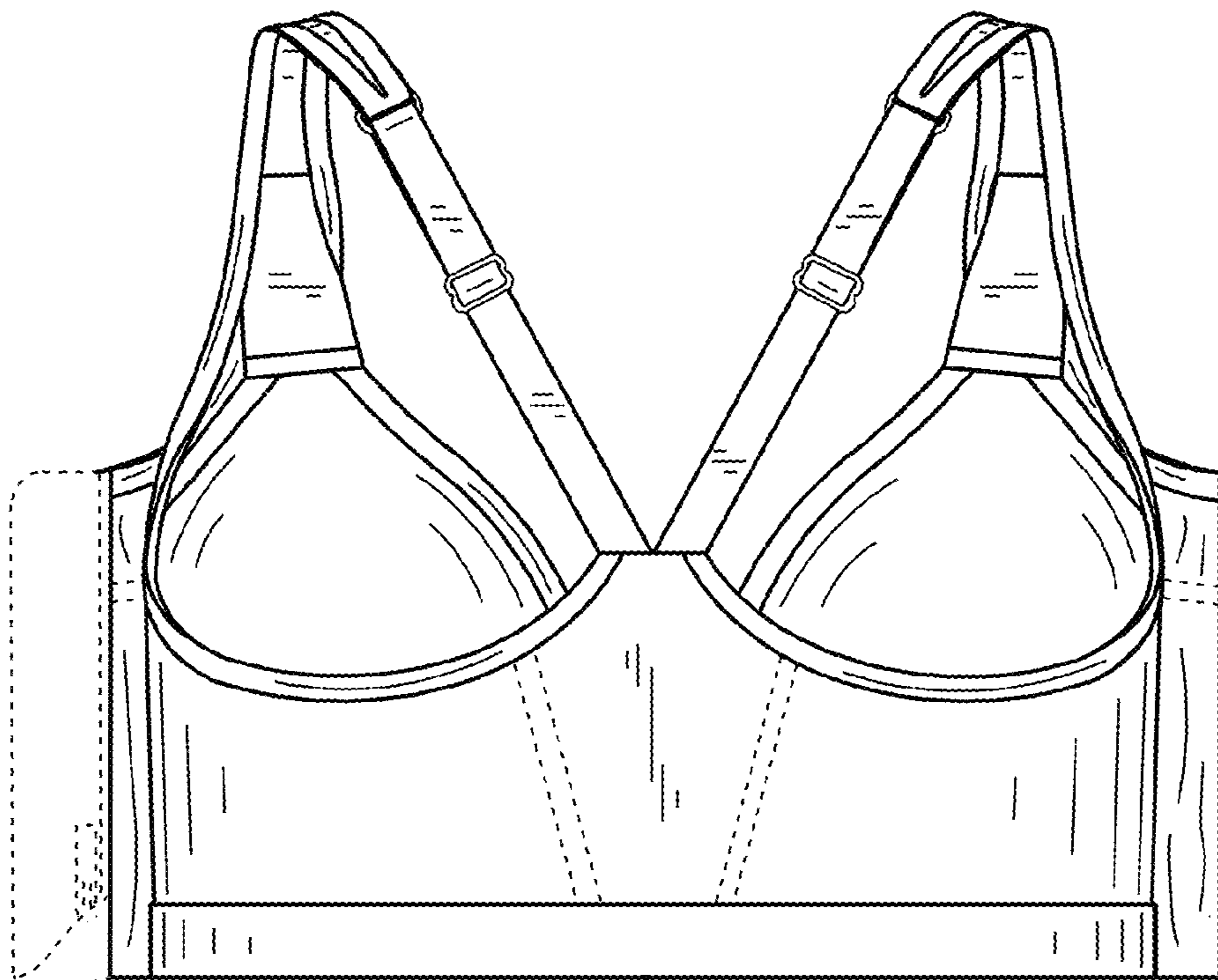
