The ornamental design for a protector for footwear, as shown and described.

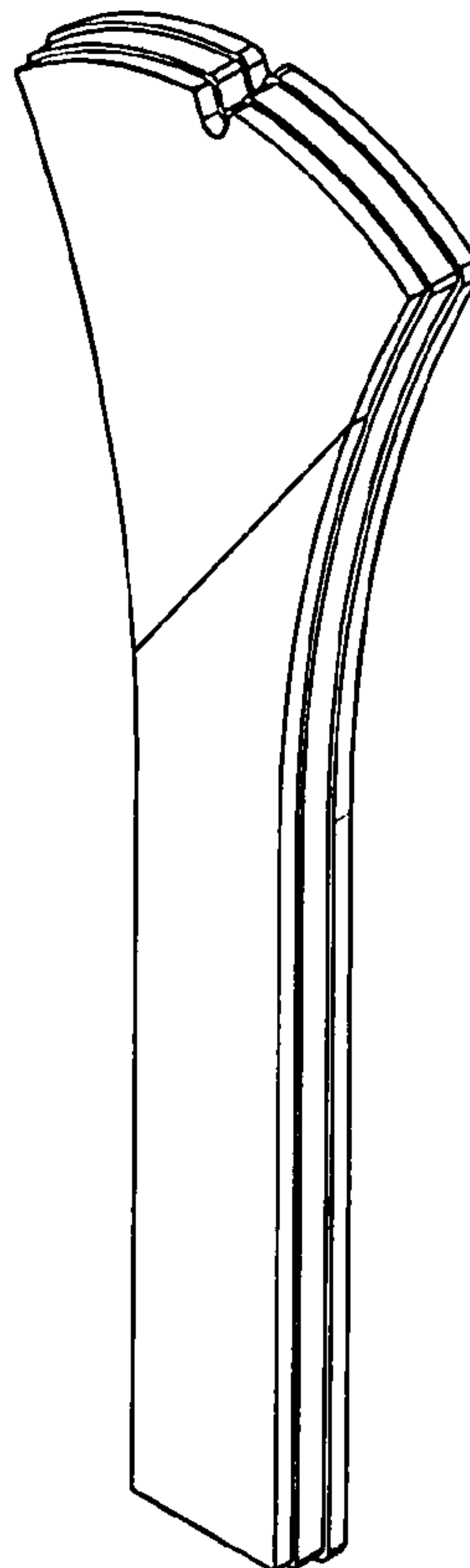
DESCRIPTION

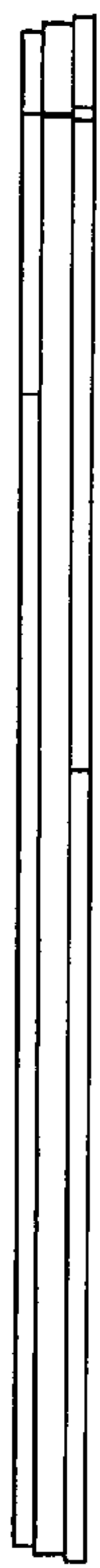

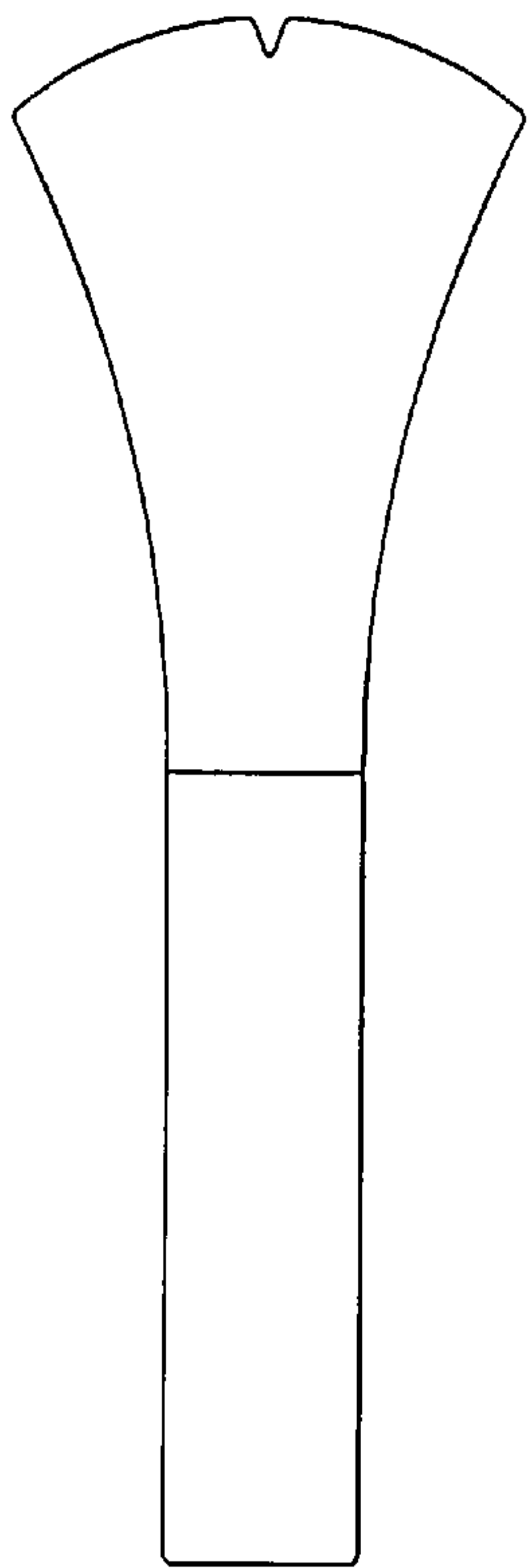

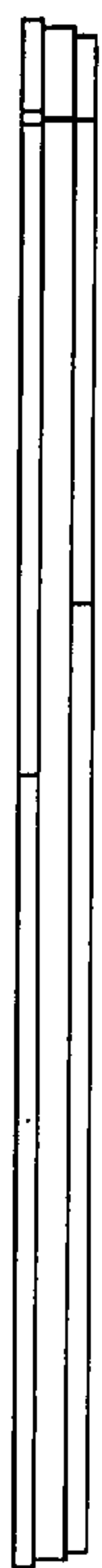

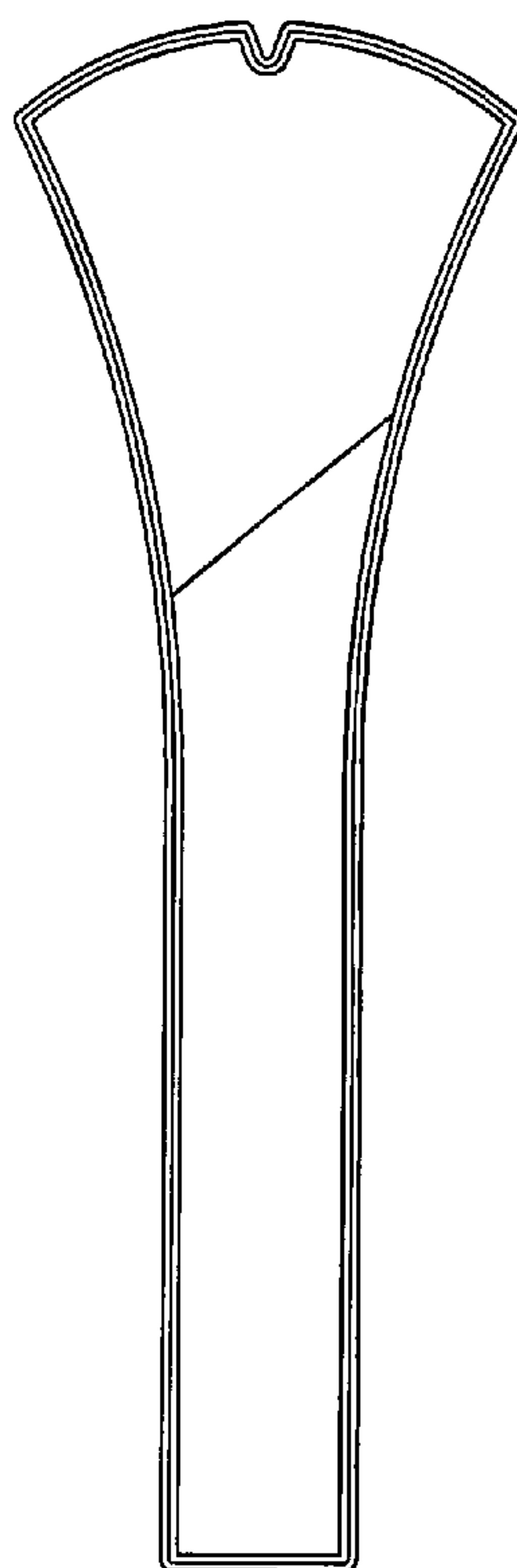

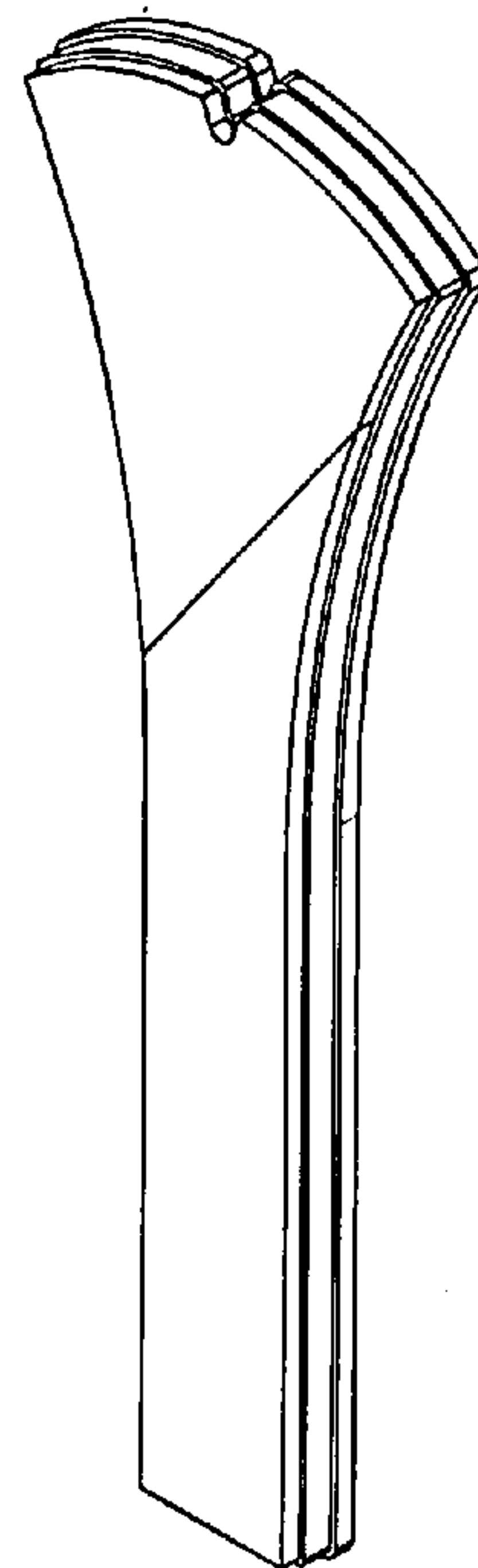

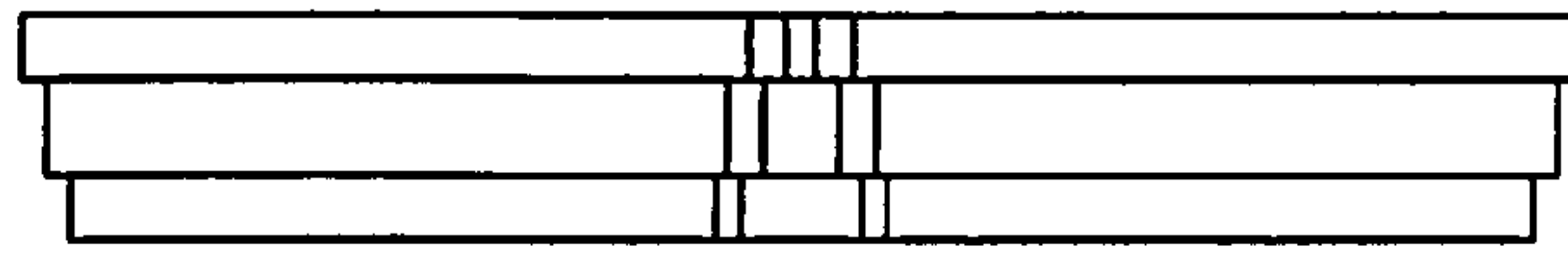

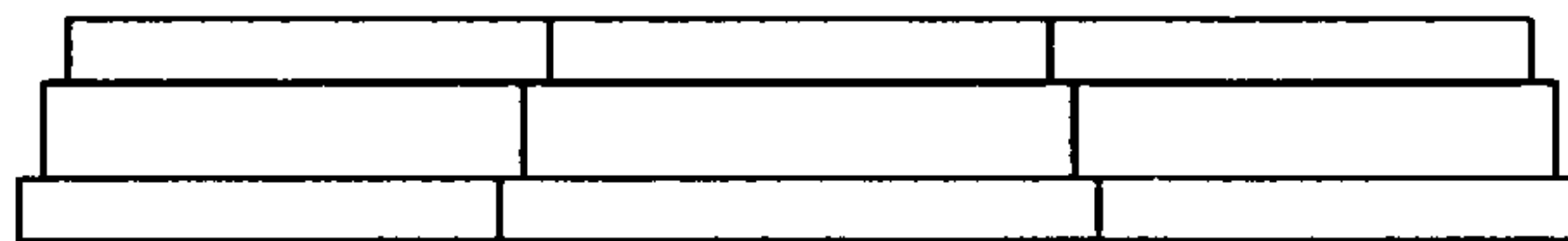

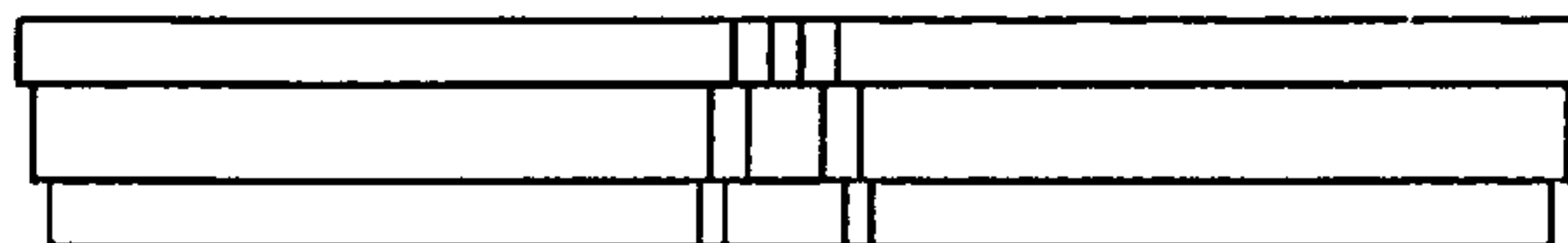

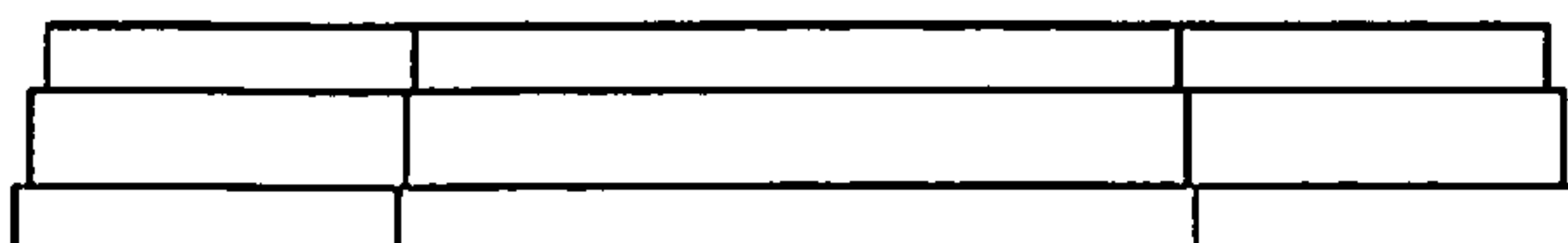

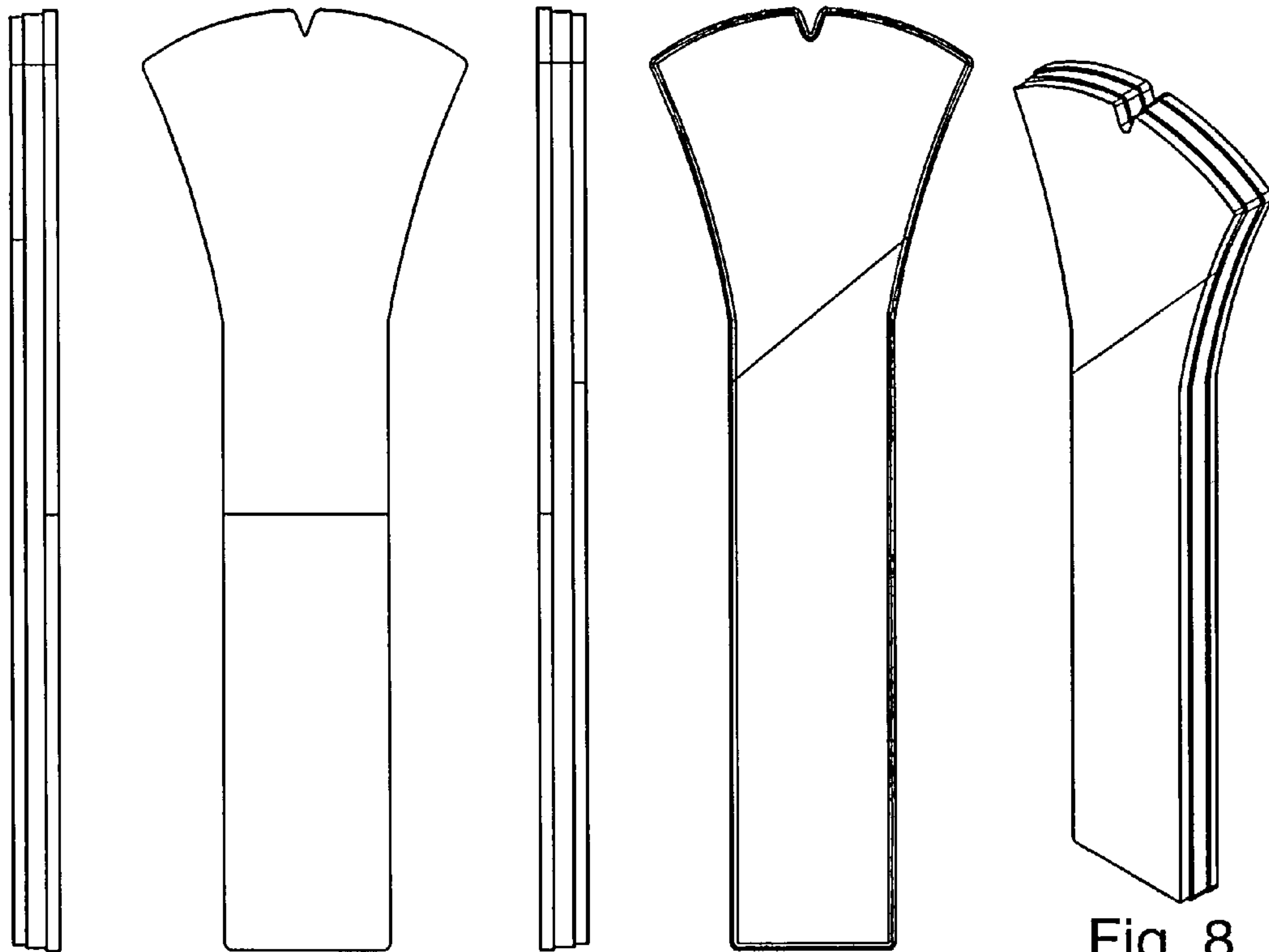
