FIG. 1 is a perspective view of a sole for footwear showing my new design;

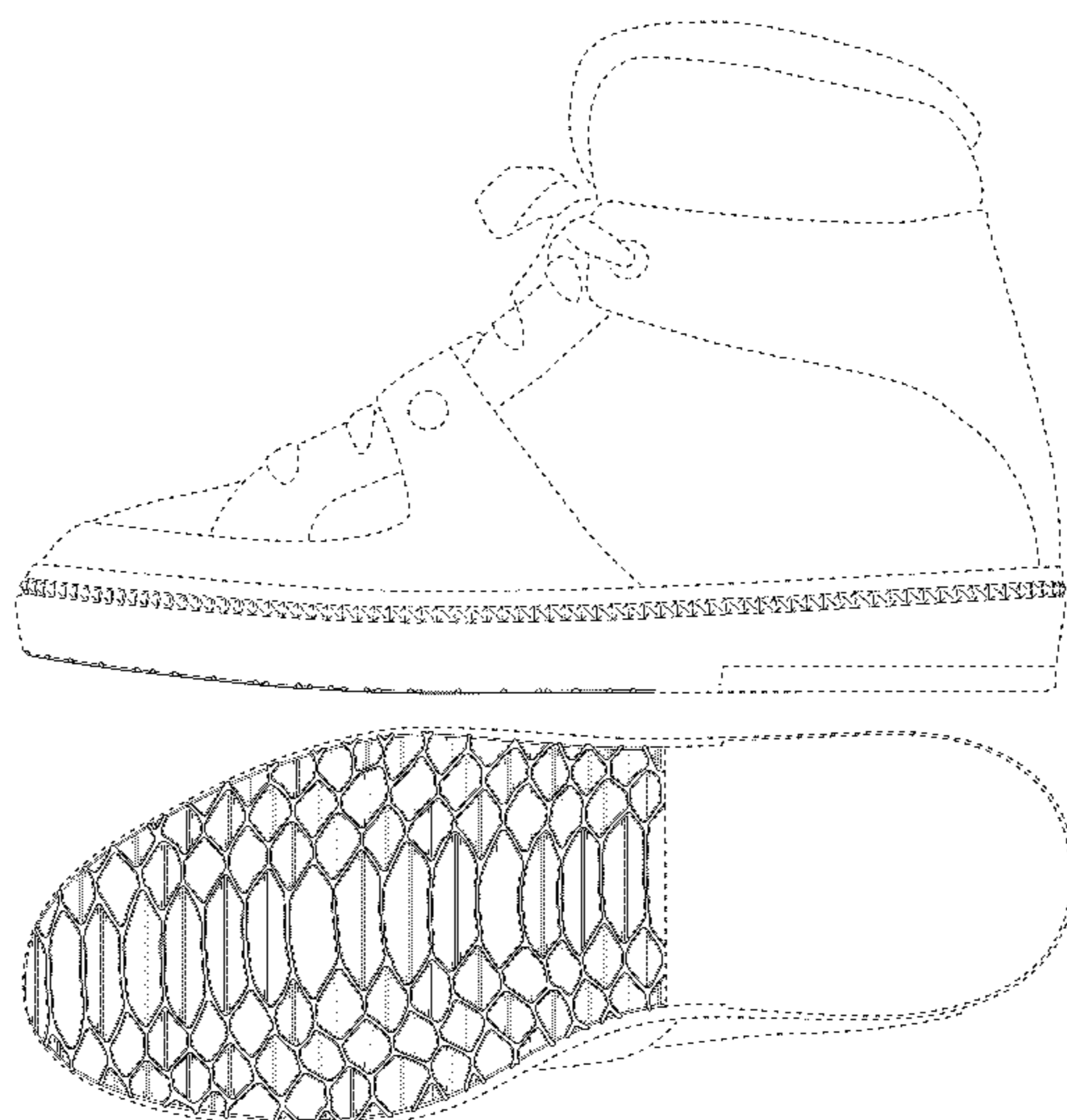
FIG. 2 is a side view of the sole for footwear shown in FIG. 1; FIG. 3 is the other side view of the sole for footwear shown in FIG. 1;

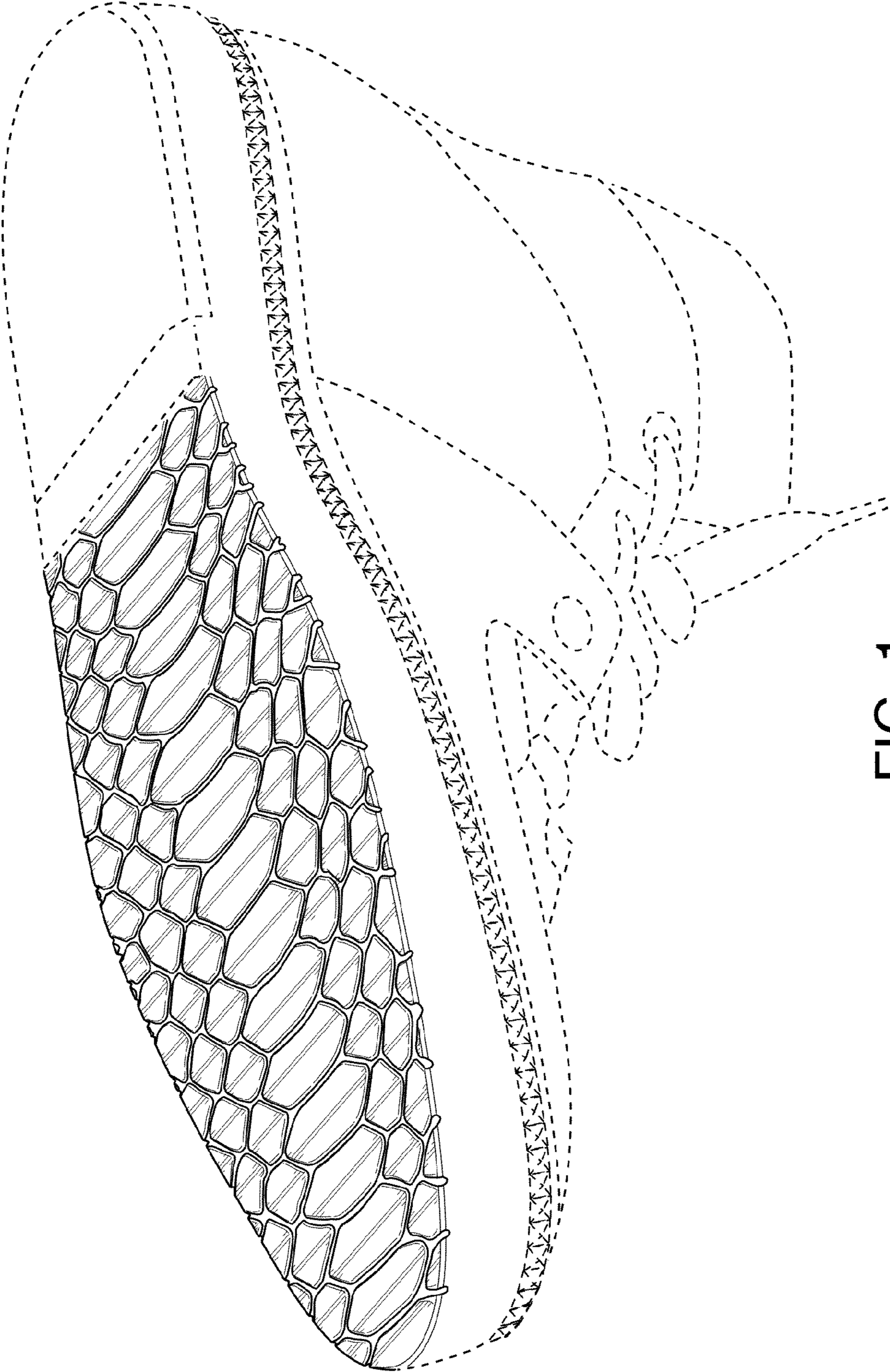

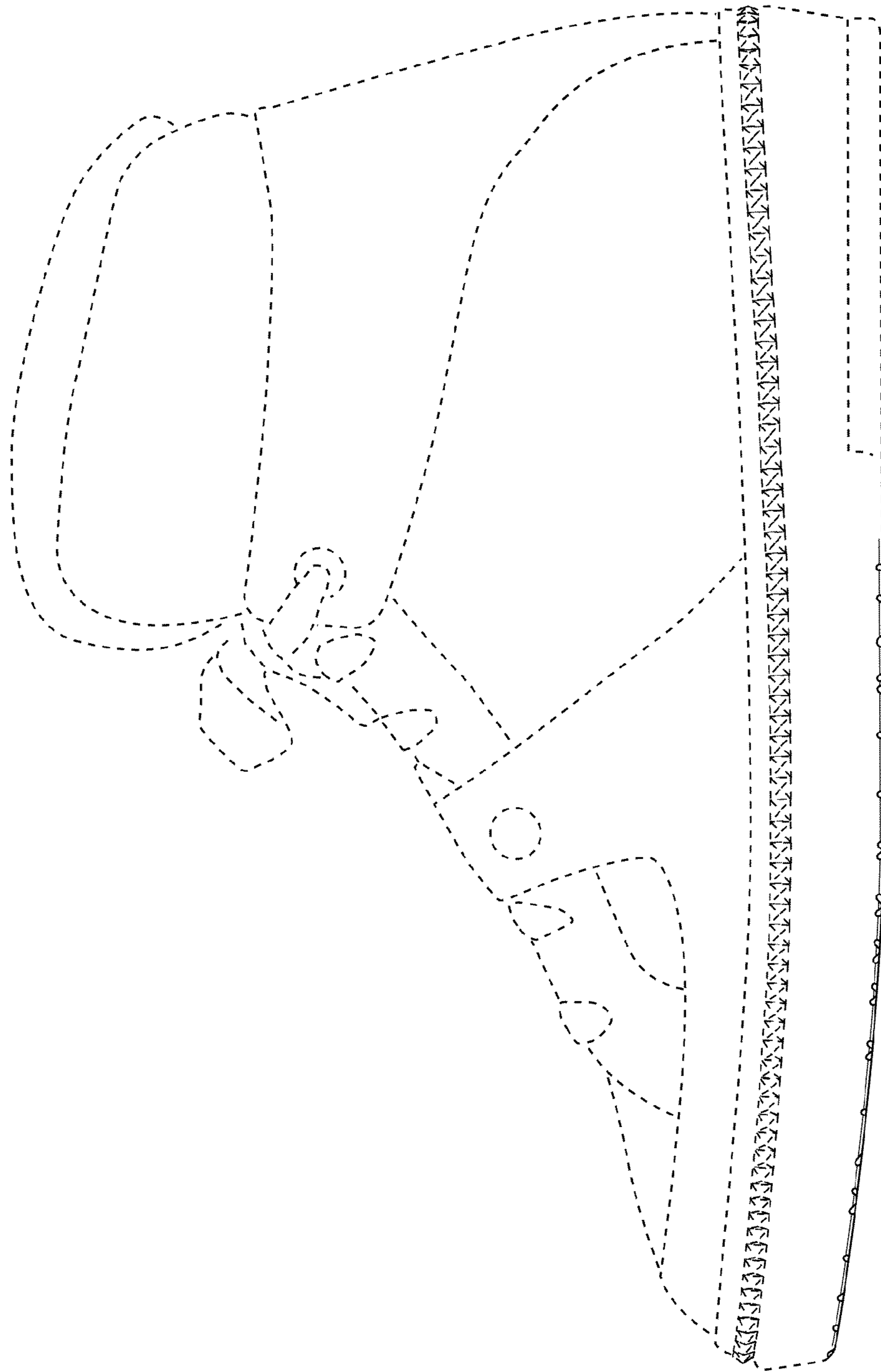

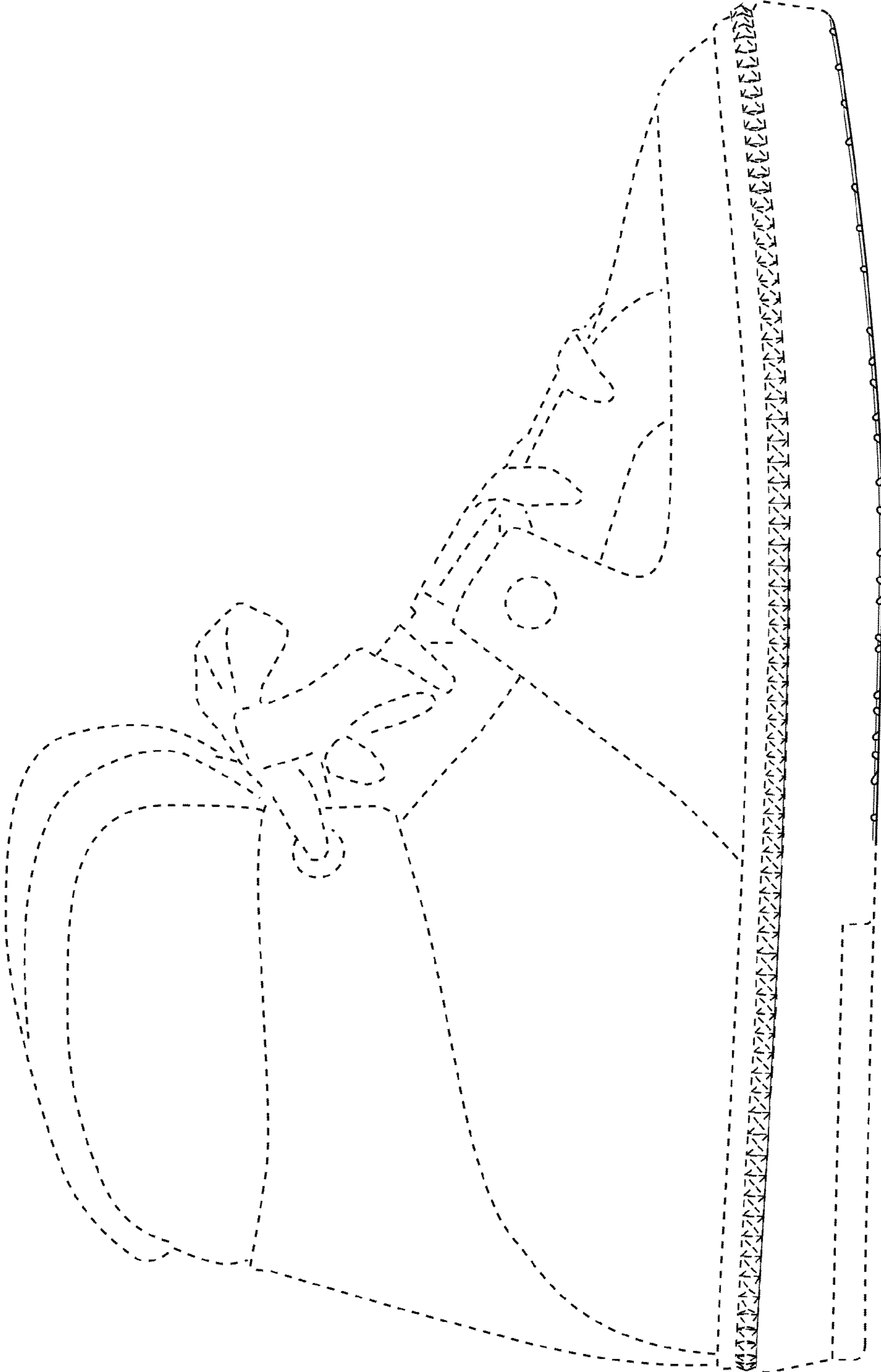

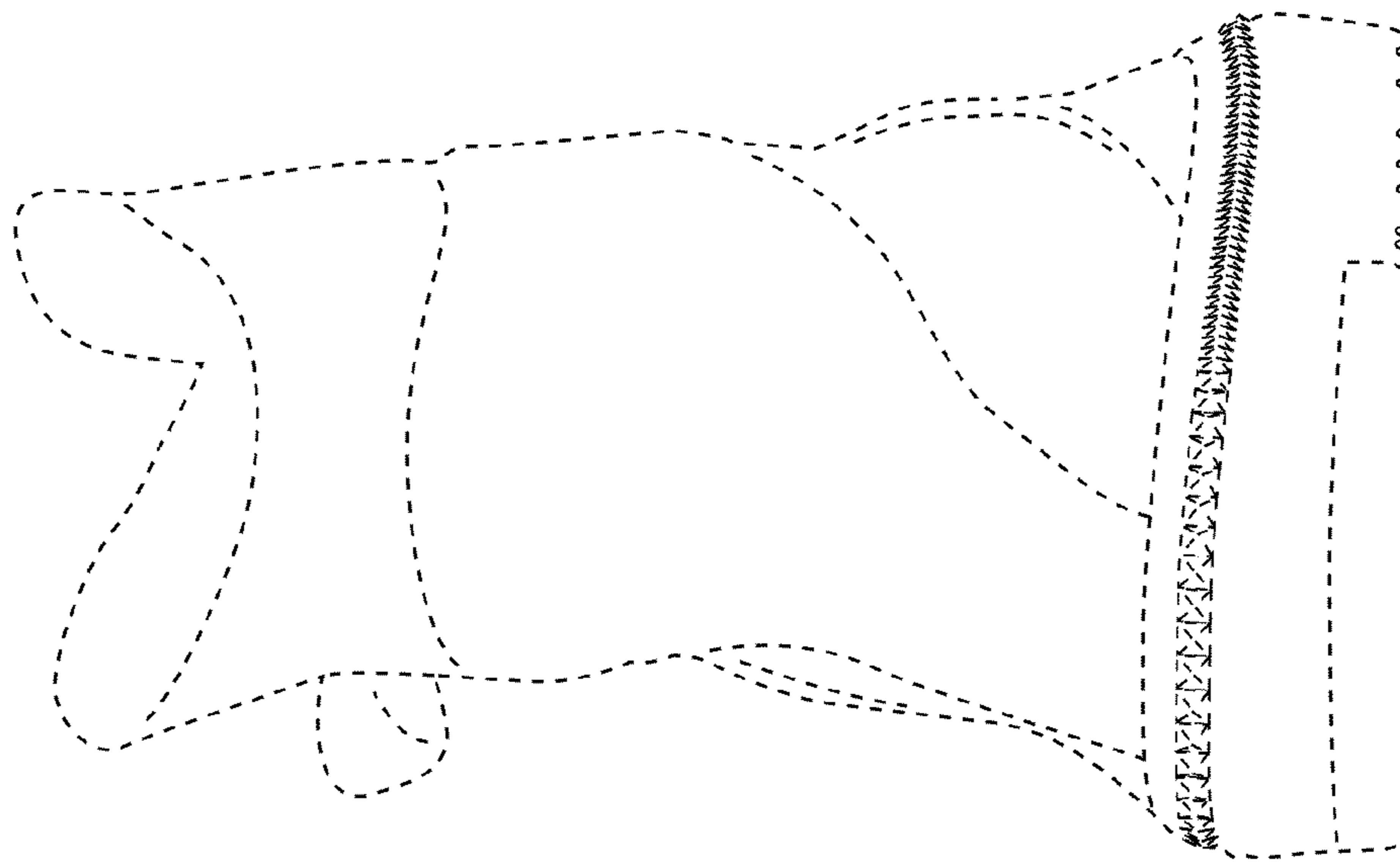

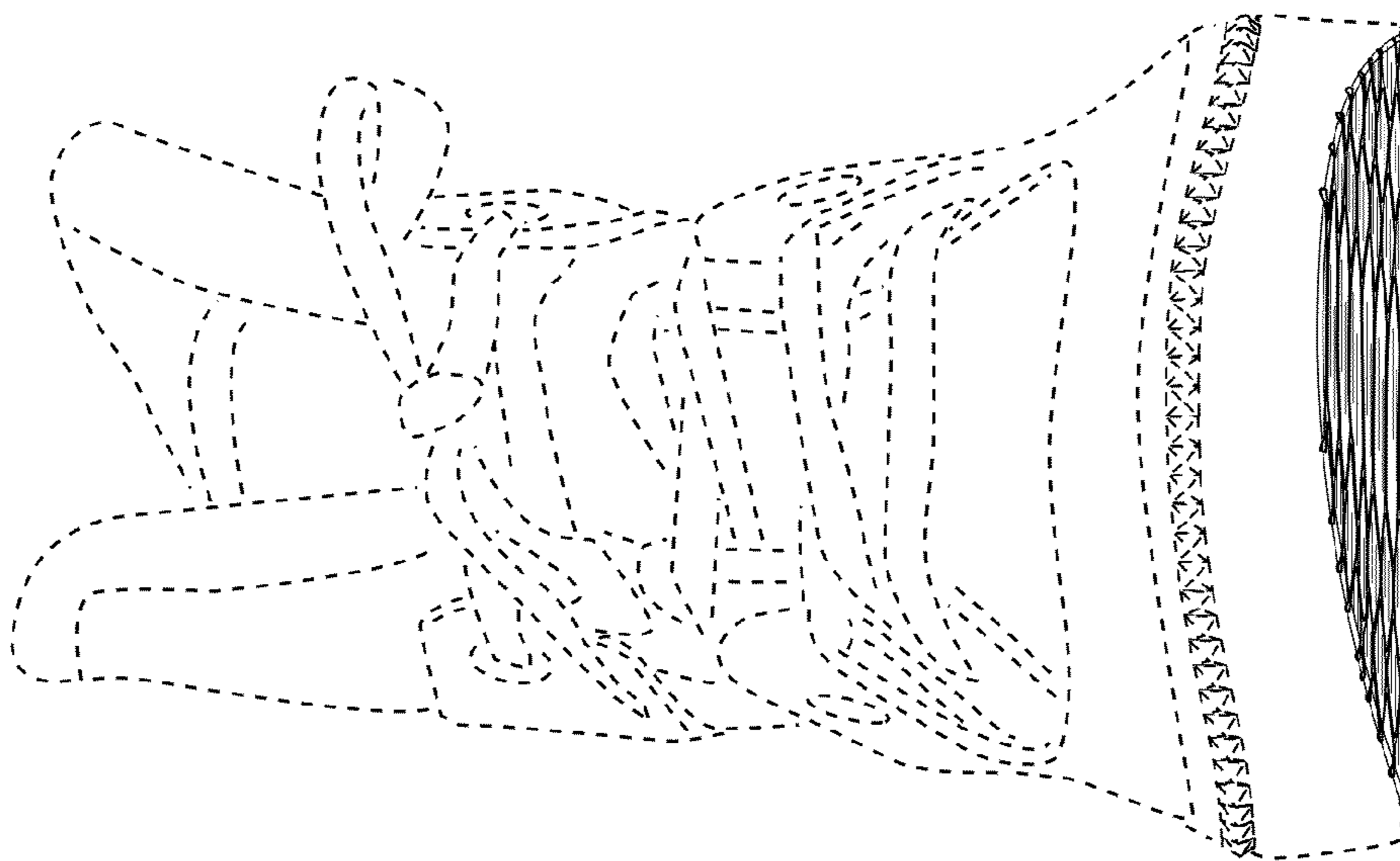

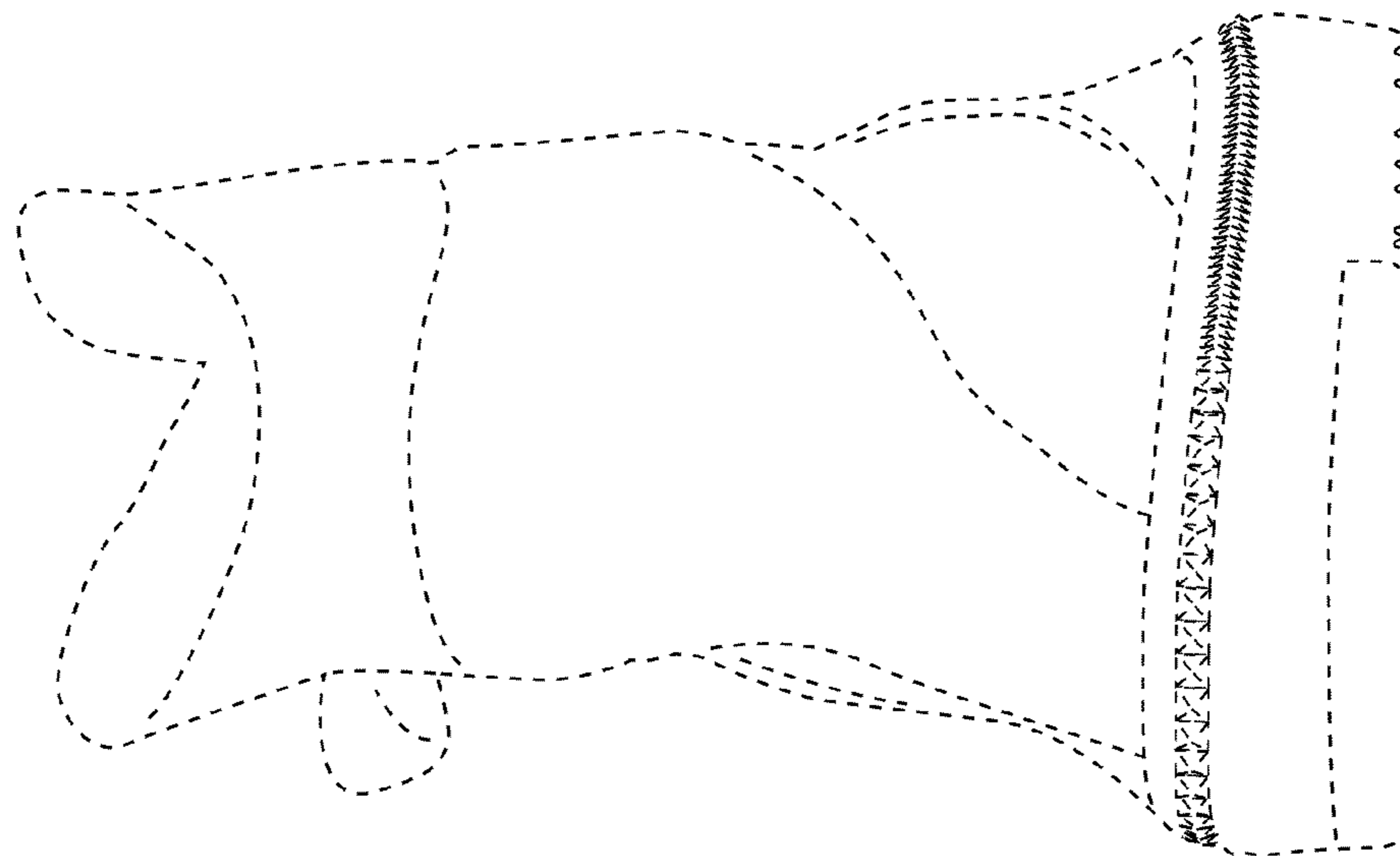

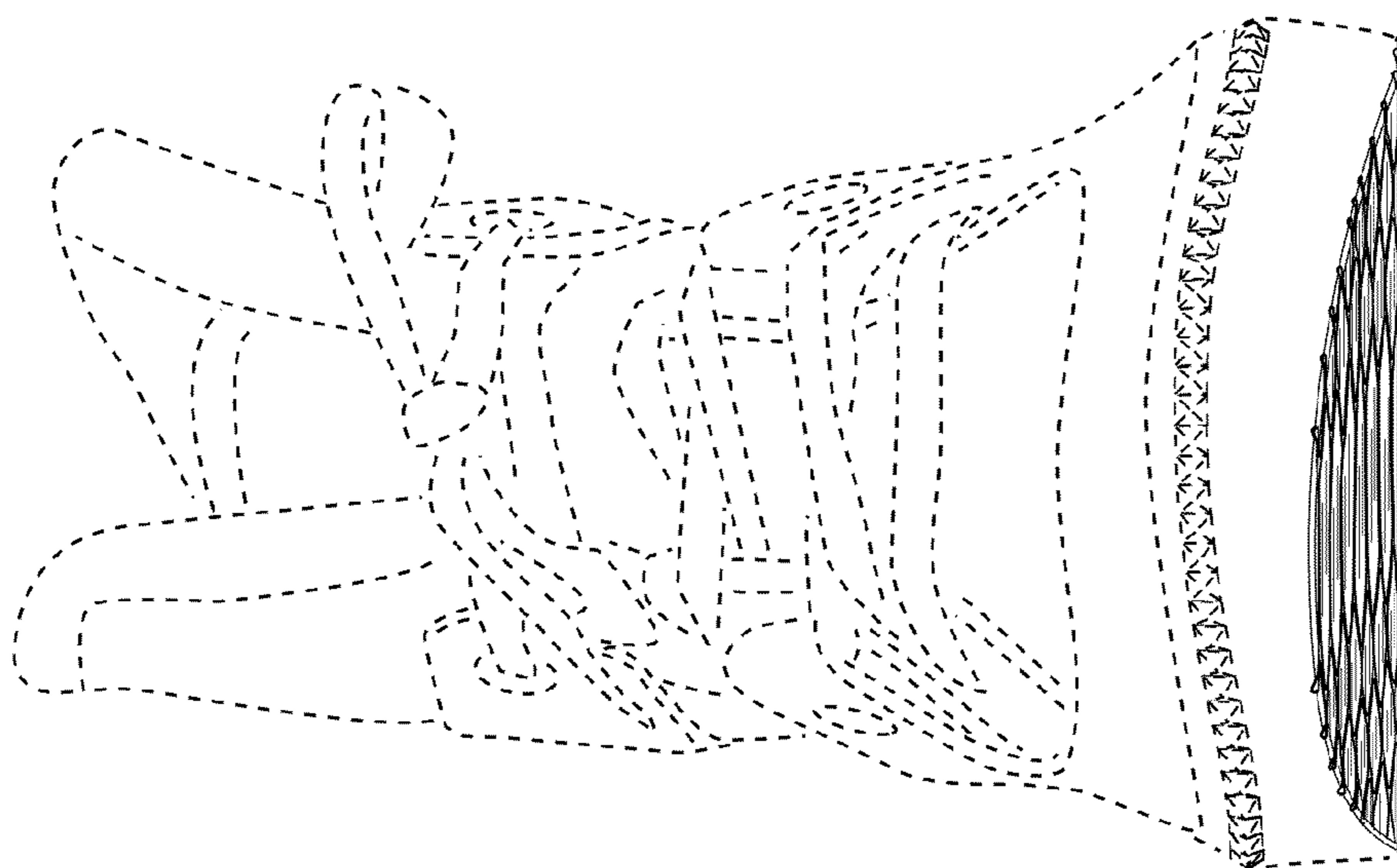

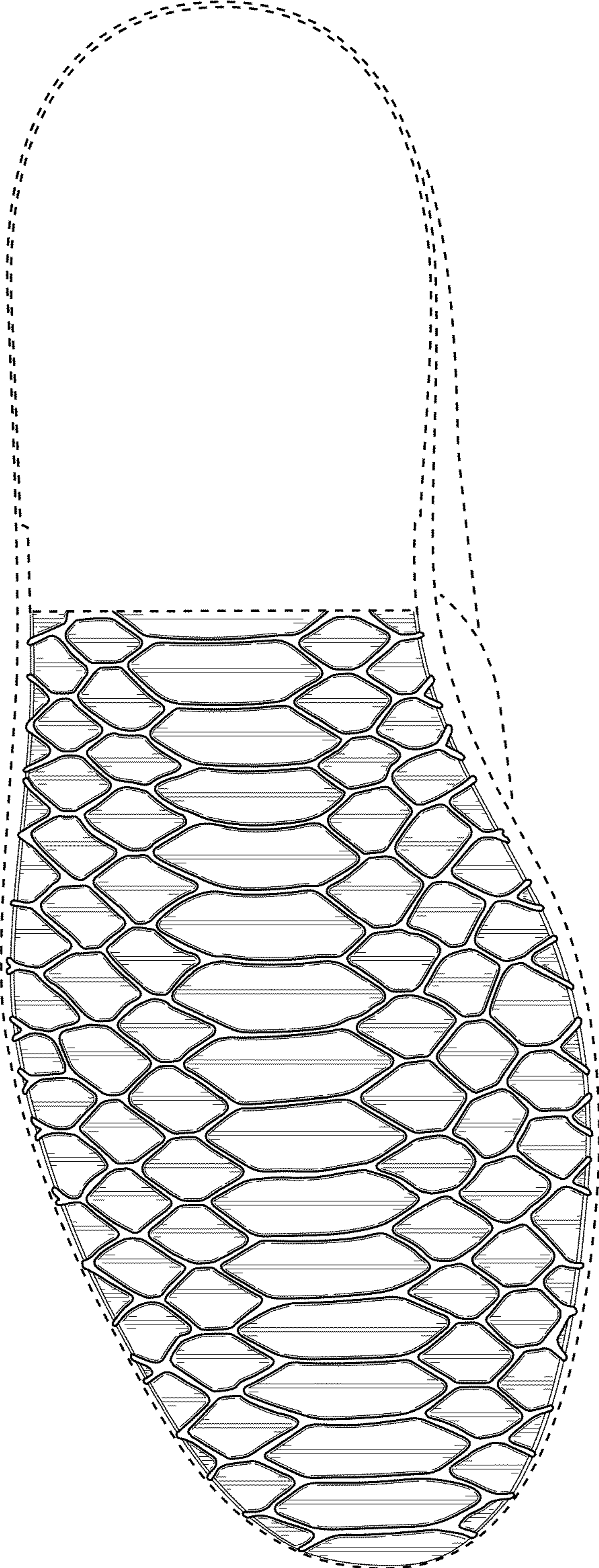

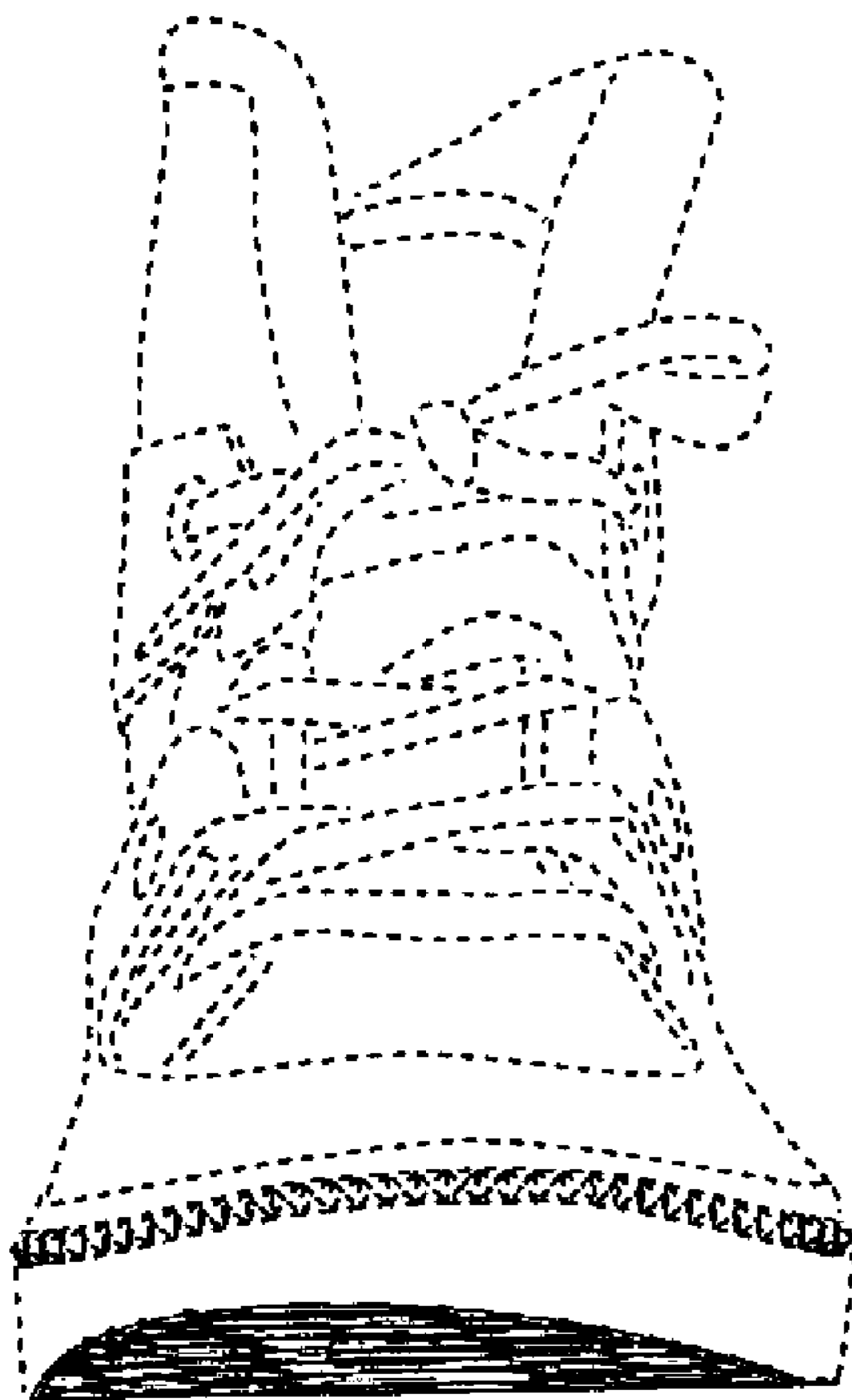

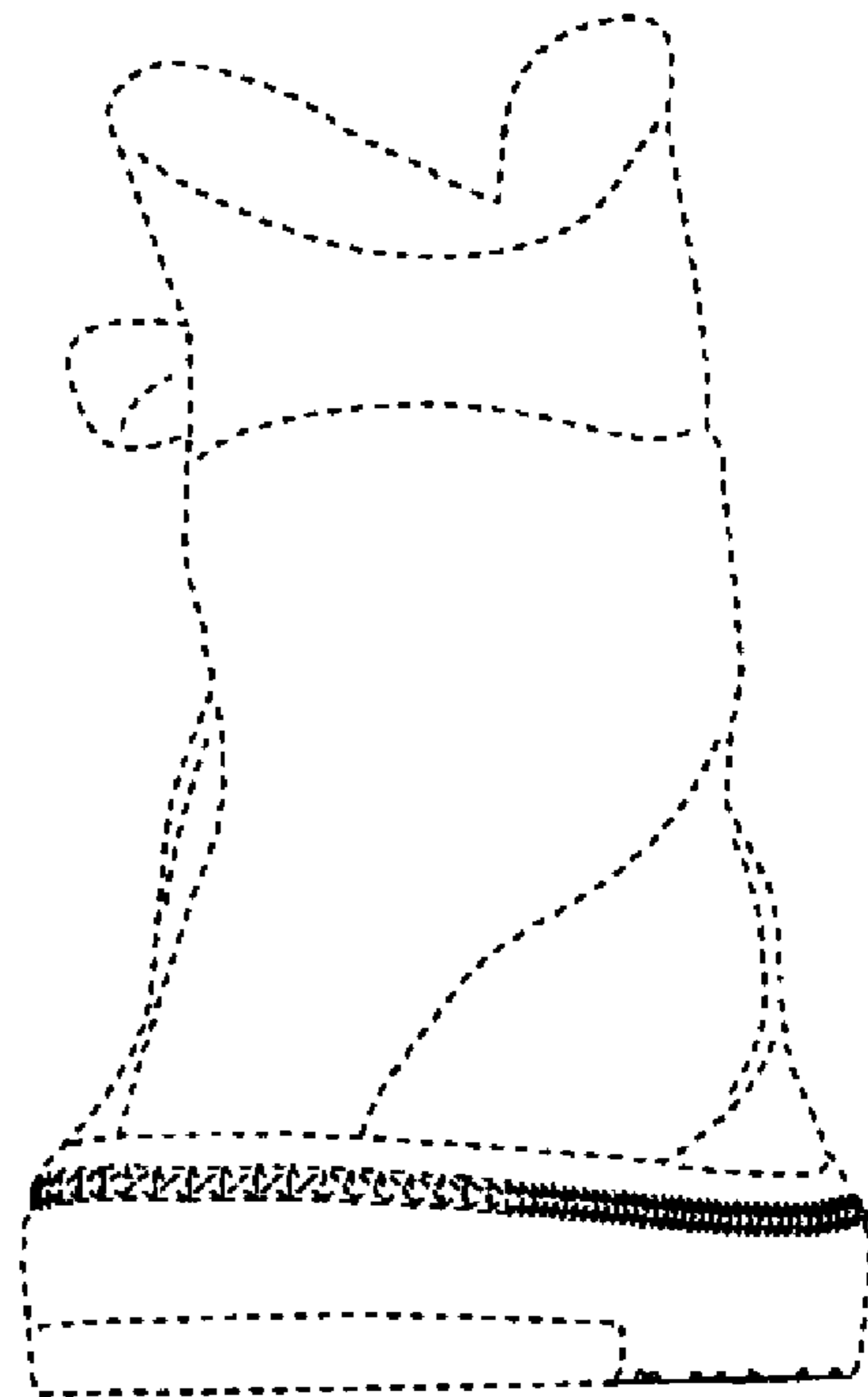
