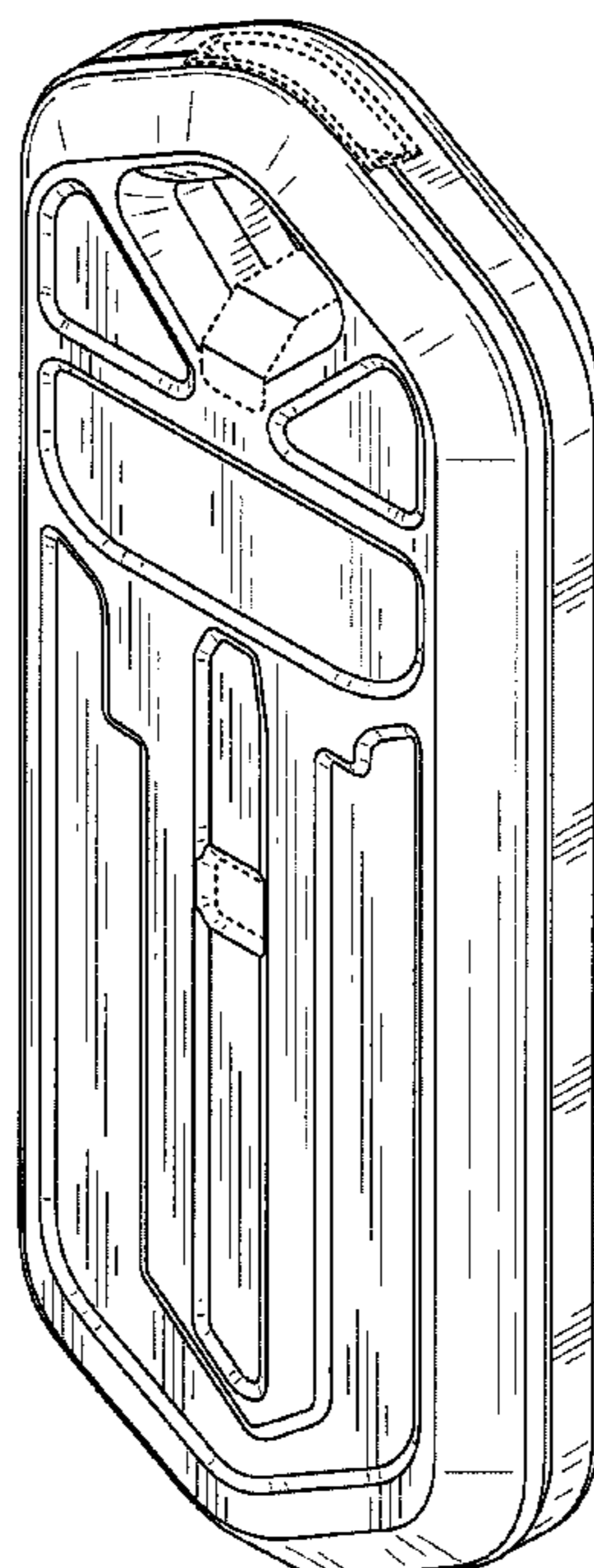

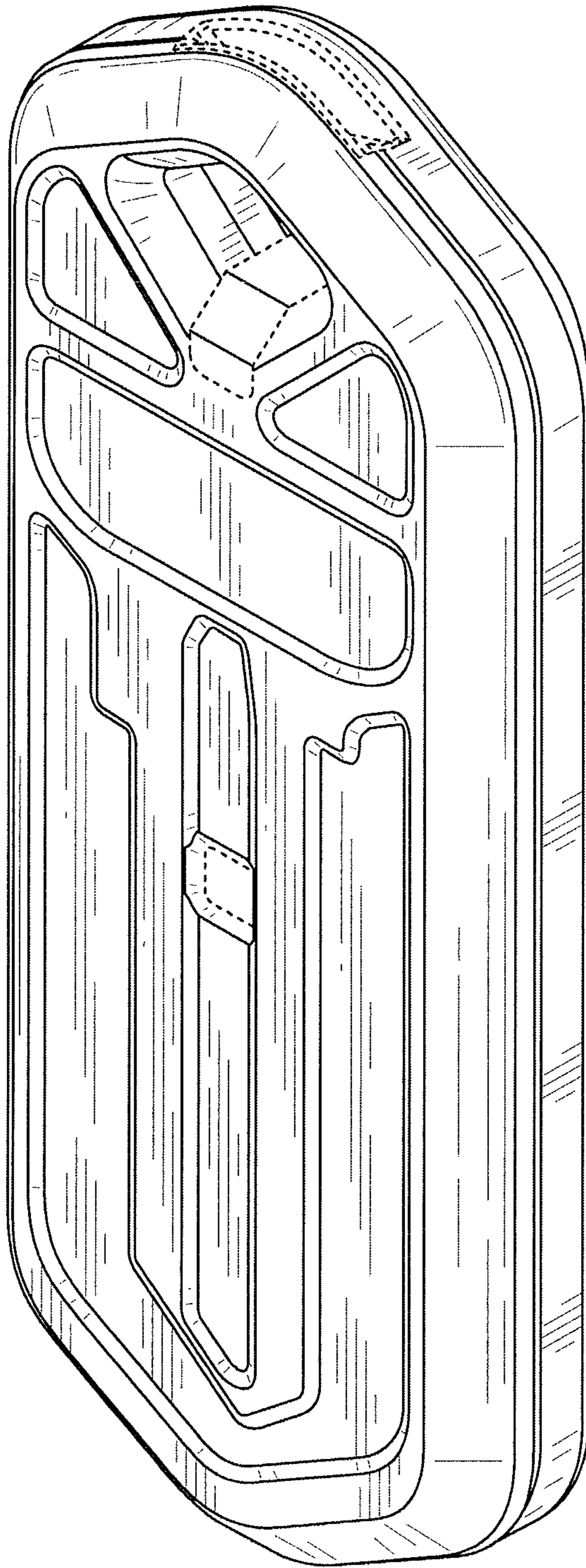
What is claimed is the ornamental design for a keyfob, as shown and described.

**DESCRIPTION**

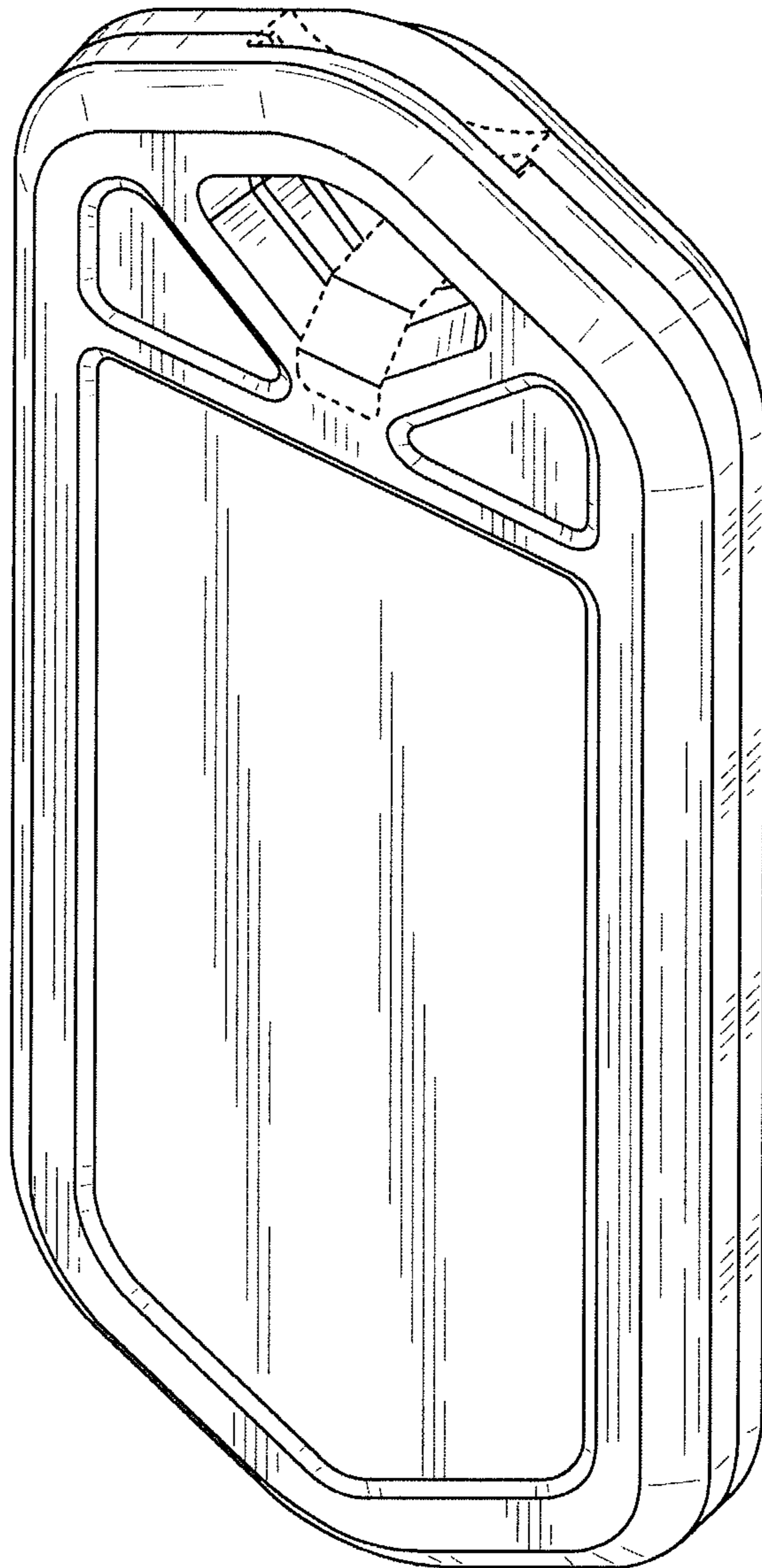

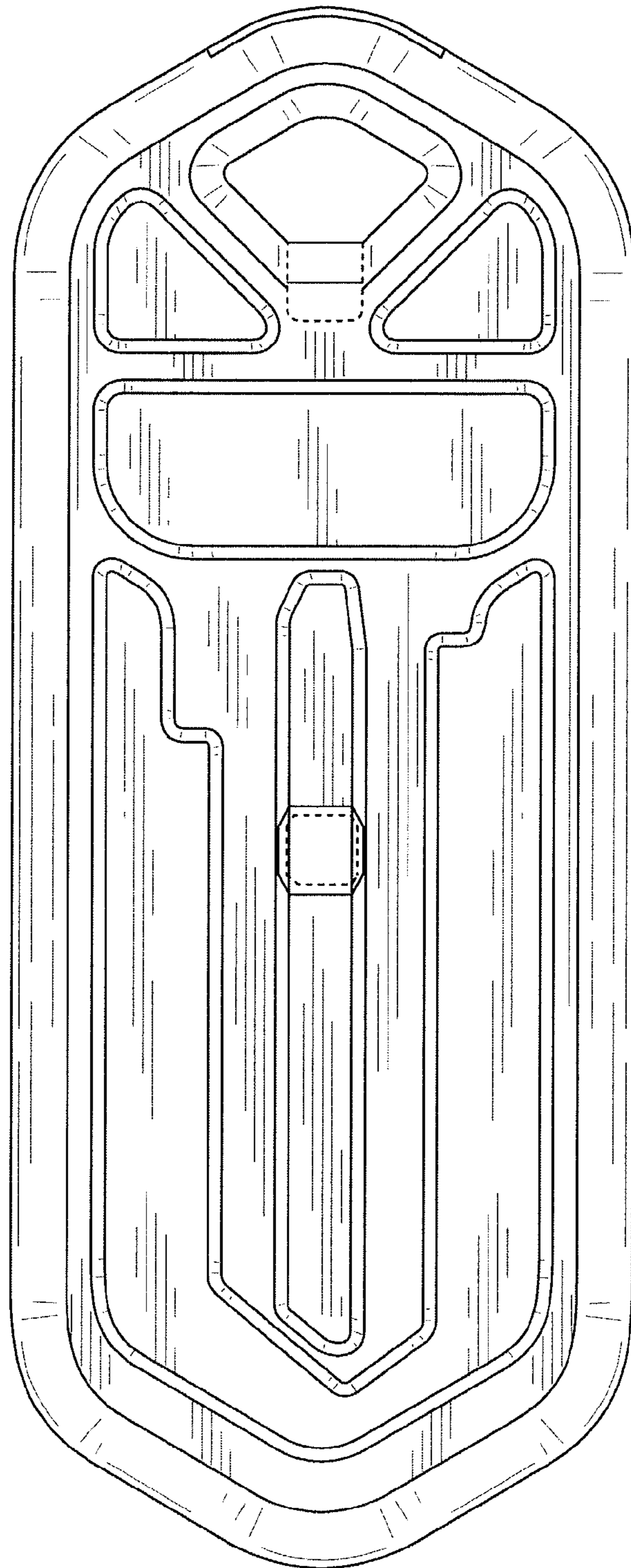

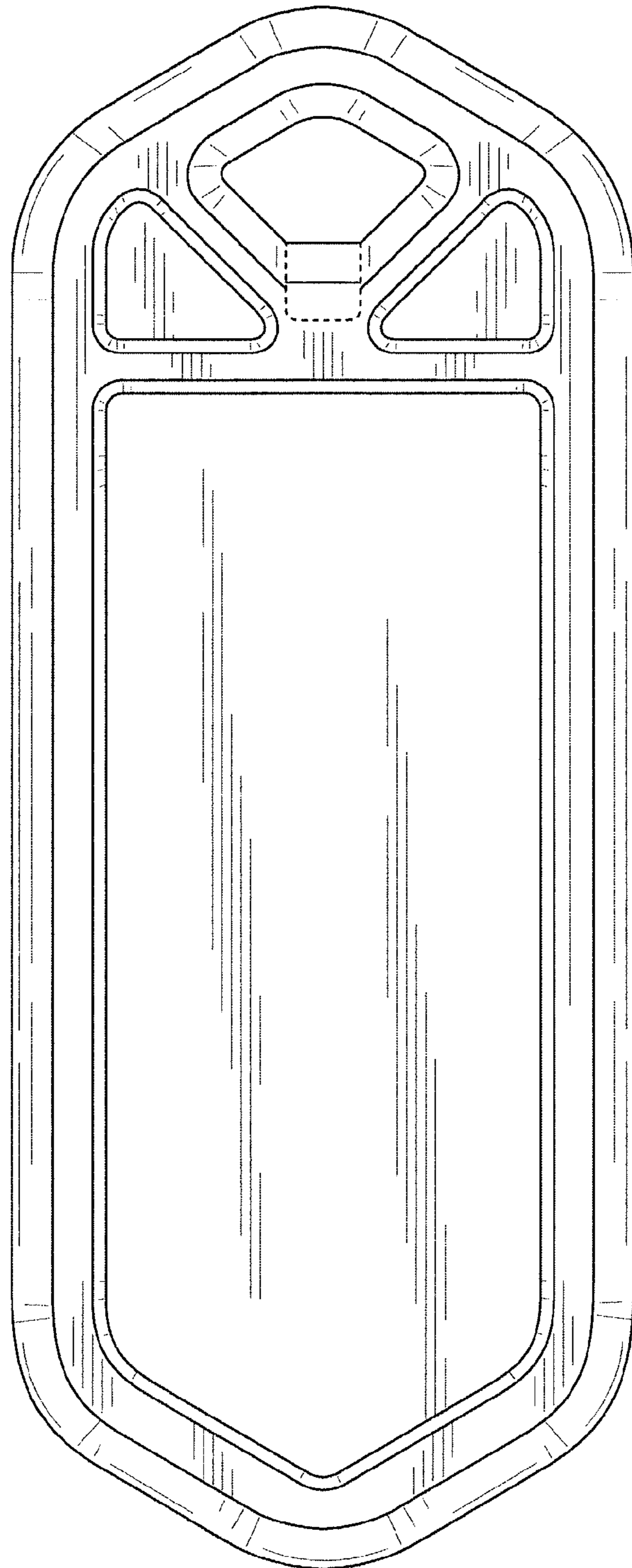
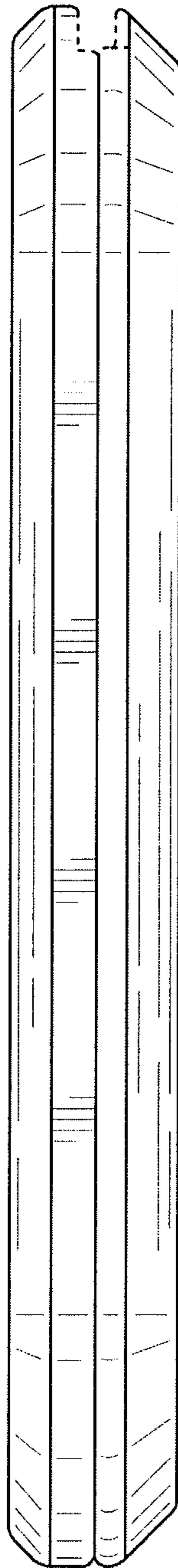
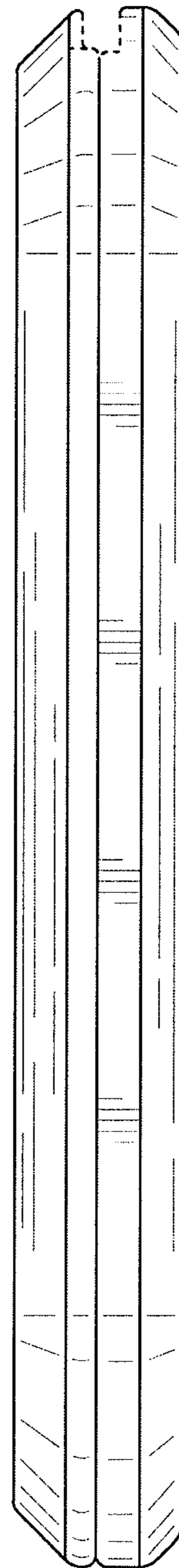


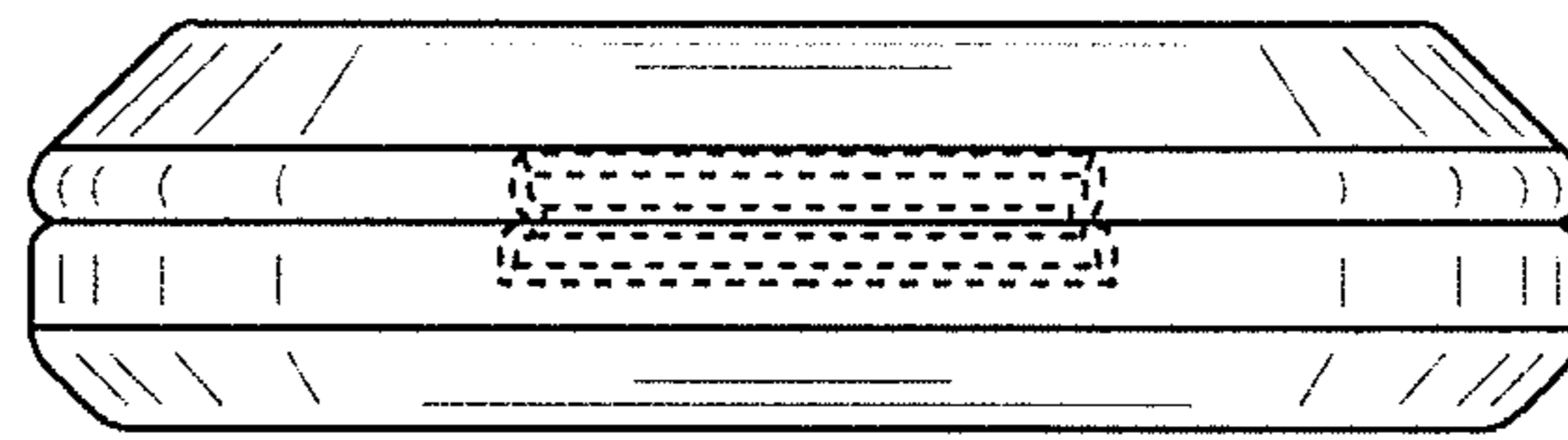

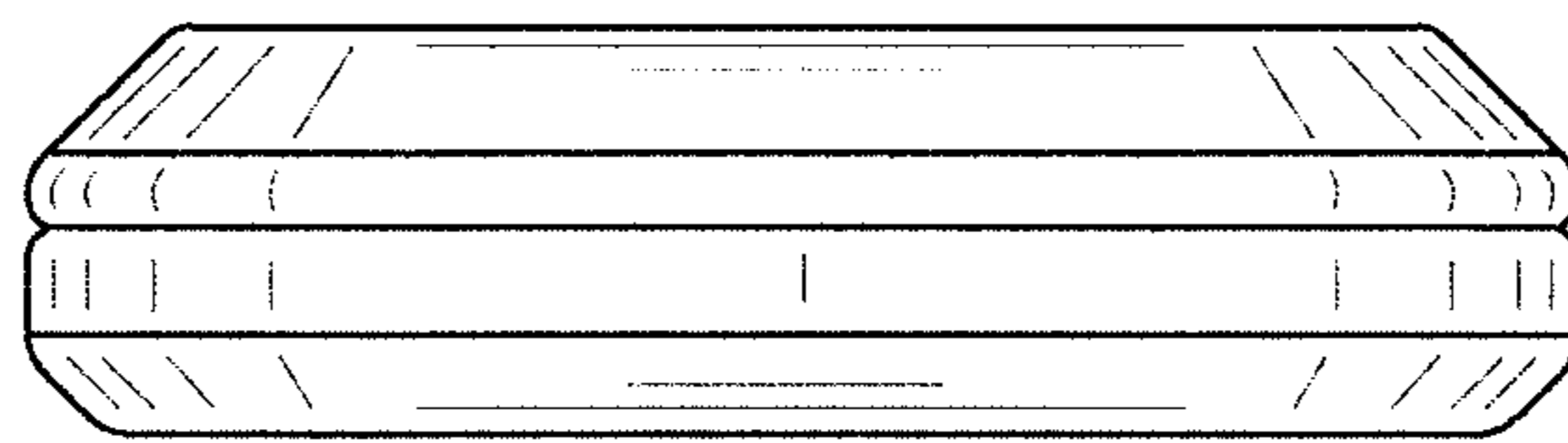
