The ornamental design for a storage pouch for pet leash, as shown and described.

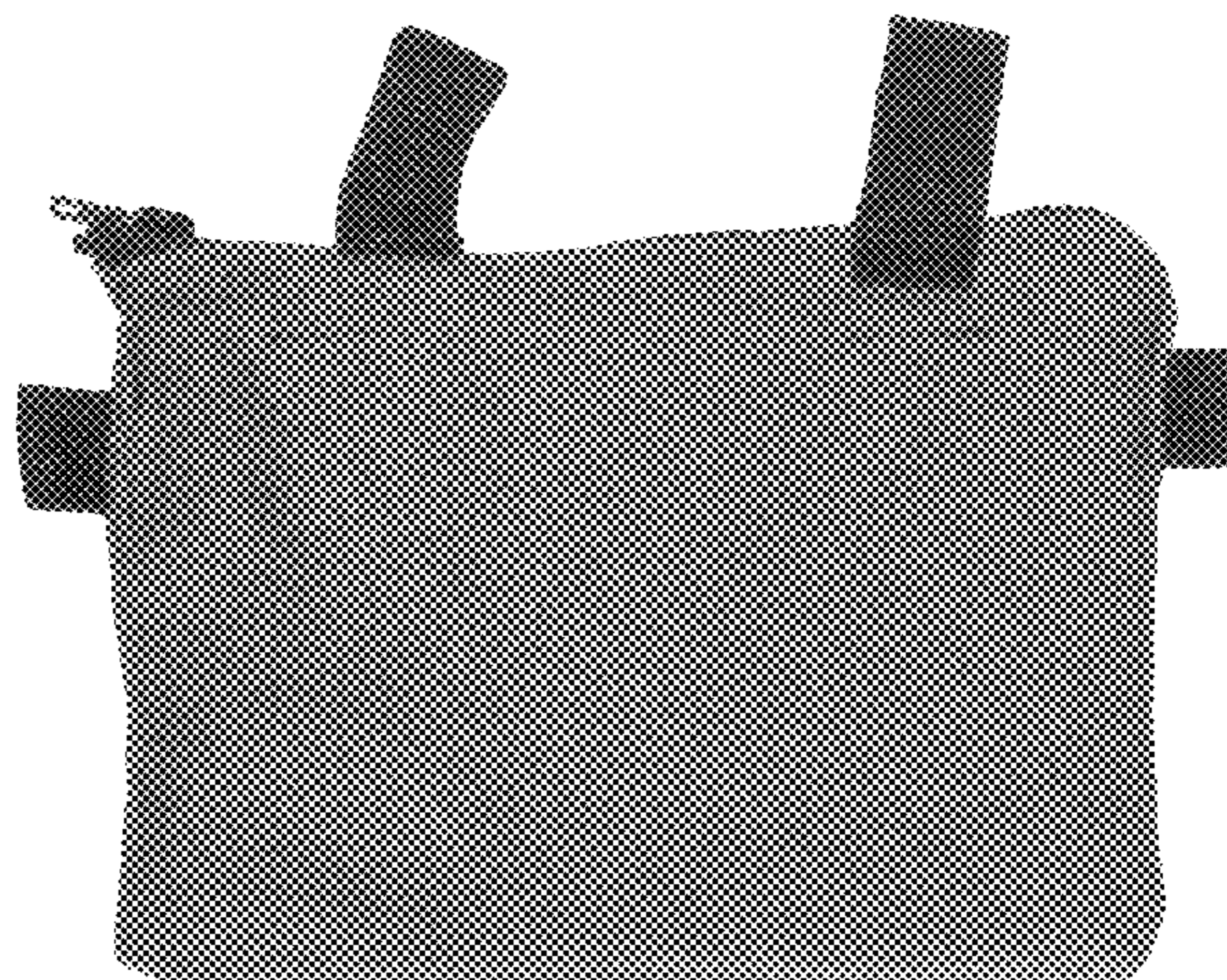
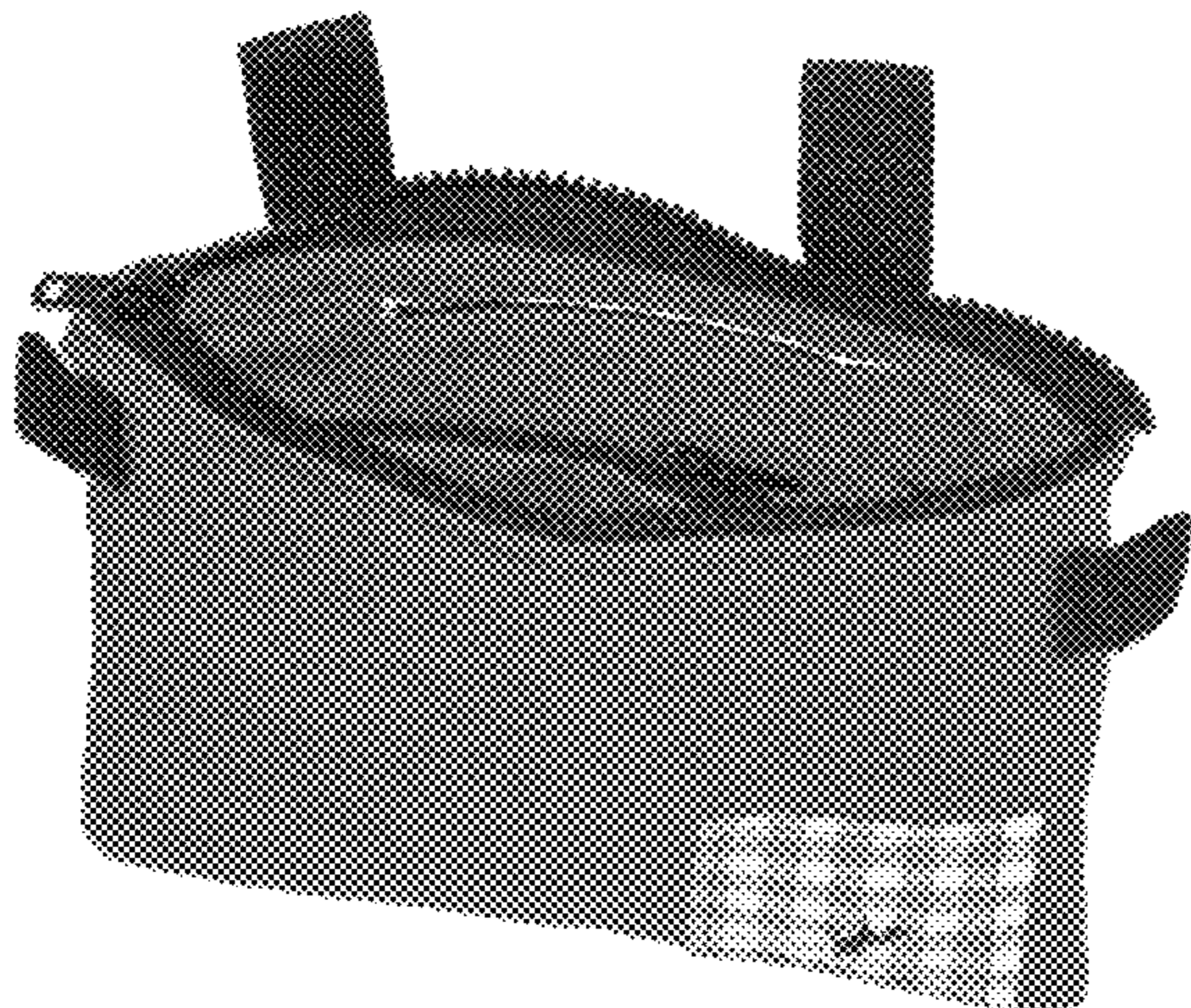
**DESCRIPTION**

FIG. 1 is a top front perspective view for a storage pouch for pet leash with the top opened showing my new design; FIG. 2 is a front side view thereof; FIG. 3 is a back side view thereof; FIG. 4 is a bottom side view thereof; FIG. 5 is a top side view with the zipper closed thereof; FIG. 6 is a right side view thereof; FIG. 7 is a left side view thereof; FIG. 8 is a top side view with the zipper open thereof; and, FIG. 9 is a top side view with the zipper and water proof pocket open.

The broken line showing of the pet leash in FIG. 1 illustrates the environment of the claimed design and form no part thereof. The broken lines in FIGS. 1-3 illustrate portions of the storage pouch for pet leash which form no part of the claimed design.

The break lines indicate that the appearance of any portion of the storage pouch for pet leash between the break lines forms a part of the claimed design.

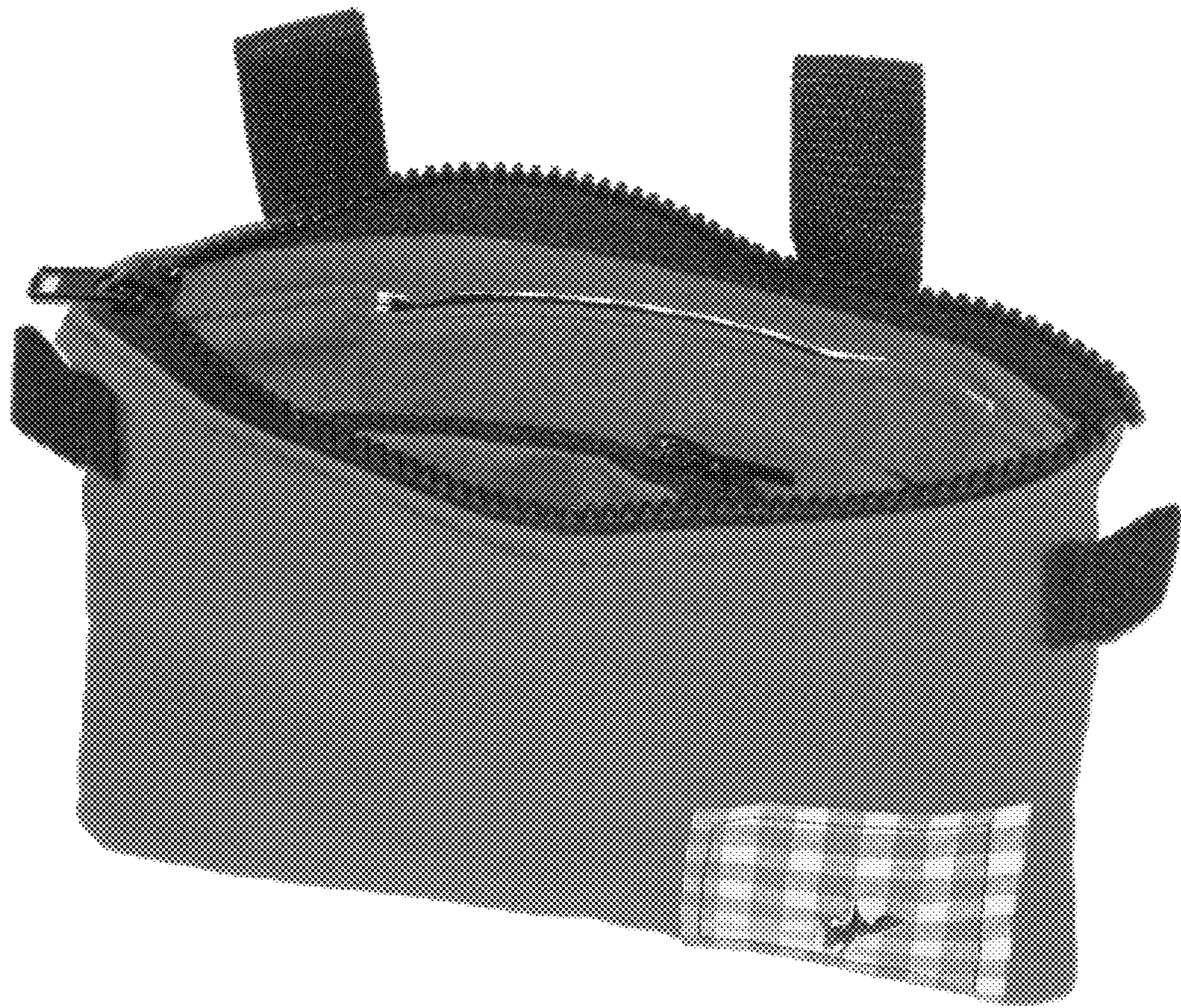

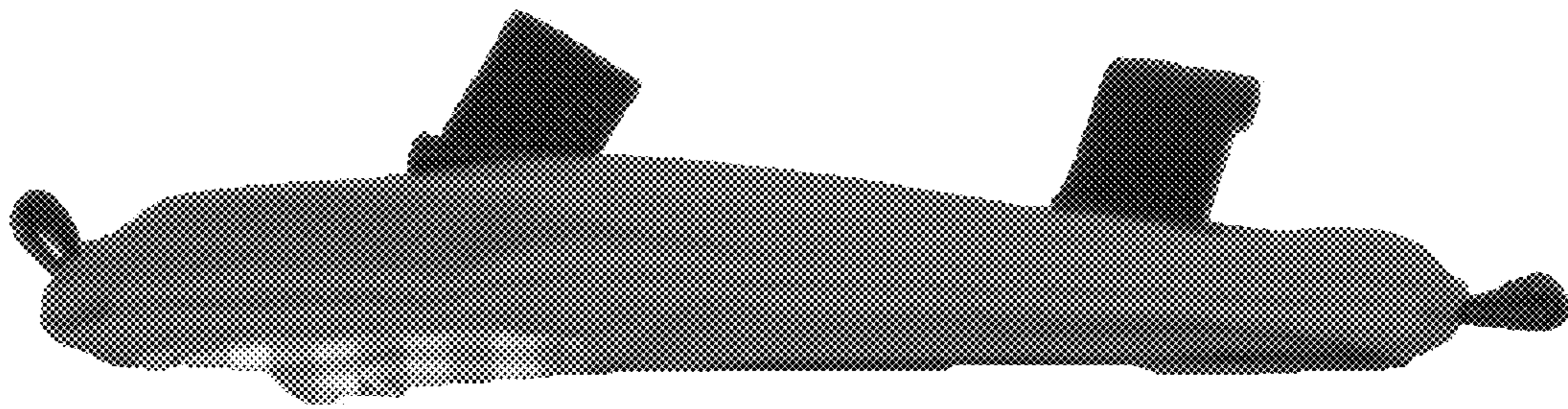

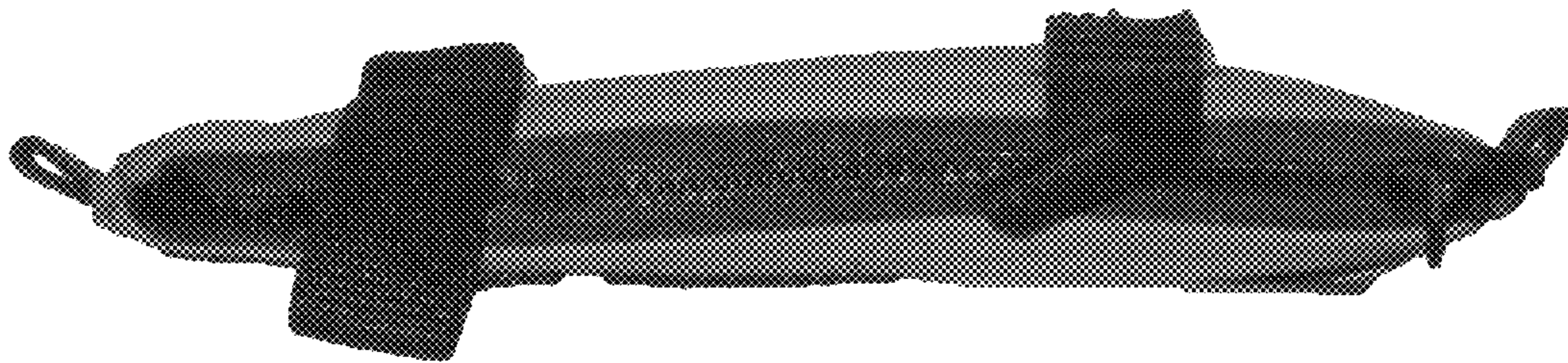

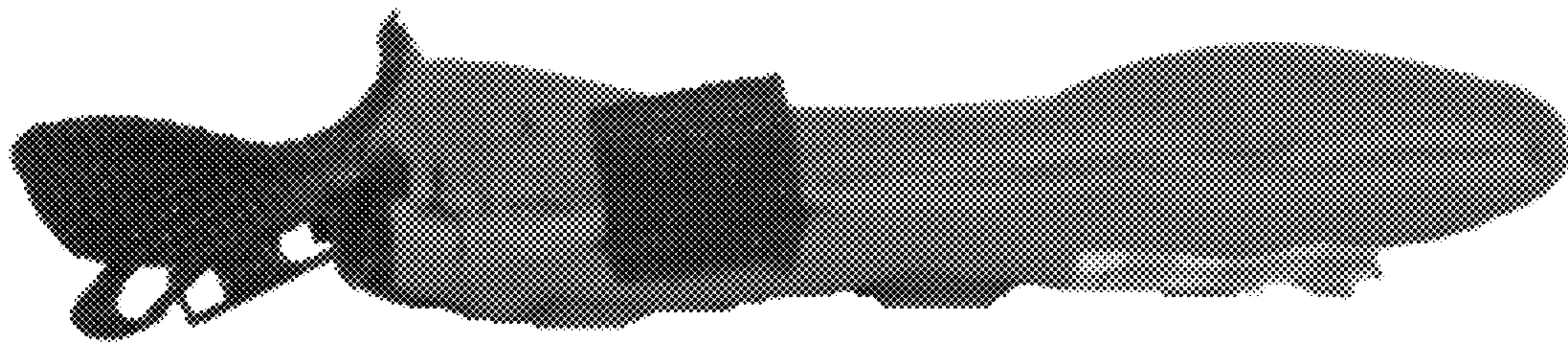

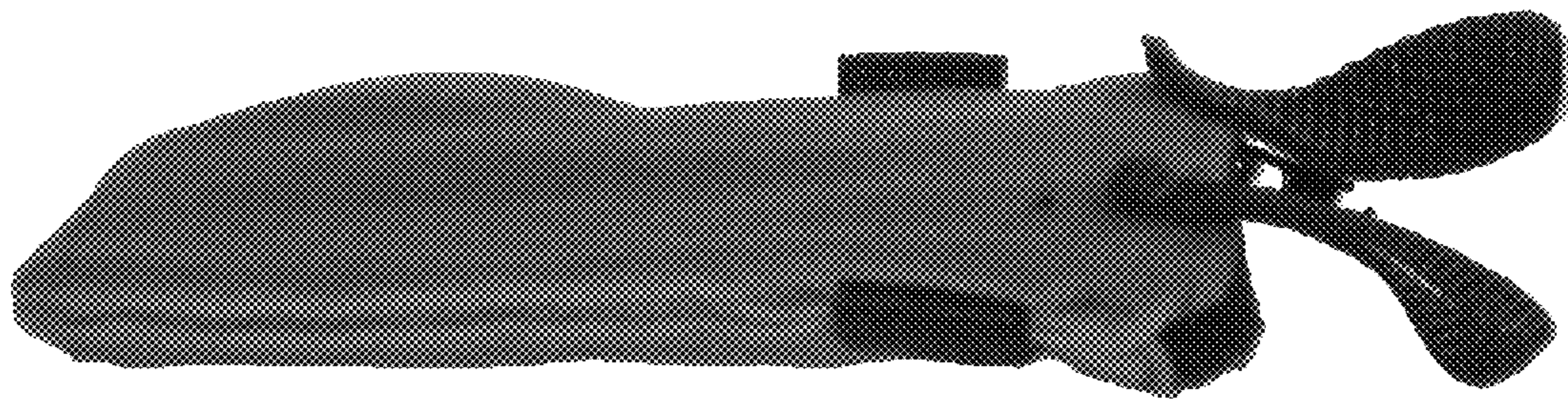

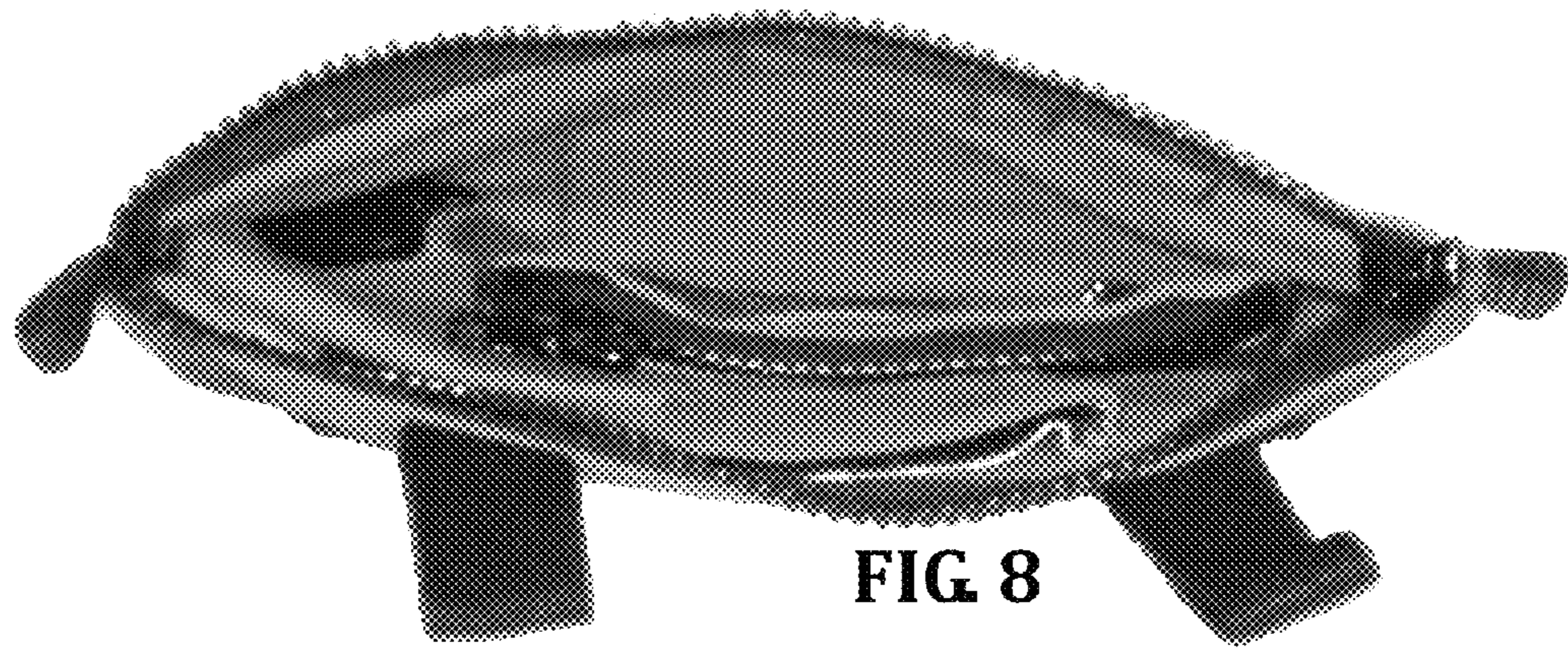

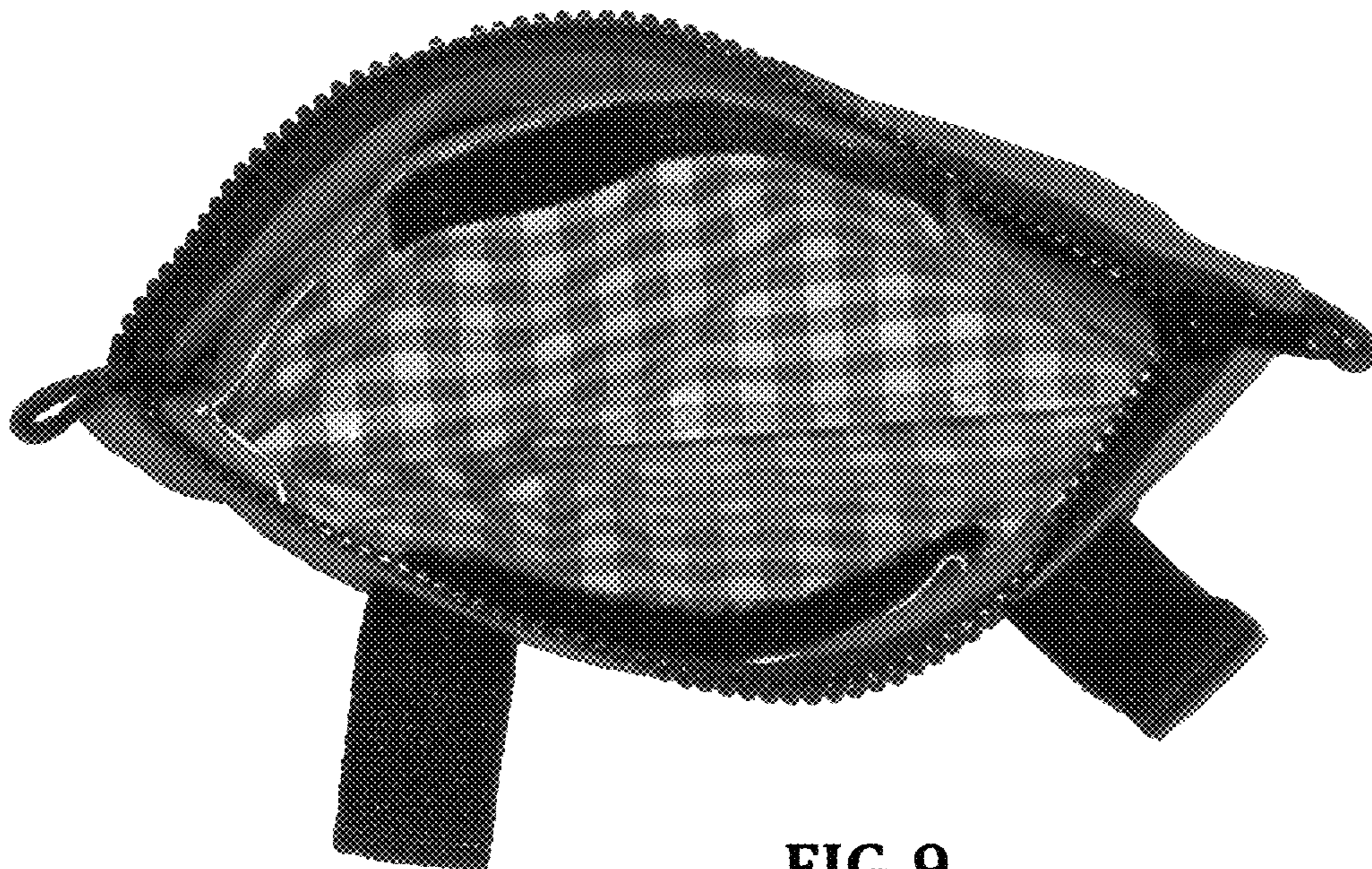
