(57) **CLAIM**

The ornamental design for a toothbrush, as shown and  
described.

**DESCRIPTION**

FIG. 1 depicts a front bottom perspective view of a toothbrush  
of the present ornamental design;  
FIG. 2 depicts a front top perspective view of the ornamental  
design shown in FIG. 1;  
FIG. 3 depicts a rear elevation view of the ornamental design  
shown in FIG. 2;  
FIG. 4 depicts a front elevation view of the ornamental design  
shown in FIG. 2;  
FIG. 5 depicts a left side elevation view of the ornamental  
design shown in FIG. 2, wherein the toothbrush has left-right  
symmetry;  
FIG. 6 depicts a top plan view of the ornamental design shown  
in FIG. 2; and,  
FIG. 7 depicts a bottom plan view of the ornamental design  
shown in FIG. 2.  
The broken lines showing the two sets of bristles illustrate  
portions of the toothbrush that form no part of the claimed  
design.
