The ornamental design for a mattress cover, as shown and described.

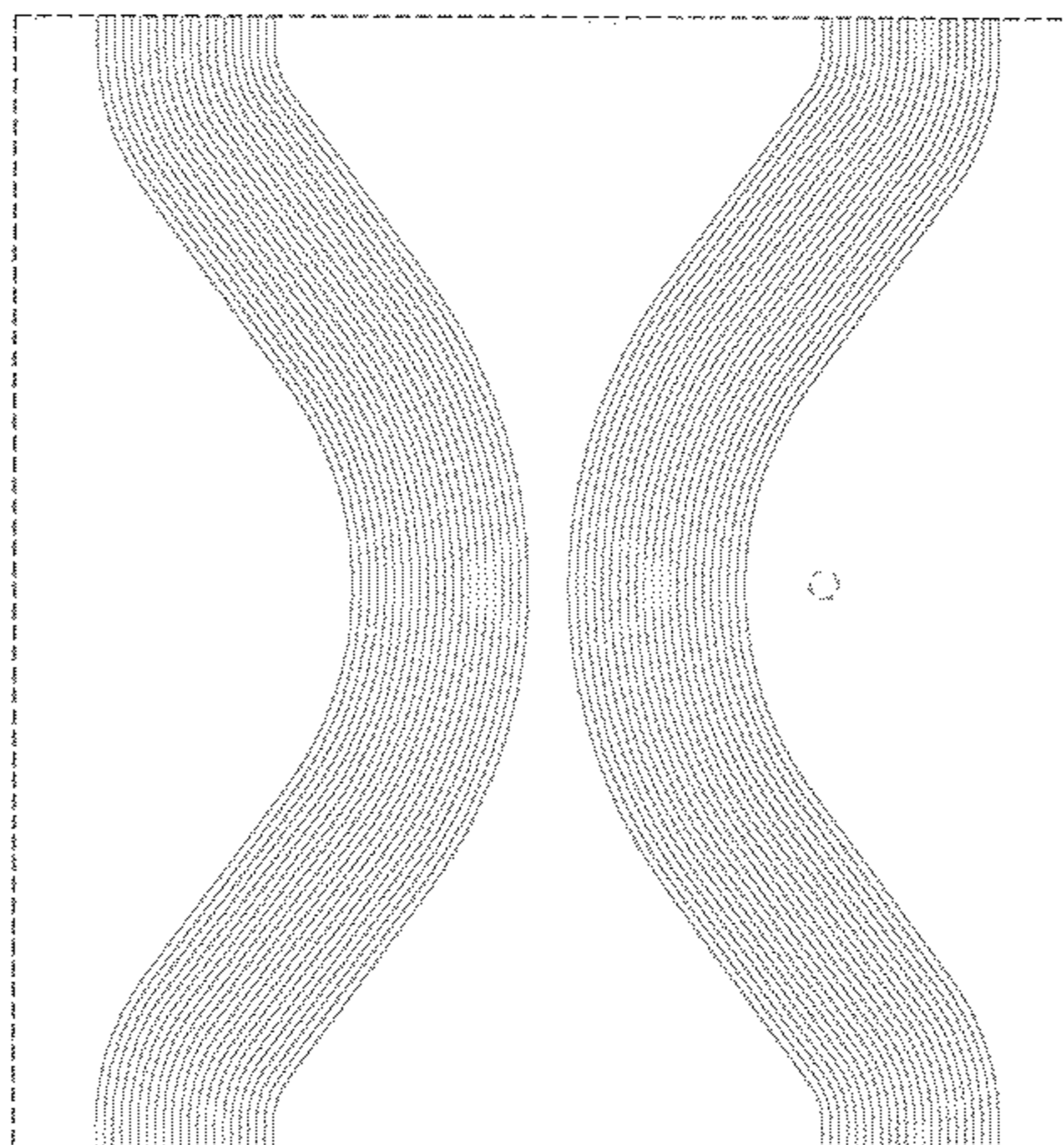
**DESCRIPTION**

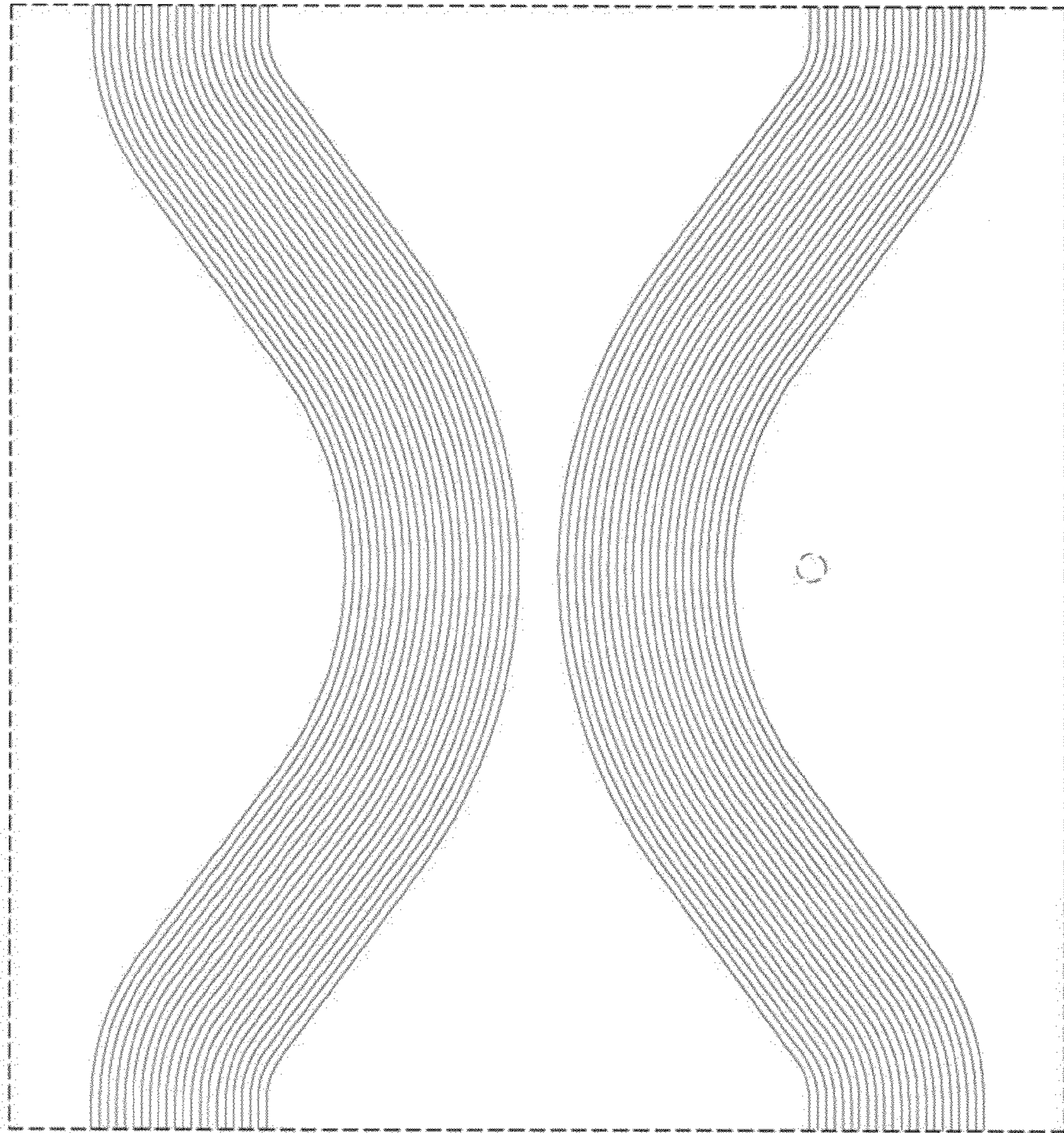

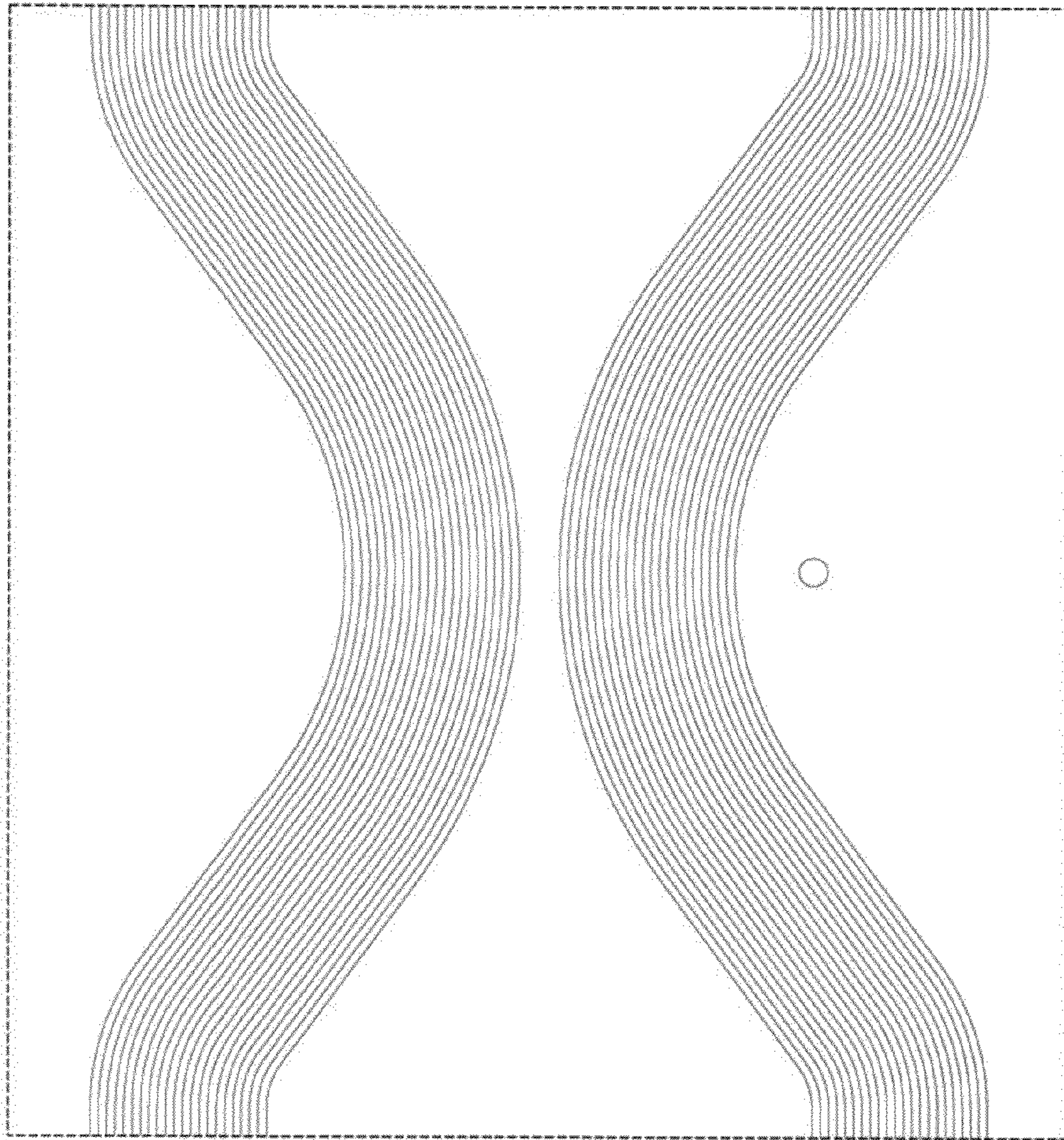
