FIG. 6 is a bottom plan view thereof.

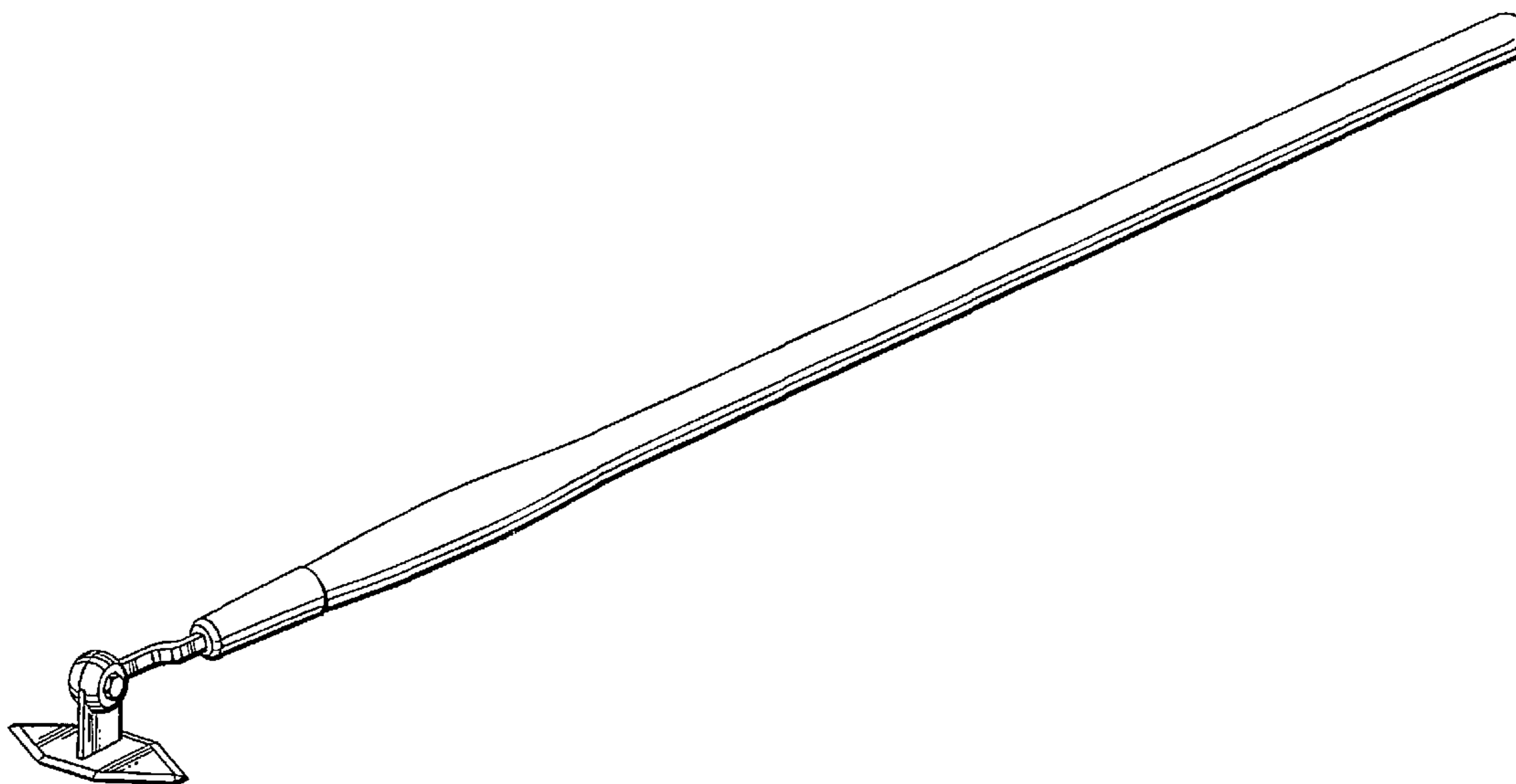
FIG. 7 is an elevational view from the left end thereof; and,

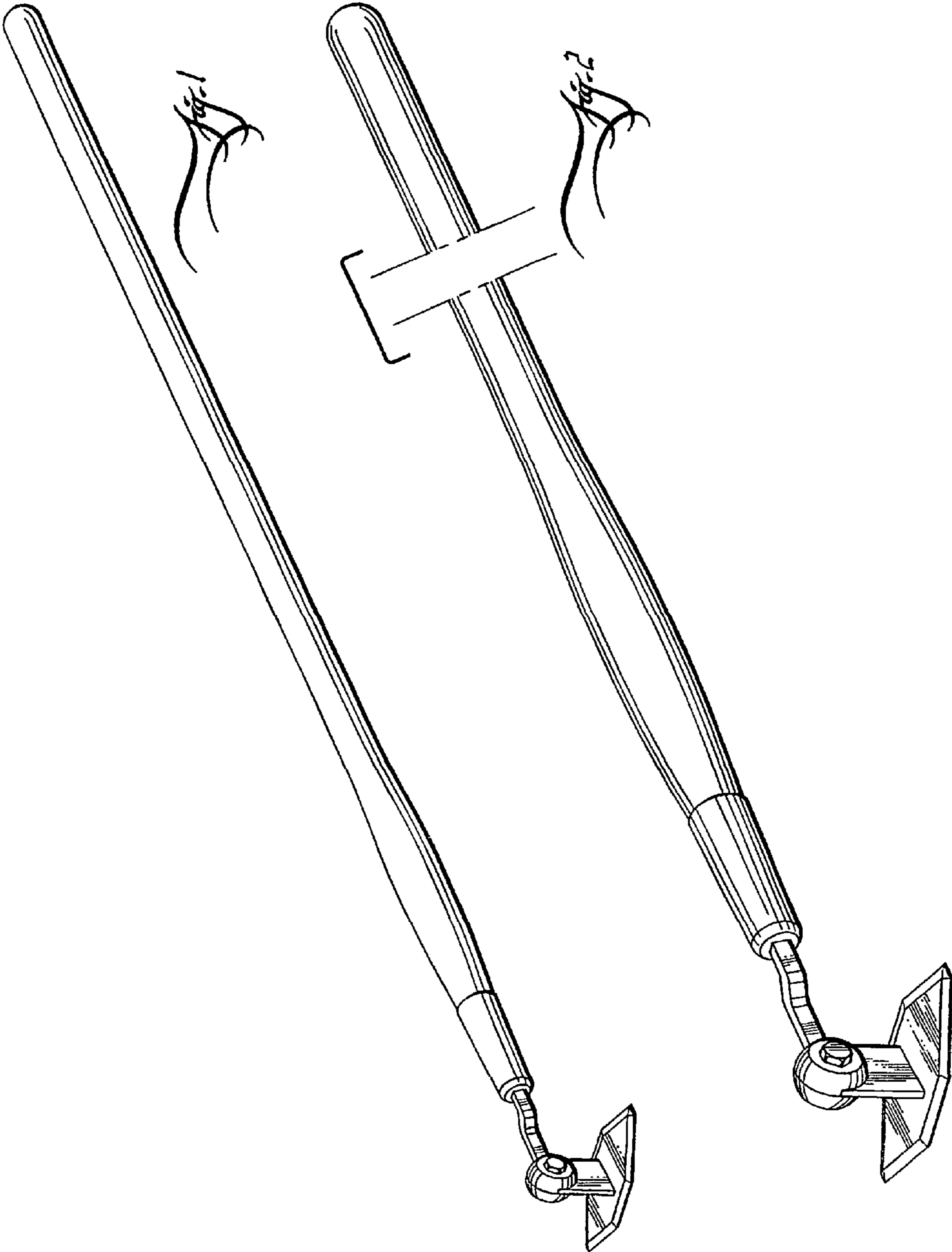
FIG. 8 is an elevational view of the right end thereof.

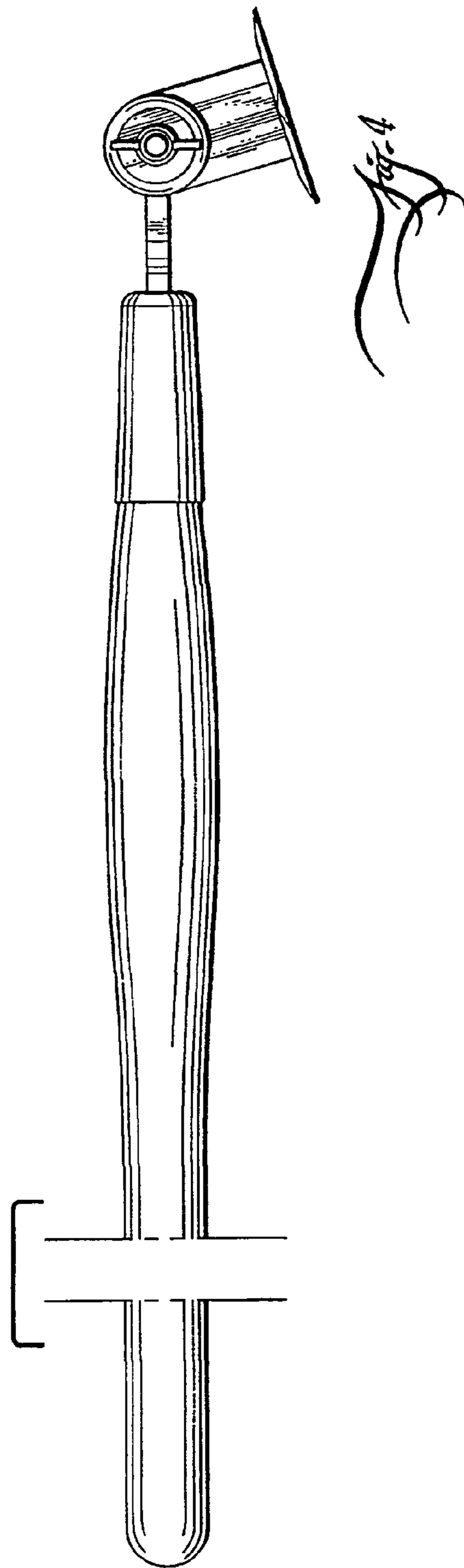
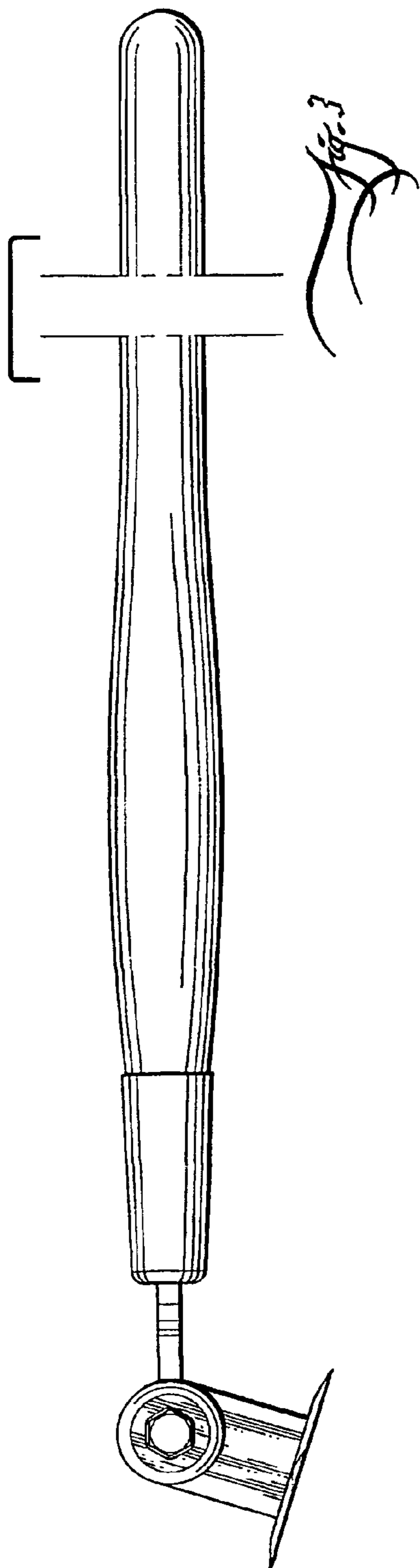
The weed eradicator is shown with a symbolic break in the handle. The appearance of any portion of the article between the break lines from no part of the claimed design.

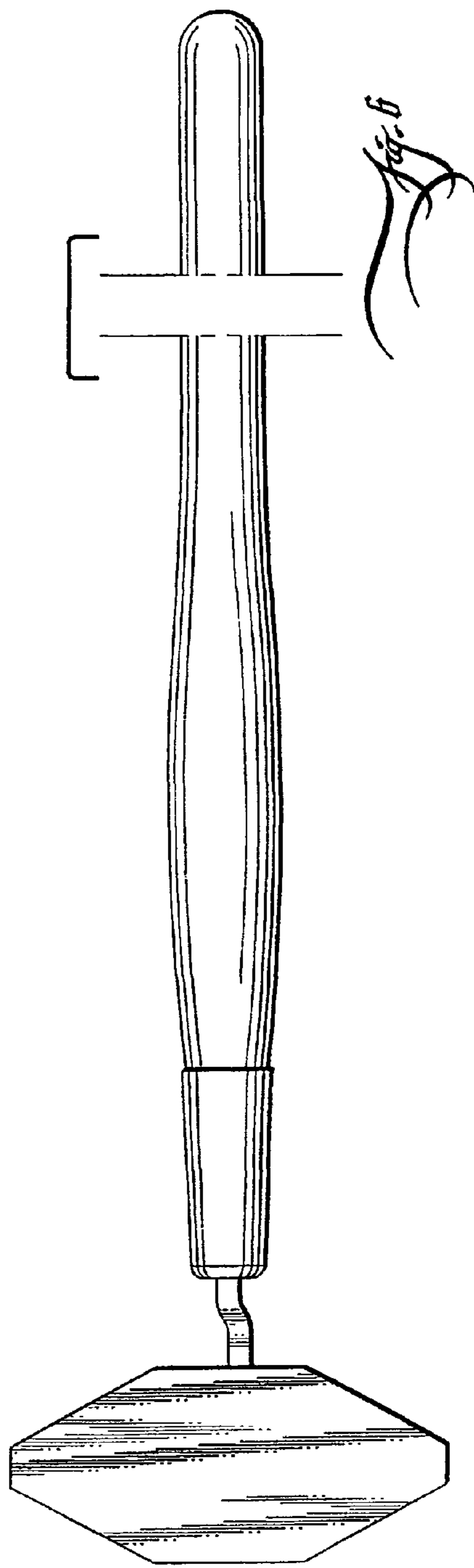
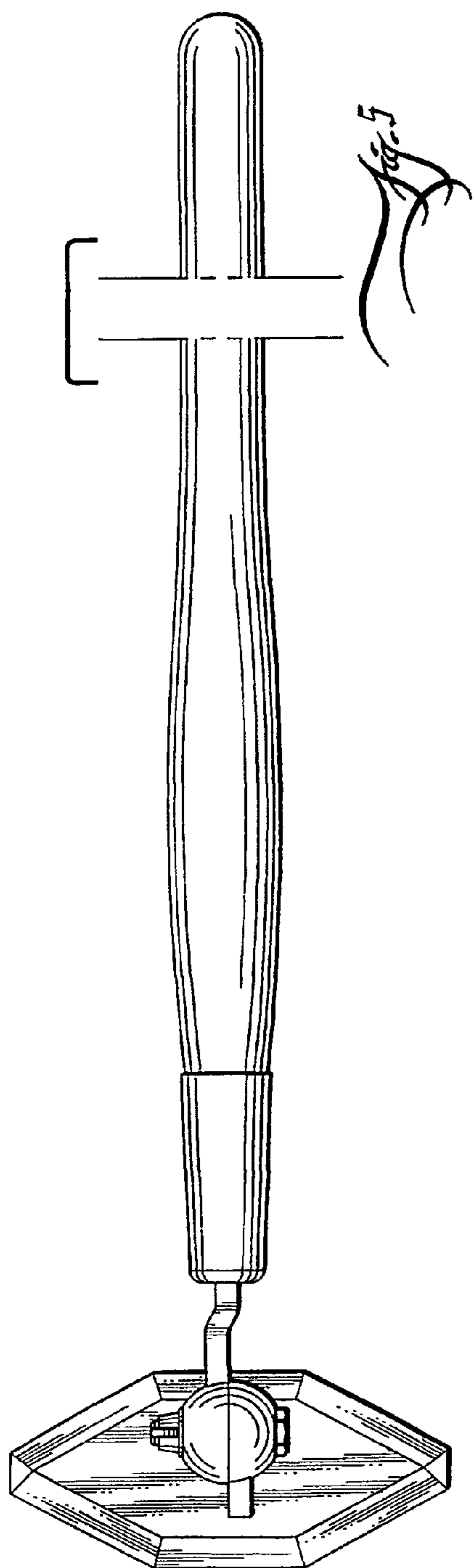
FIGS. 2-6 are shown enlarged for ease of illustration.

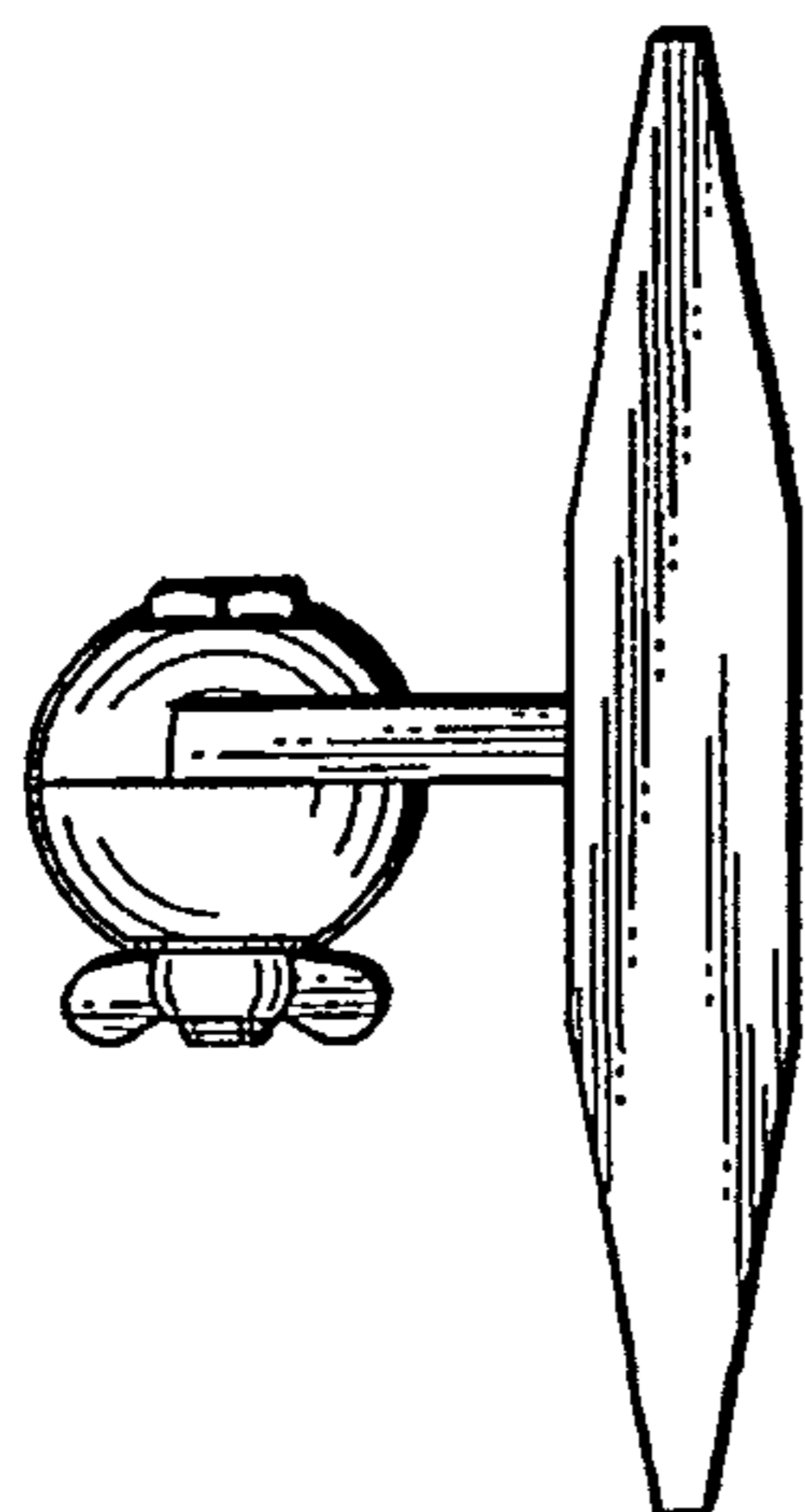

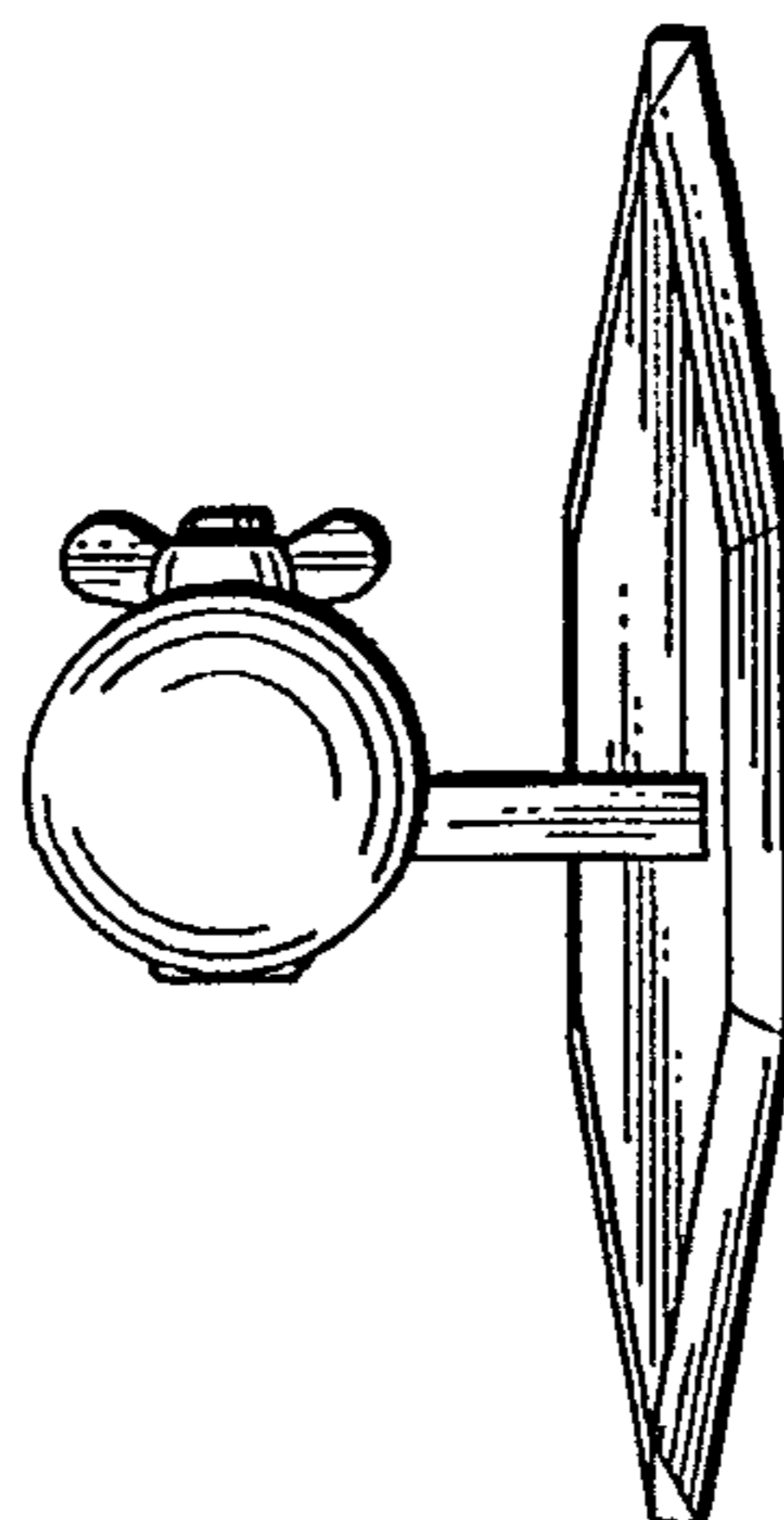
