(57) **CLAIM**

The ornamental design for a foot plate, as shown and described.

DESCRIPTION

FIG. 1 is a perspective top front view of an embodiment of a foot plate showing my new design;

FIG. 2 is a perspective top front view thereof, showing a power tool handle and power tool inserted in the power tool handle, attached to the foot plate;

FIG. 3 is a front side view of the embodiment of FIG. 1;

FIG. 4 is a top view of the embodiment FIG. 1;

FIG. 5 is a bottom view of the embodiment FIG. 1;

FIG. 6 is a left side view of the embodiment FIG. 1;

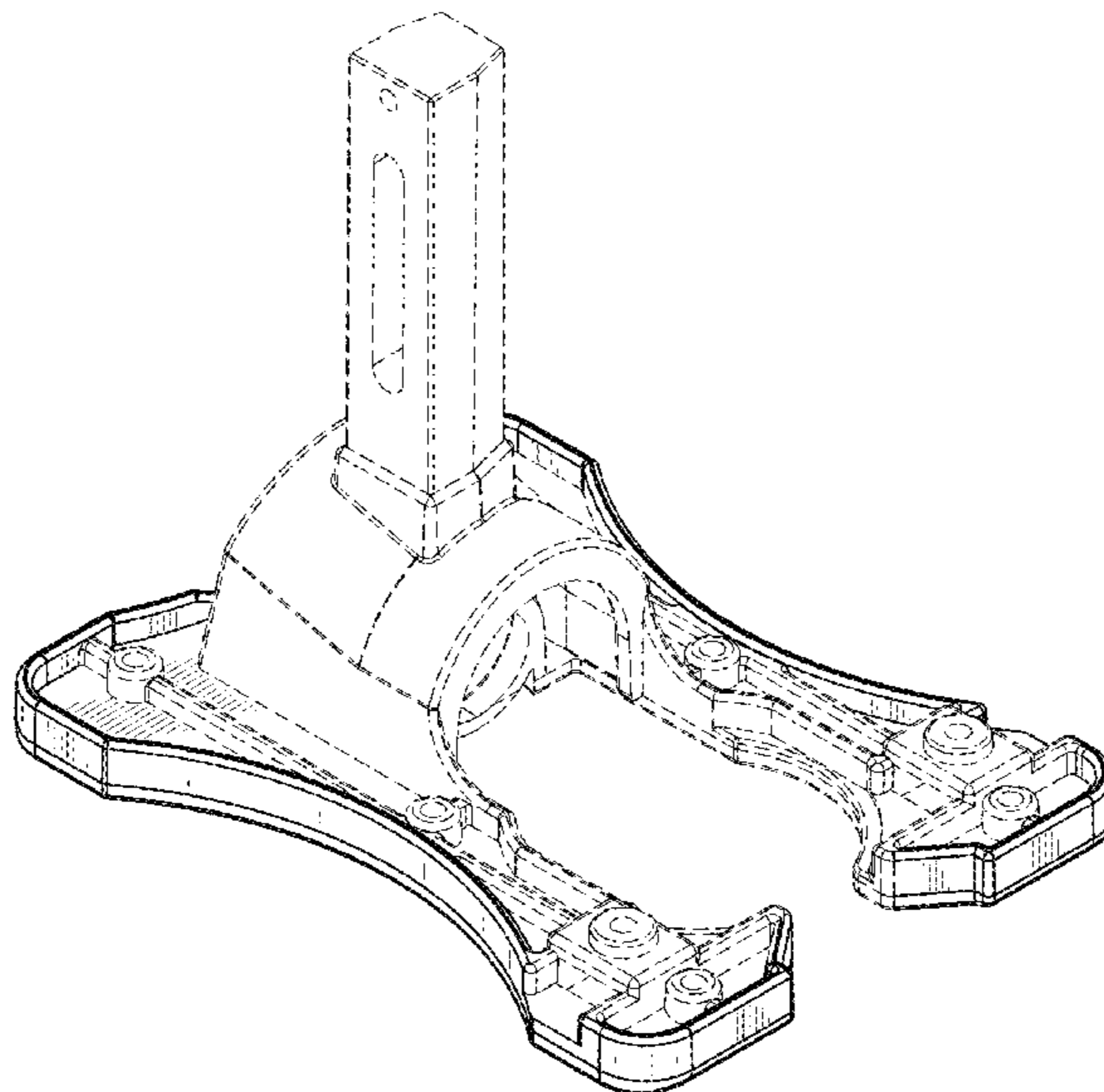
FIG. 7 is a right side view of the embodiment FIG. 1;

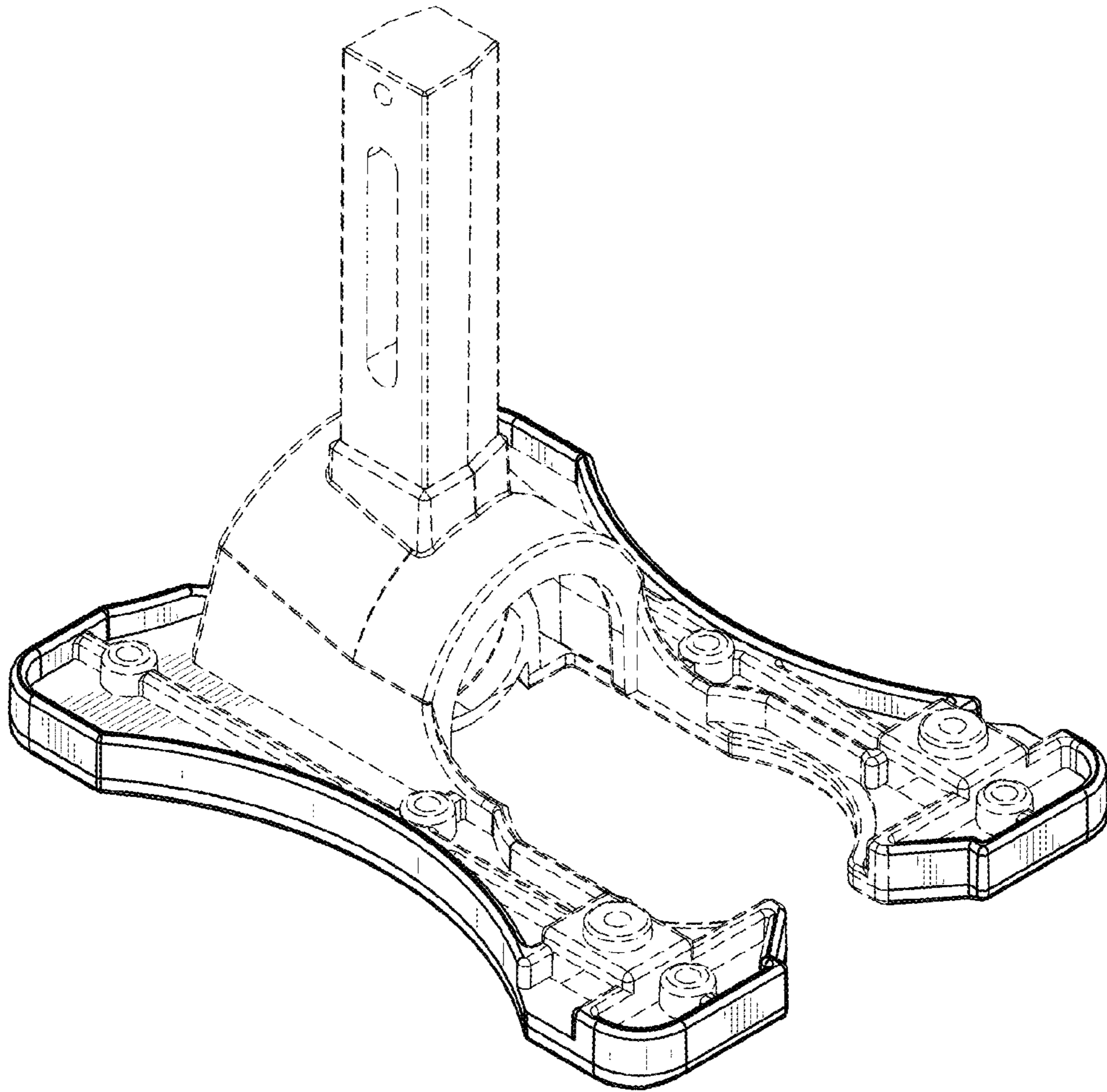

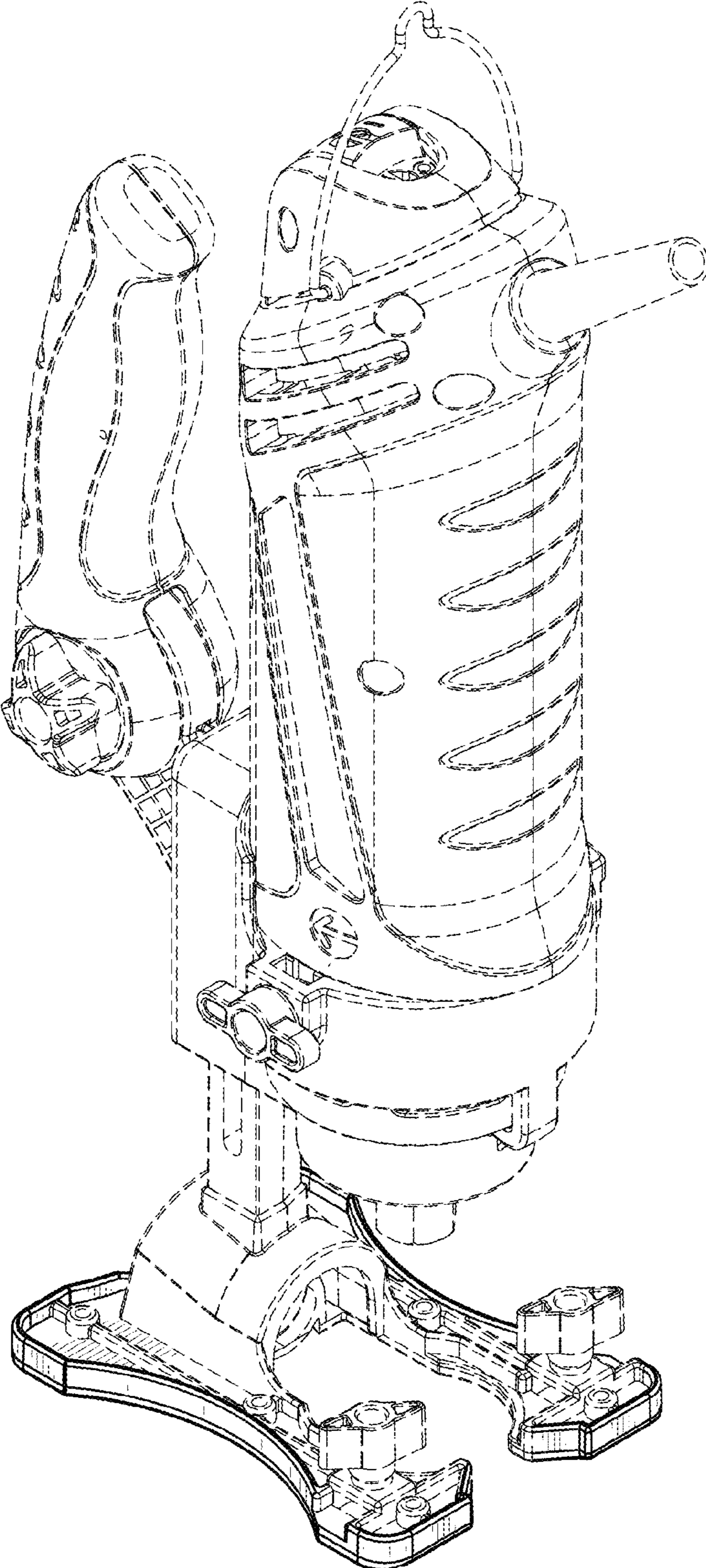

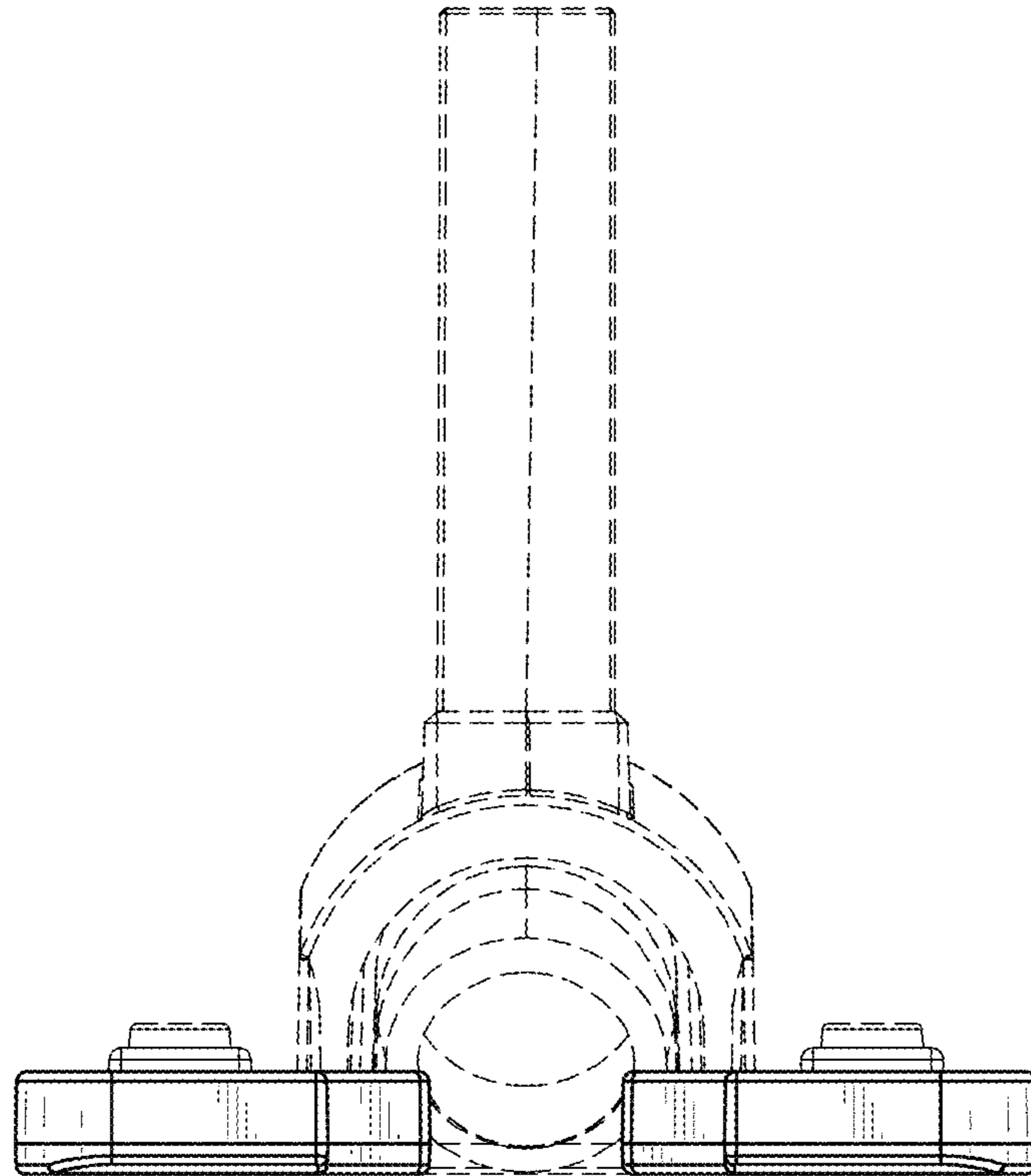

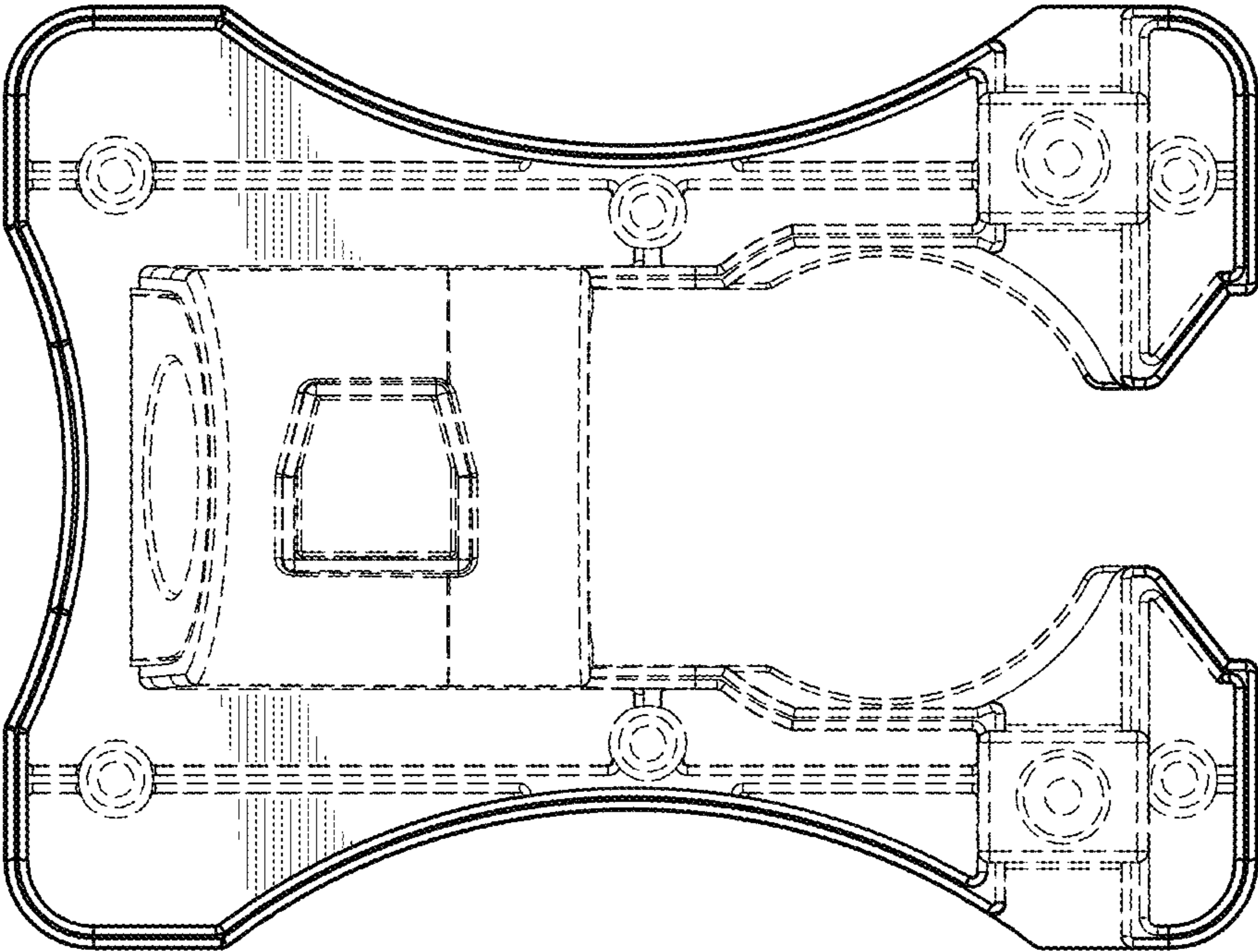

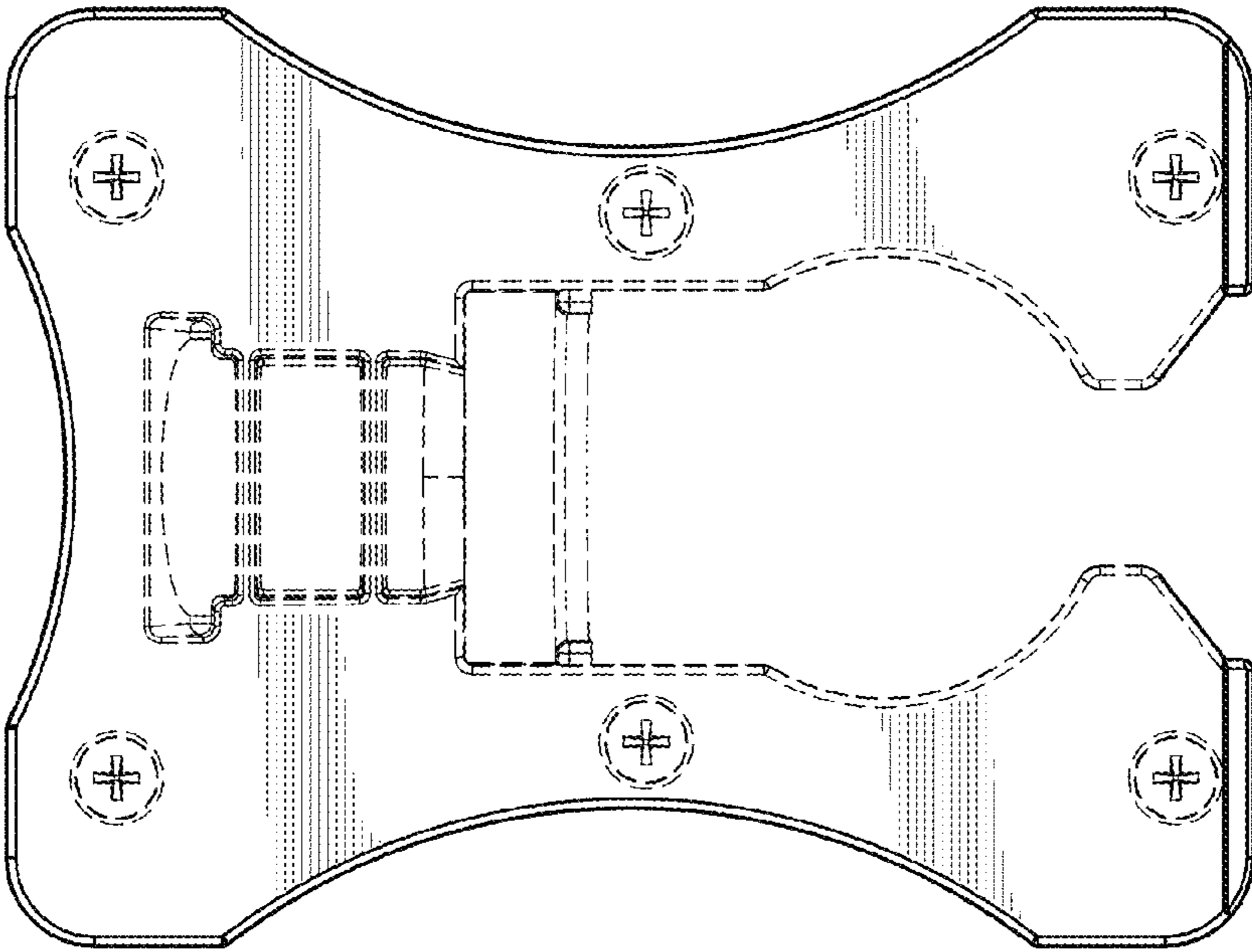

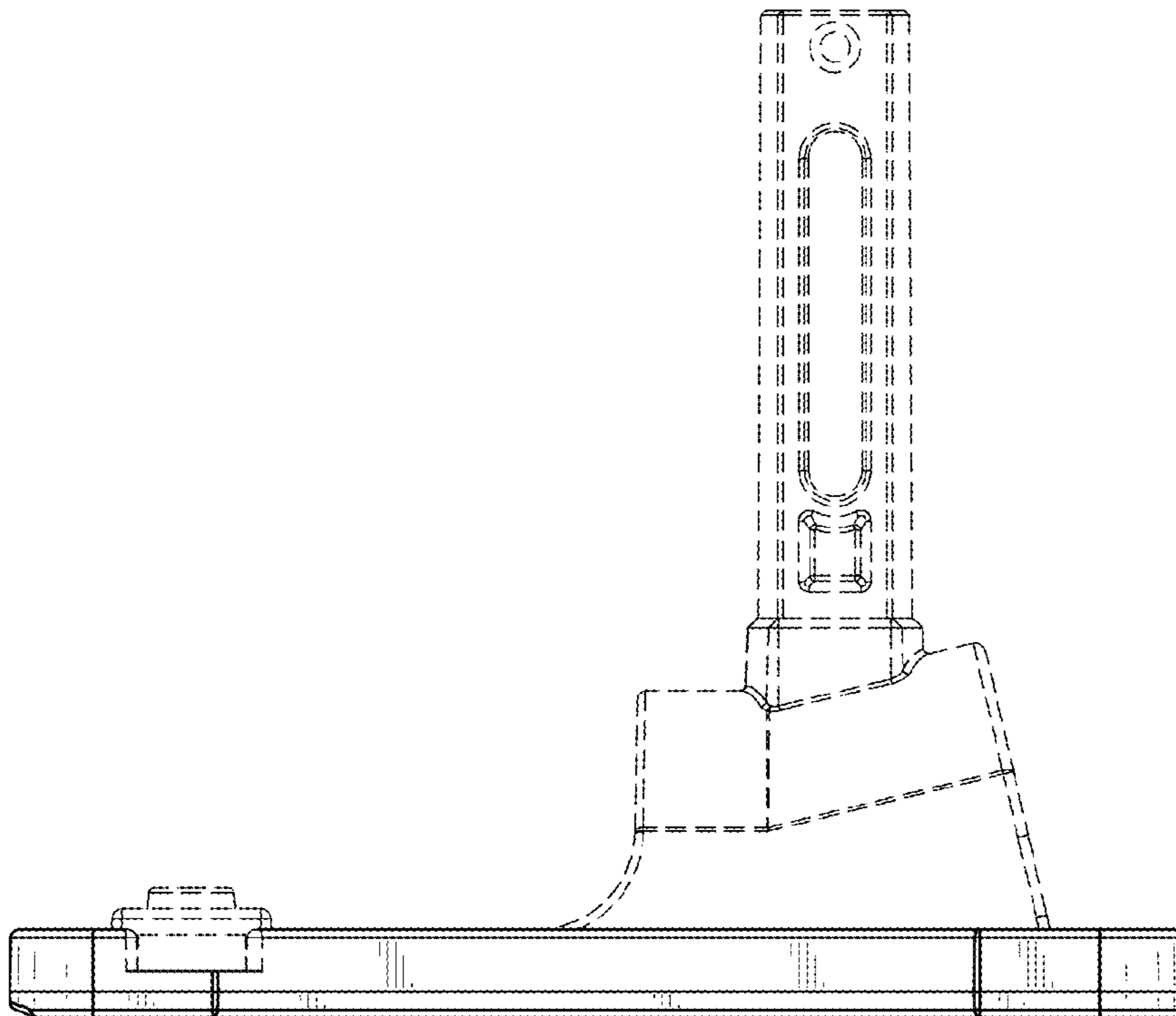

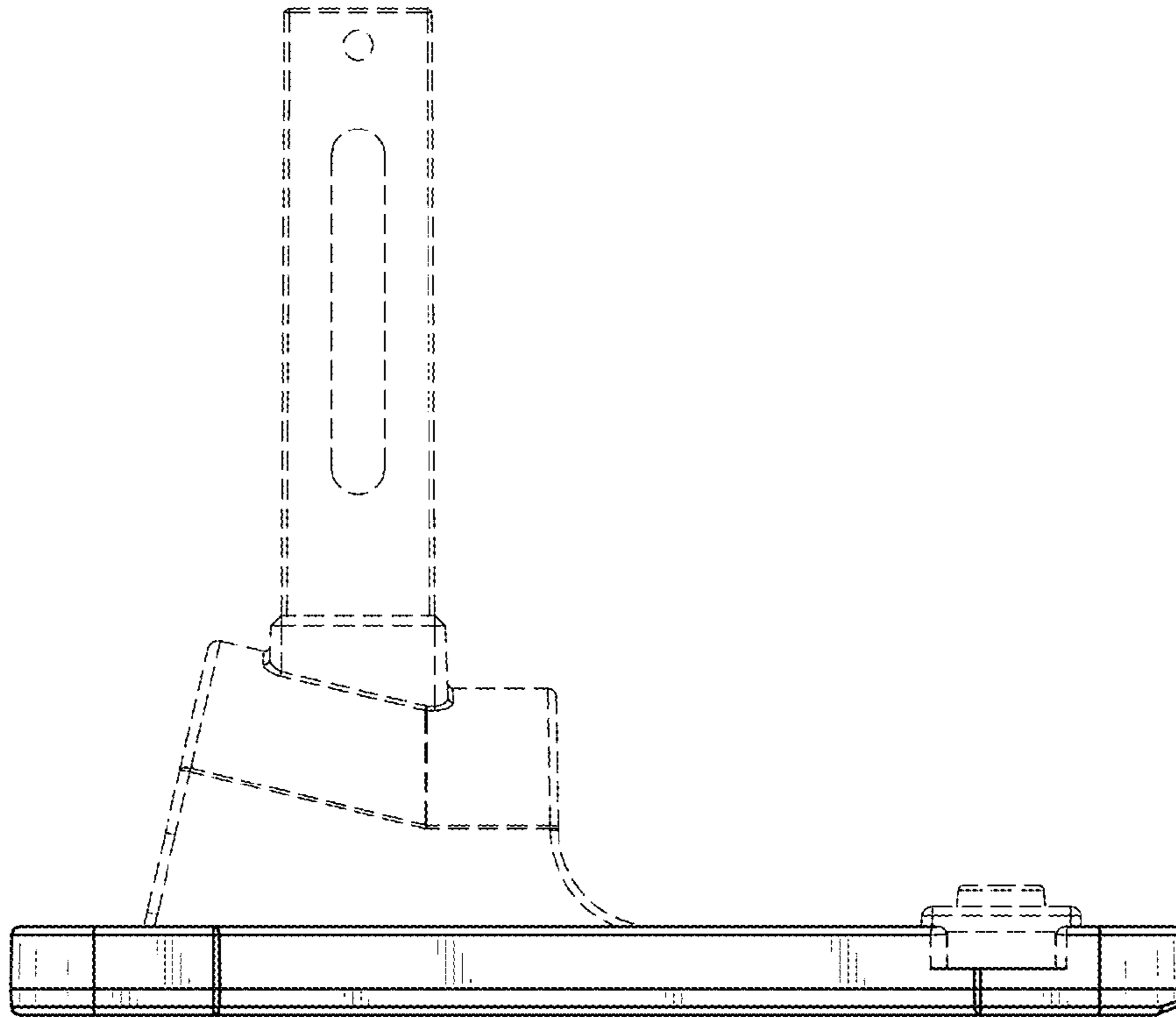

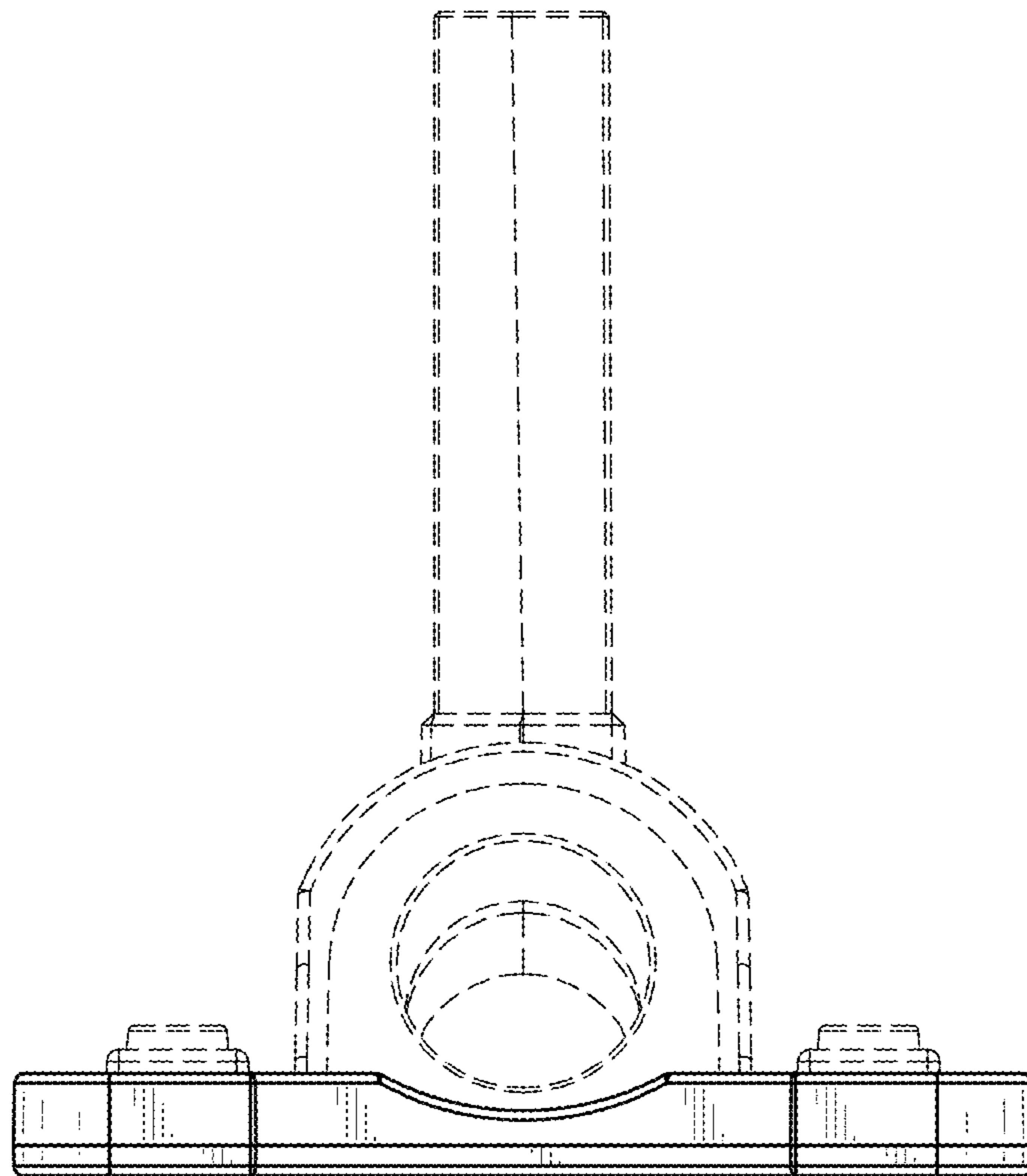

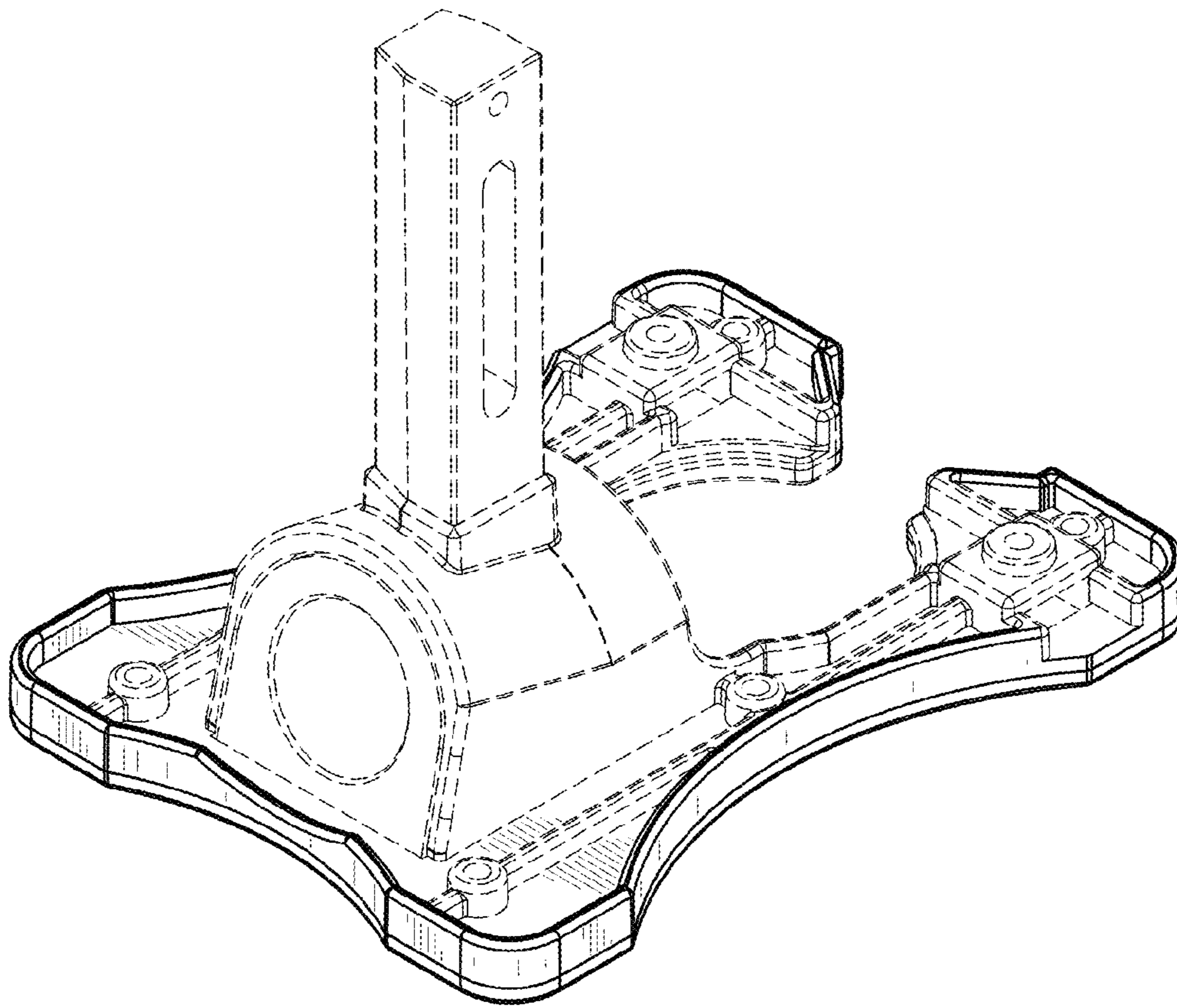
