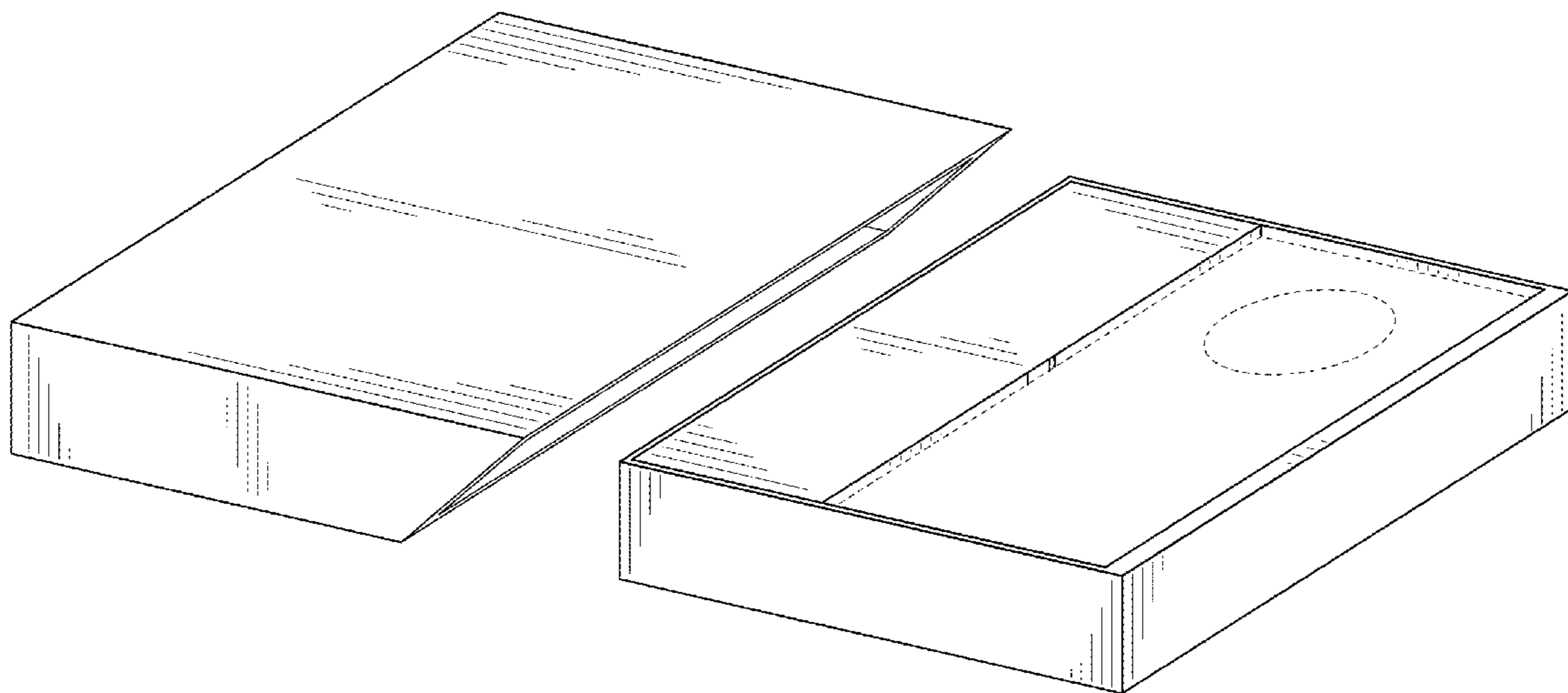
The ornamental design for packaging, as shown and described.

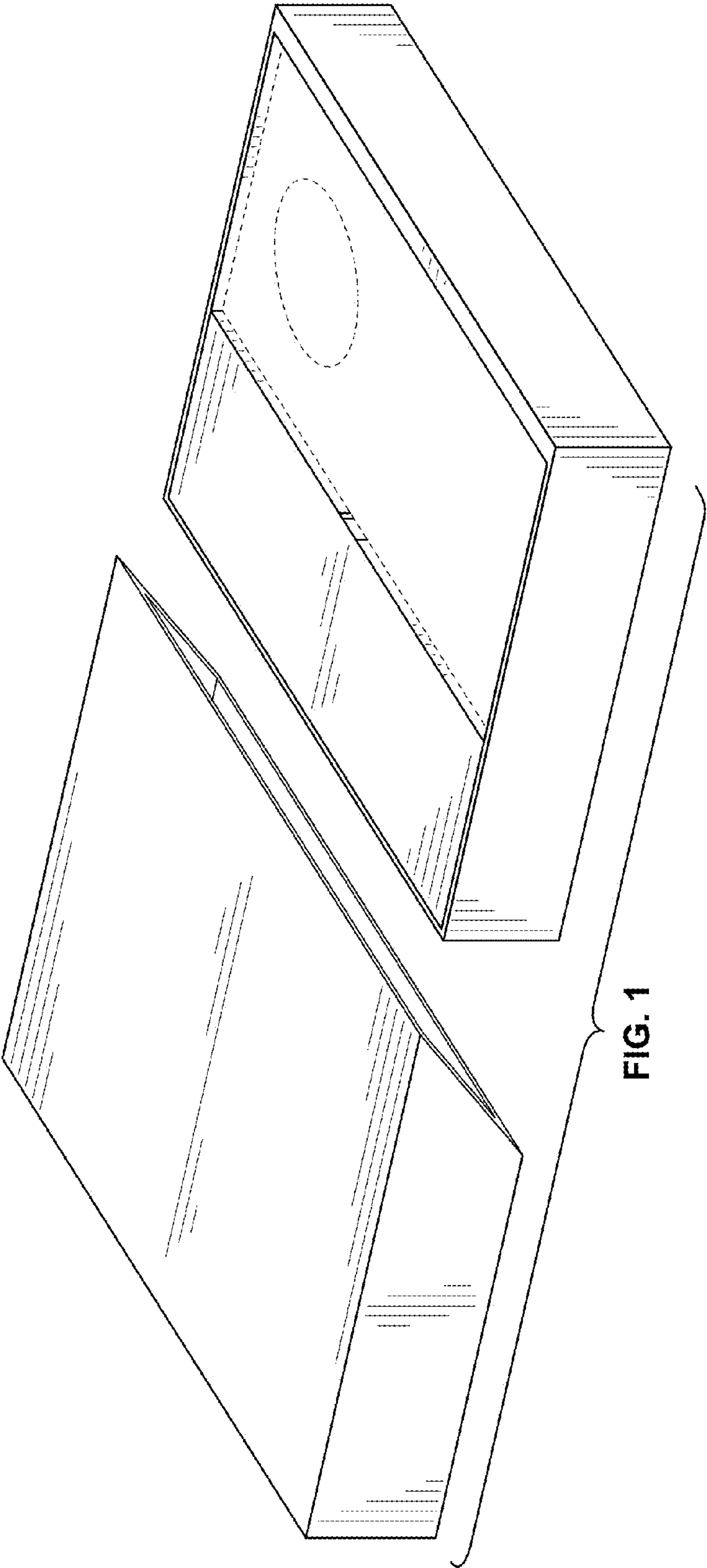
**DESCRIPTION**

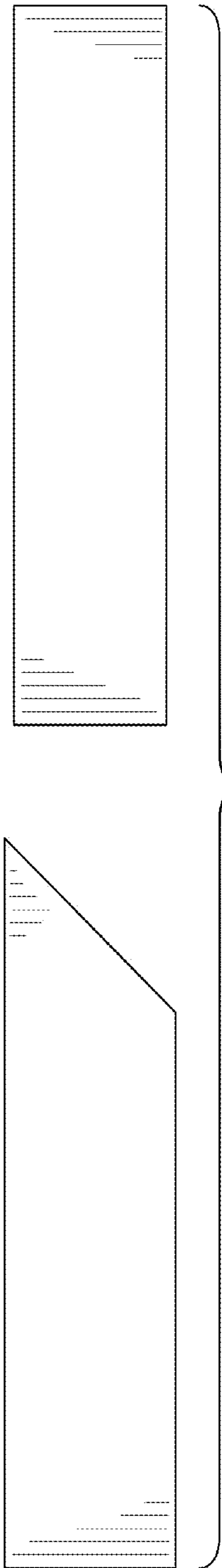

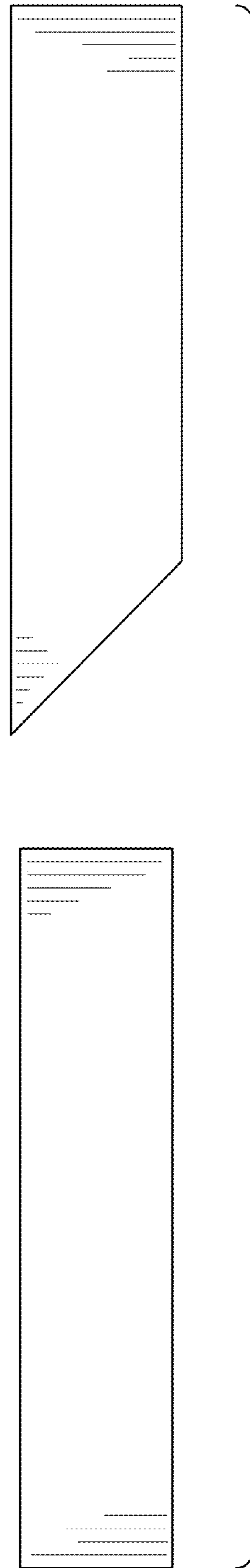

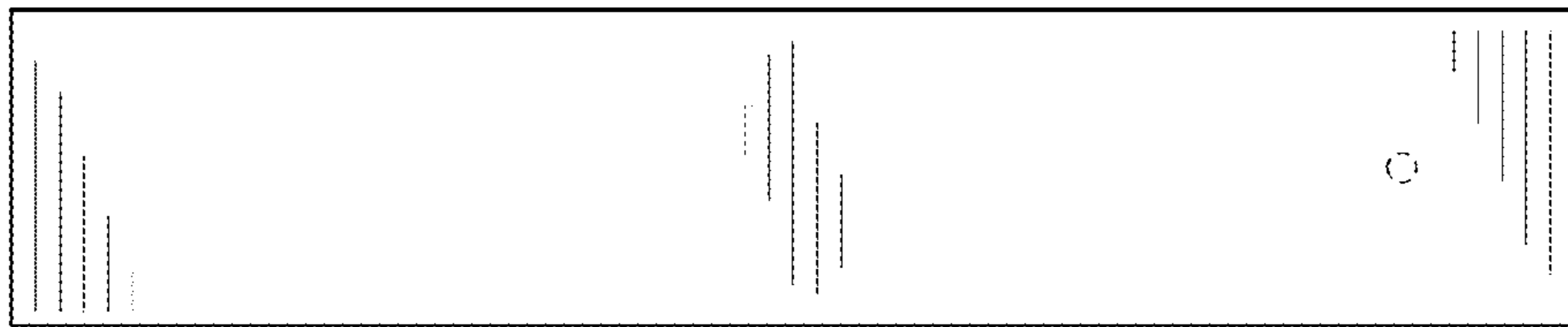

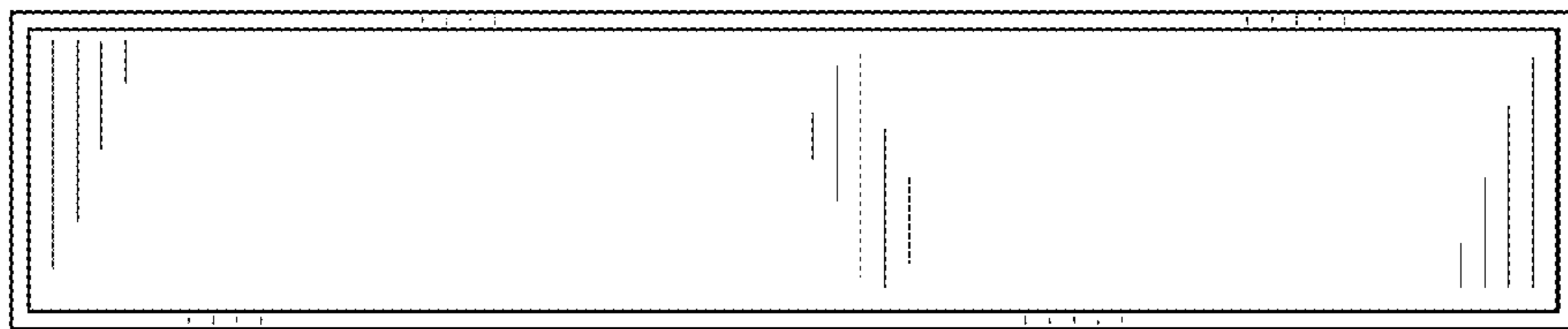

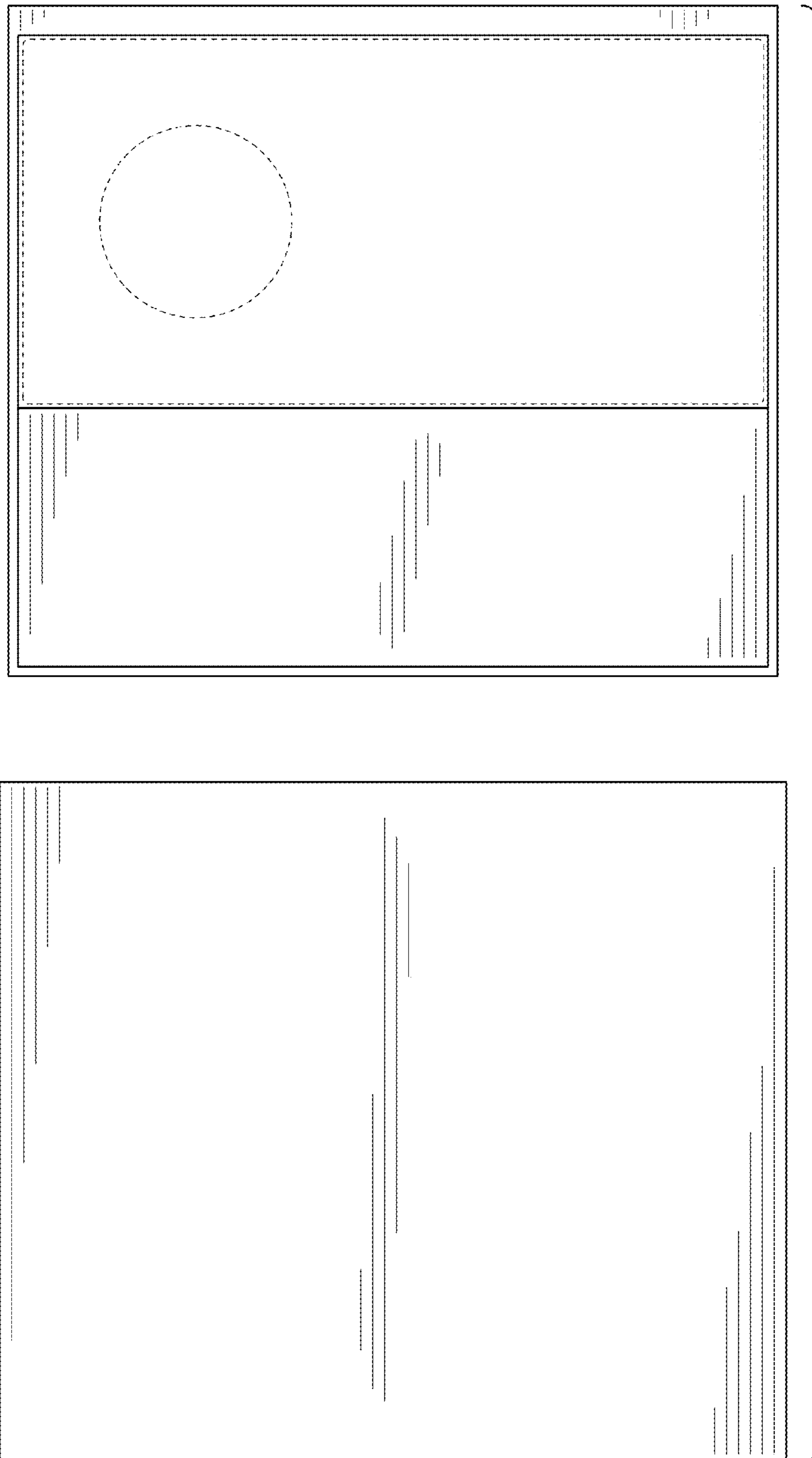

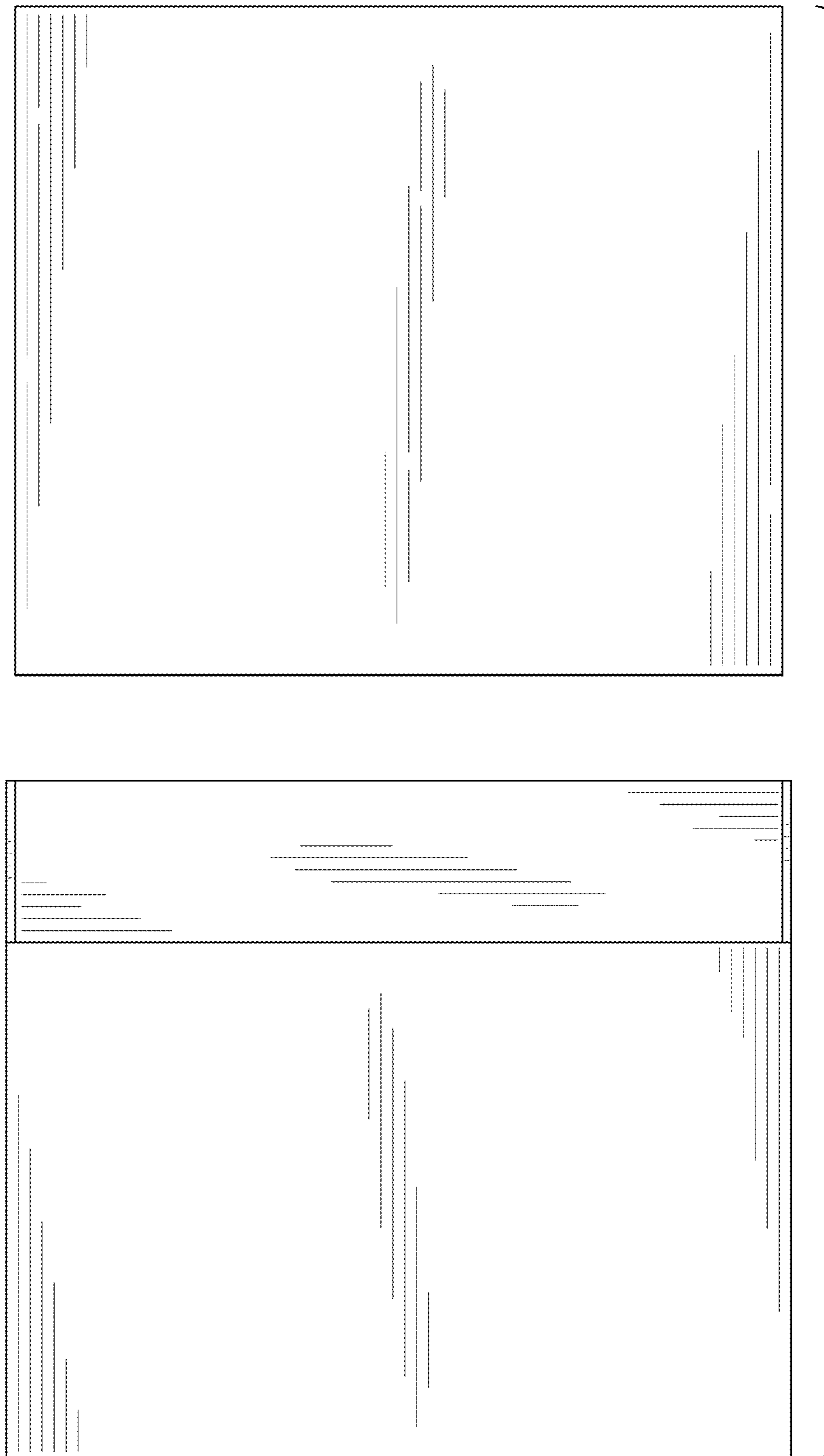

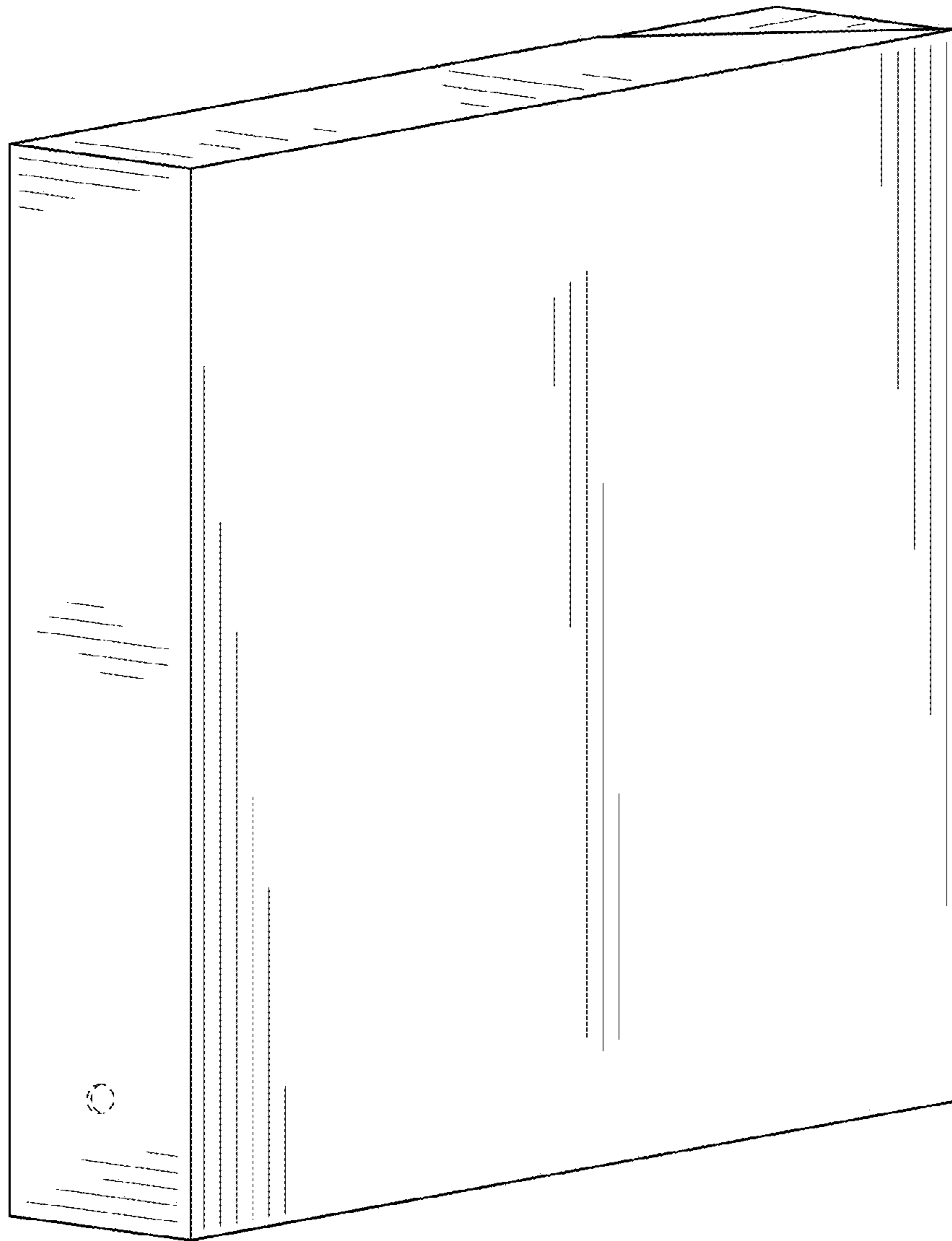

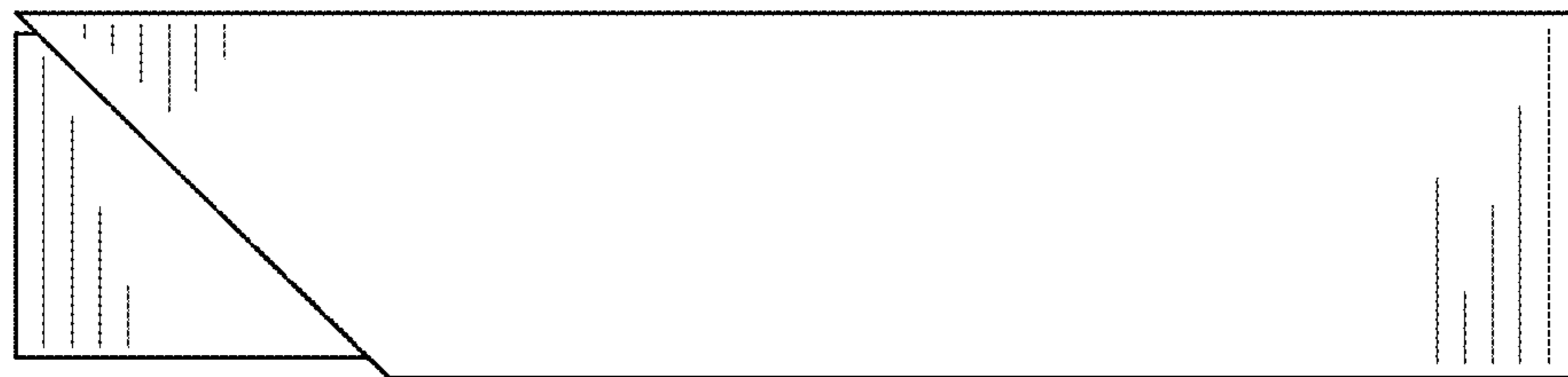

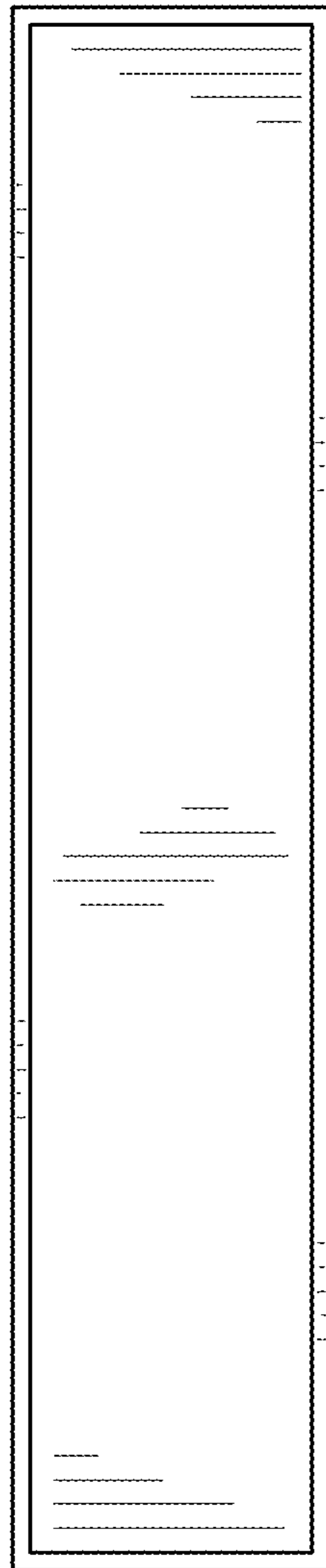

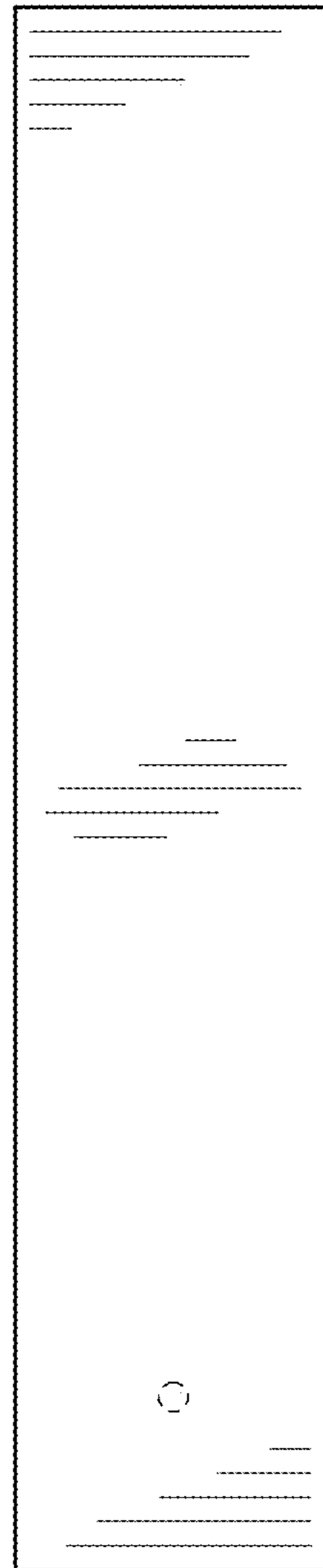

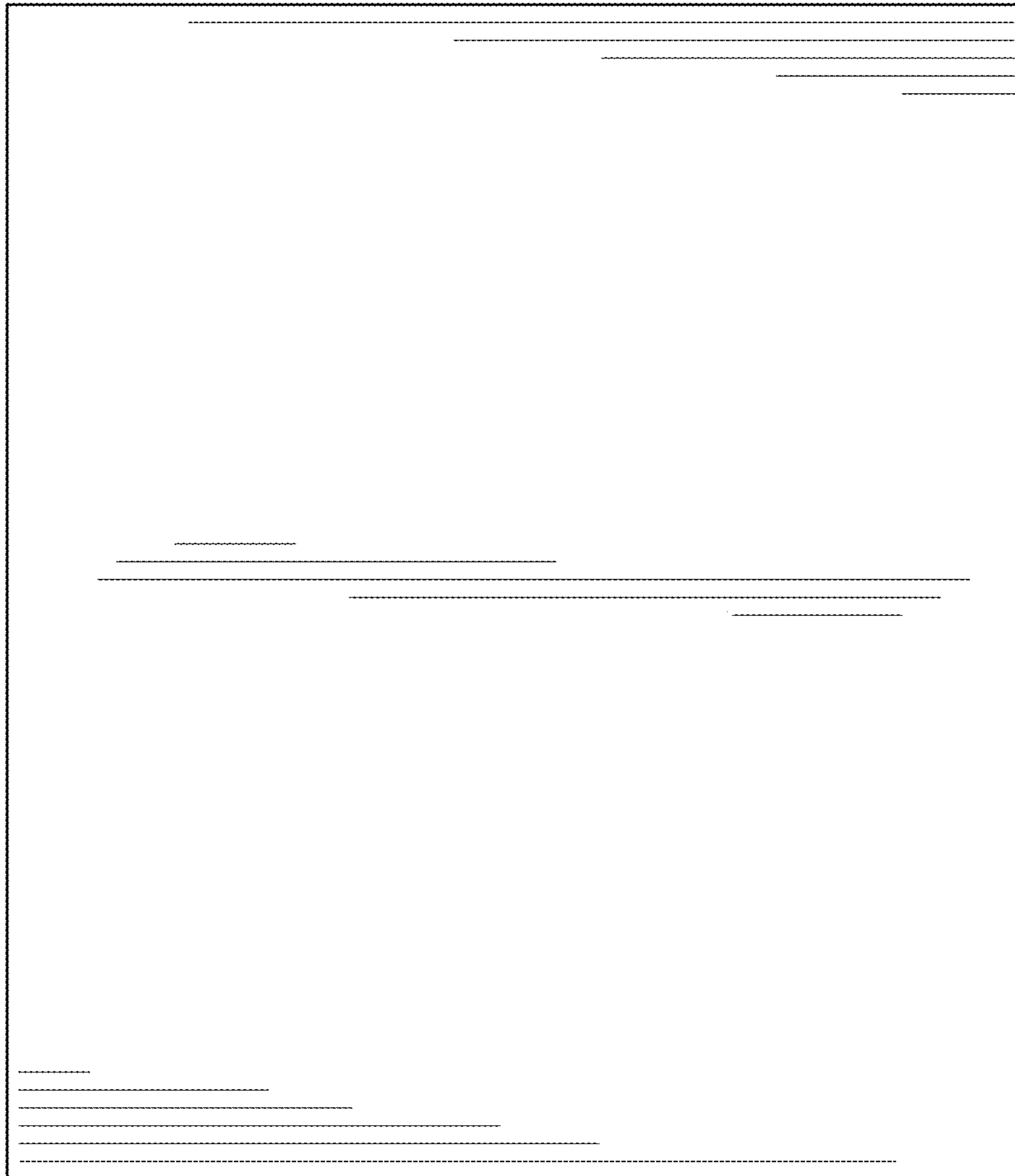

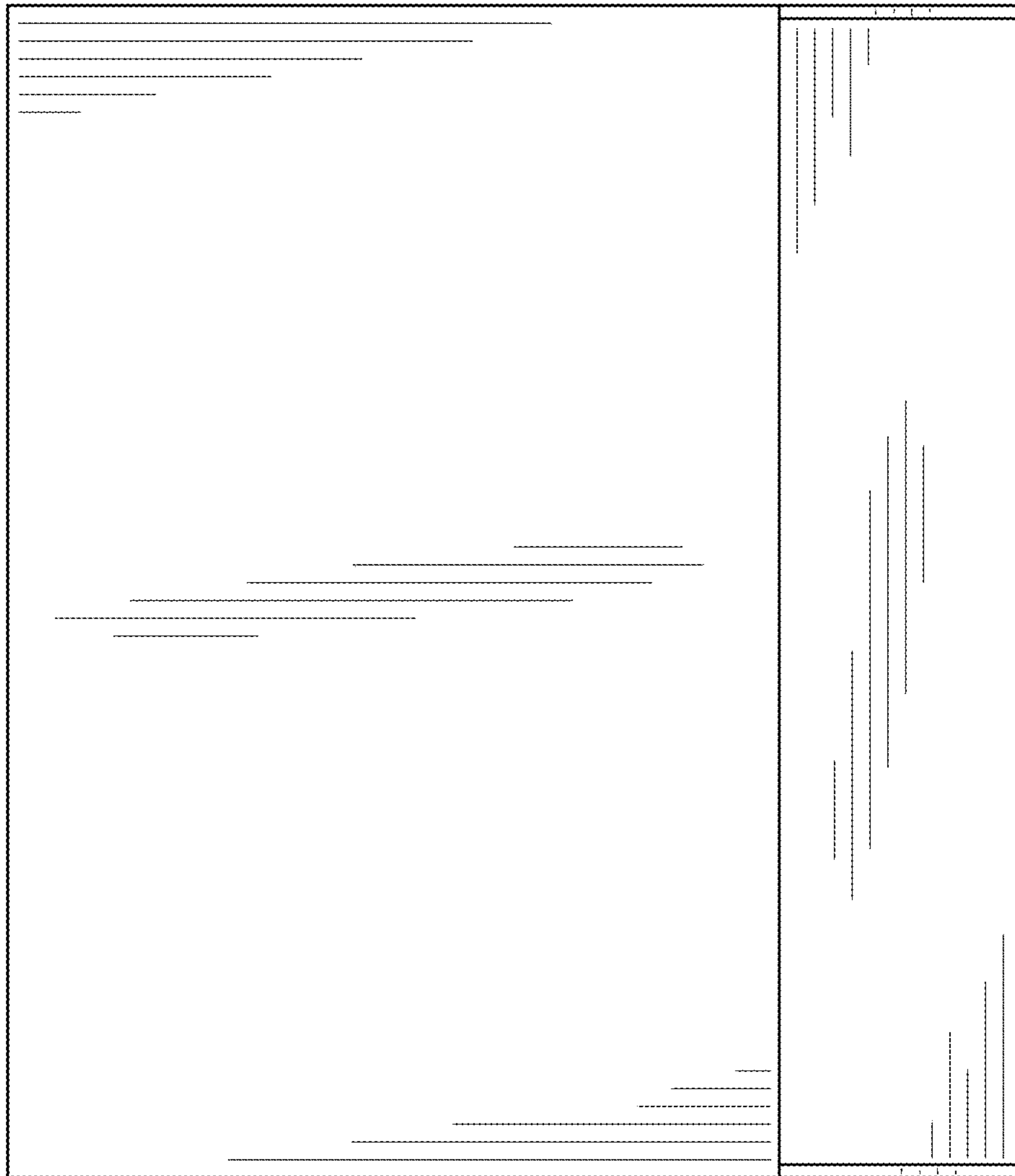
