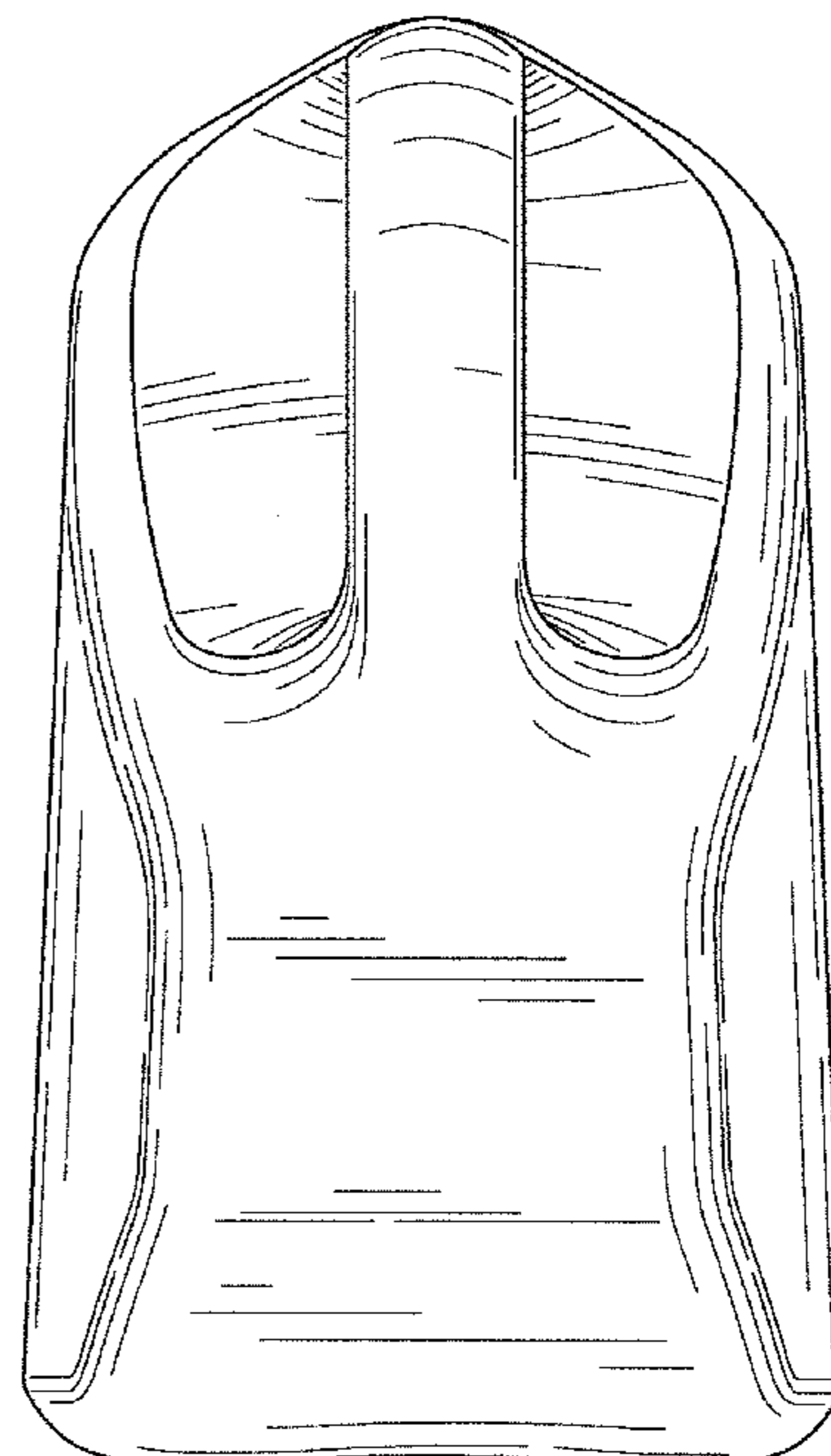
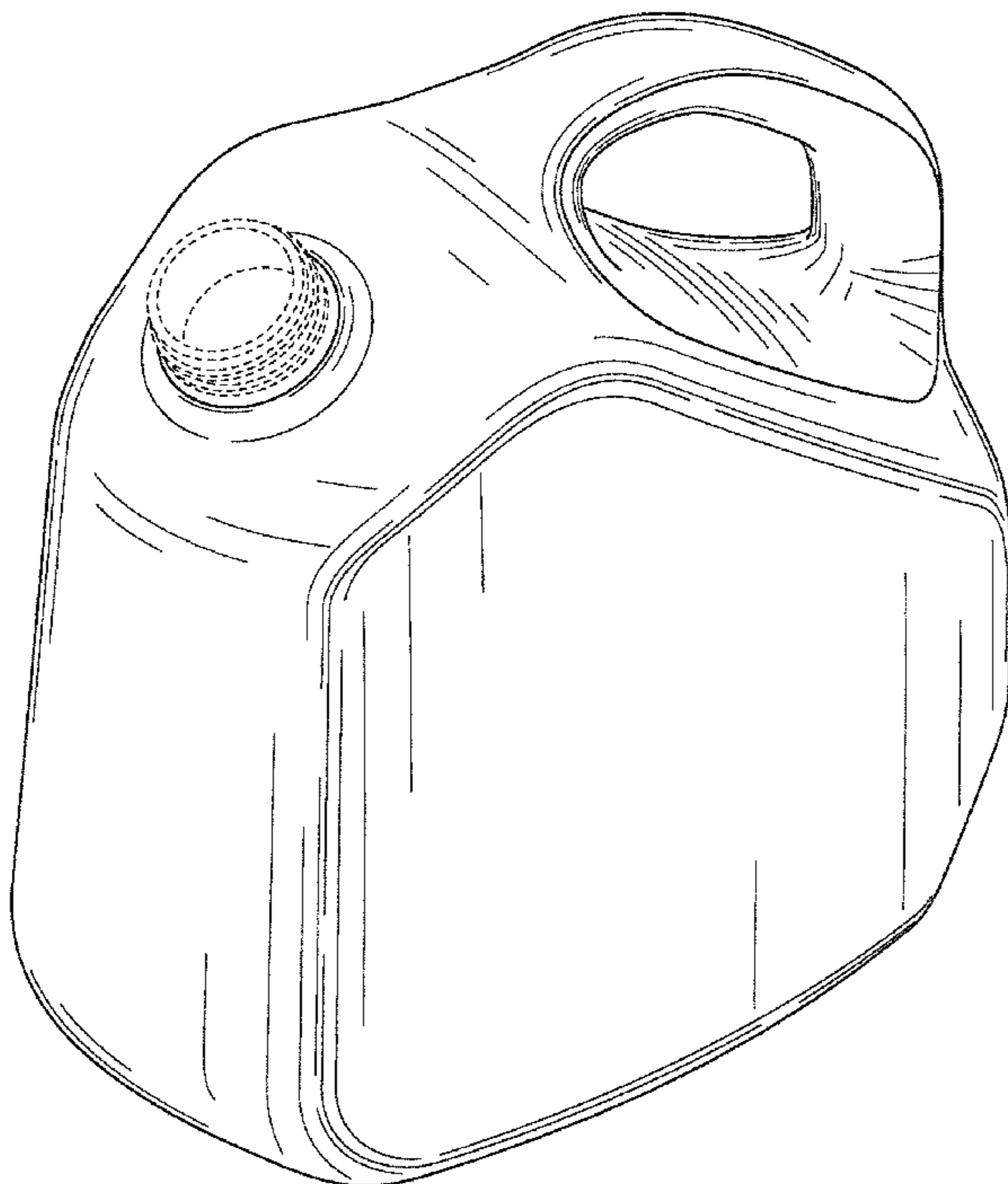
(57) **CLAIM**

The ornamental design for a bottle, as shown and described.

**DESCRIPTION**

FIG. 1 is an isometric view of a front, top, and left side of an ornamental design for a bottle;  
FIG. 2 is a left side elevational view of the bottle of FIG. 1, the right side elevational view being a mirror image of FIG. 2;  
FIG. 3 is a front elevational view of the bottle of FIG. 1;  
FIG. 4 is a rear elevational view of the bottle of FIG. 1;  
FIG. 5 is a top plan view of the bottle of FIG. 1; and,  
FIG. 6 is a bottom plan view of the bottle of FIG. 1.  
The broken line showings of the bottle neck in FIGS. 1-3 and 5, and the bottle bottom in FIG. 6 are included for the purpose of illustrating unclaimed portions of the bottle and form no part of the claimed design.

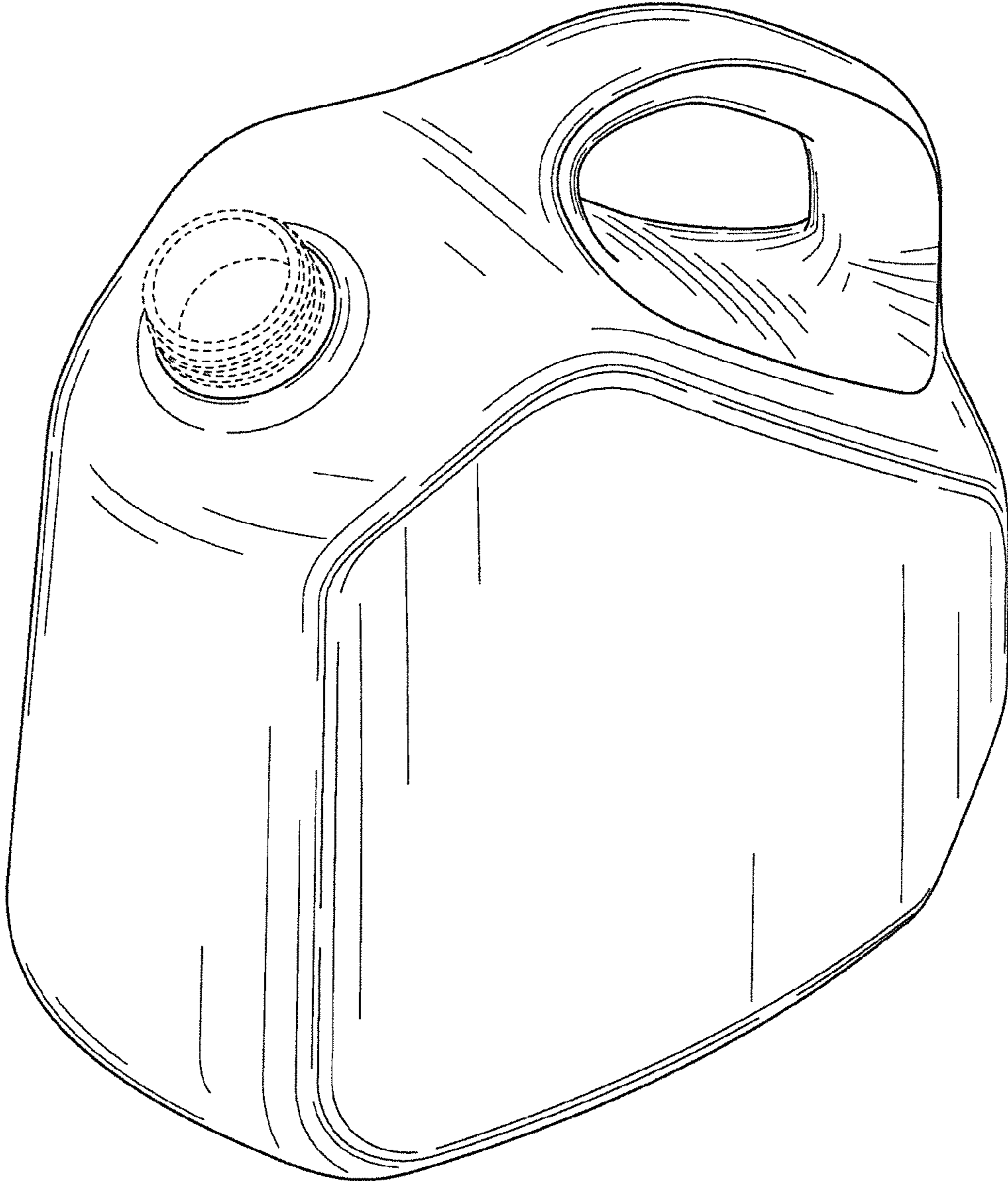

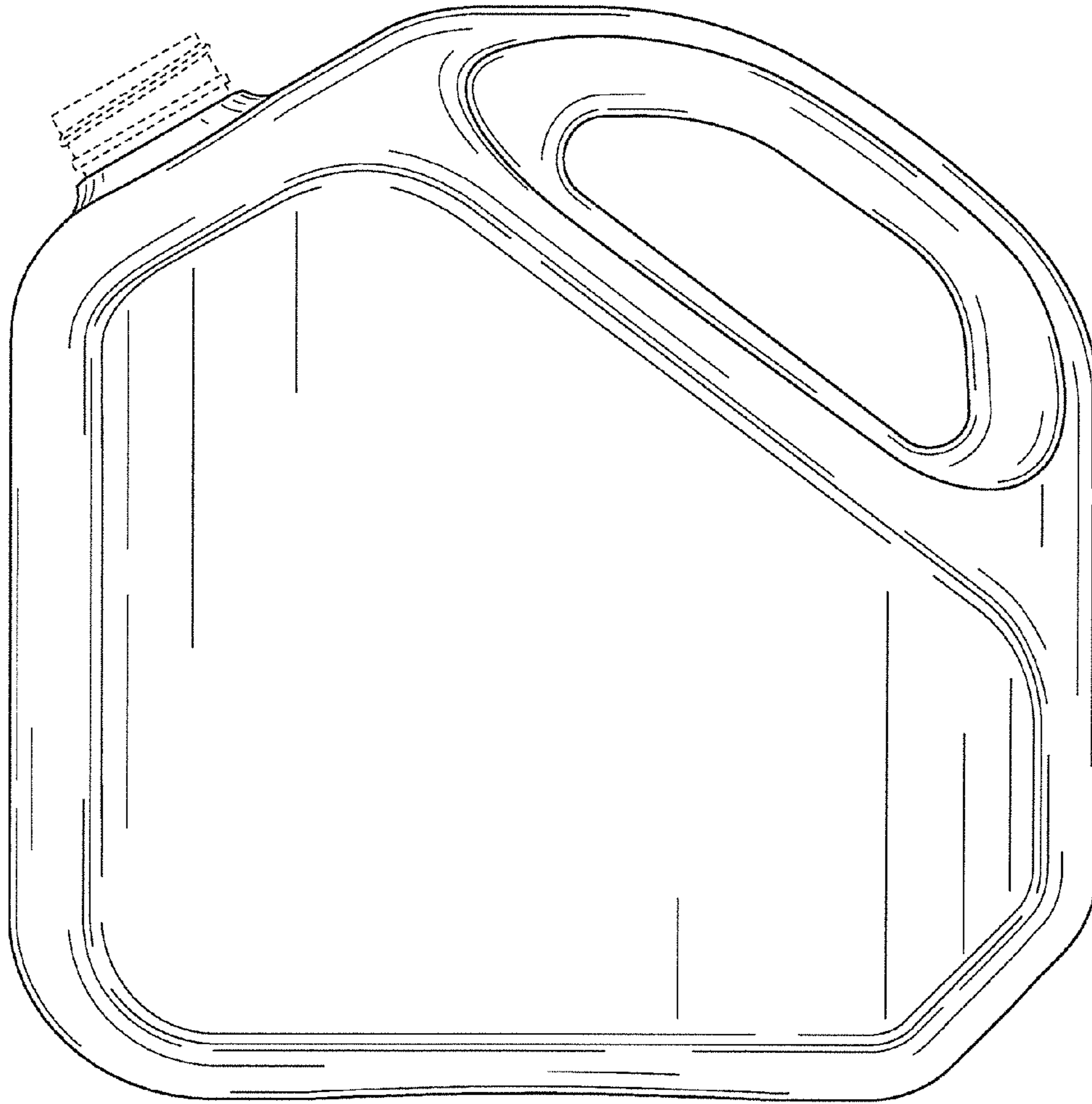

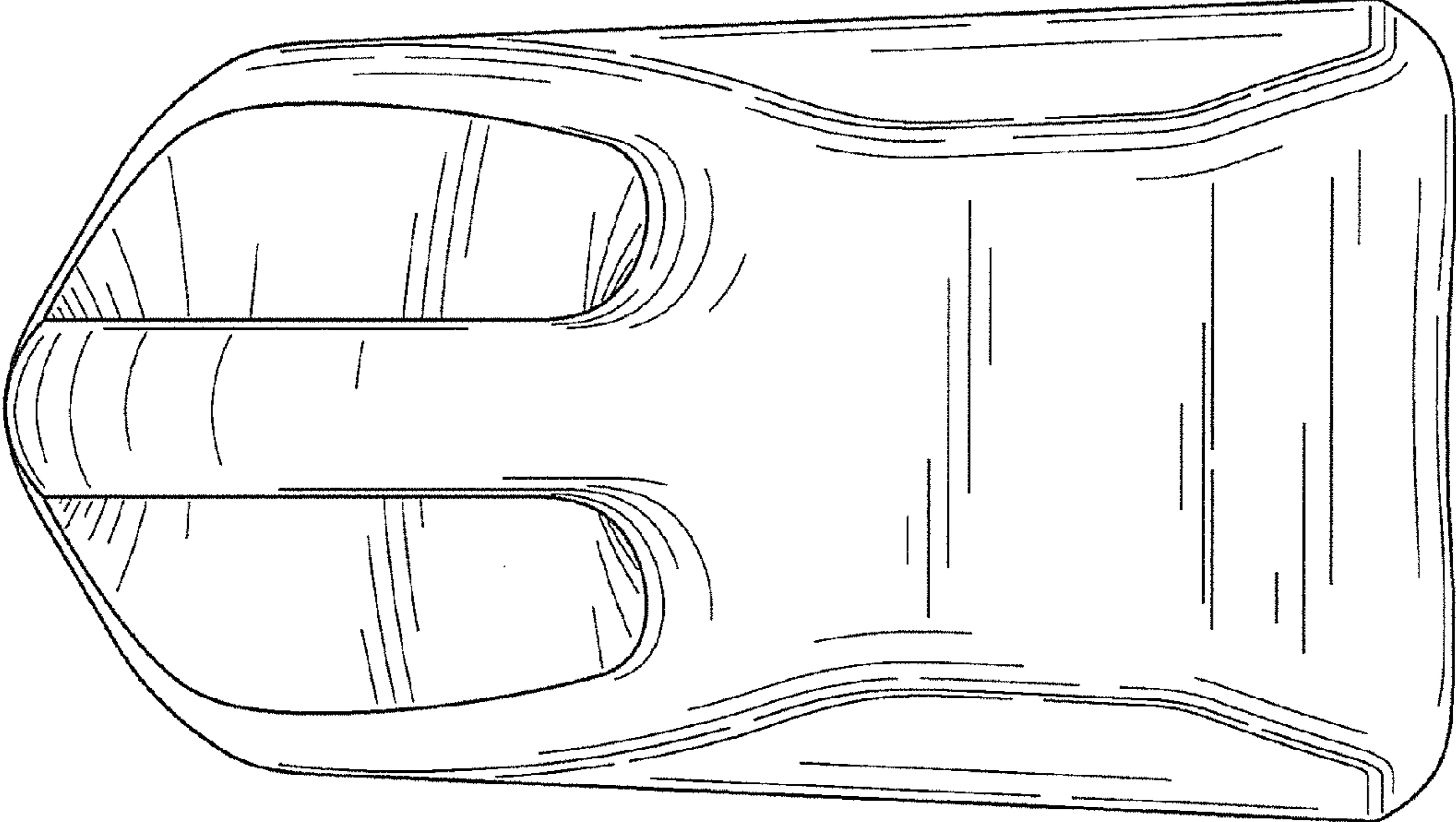

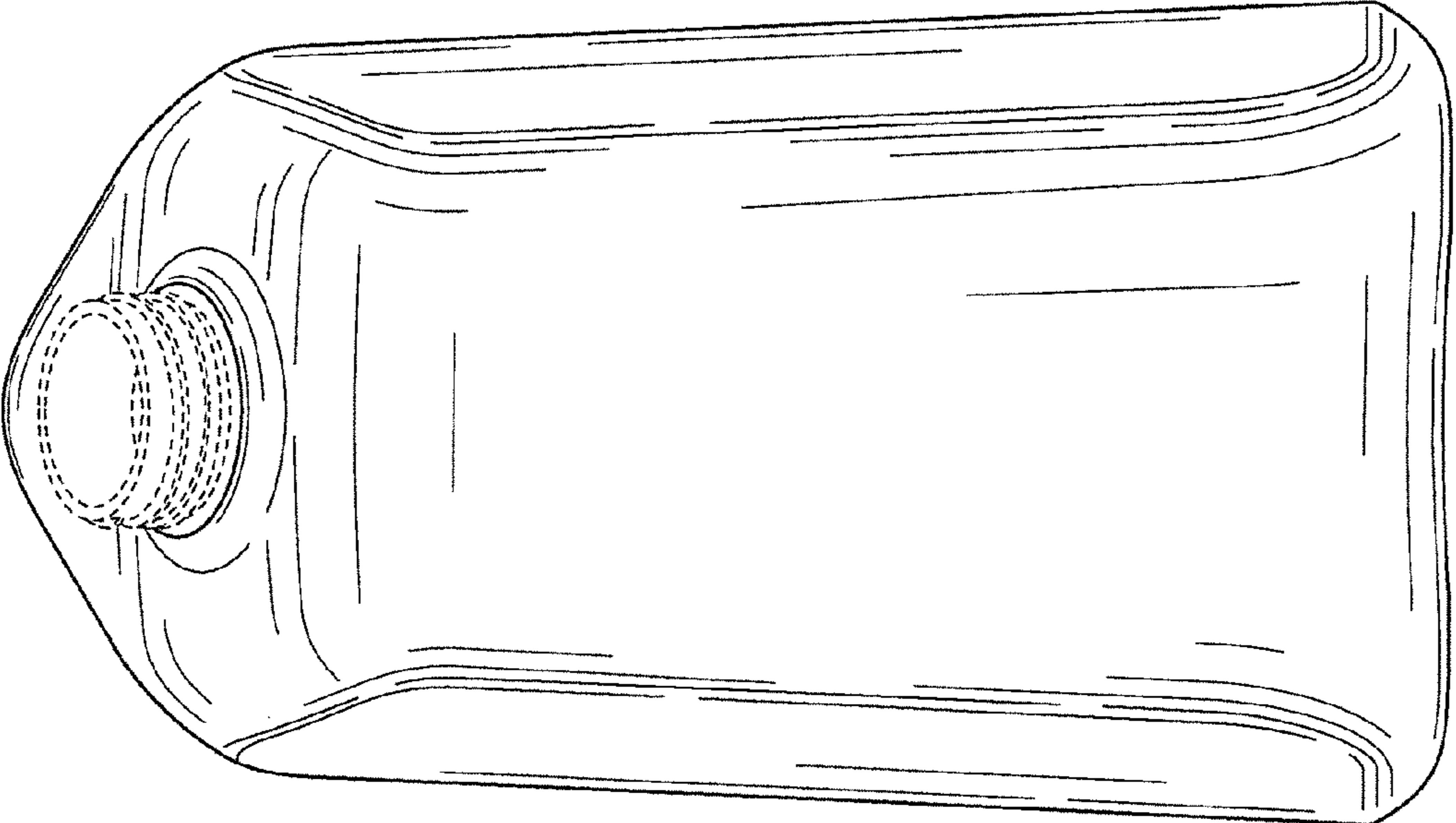

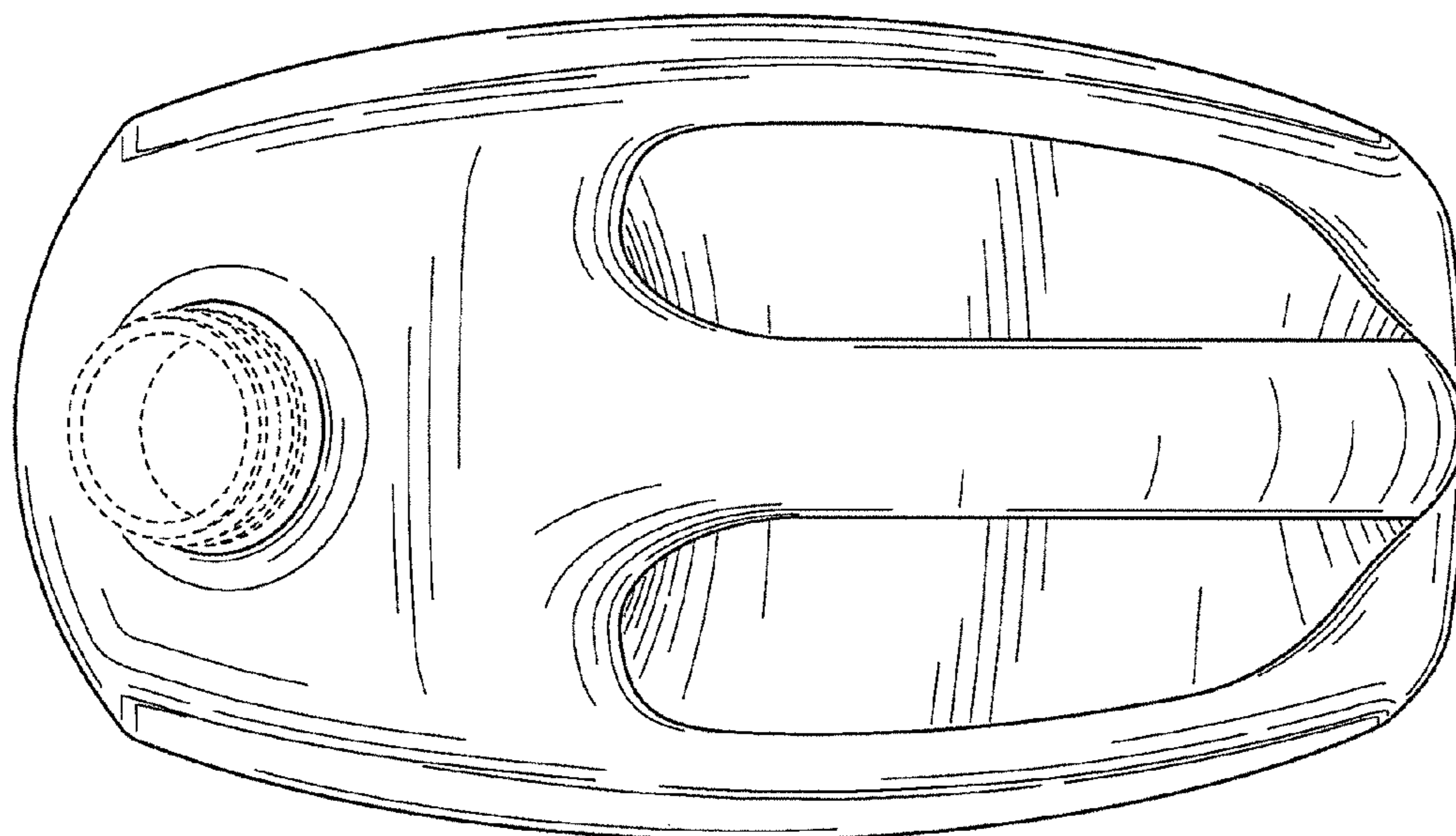

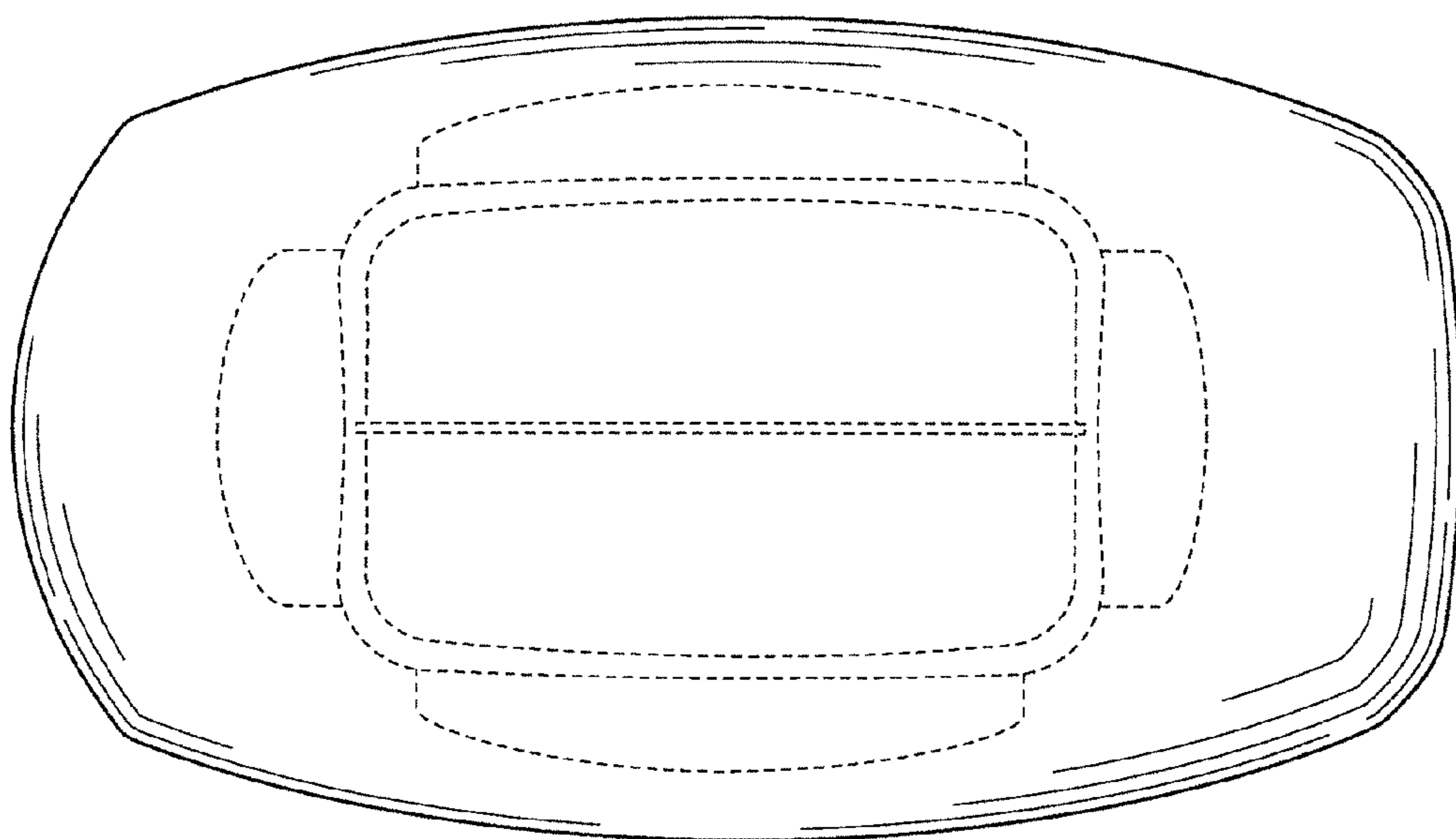
