FIG. 1 is a bottom, right front perspective view of a clock showing my new design:

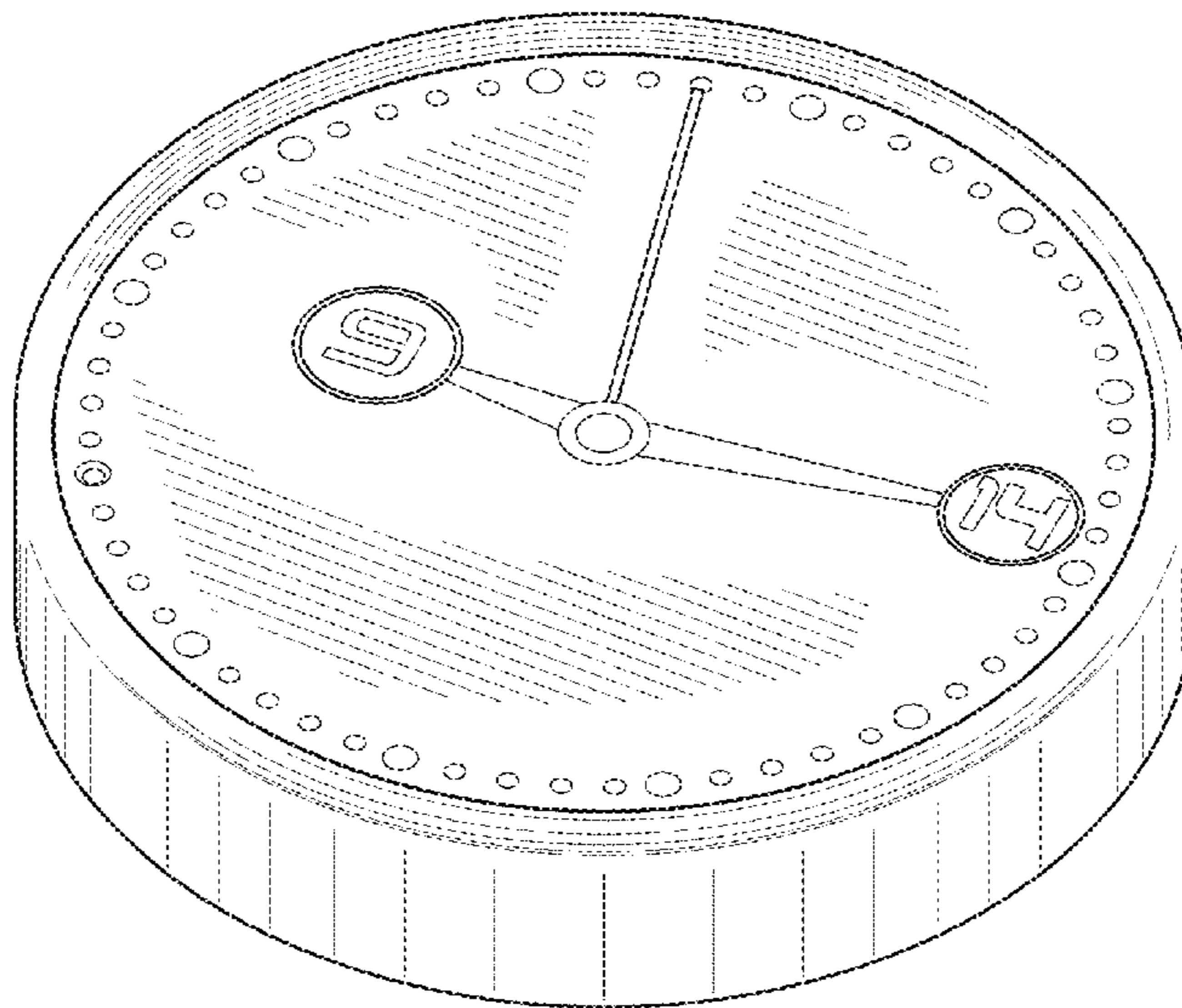
FIG. 2 is a front elevational view thereof;

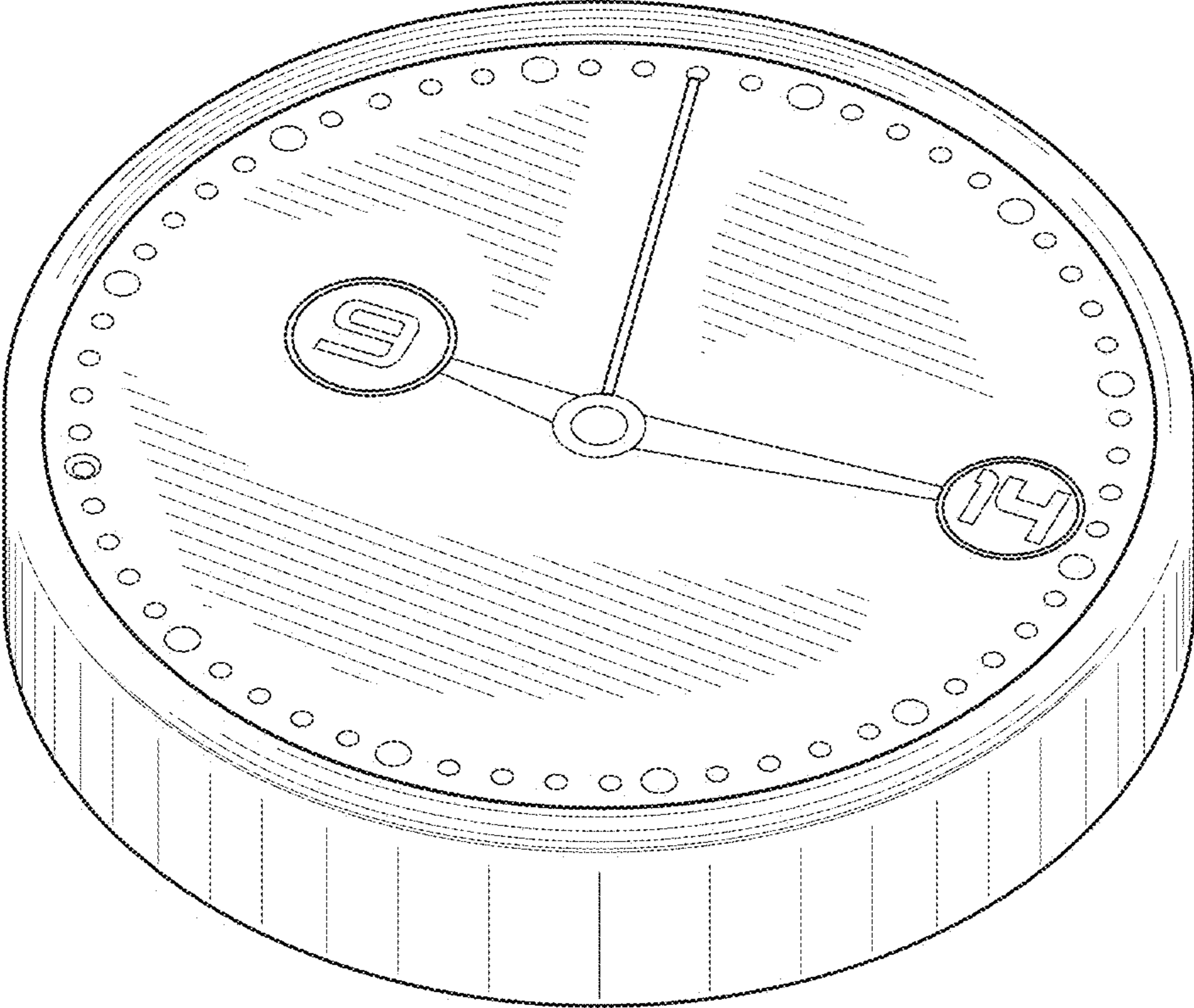

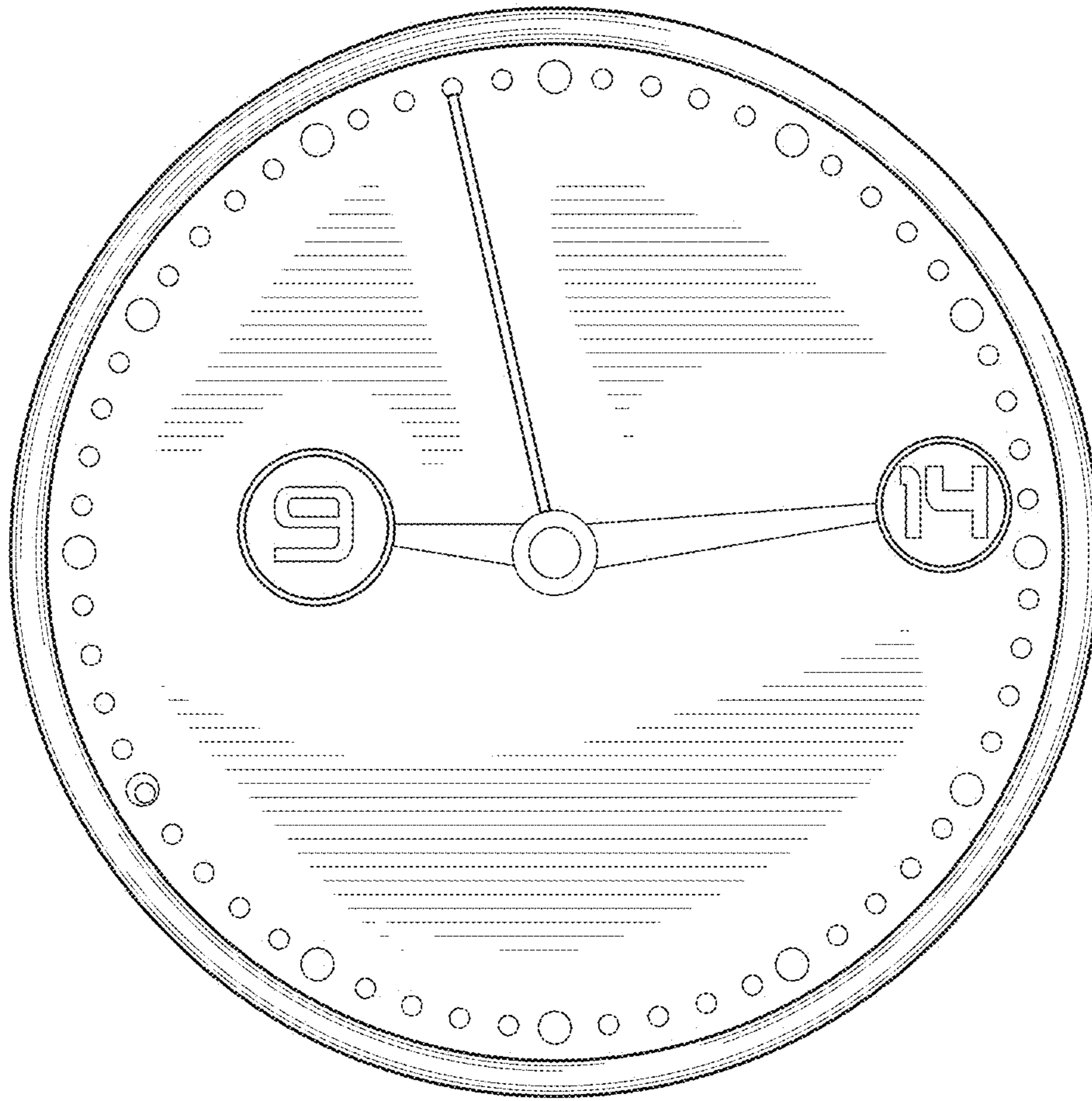

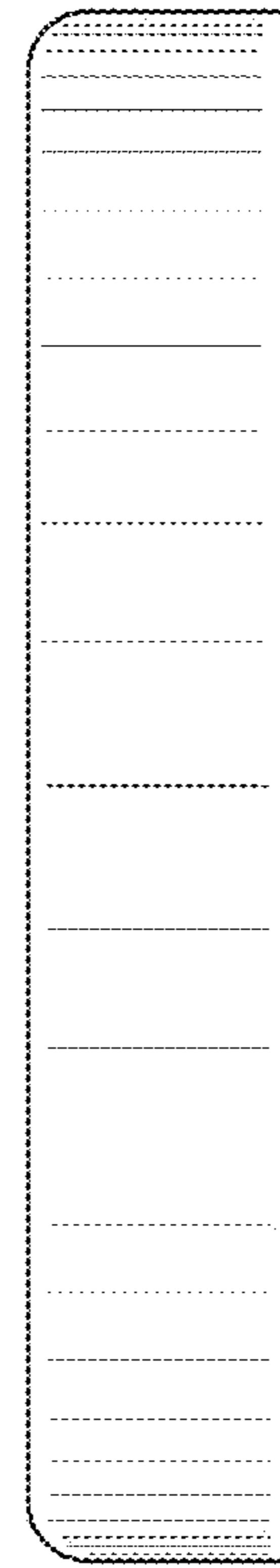
