DESCRIPTION

FIG. 1 is a bottom, right front perspective view of a watch case showing my new design;
FIG. 2 is a front elevational view thereof;

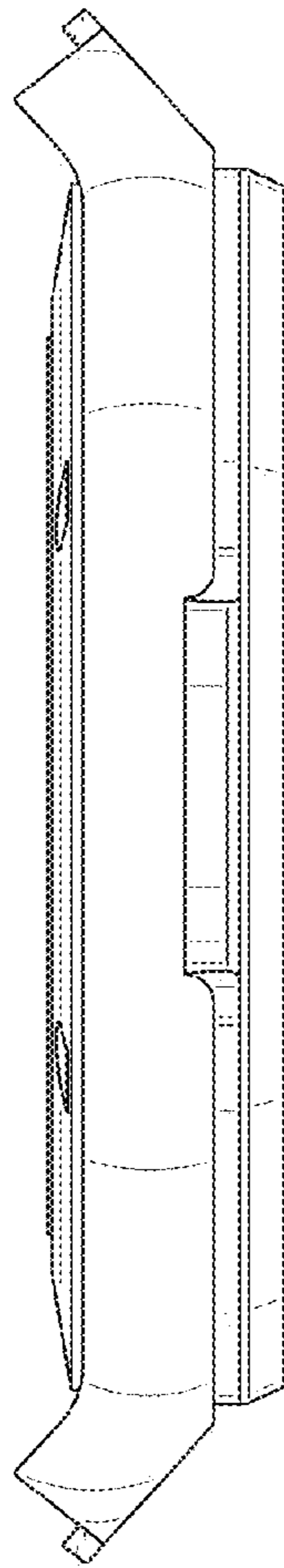

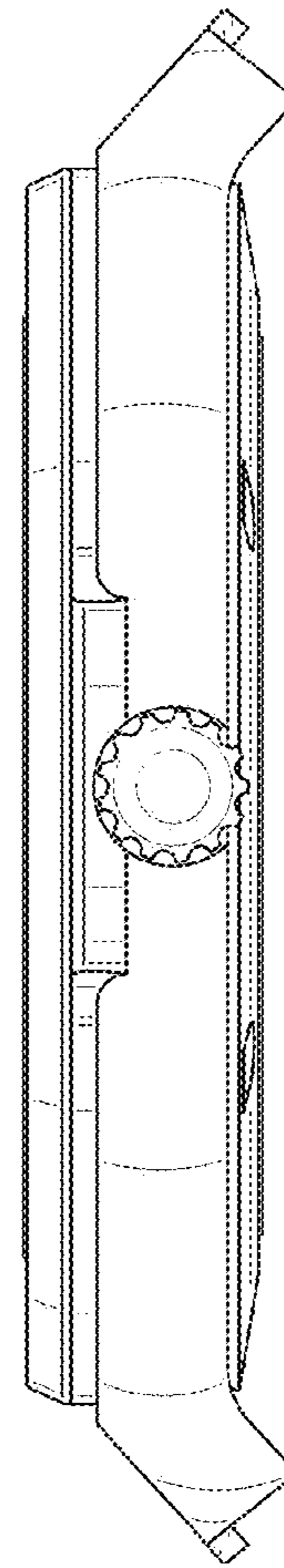

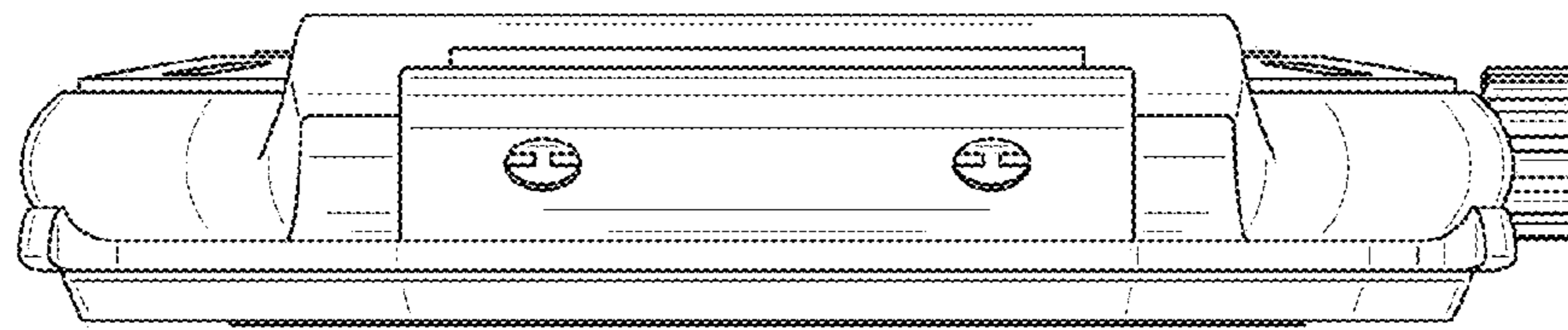

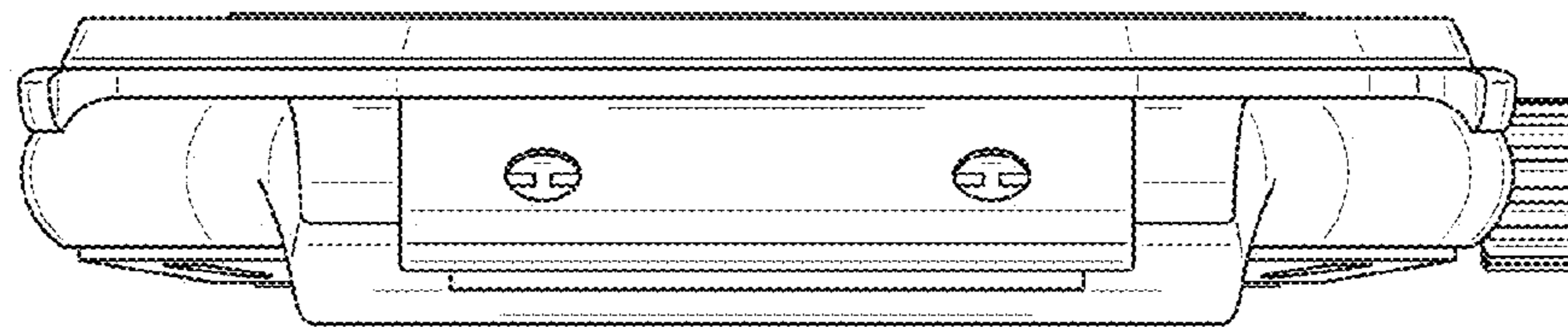
