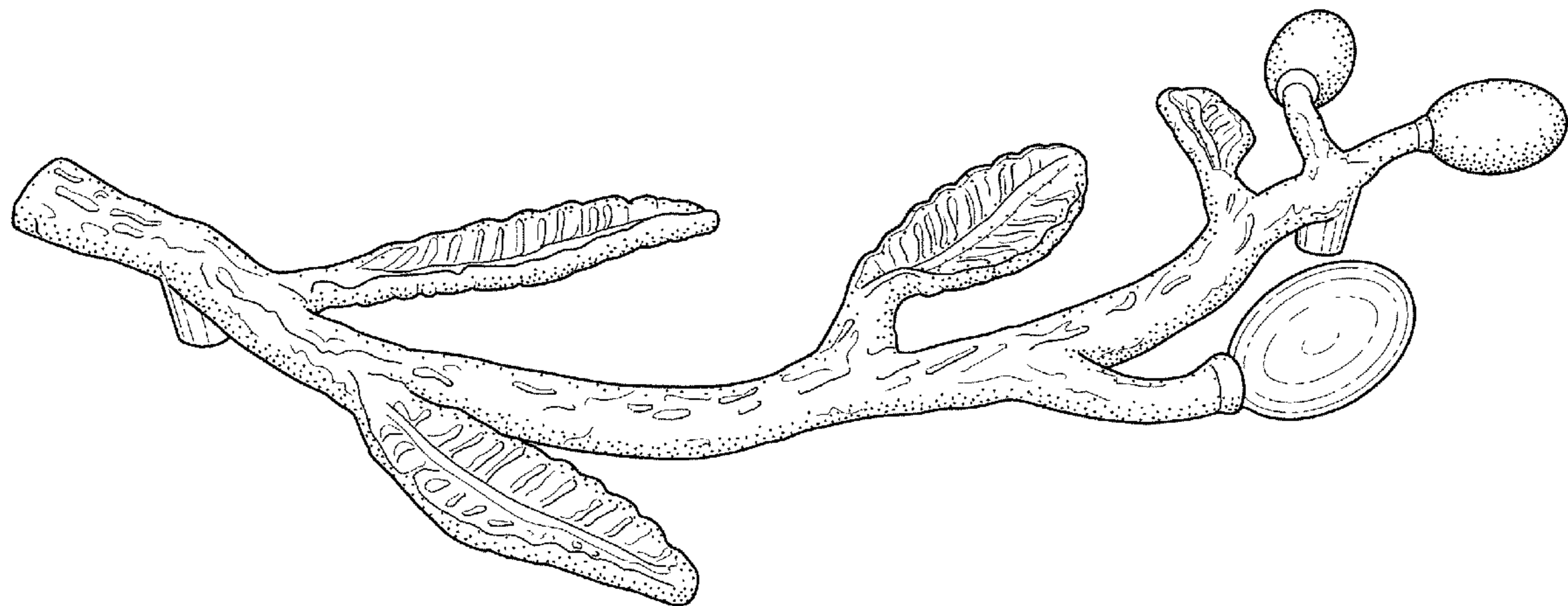
(57) **CLAIM**

The ornamental design for a decorative branch with leaves, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of a decorative branch with leaves showing my new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is a side elevation view thereof;
FIG. 5 is an opposite elevation side view thereof;
FIG. 6 is a front elevation view thereof;
FIG. 7 is a rear elevation view thereof; and,
FIG. 8 is an isometric view thereof shown in a used condition with a serving tray shown in broken lines.
The broken lines shown in the drawings of a serving tray in FIG. 8 form no part of the claimed design.

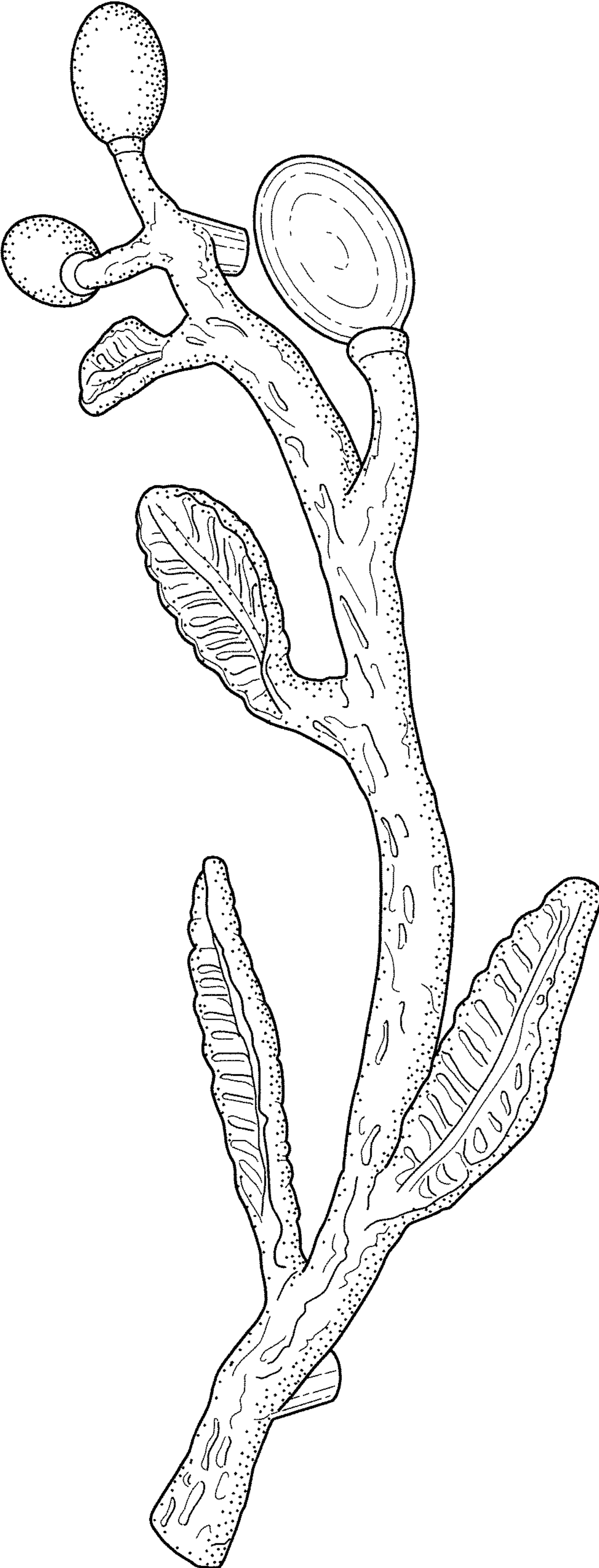

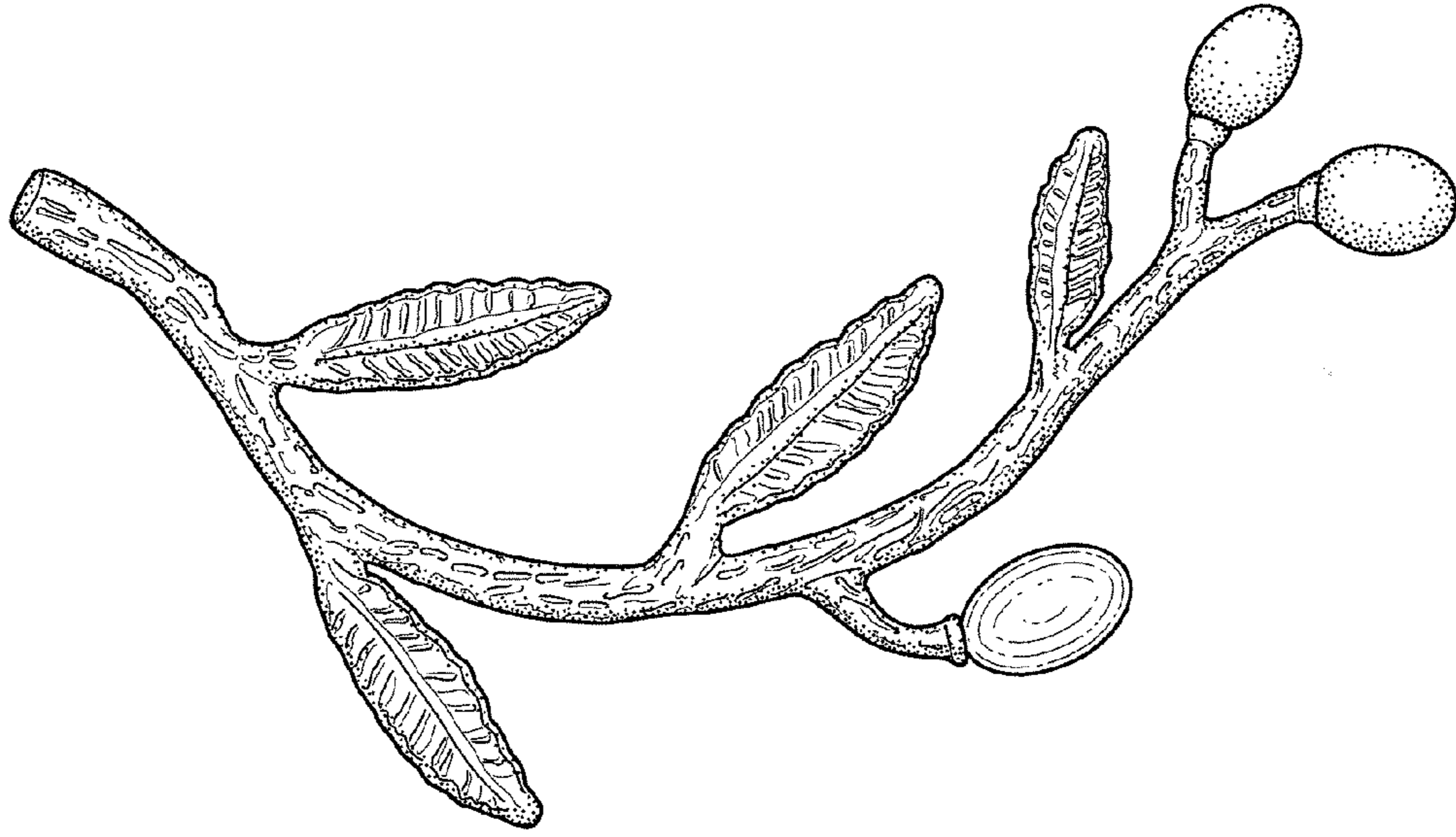

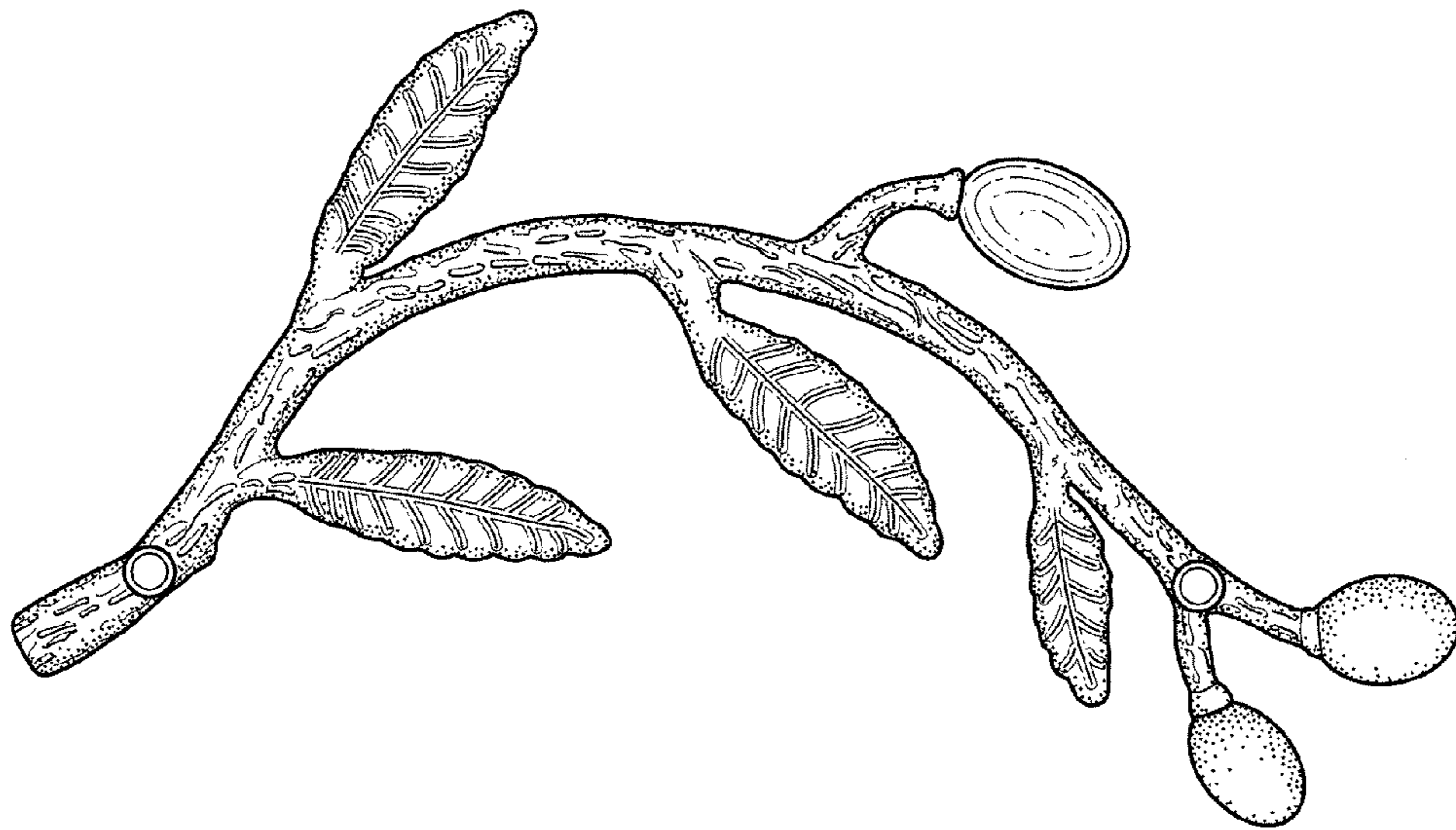

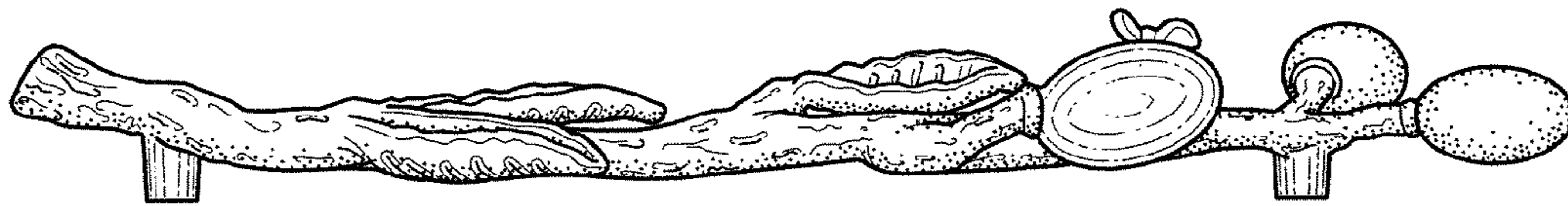

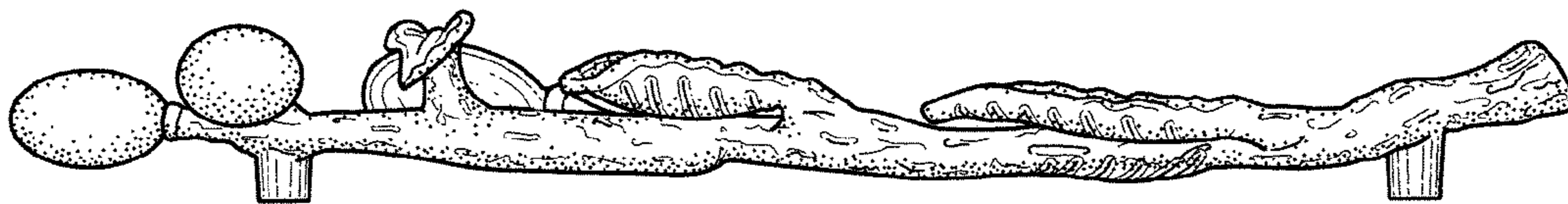

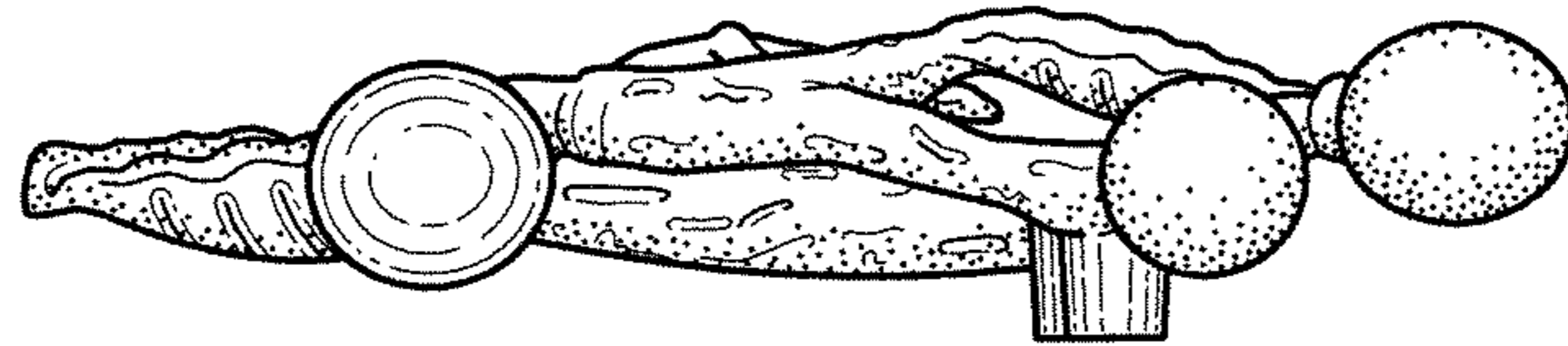

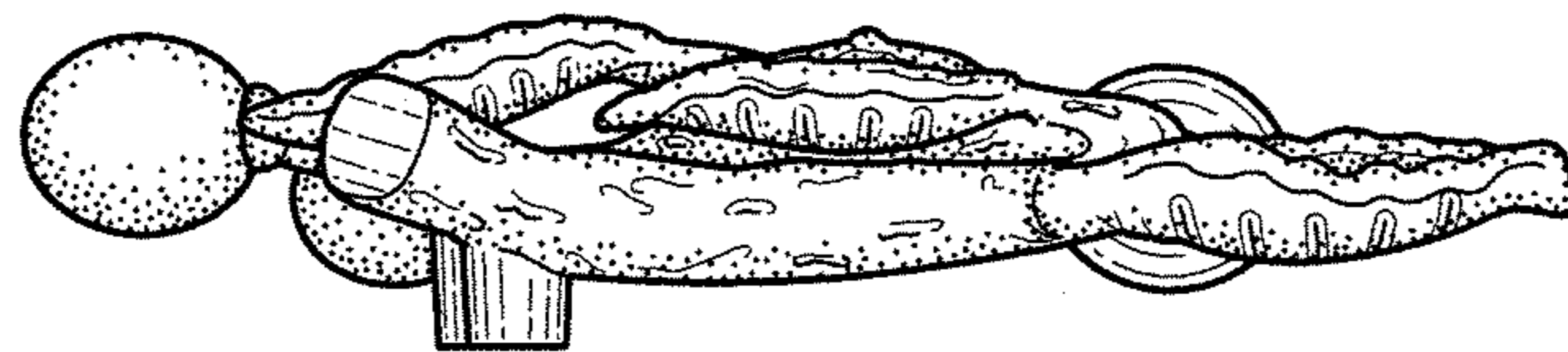

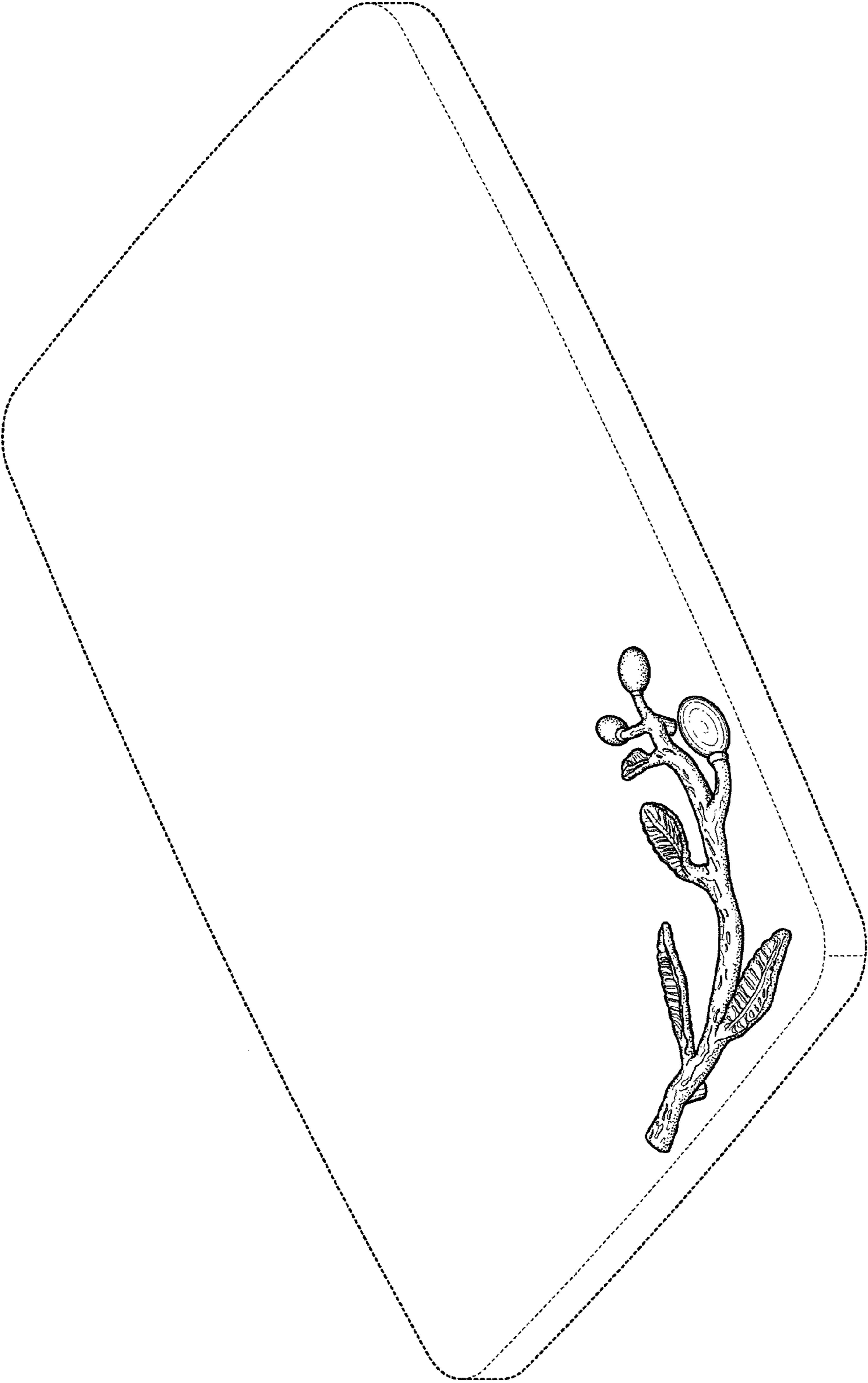
