(57) **CLAIM**

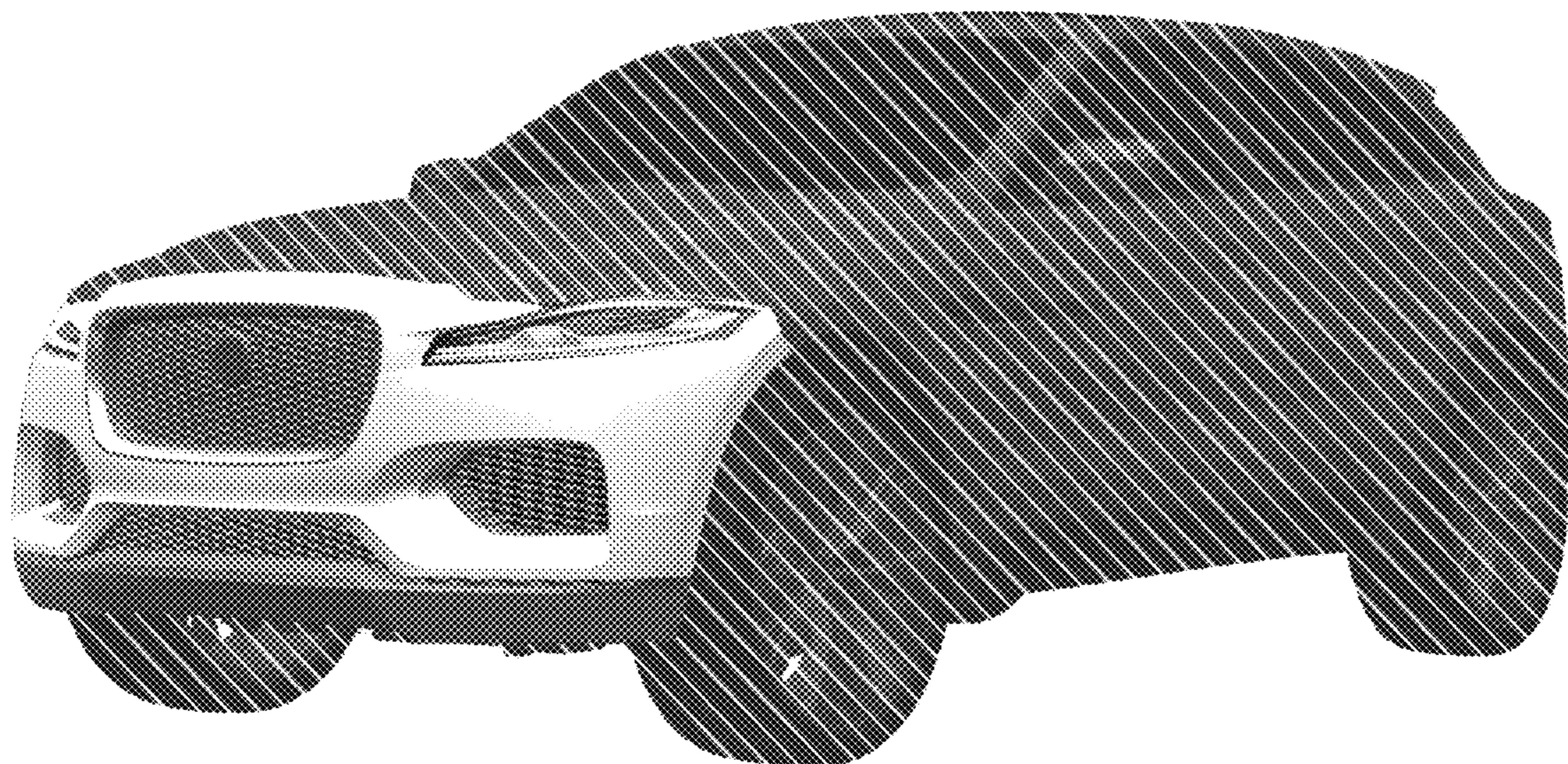
The ornamental design for a front end portion of a vehicle, as shown and described.

**DESCRIPTION**

FIG. 1 is a left front 3/4 view of a front end portion of a vehicle; FIG. 2 is a right front 3/4 view of front end portion of a vehicle; FIG. 3 is a left side view of front end portion of a vehicle; FIG. 4 is right side view of front end portion of a vehicle; and, FIG. 5 is a front view of front end portion of a vehicle.

The portions of the figures shown with diagonal lines are for the purpose of illustrating environmental structure and form no part of the claimed design.

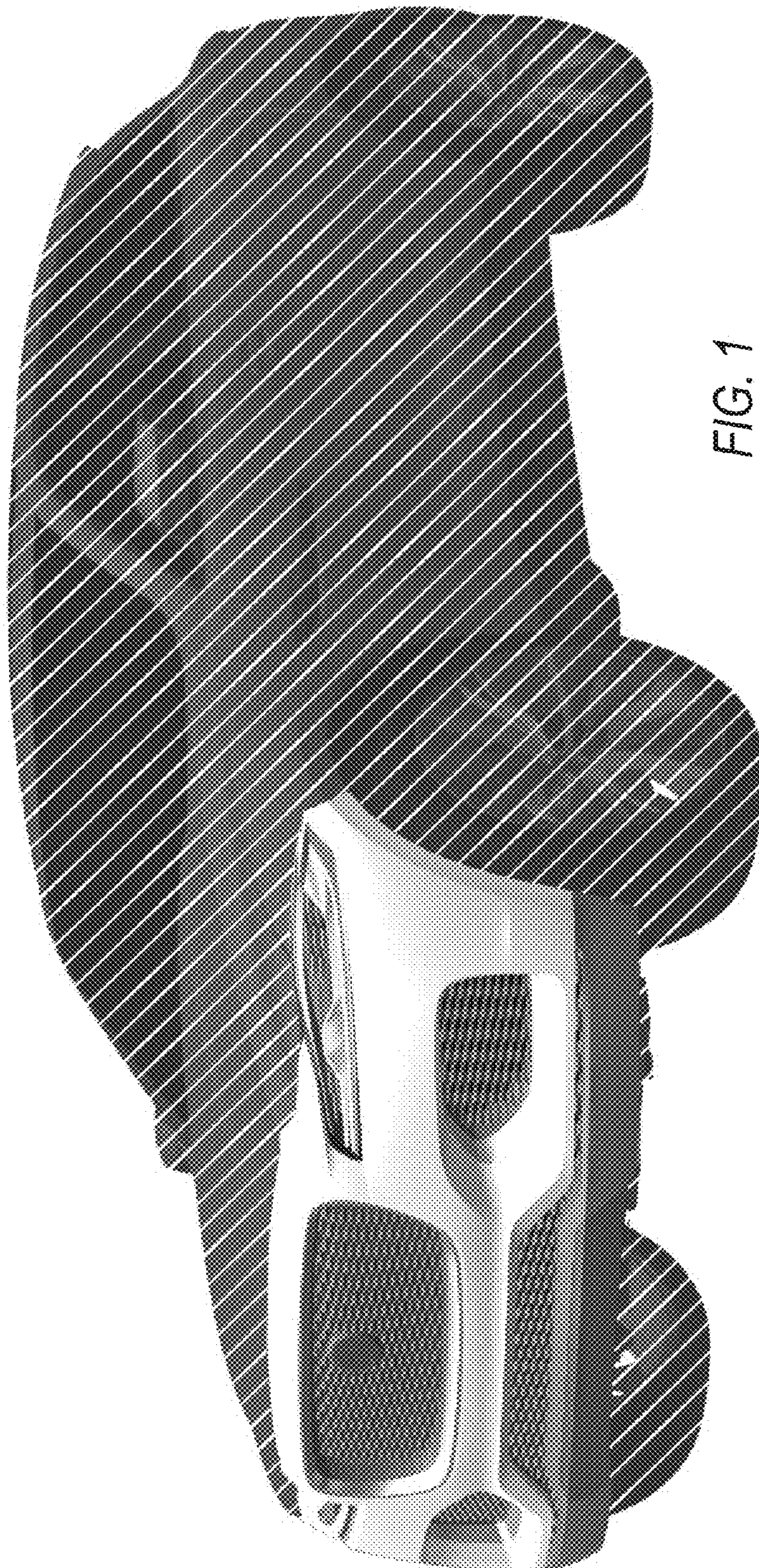

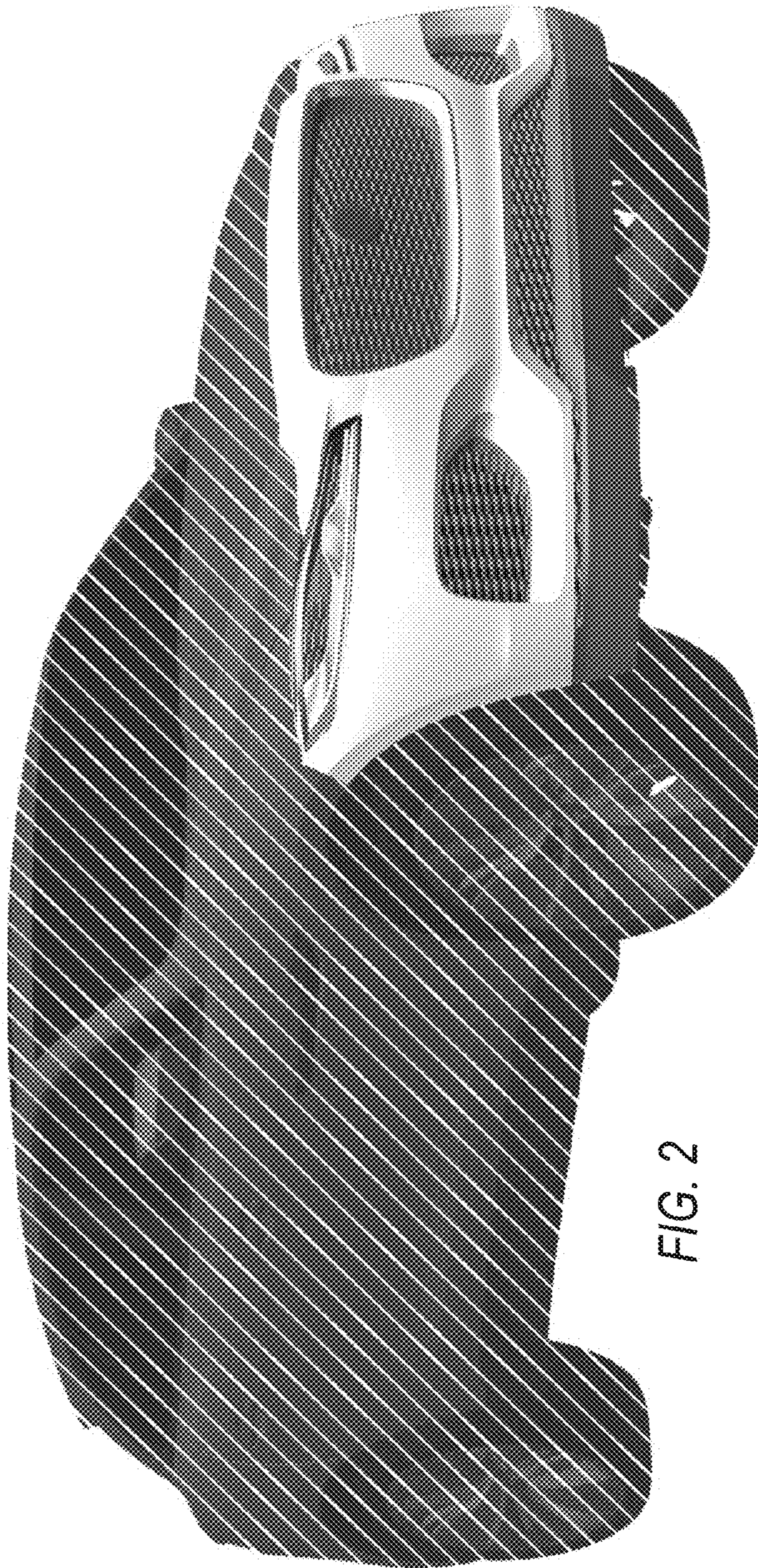

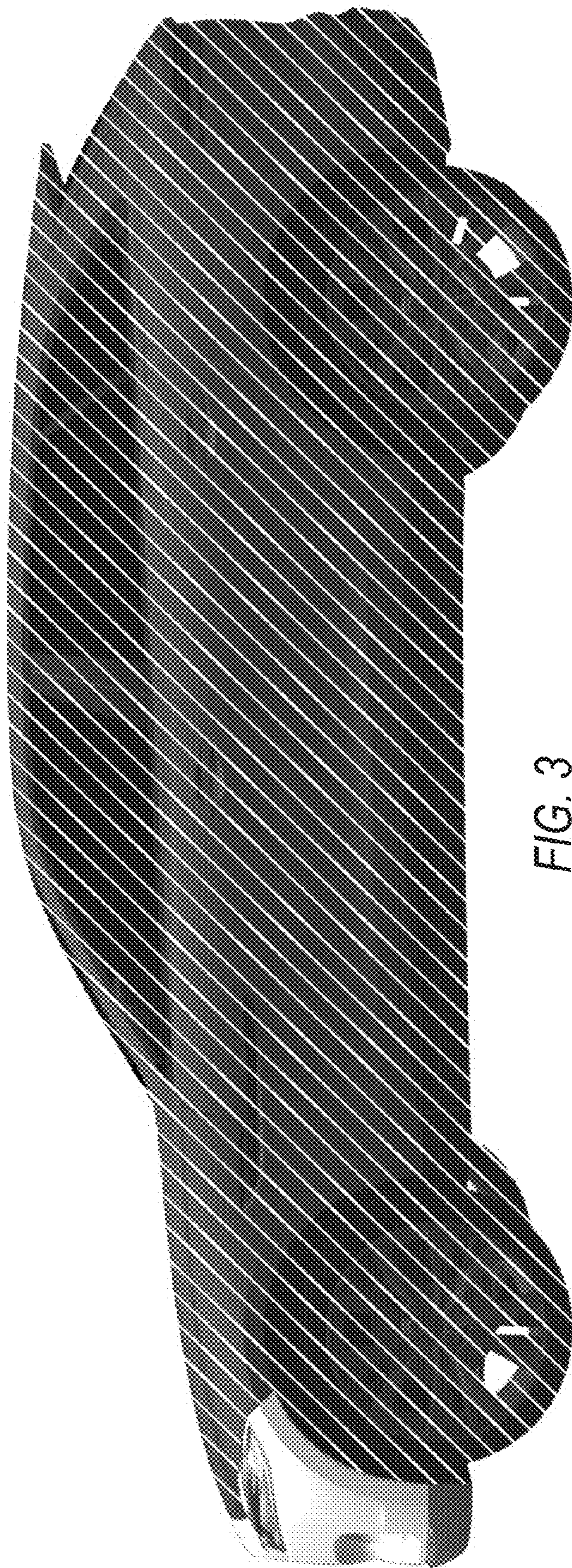

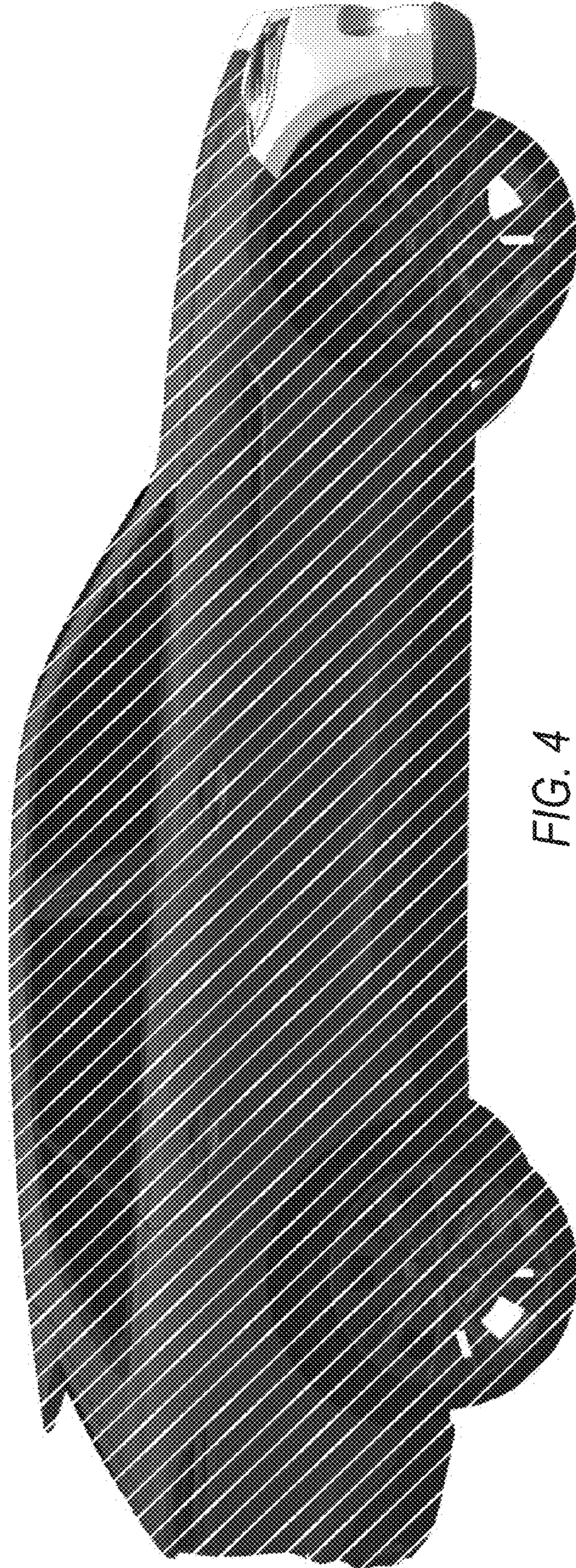

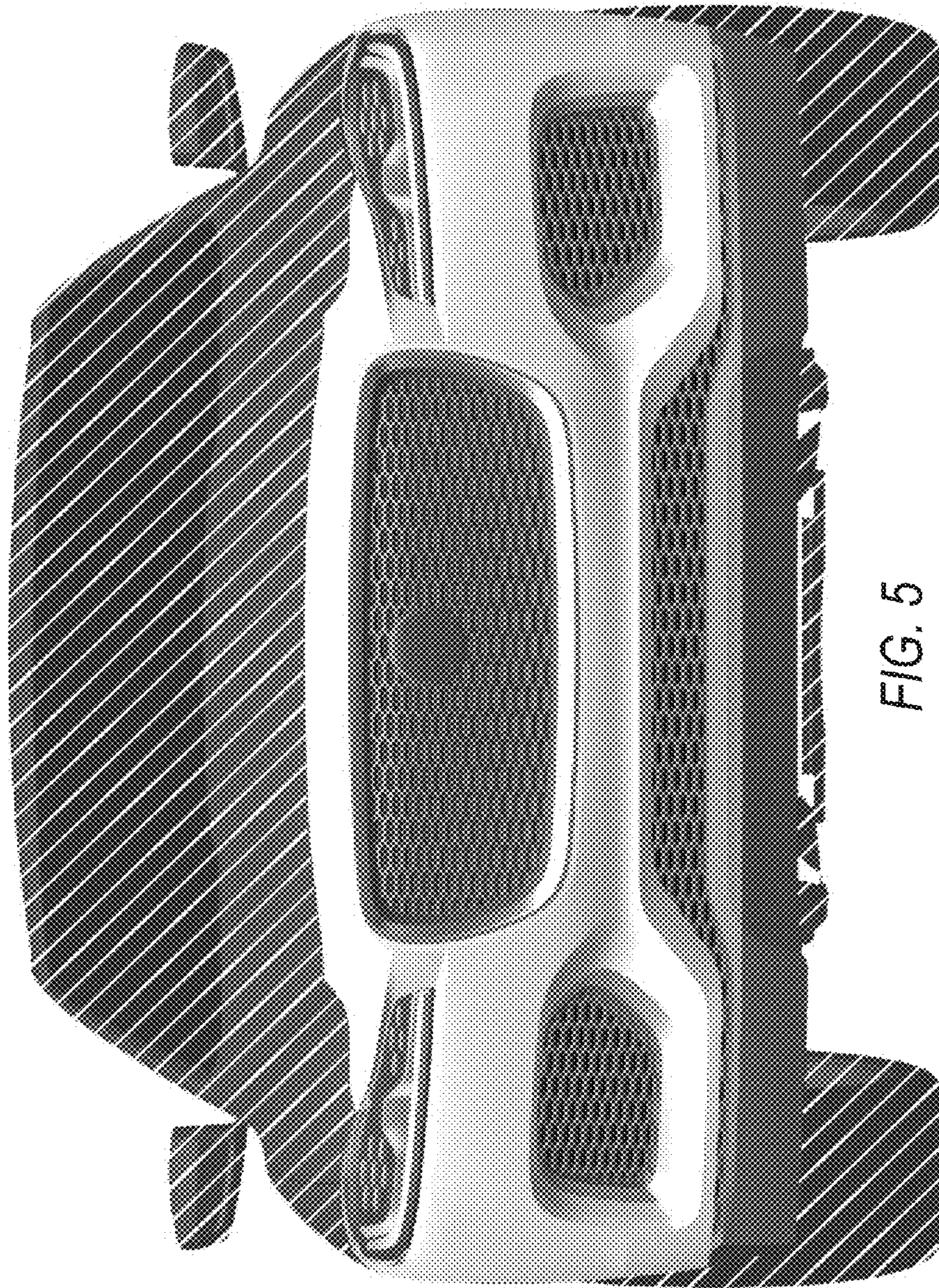
