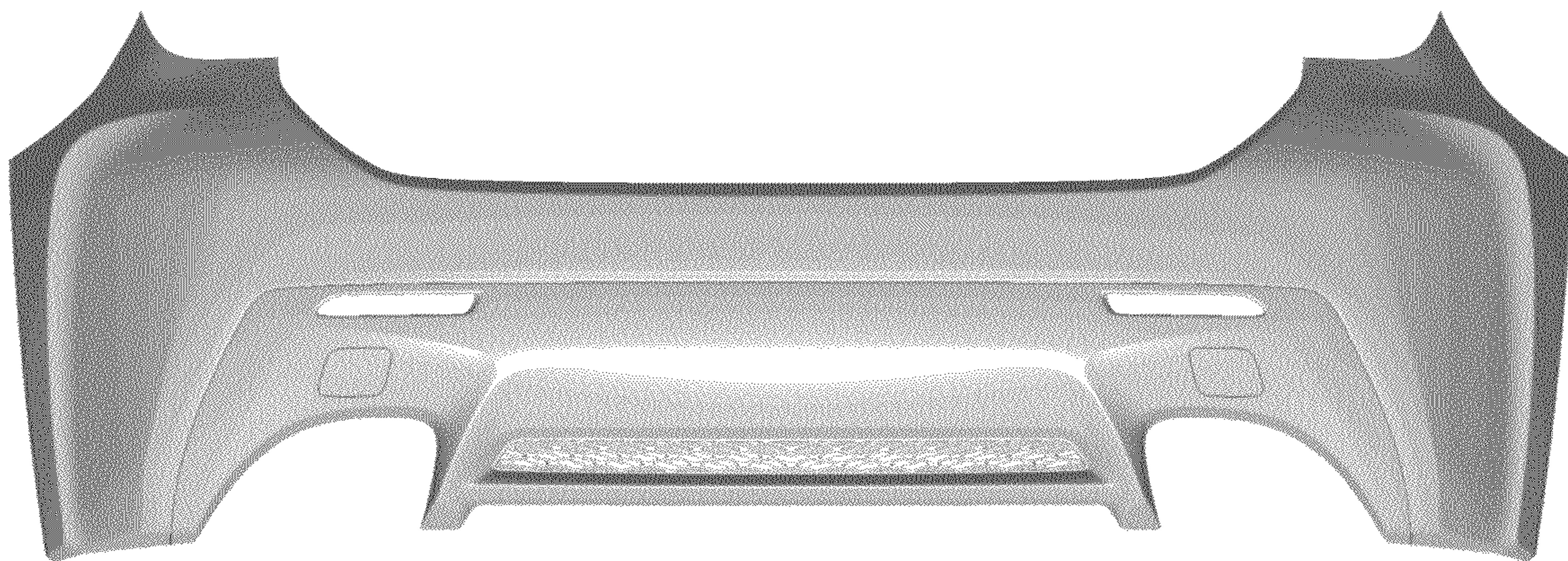

(57) **CLAIM**
The ornamental design for a bumper for an automobile, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a bumper for an automobile showing our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a top view thereof;
FIG. 5 is a bottom view thereof; and,
FIG. 6 is a right side view thereof, the left side view being a mirror image thereof.
The drawings include shadows and reflections, which indicate contour not surface ornamentation.

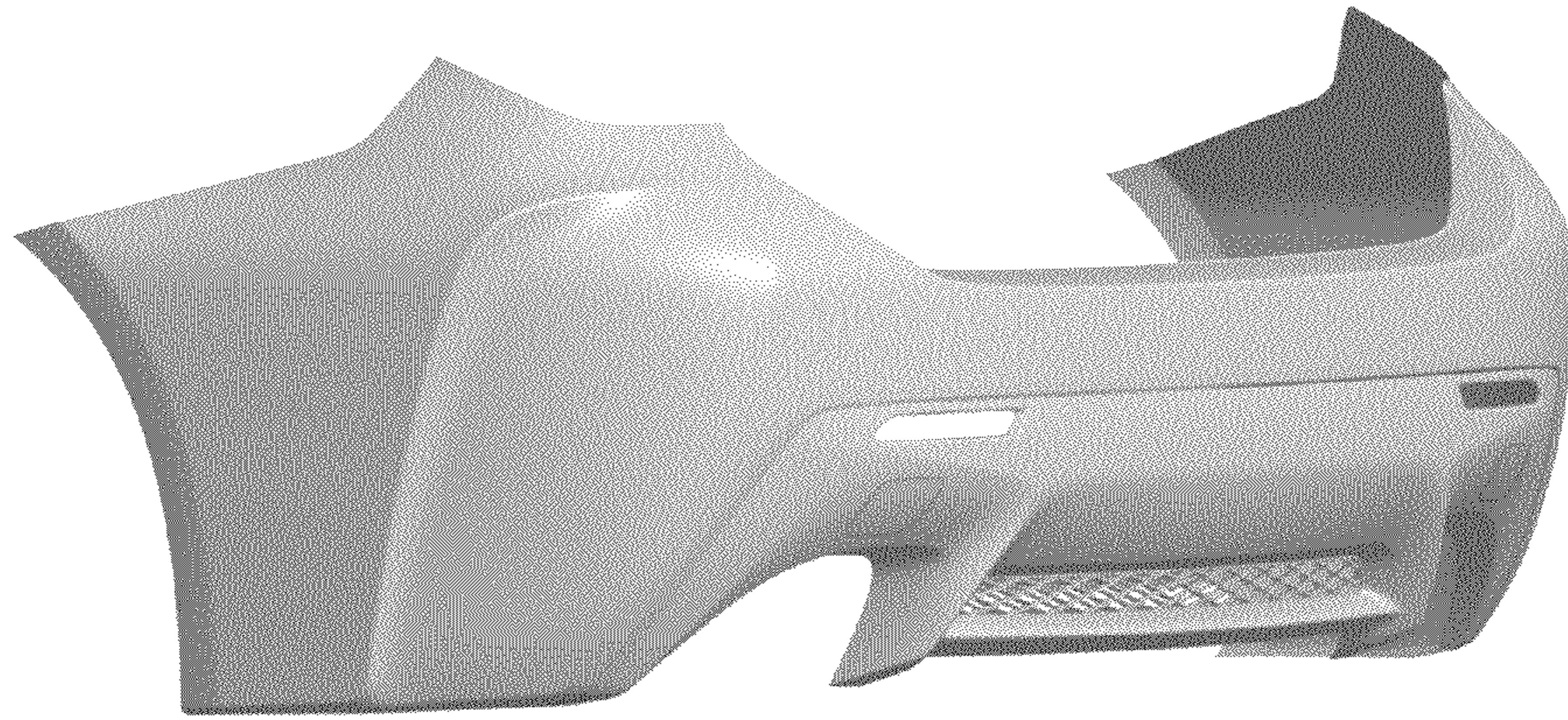

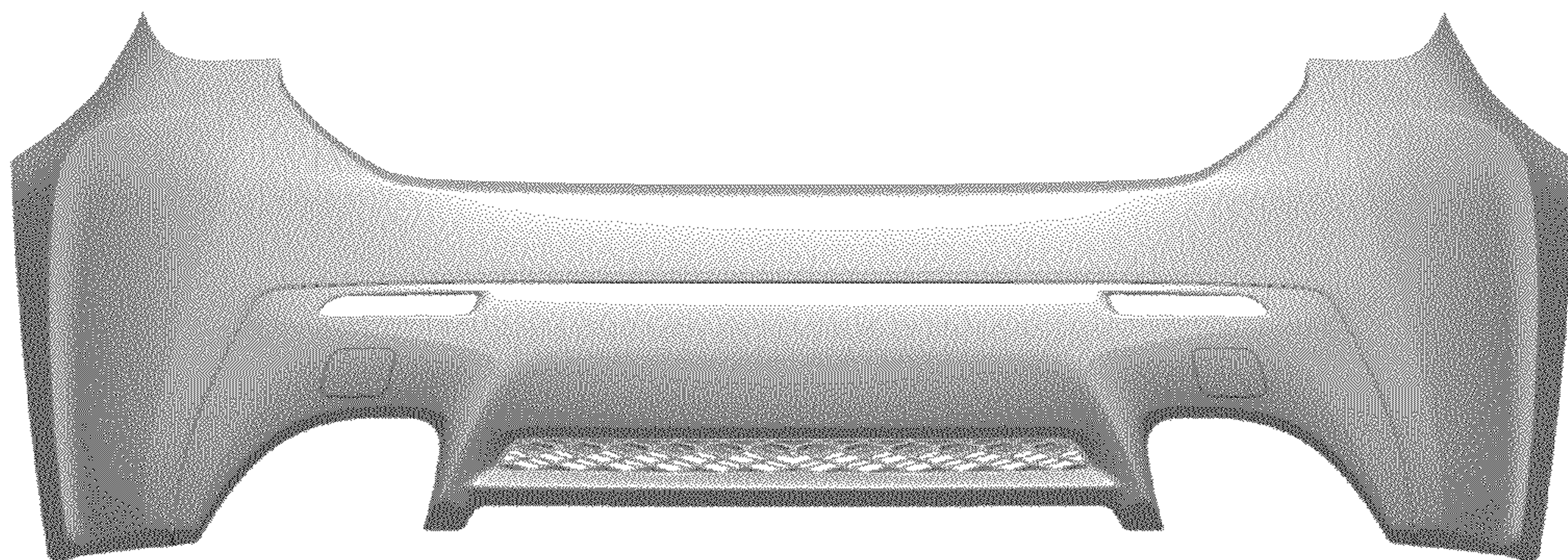

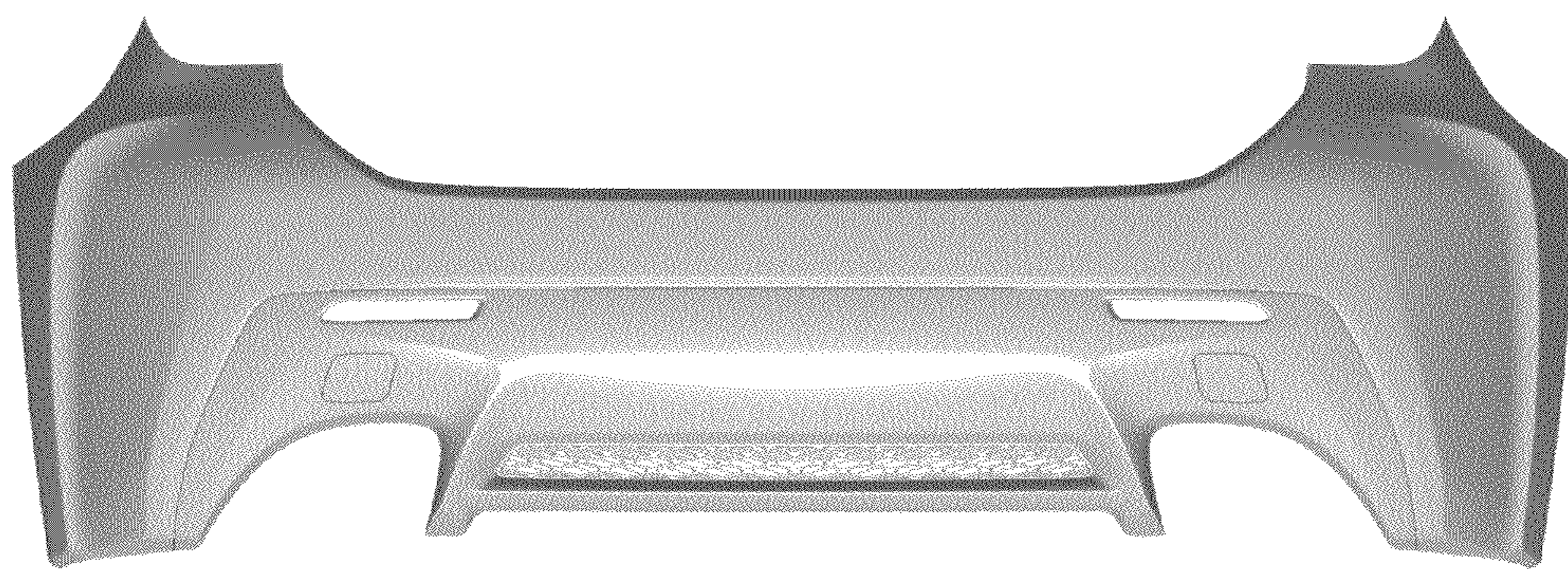

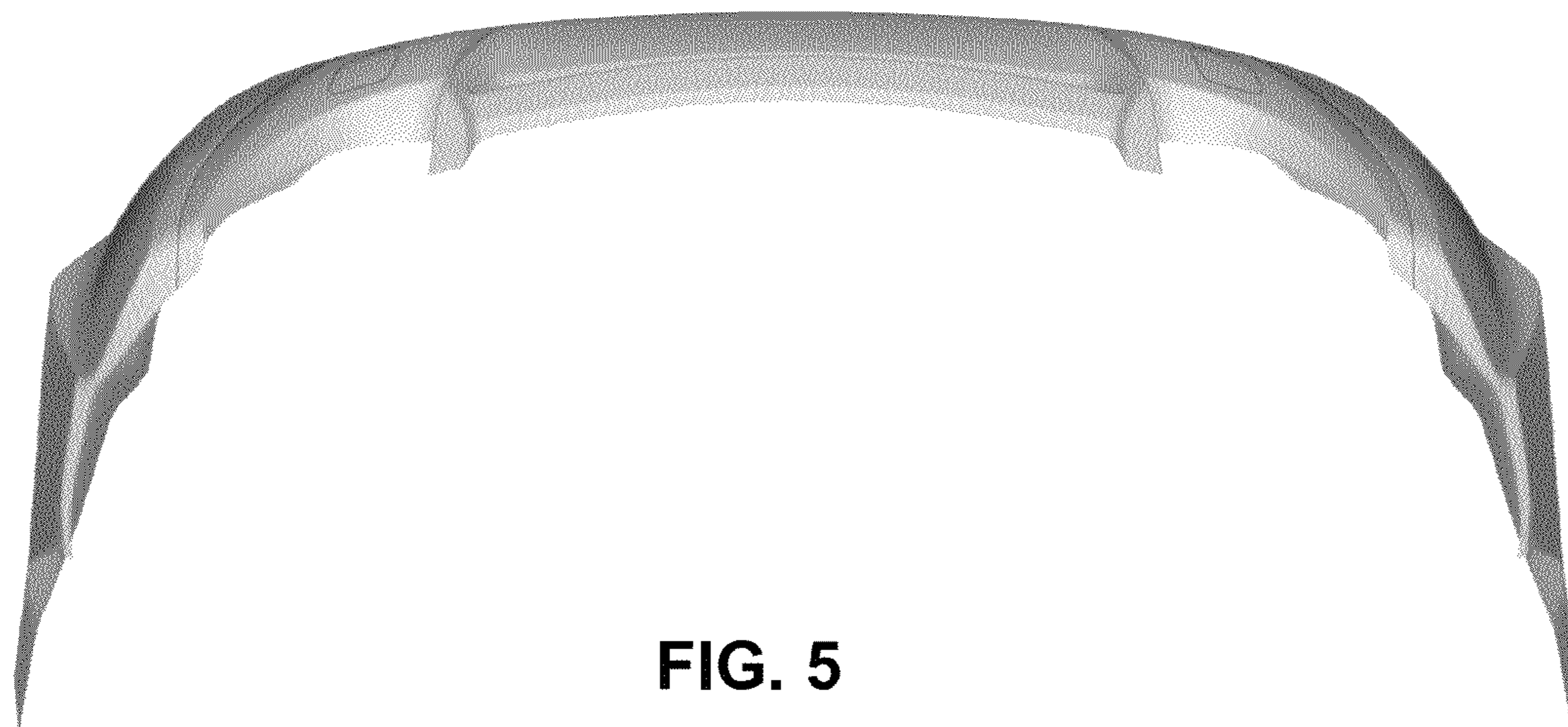

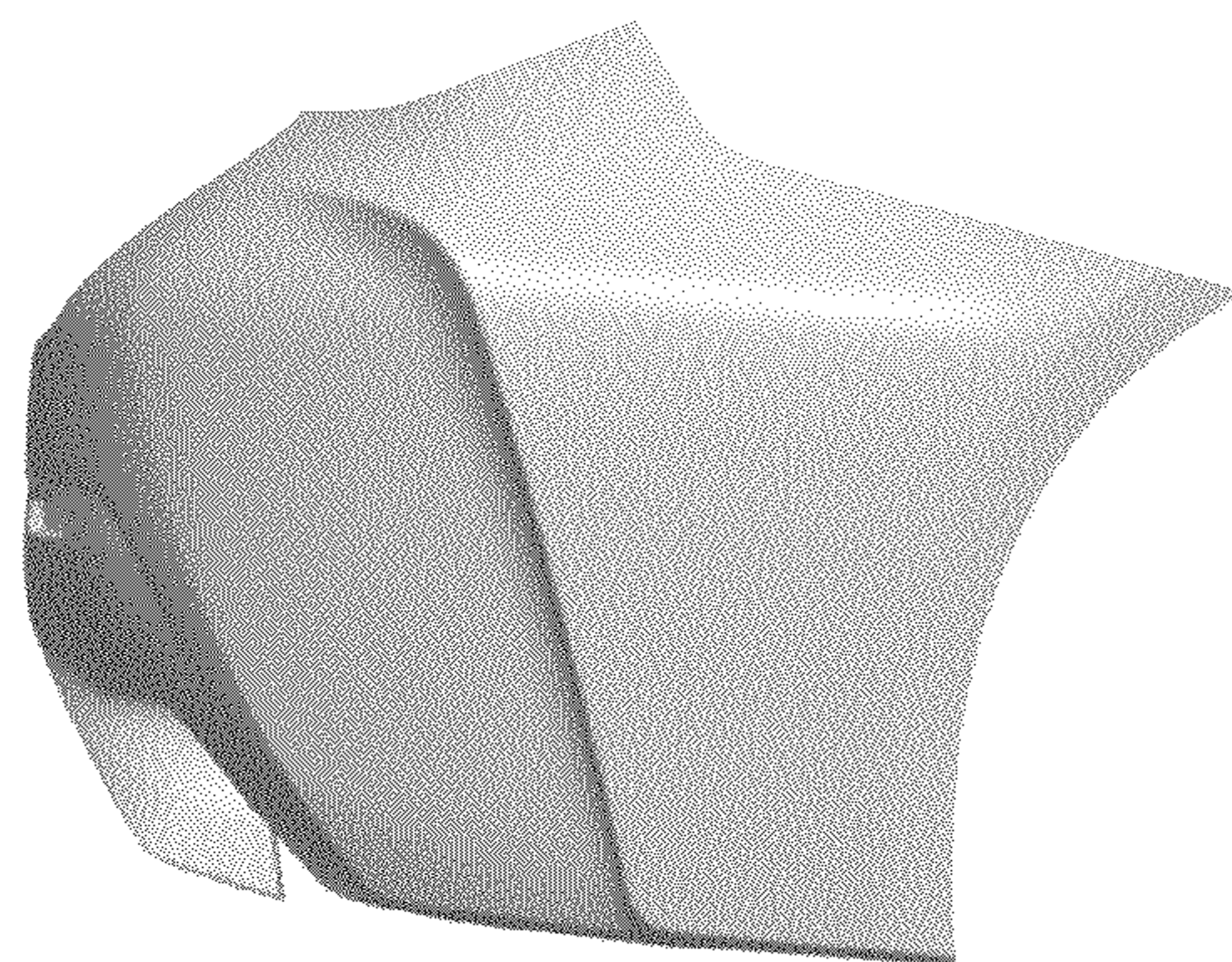
