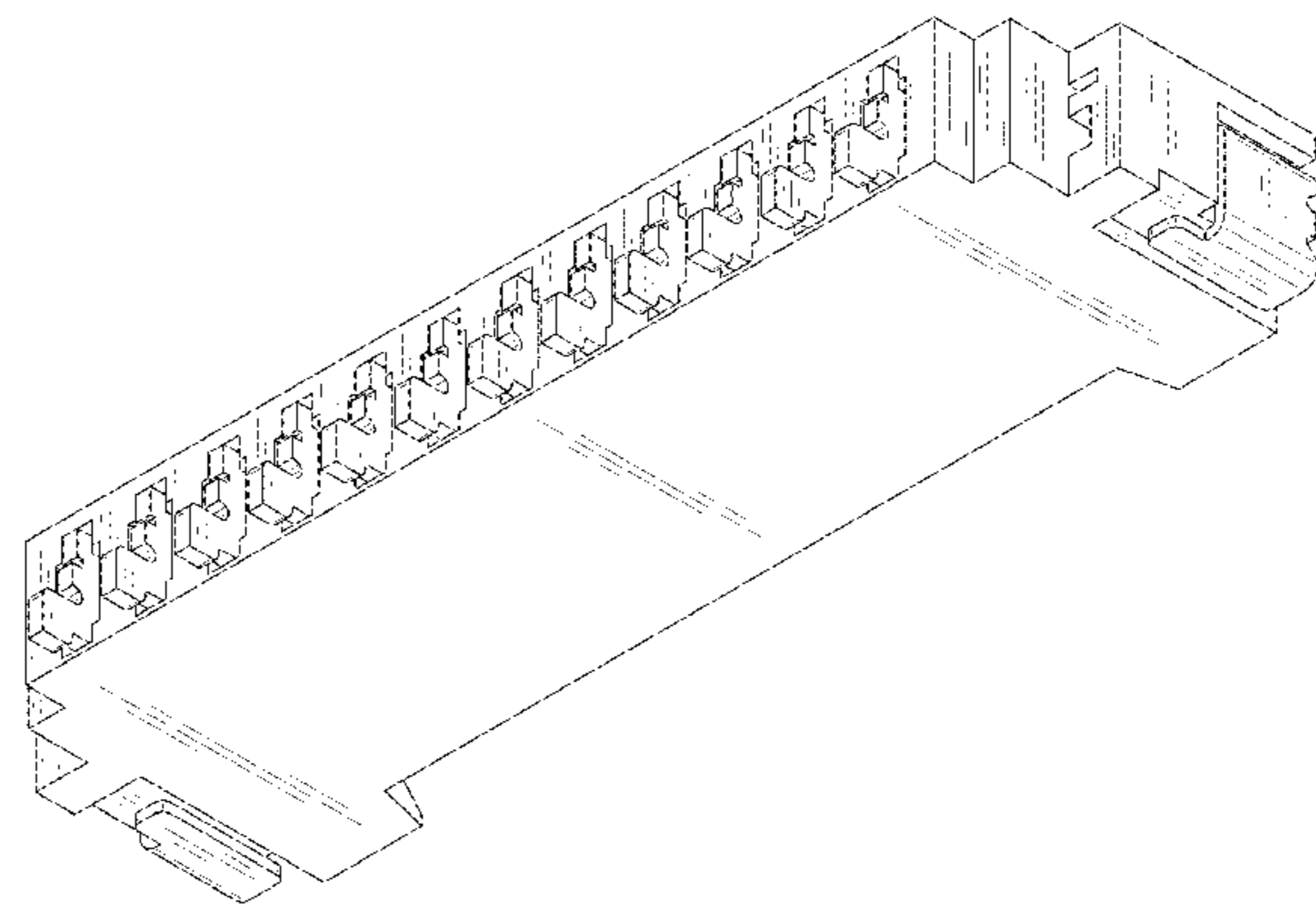
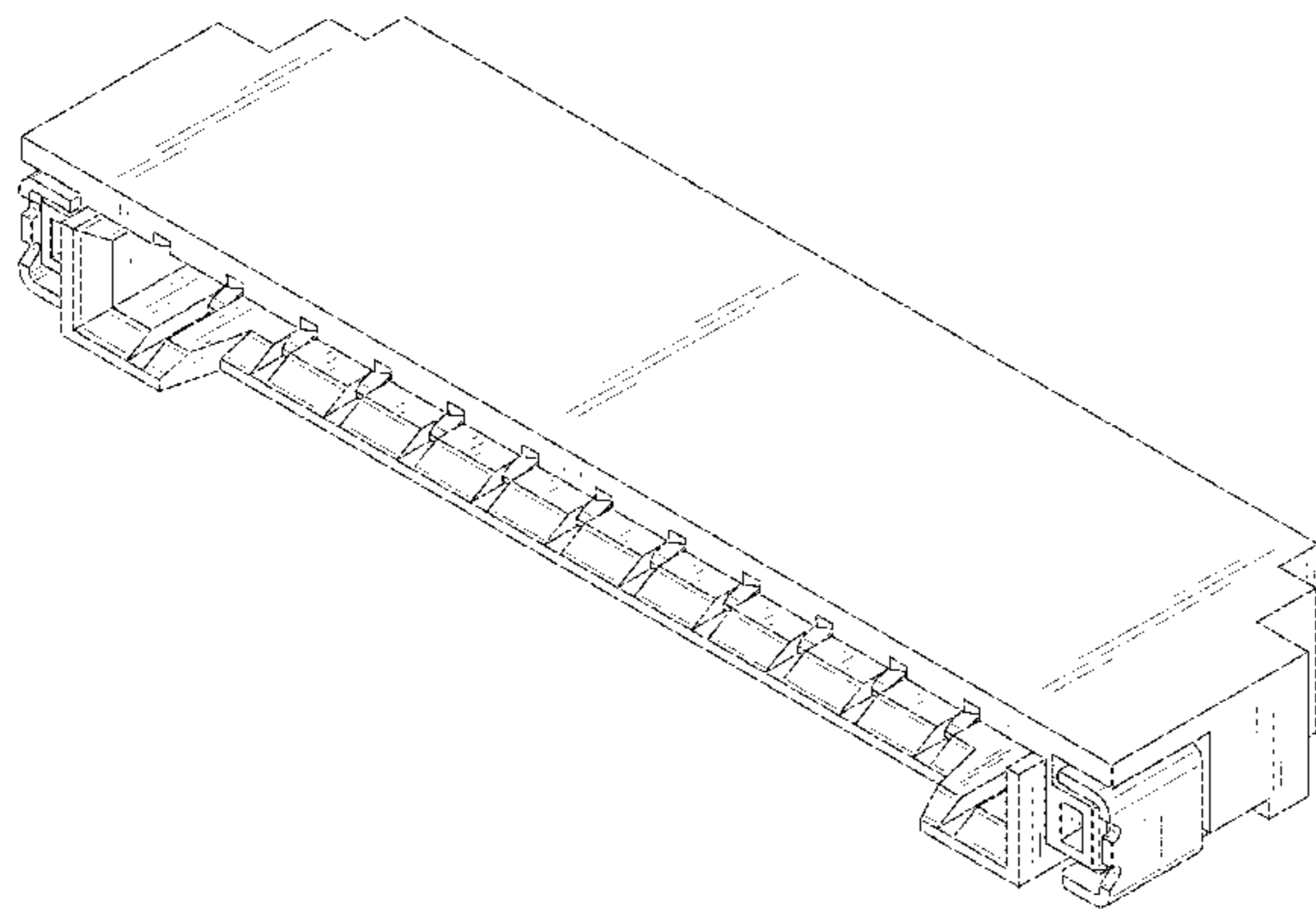
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front elevational view of an electrical connector, showing my new design;

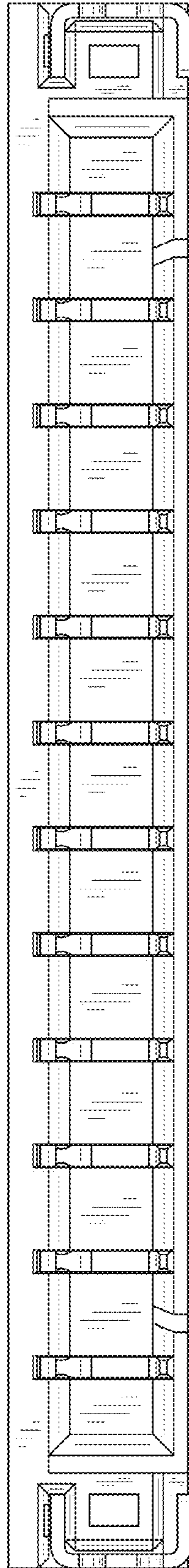

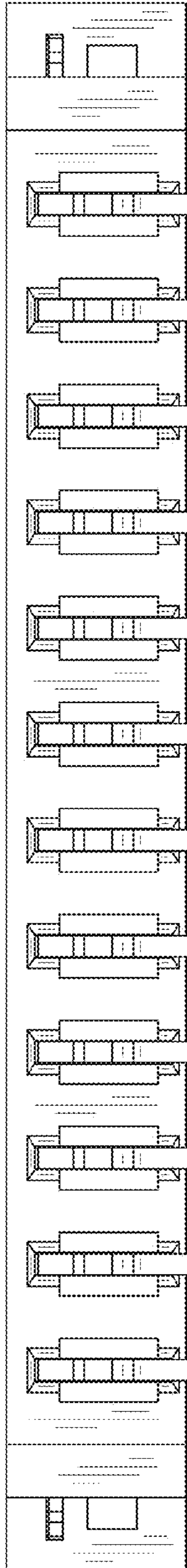

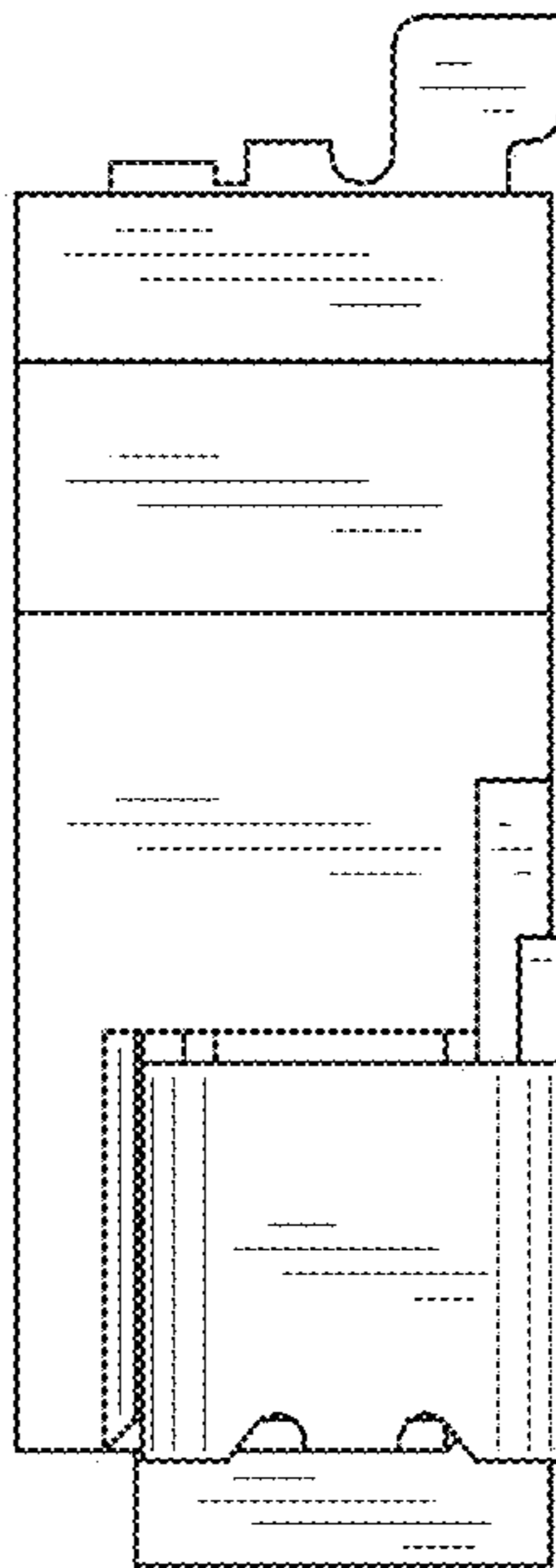

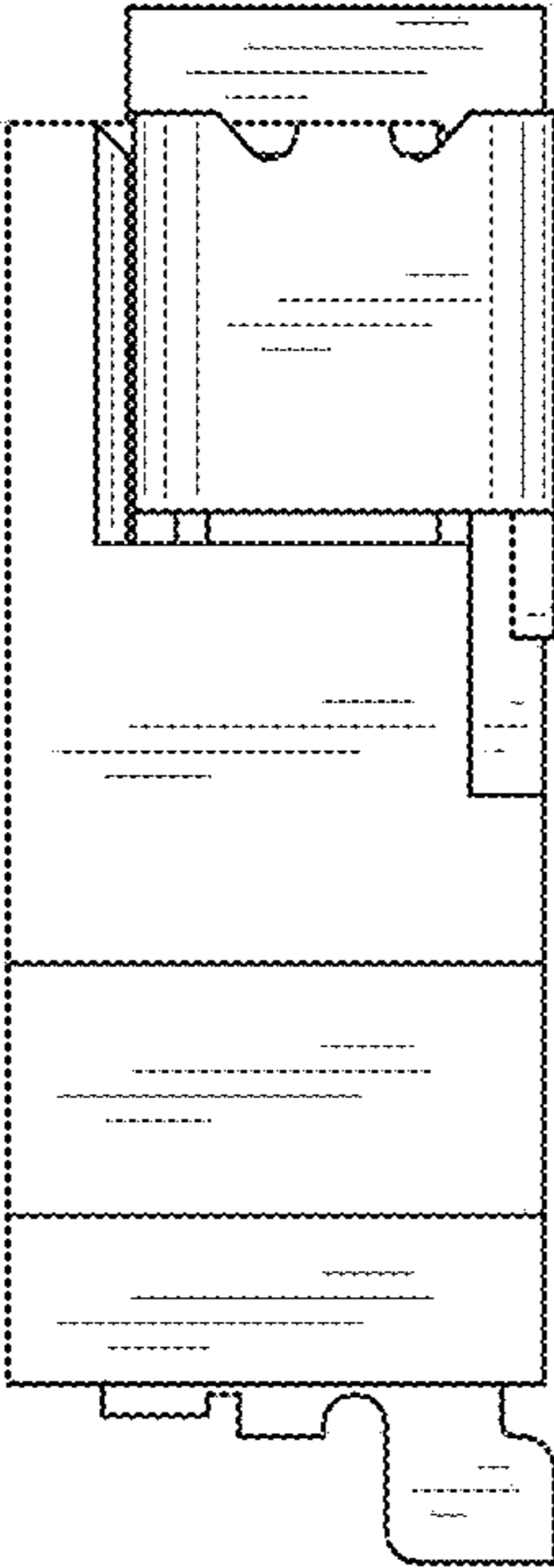

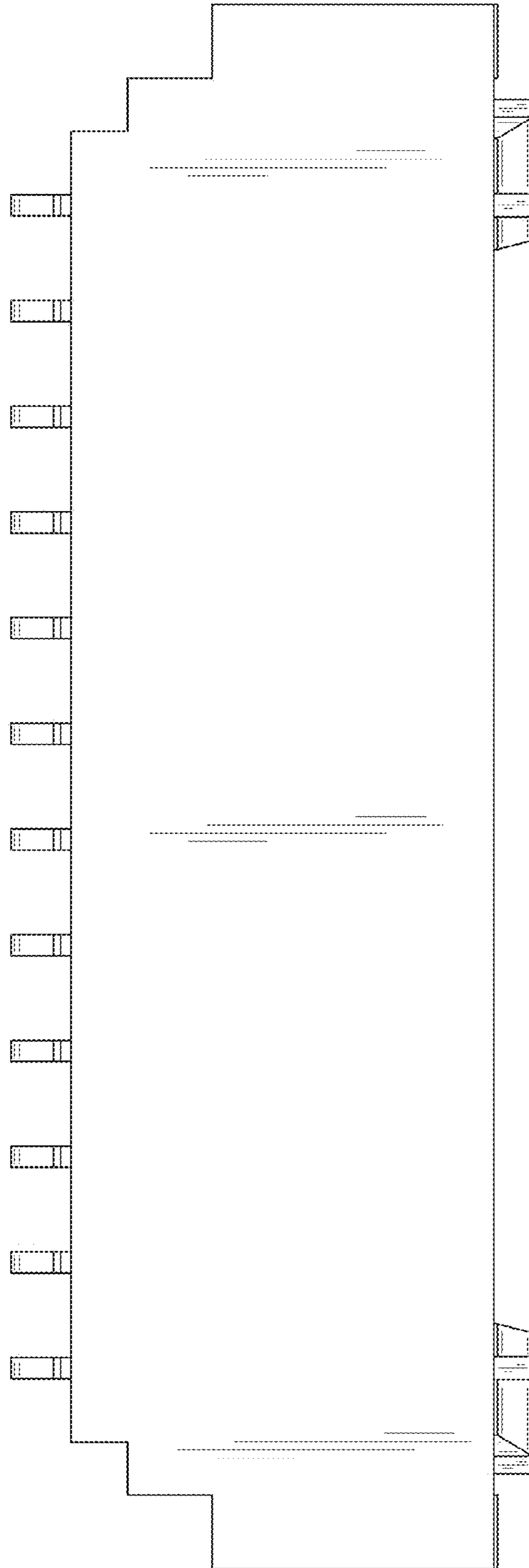

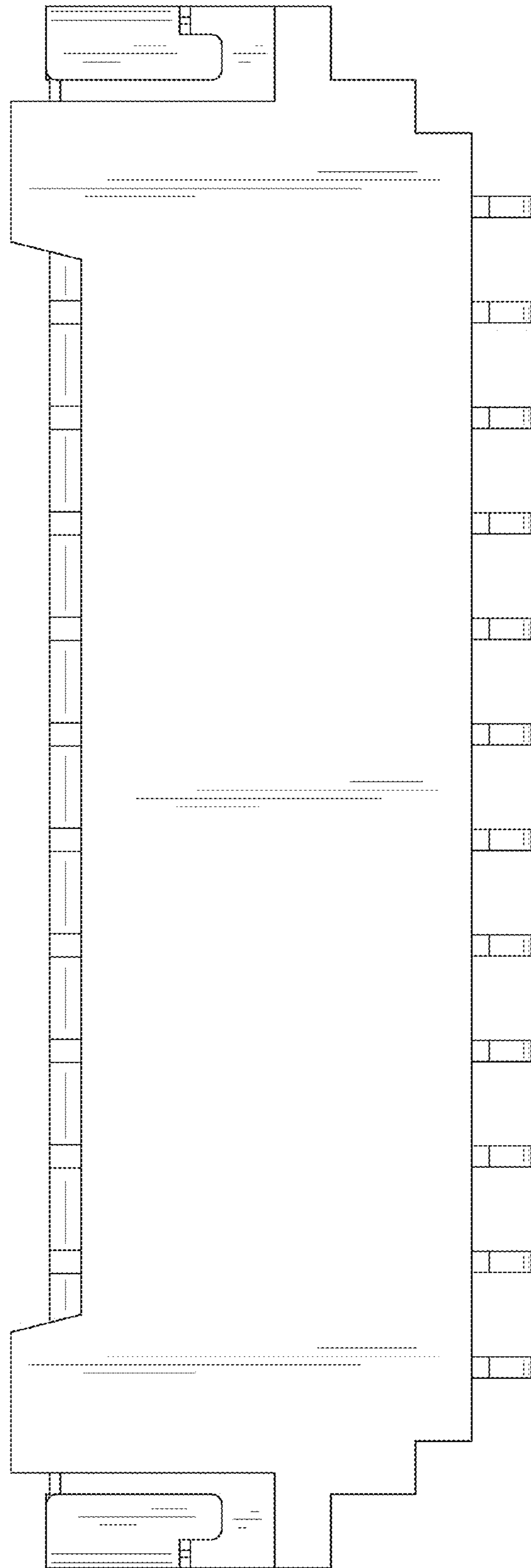

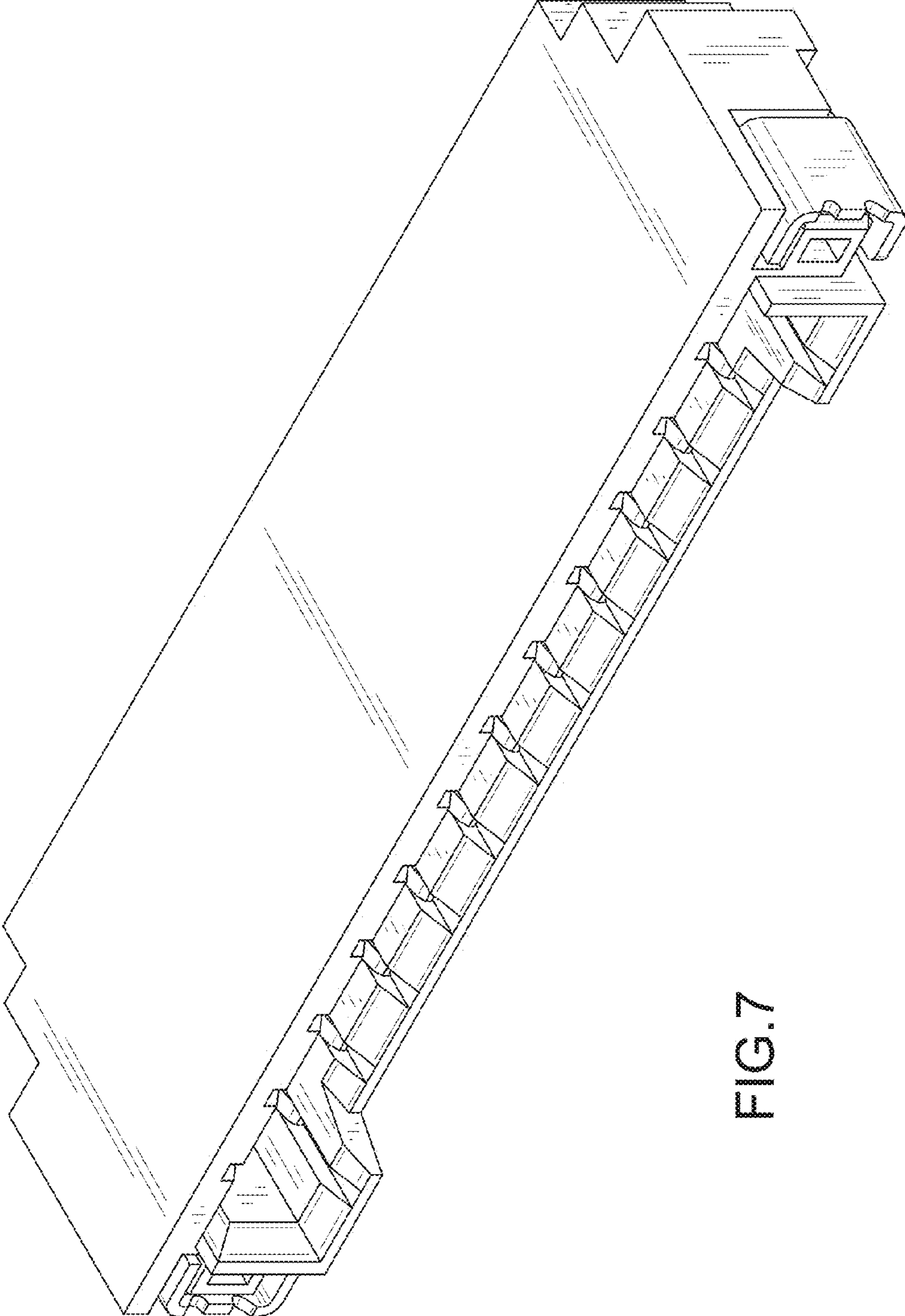

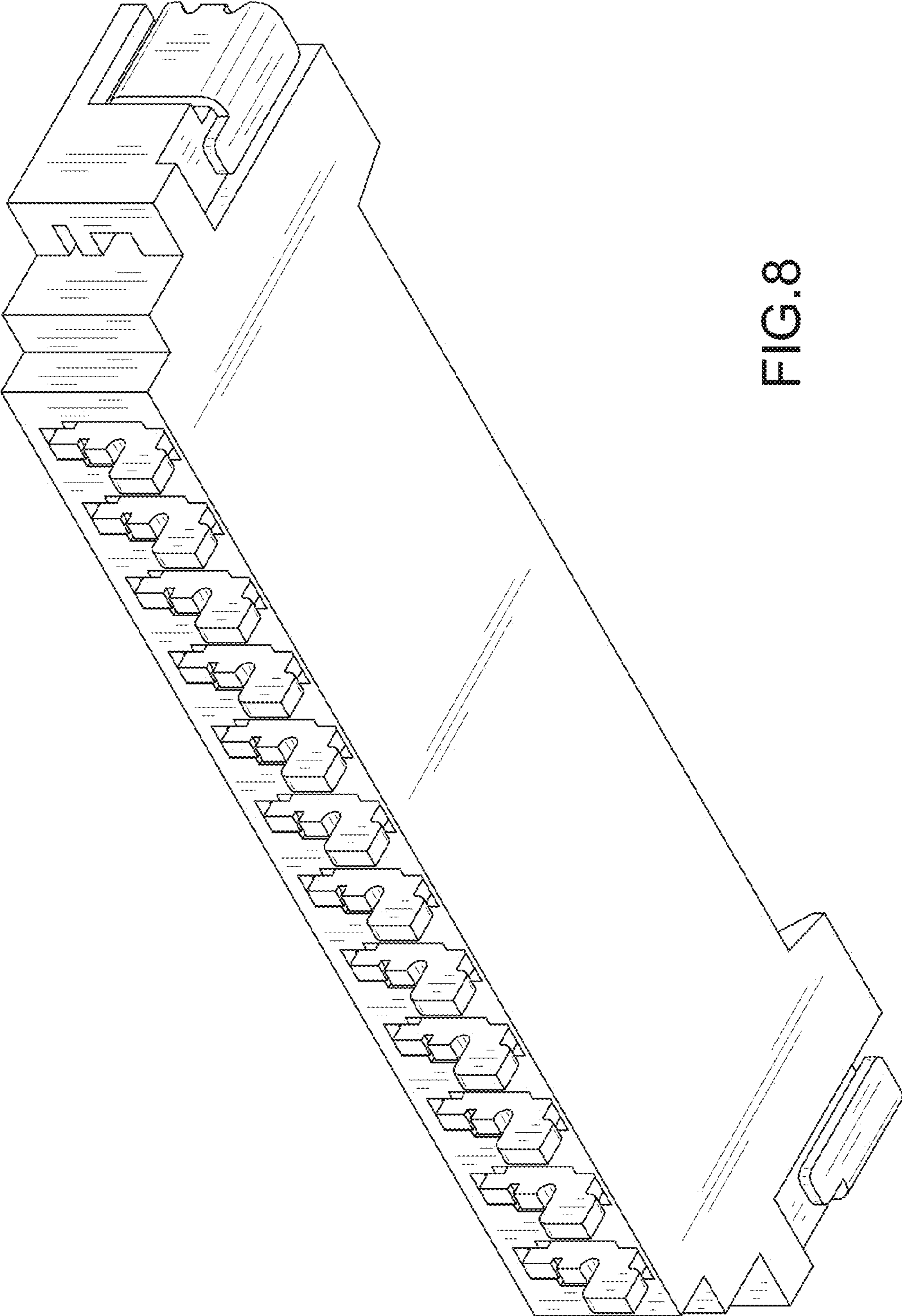

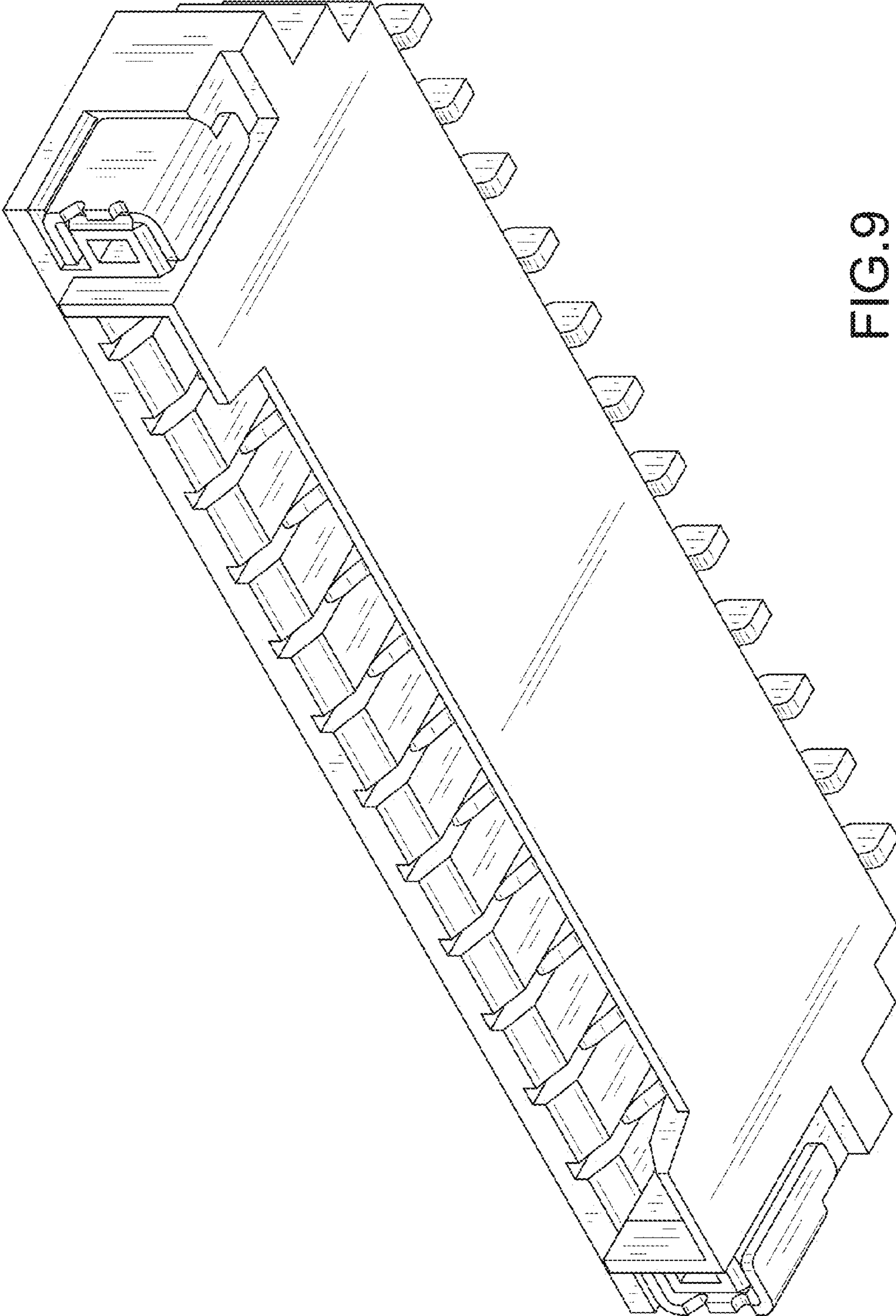

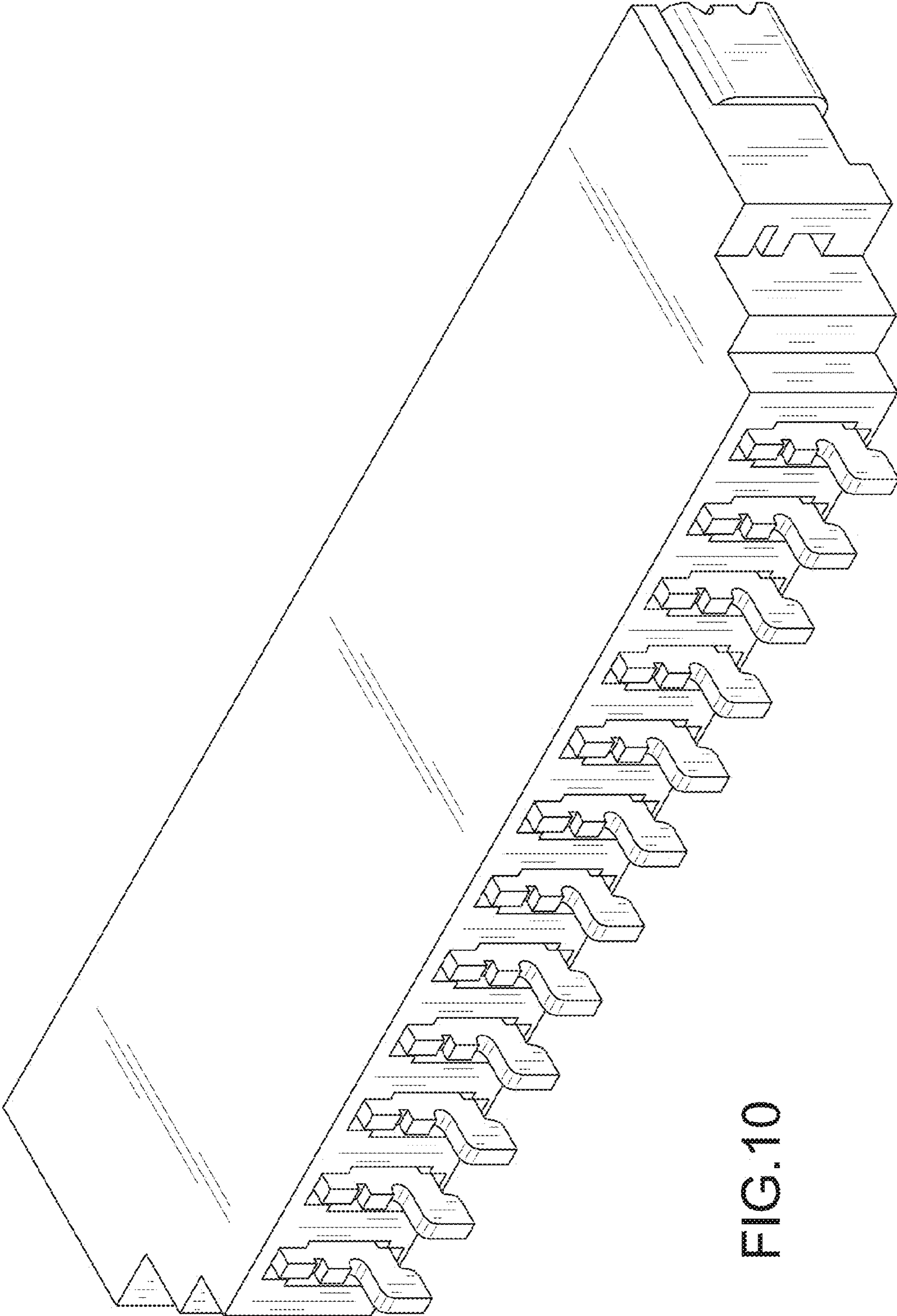
