The ornamental design for a portable terminal, as shown and  
described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a portable terminal  
showing my new design;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a left-side view thereof;

FIG. 5 is a right-side view thereof;

FIG. 6 is a top view thereof;

FIG. 7 is a bottom view thereof;

FIG. 8 is an enlarged view of the encircled portion A as shown  
in FIG. 2; and,

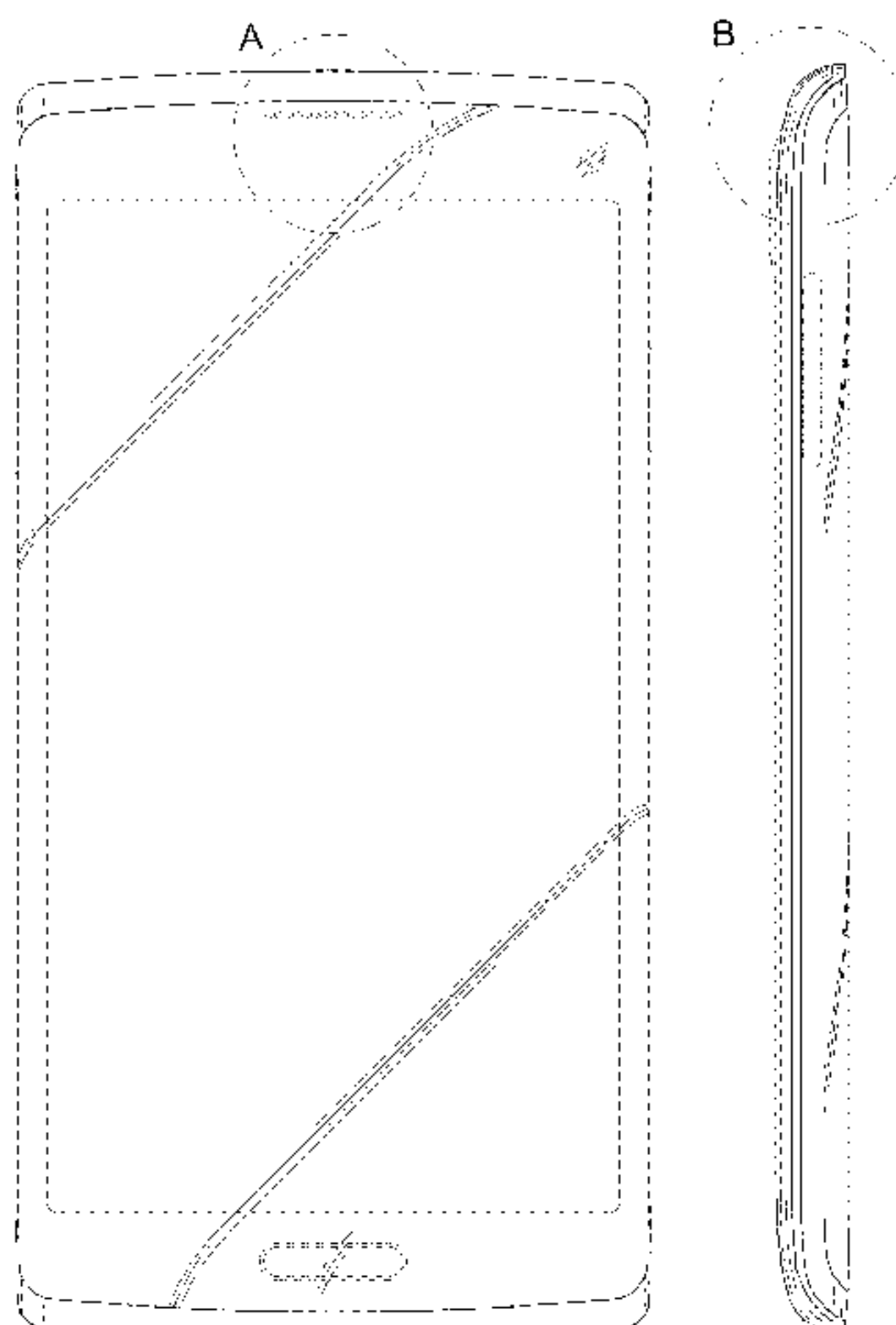
FIG. 9 is an enlarged view of the encircled portion B as shown  
in FIG. 4.

The broken lines shown in the figures that are immediately

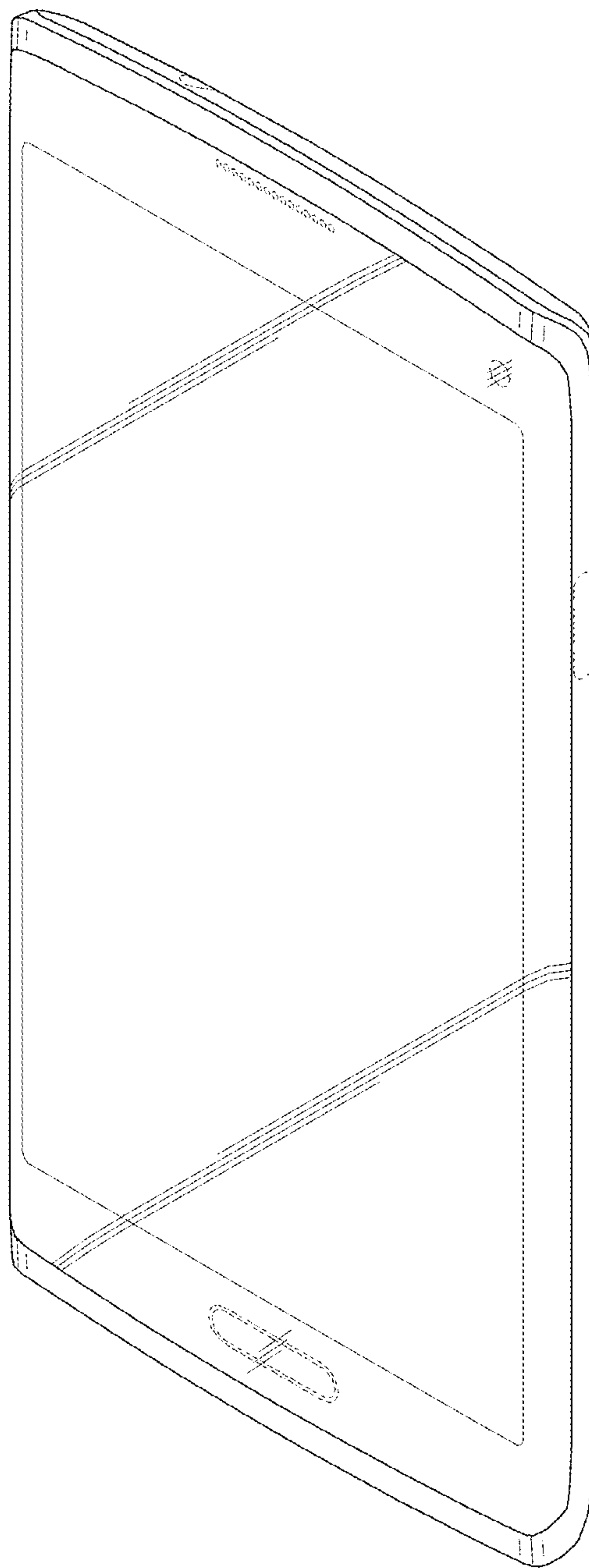

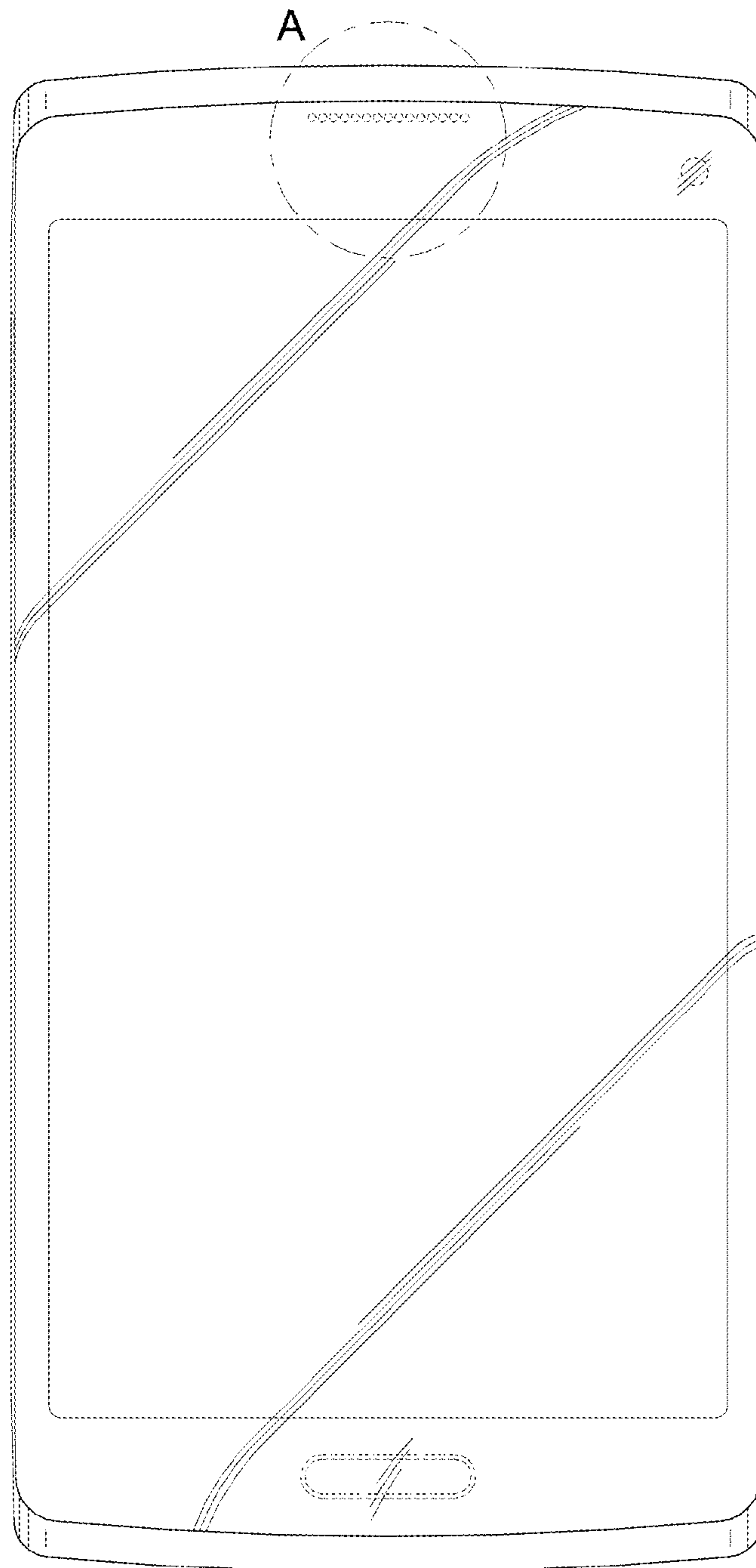

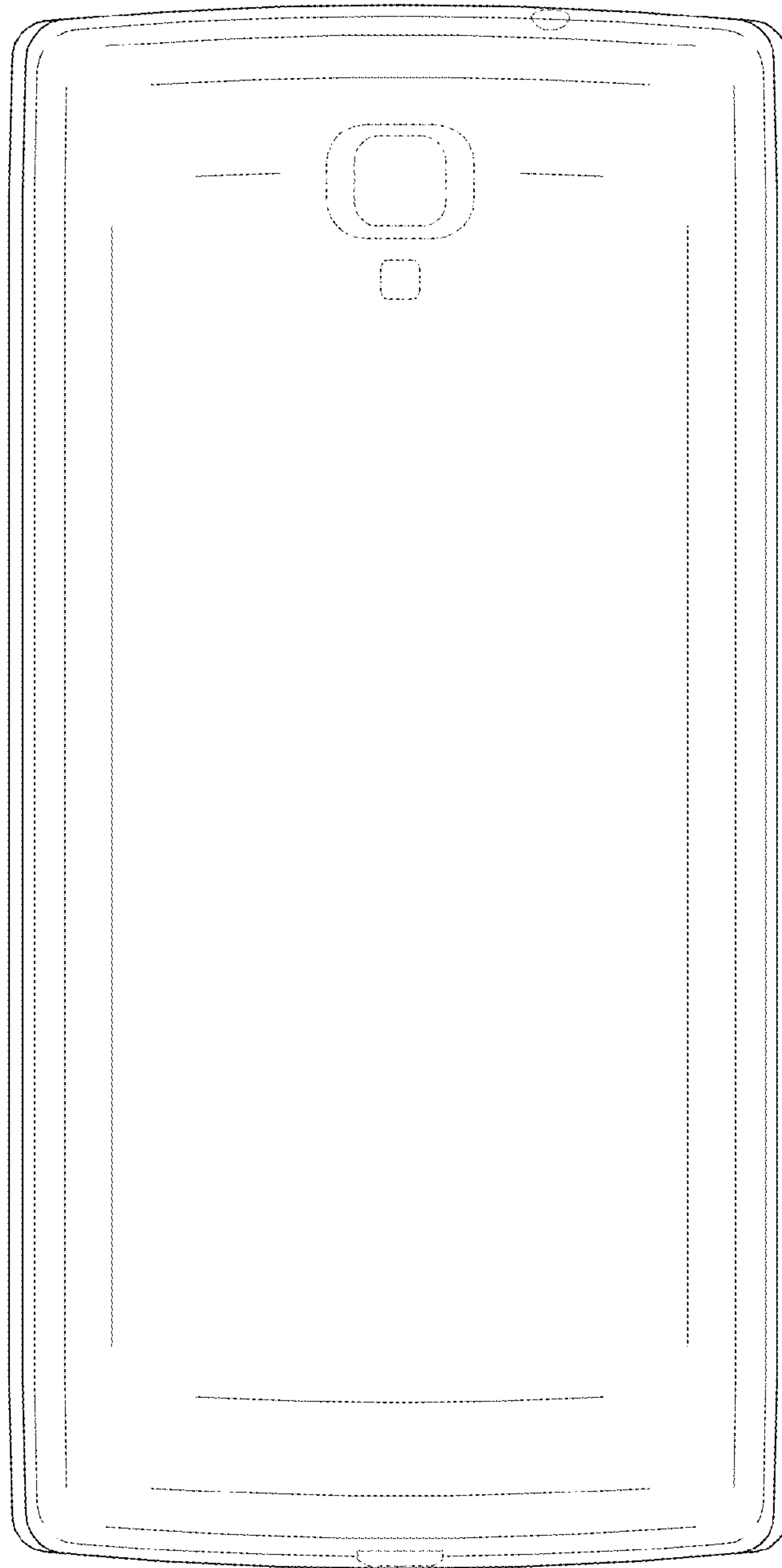

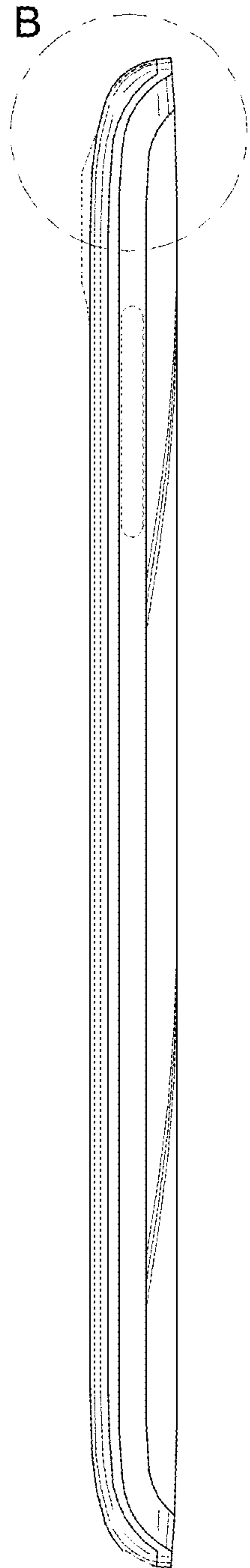

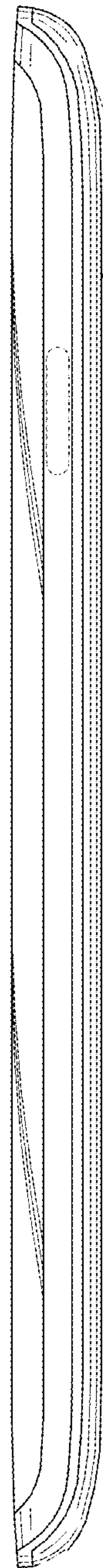

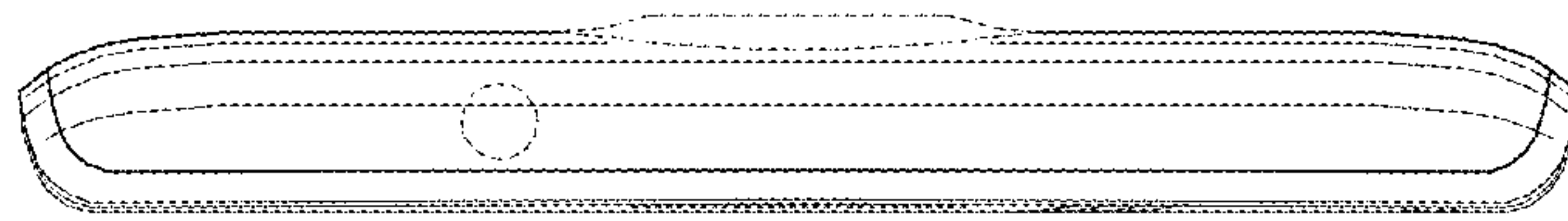

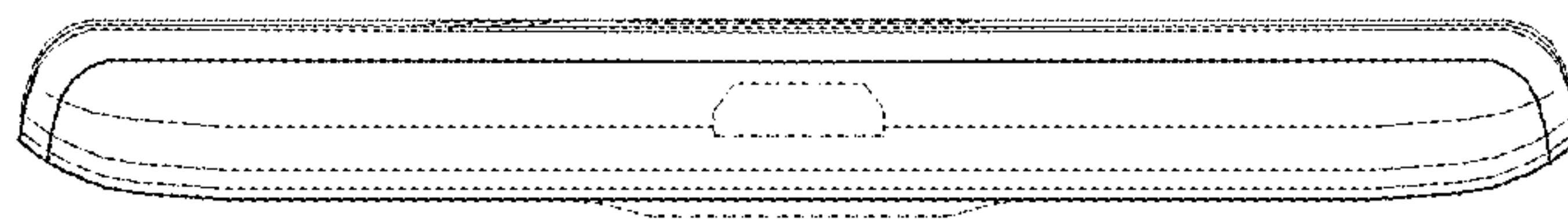

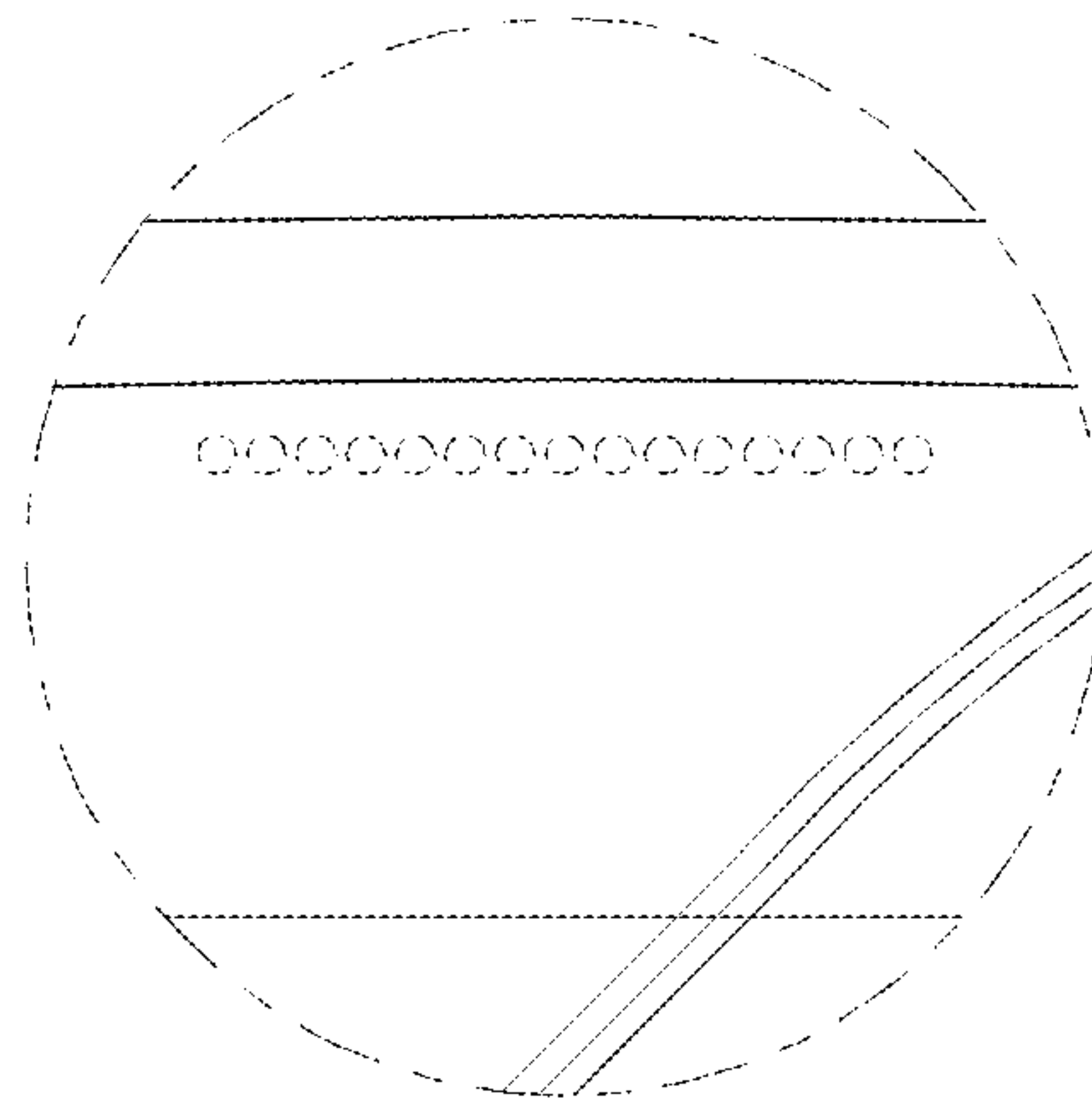
